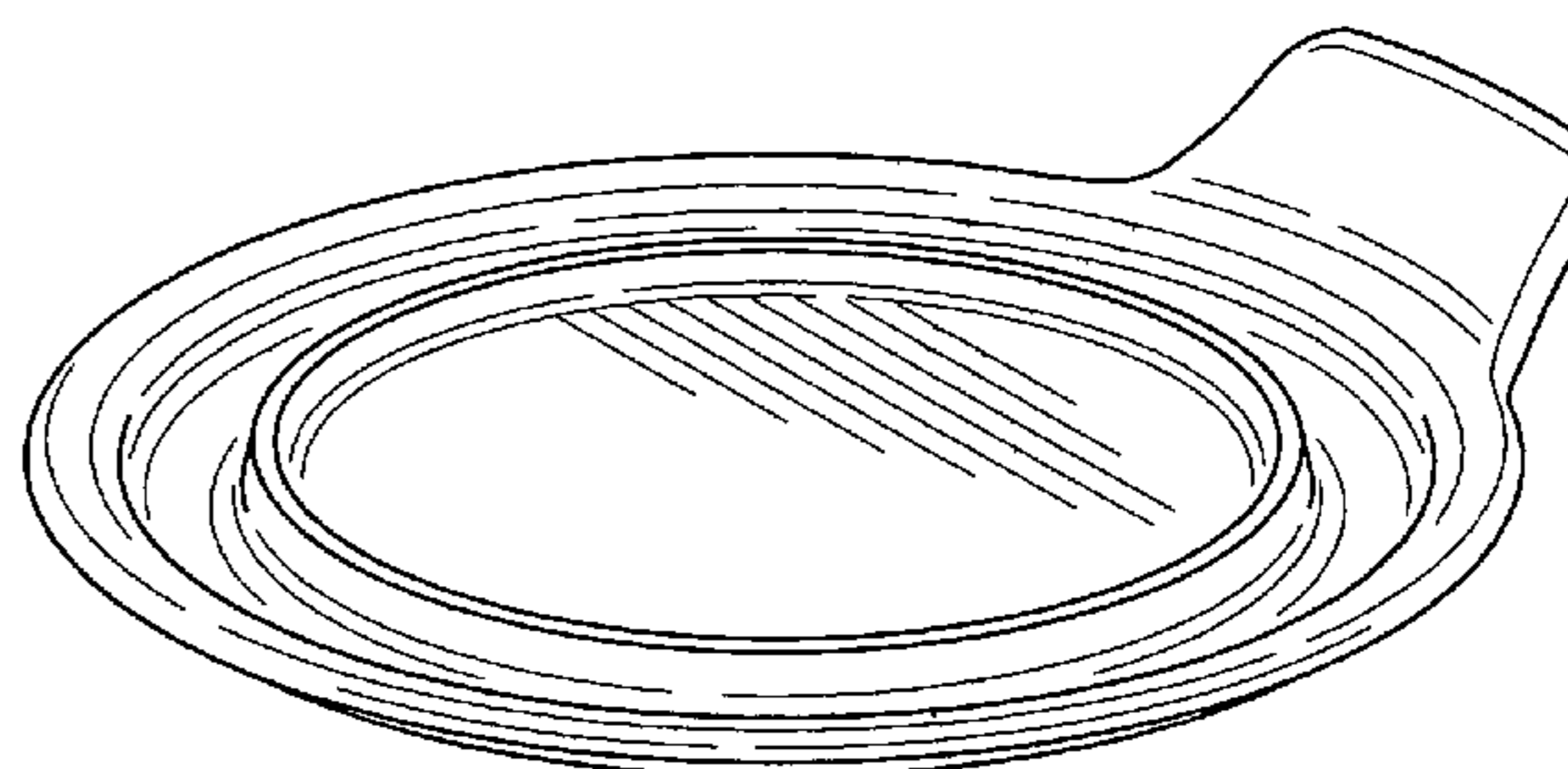
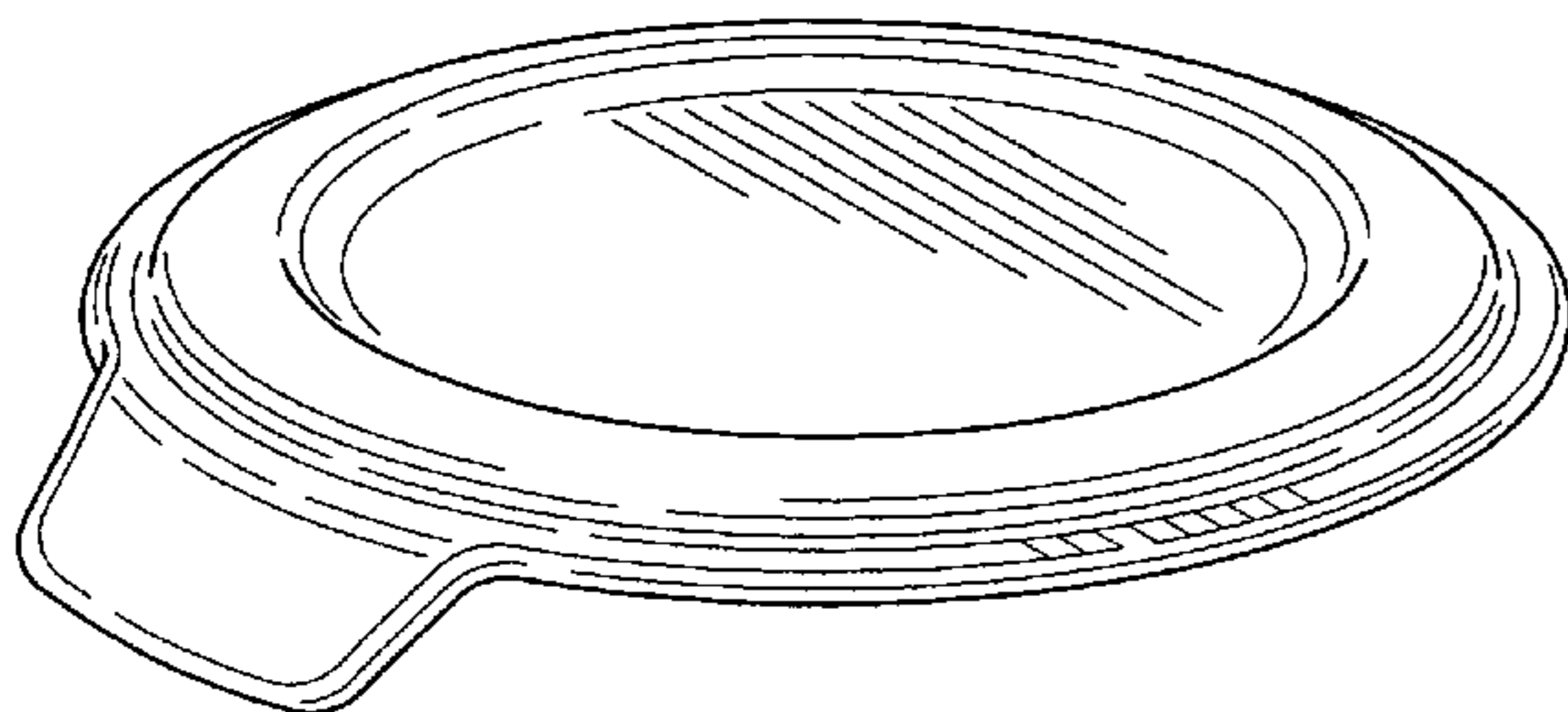
(57) **CLAIM**

The ornamental design for a combined cover and saucer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a combined cover and saucer showing my new design;  
FIG. 2 is a bottom, rear and right side perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a left side elevation view, the right side being a mirror image thereof;

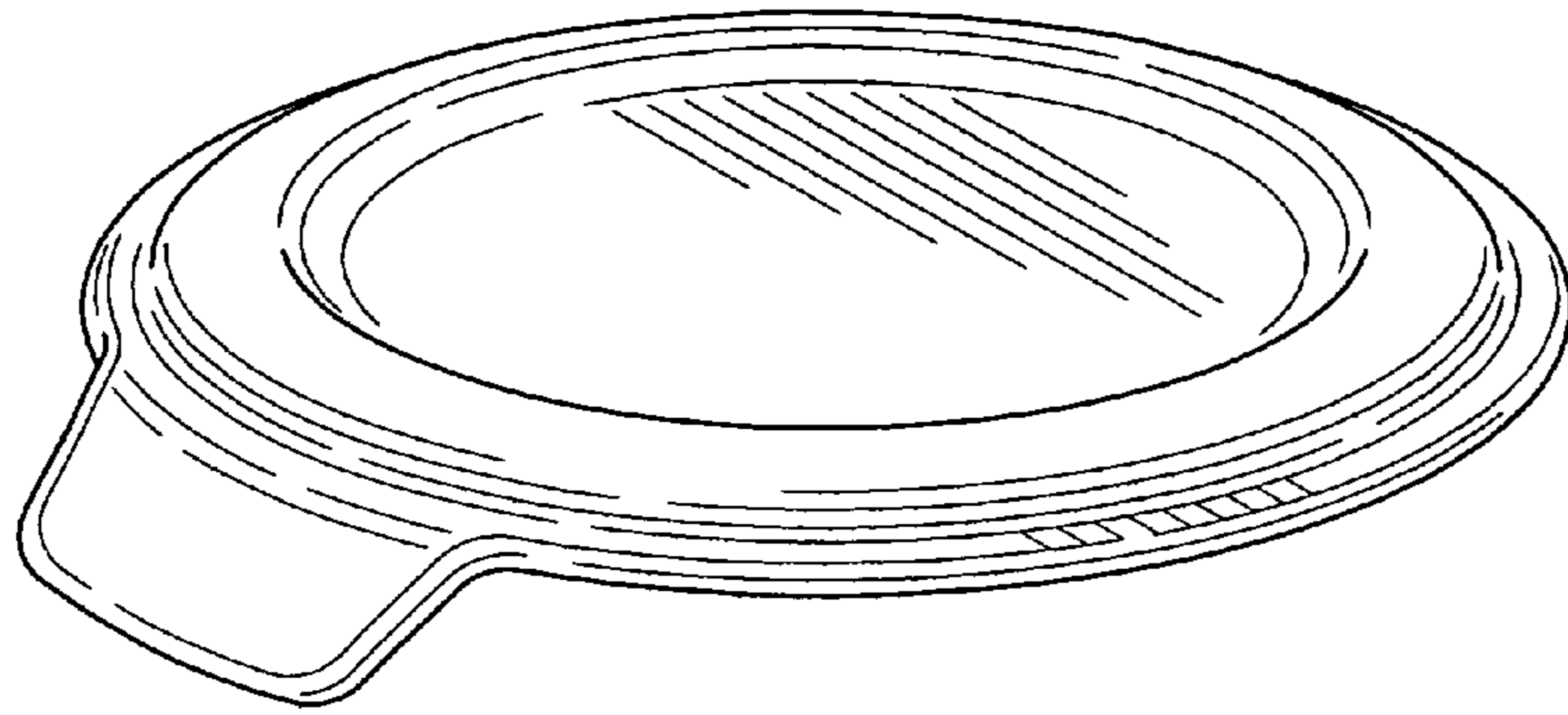

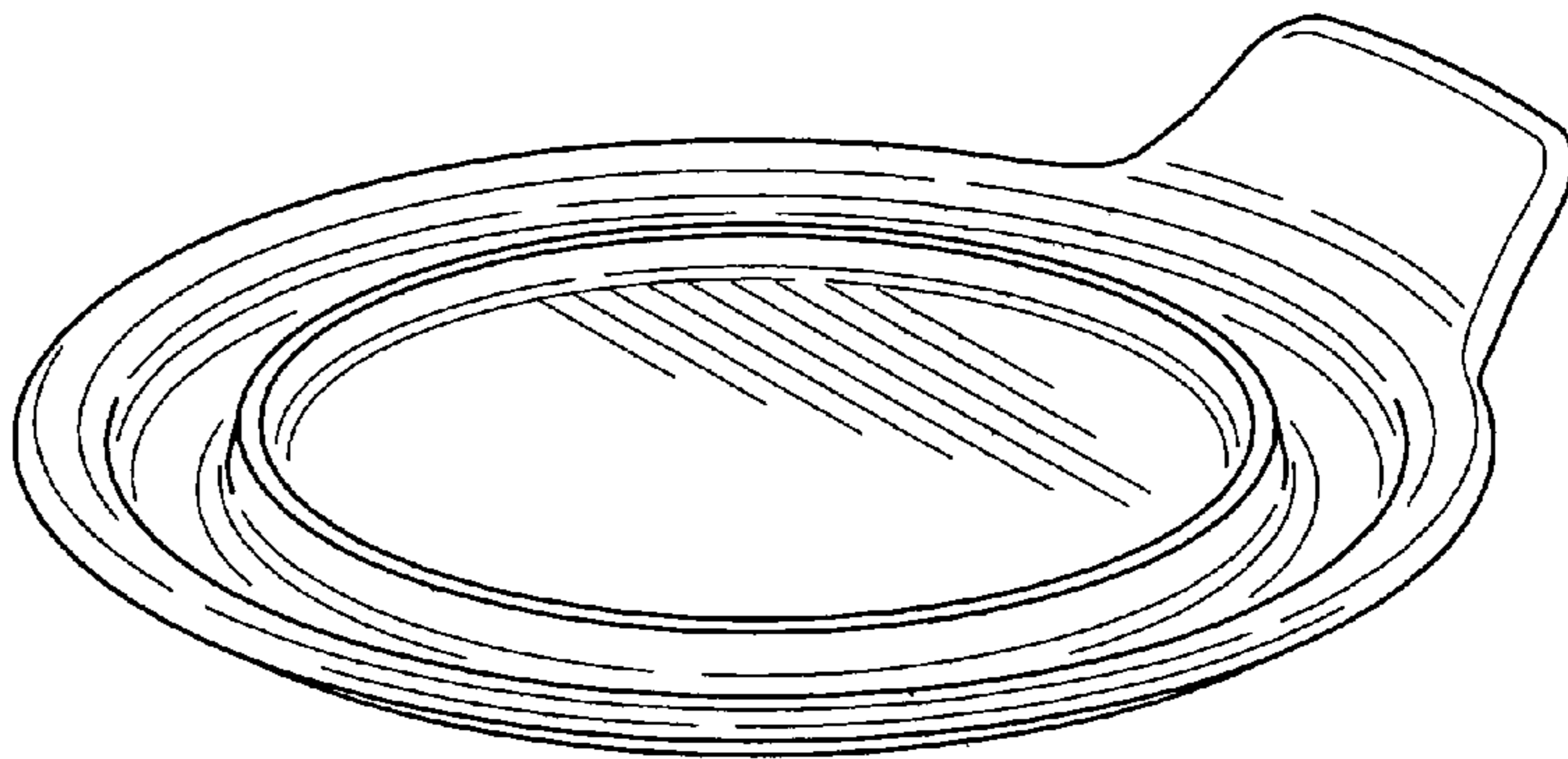

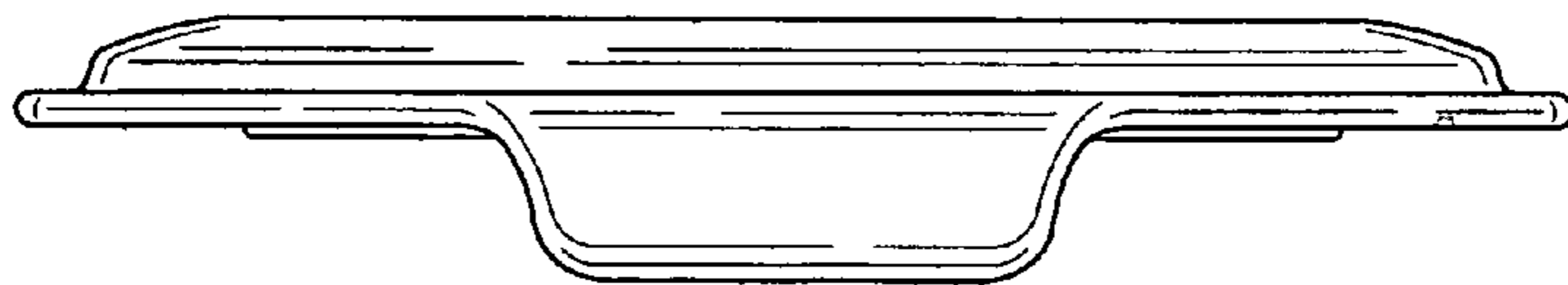

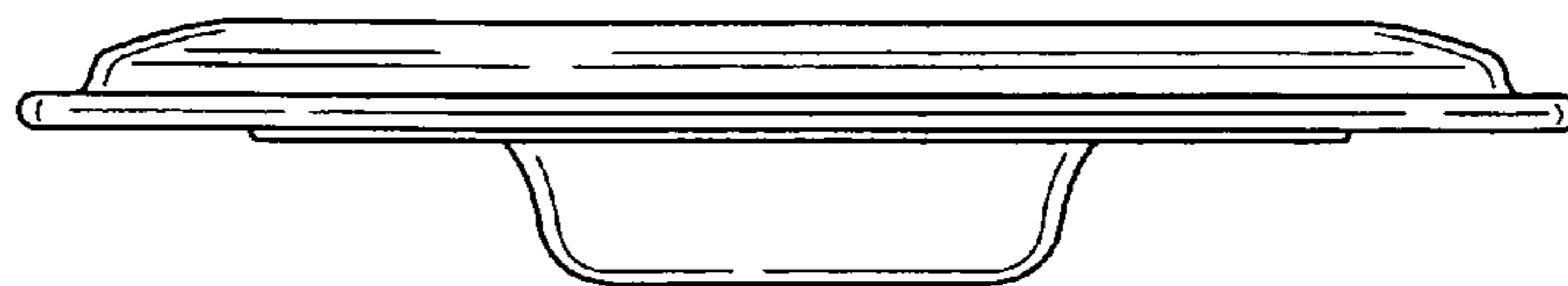

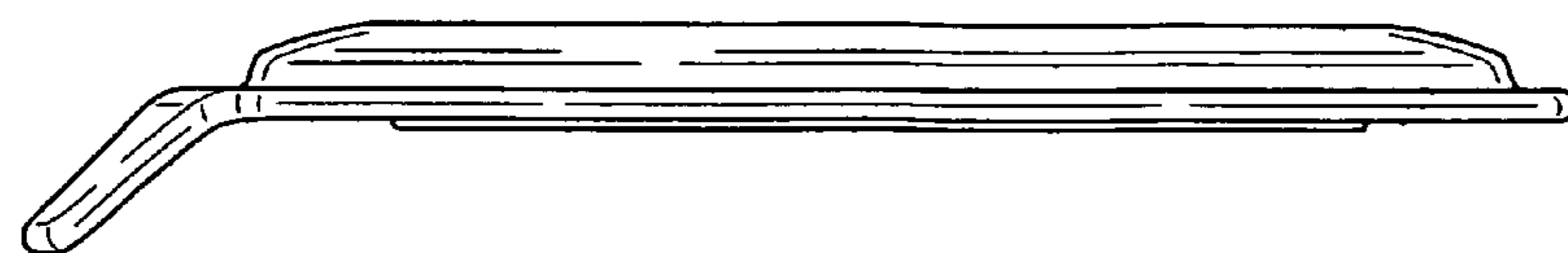

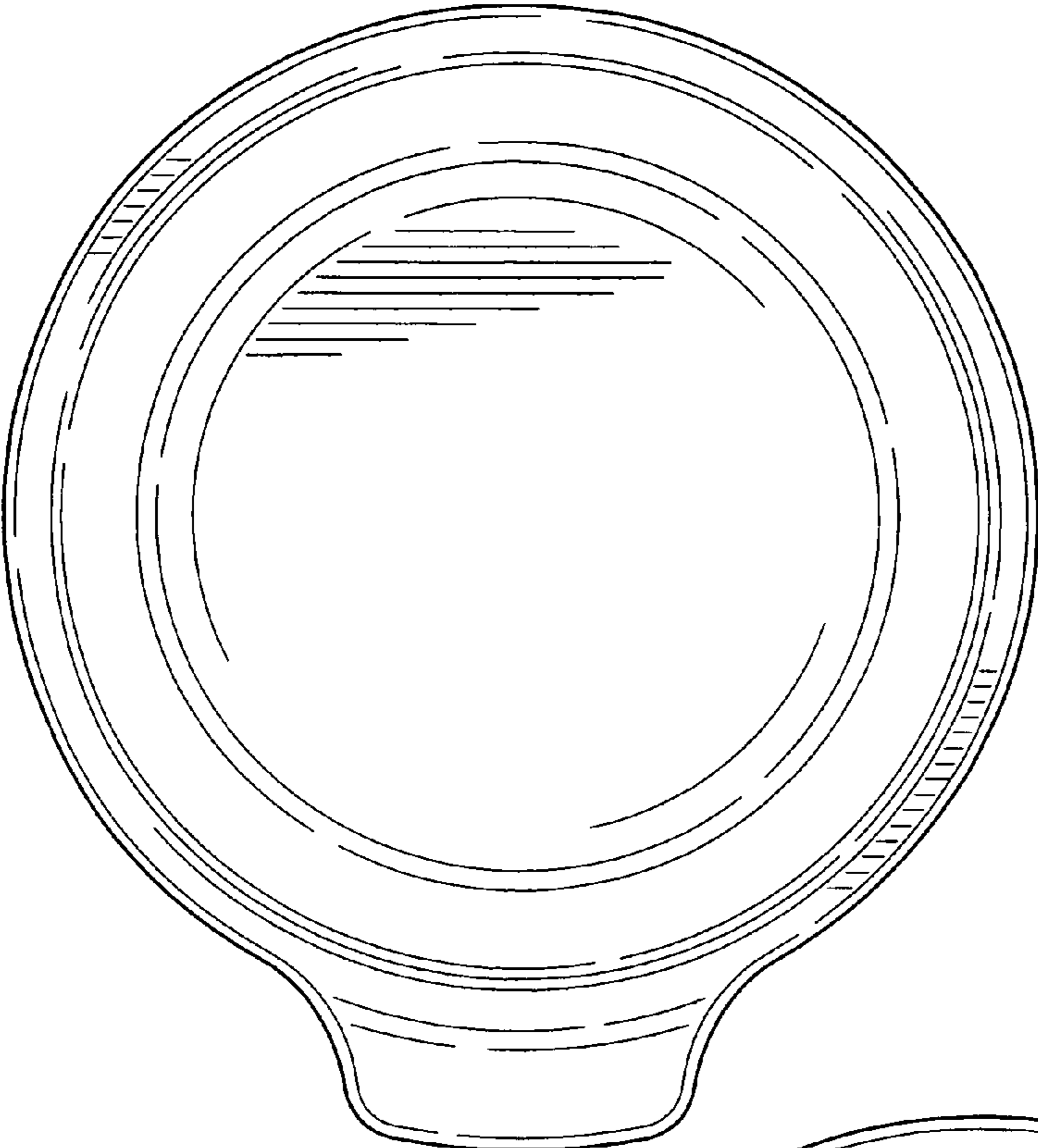

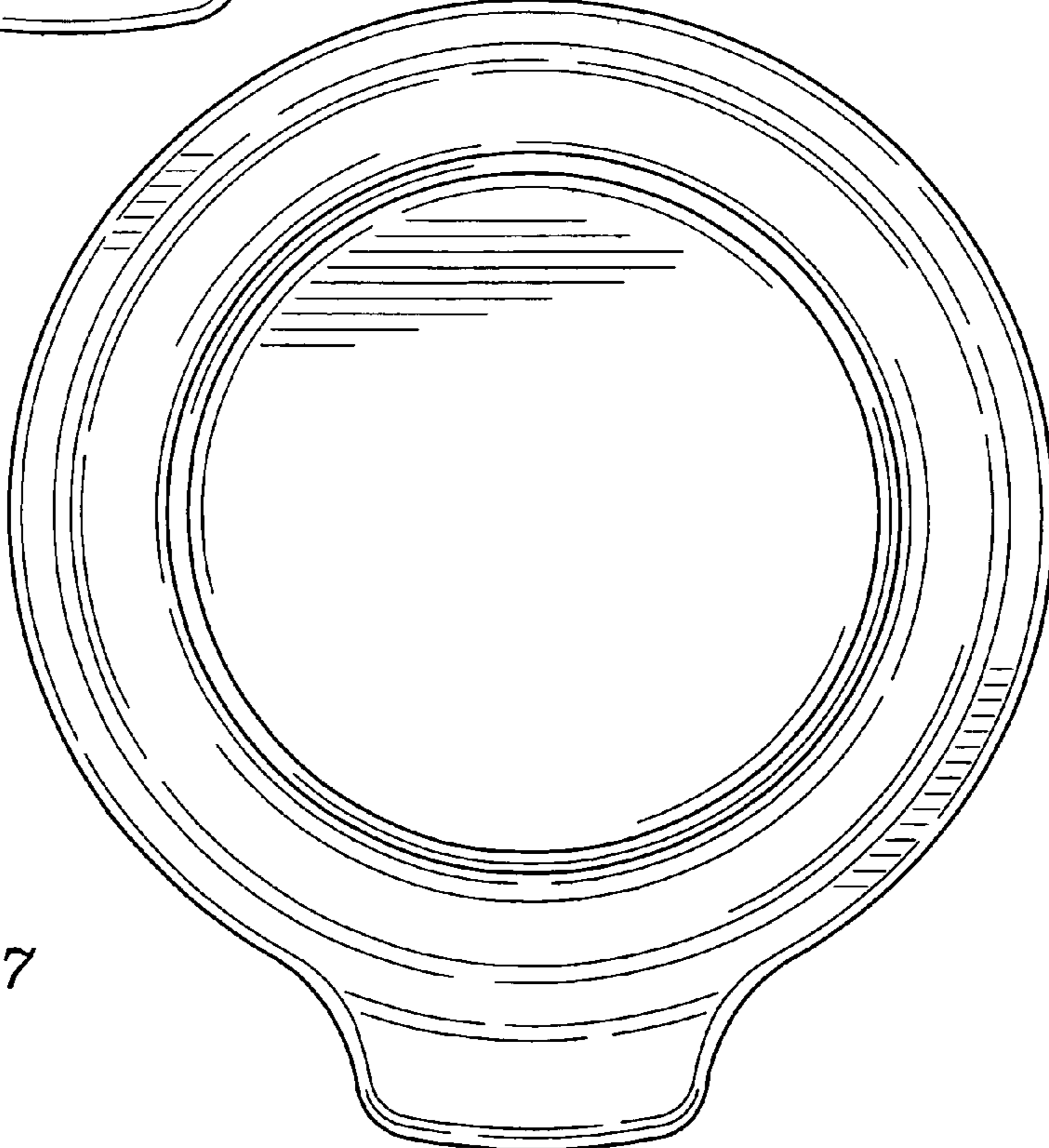
