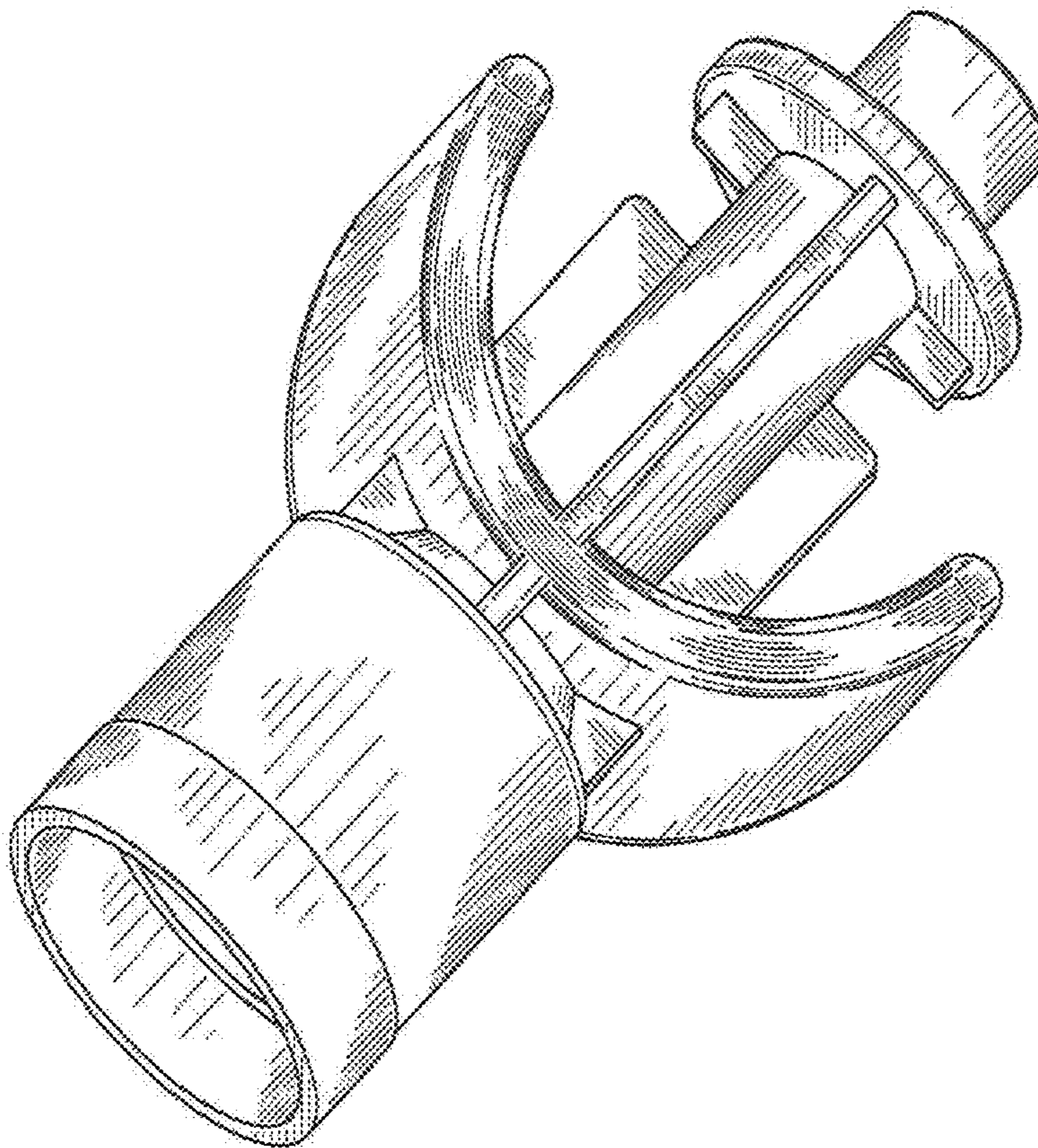
(57) **CLAIM**

I claim the ornamental design for a nozzle for a liquid or foam pump, as shown and described.

DESCRIPTION

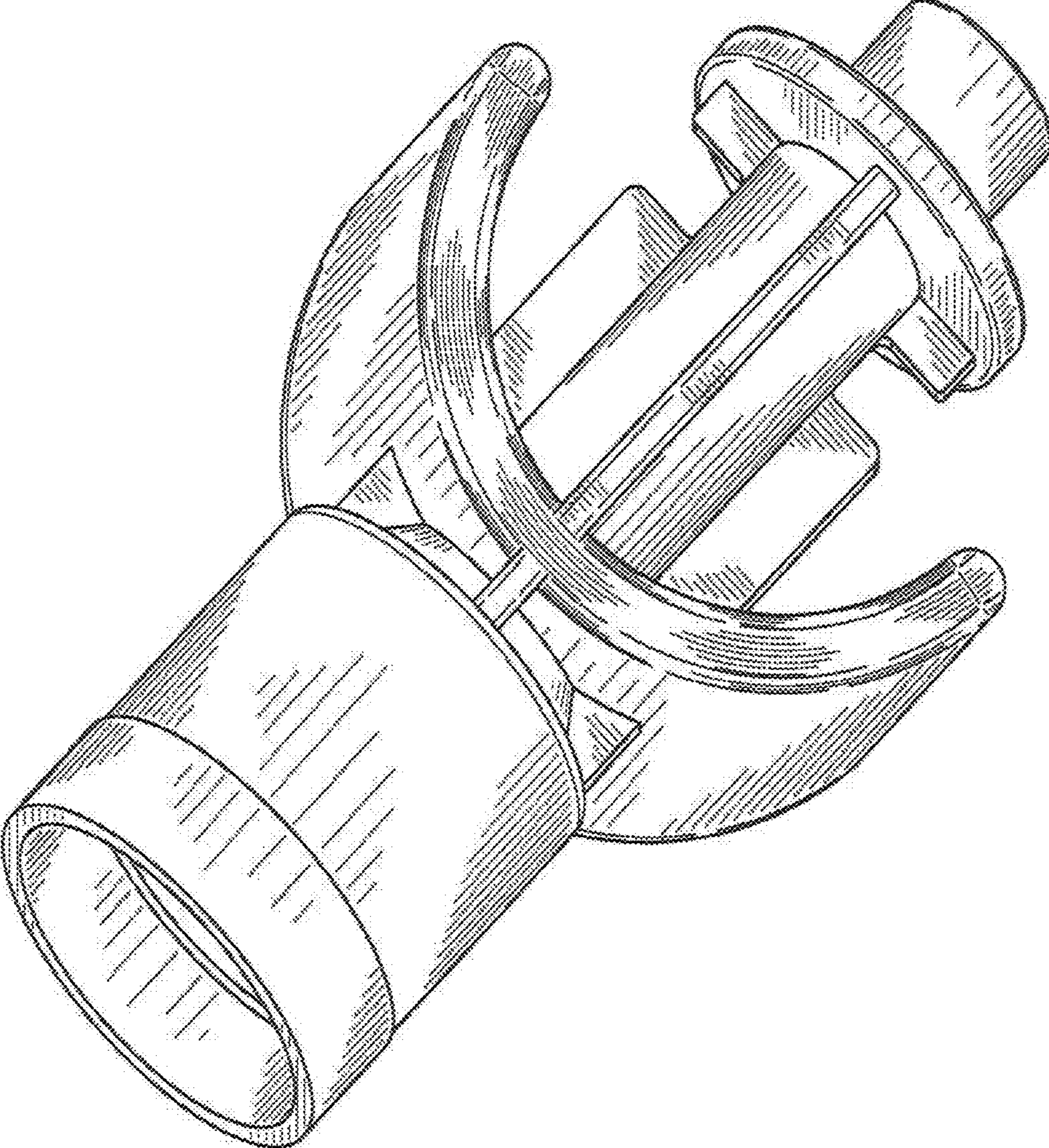

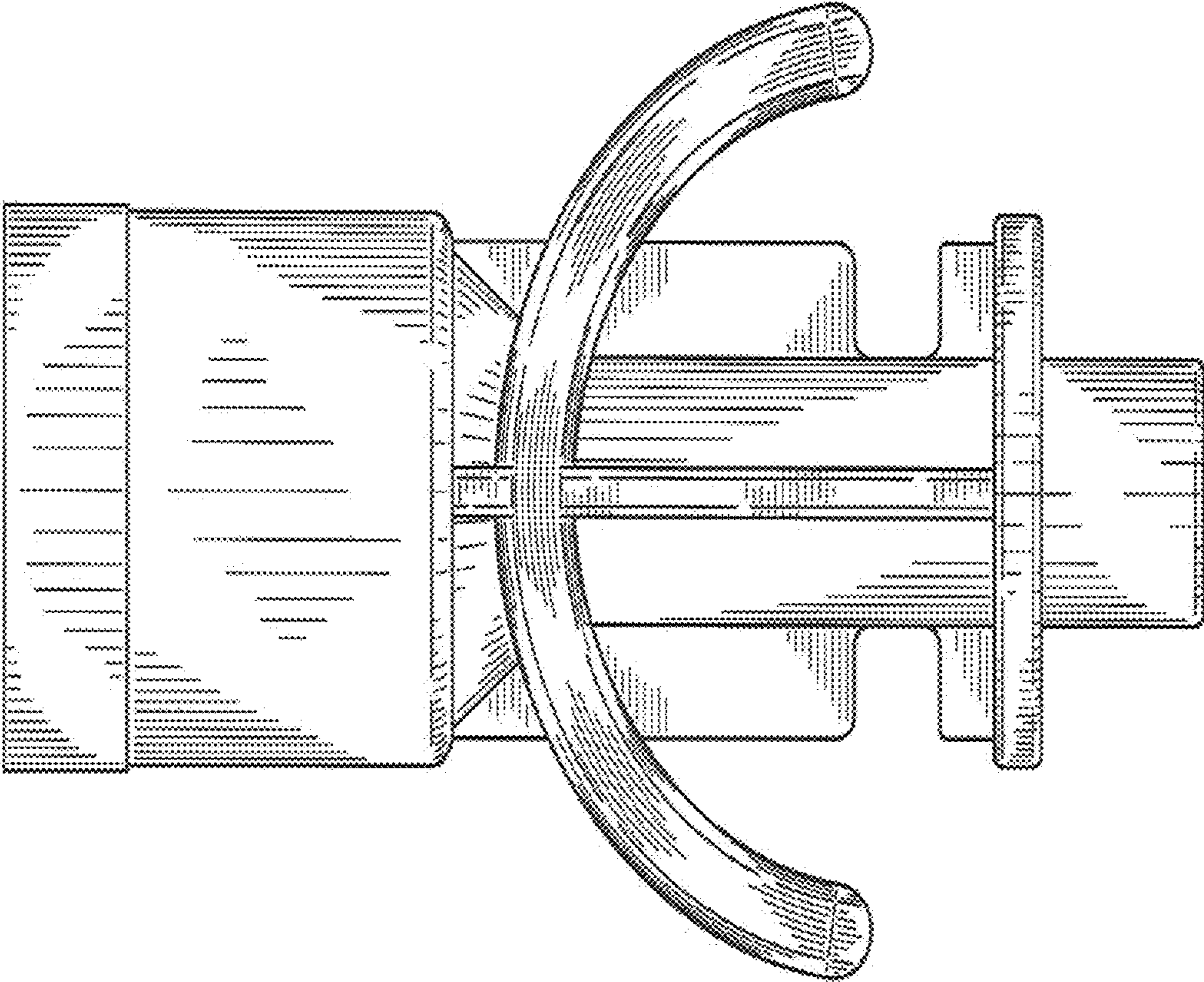

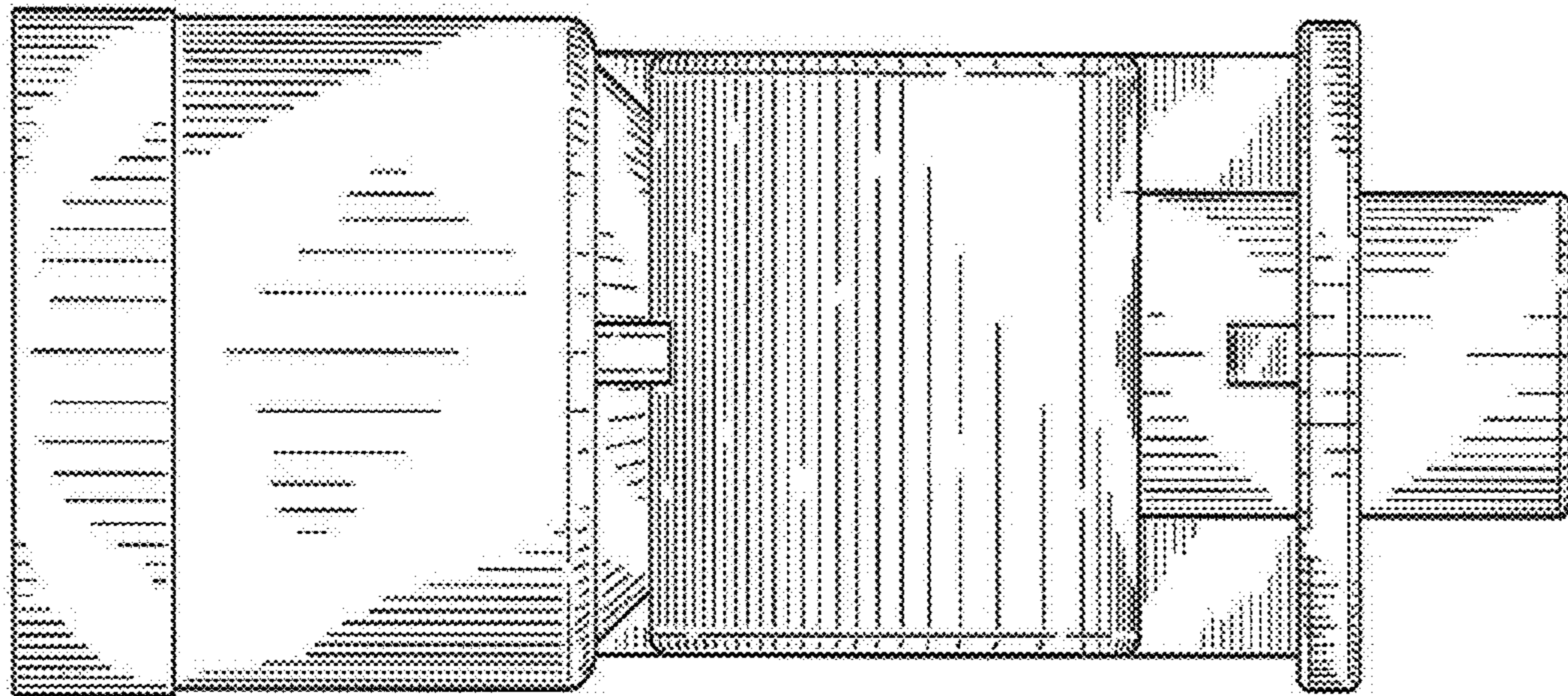

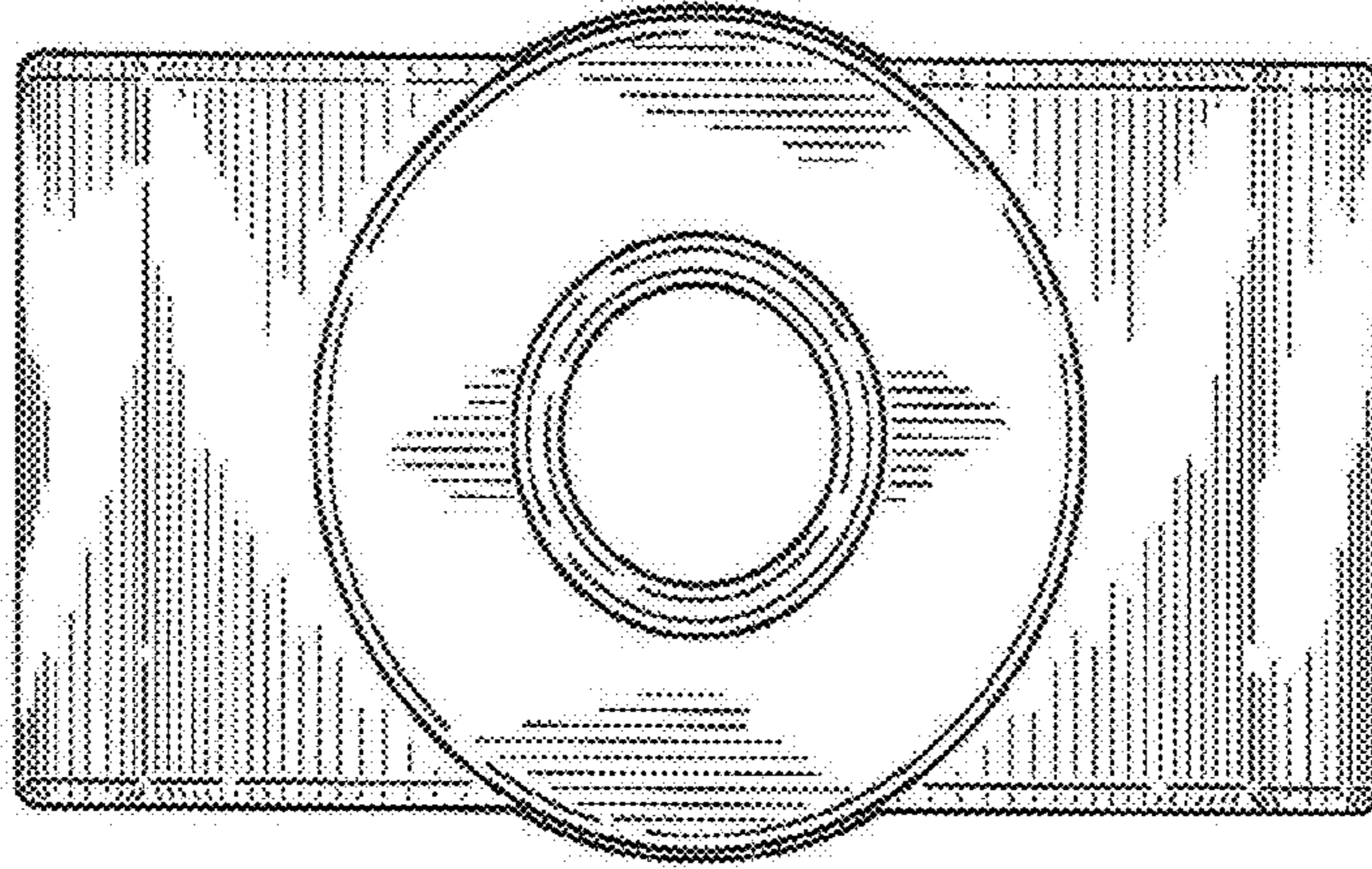

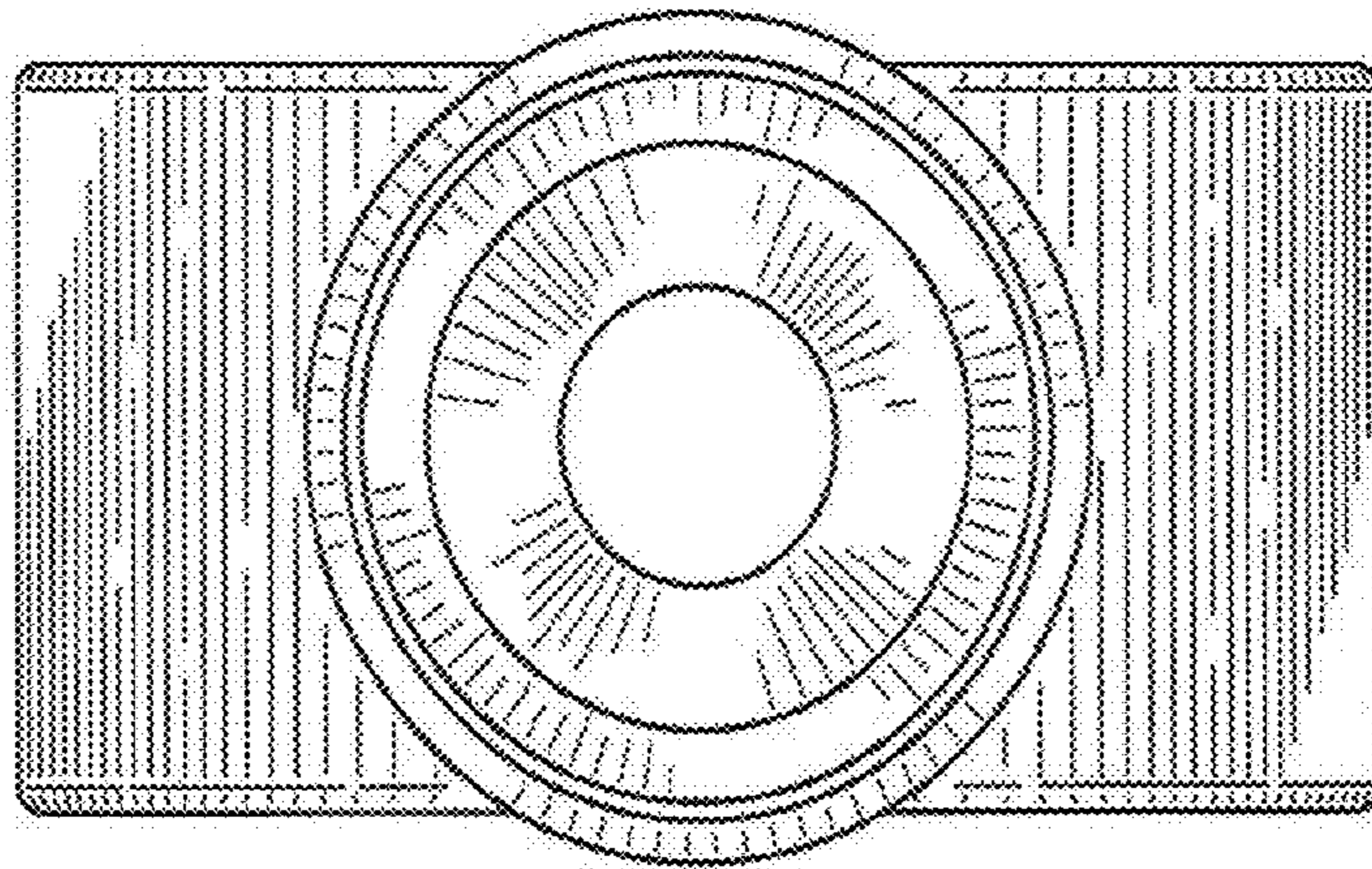
