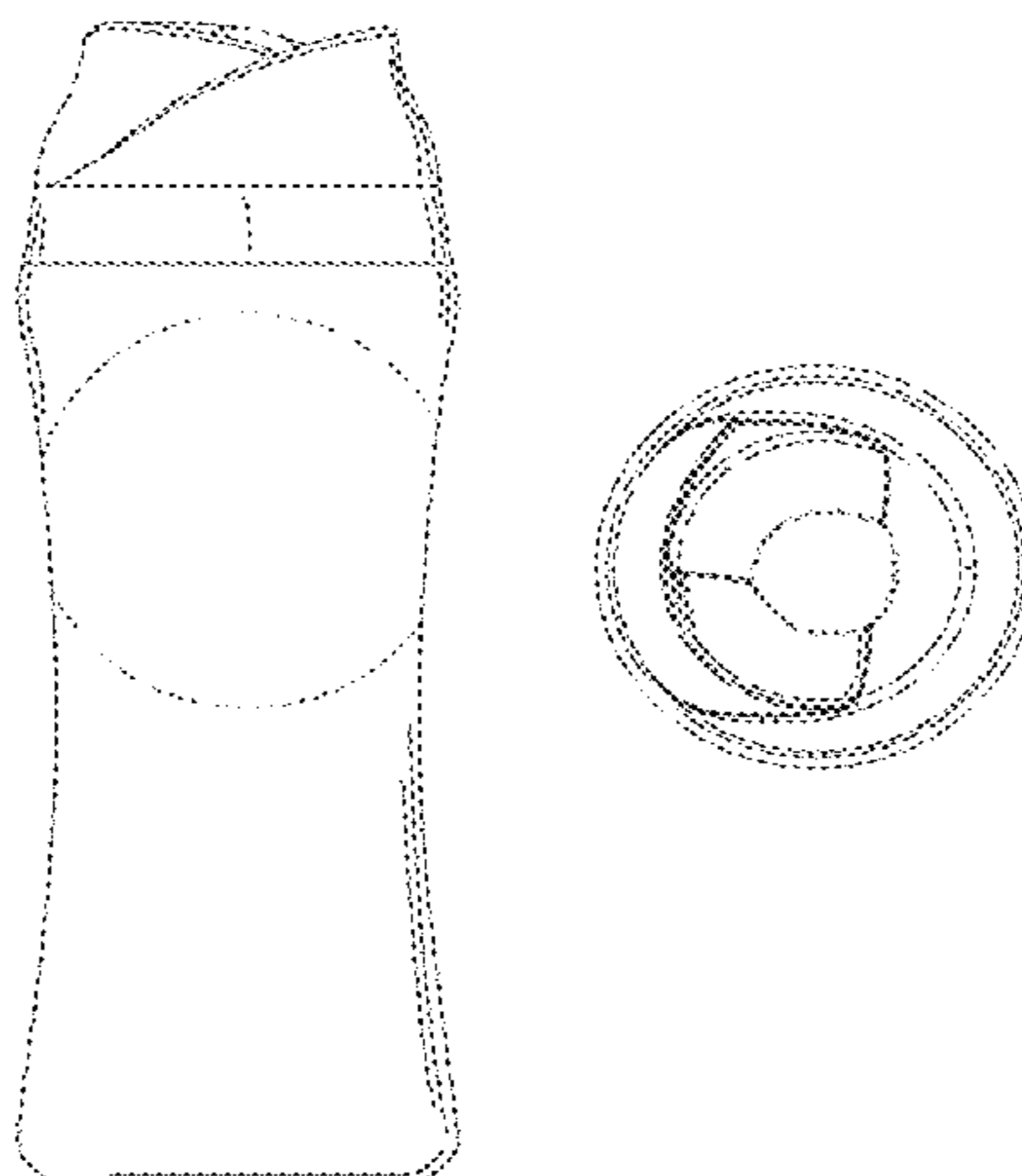
(57) **CLAIM**

The ornamental design for a package for laundry additive, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a package for laundry additive showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings illustrate the portions of the design that form no part of the claim.

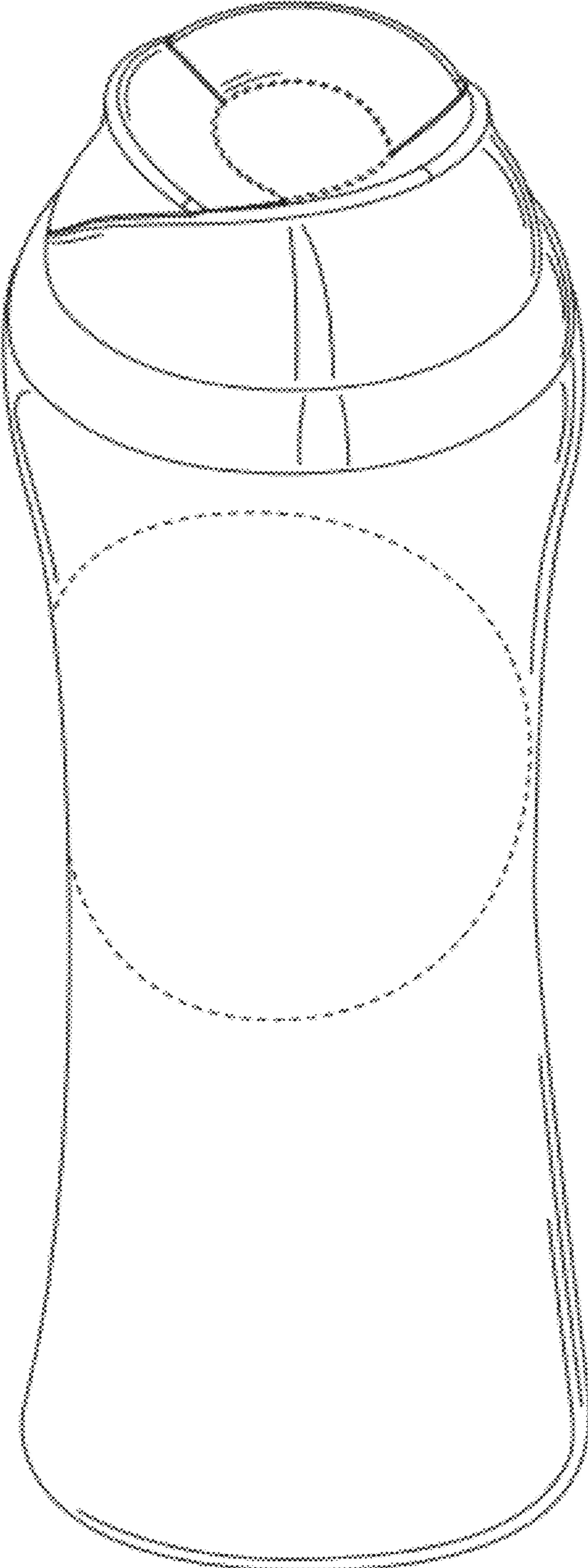

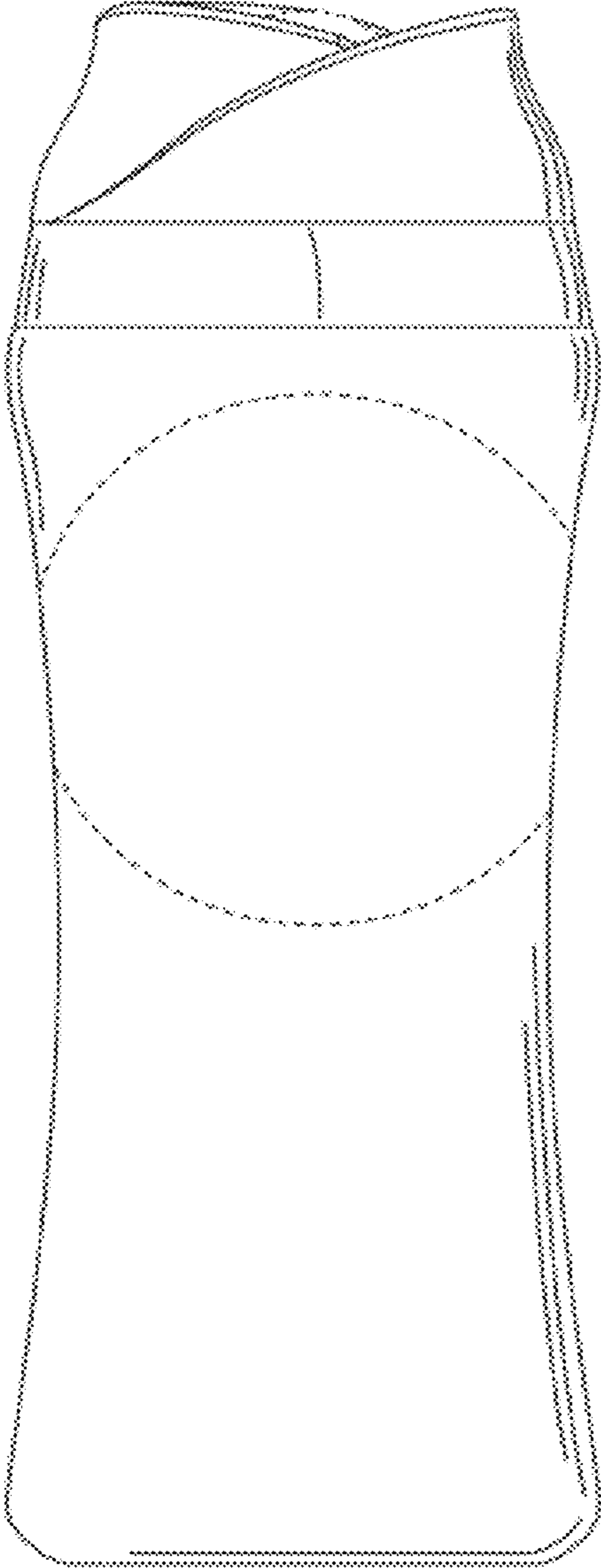

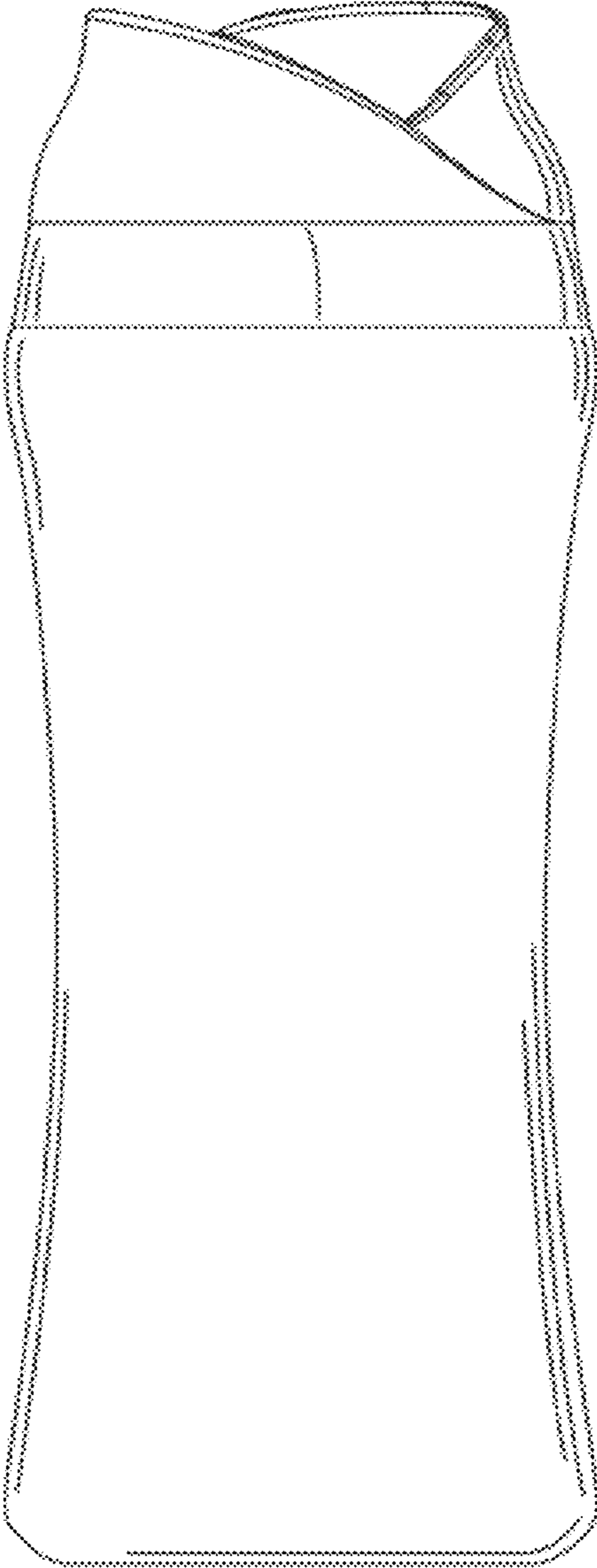

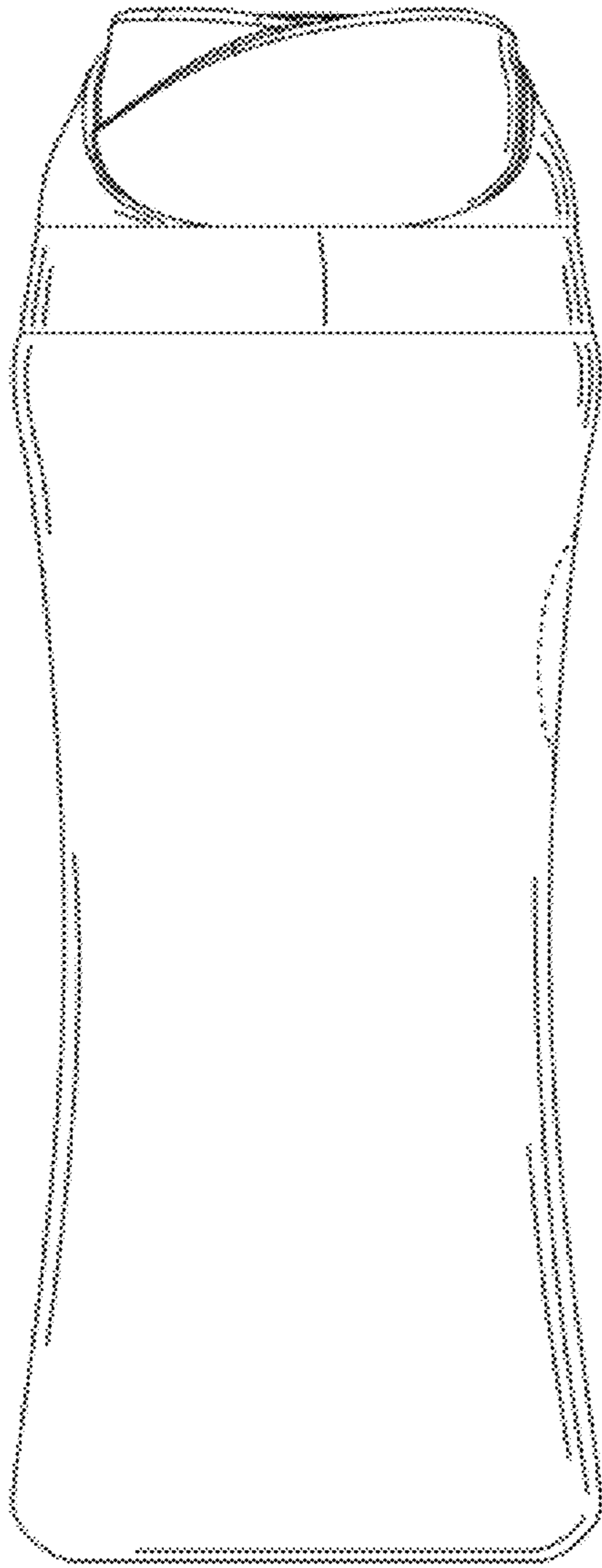

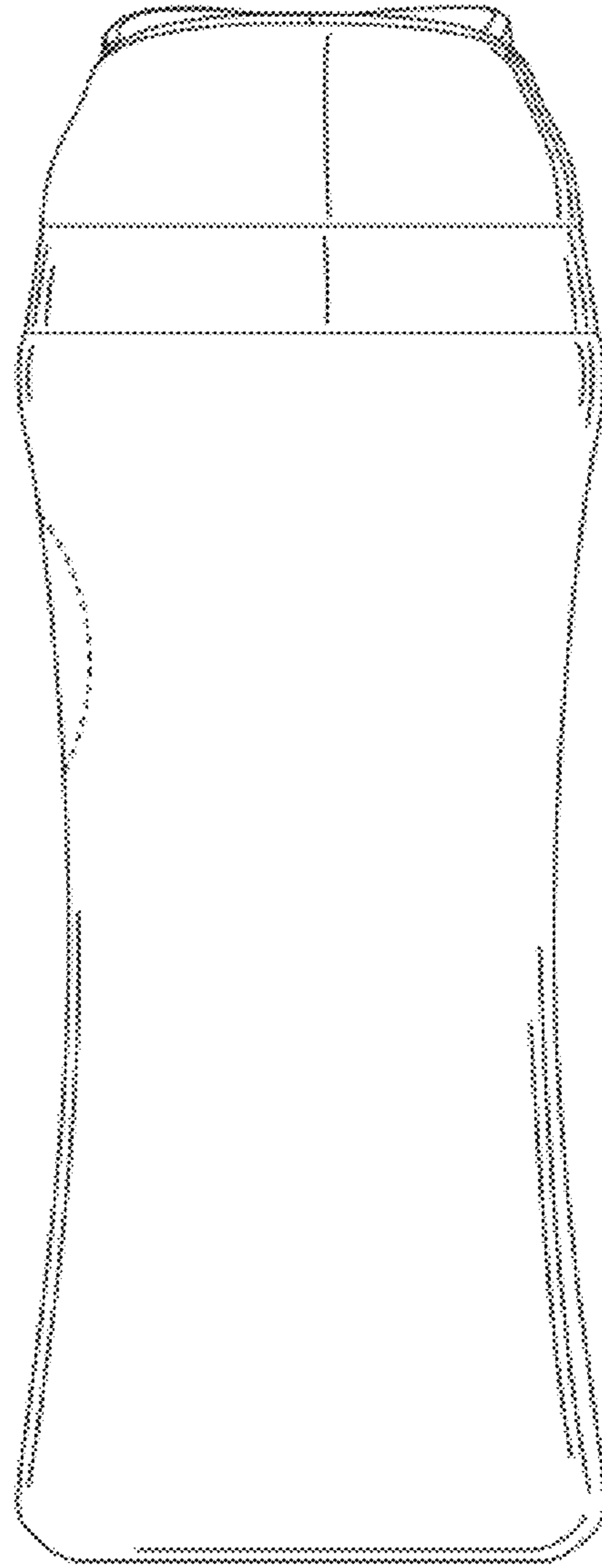

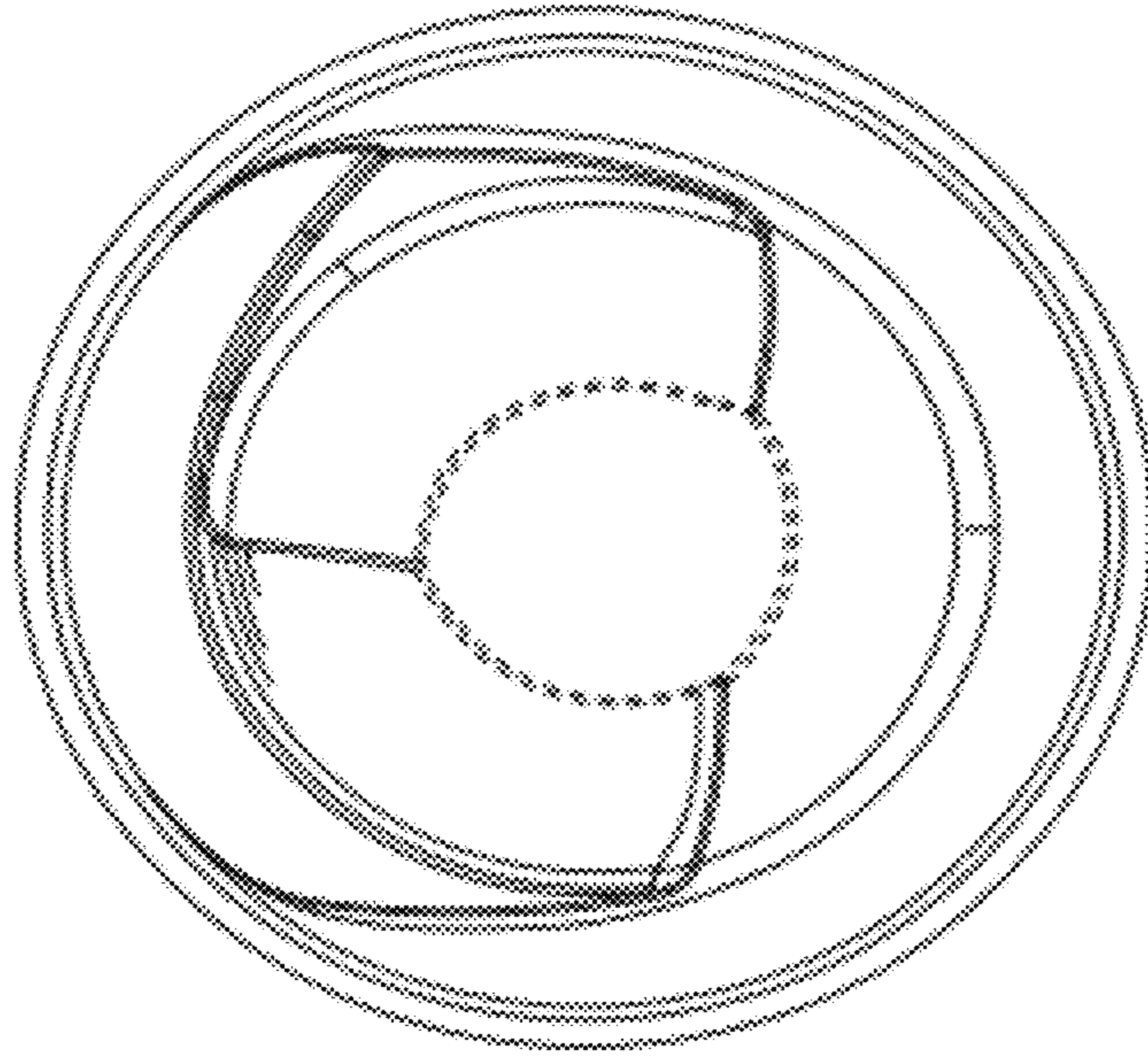

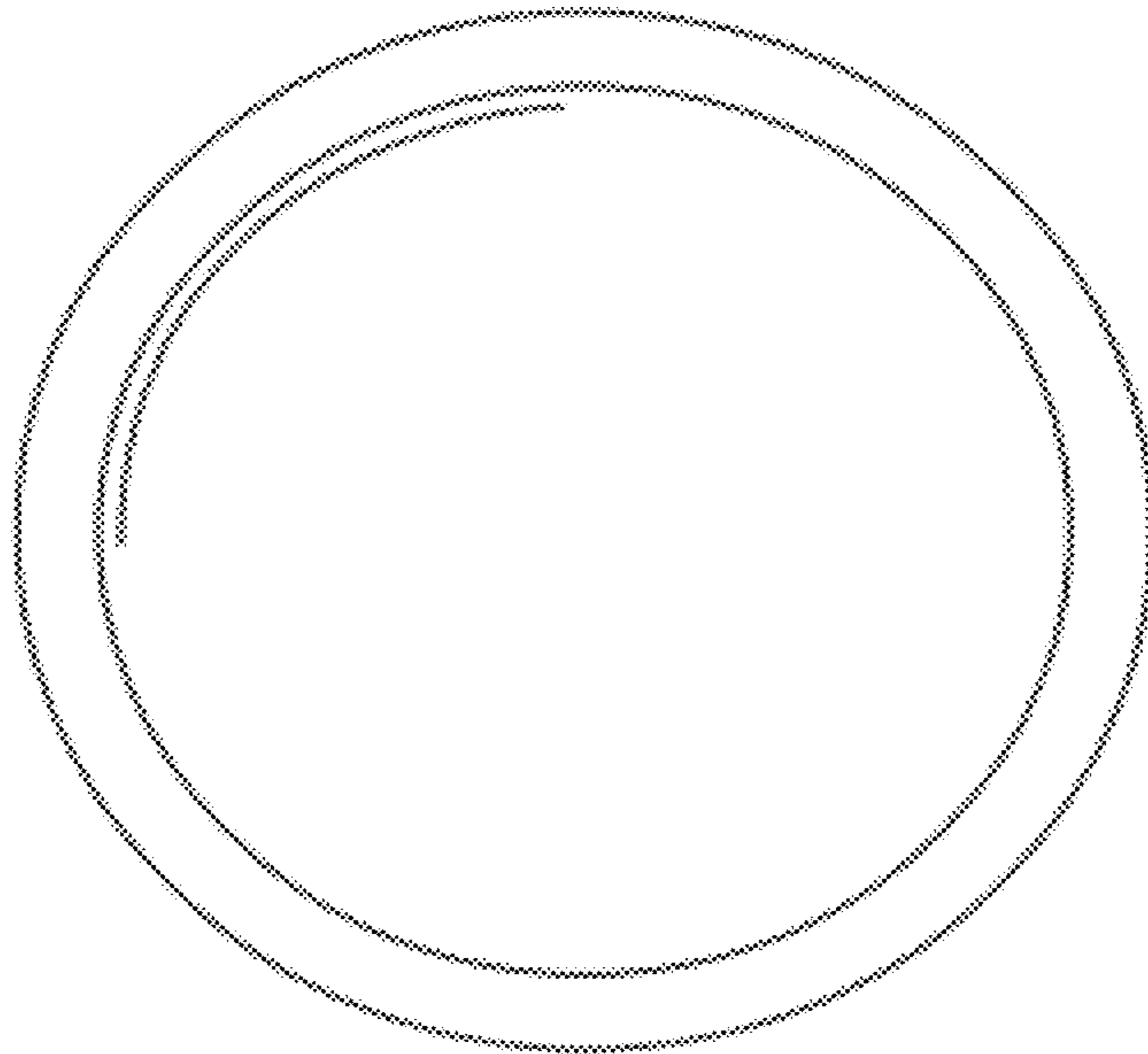
