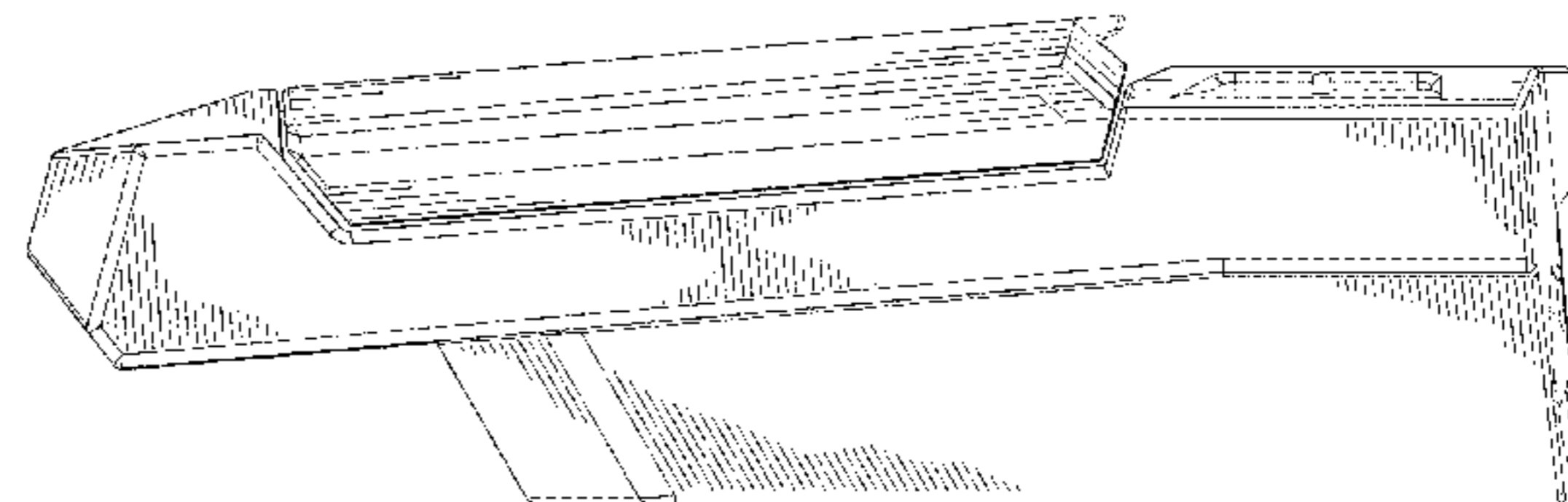
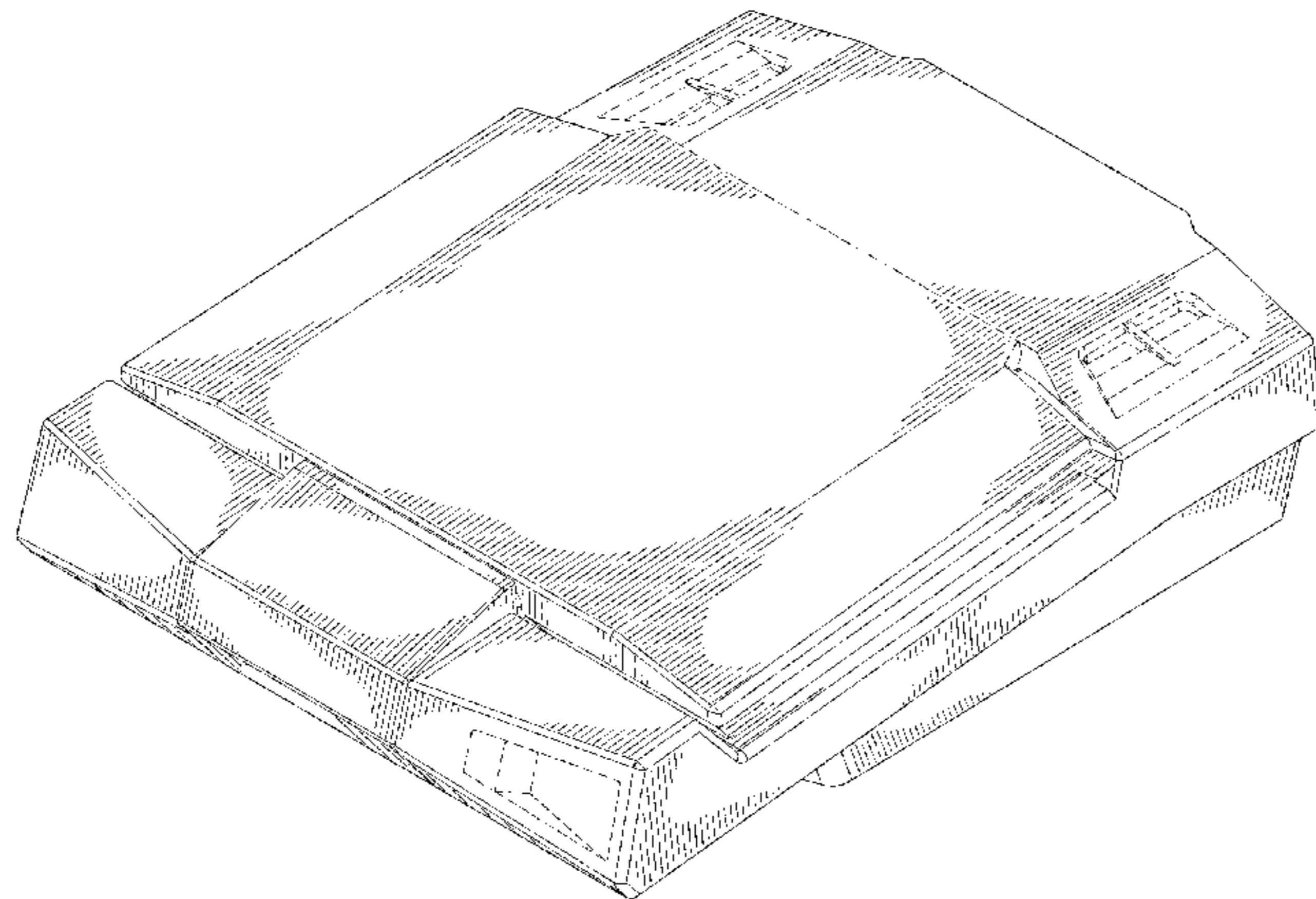
The ornamental design for a radar detector with fold-out display, as shown and described.

DESCRIPTION

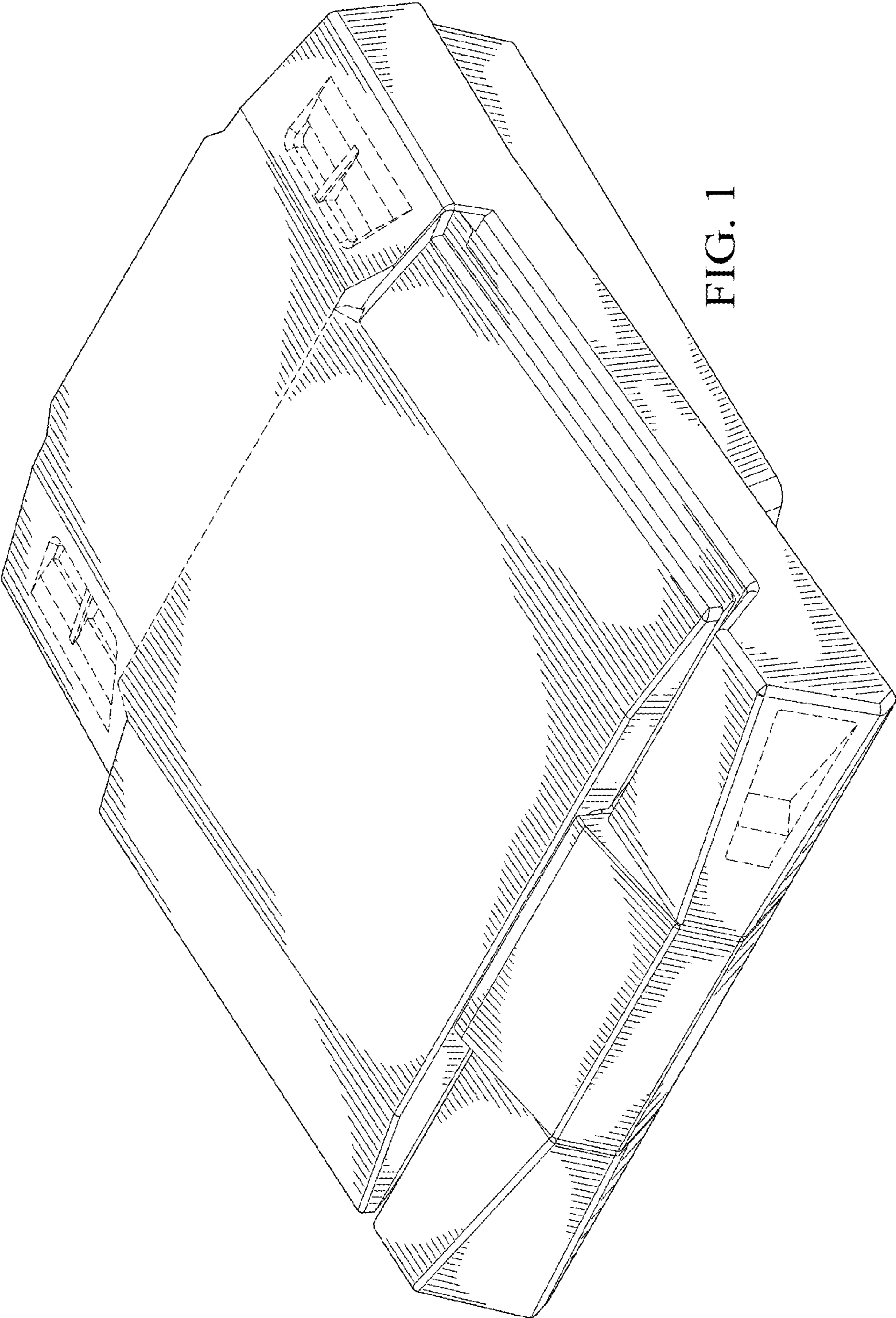

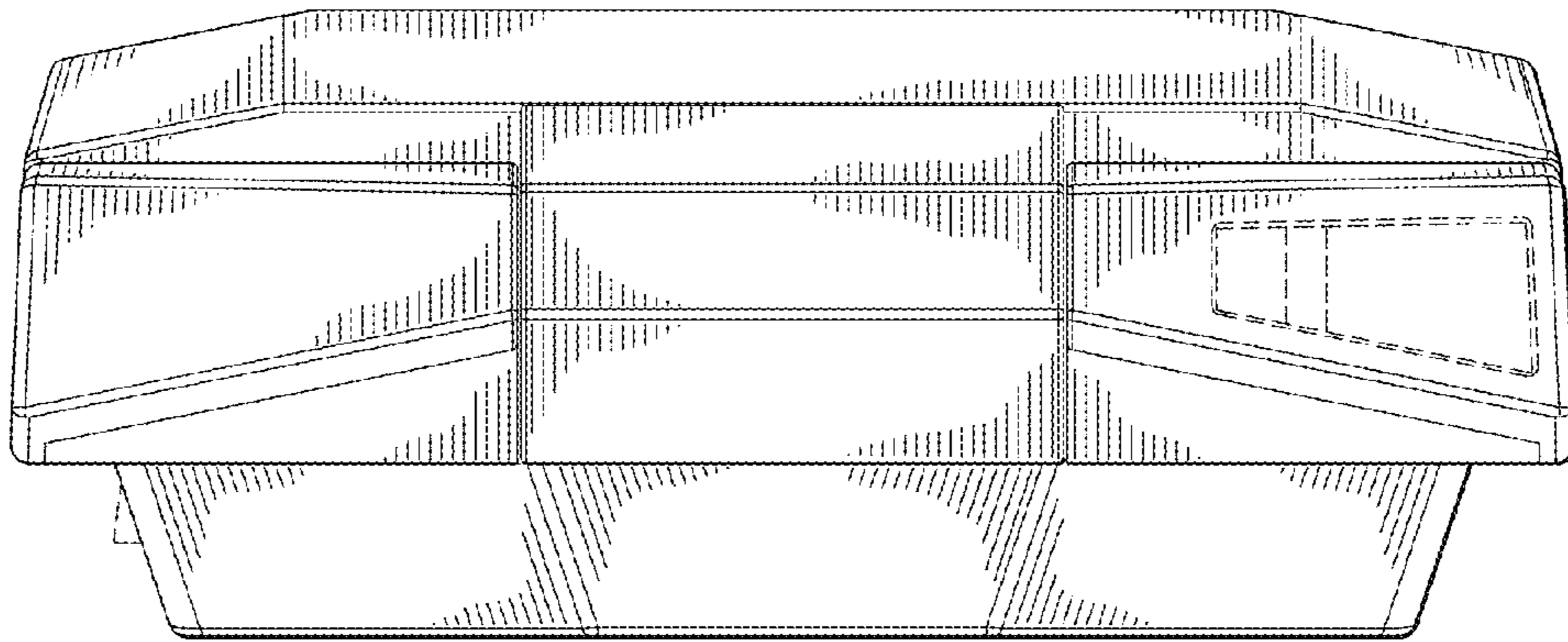

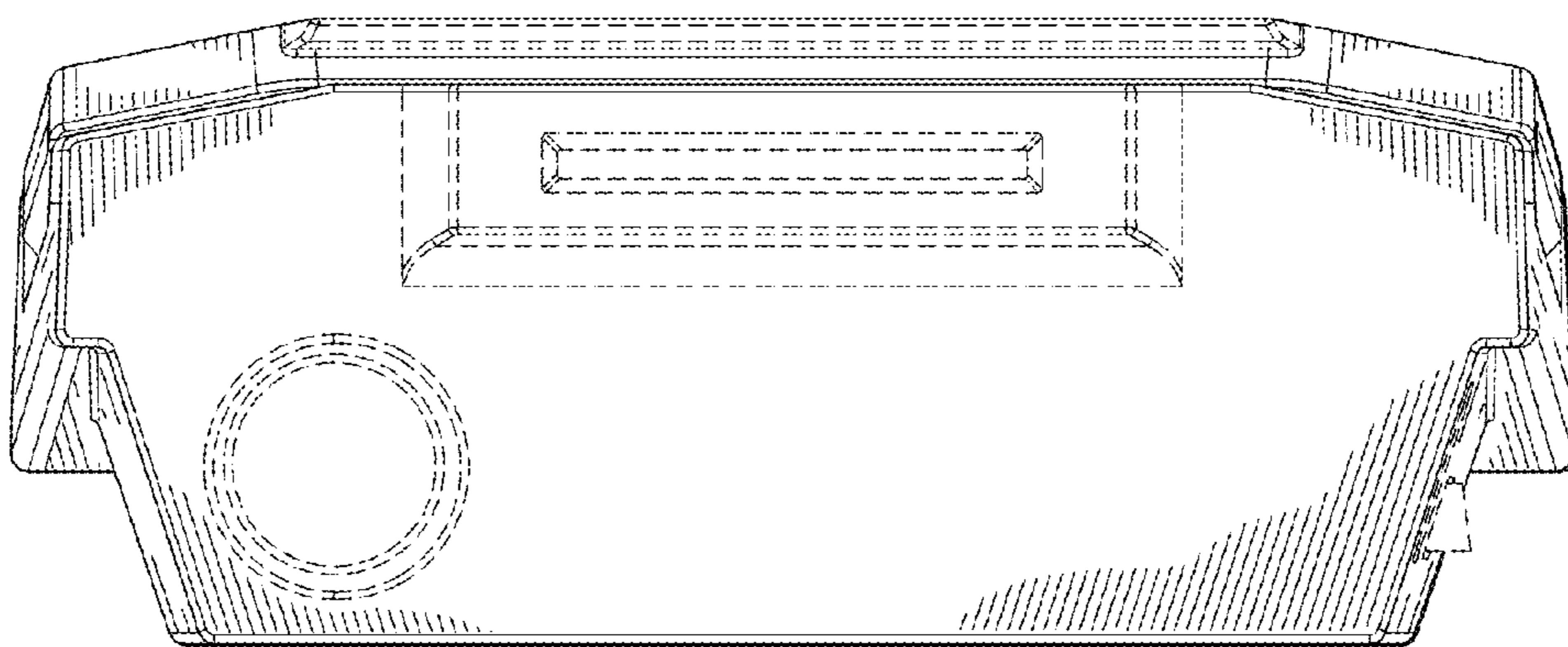

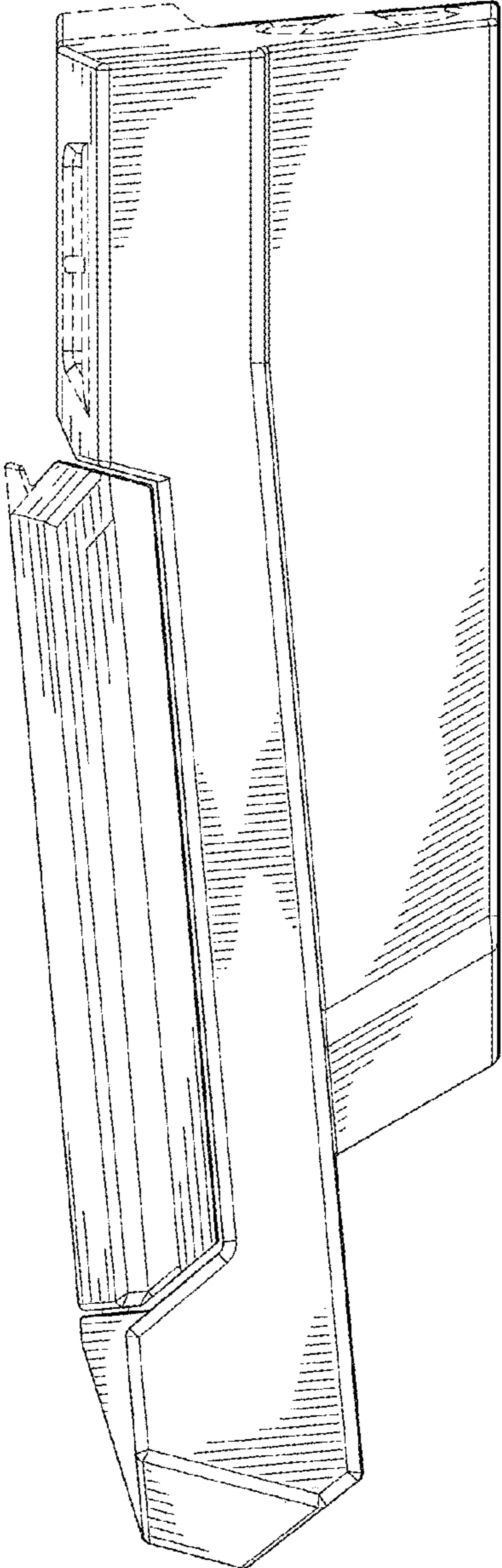

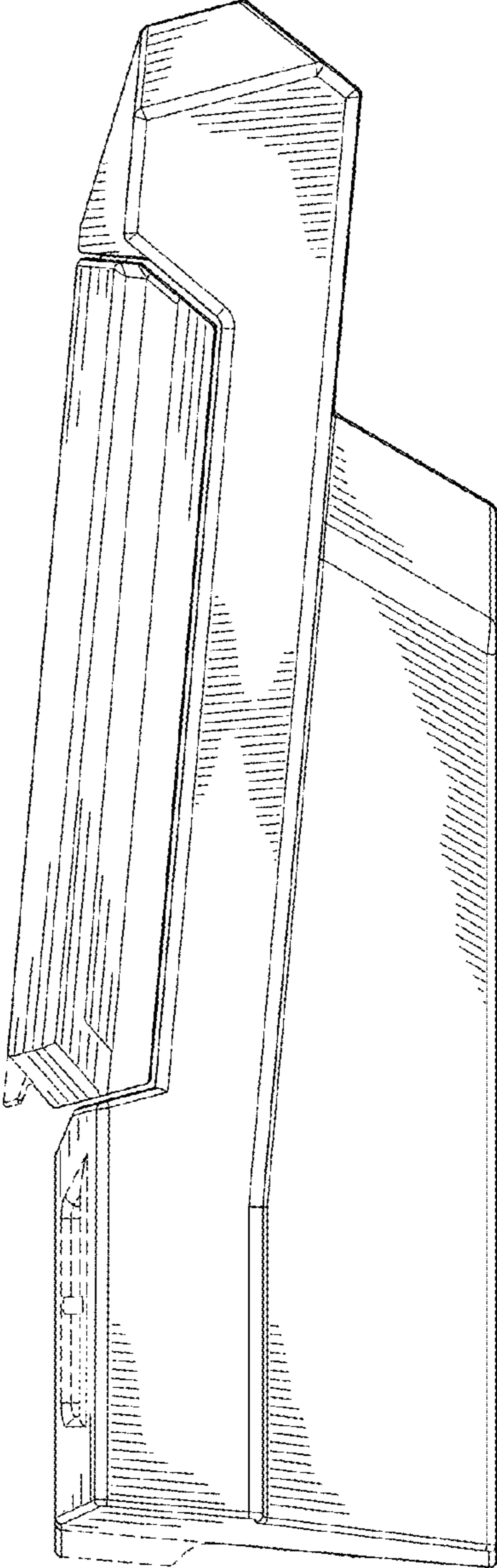

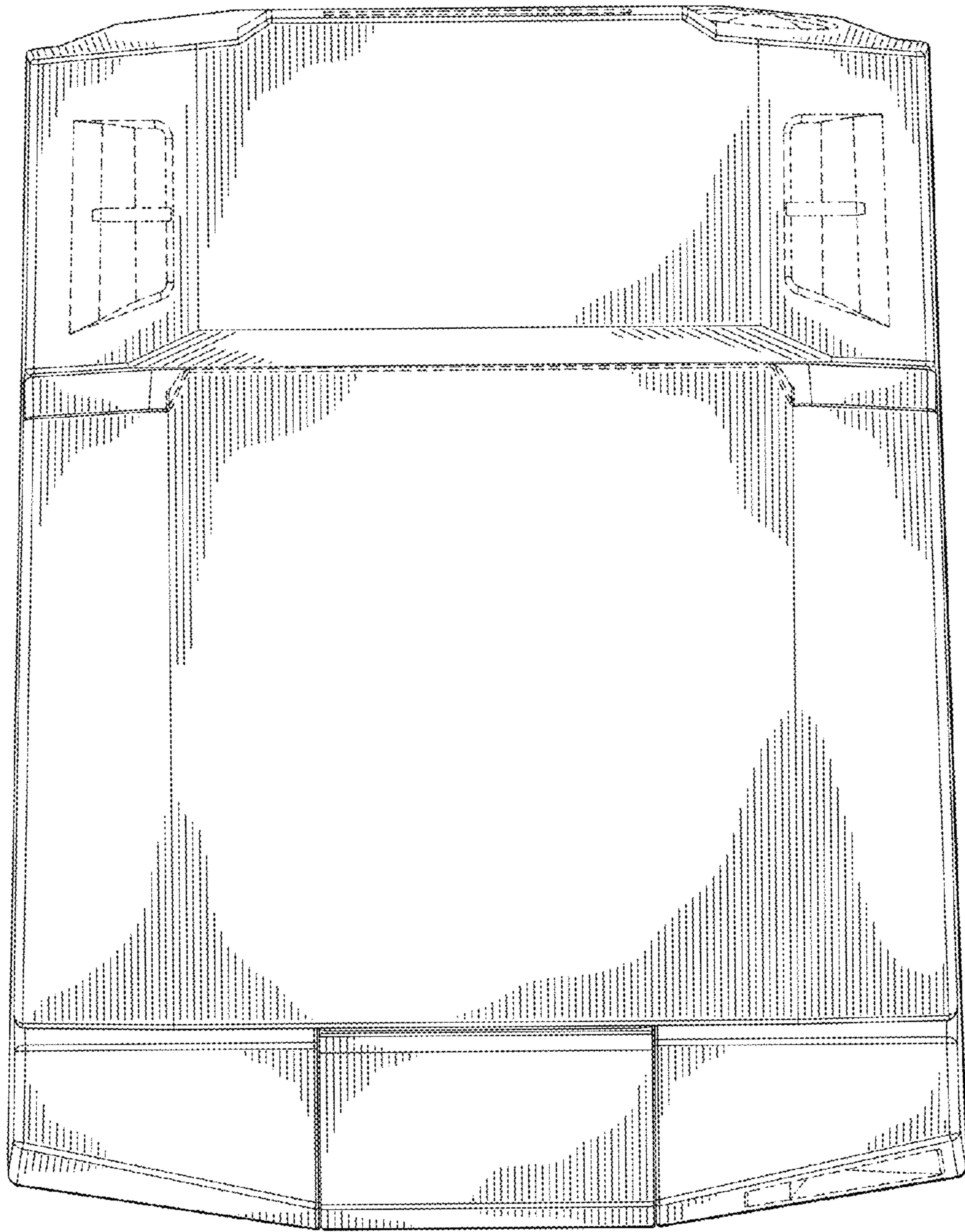

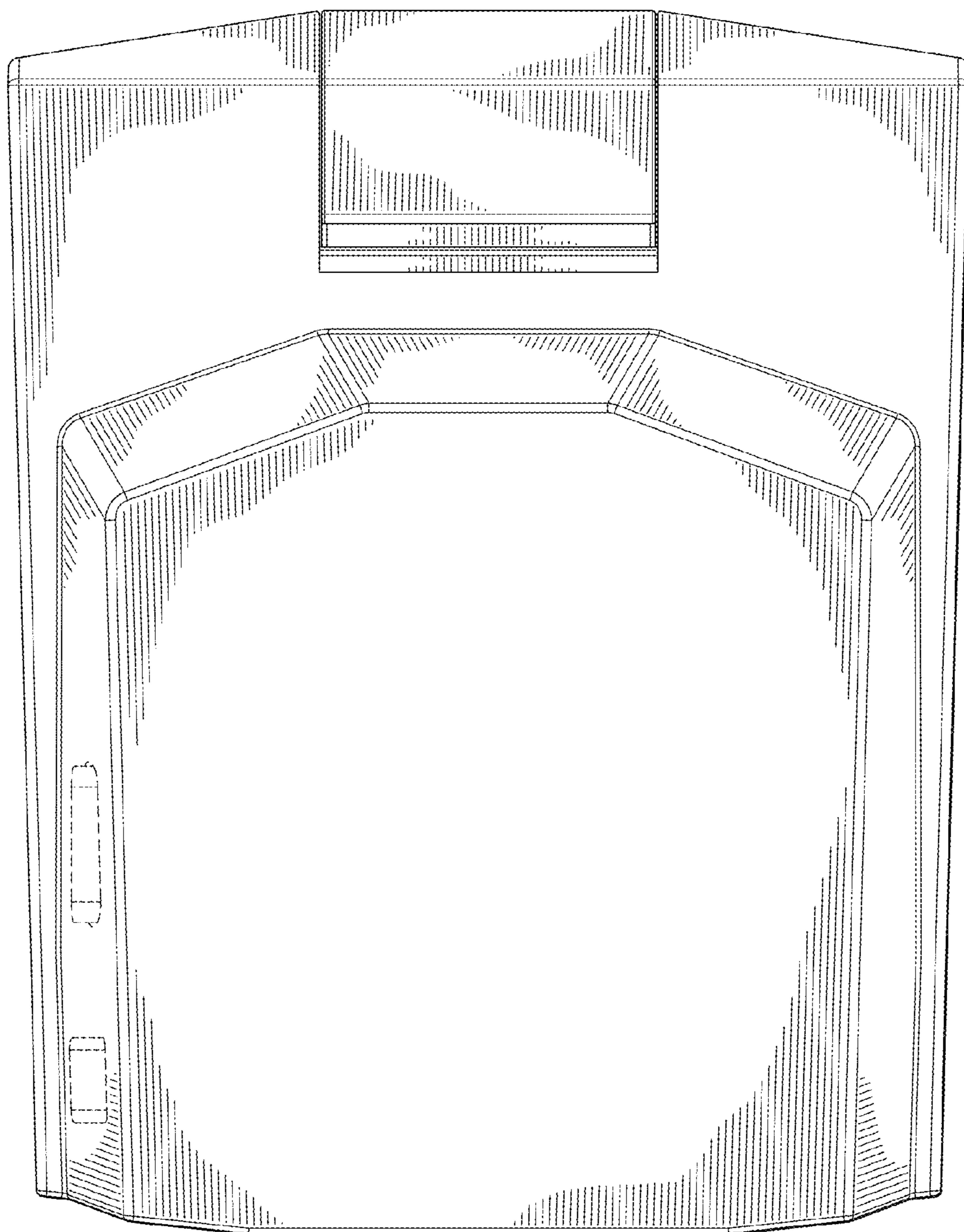

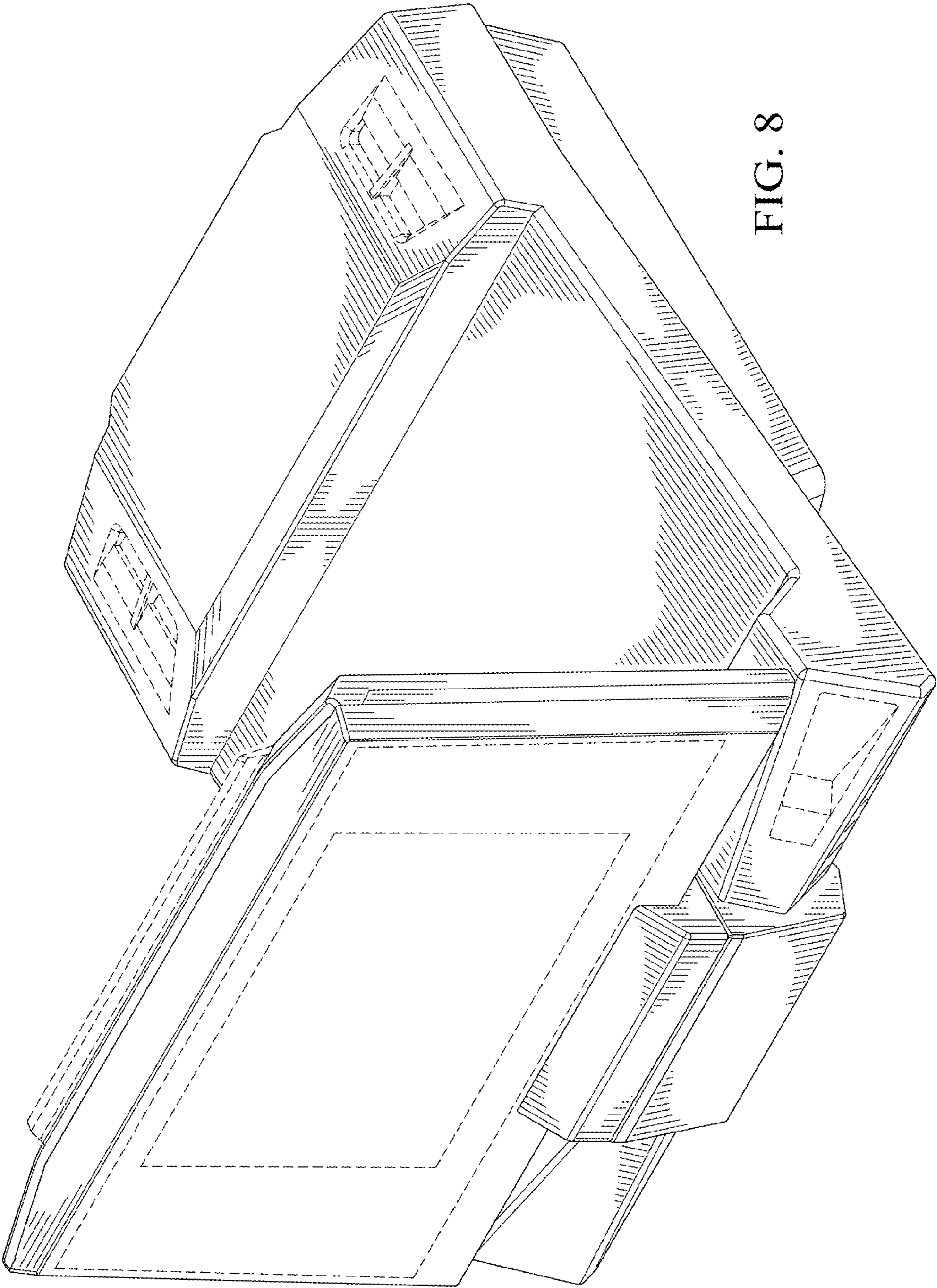

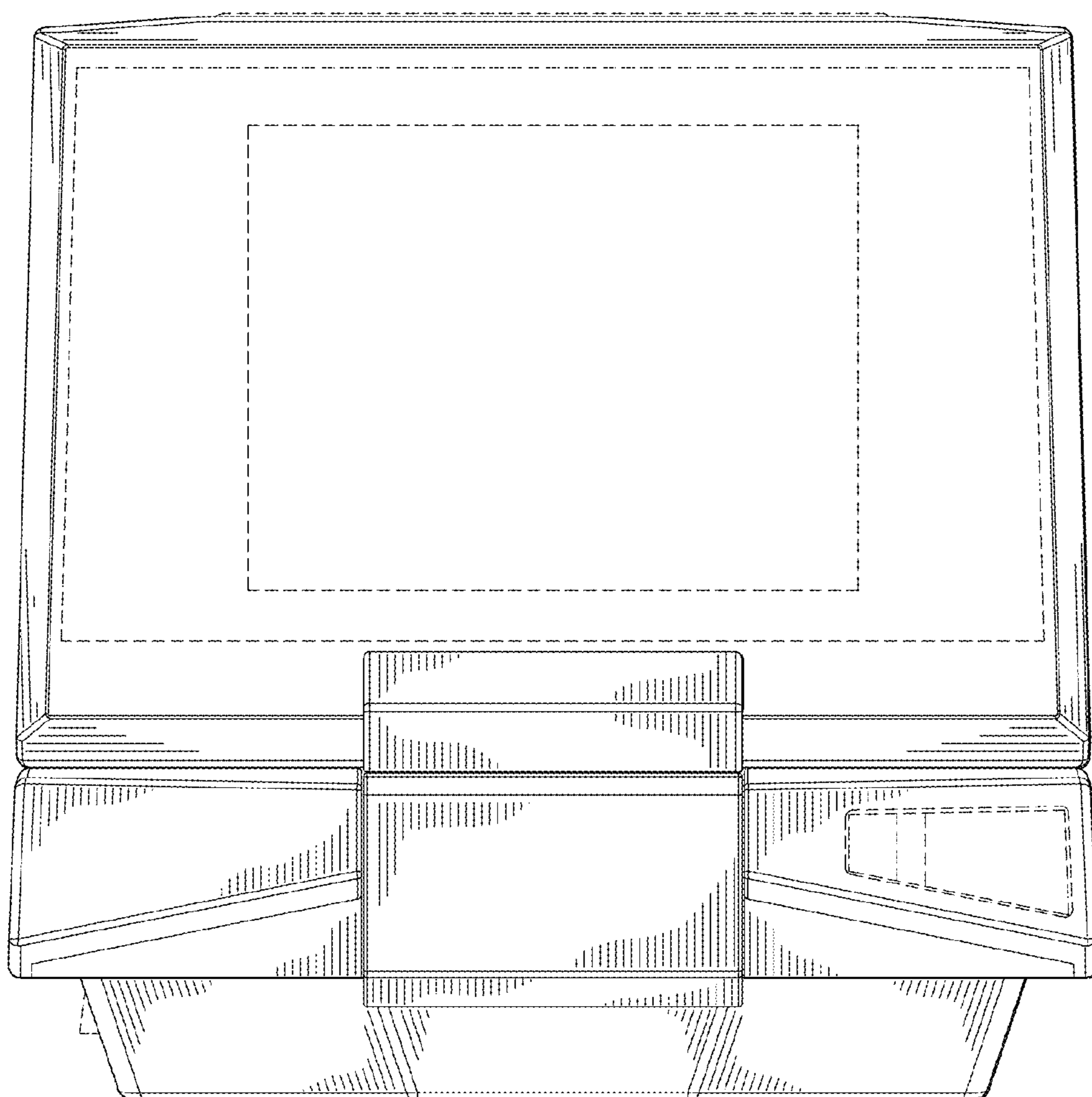

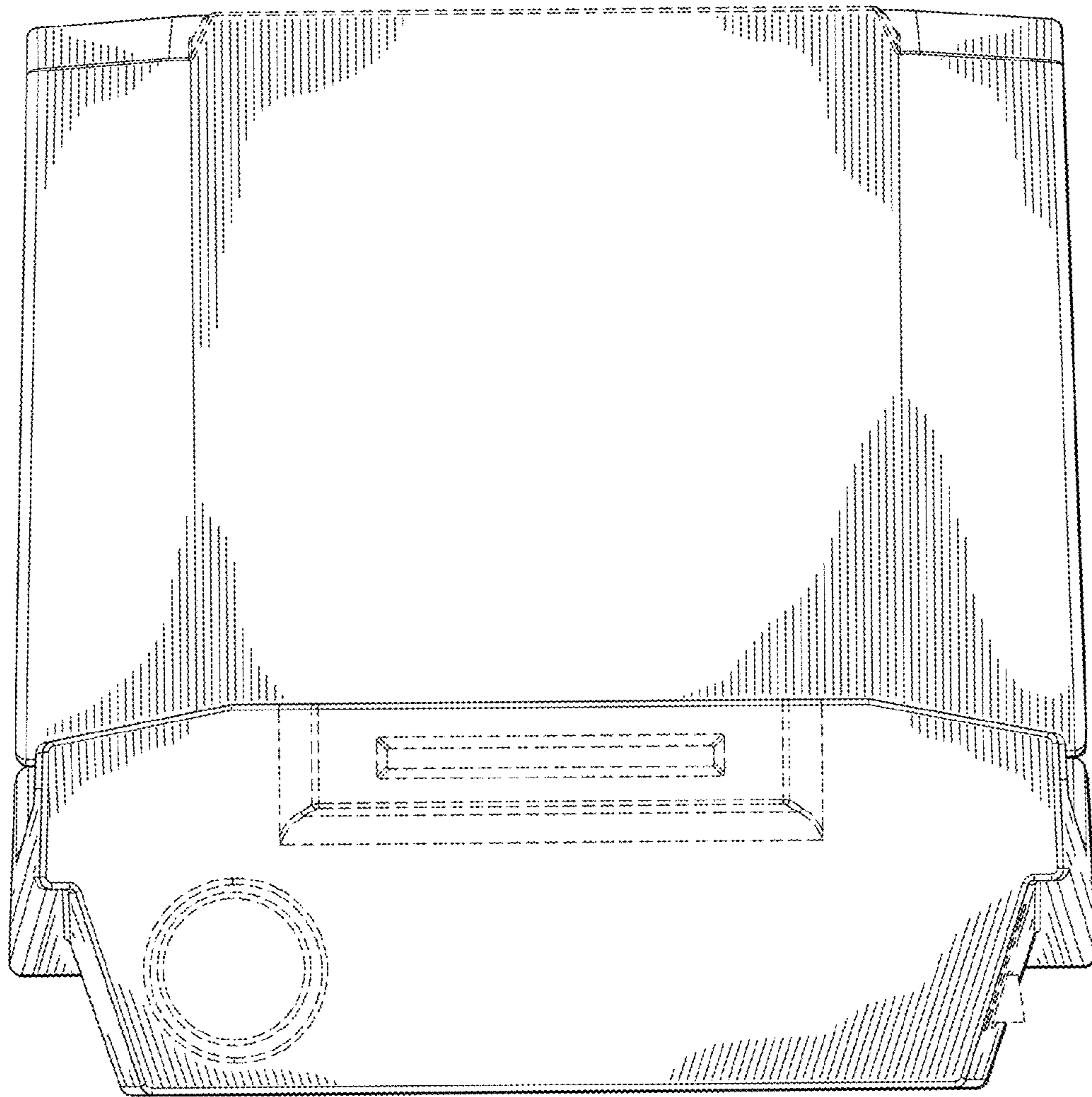

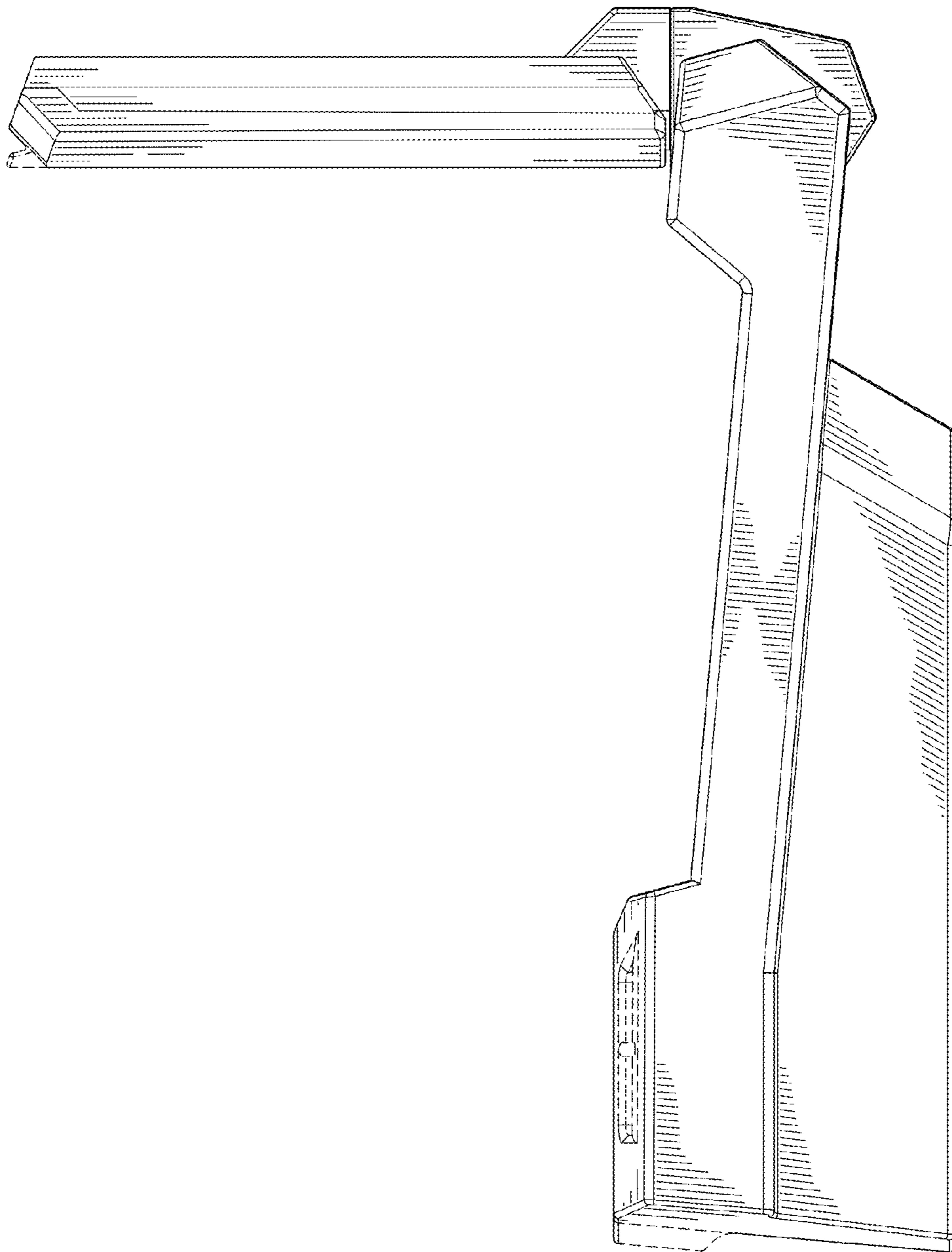

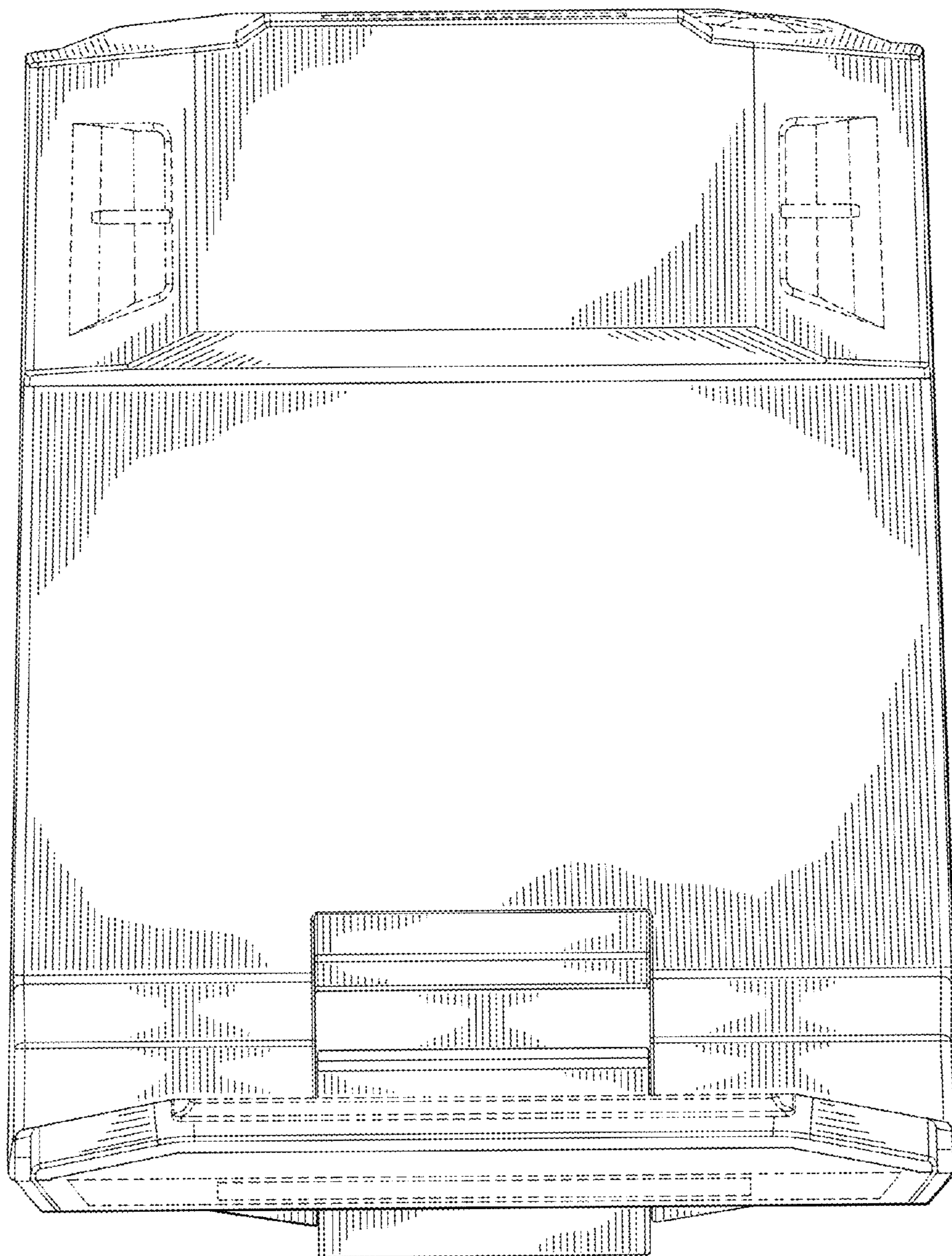

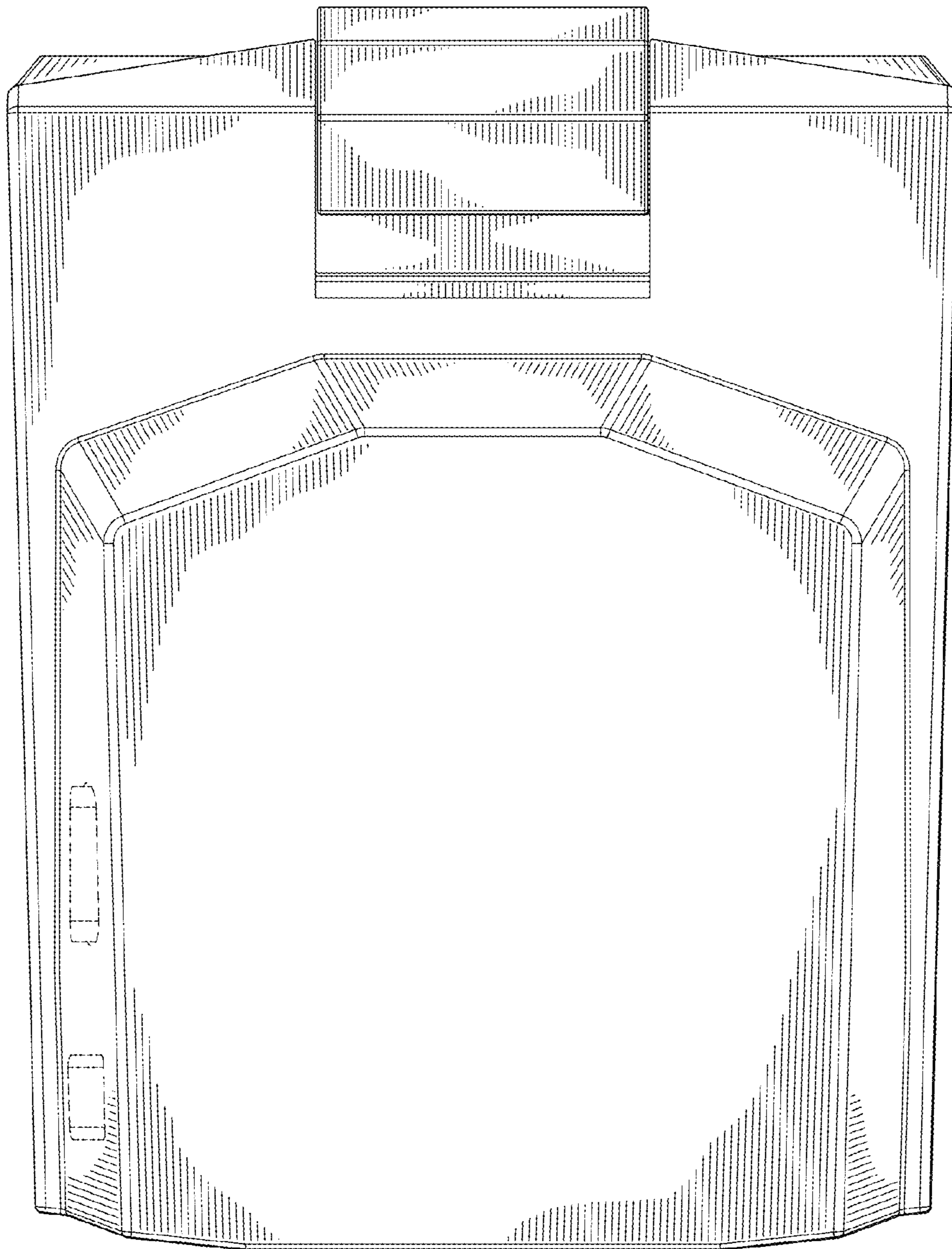
