DESCRIPTION

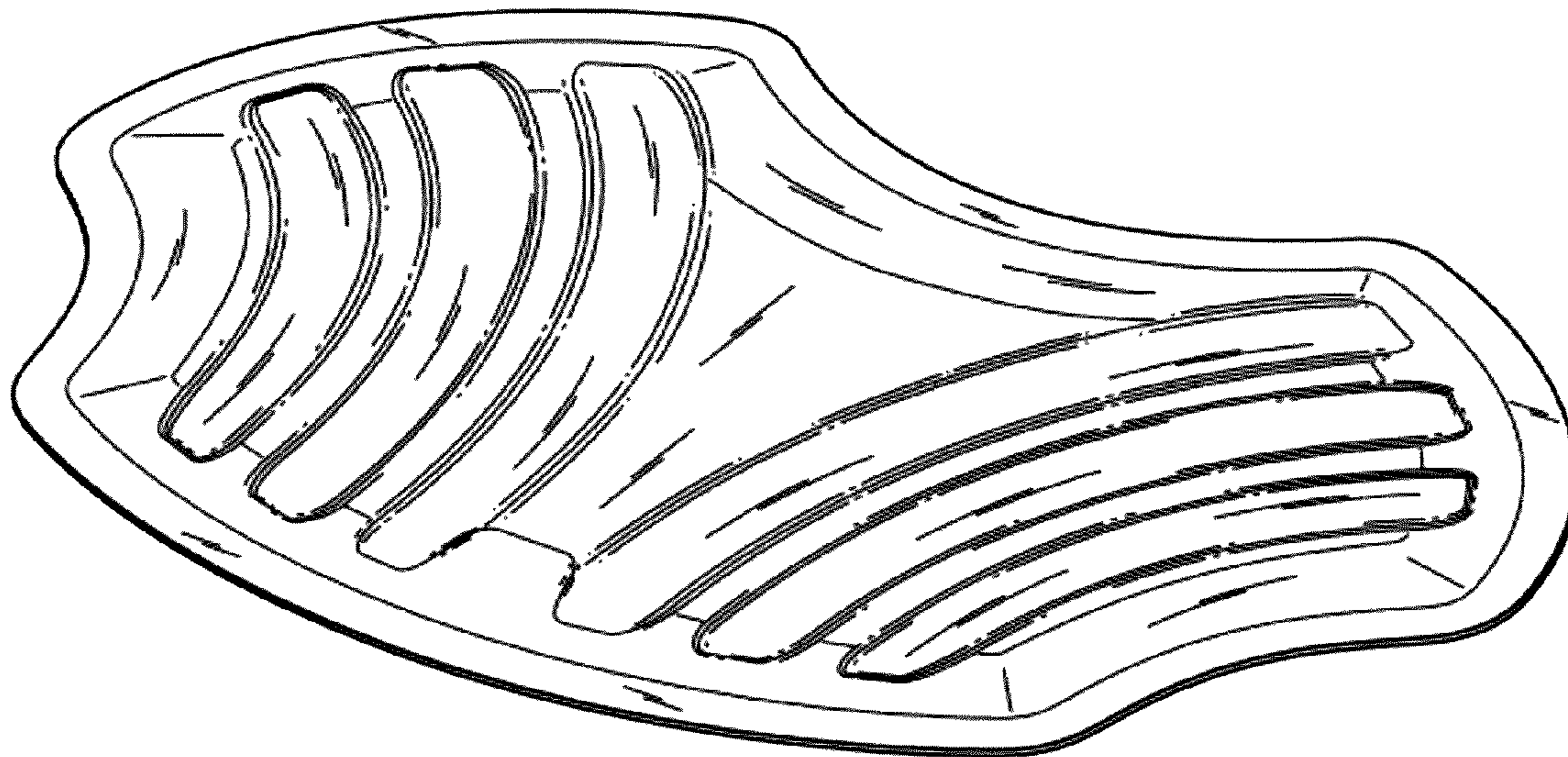
FIG. 1 is an isometric view of one embodiment a achilles blister dressing;

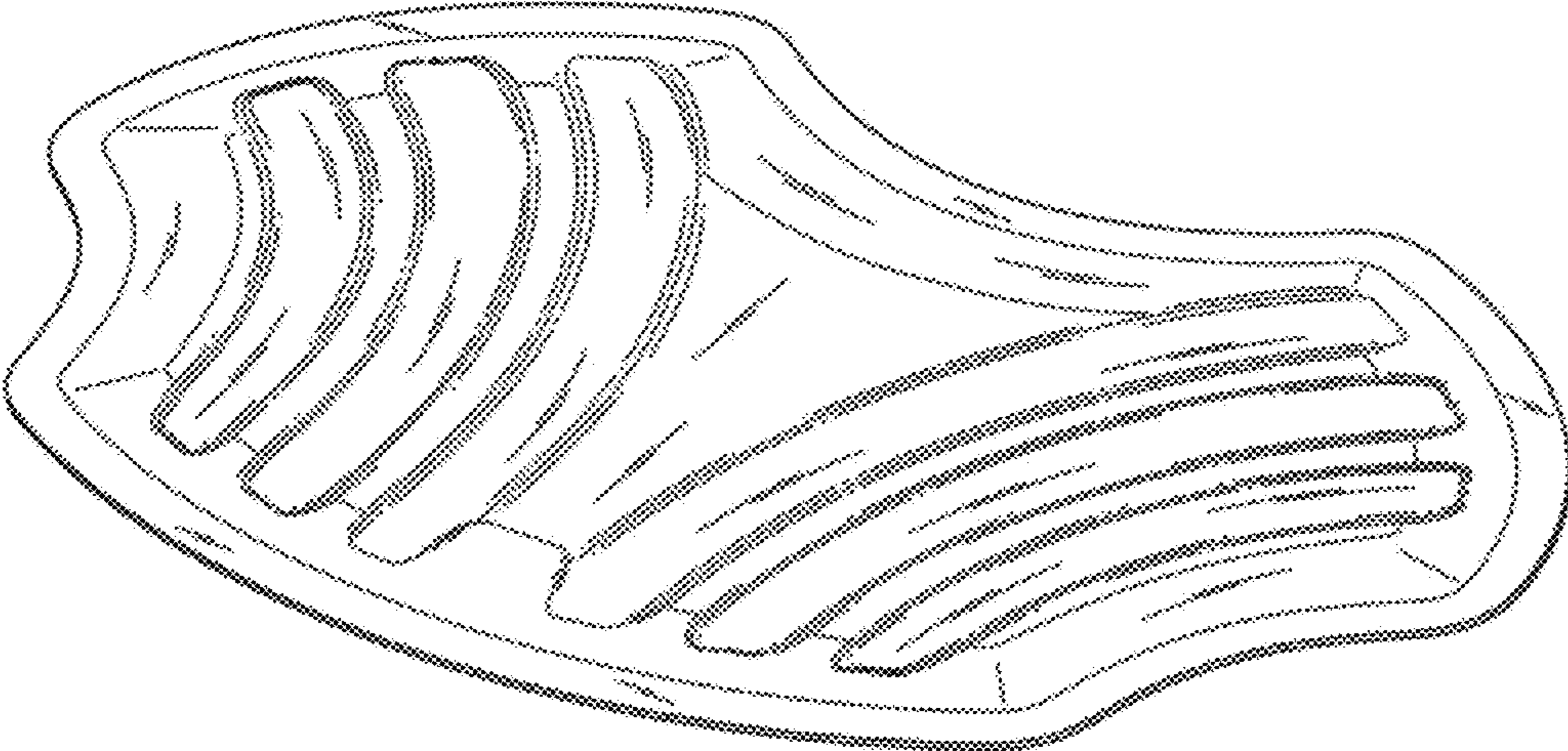

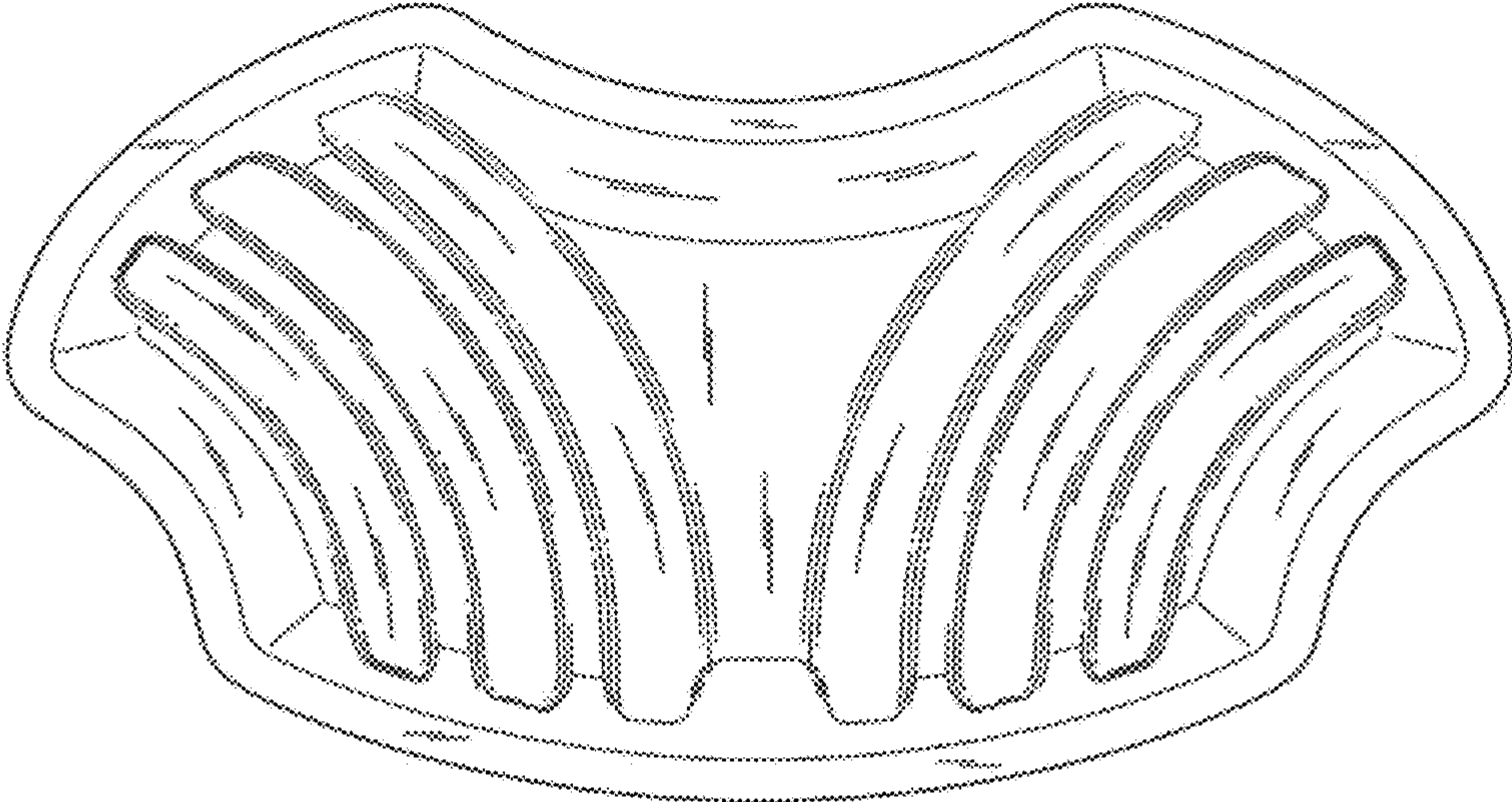

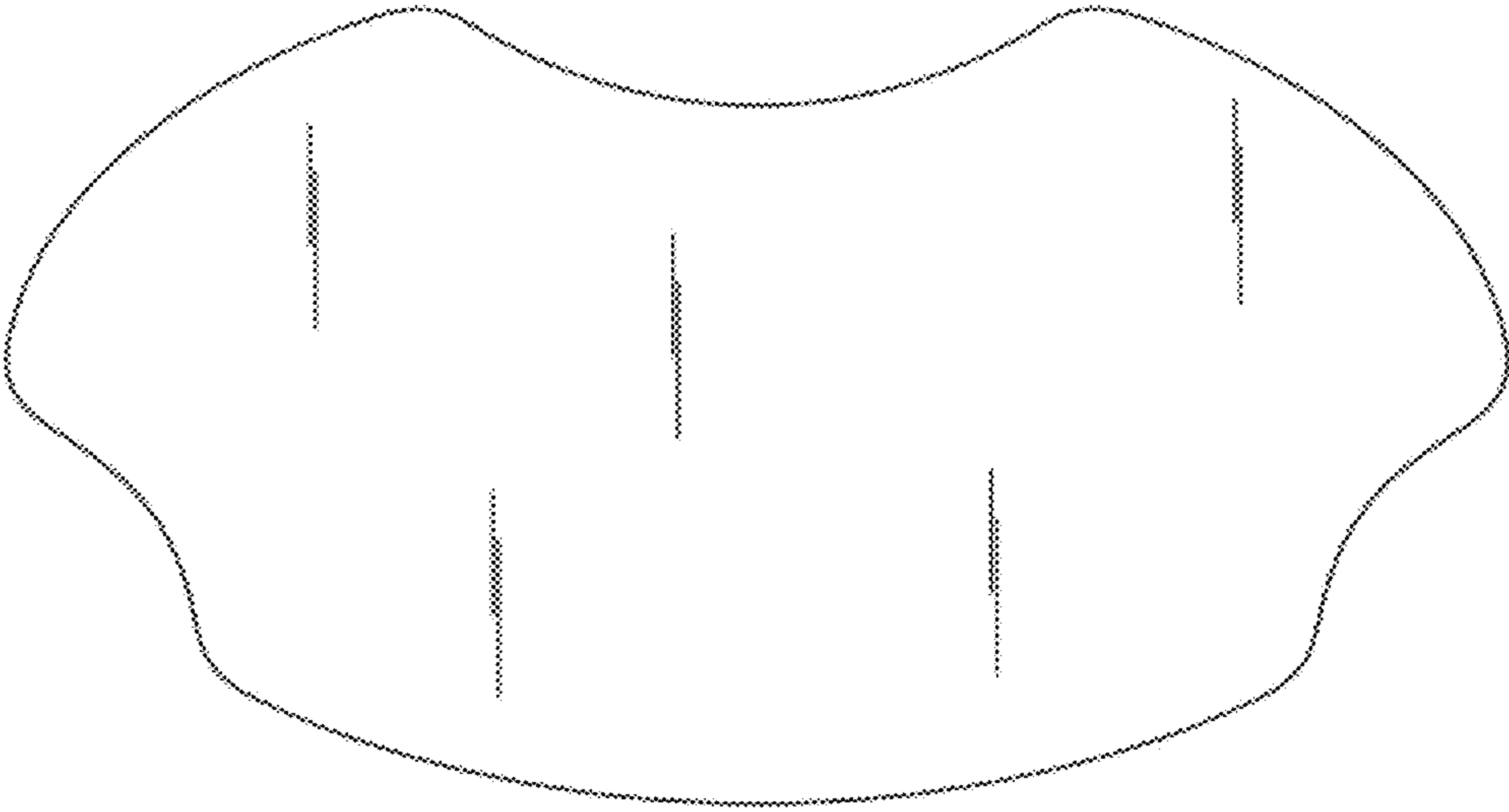

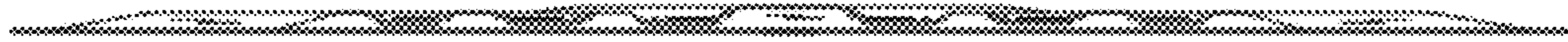
