(57) **CLAIM**

The ornamental design for tanning booth, as shown and described.

DESCRIPTION

FIG. 1 is a left and front perspective view of a tanning booth, according to the present invention;

FIG. 2 is a right and front perspective view thereof;

FIG. 3 is a front perspective view thereof;

FIG. 4 is a rear perspective view thereof;

FIG. 5 is a left perspective view thereof;

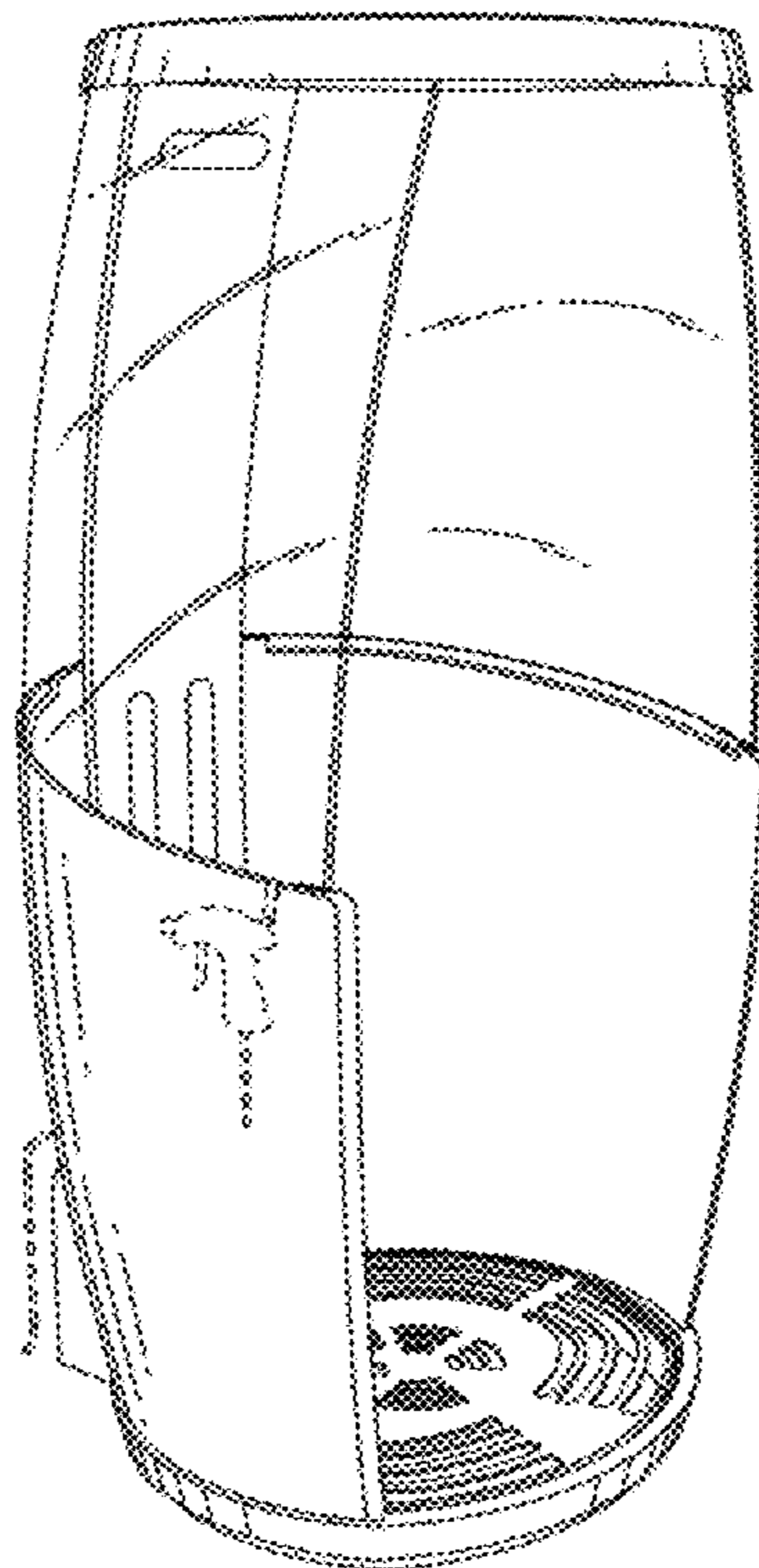
FIG. 6 is a right perspective view thereof;

FIG. 7 is a right and rear perspective view thereof; and,

FIG. 8 is a front perspective view of a first alternative design of a tanning booth having features identical to the tanning booth shown in FIGS. 1, 2, and 4-7, with the exception of the design of the grate located on the floor of the first alternative design of the tanning booth of FIG. 8.

The broken lines in the drawings form no part of the claimed design. The top and bottom views of the tanning booth form no part of the claimed design and are omitted from the drawings.

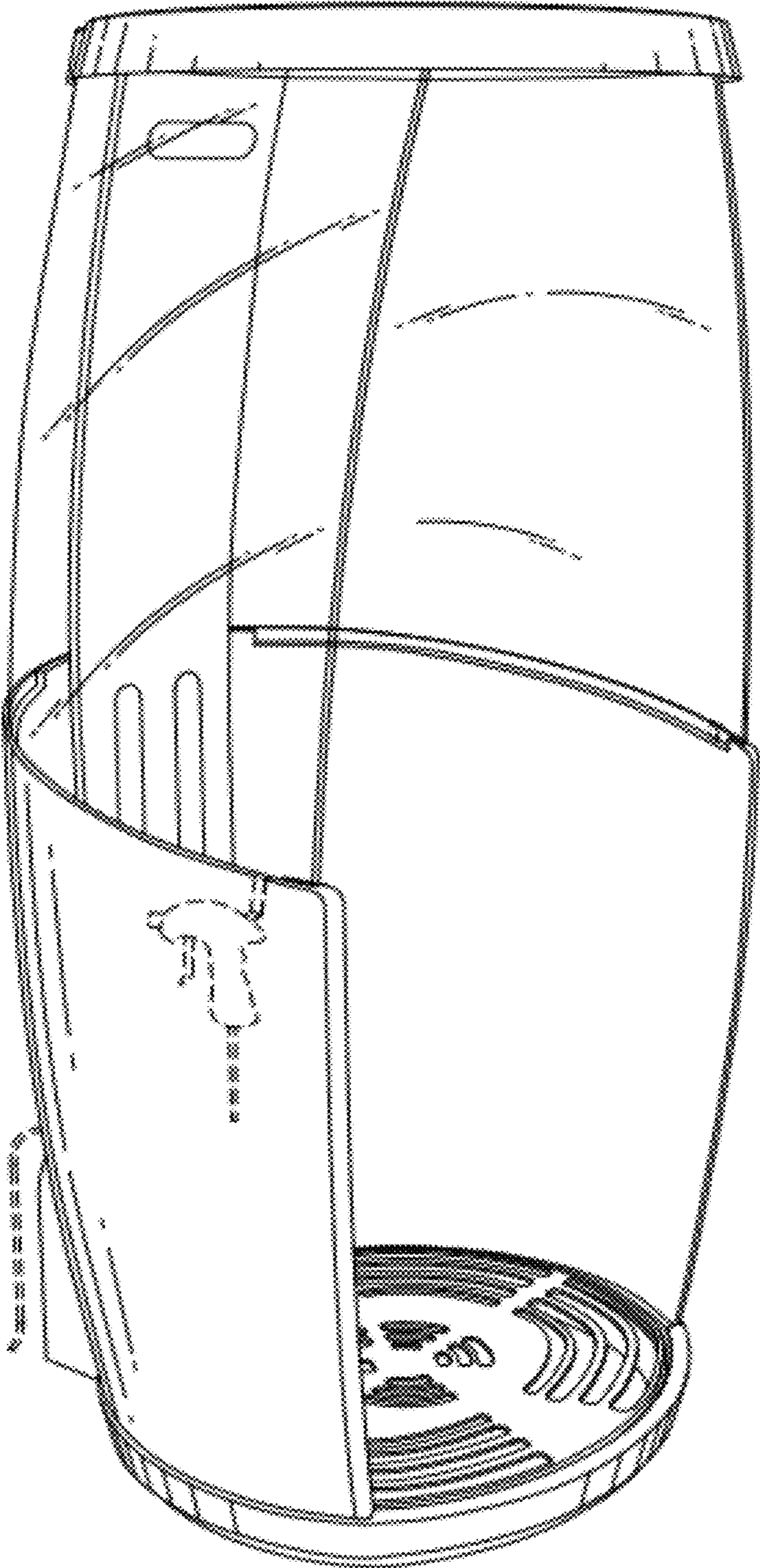

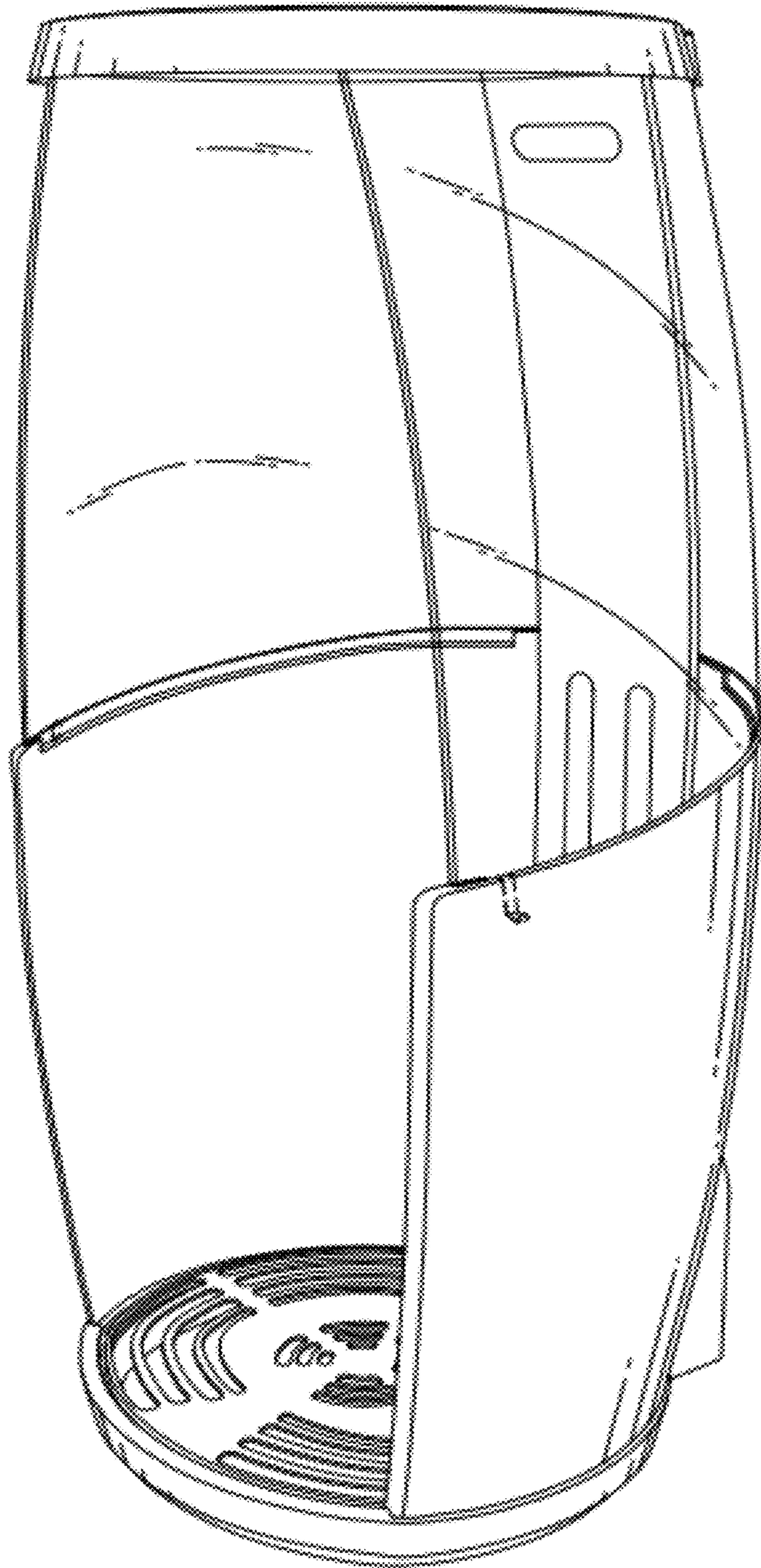

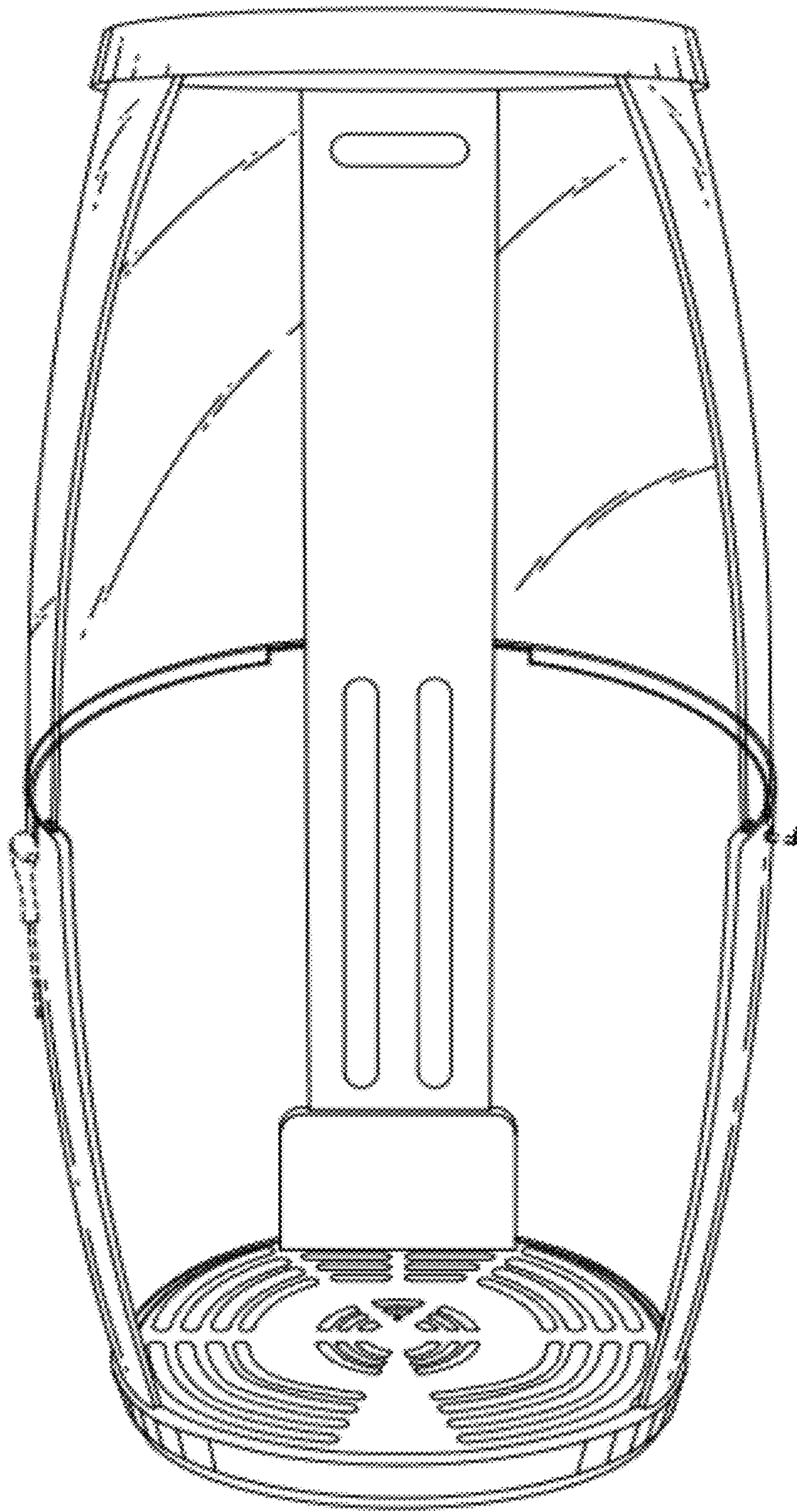

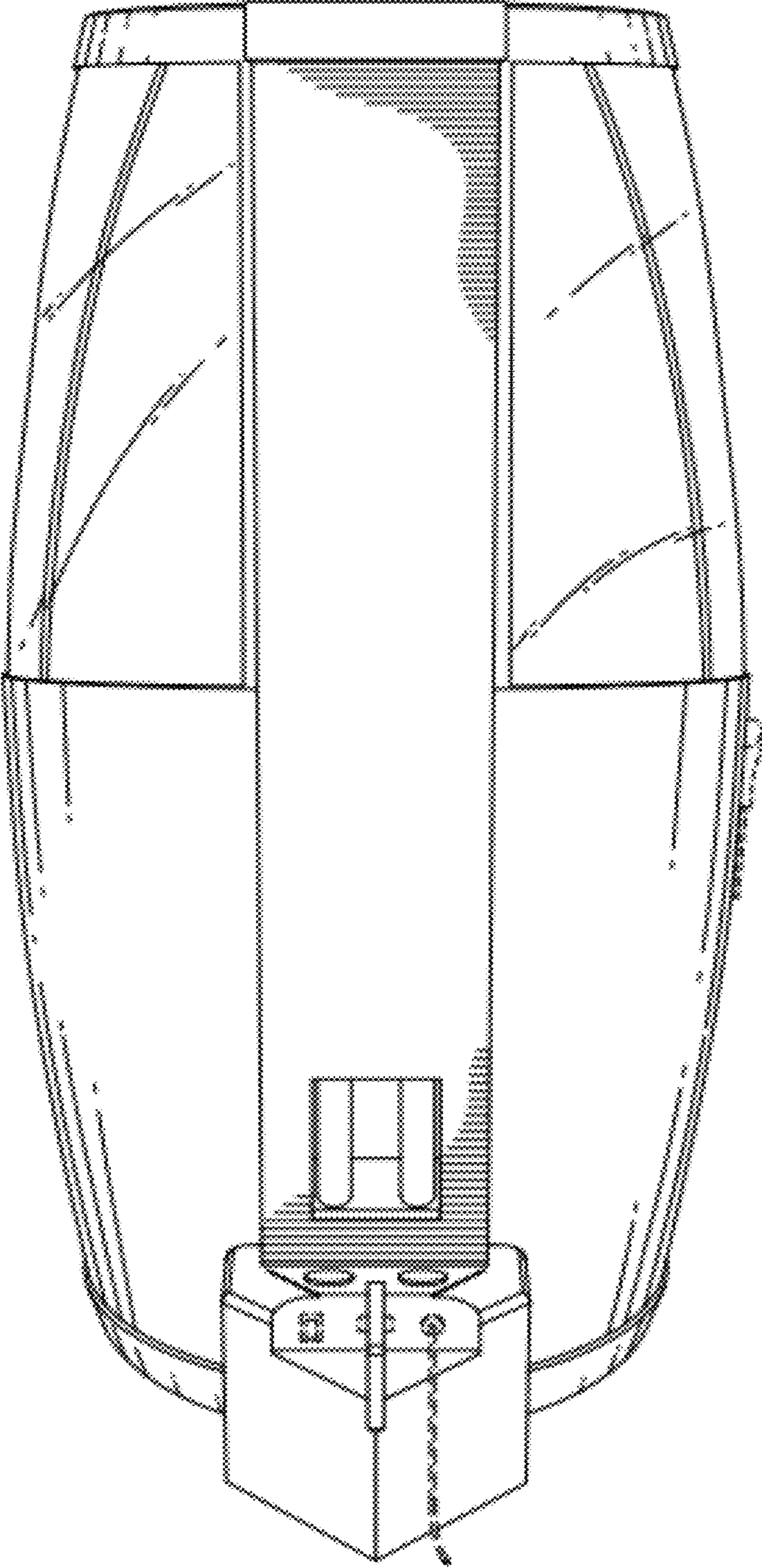

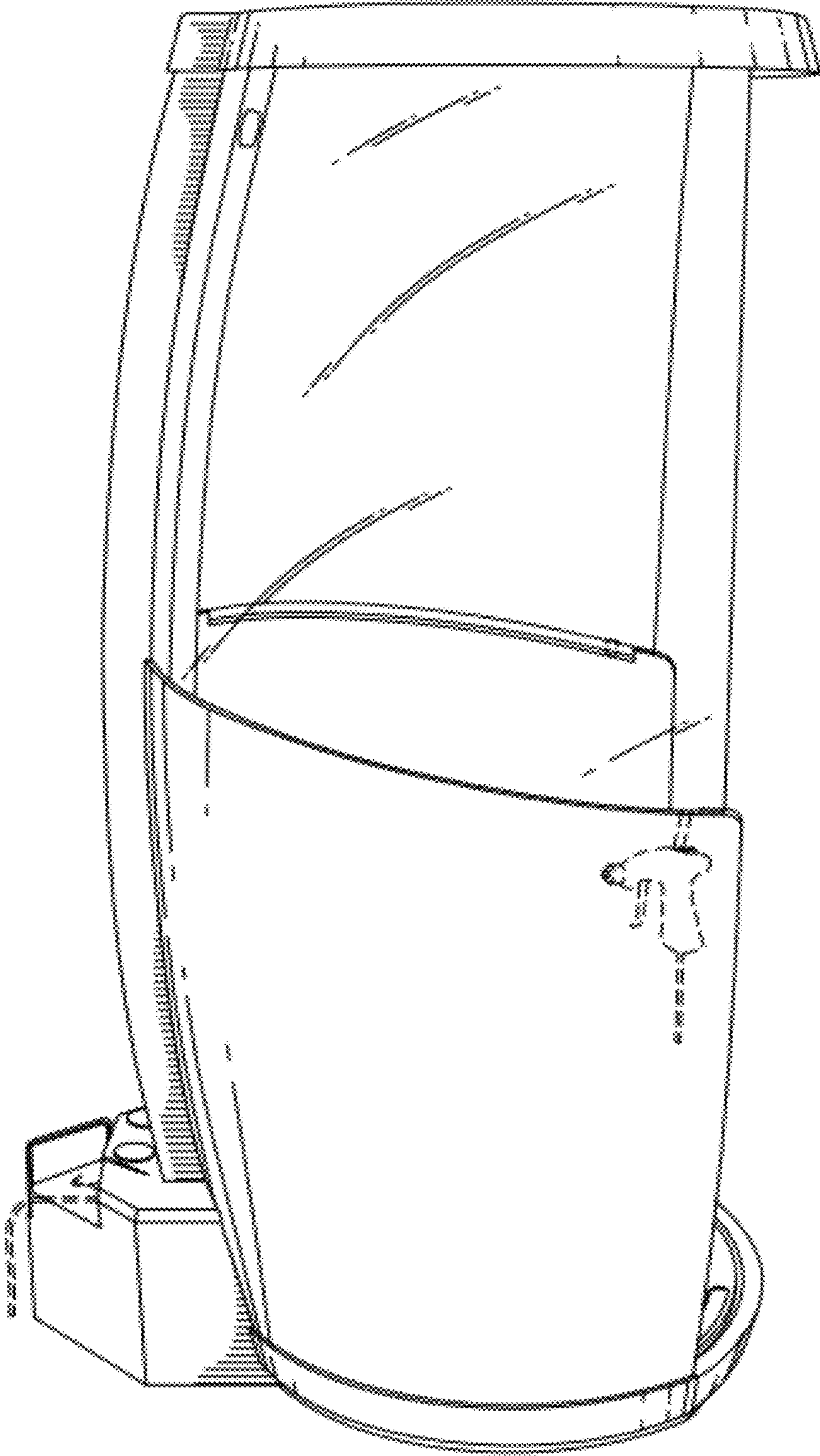

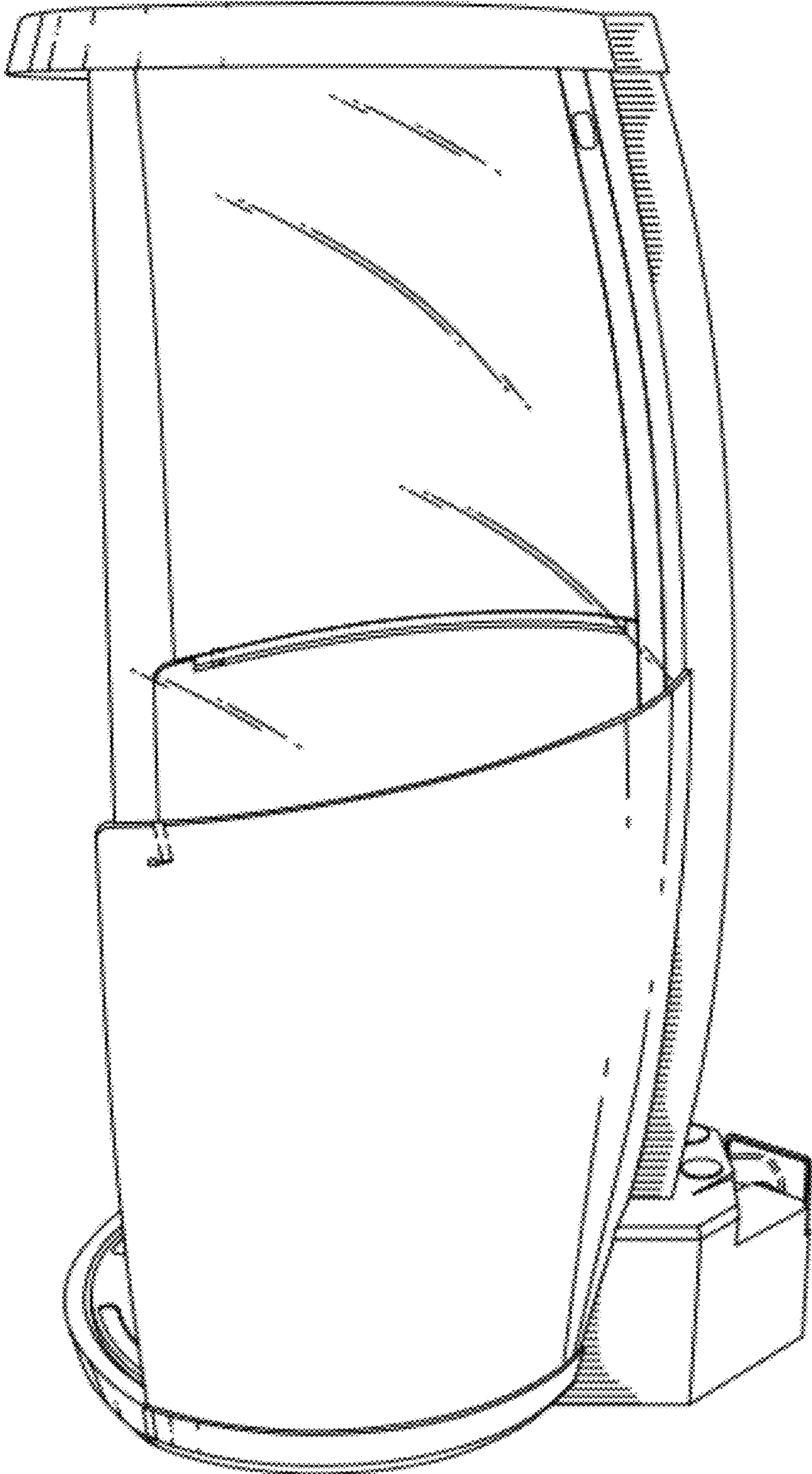

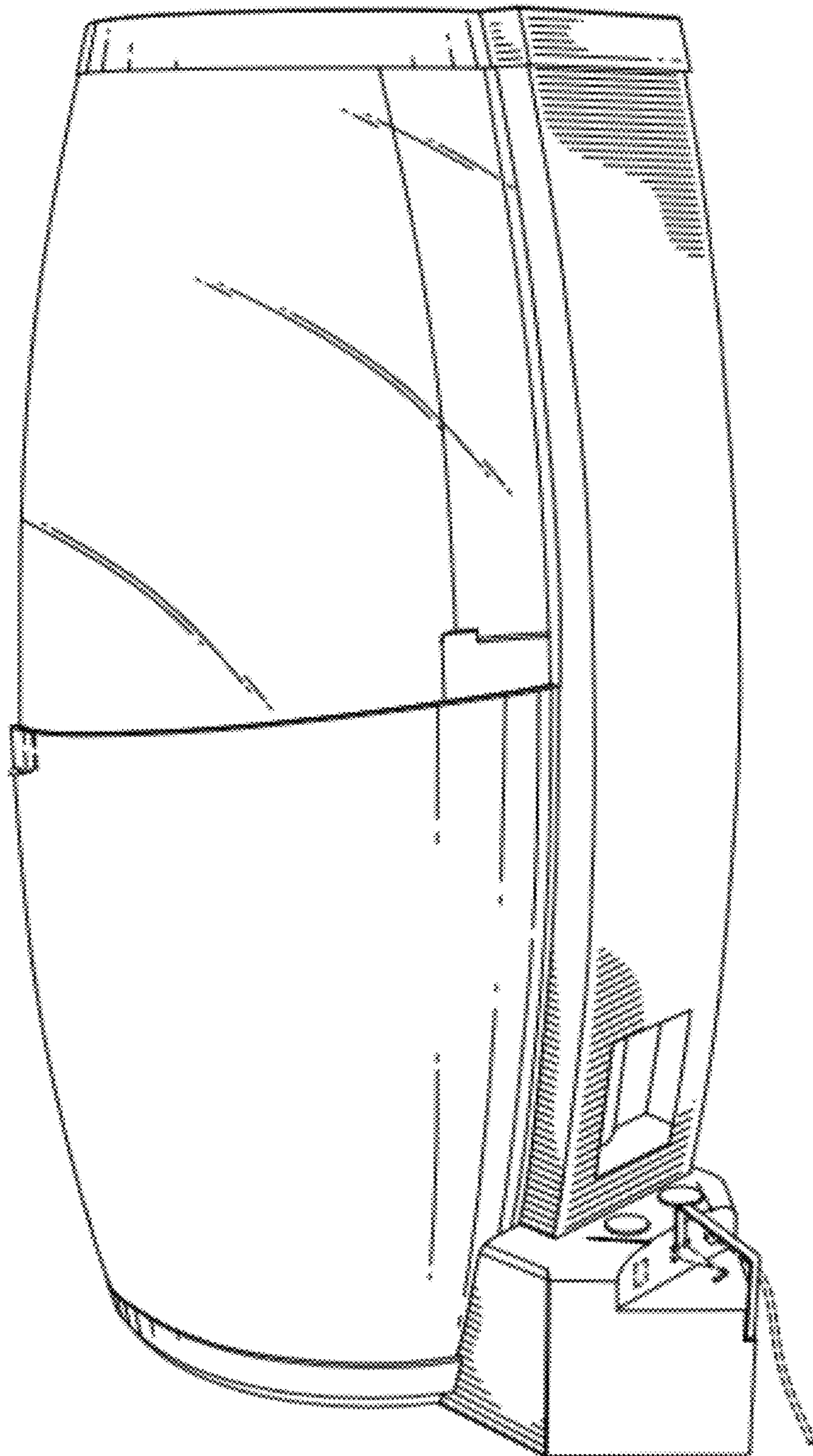

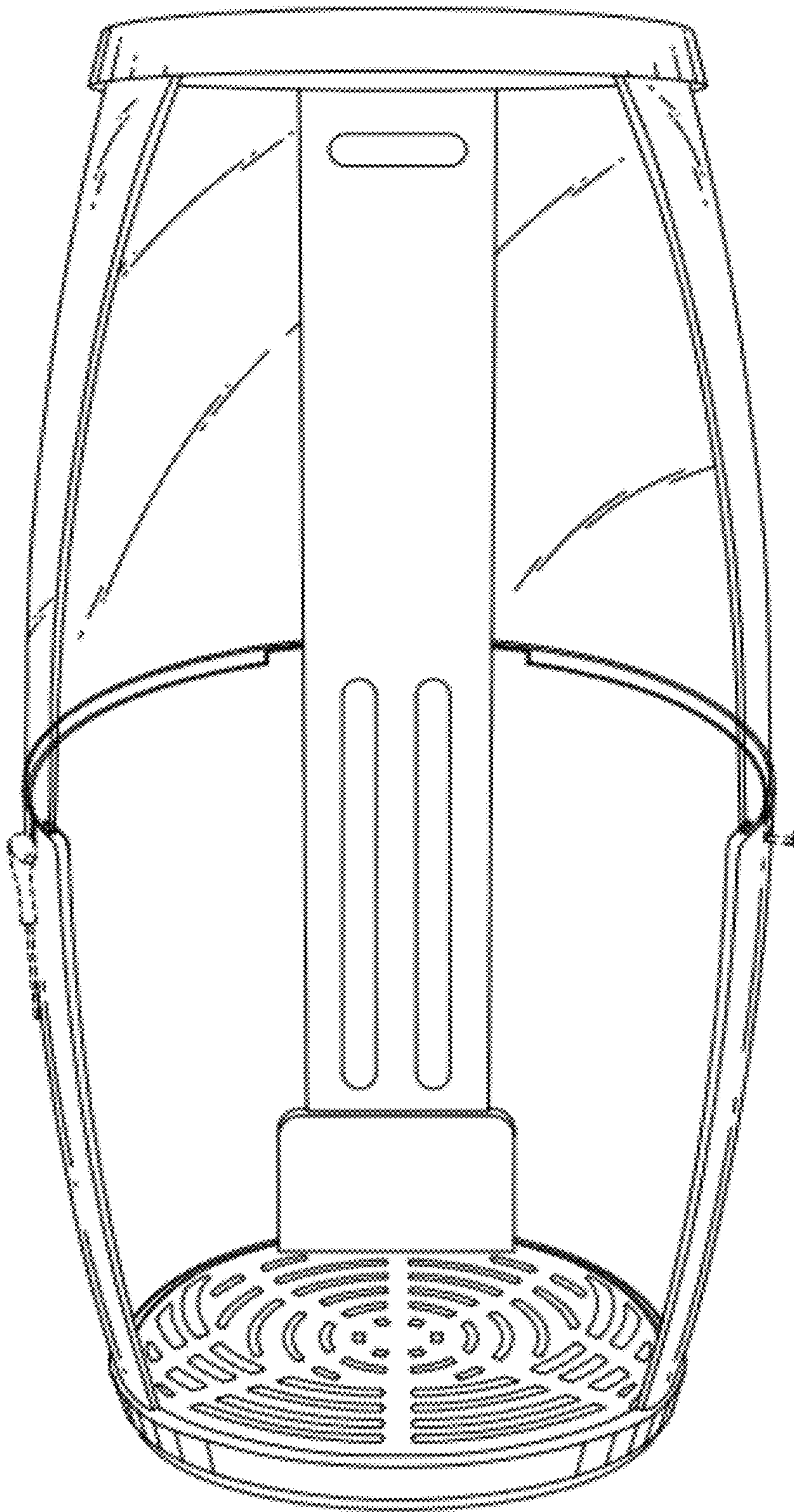
