(57) **CLAIM**

The ornamental design for a baked food product, as shown and described.

**DESCRIPTION**

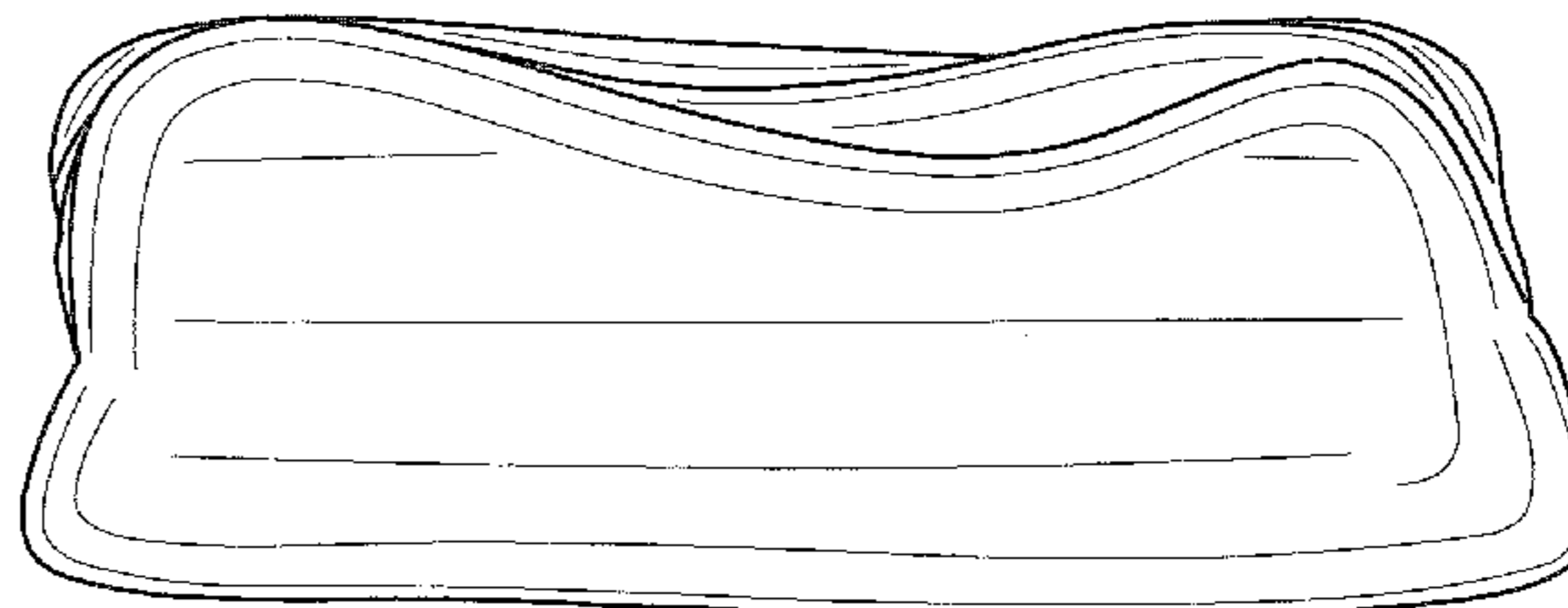
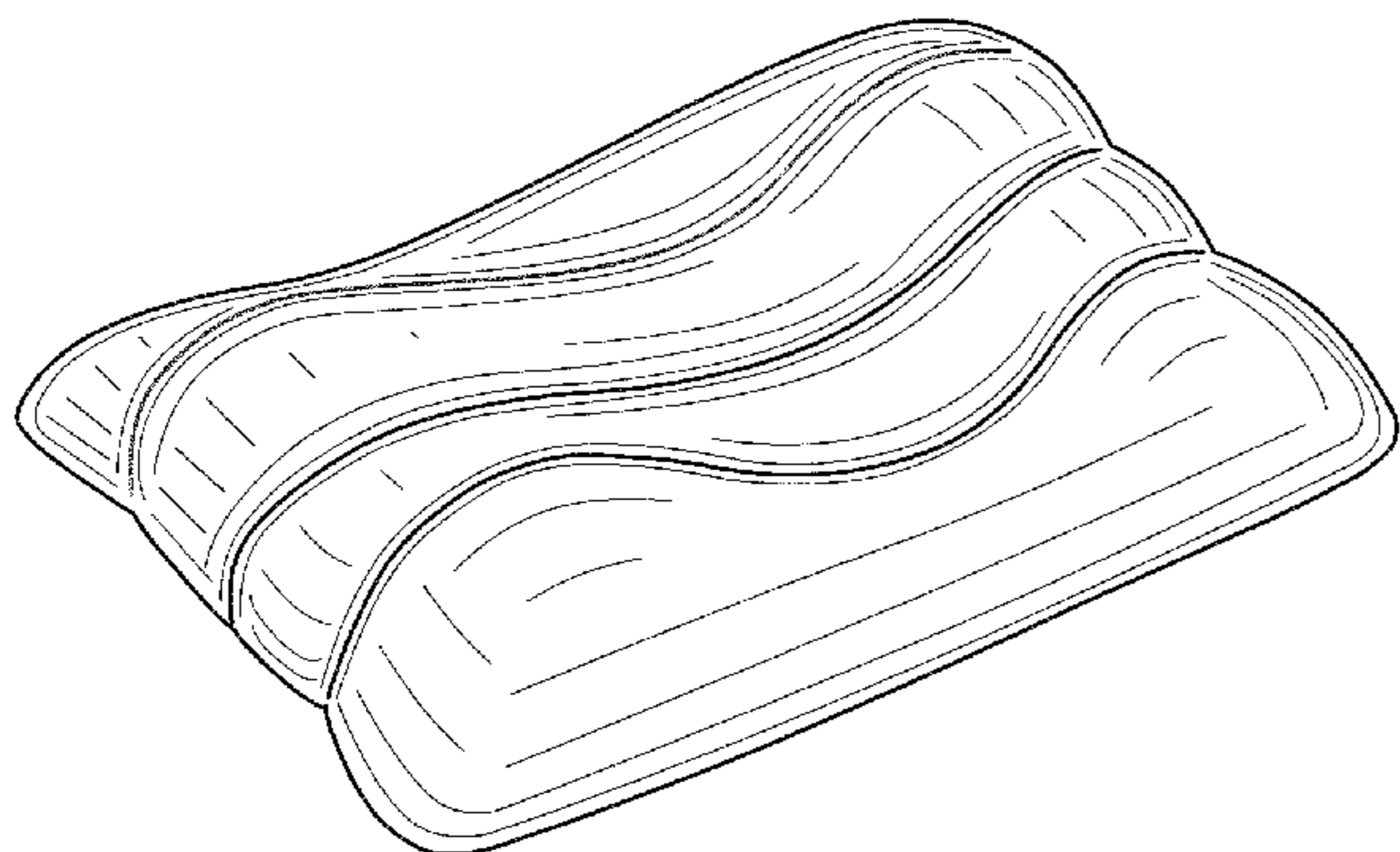

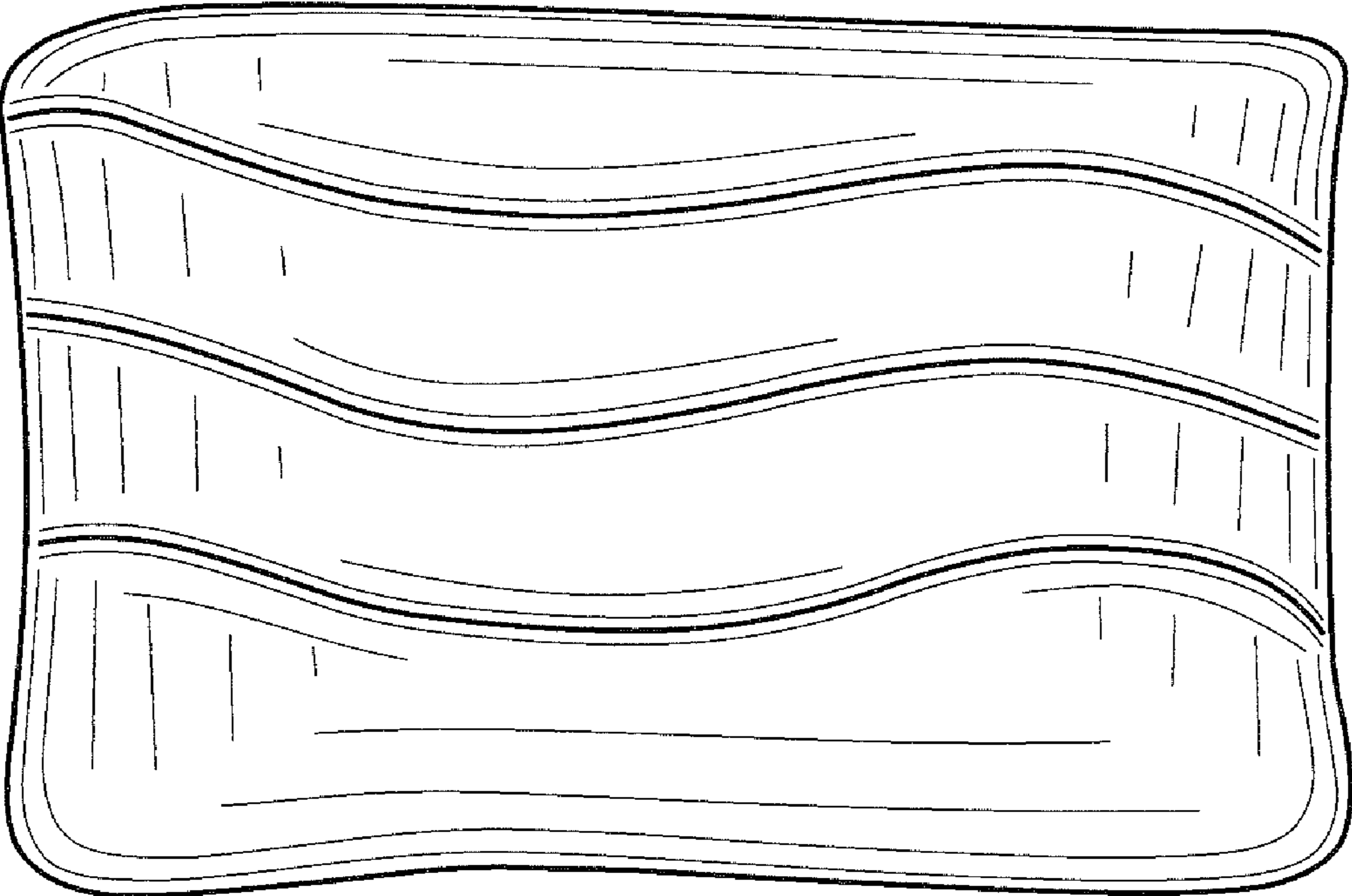

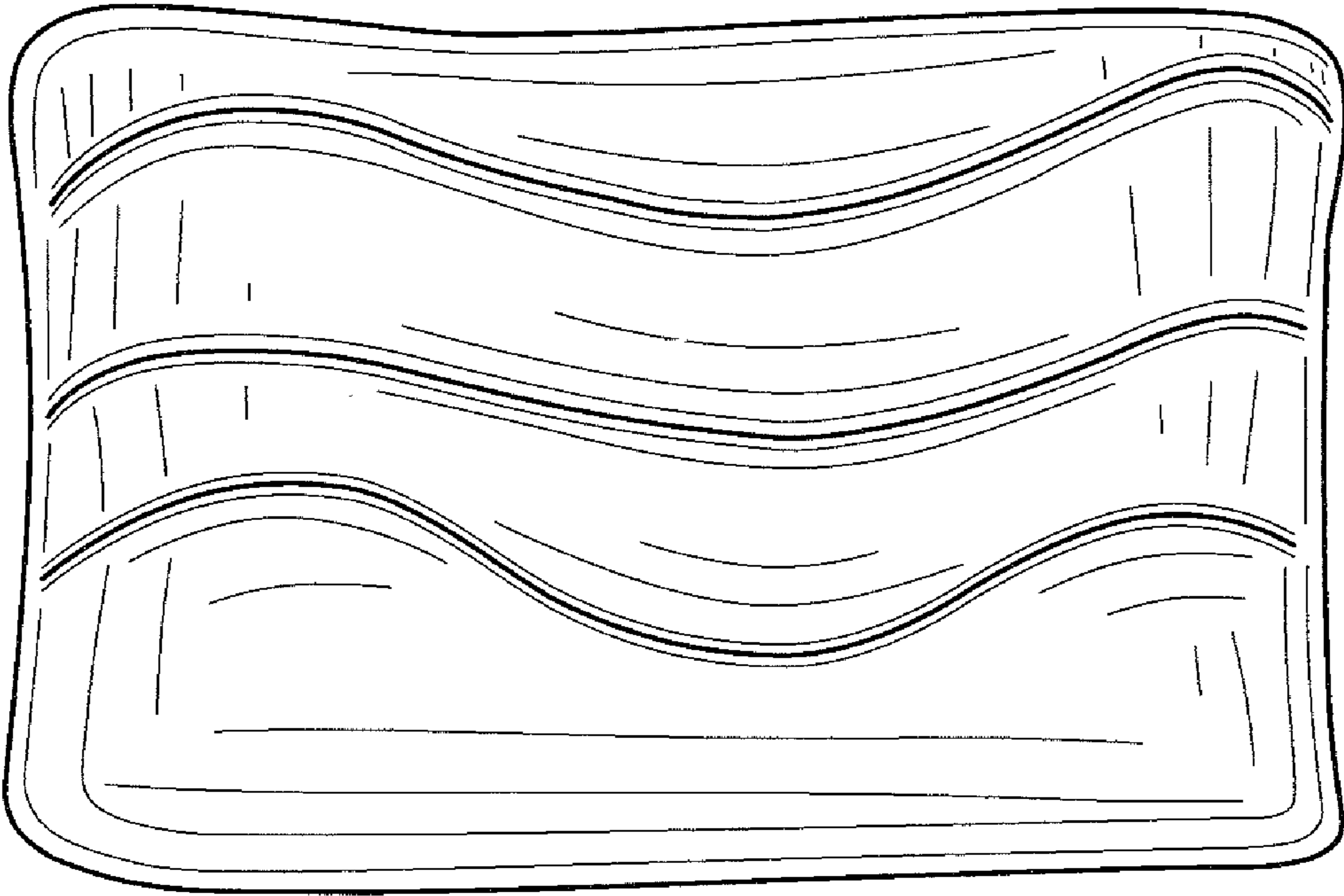

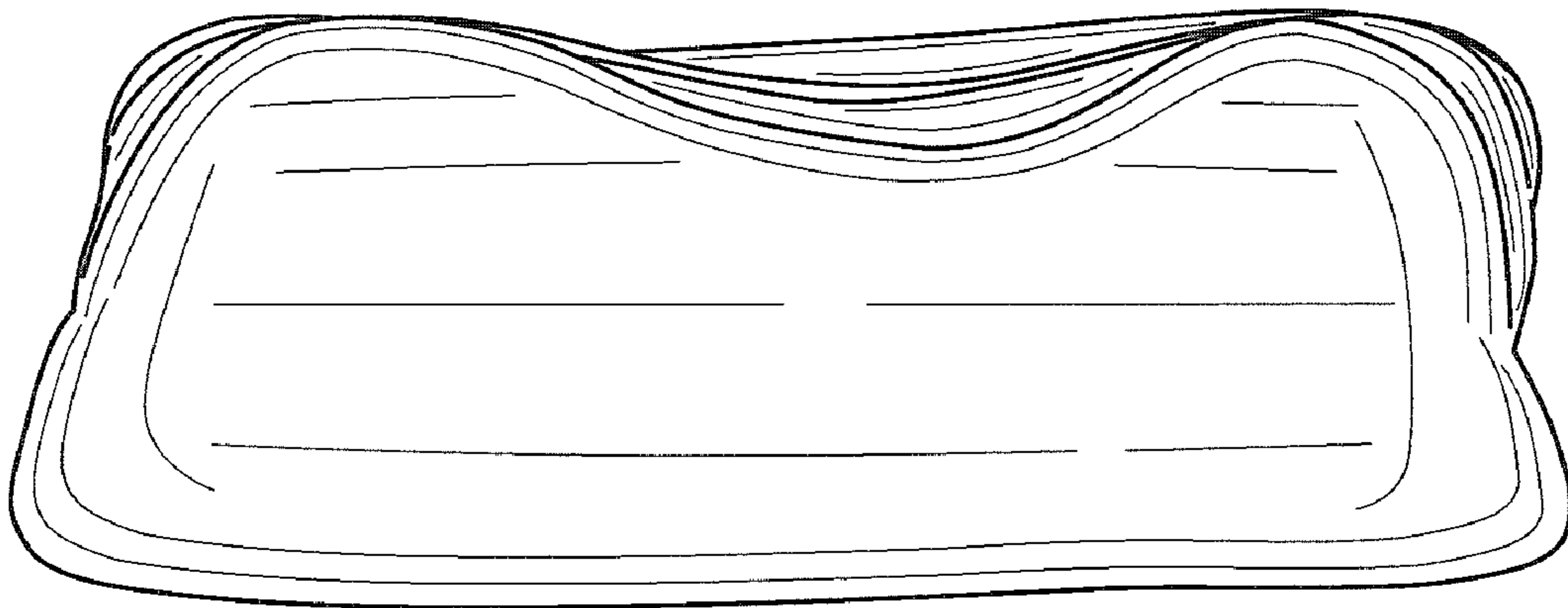
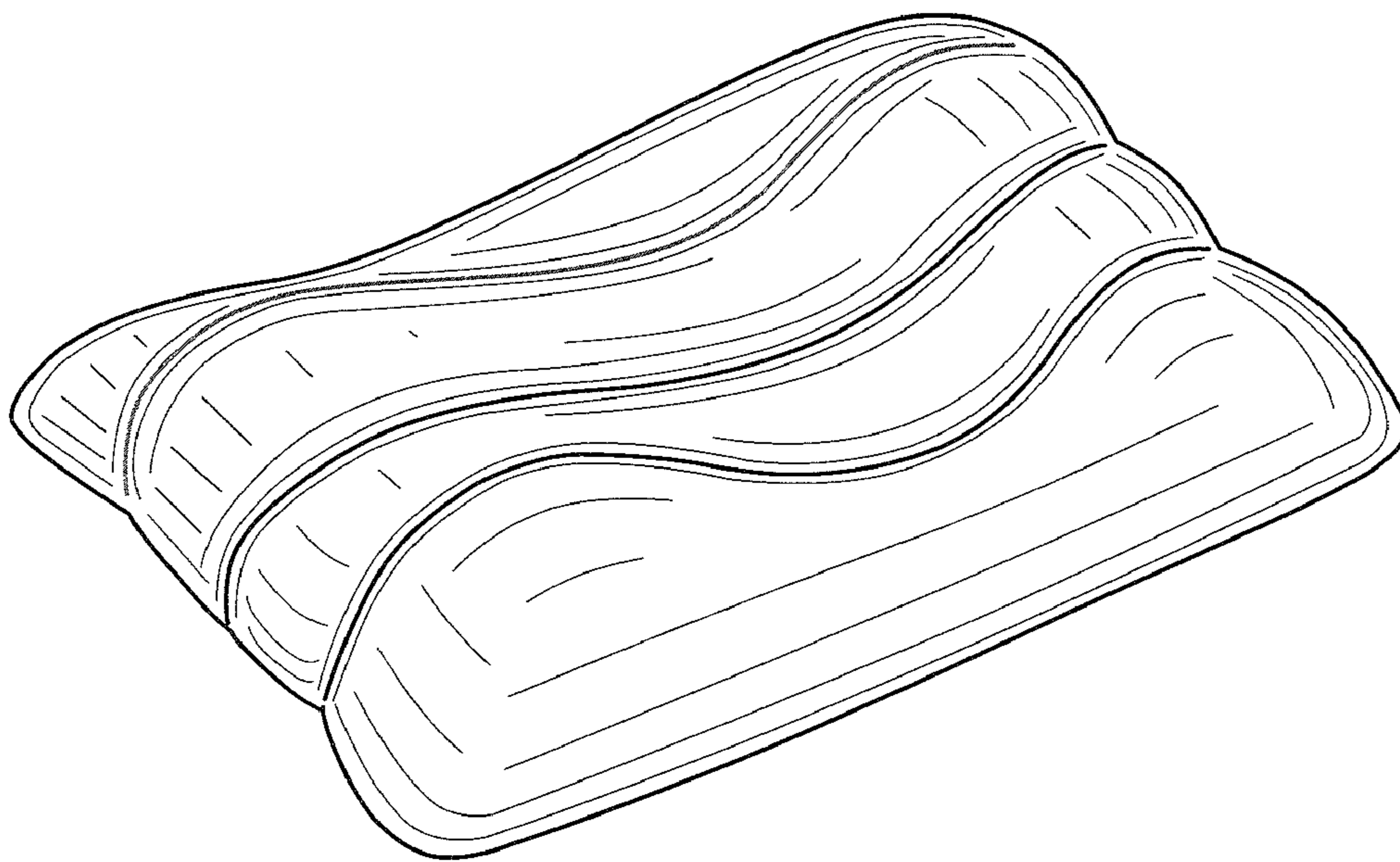

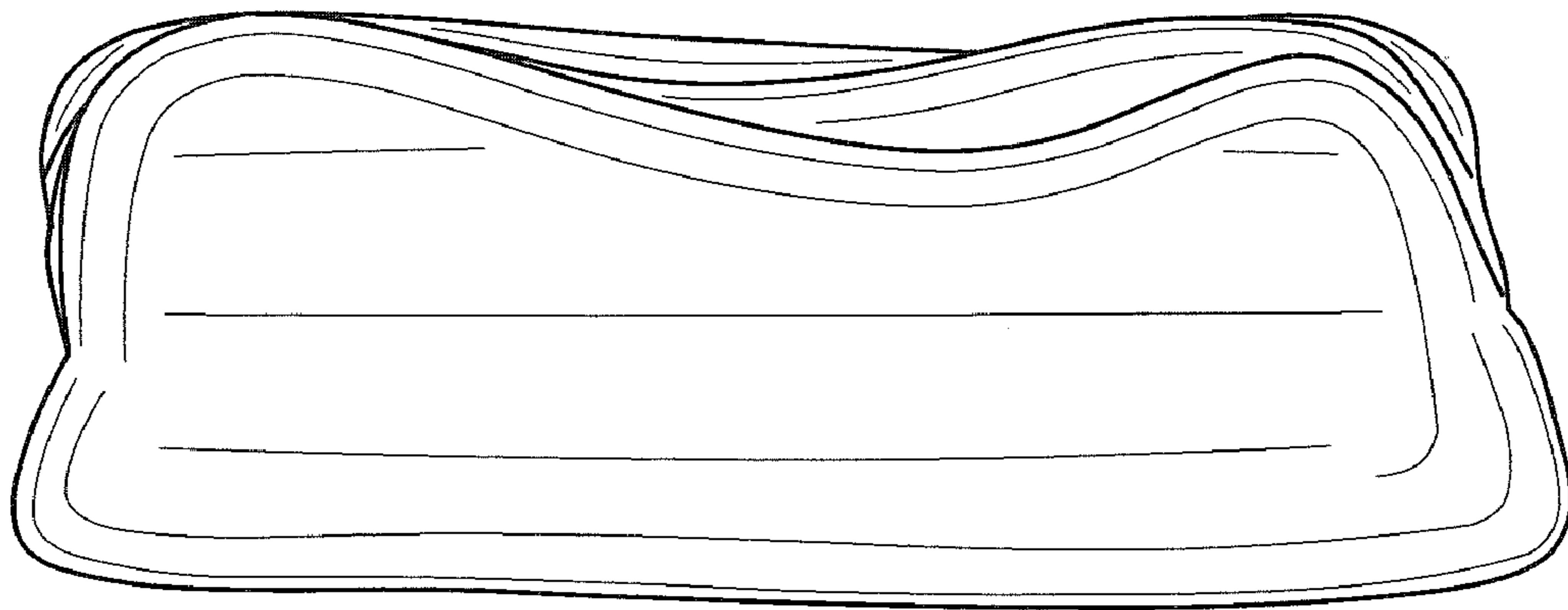

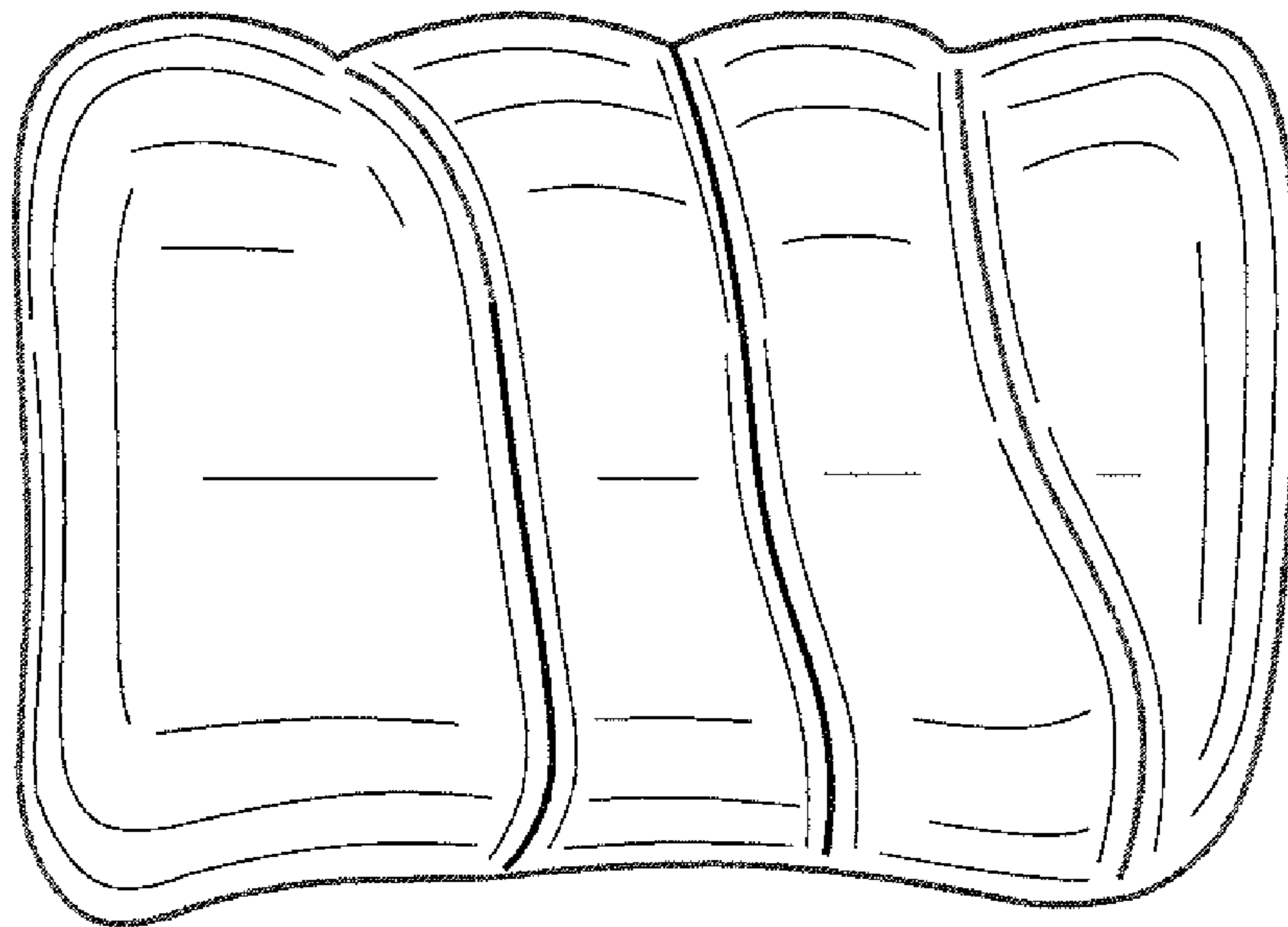
