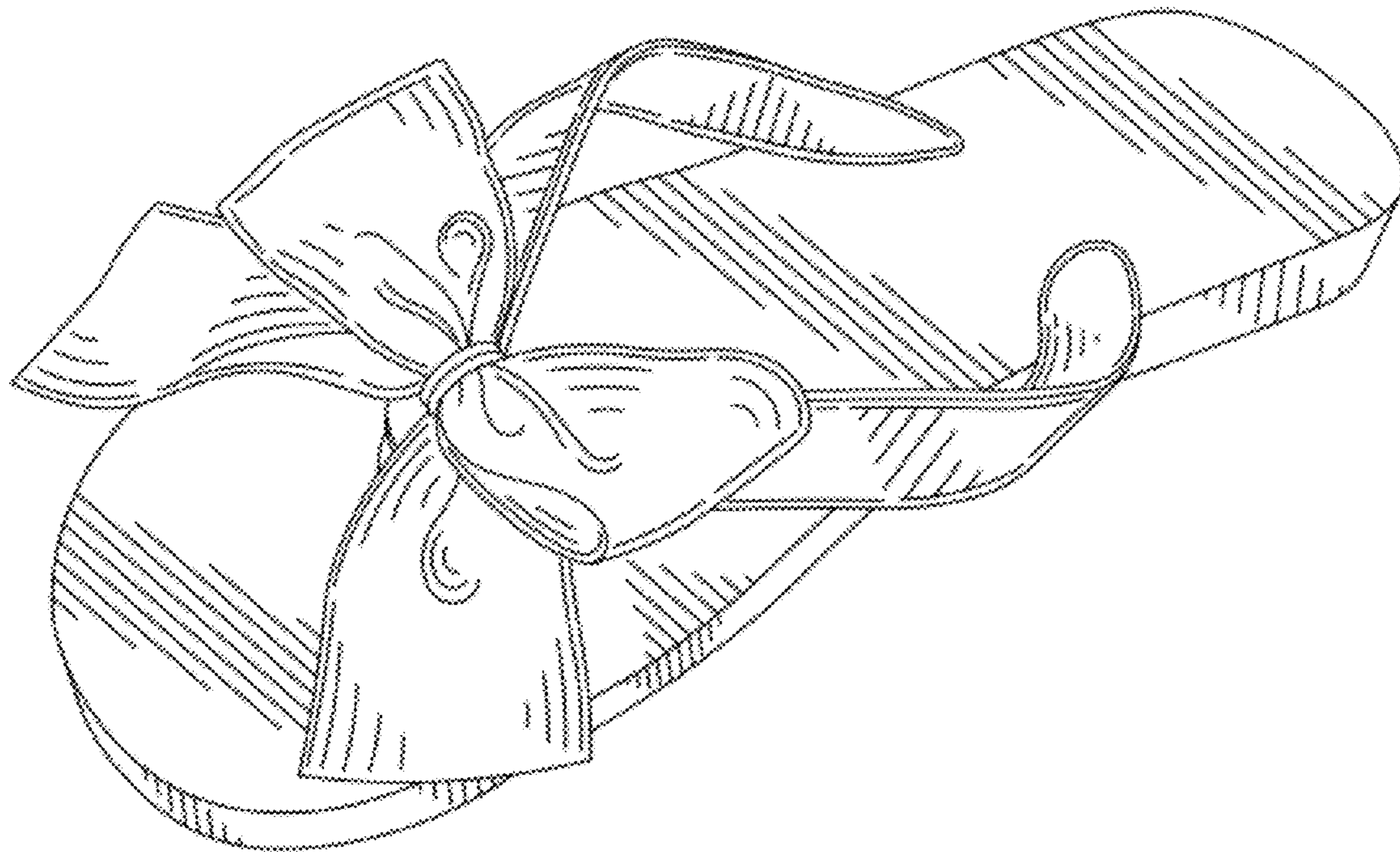
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of casual footwear;
FIG. 2 is a top plan view thereof;

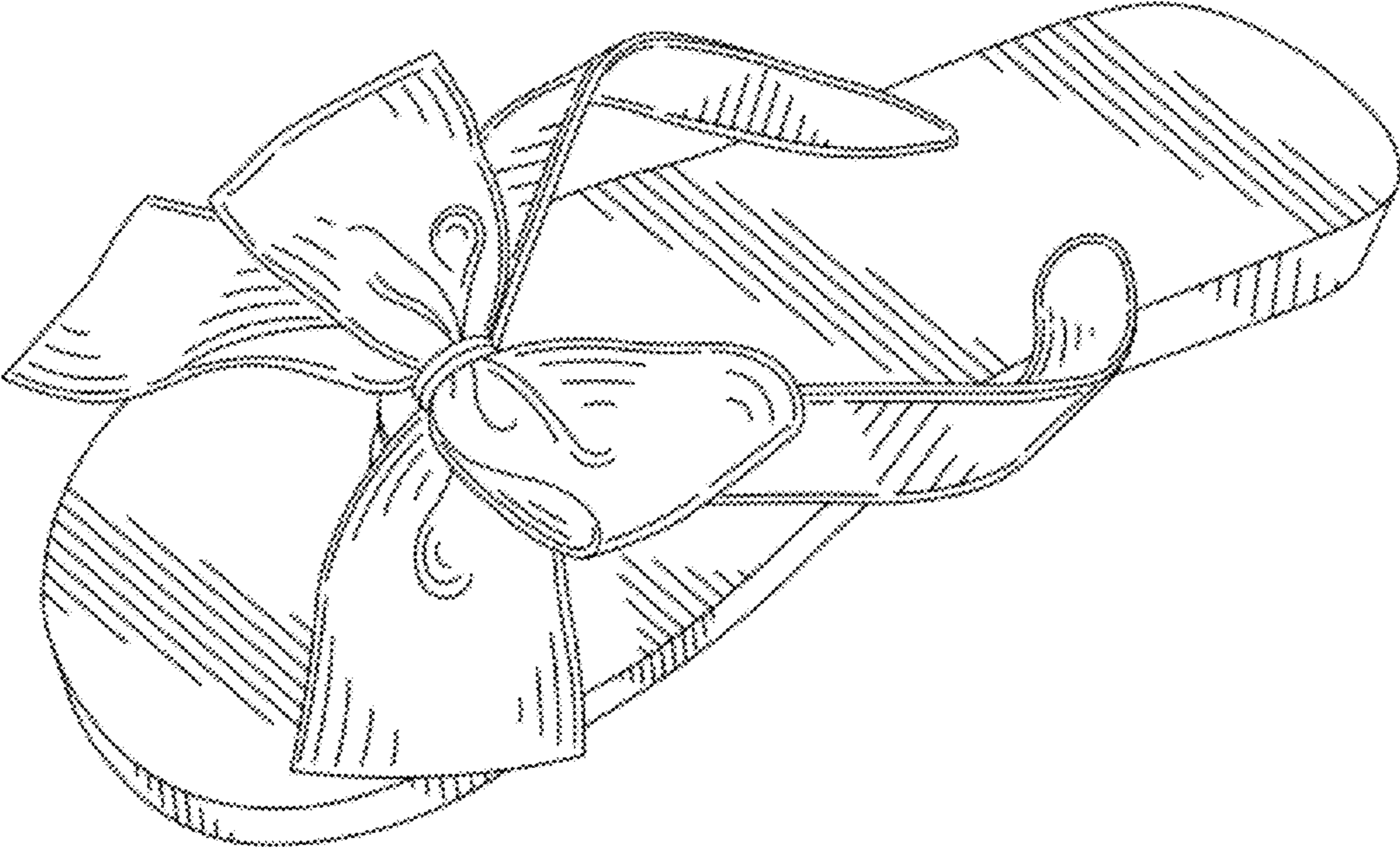

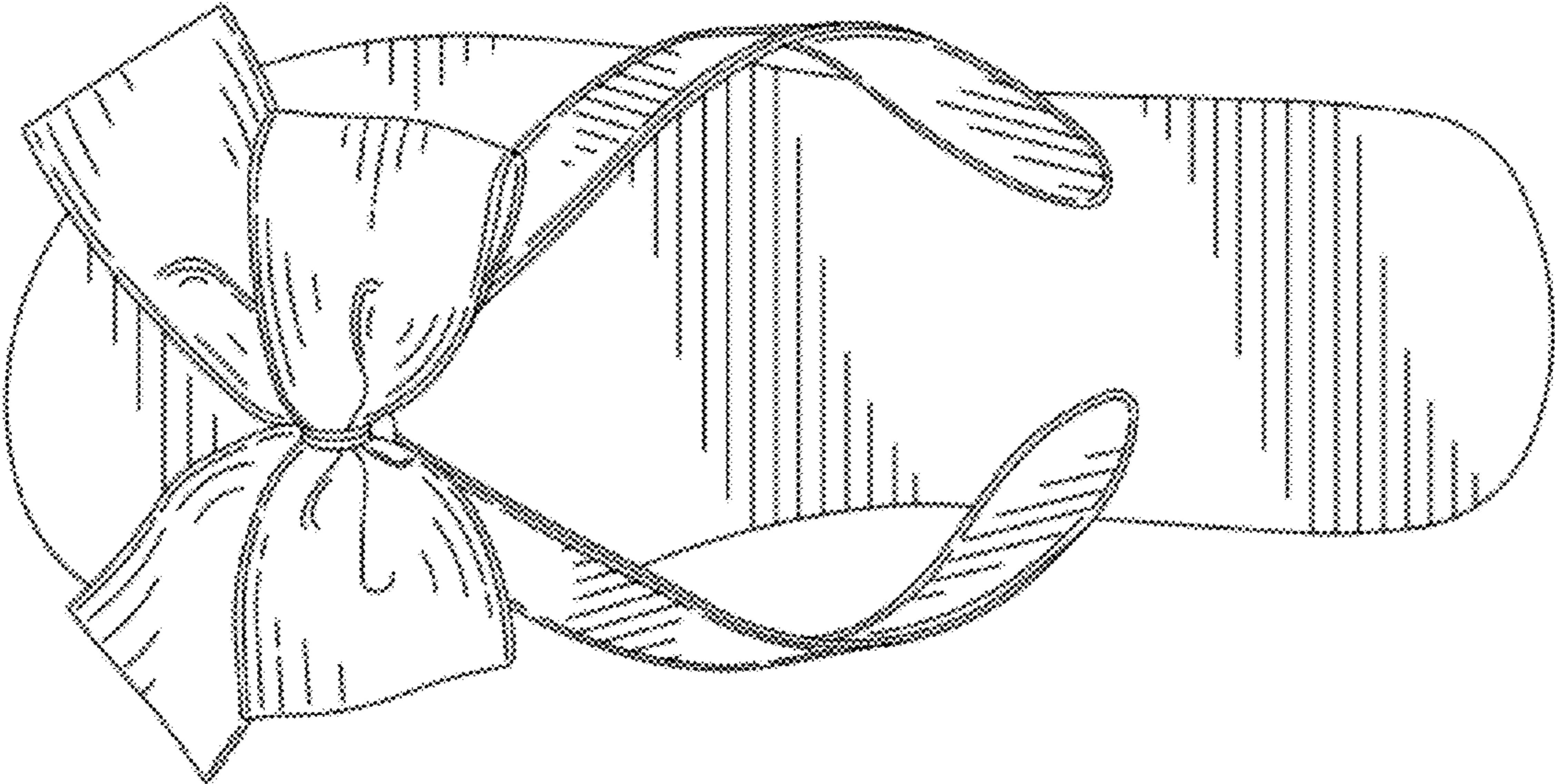

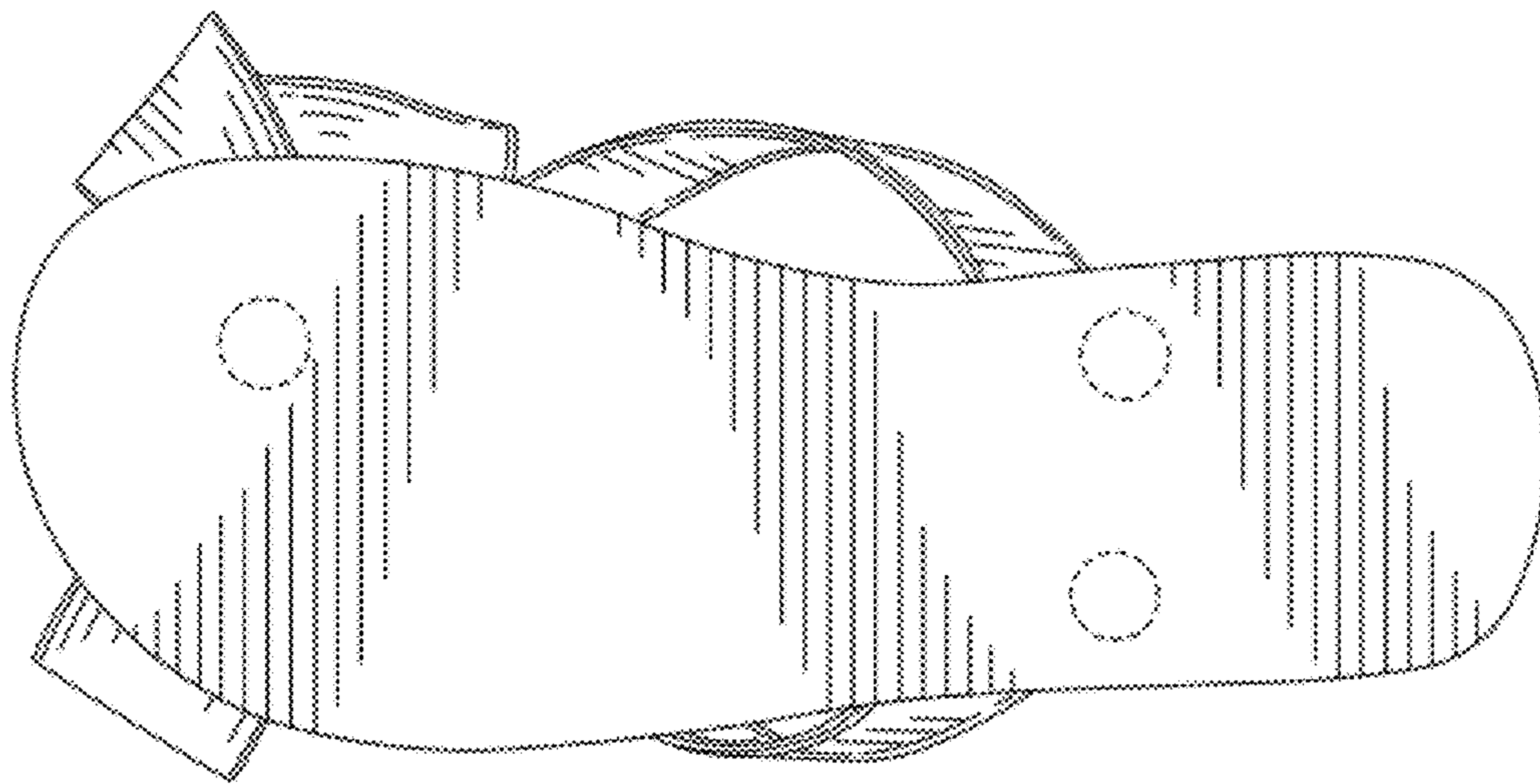

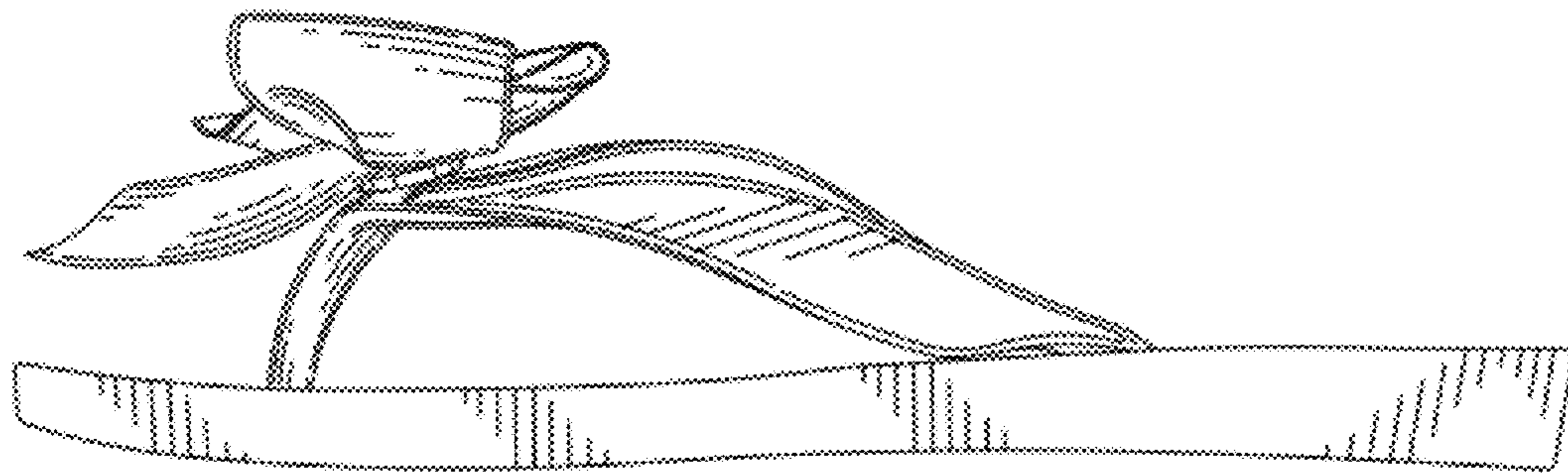

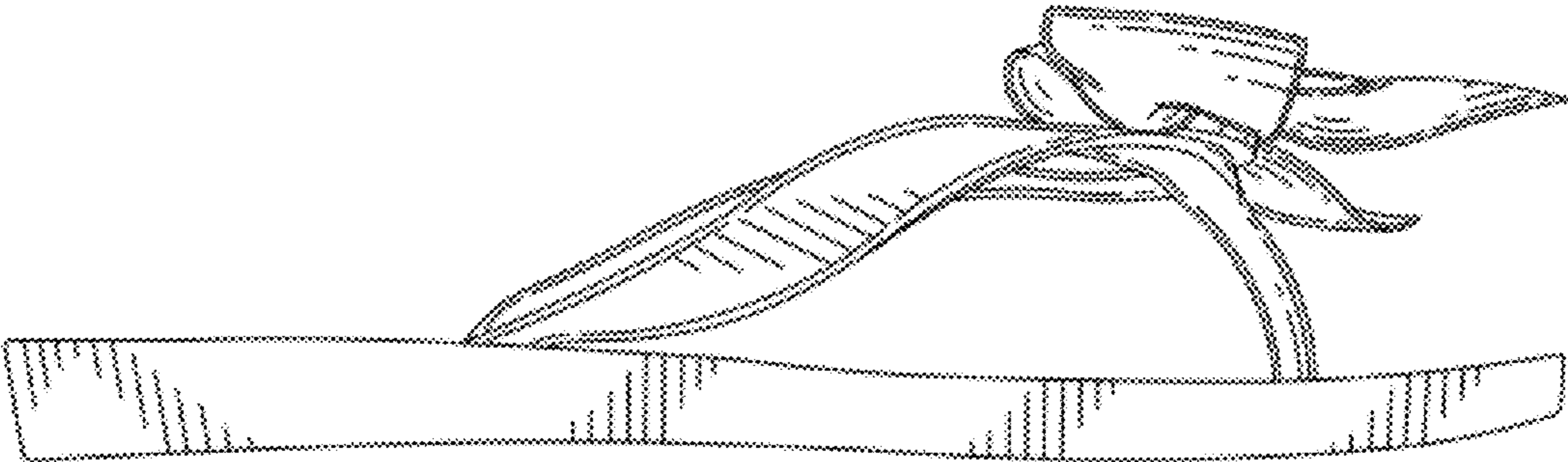

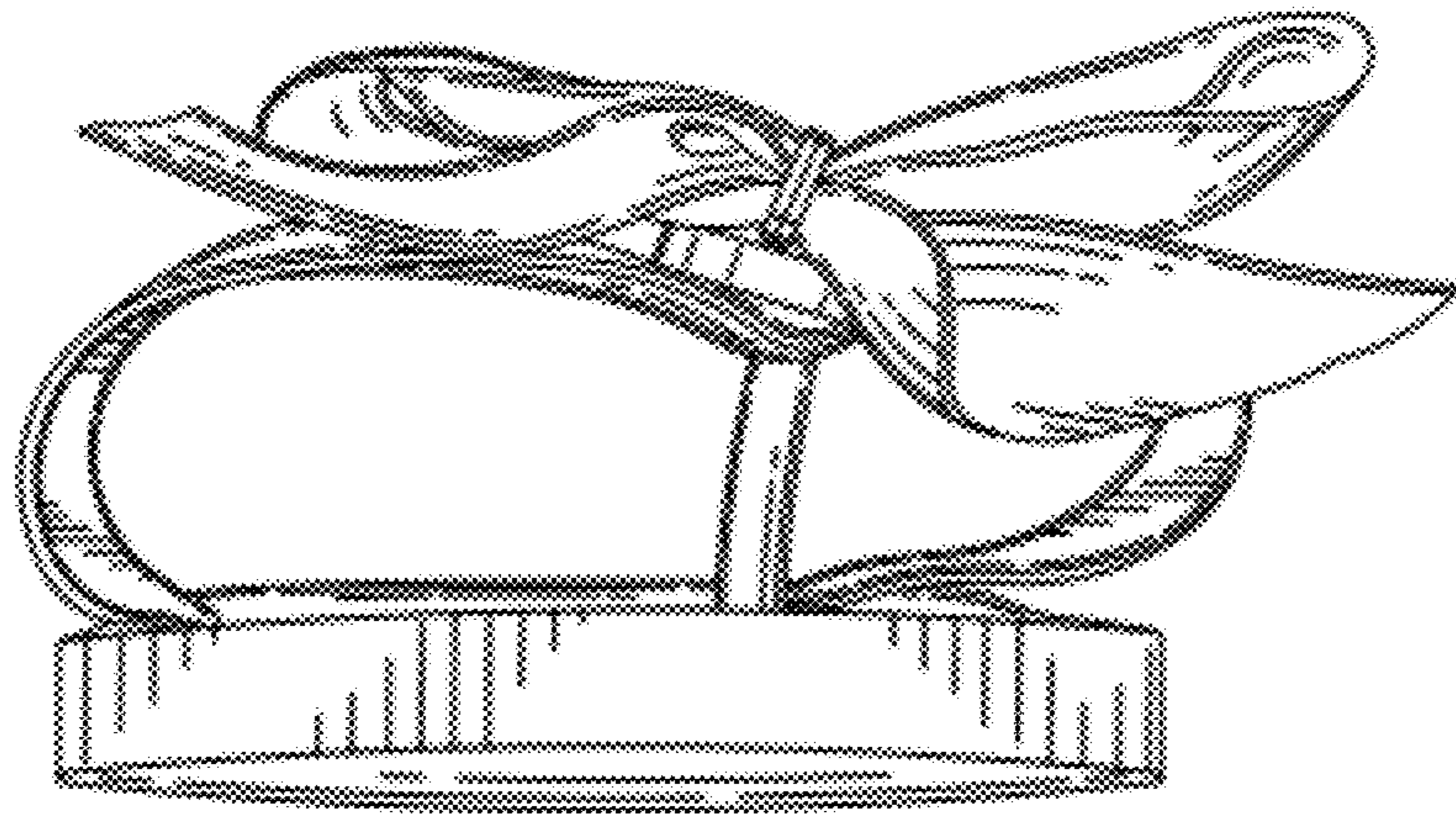

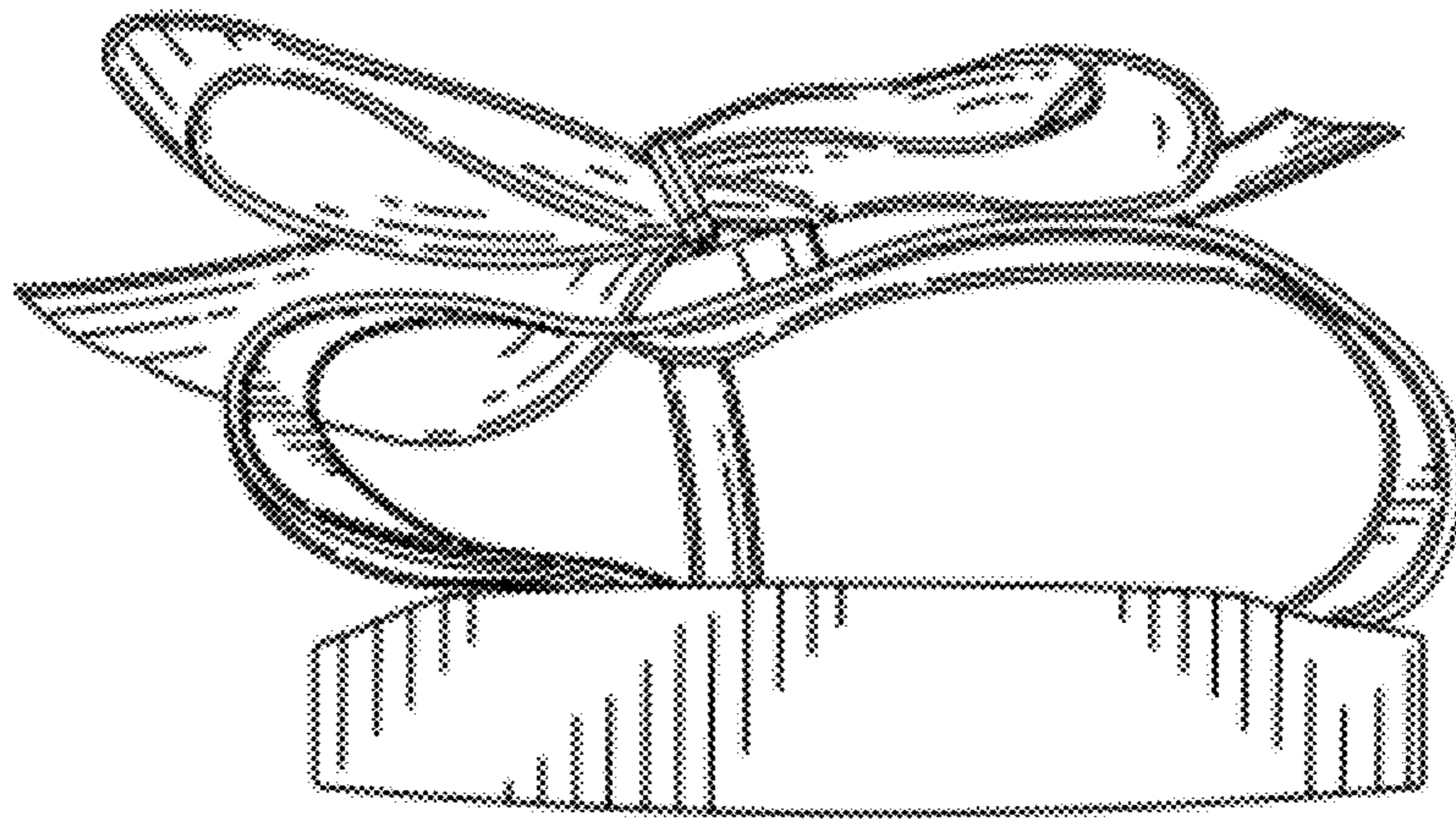

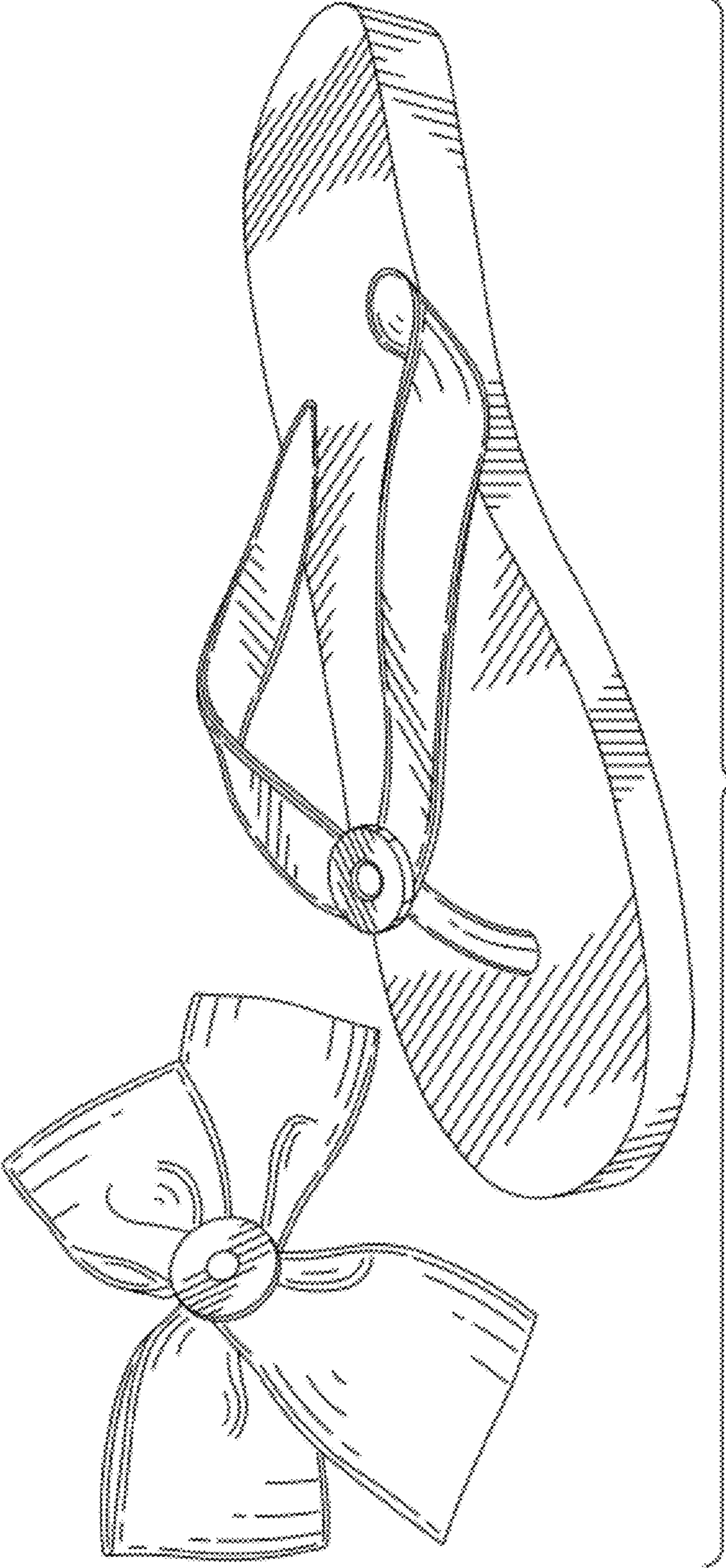
