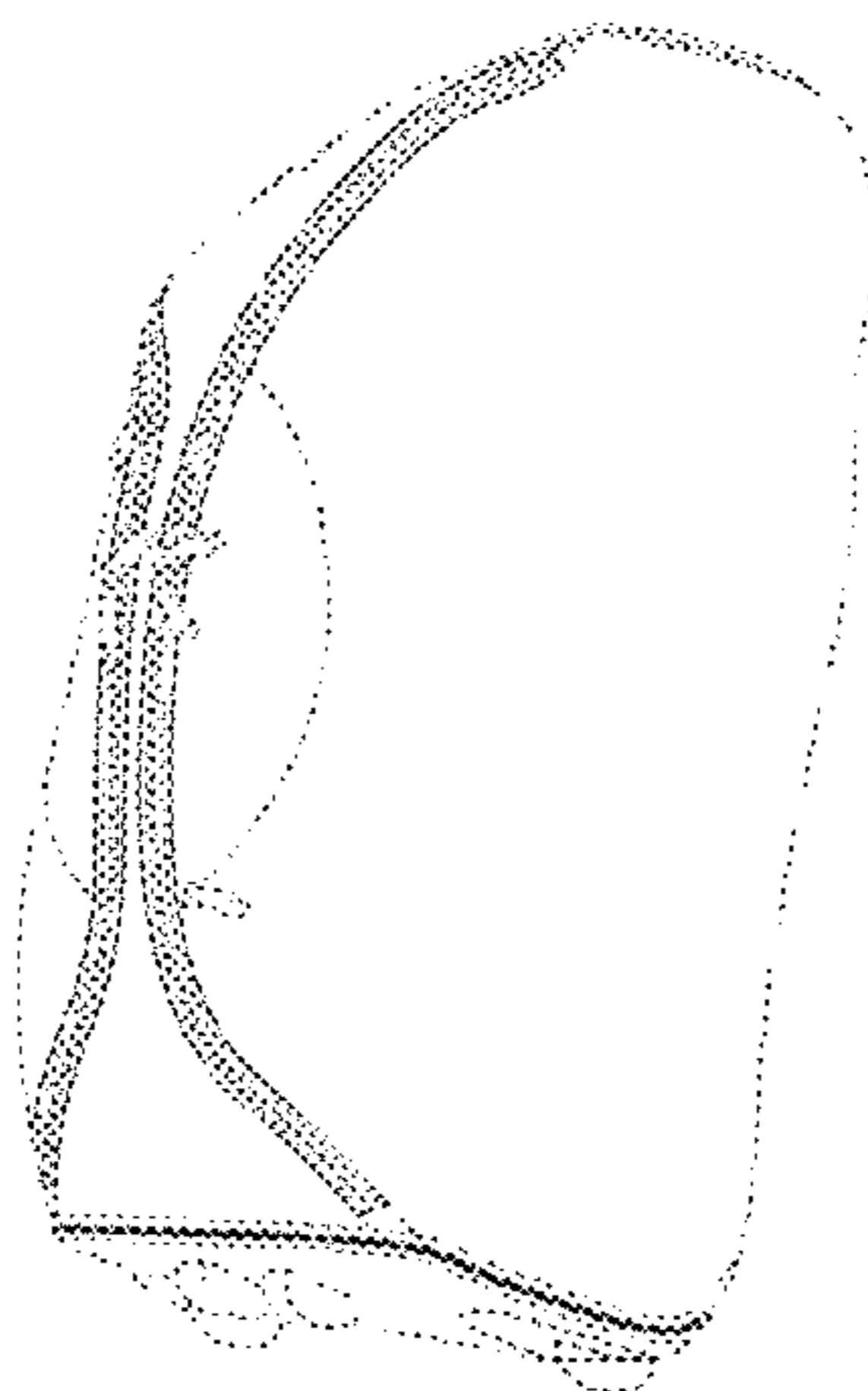

DESCRIPTION

FIG. 1 shows a front perspective view of a zipper;

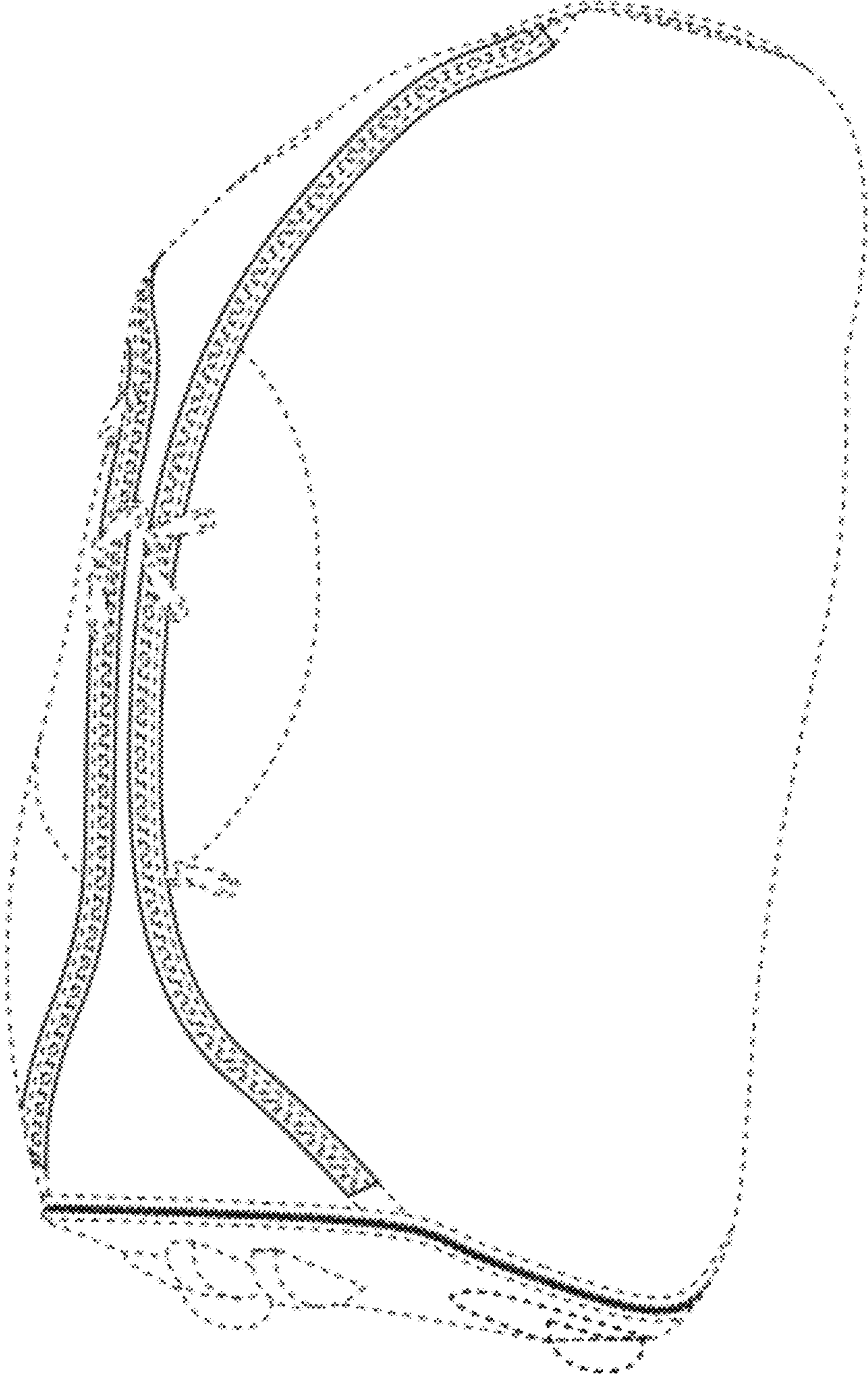

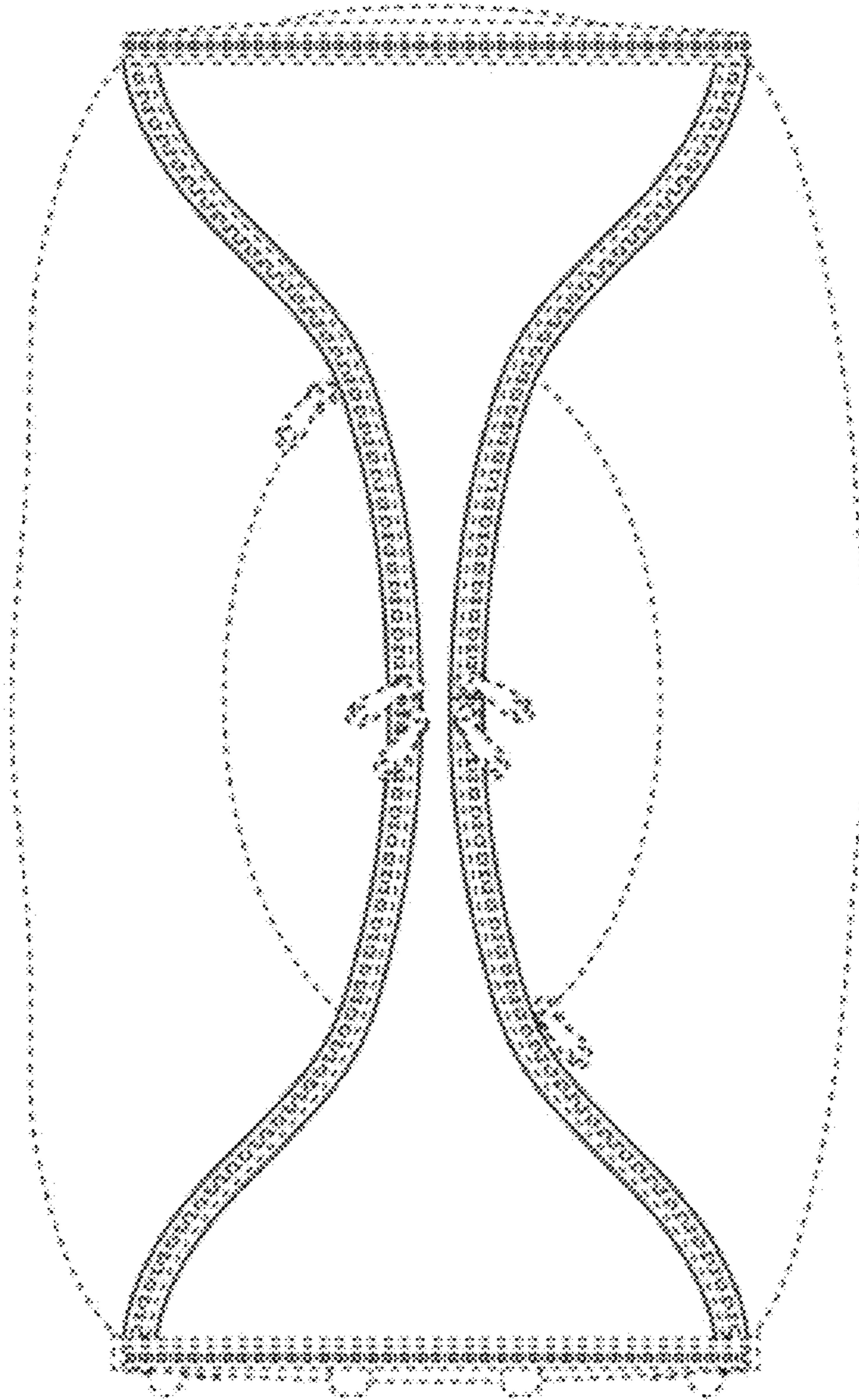

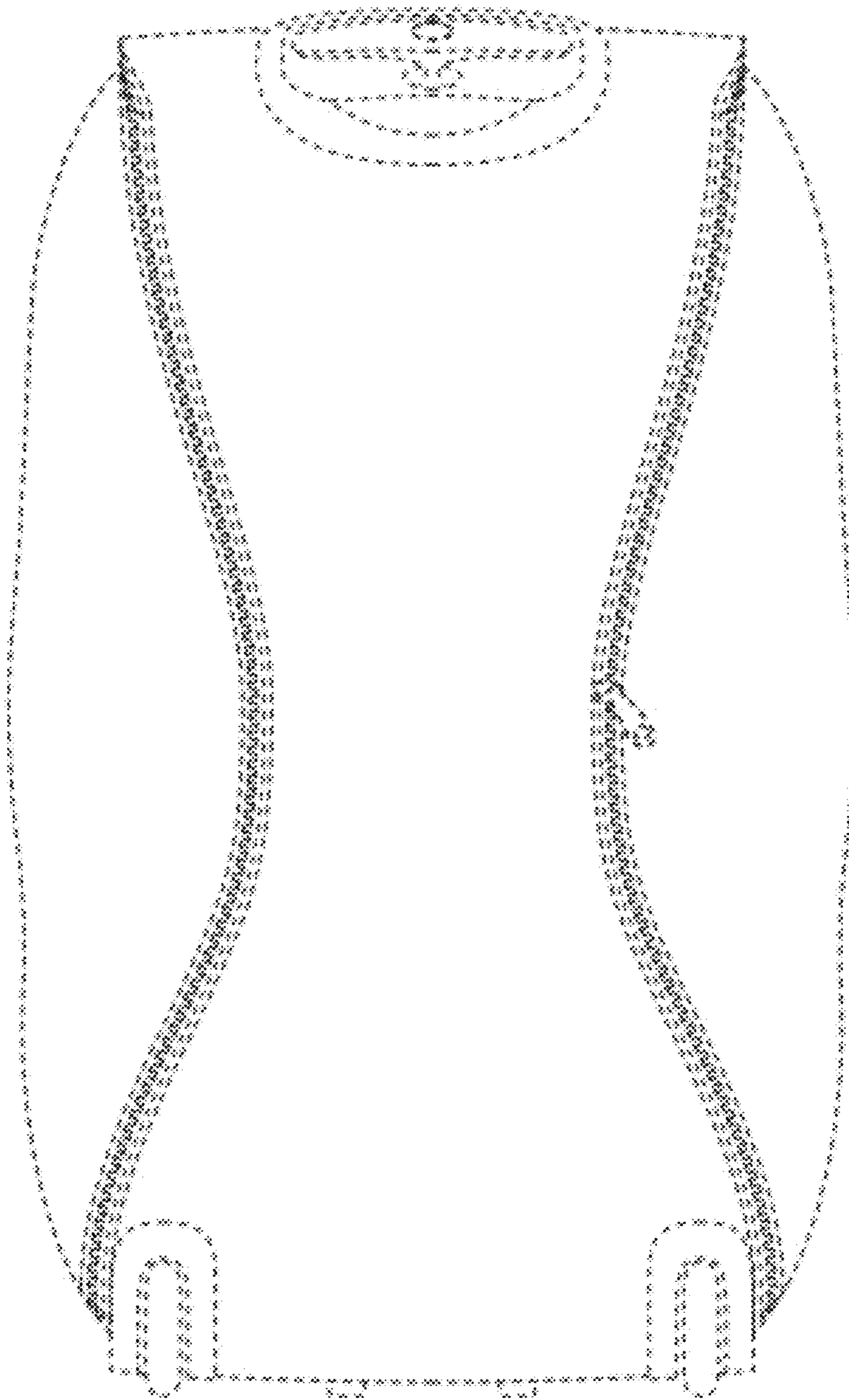

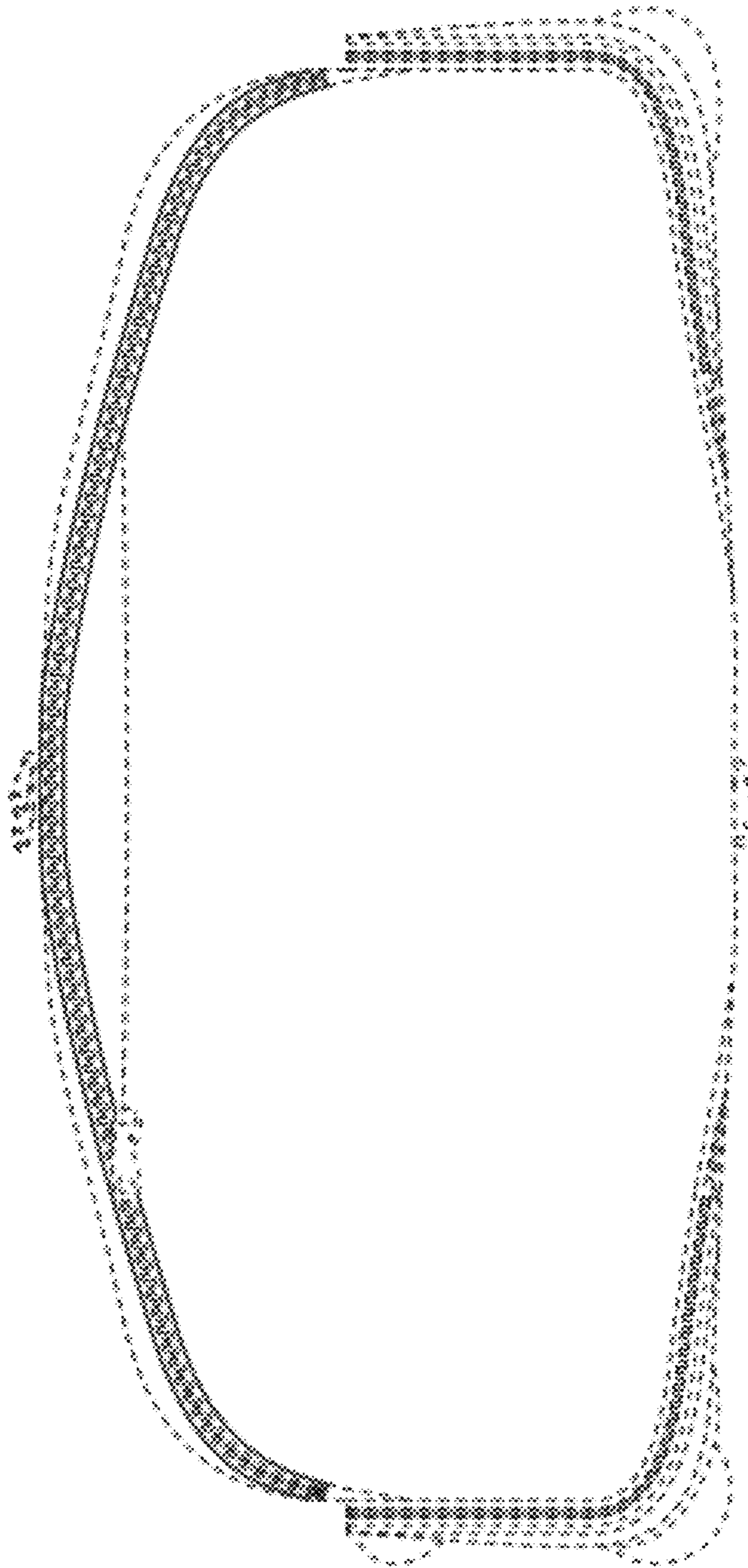

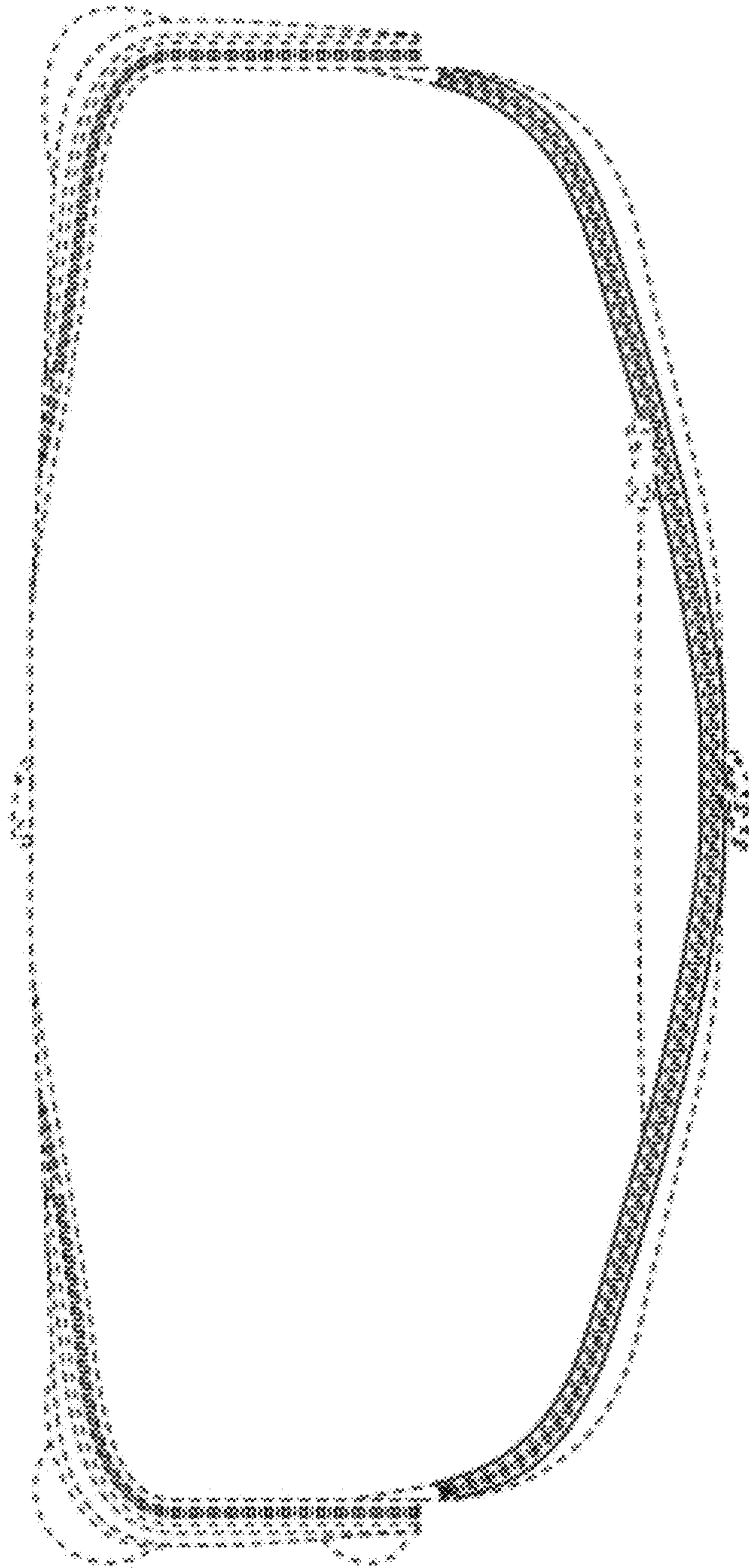

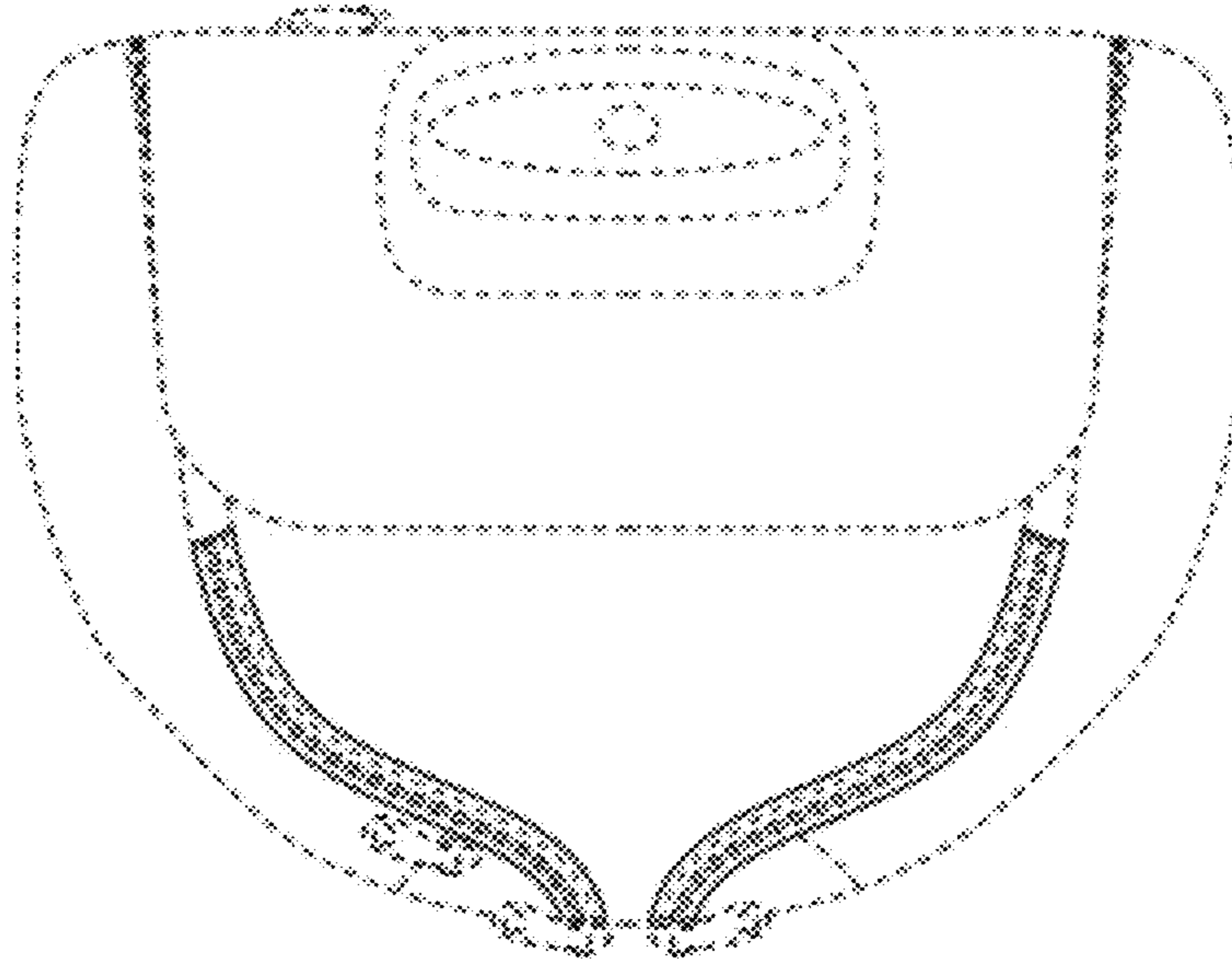

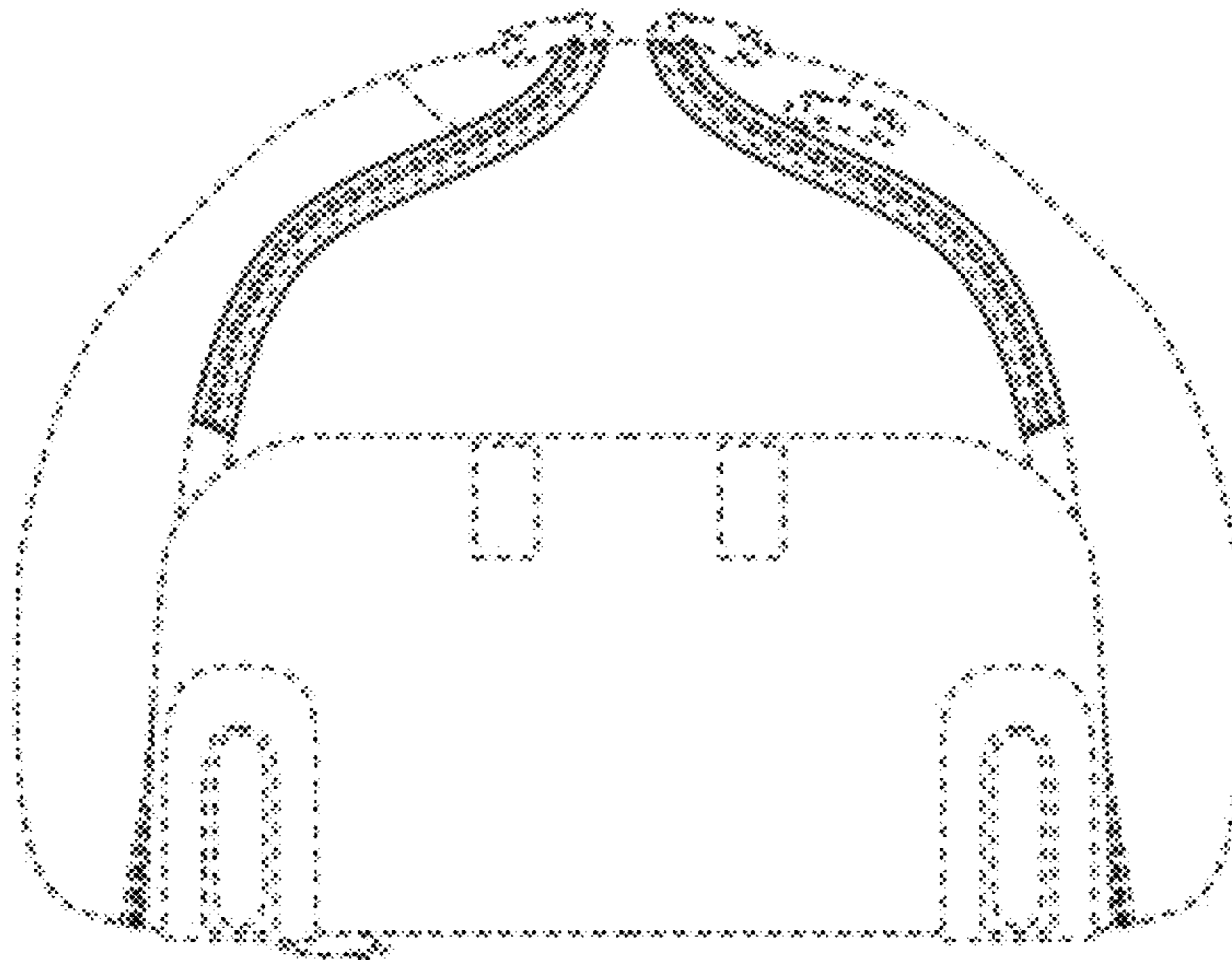
