(57) **CLAIM**

I claim the ornamental design for a sheet for vehicle seats, as shown and described.

DESCRIPTION

The sole FIGURE is a surface view of a sheet for vehicle seats according to the design claimed.

The broken line perimeter represents the boundaries of the claim and forms no part thereof. The thickness and the rear of the sheet for vehicle seats form no part of the claimed design.
