DESCRIPTION

FIG. 1 is a top, front, right perspective view of a dispenser showing our new design;

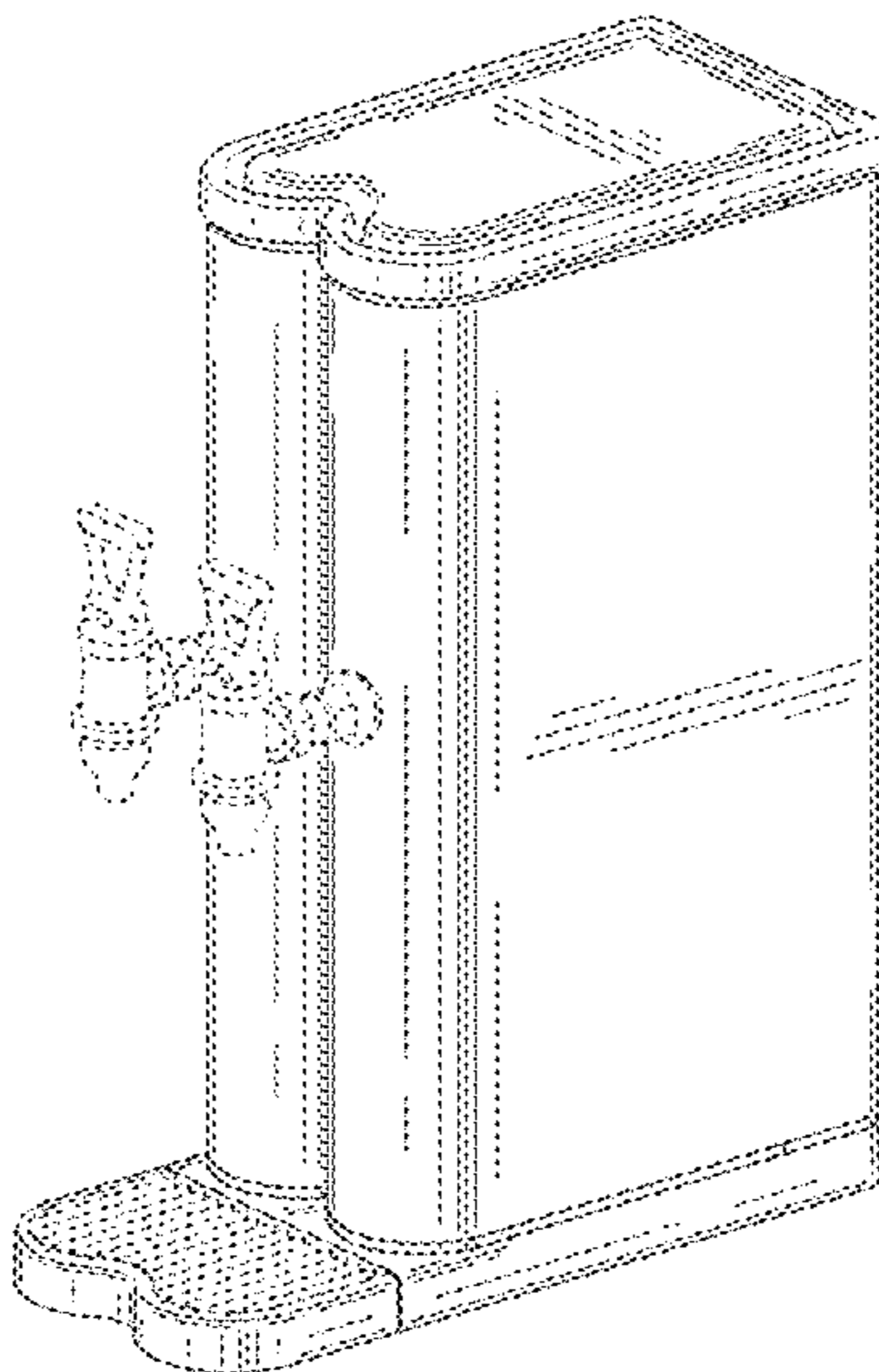
FIG. 2 is a front view thereof;

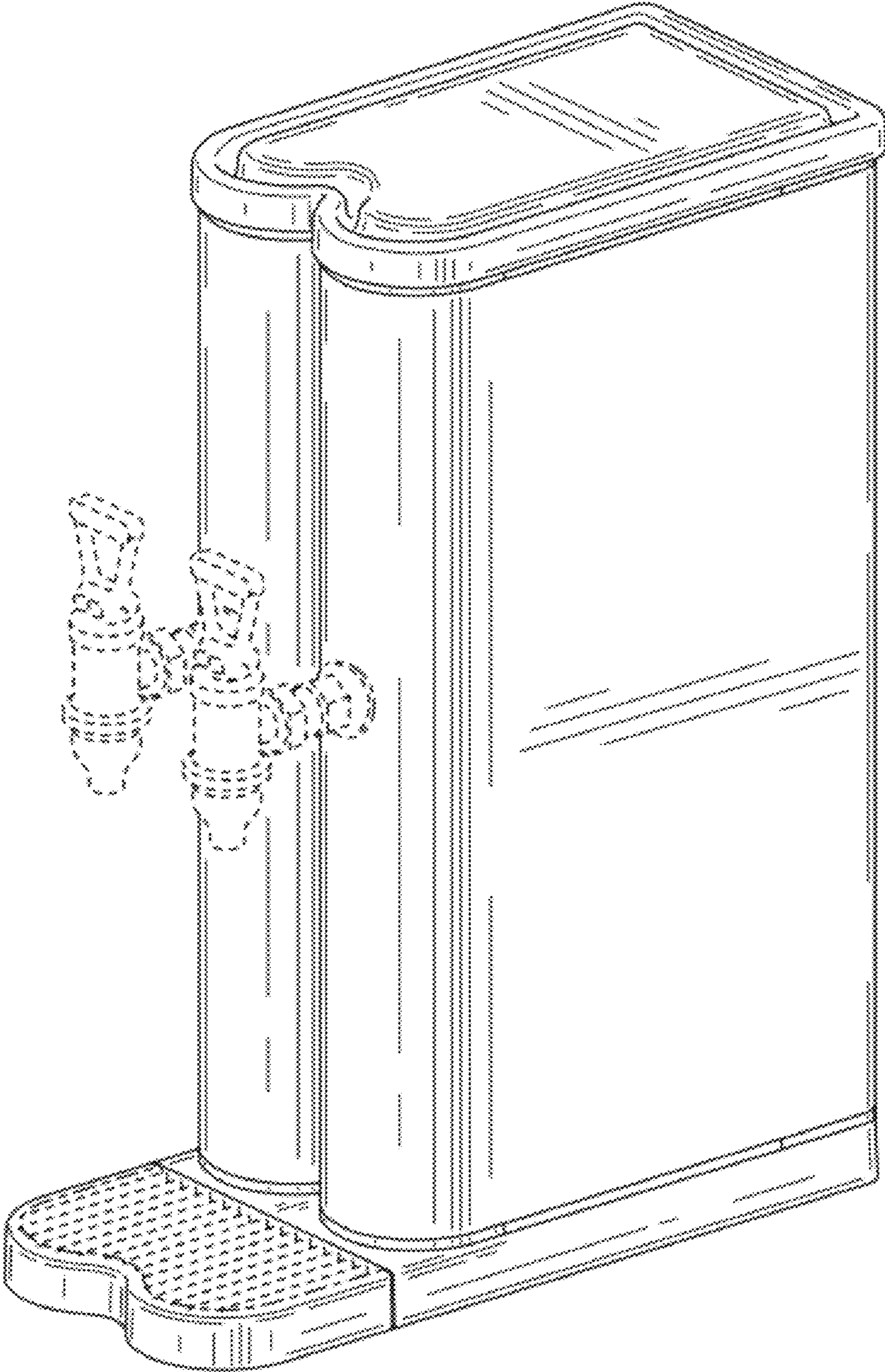

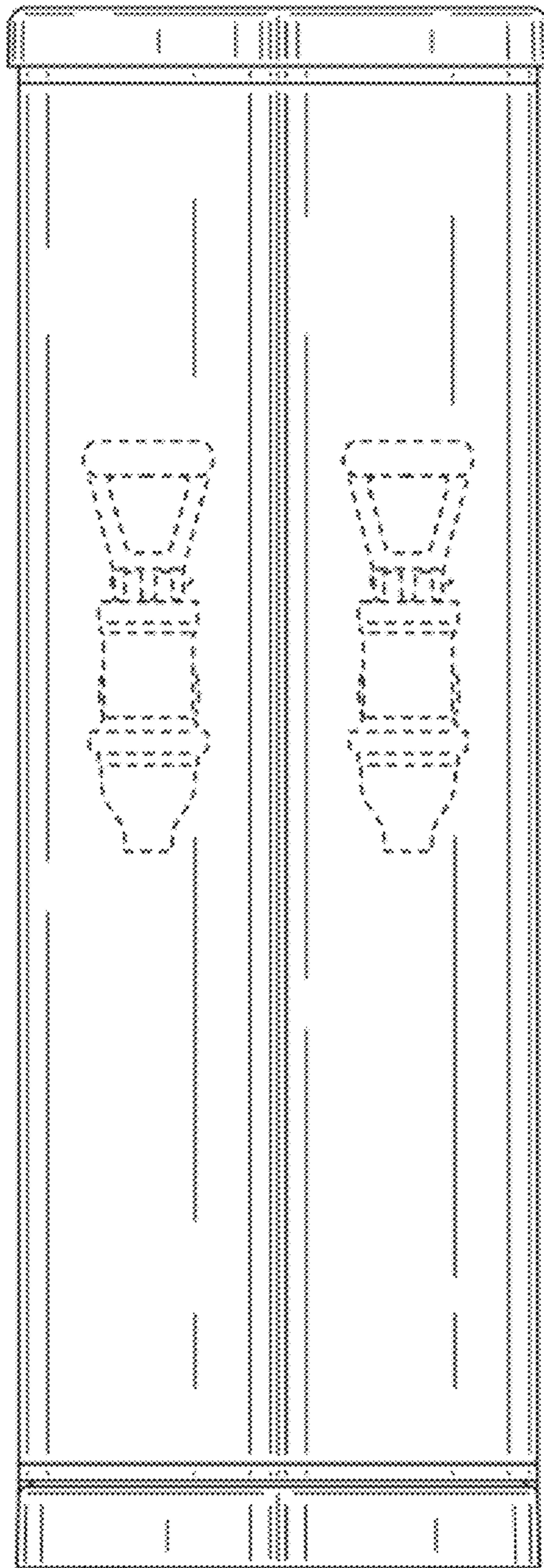

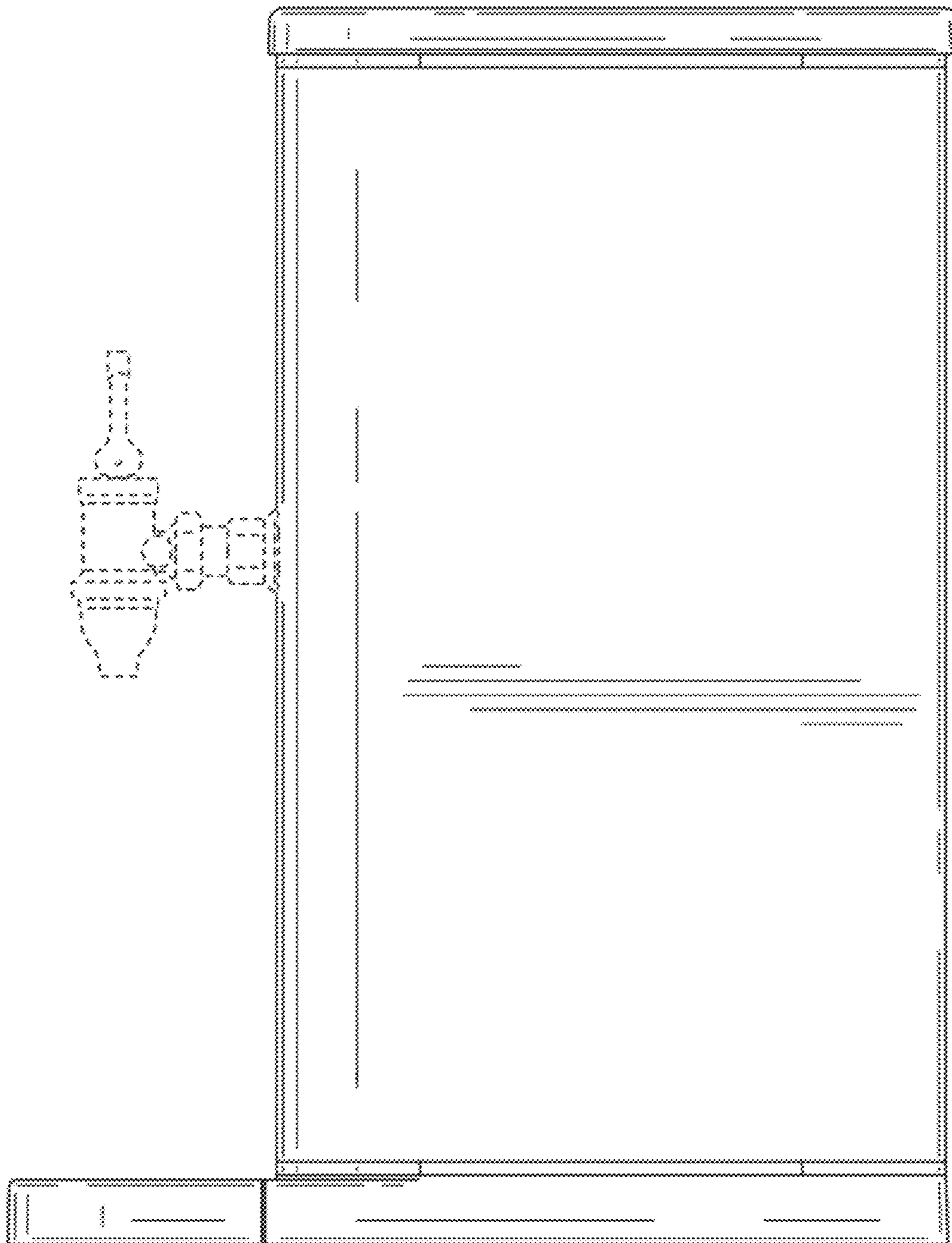

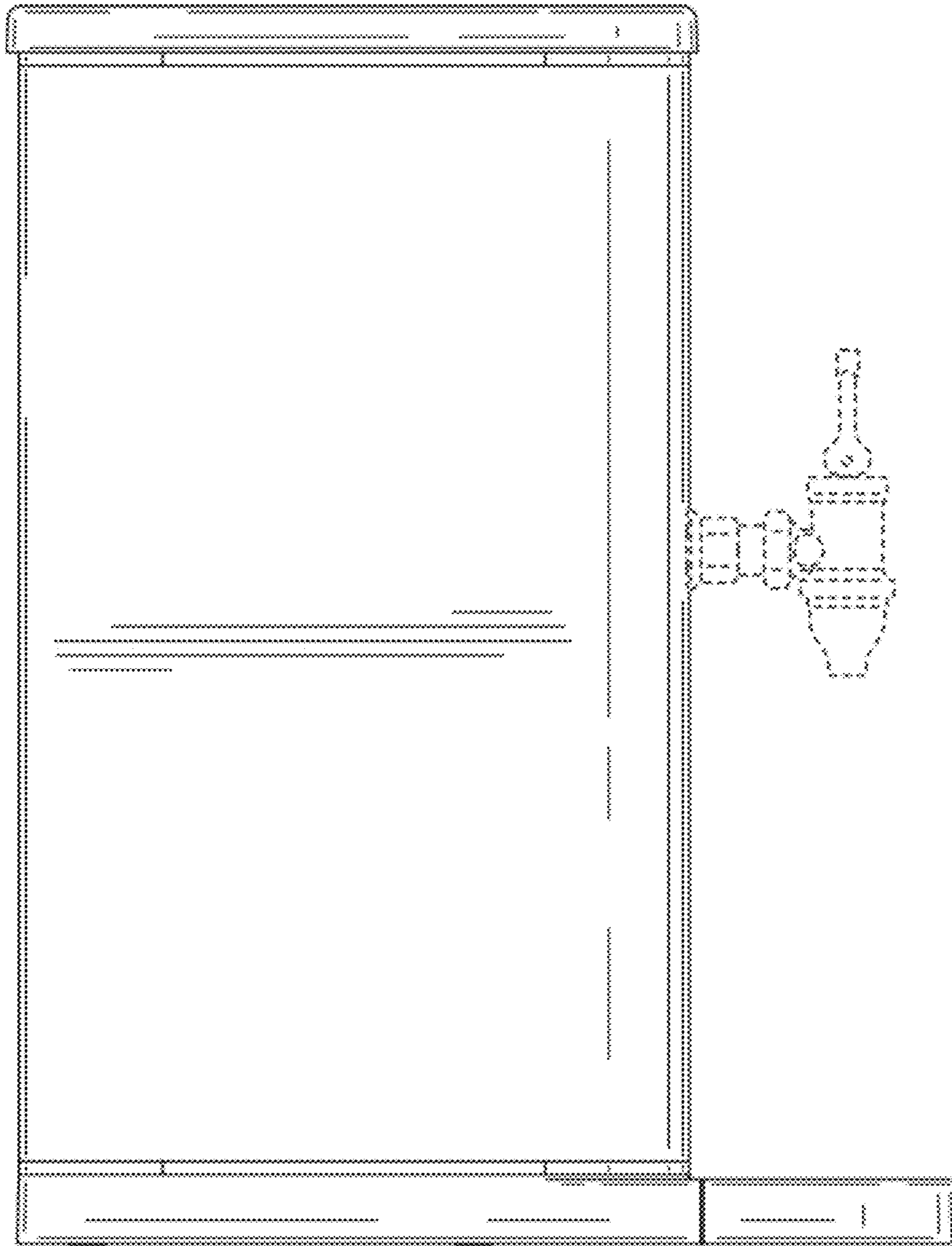
