FIG. 1 is a top, side and front perspective view of a condiment server showing my new design;

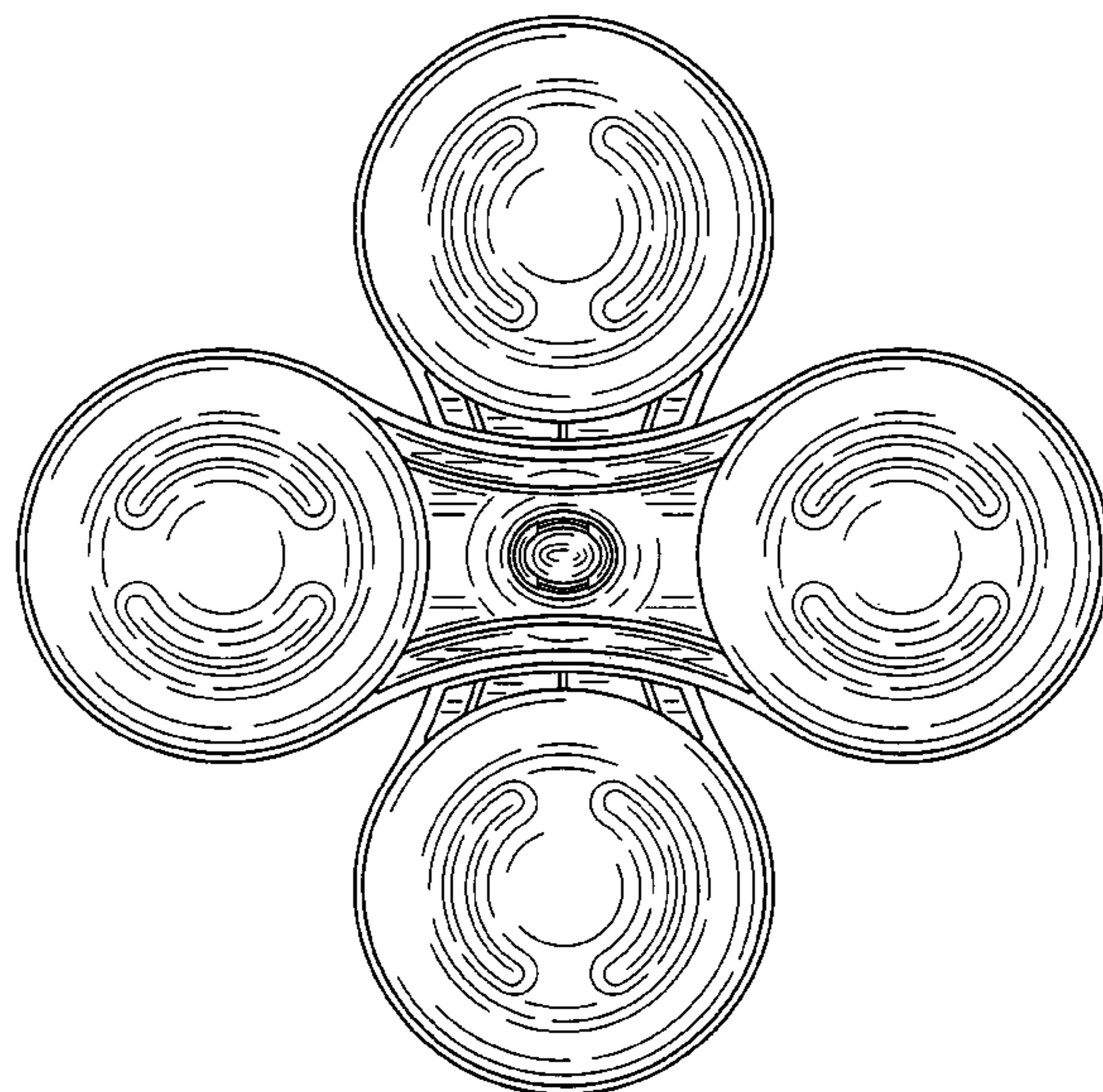
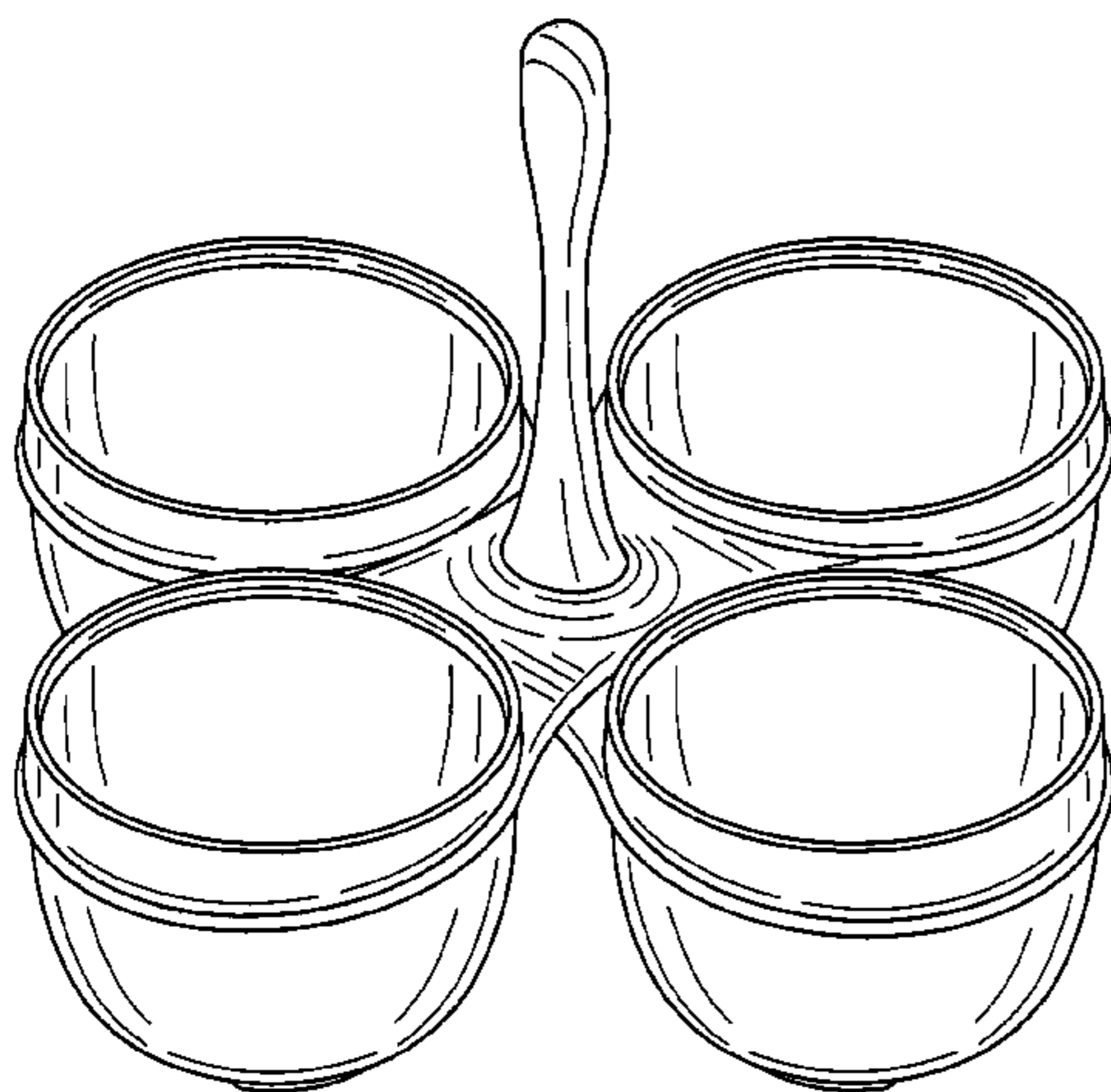
FIG. 2 is a front elevation view, the rear elevation being identical thereto;

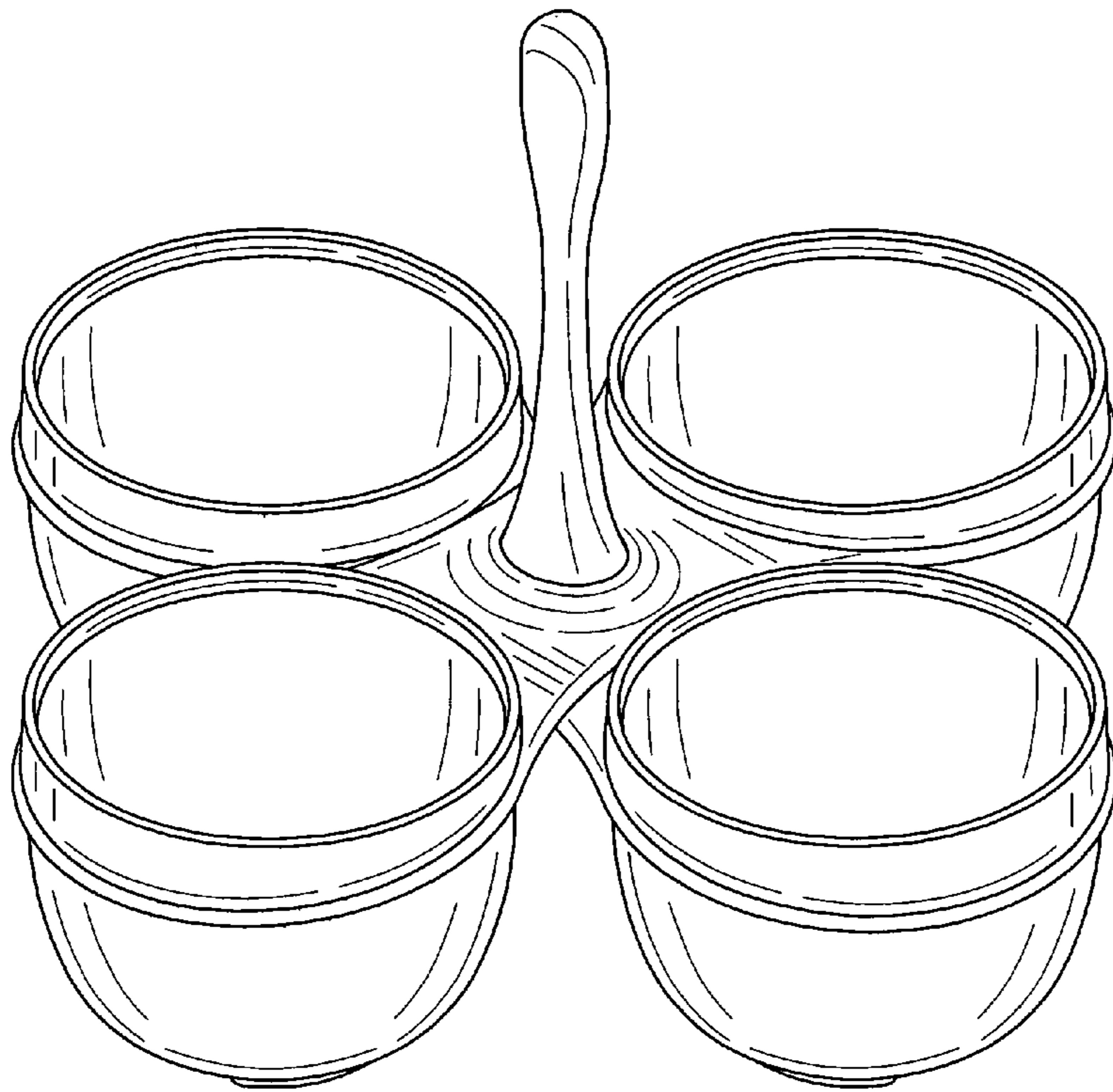

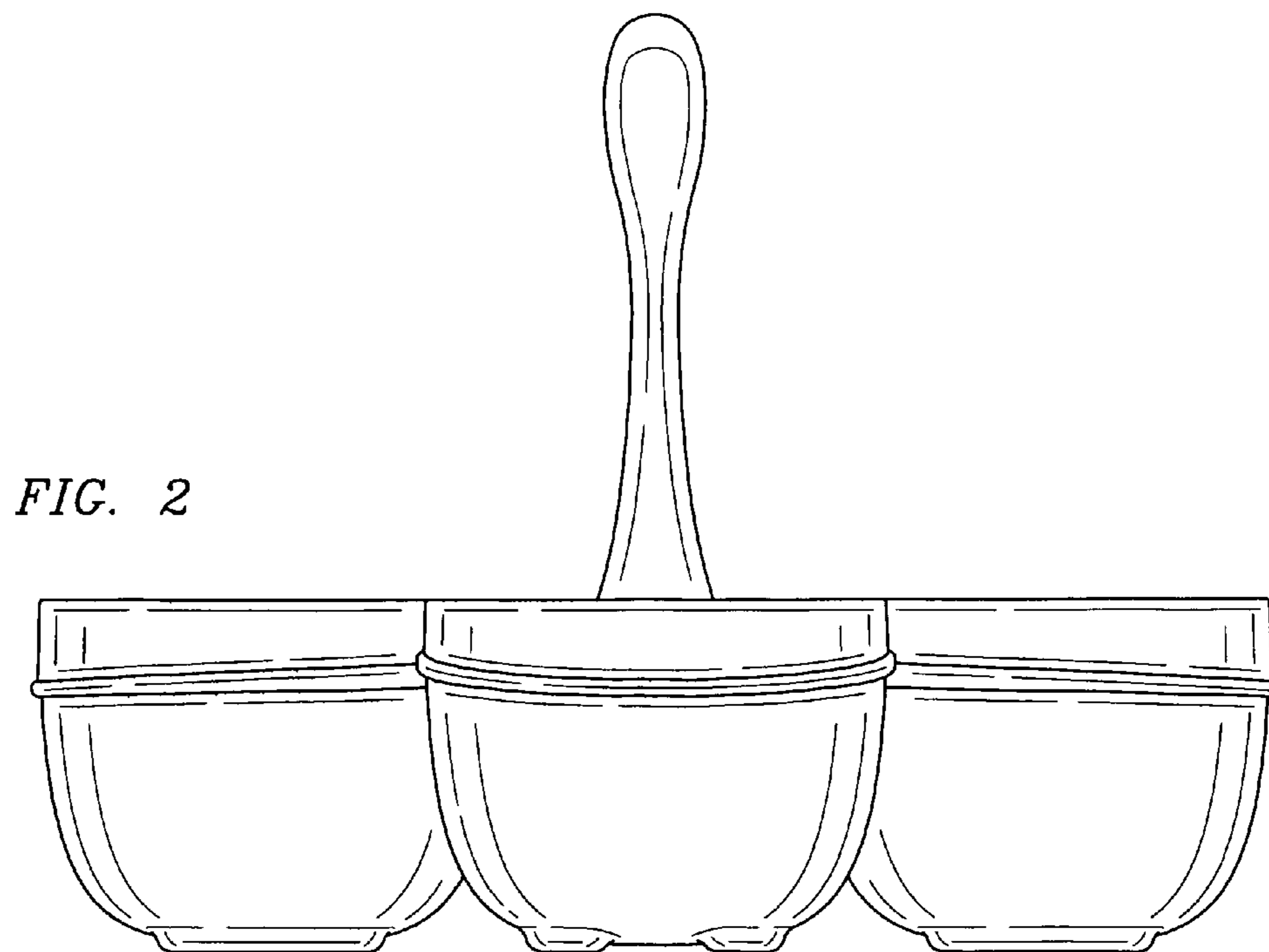

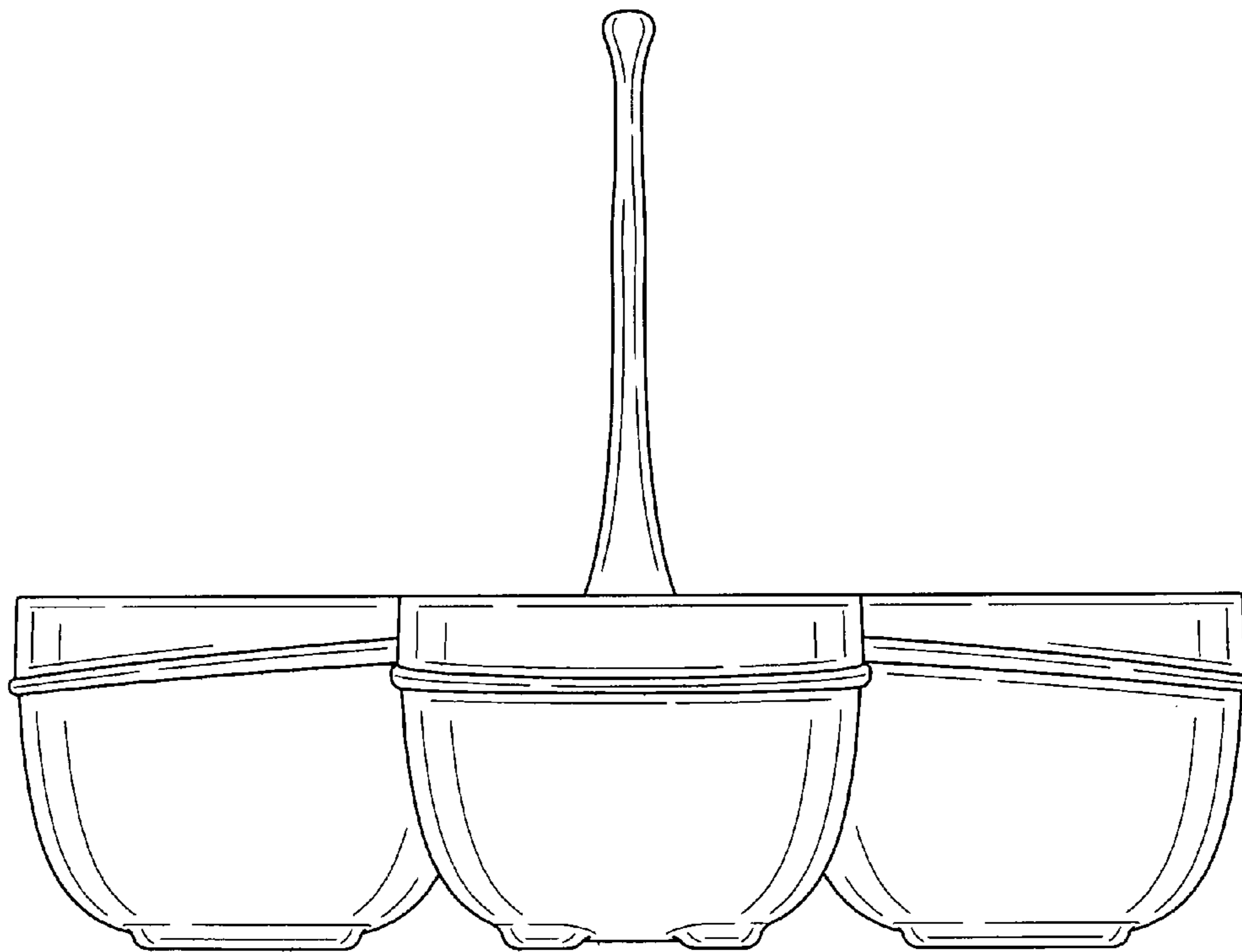

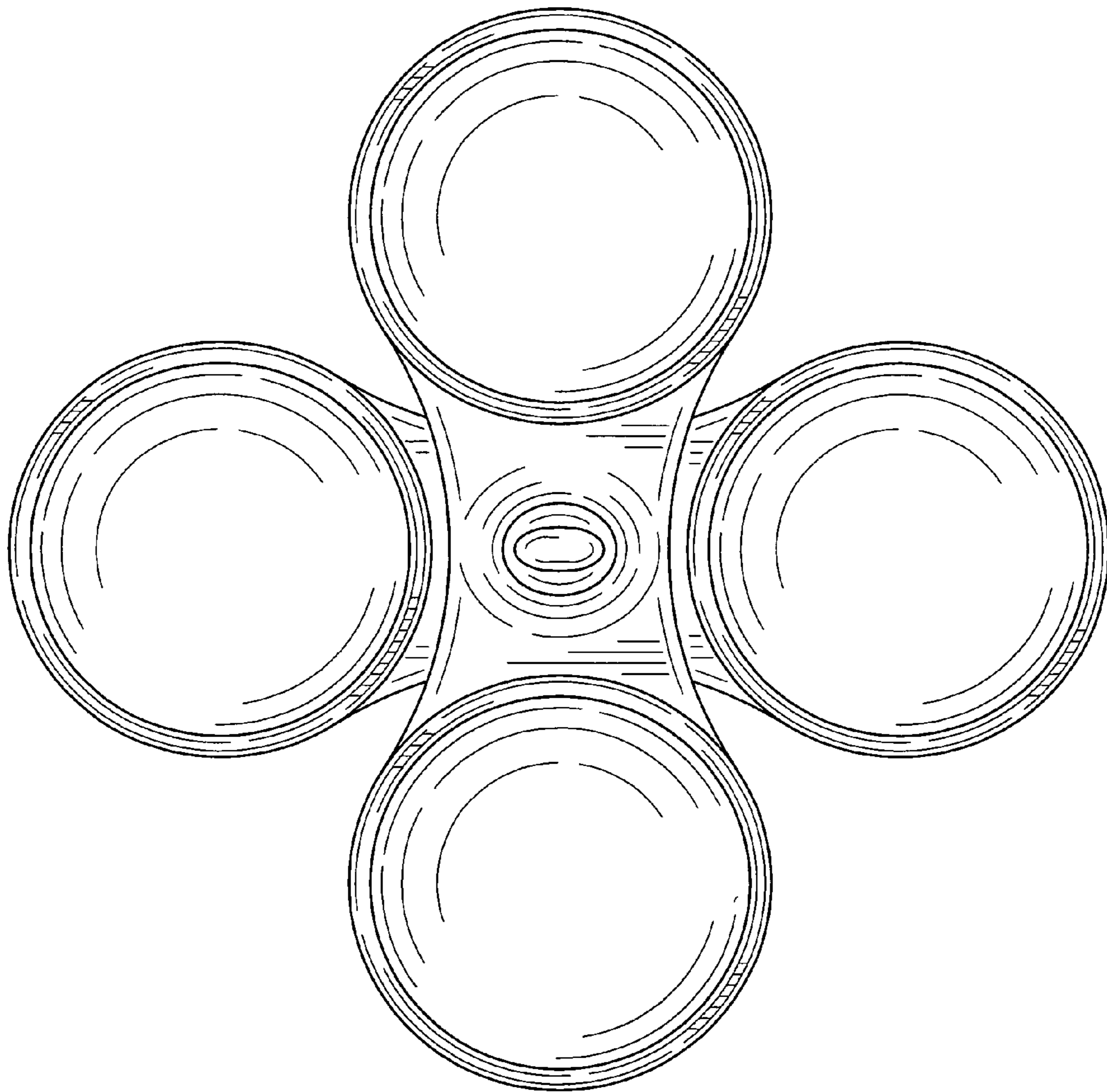

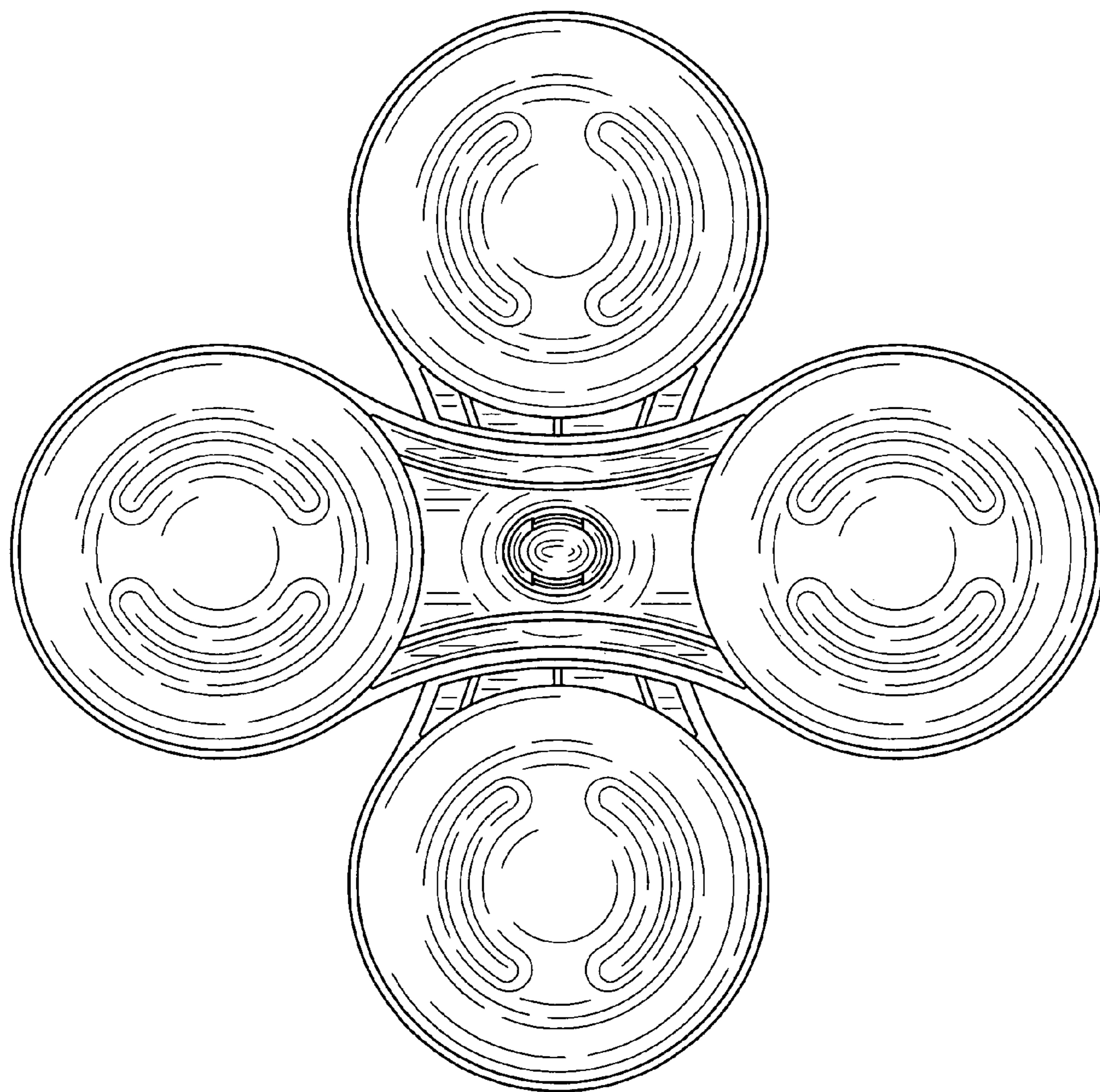
