FIG. 3 is a top edge plan view thereof;

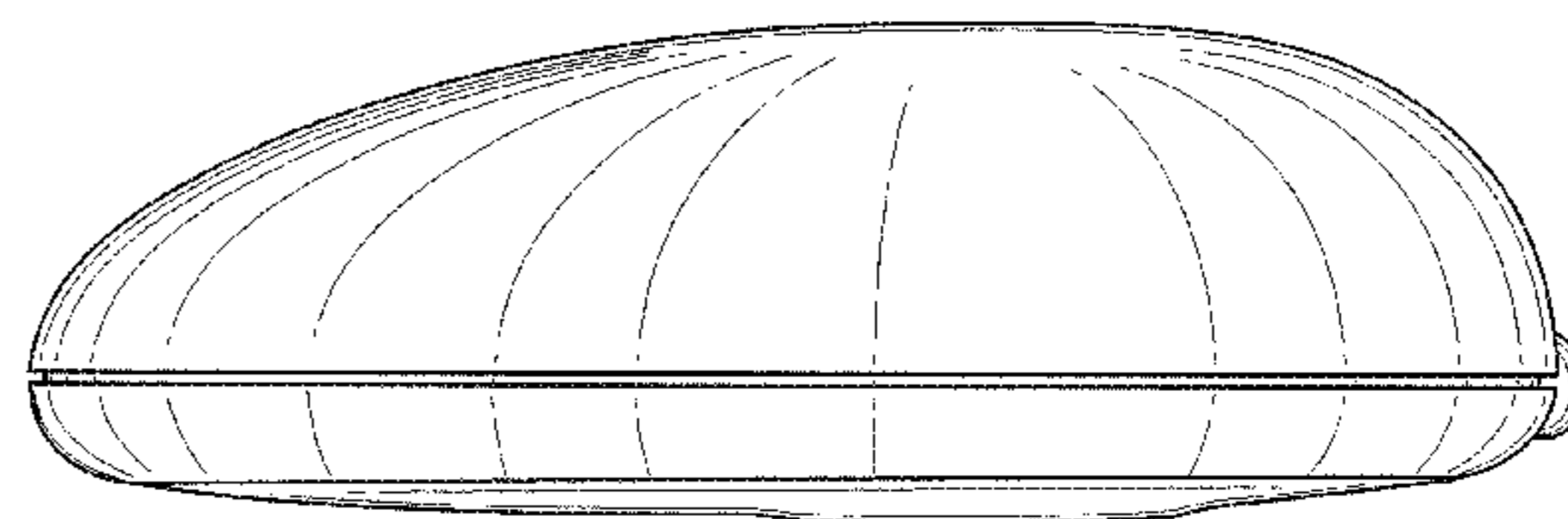
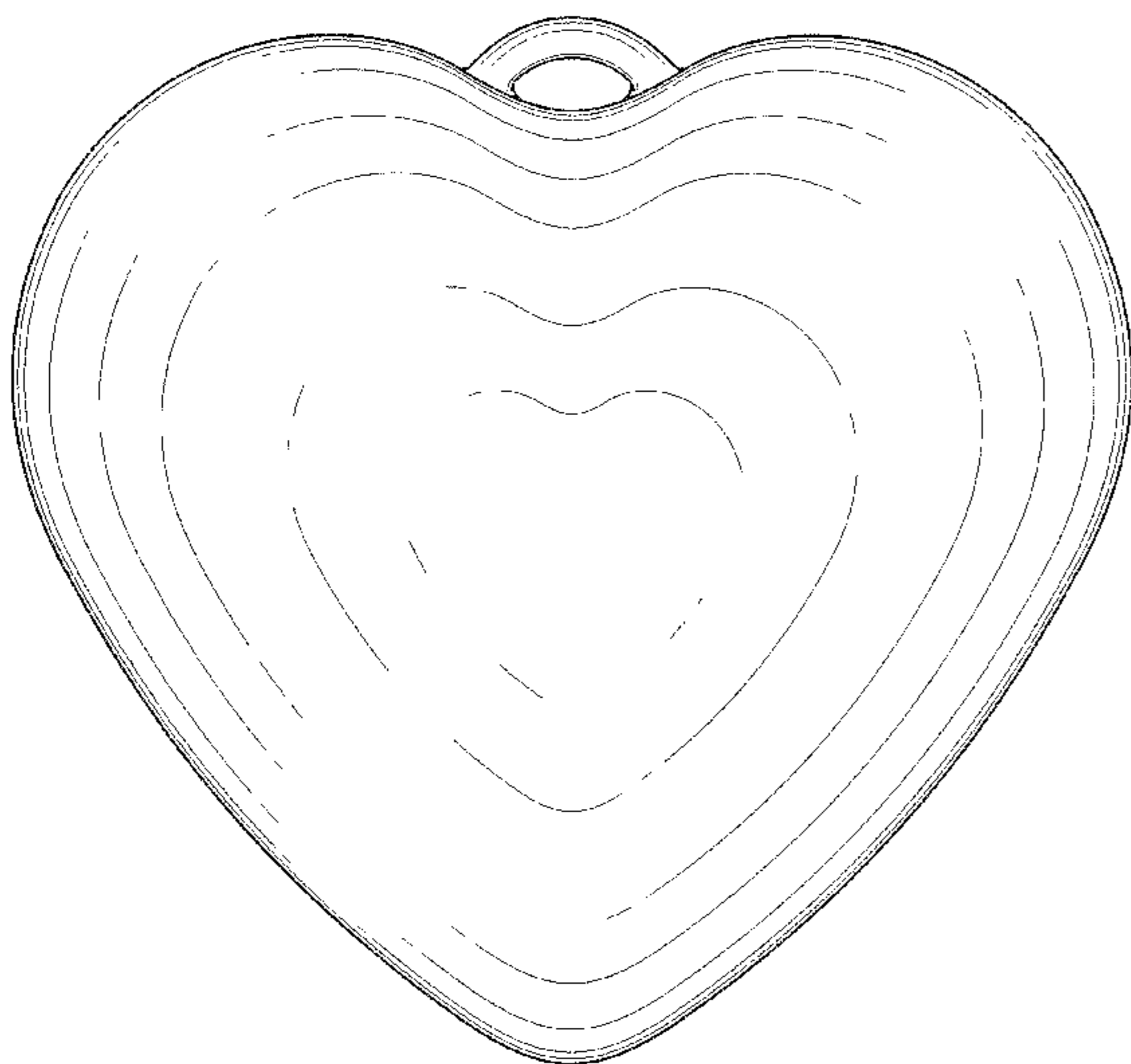
FIG. 4 is a bottom edge plan view thereof;

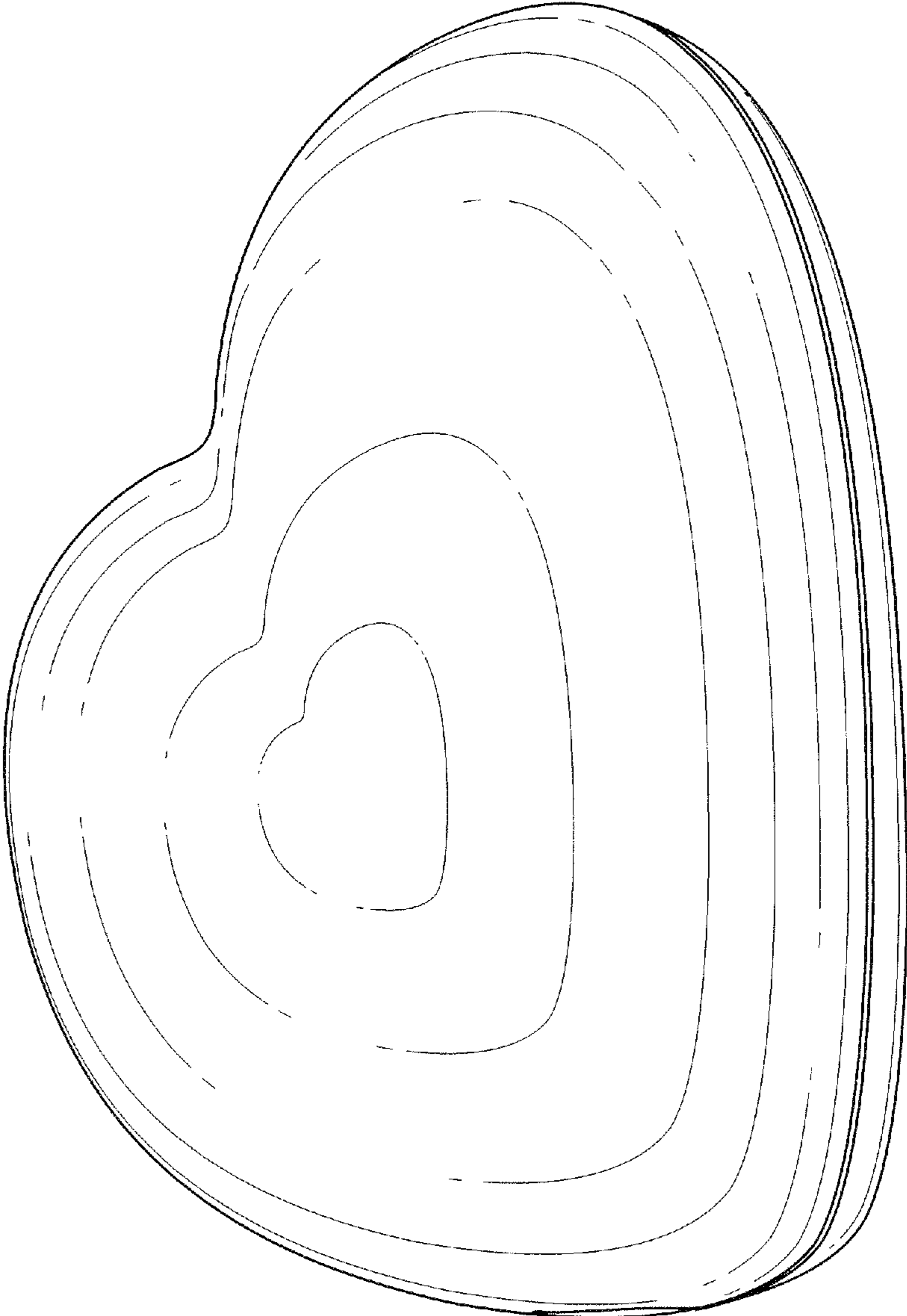
FIG. 5 is a left edge plan view thereof;

FIG. 6 is a right edge plan view thereof; and,

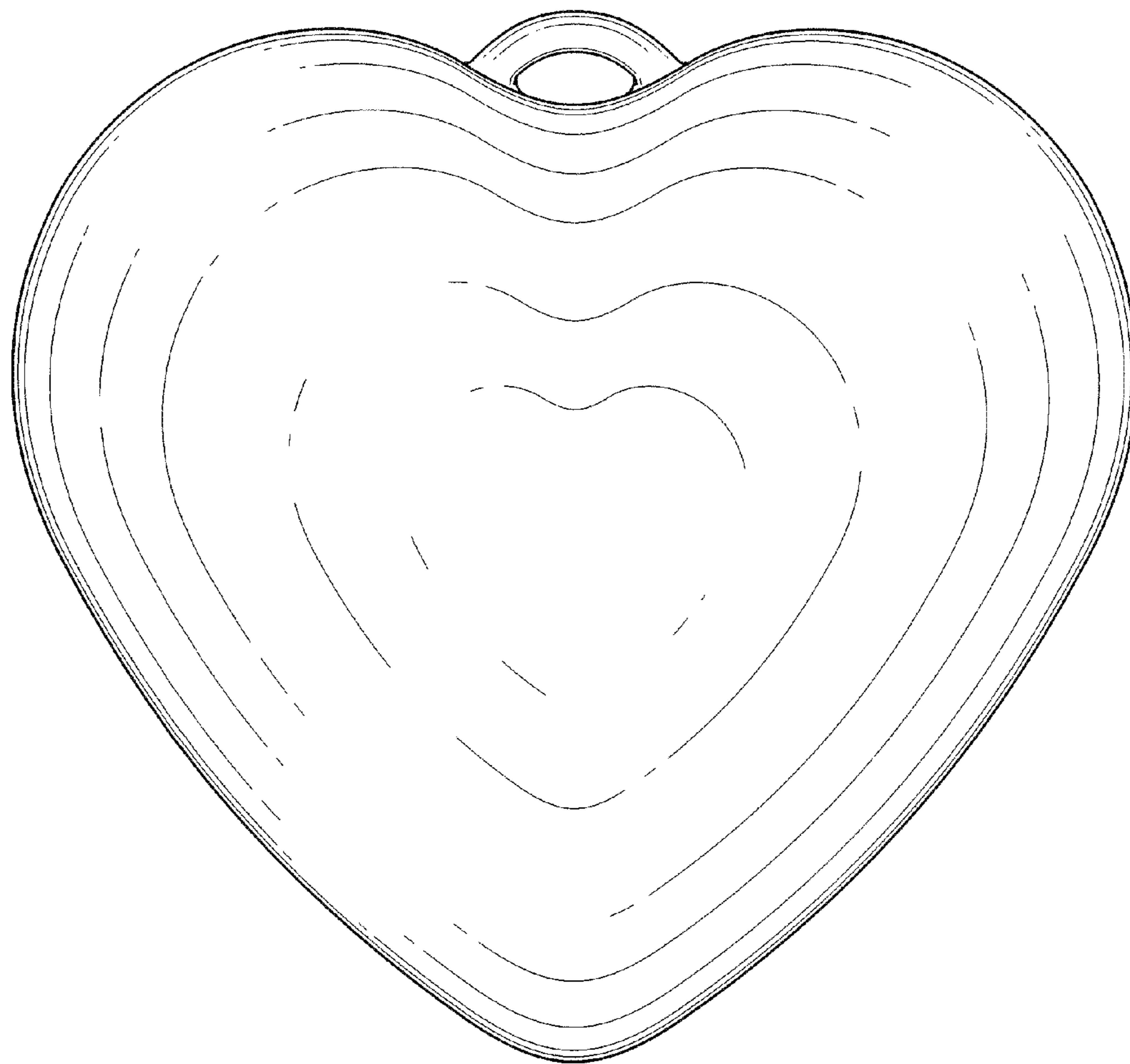
FIG. 7 is a back plan view thereof.

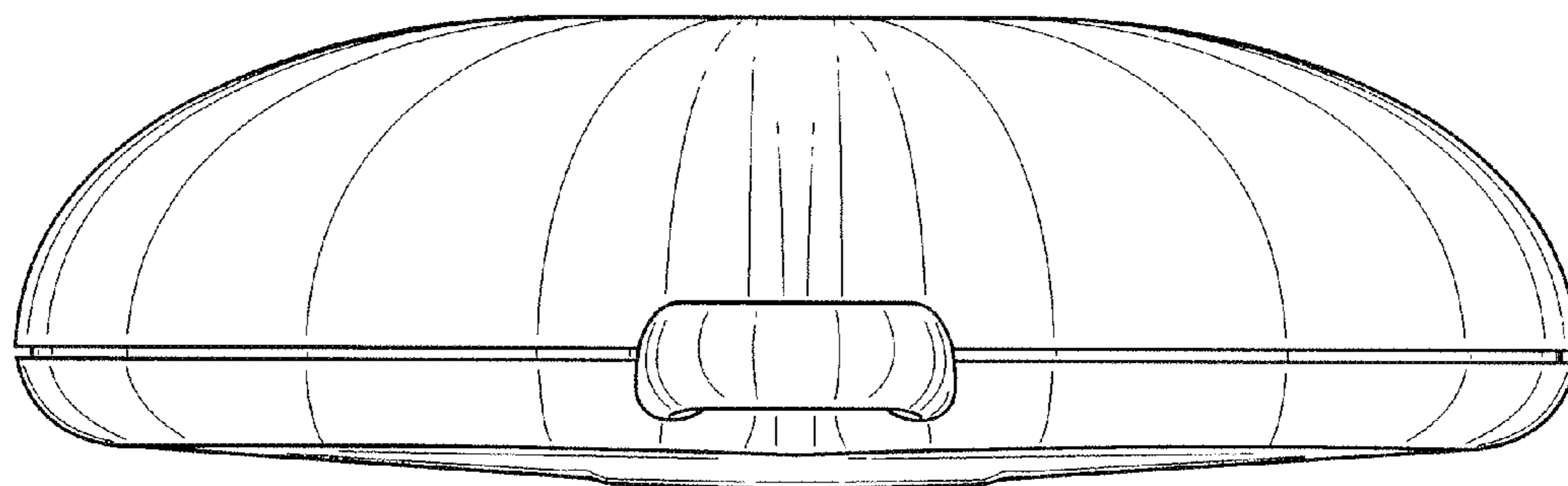




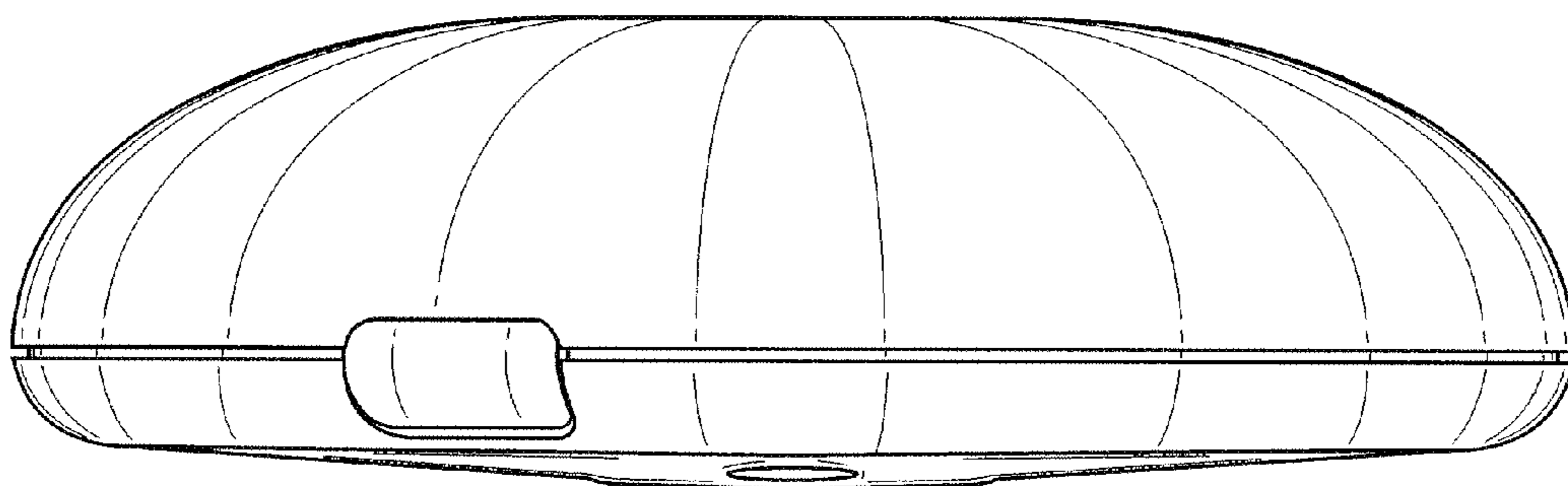

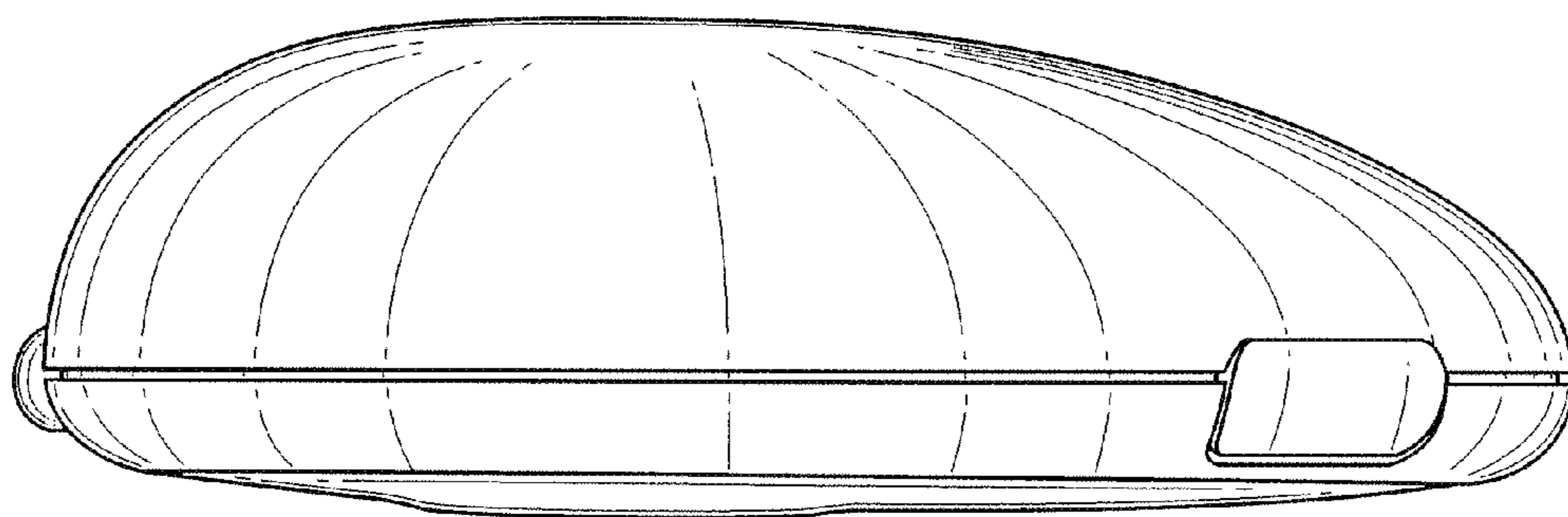

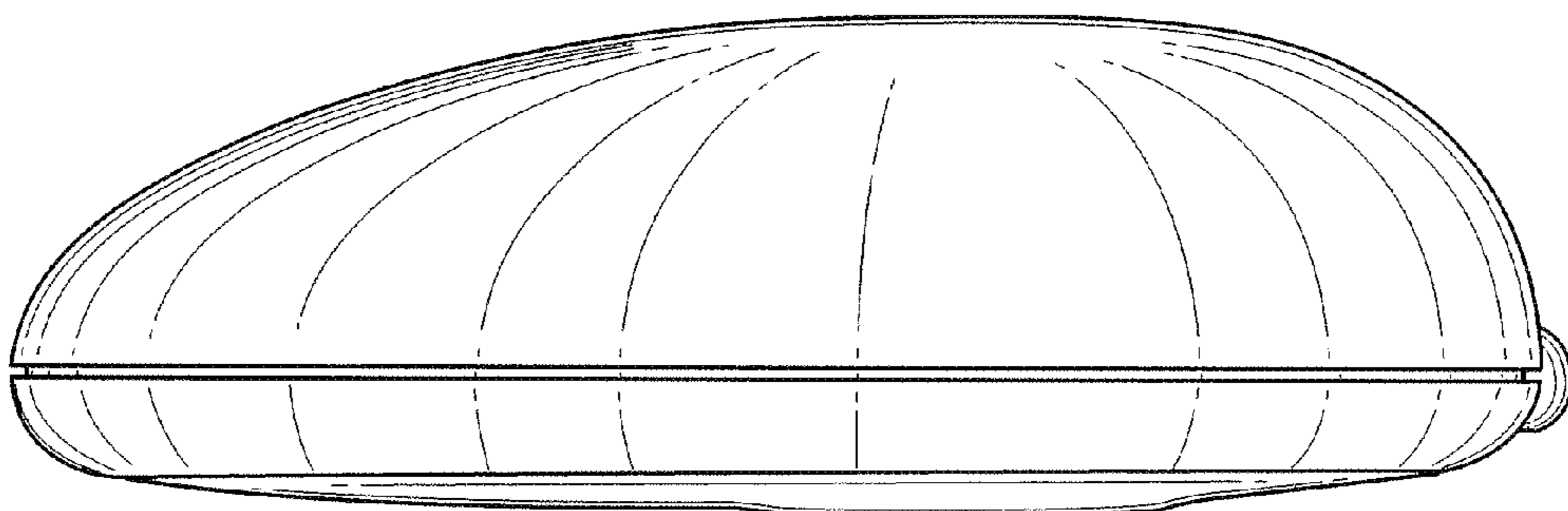

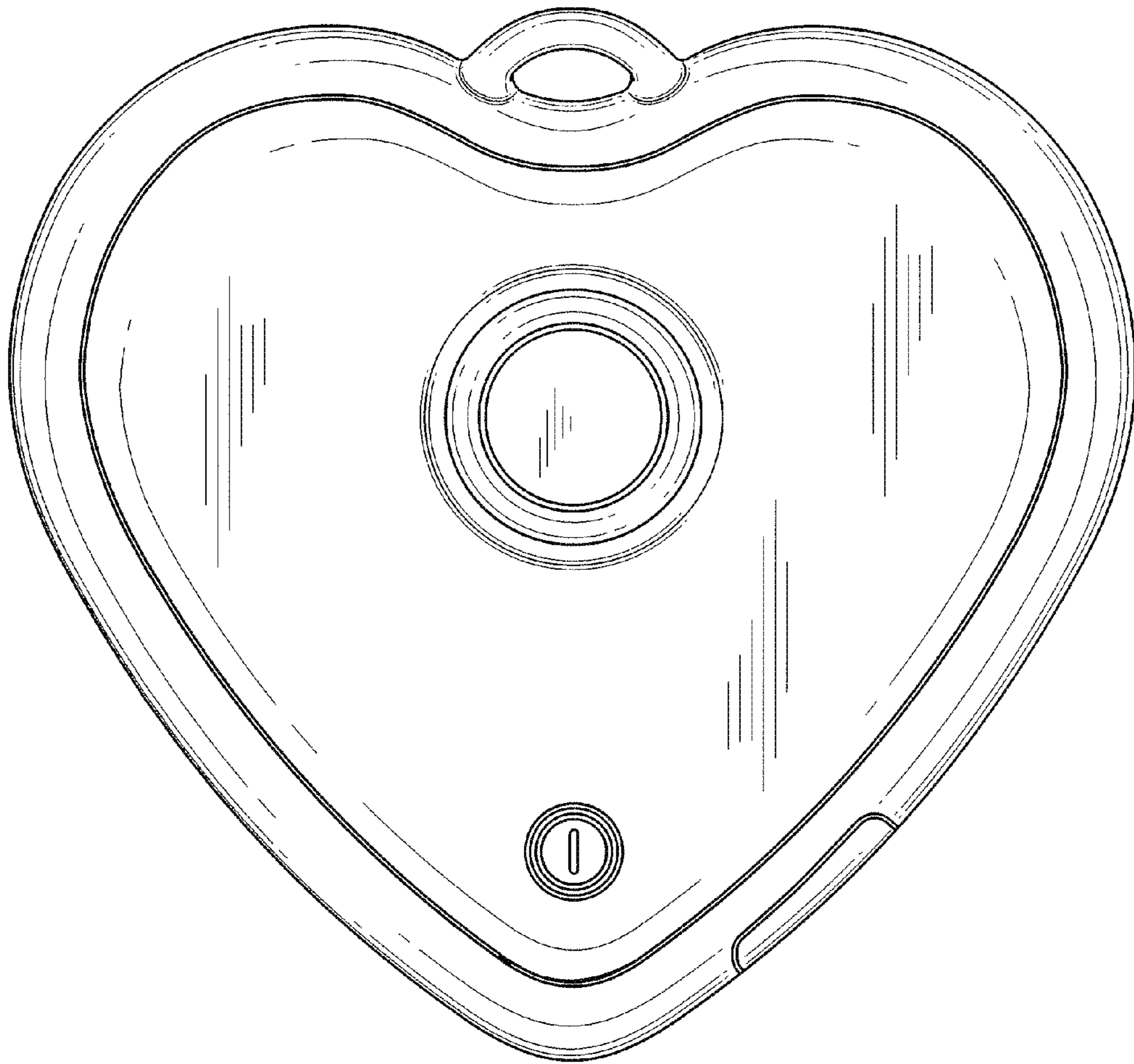
