The ornamental design for a display screen with animated graphical user interface, as shown and described.

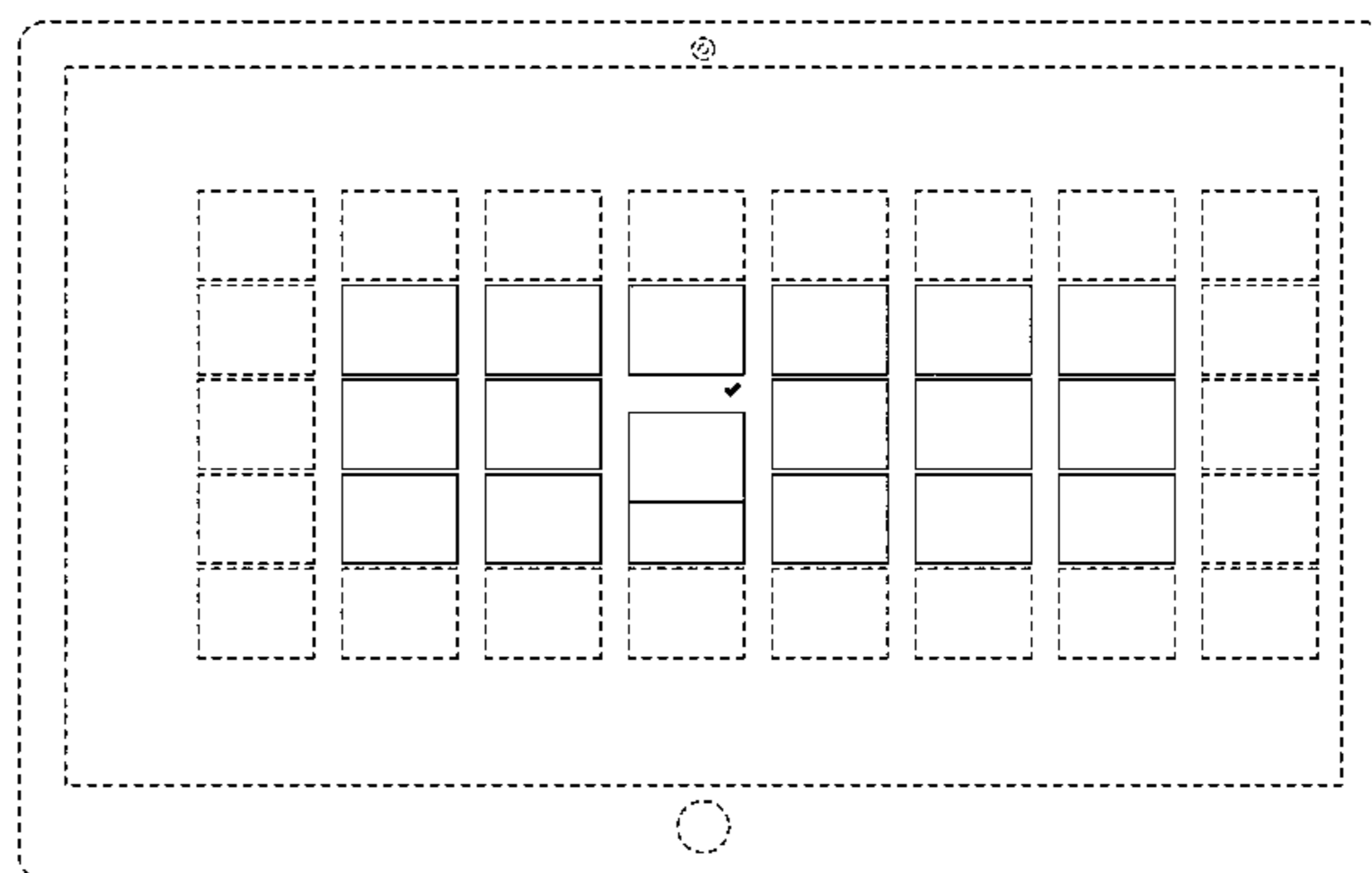
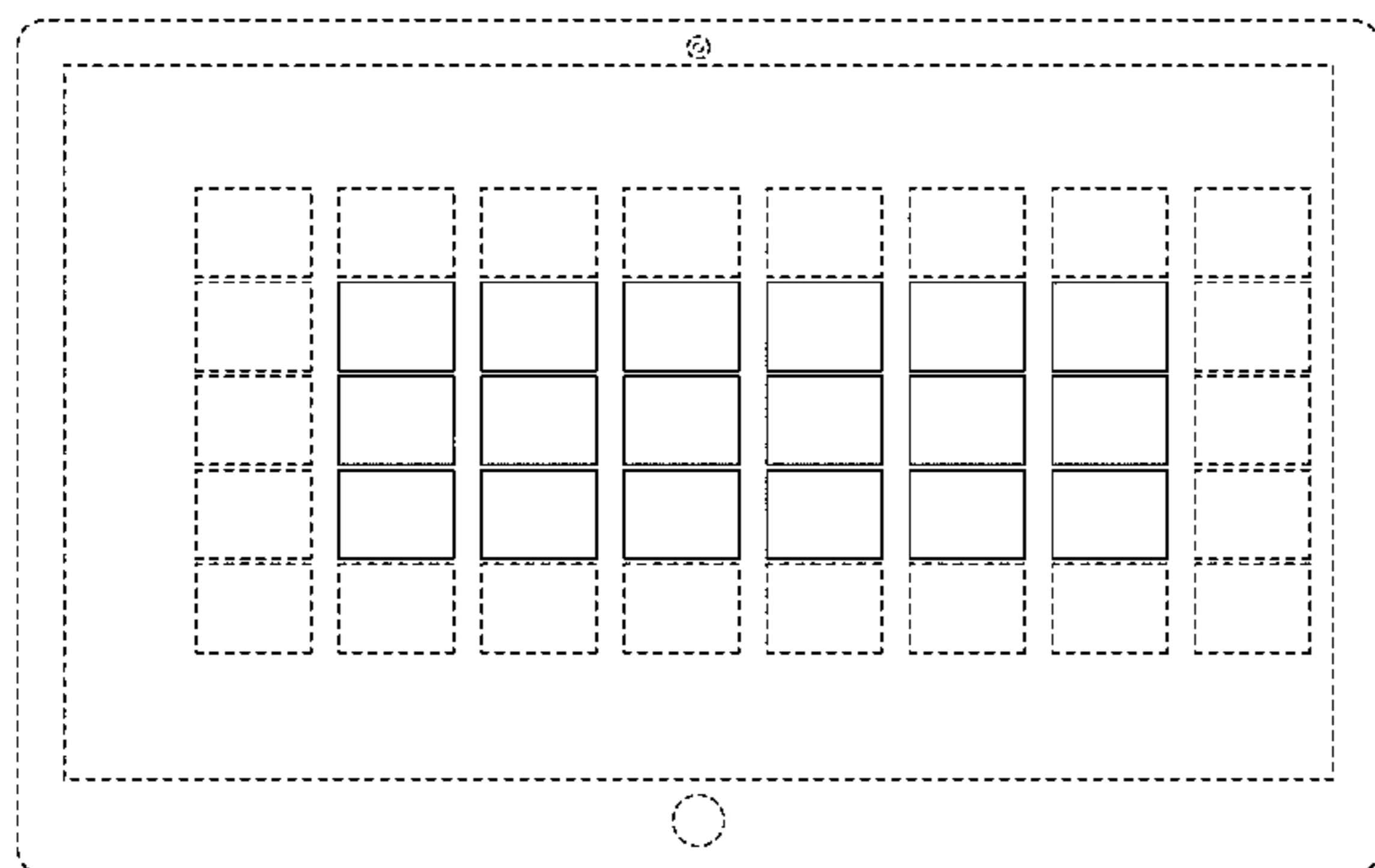
**DESCRIPTION**

FIG. 1 is the first image in a sequence for a display screen with animated graphical user interface showing the new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; FIG. 4 is the fourth image thereof; FIG. 5 is the fifth image thereof; and, FIG. 6 is the sixth image thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-6. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken line showing of the display screen illustrates the environment of the claimed design and forms no part thereof. The broken line showing of portions of the animated graphical user interface illustrate portions of the animated graphical user interface which form no part of the claimed design.

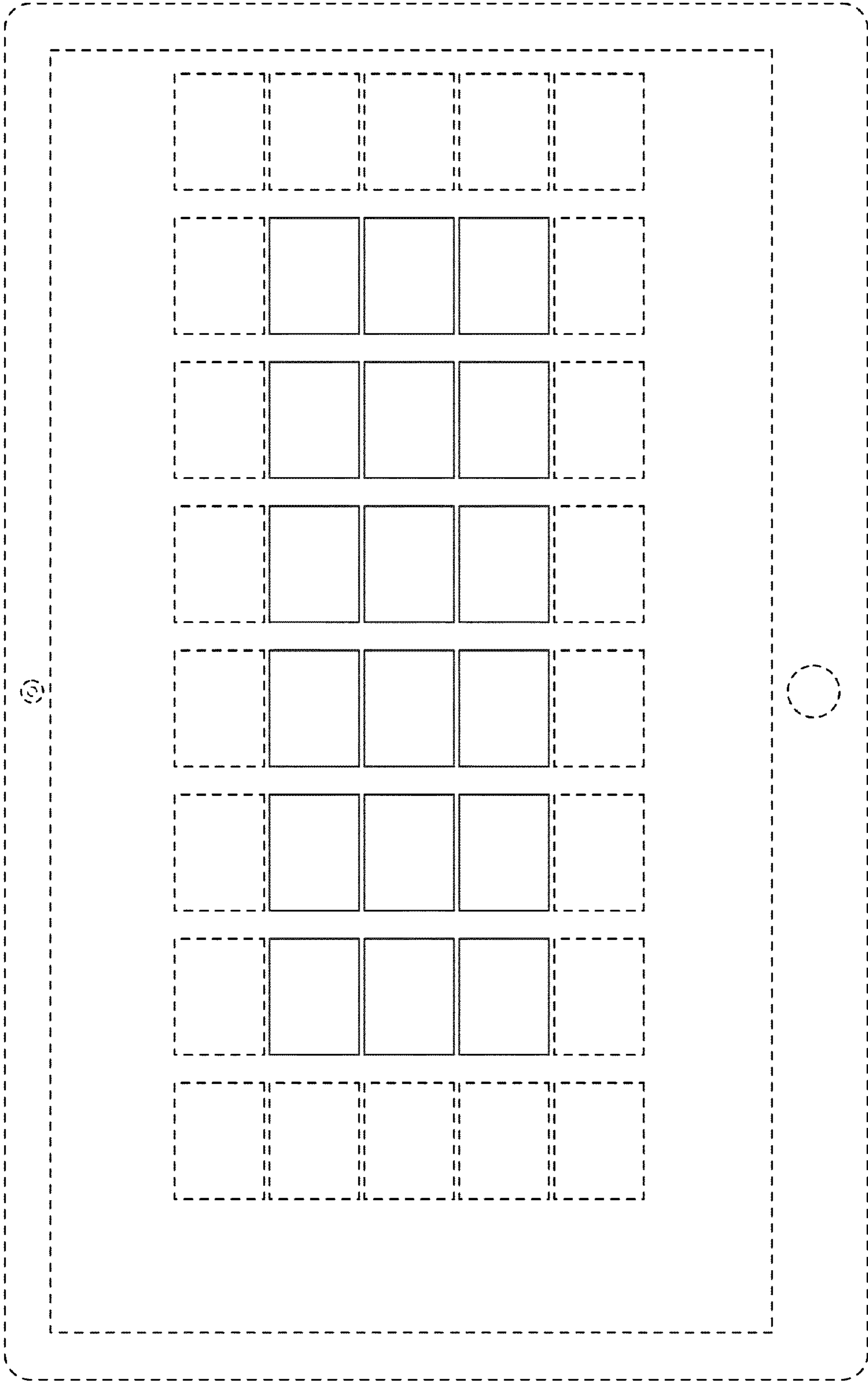

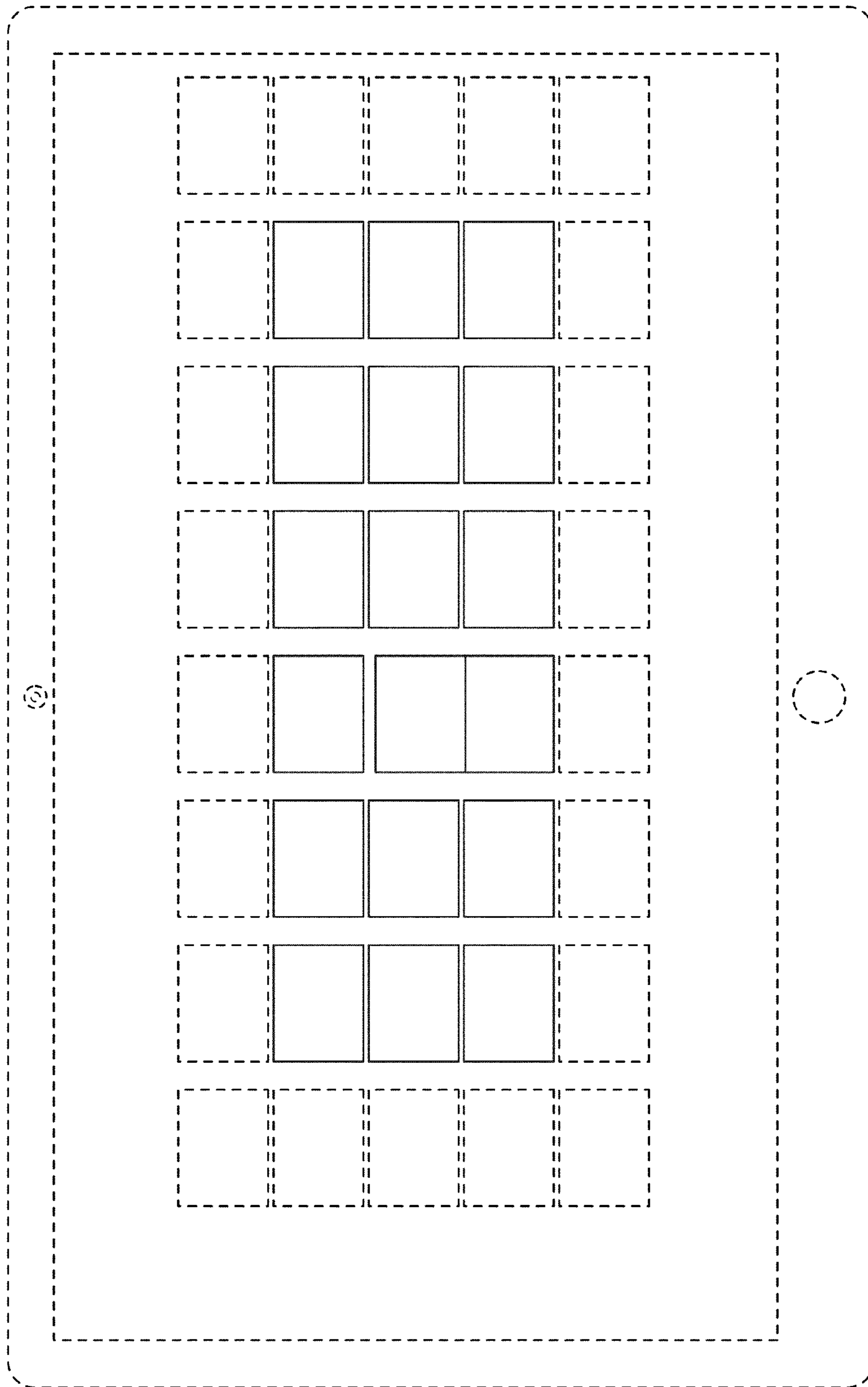

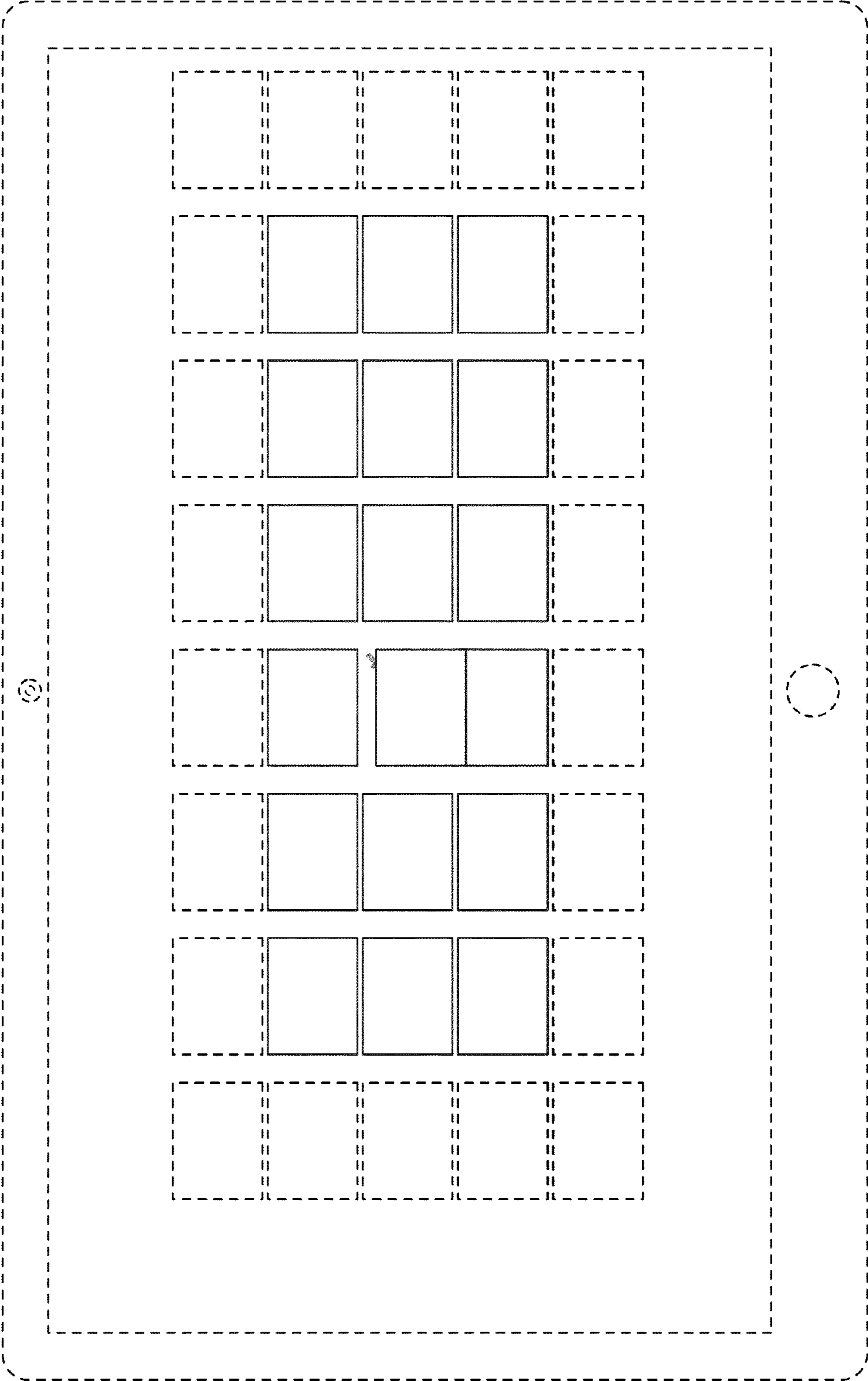

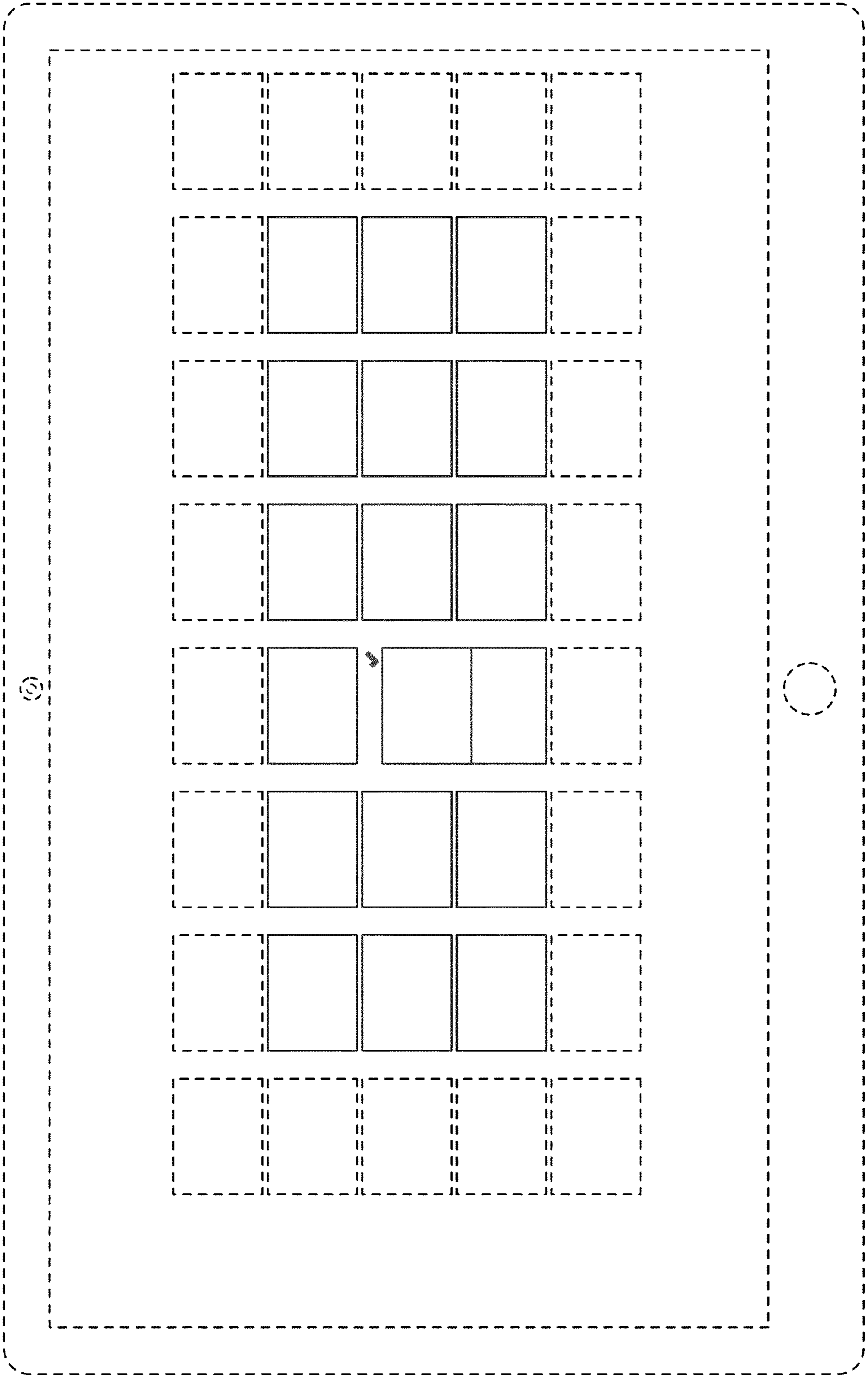

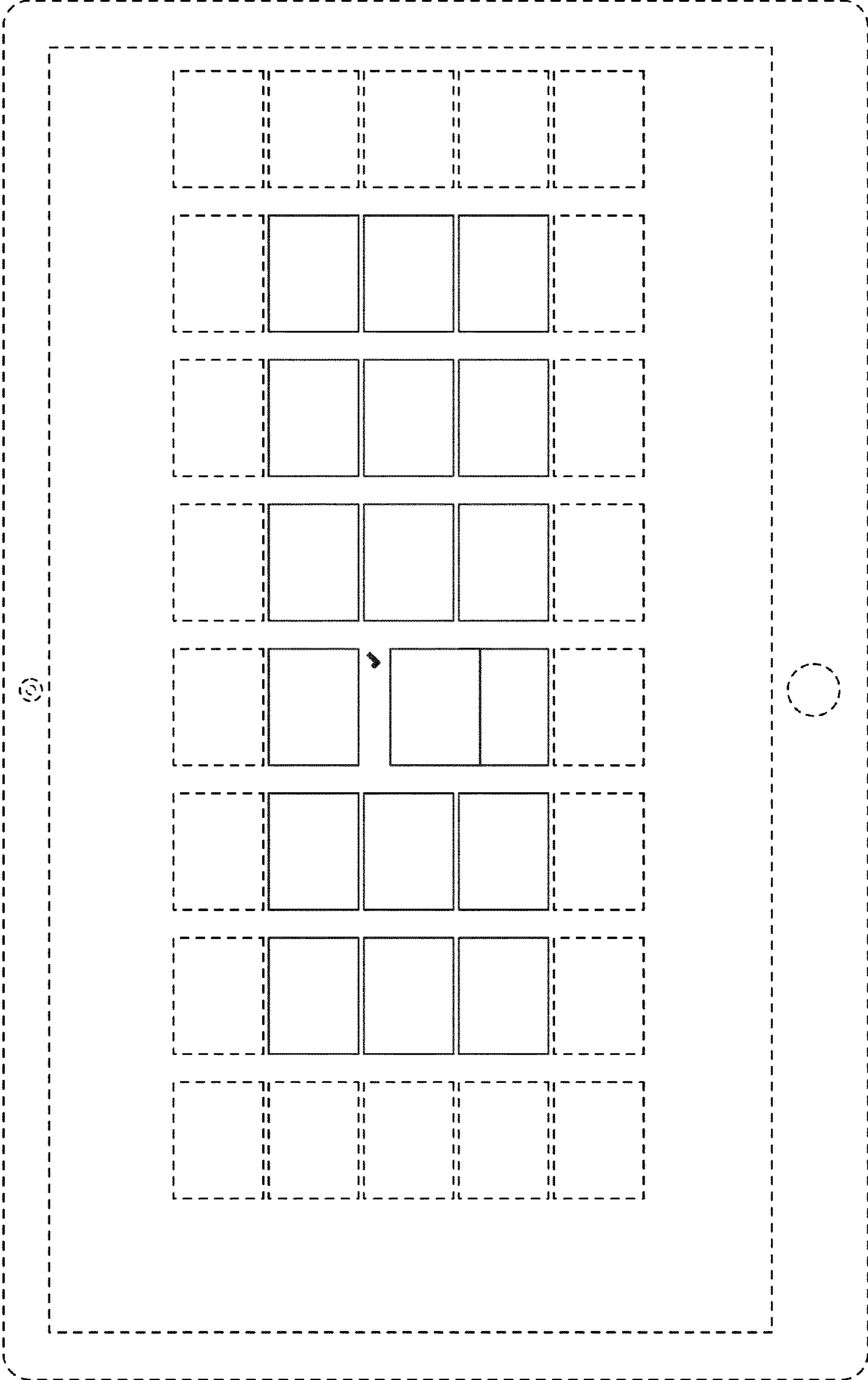

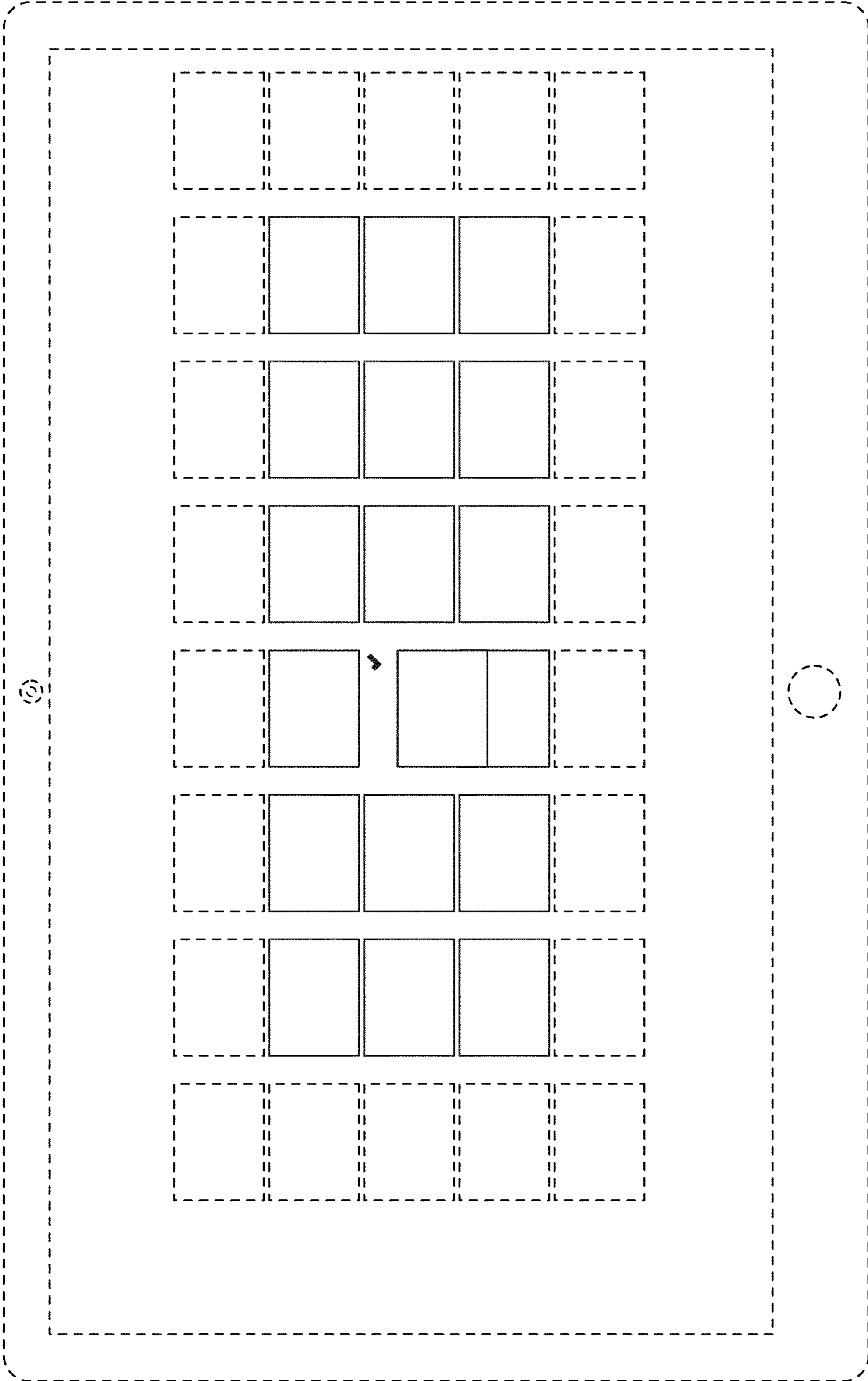
