DESCRIPTION

FIG. 1 is a front perspective view of a point of sales terminal of the present invention;
FIG. 2 is a rear perspective view thereof;

FIG. 5 is a first side view thereof;
FIG. 6 is a second side view thereof;
FIG. 7 is a top view thereof; and

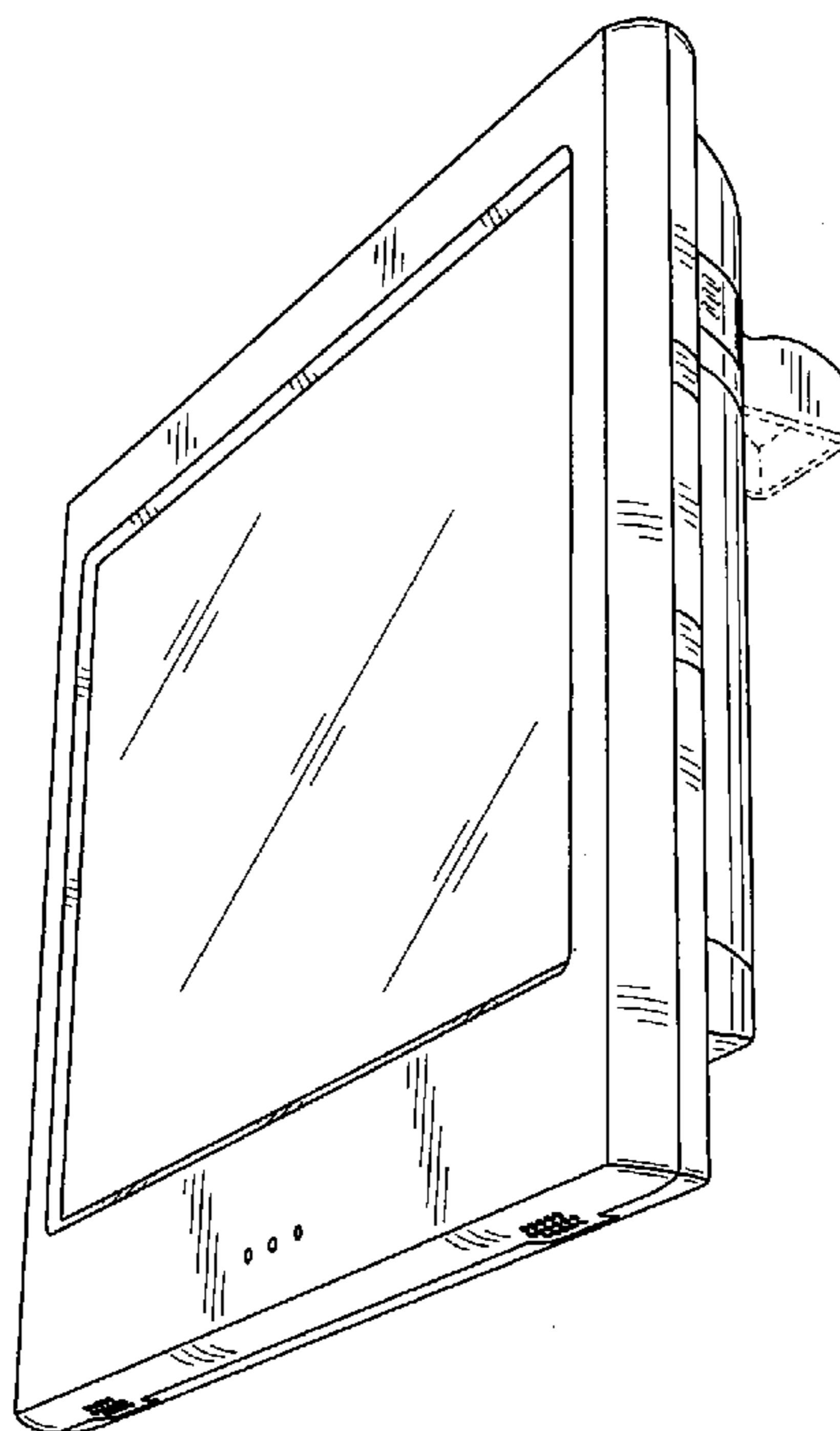

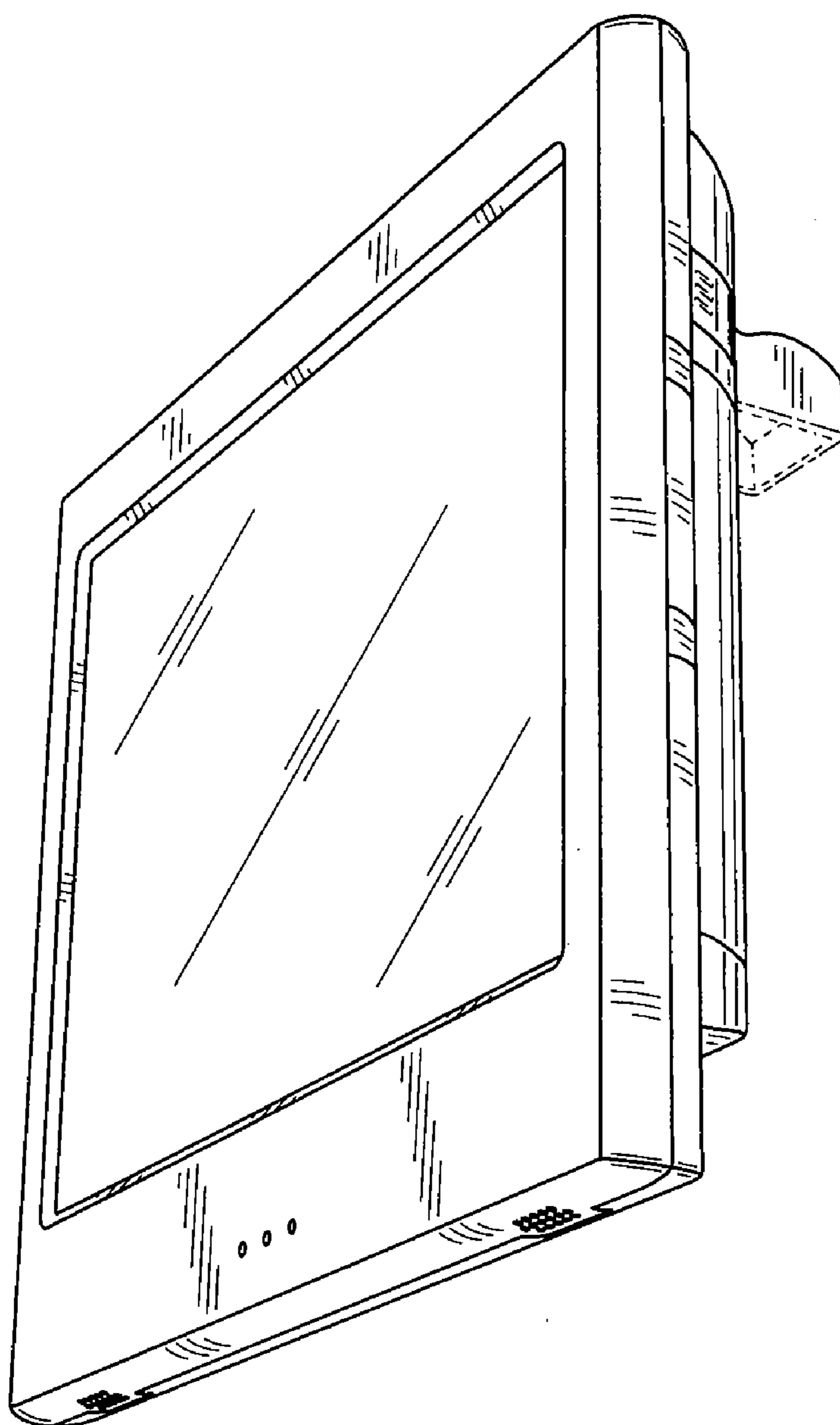

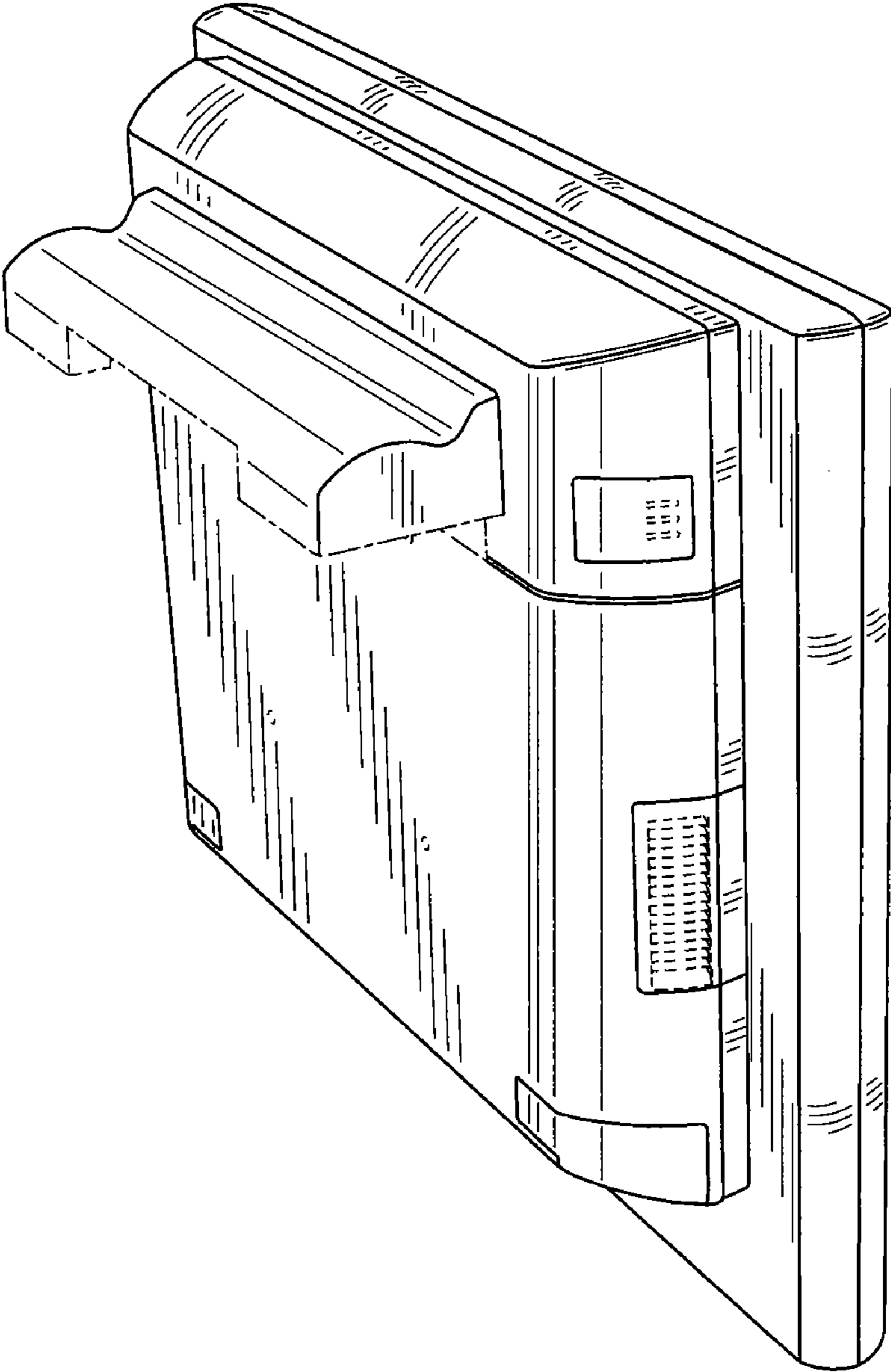

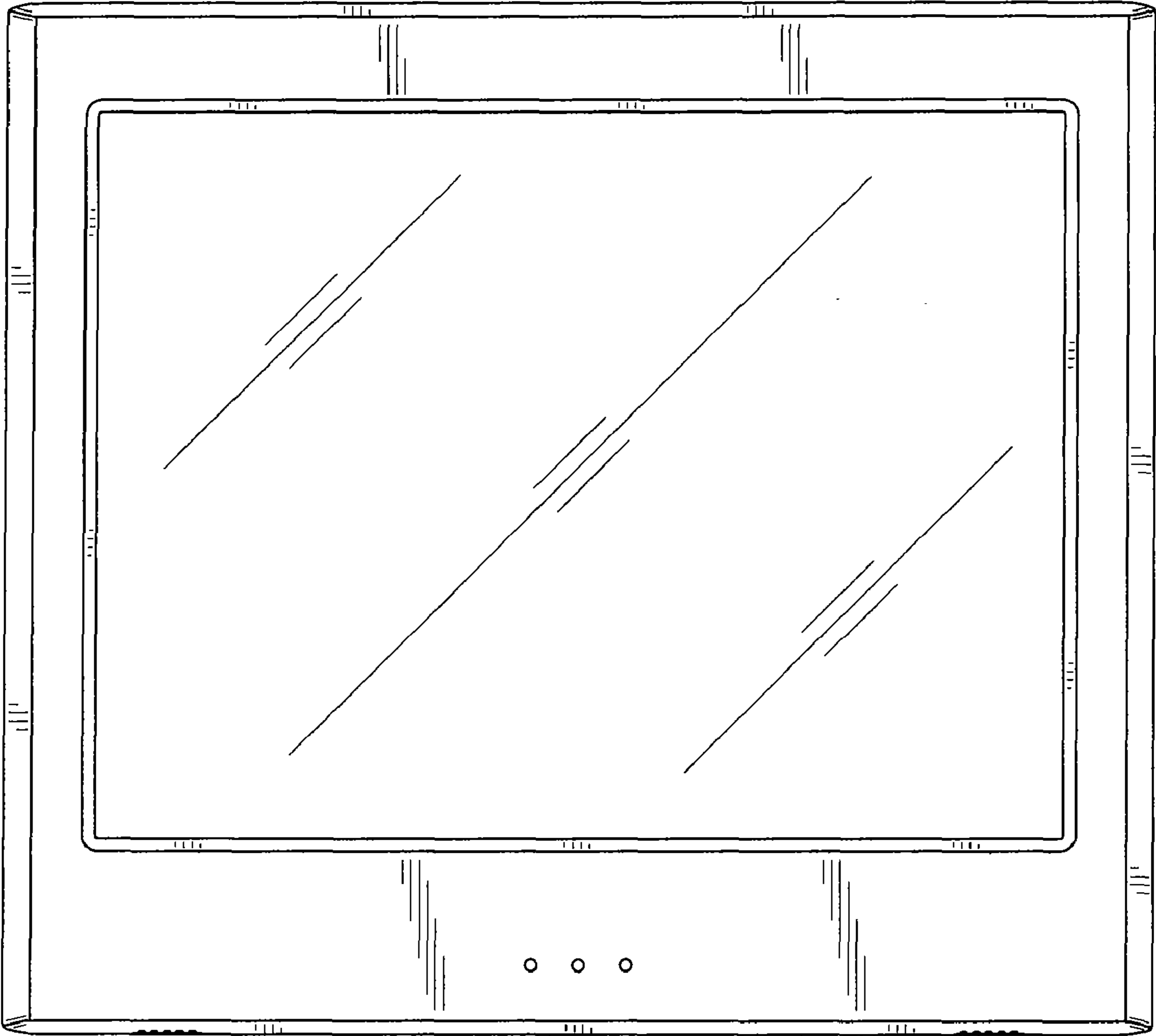

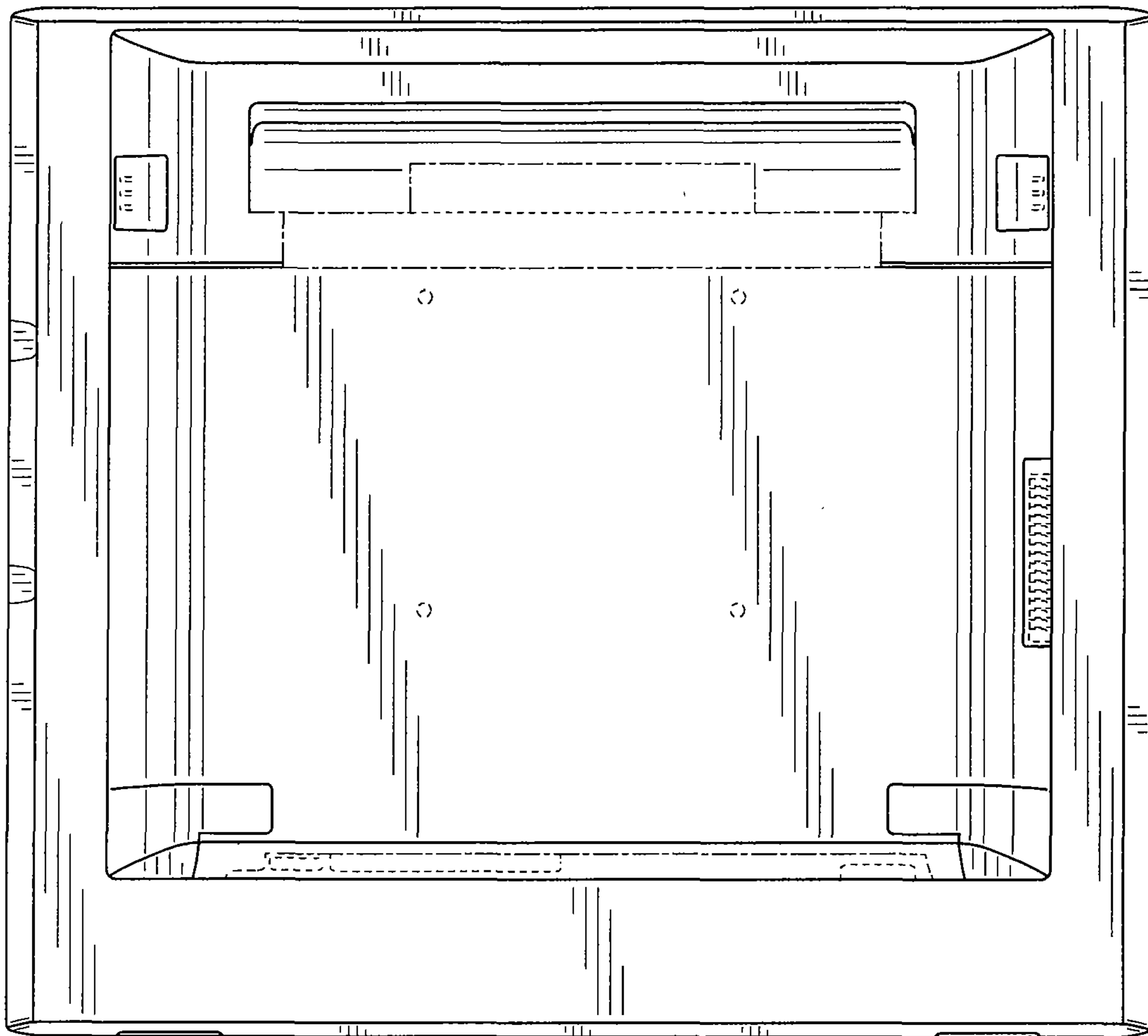

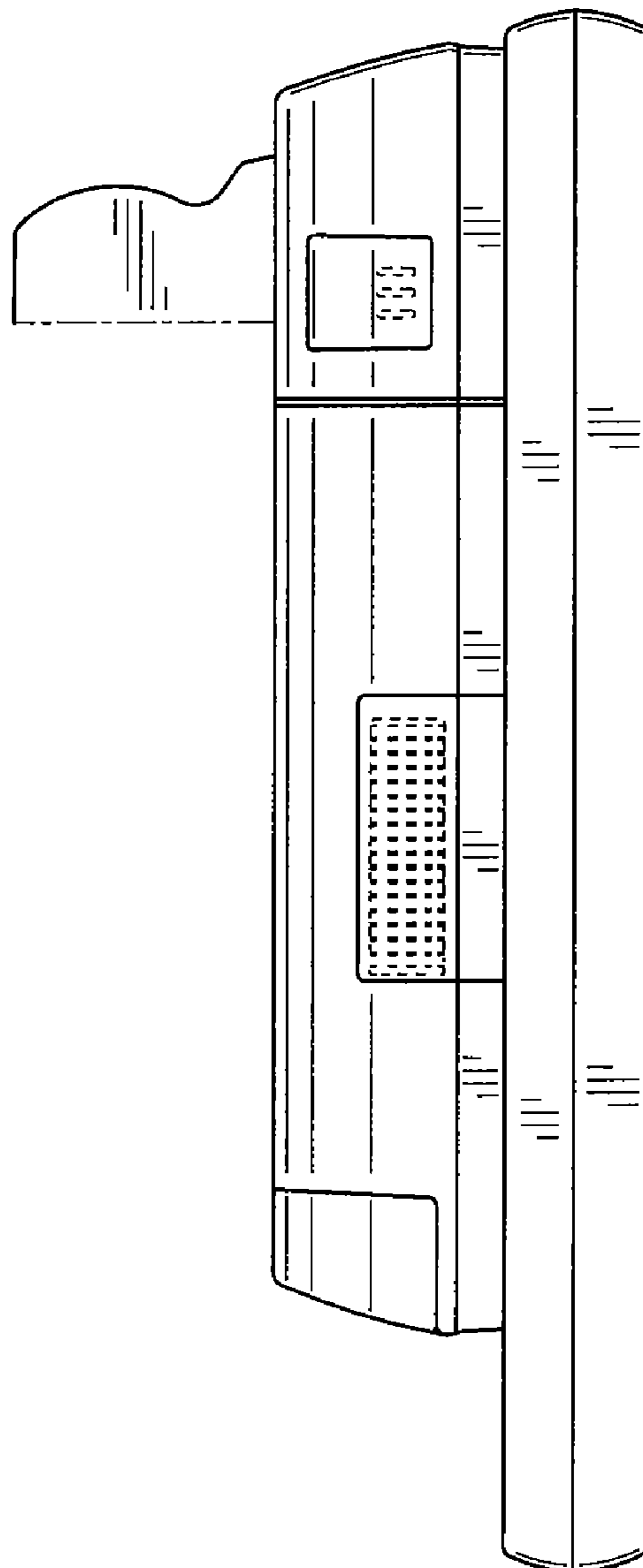

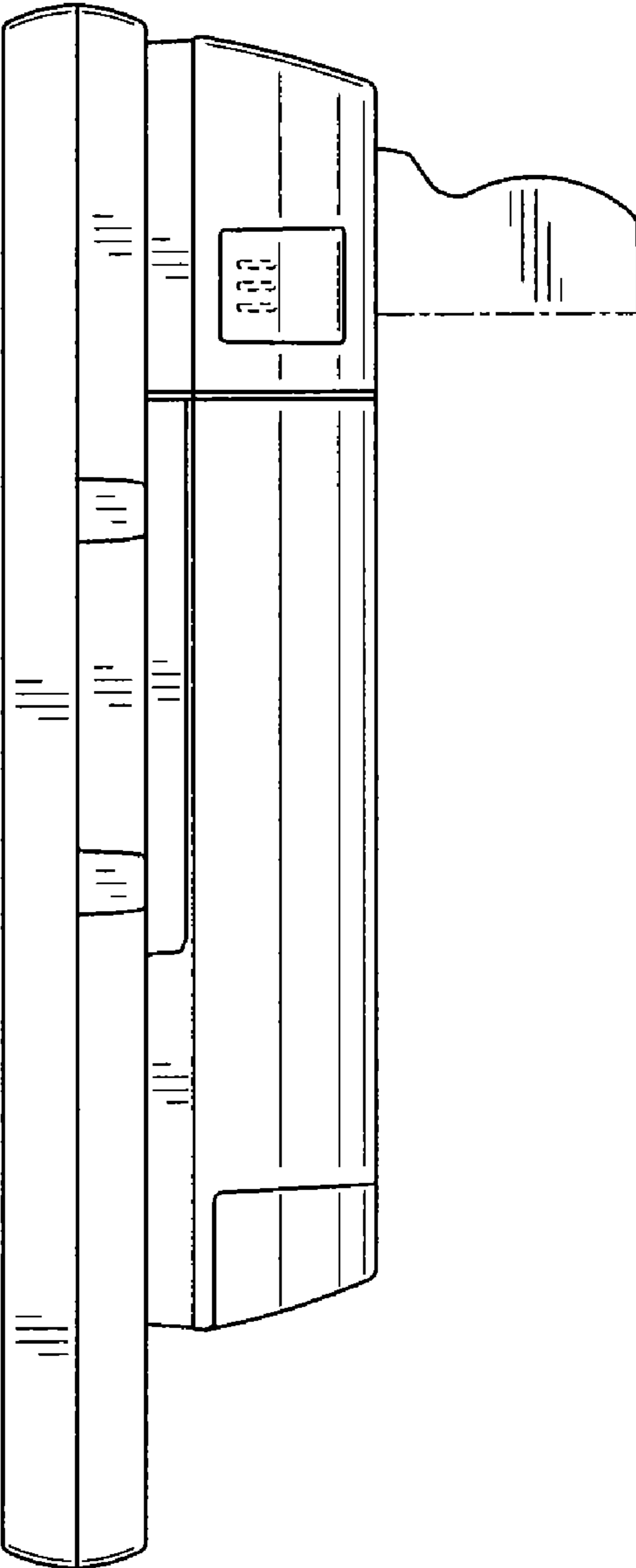

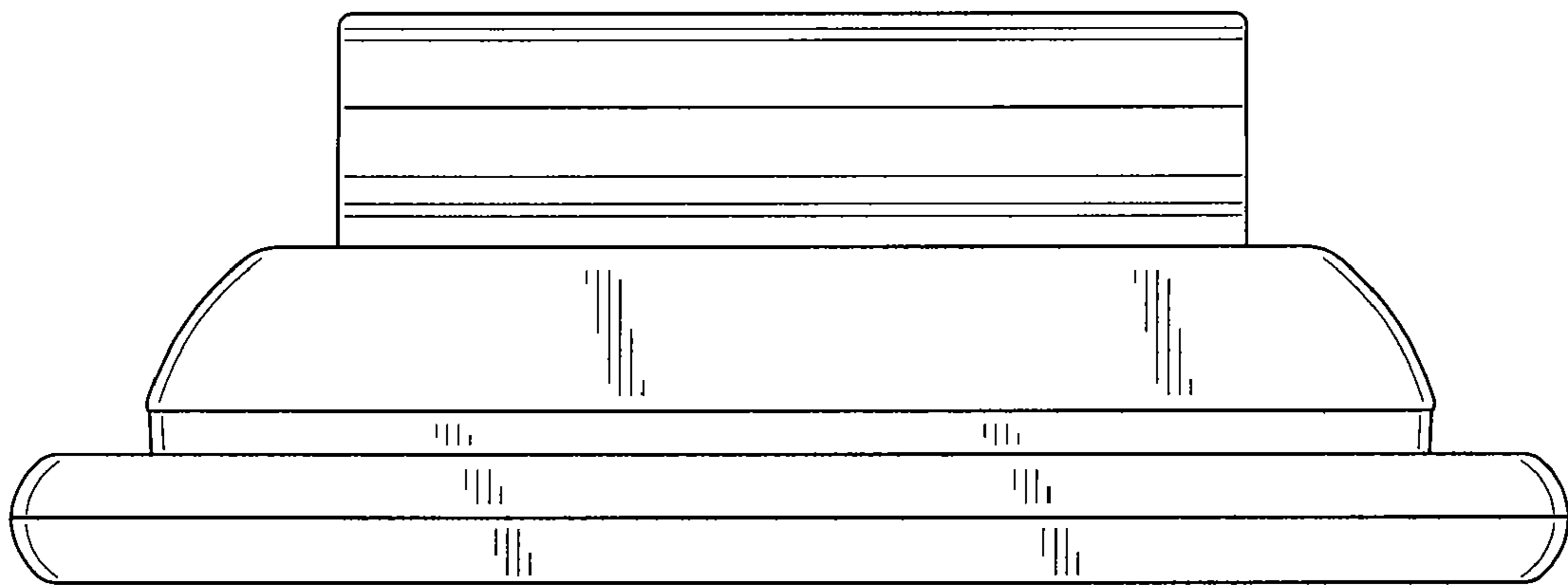
