(57) **CLAIM**

The ornamental design for a headlight for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a first embodiment of a headlight for a vehicle according to our design;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof; and

FIG. 4 is a top view thereof.

FIG. 5 is a left perspective view of a second embodiment of the headlight for a vehicle according to our new design, with the headlight for a vehicle for the opposite side of the vehicle being depicted in the first embodiment;

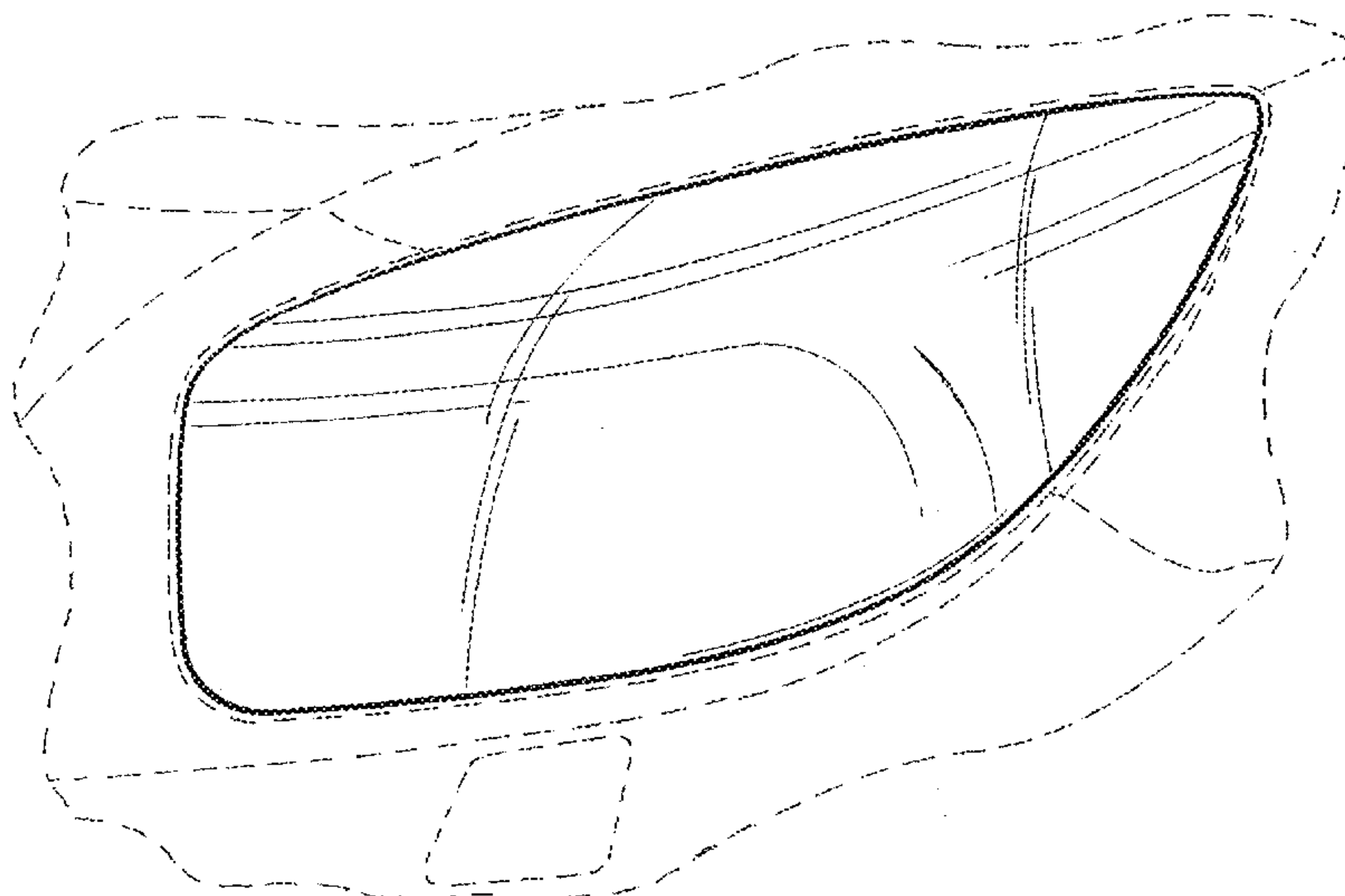
FIG. 6 is a front view thereof;

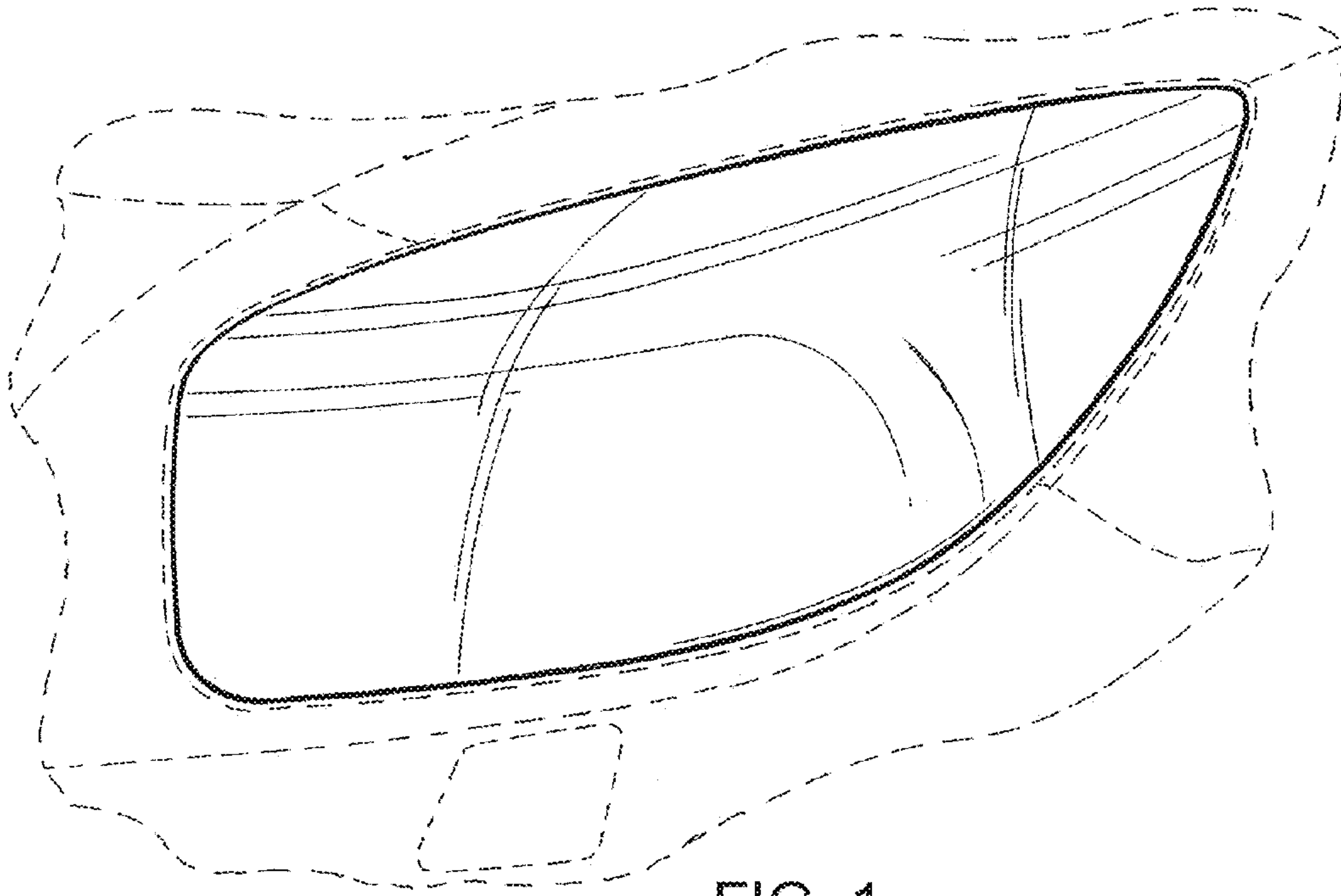

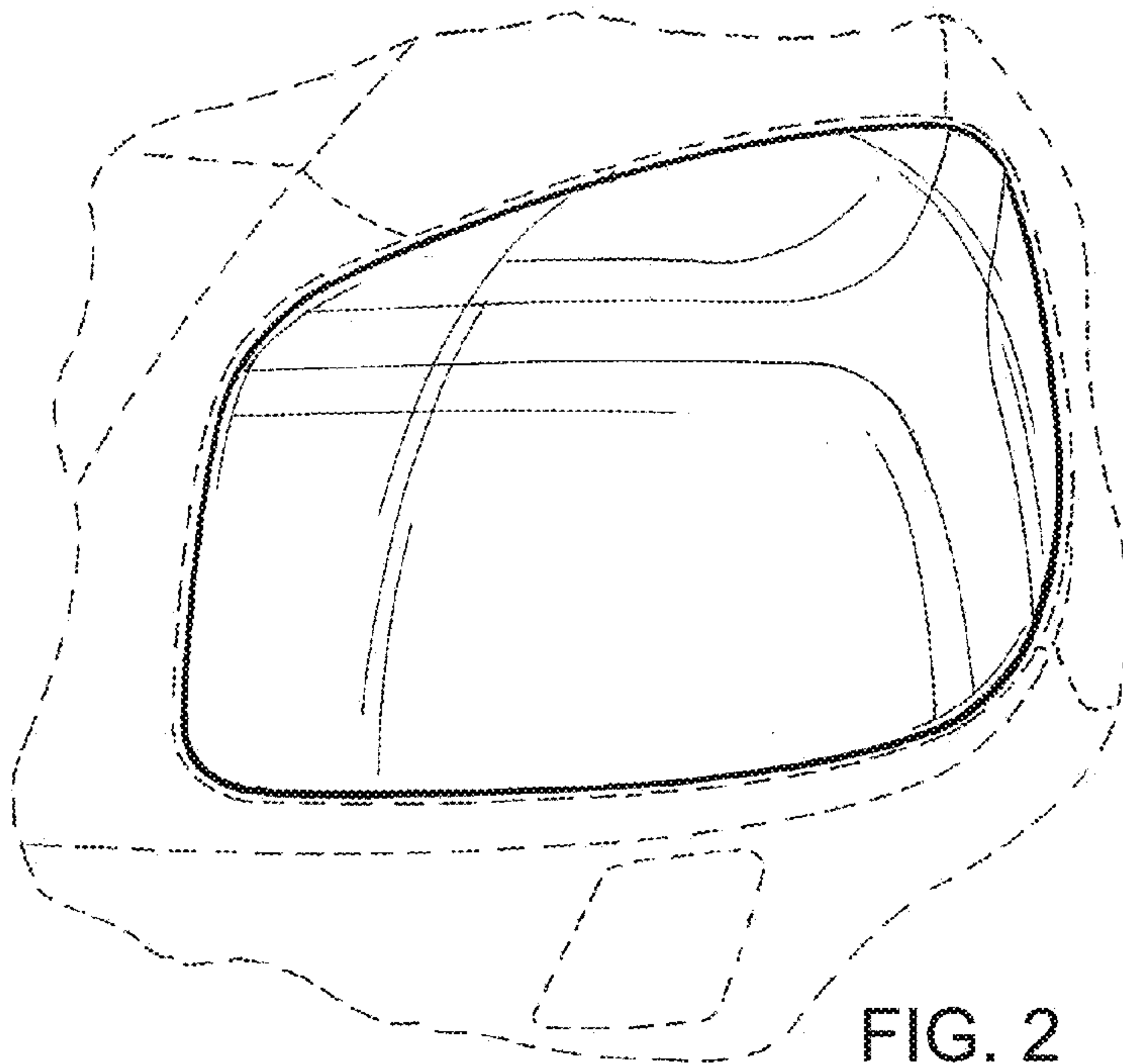

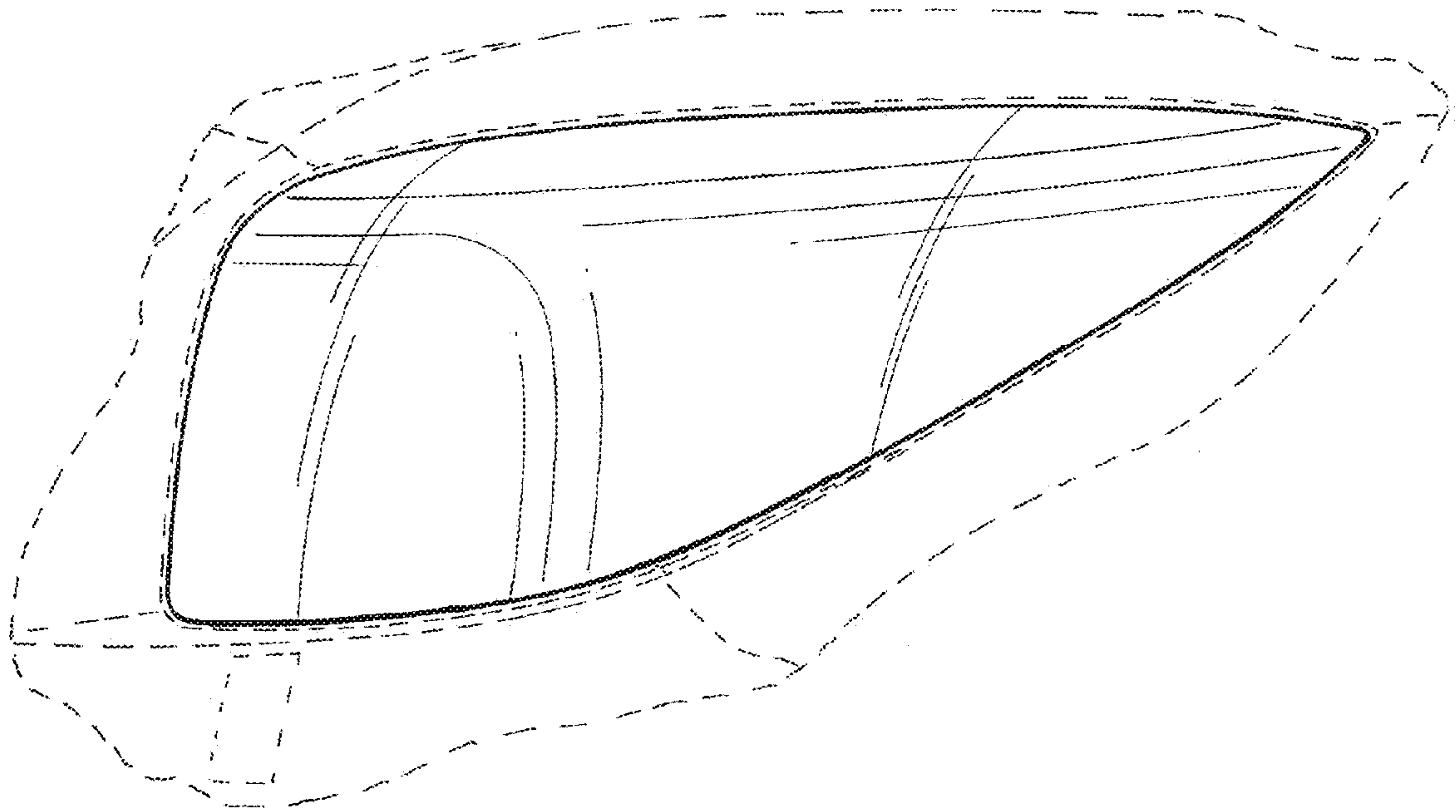

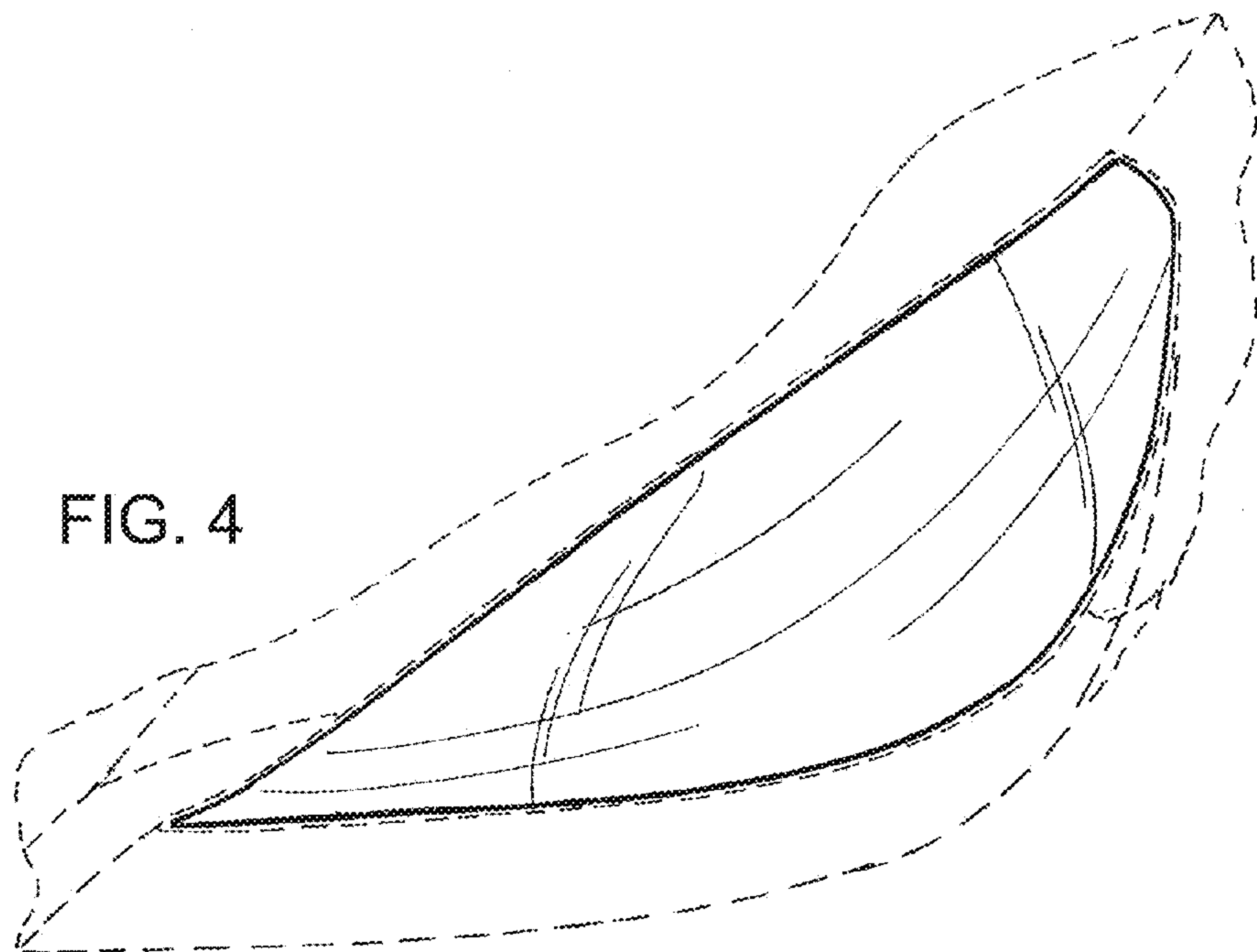

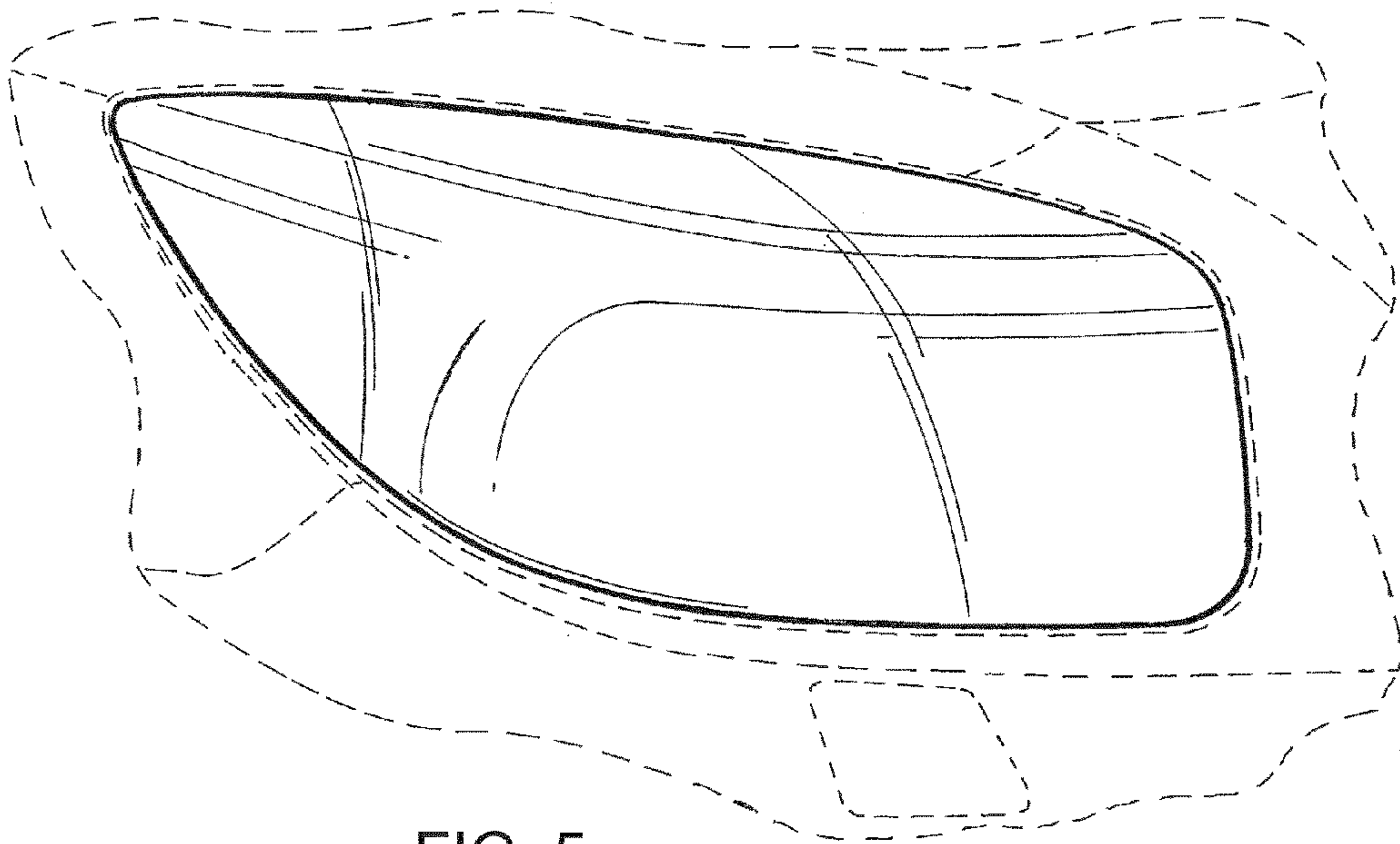

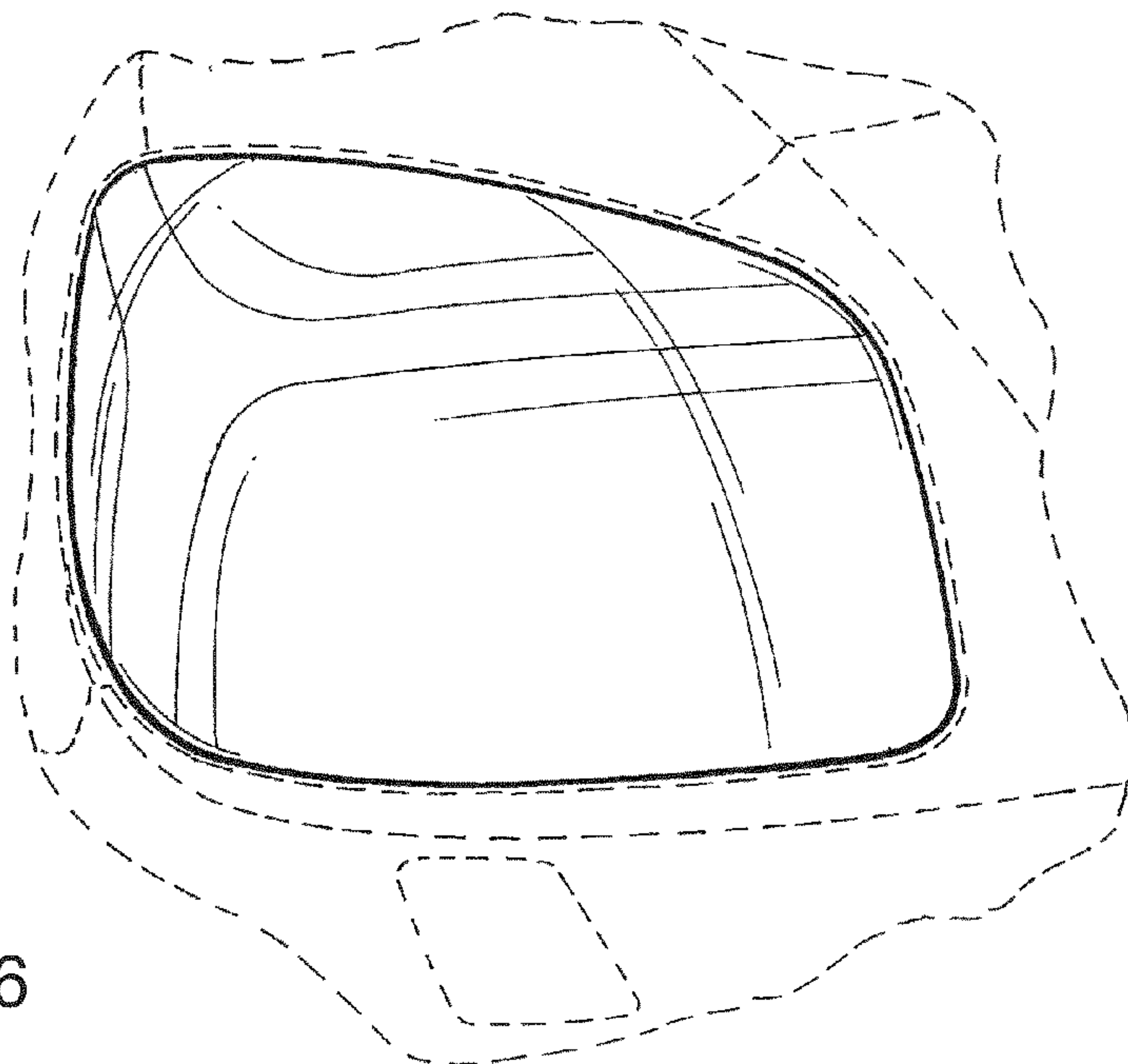

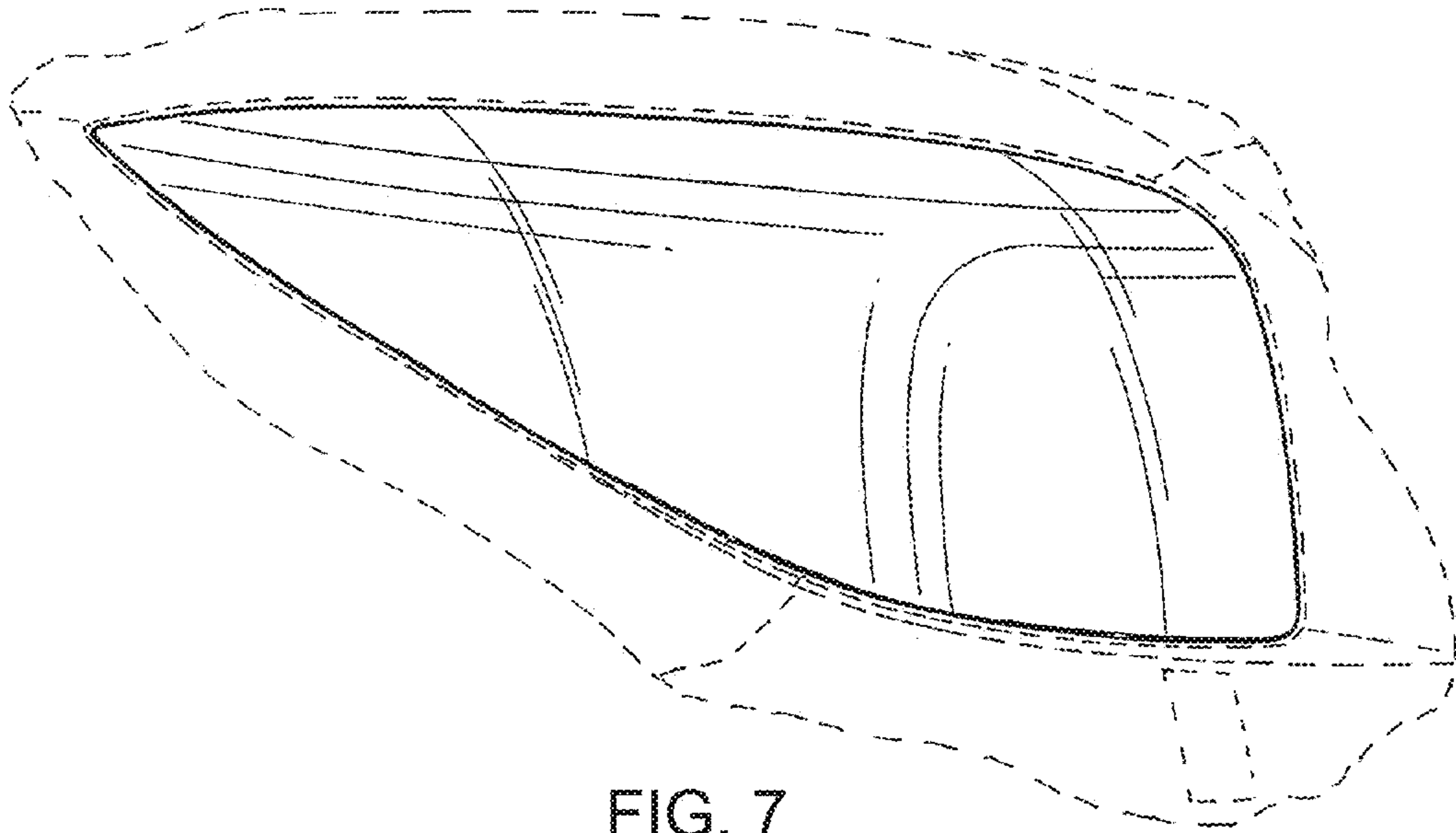

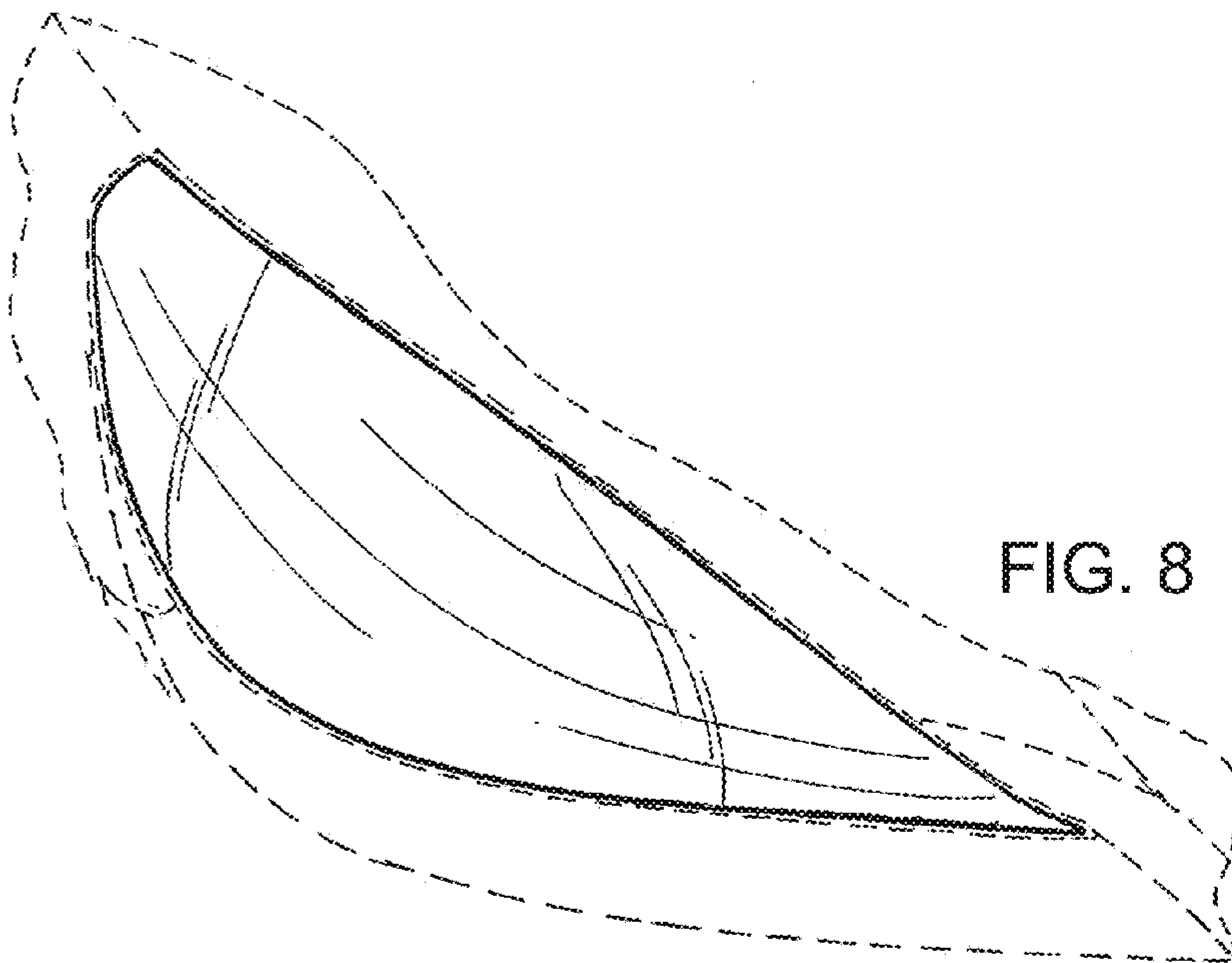
