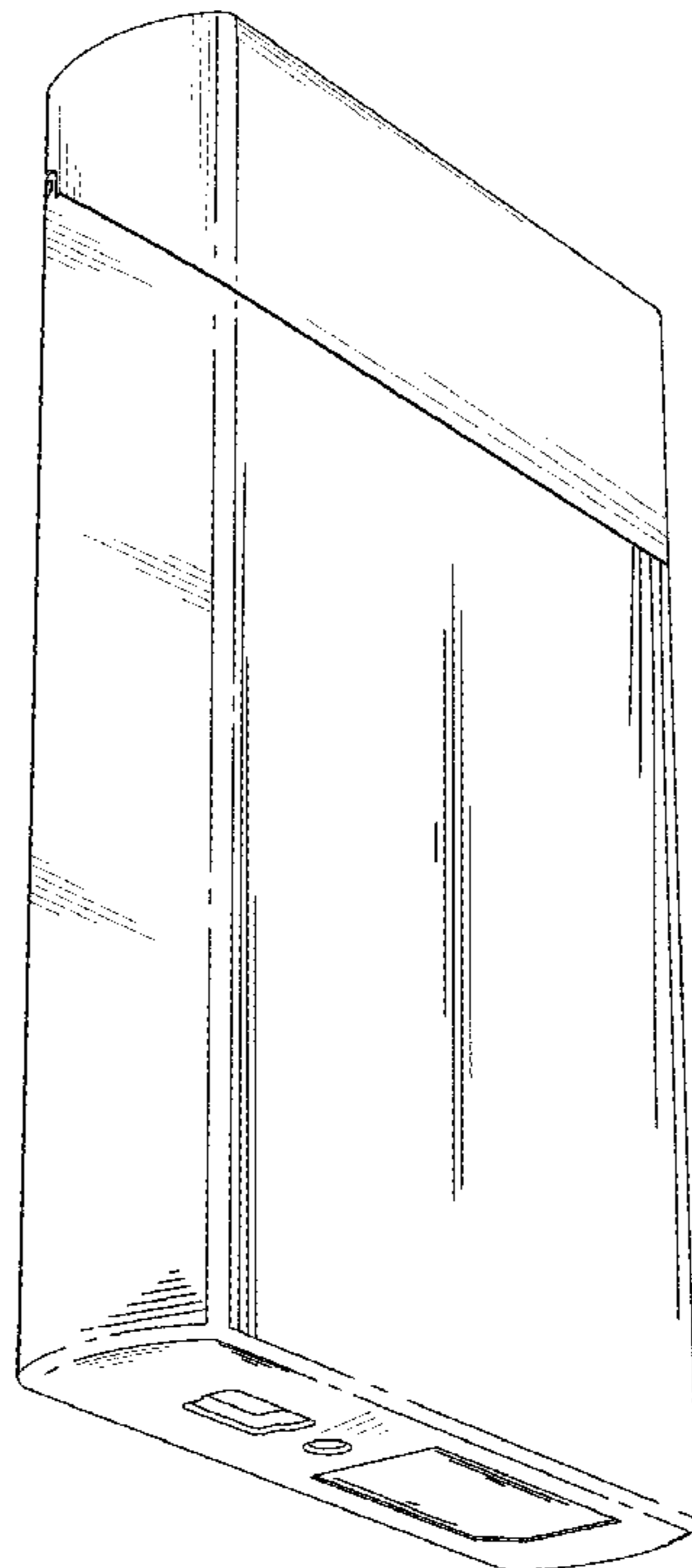
(57) **CLAIM**

The ornamental design for a “charging electronic cigarette case,” as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of a charging electronic cigarette case showing my new design; FIG. 2 is a front, top and left side perspective view thereof; FIG. 3 is a rear, bottom and right side perspective view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a top plan view thereof; and, FIG. 9 is a bottom plan view thereof.

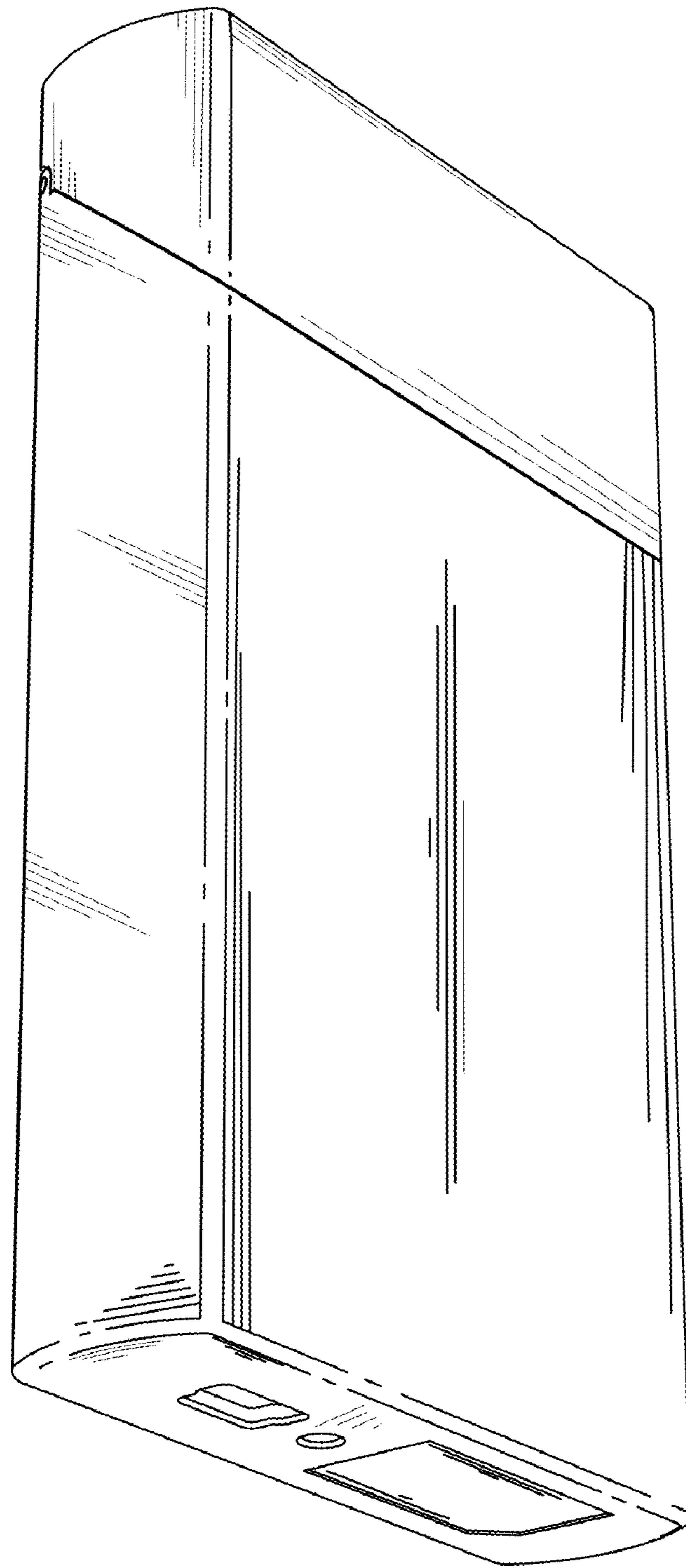

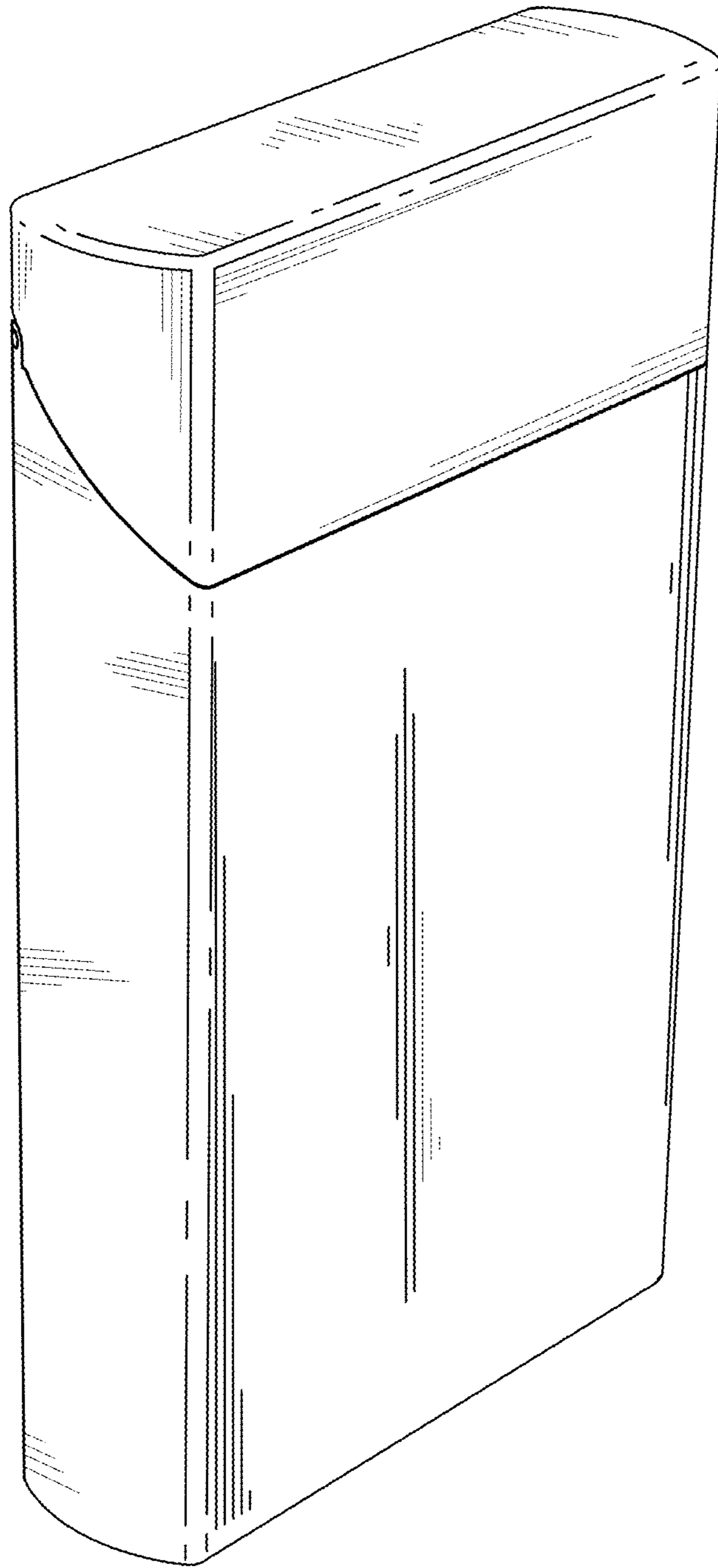

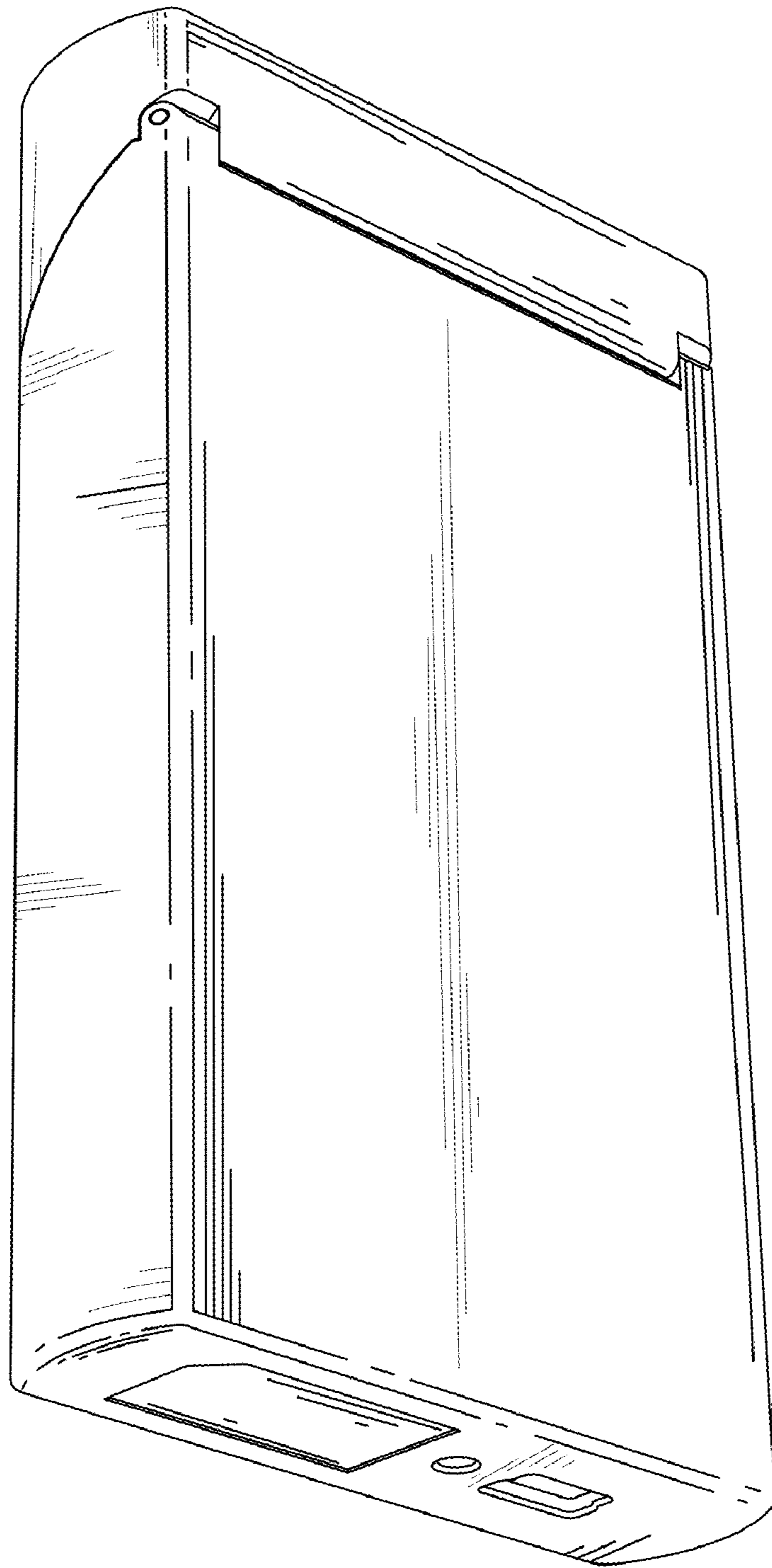

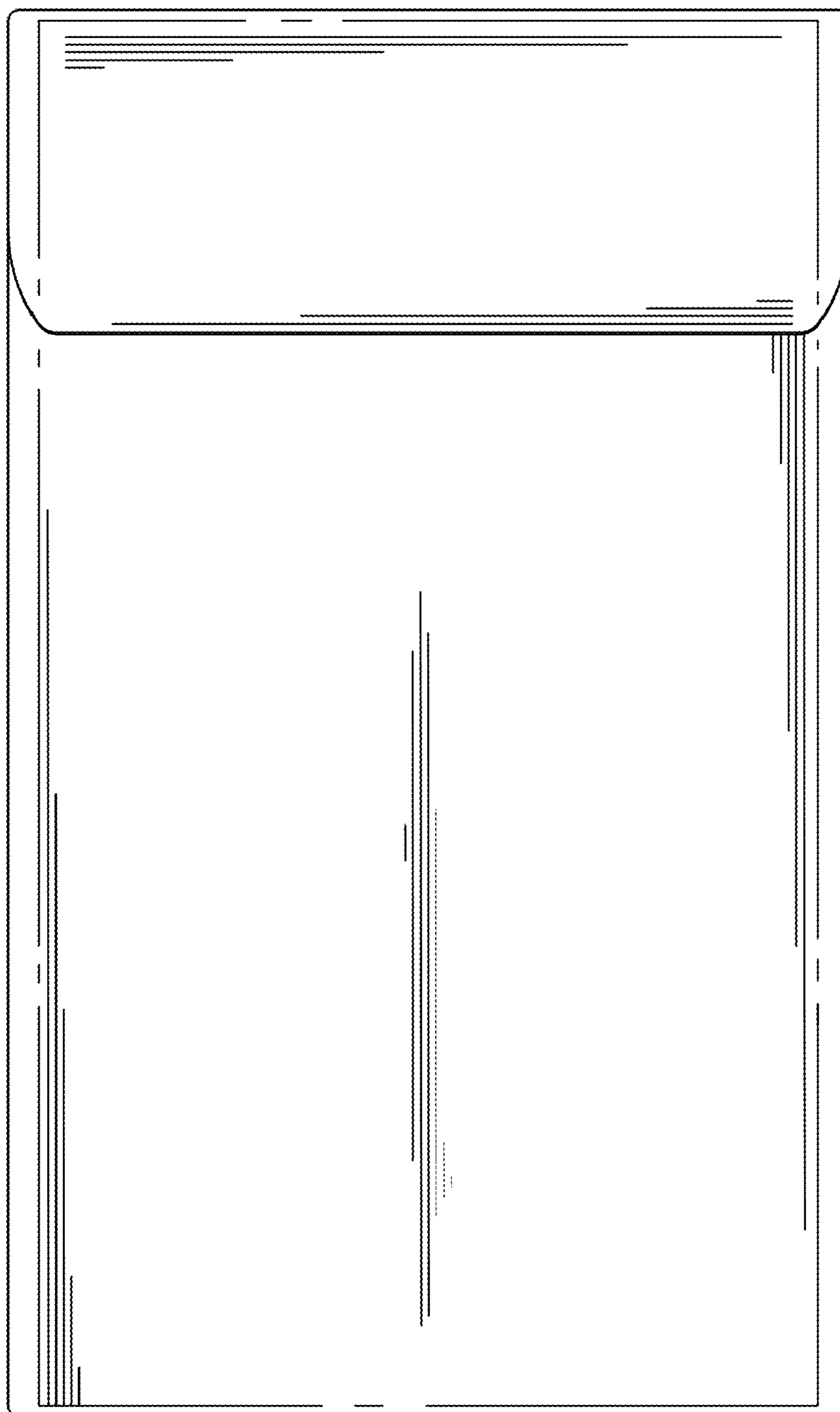

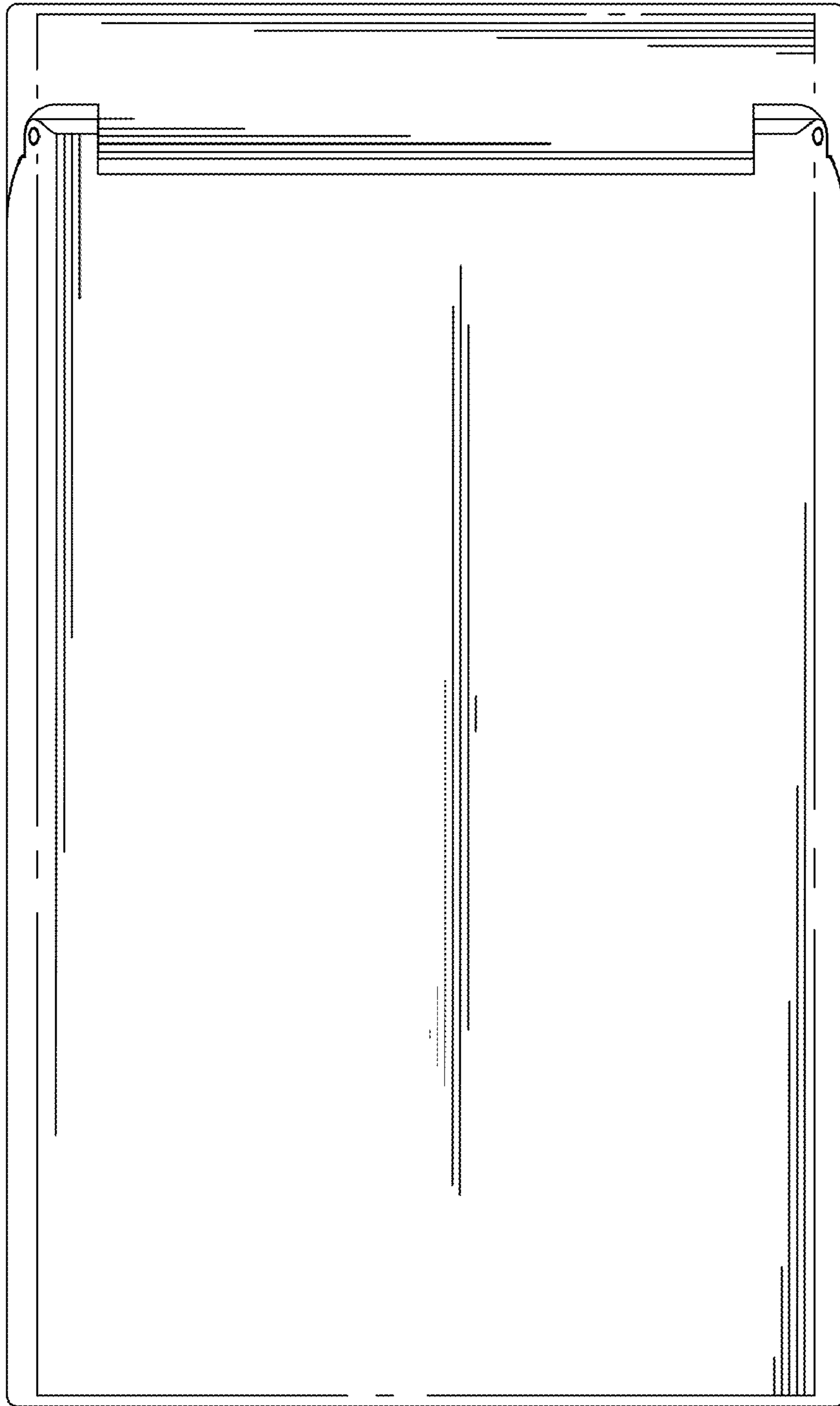

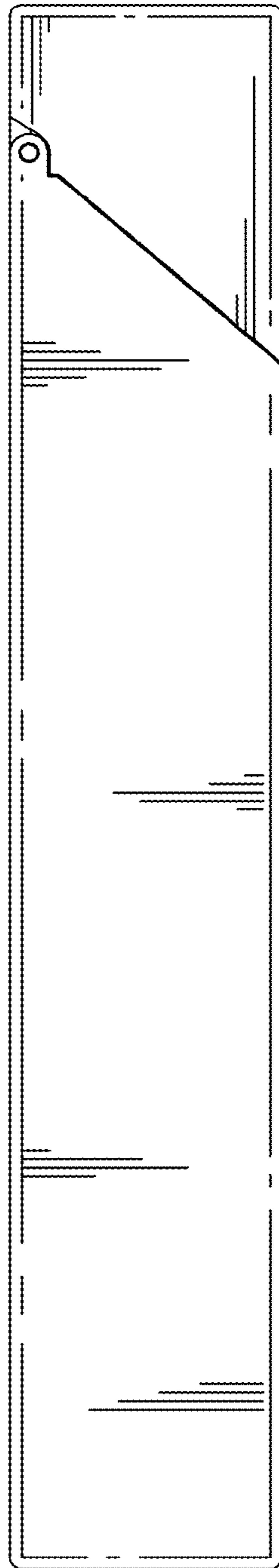

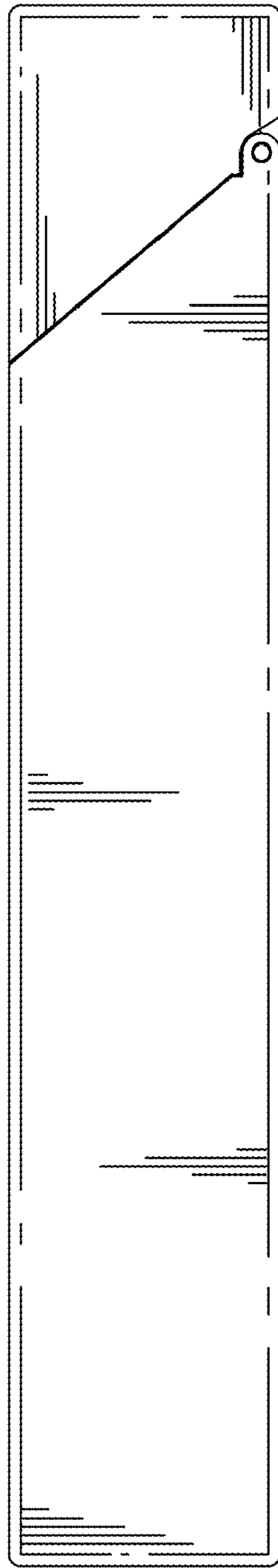

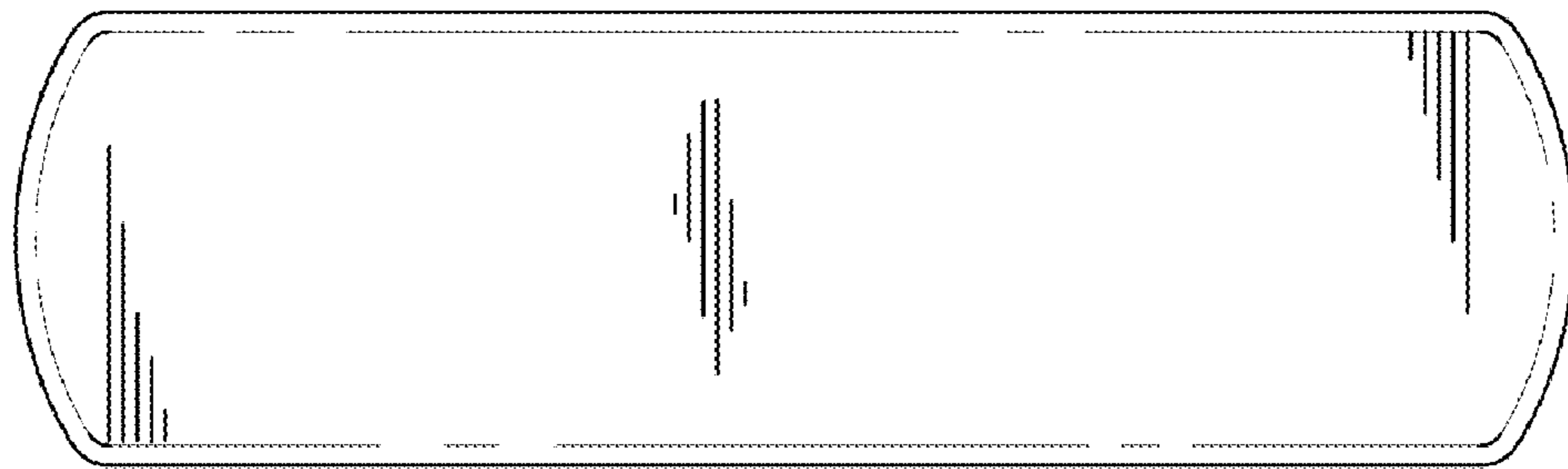

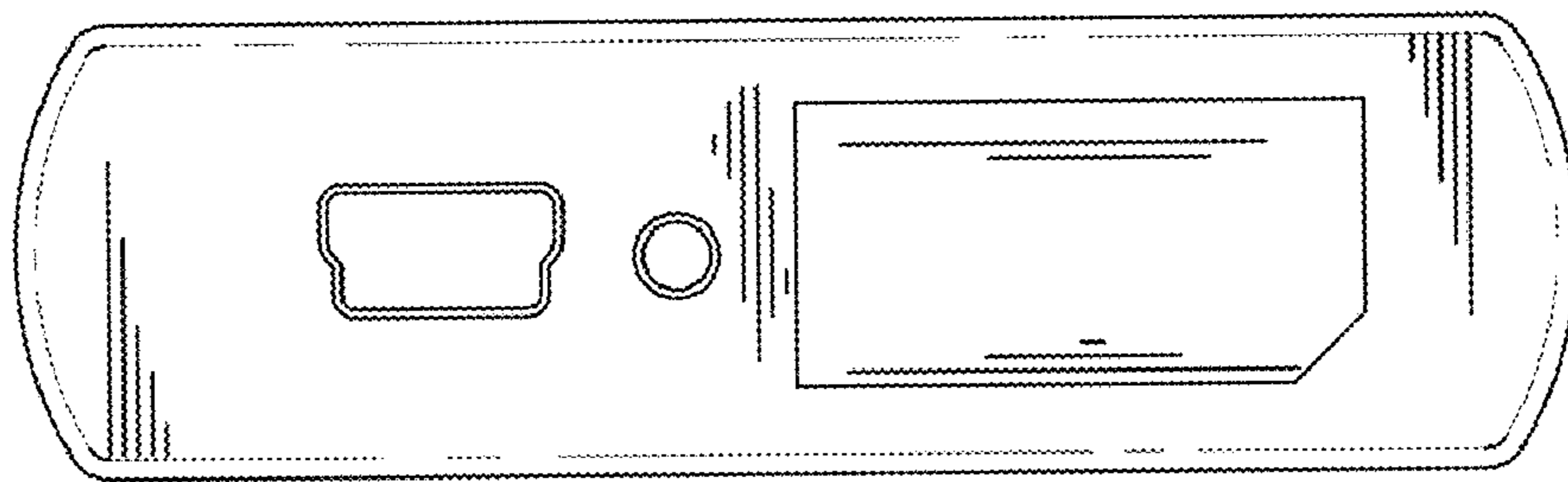
