(57) **CLAIM**

The ornamental design for a sanitary mitten, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a sanitary mitten embodying my new design, shown as it would appear worn on a human hand;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a medial side elevation view thereof;

FIG. 4 is a top plan view thereof;

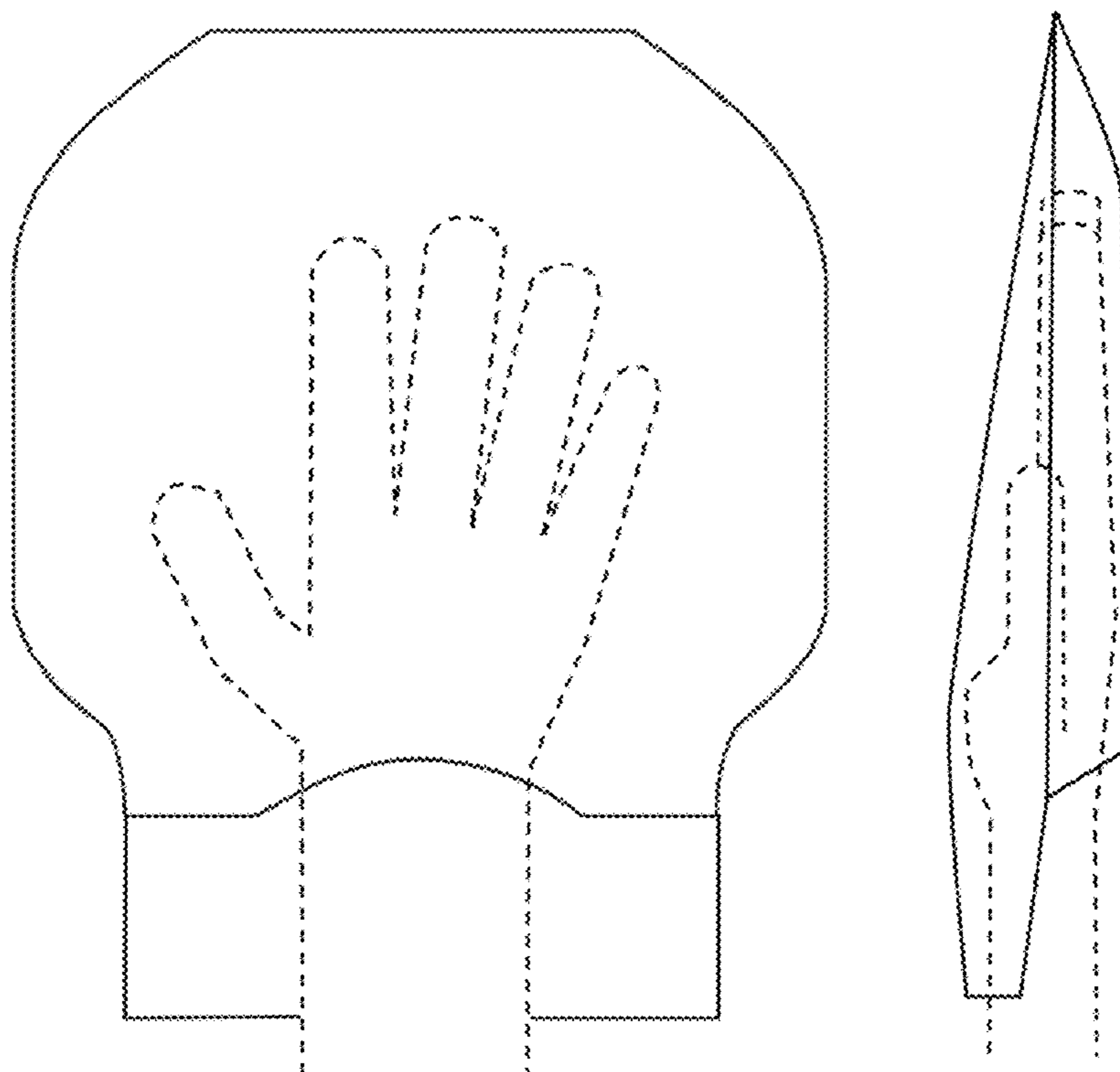
FIG. 5 is a front elevation view of the design of FIGS. 1-5, shown as it would appear when not worn;

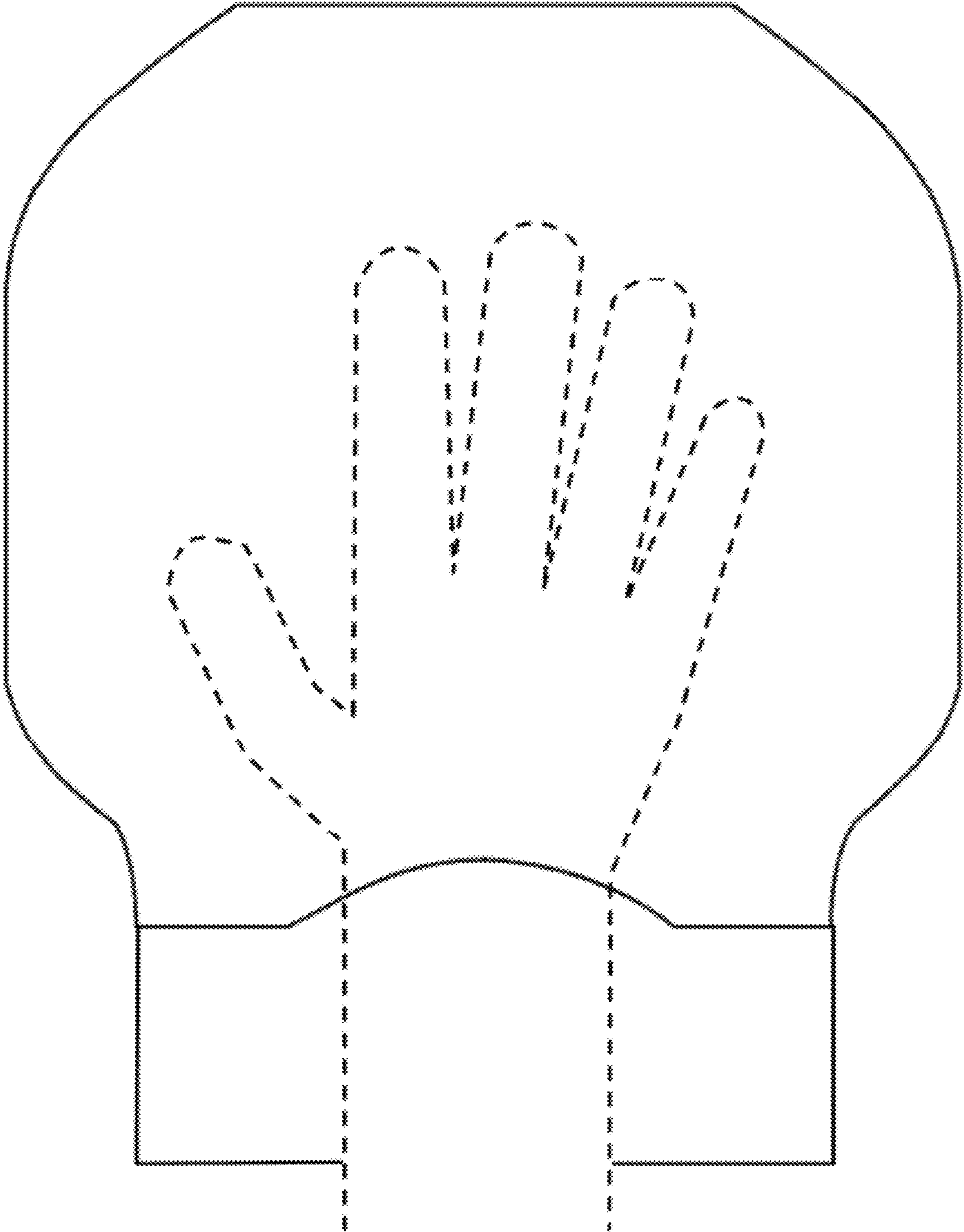

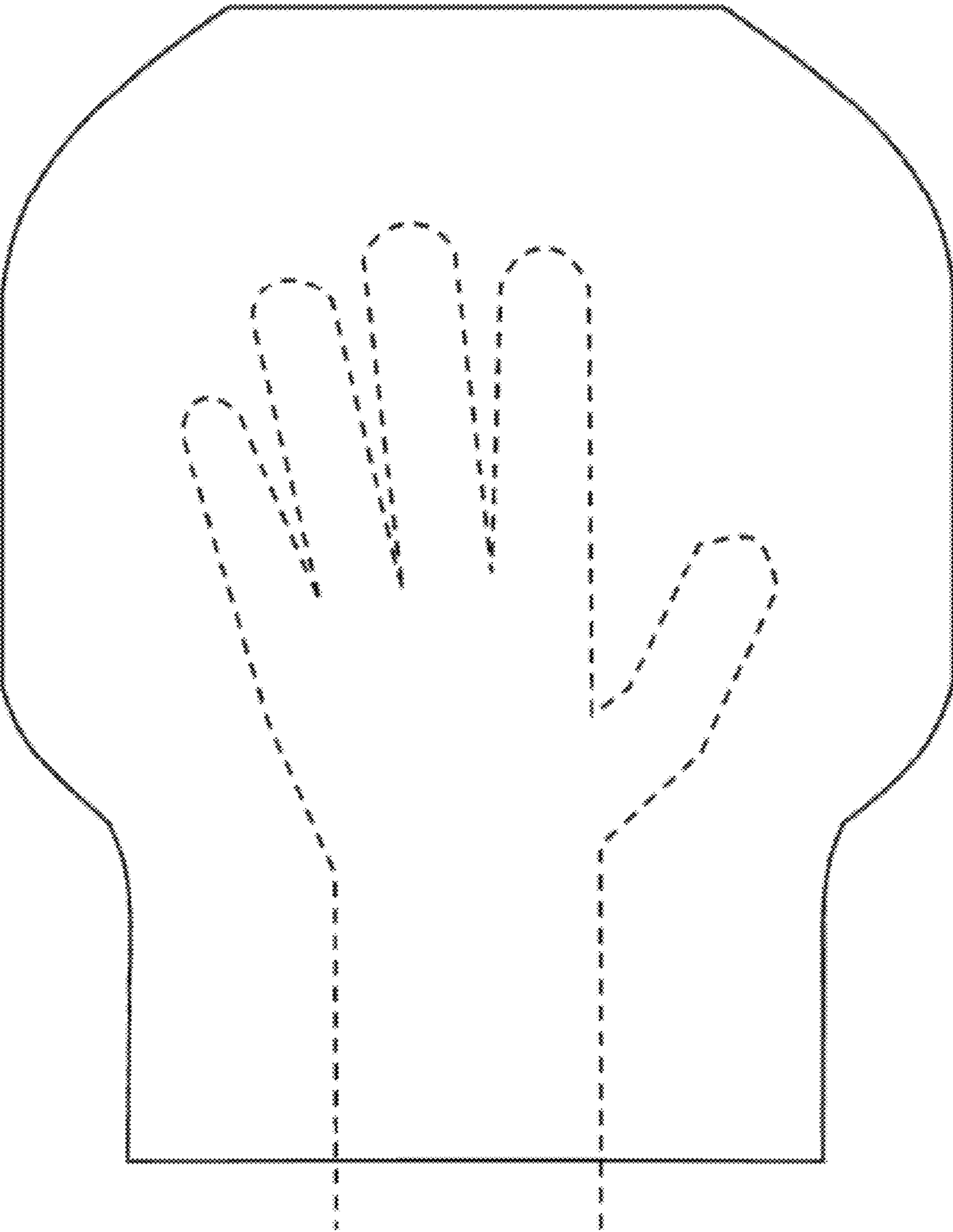

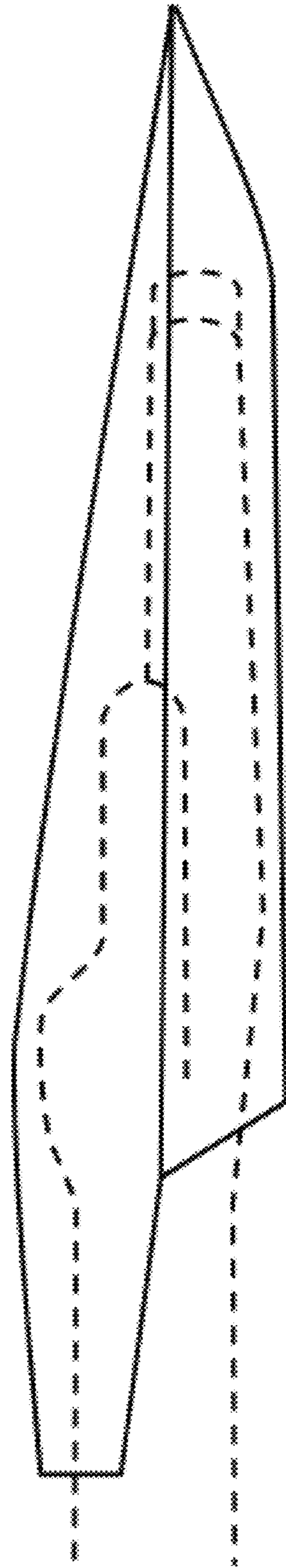

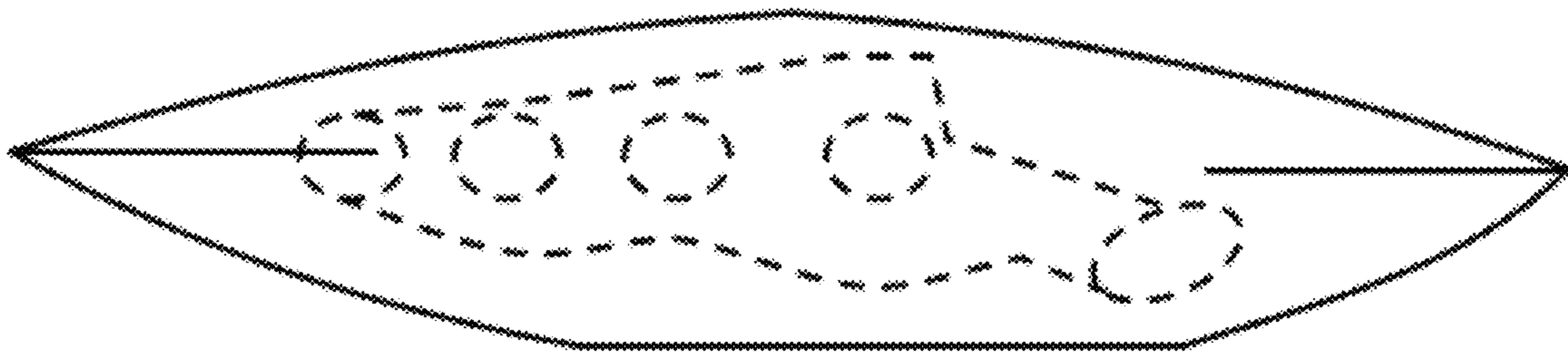

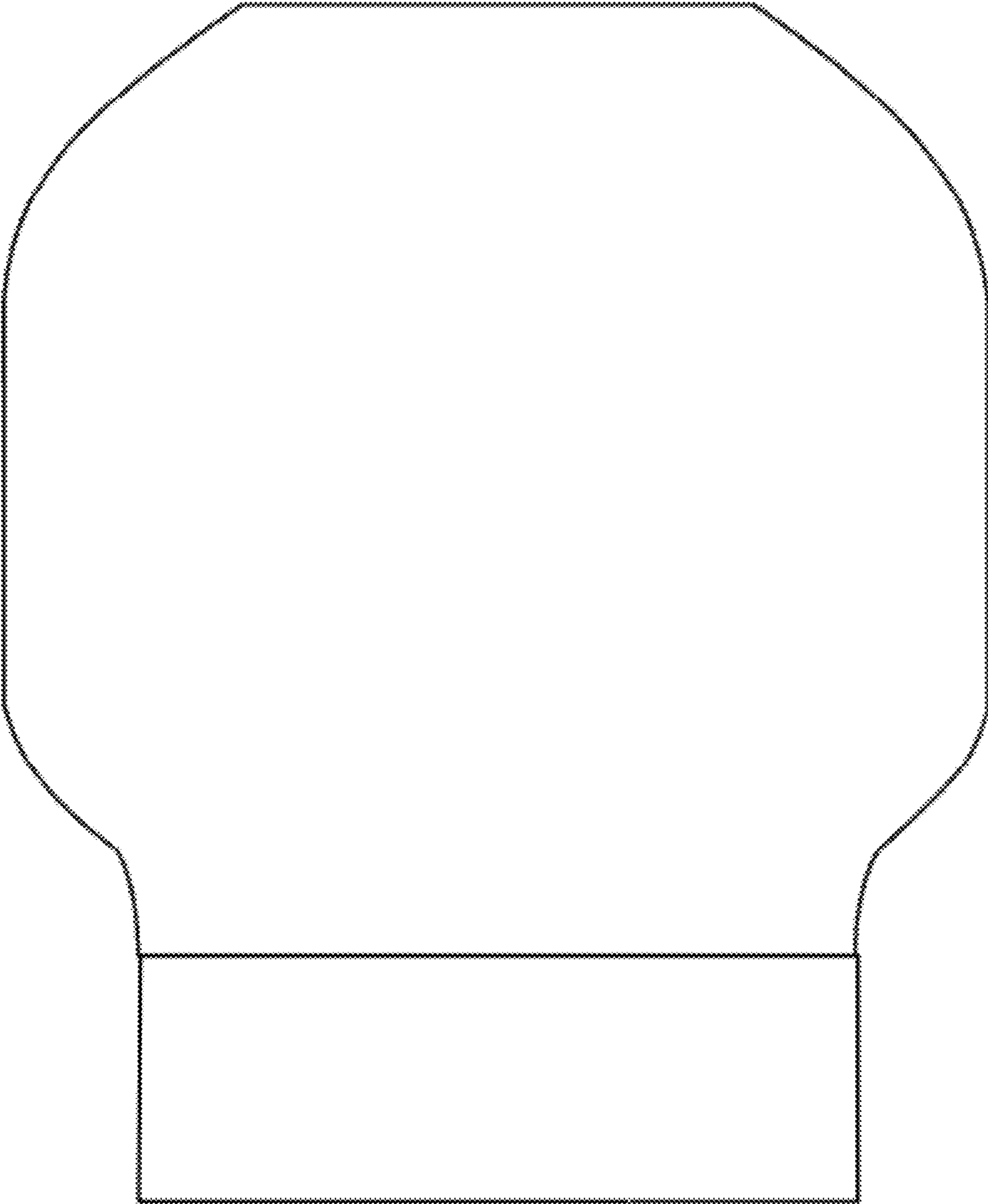

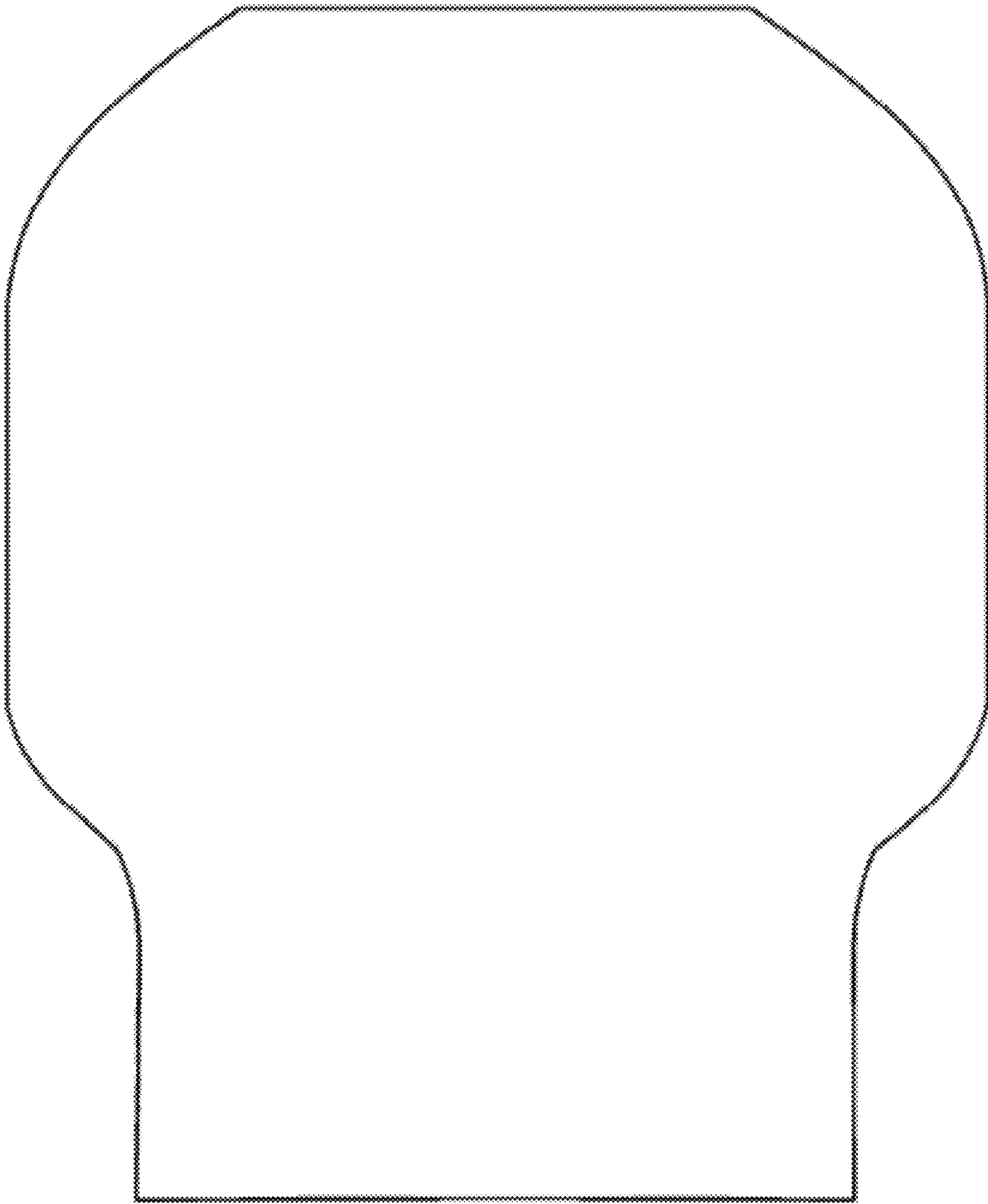
