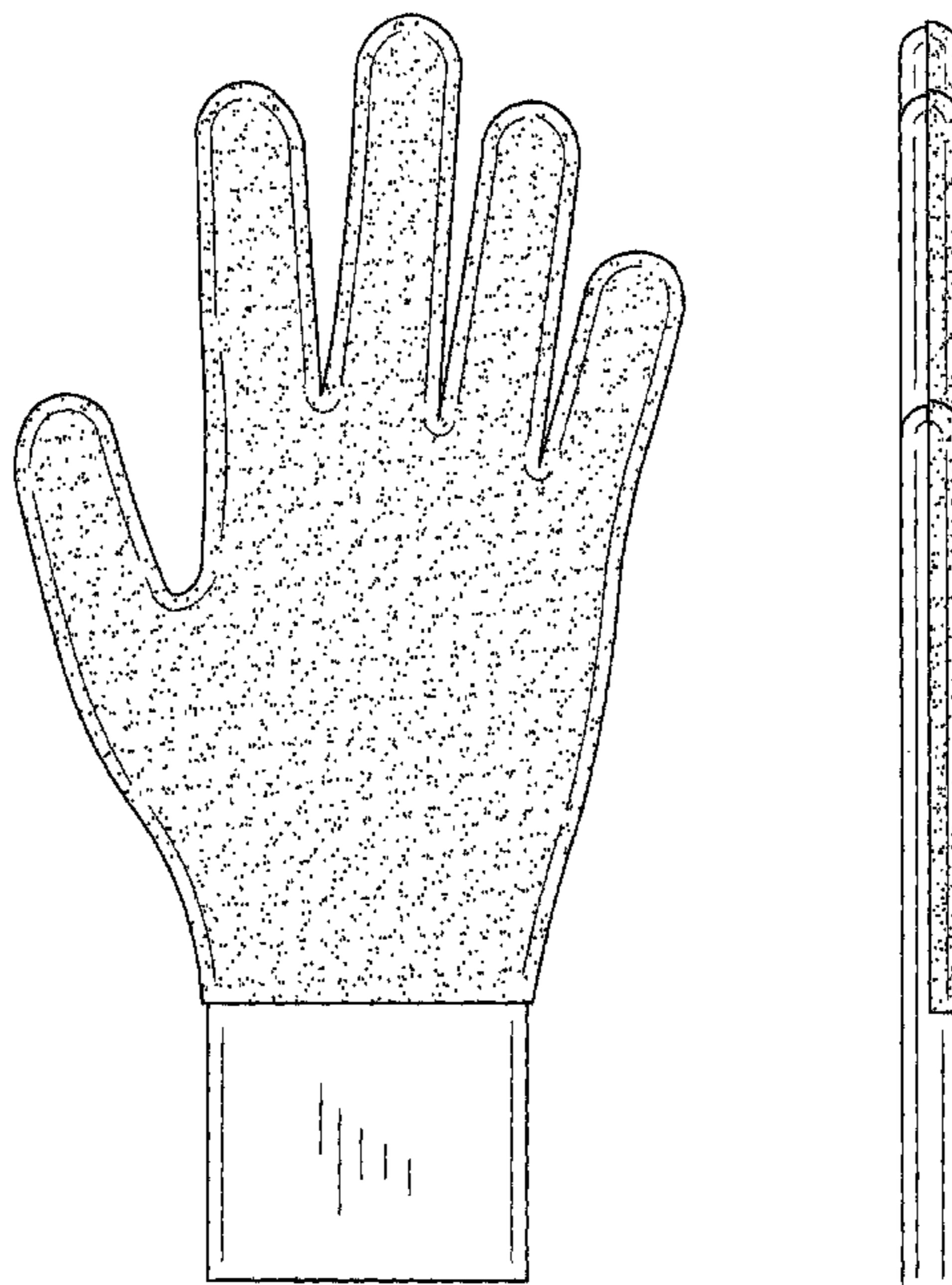
(57) **CLAIM**

The ornamental design for a cleaning glove, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a cleaning glove showing my new design;
FIG. 2 is a rear elevation view of the cleaning glove;
FIG. 3 is a right side elevation view of the cleaning glove;
FIG. 4 is a left side elevation view of the cleaning glove;
FIG. 5 is a top plan view of the cleaning glove; and,
FIG. 6 is a bottom plan view of the cleaning glove. The dot-dash line represents a boundary between claimed and unclaimed areas. The phantom lines showing the interior of the glove depict environment only and form no part of the claimed design.

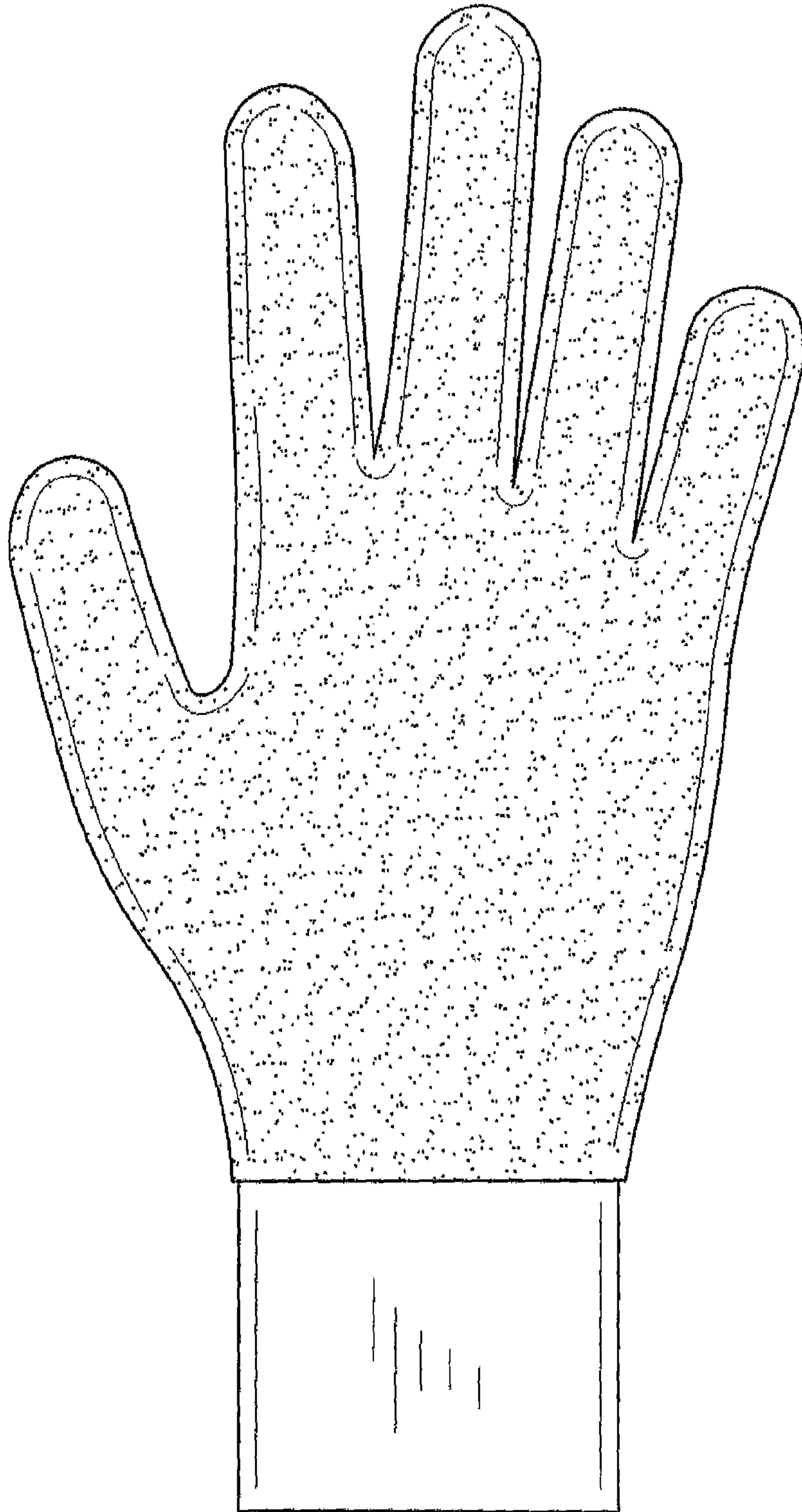

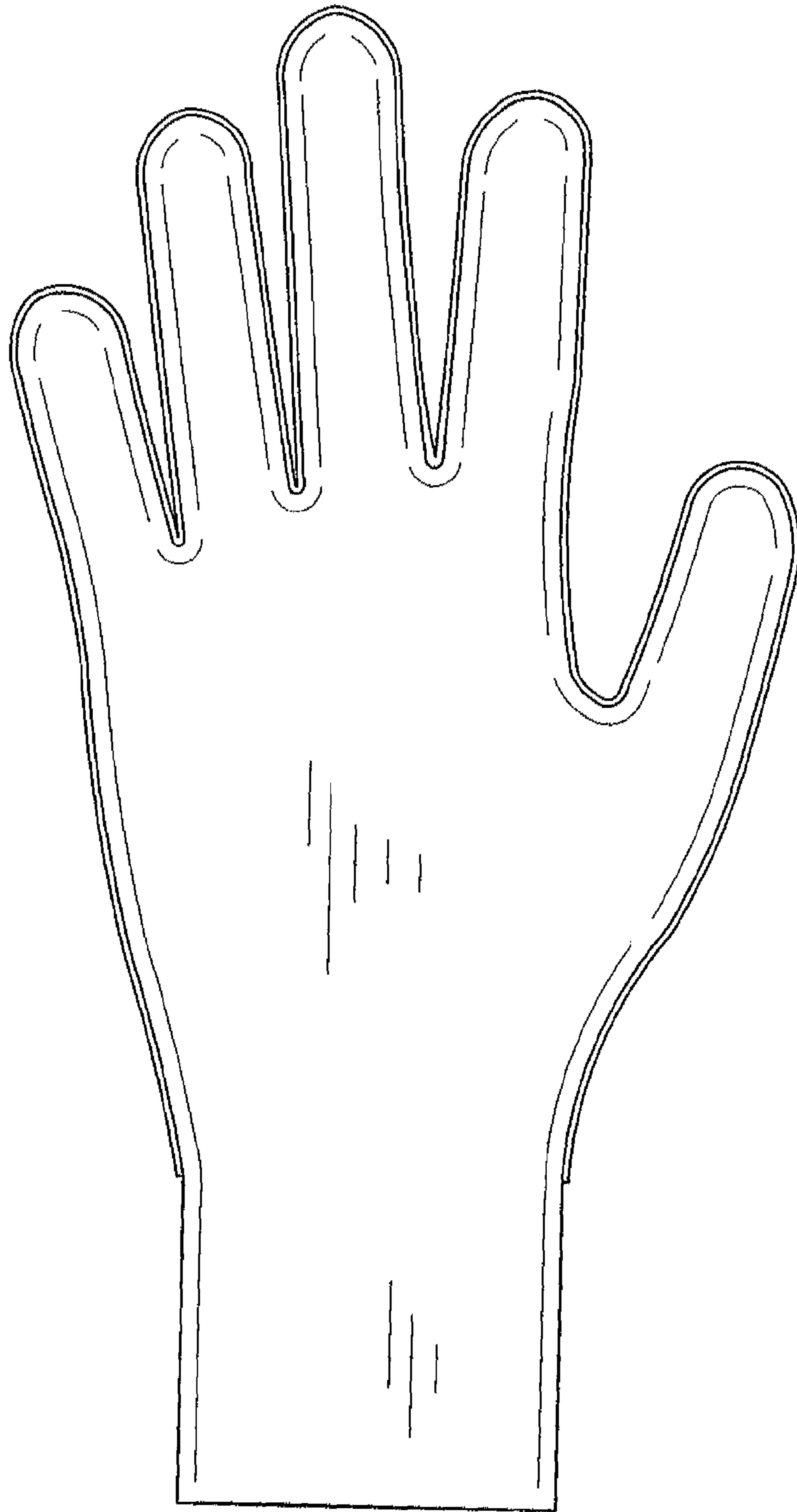

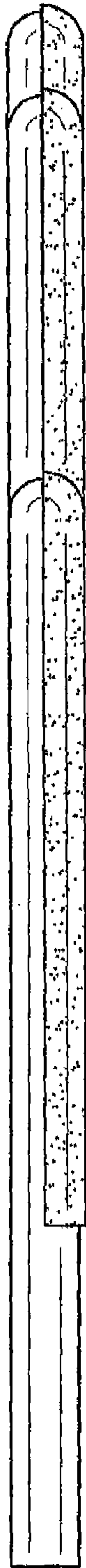
