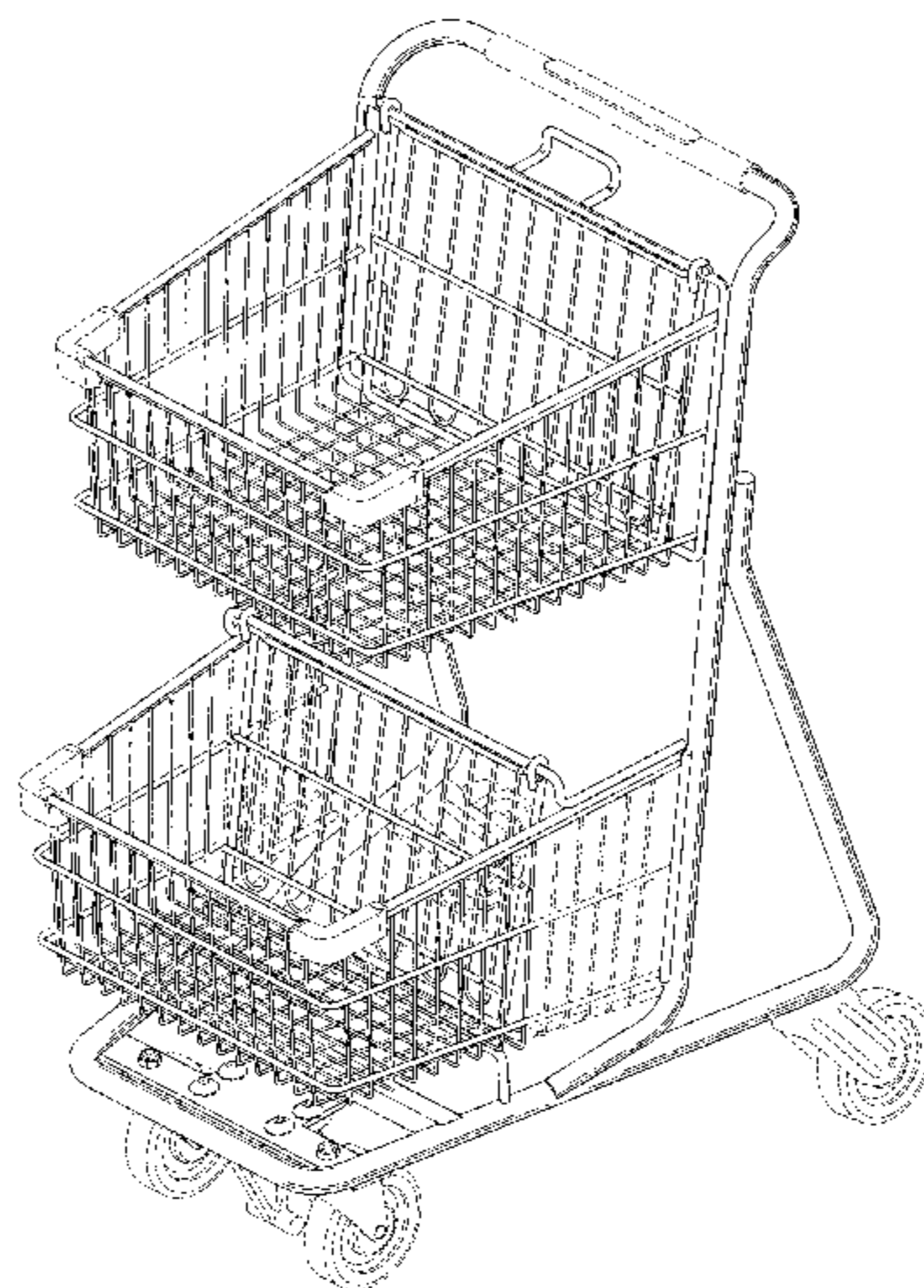
(57) **CLAIM**

The ornamental design for a cart, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of my new design for a cart showing my new design;  
FIG. 2 is a side elevation view of the right and left sides, which are mirror images, of FIG. 1.  
FIG. 3 is a front side elevation view of FIG. 1.  
FIG. 4 is a back side elevation view of FIG. 1.  
FIG. 5 is a top plan view of FIG. 1; and,  
FIG. 6 is a bottom plan view of FIG. 1.  
The broken line showing of the wheels, back portion of bottom basket, hook, handle and bumpers is included for the purpose of illustrating portions of the cart and forms no part of the claimed design.

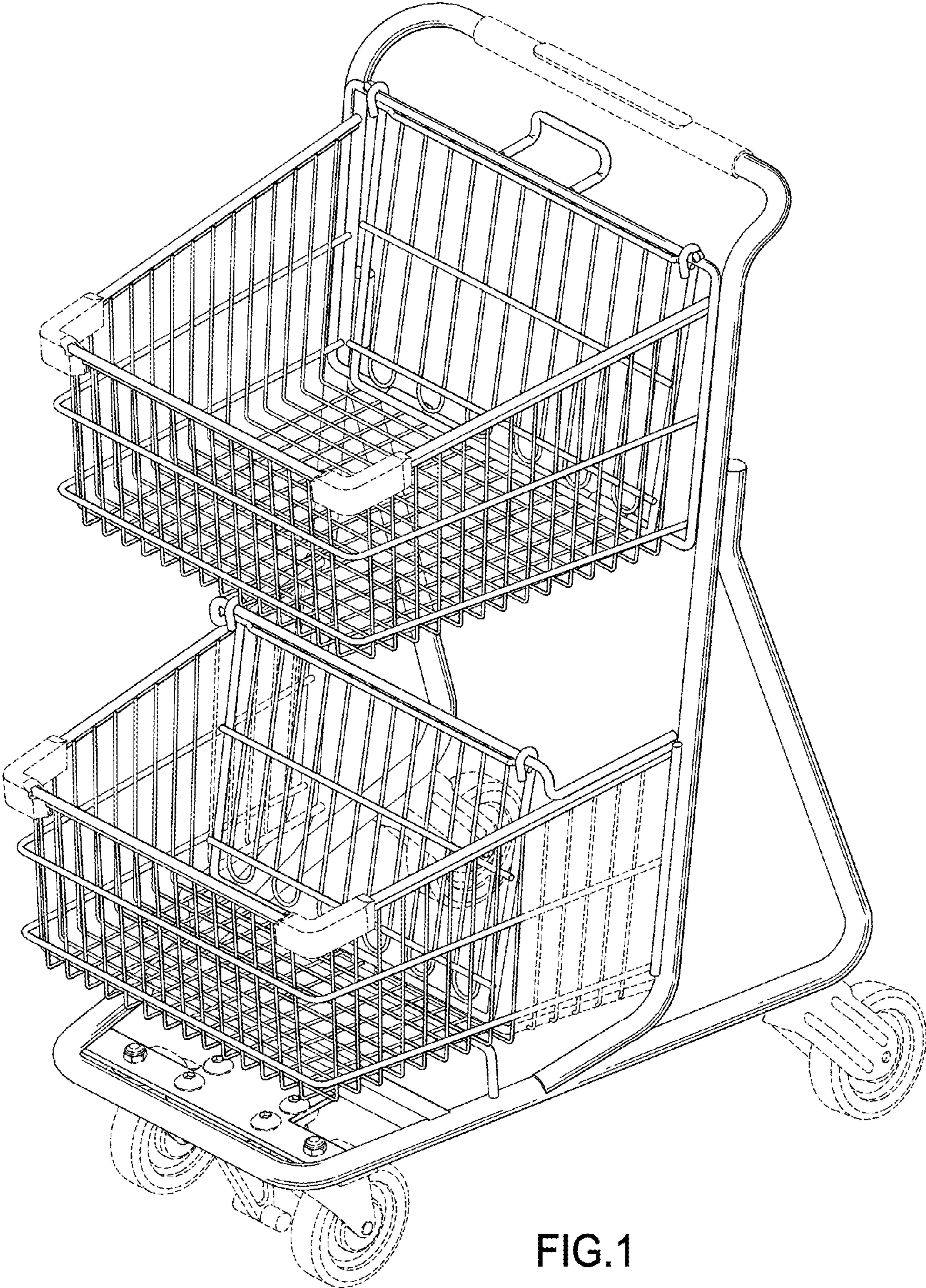

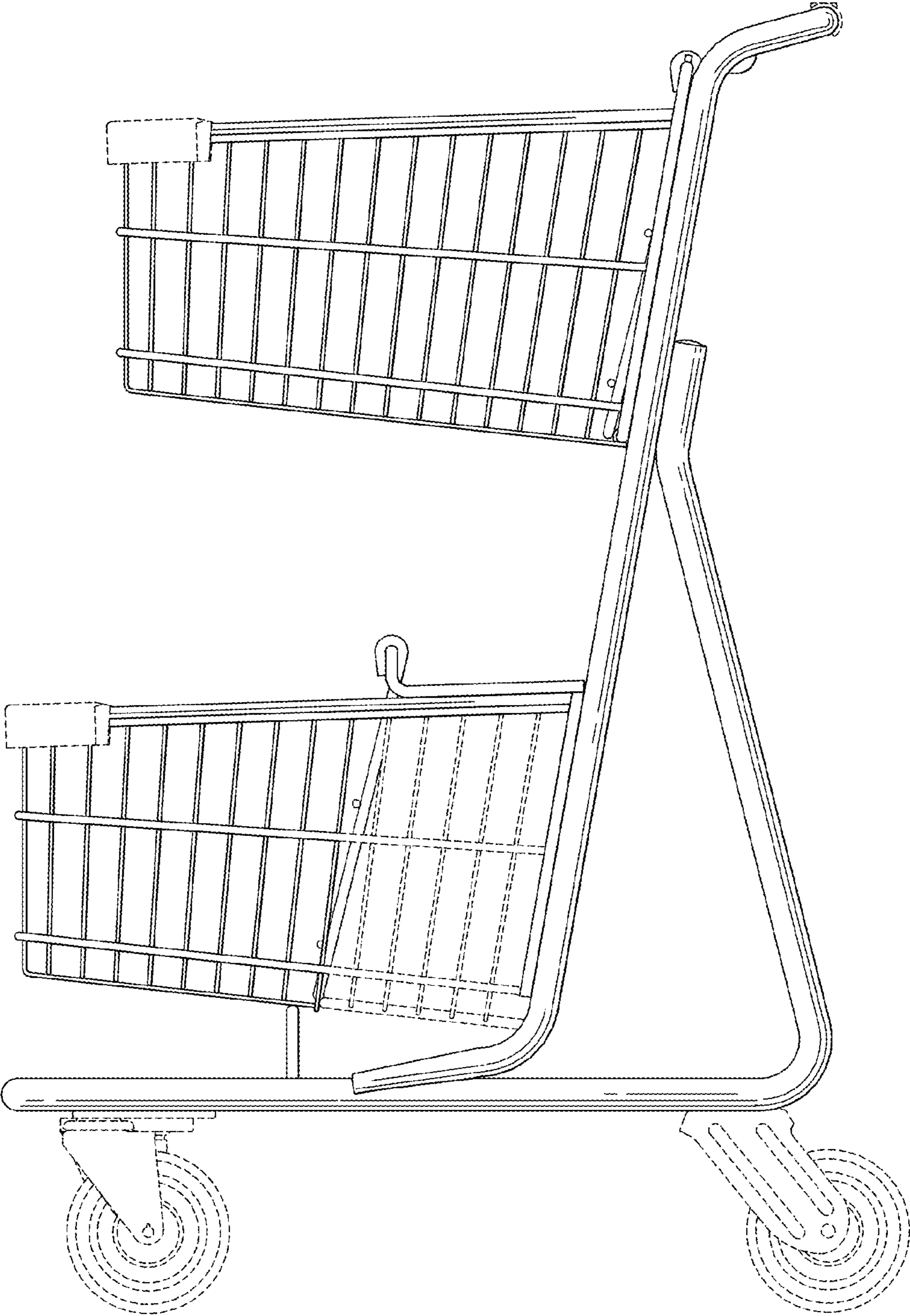

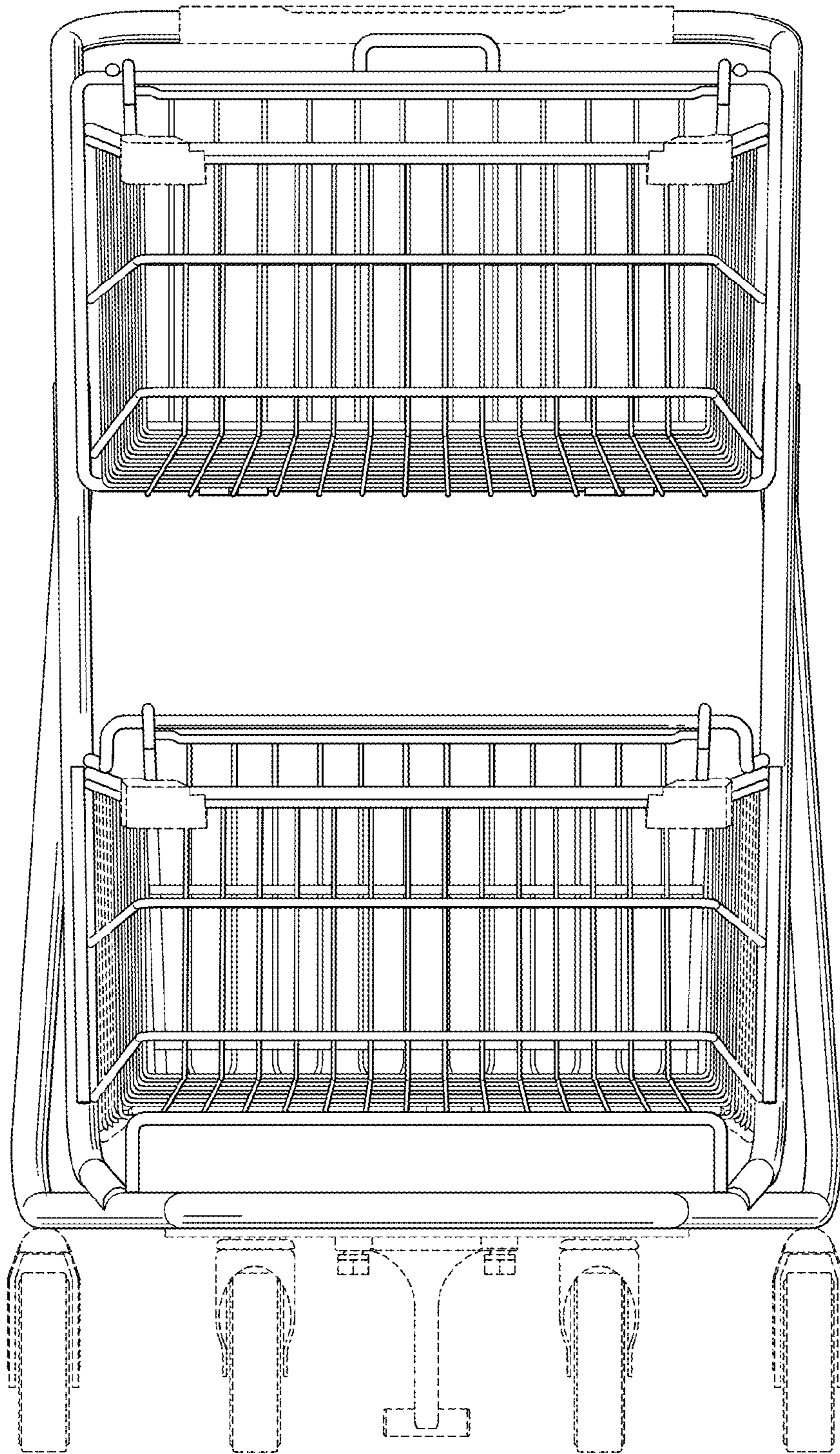

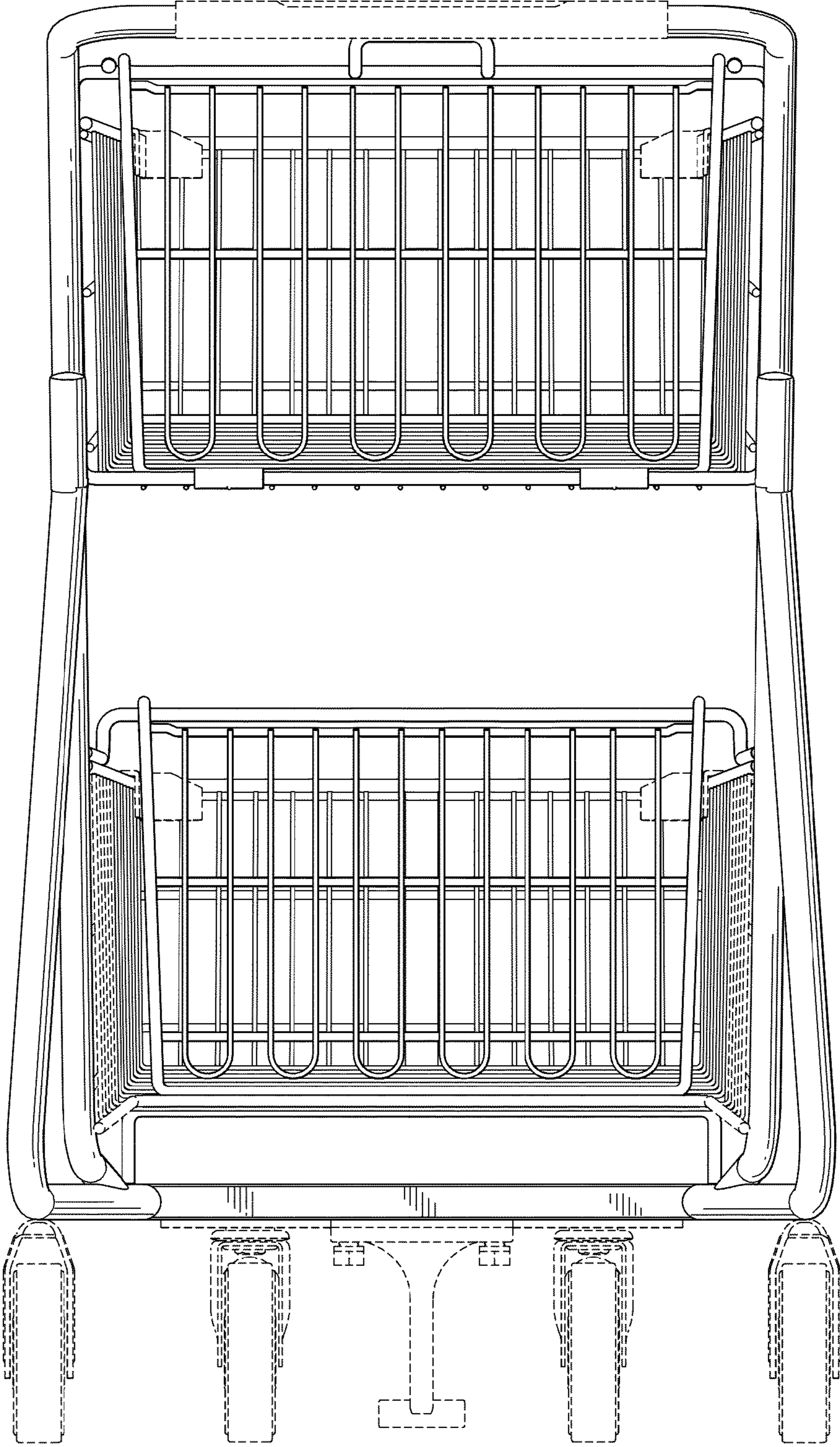

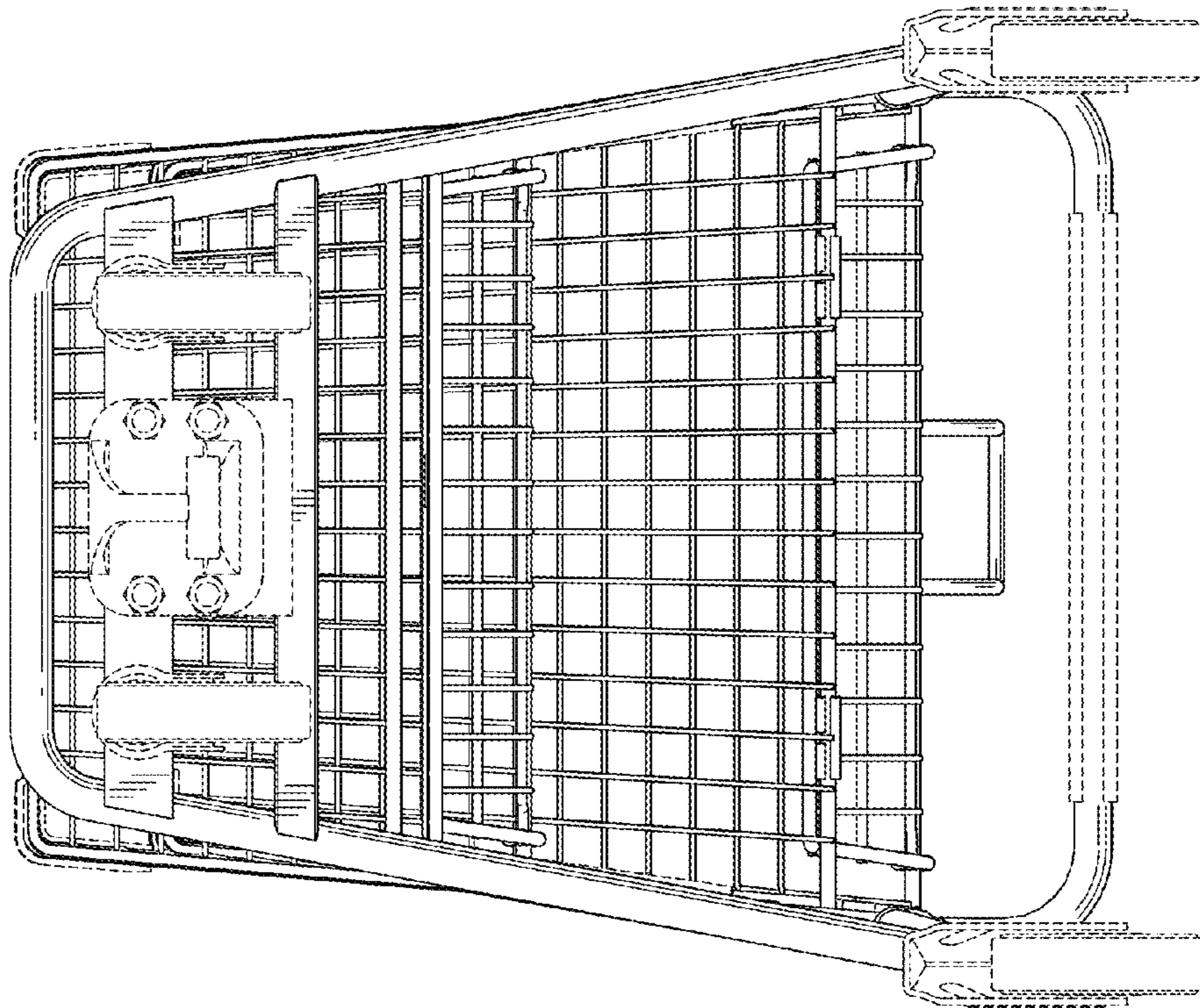

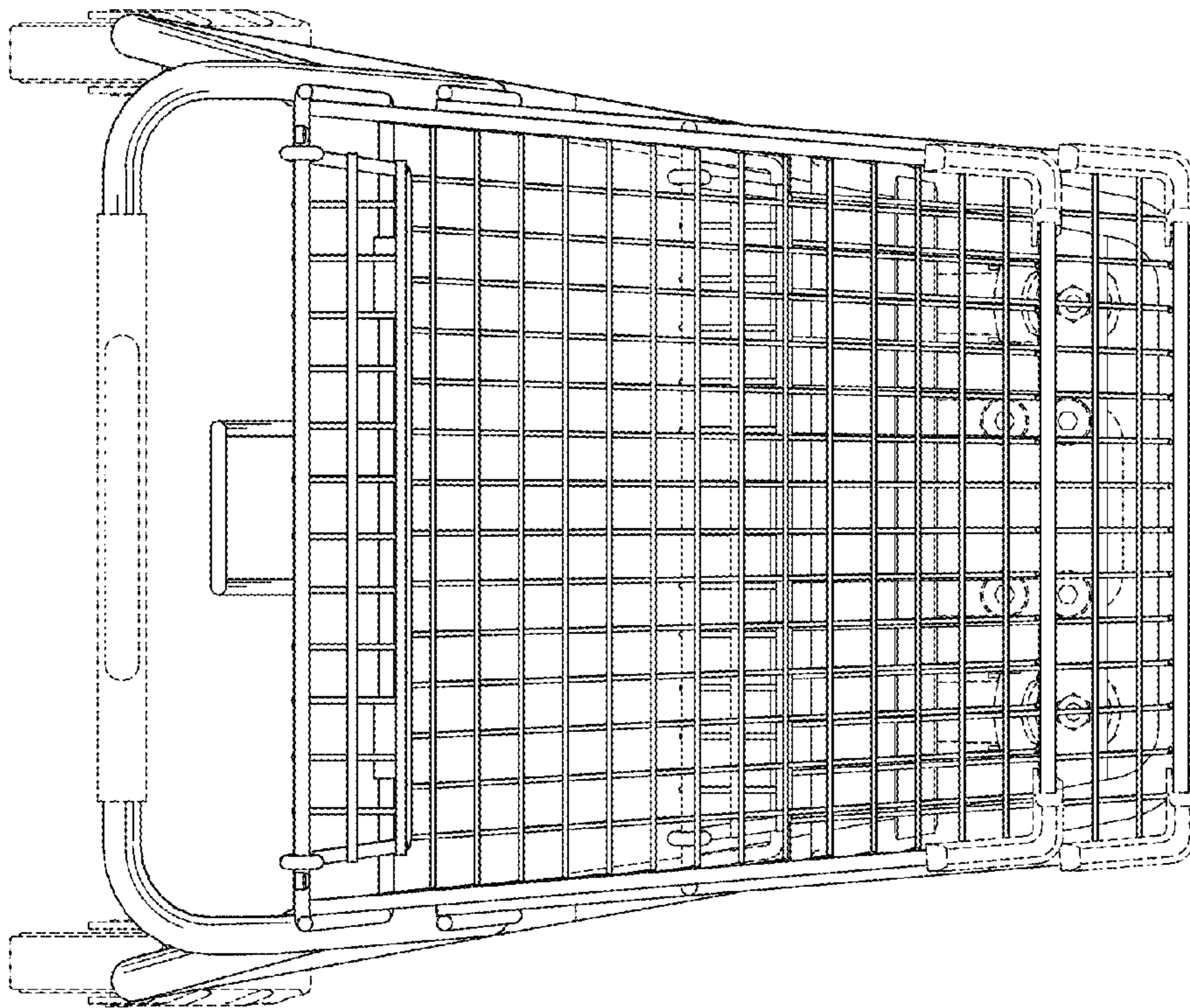
