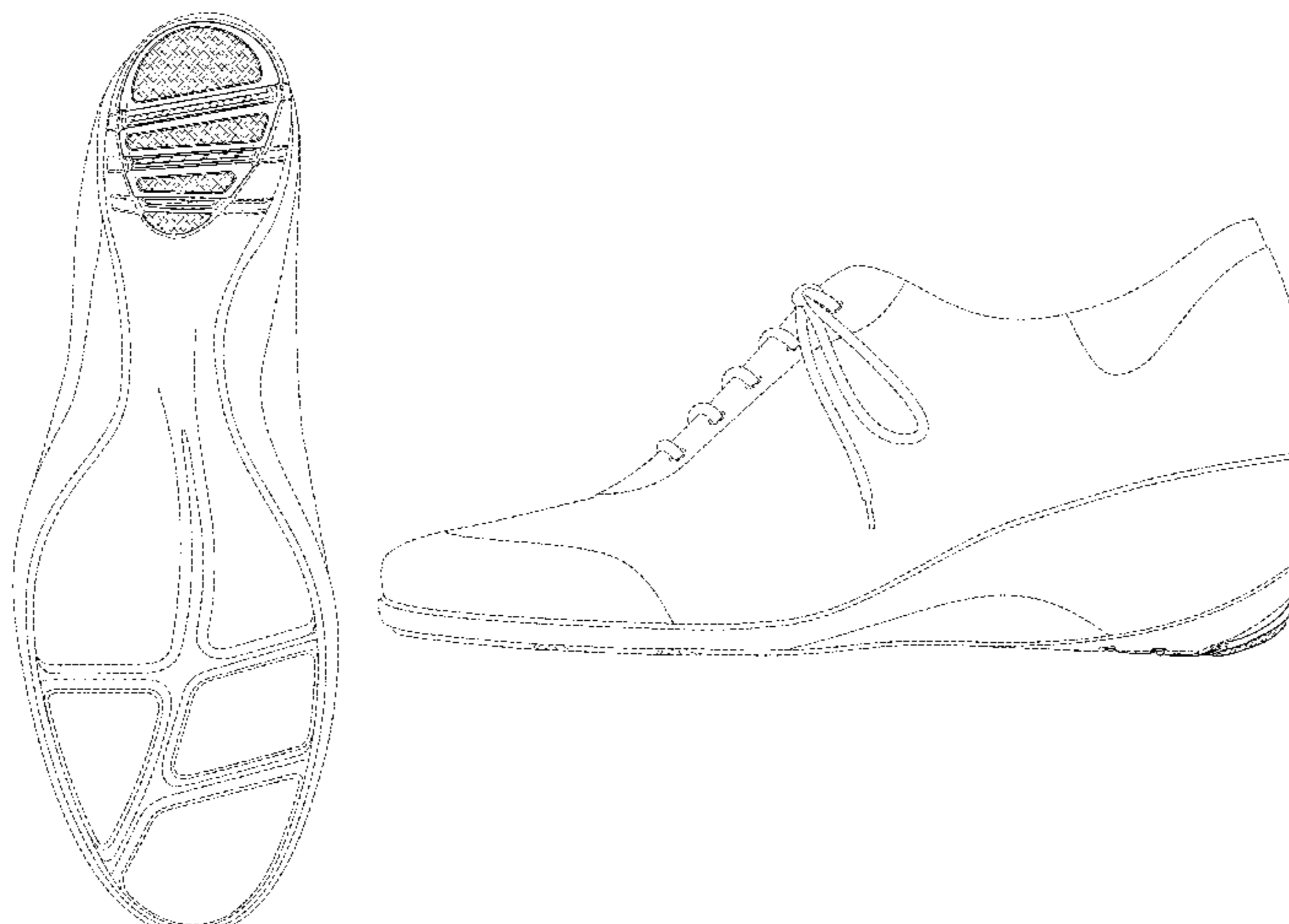
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of a shoe sole showing our new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a bottom plan view of another embodiment of the shoe sole of FIGS. 1-4 showing our new design  
FIG. 6 is a left side view thereof;  
FIG. 7 is a right side view thereof; and,  
FIG. 8 is a rear view thereof.  
The broken lines in the Figures show portions of the shoe upper and sole which form no part of the claimed design.

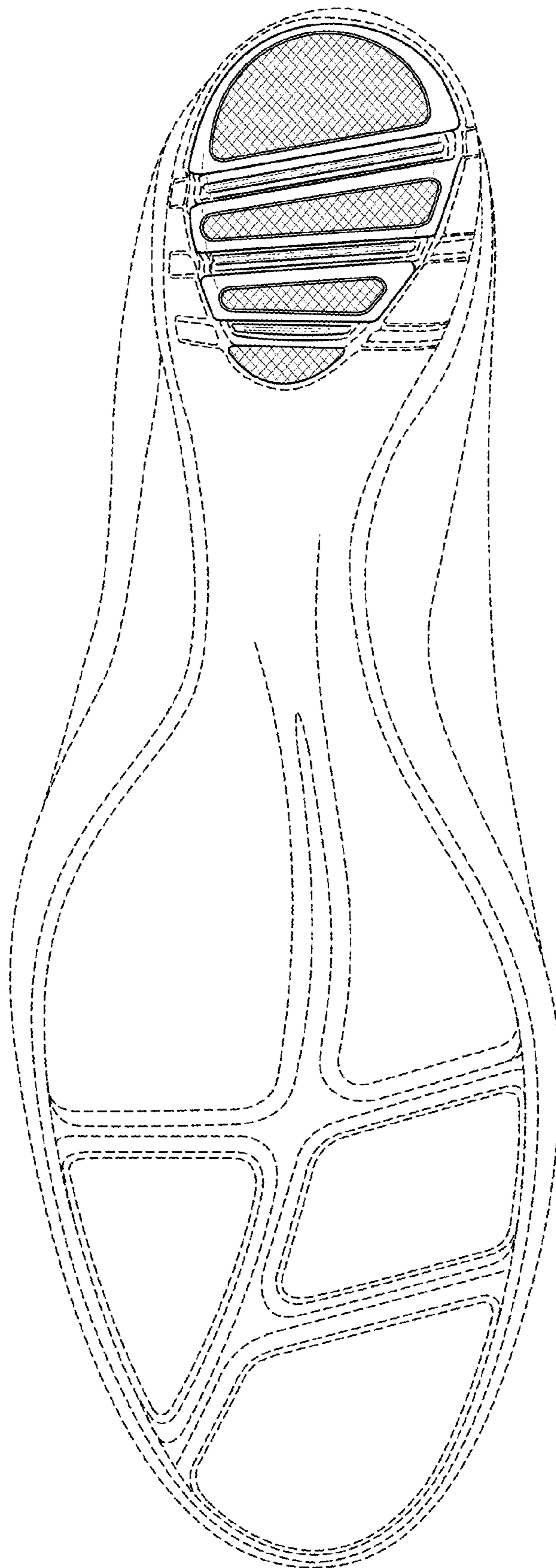

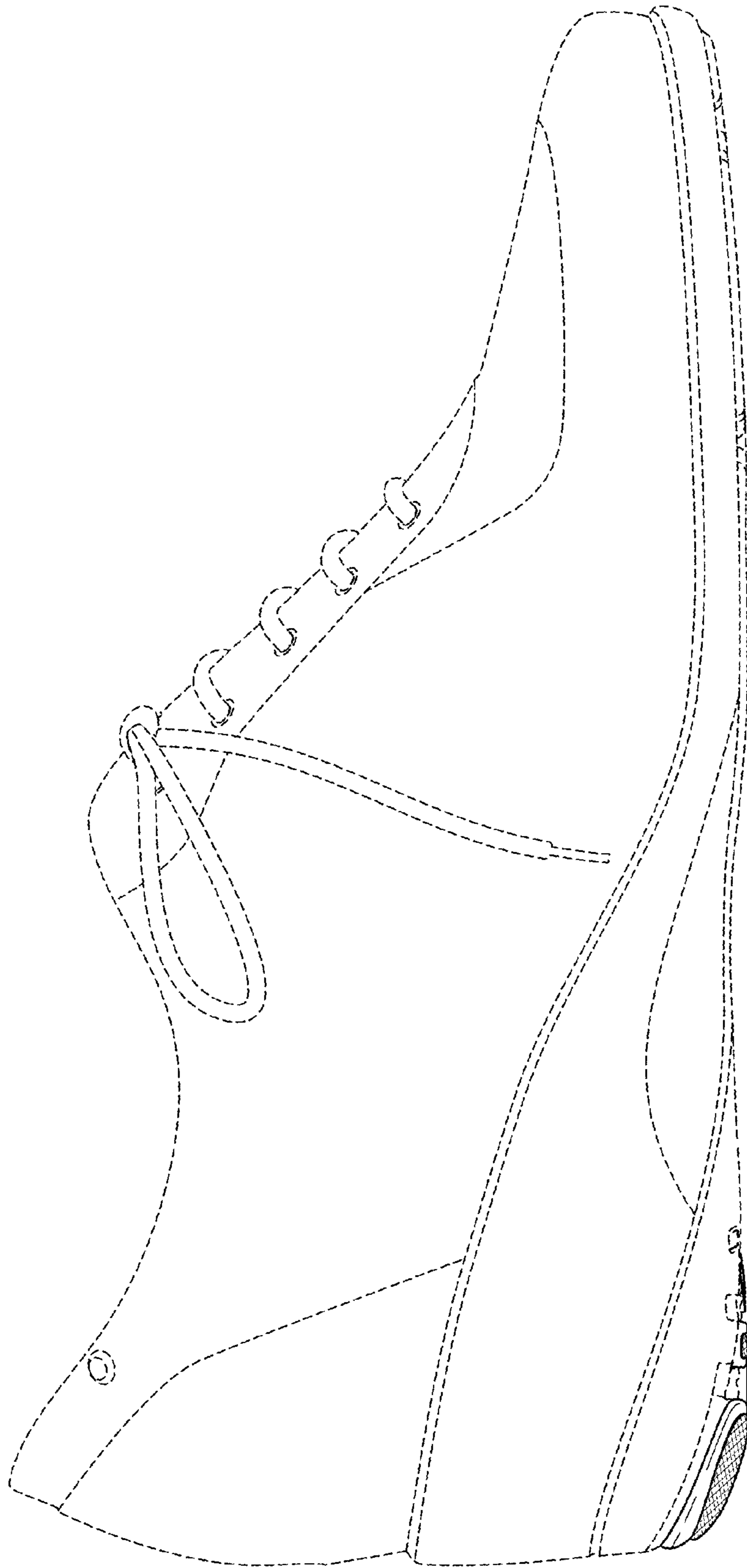

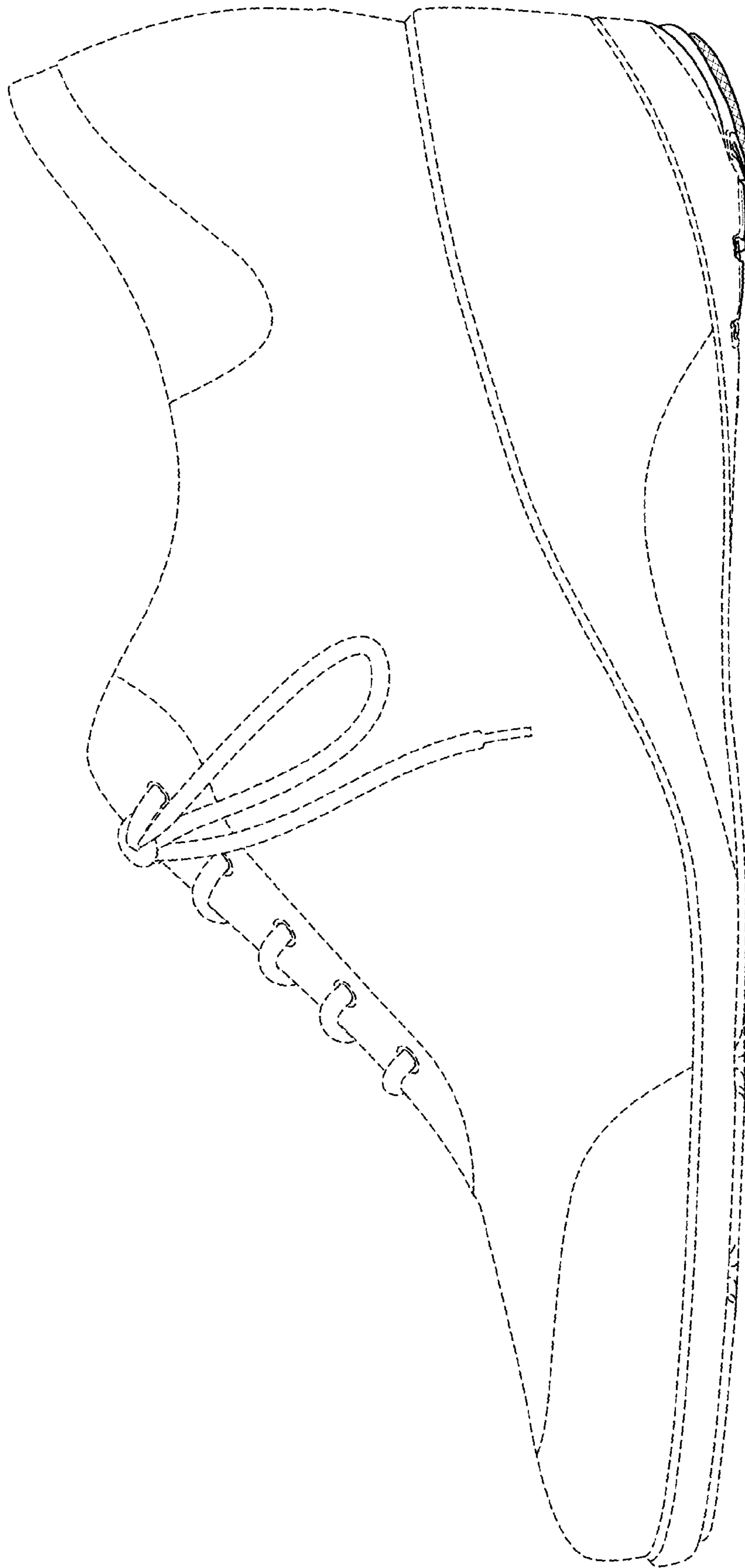
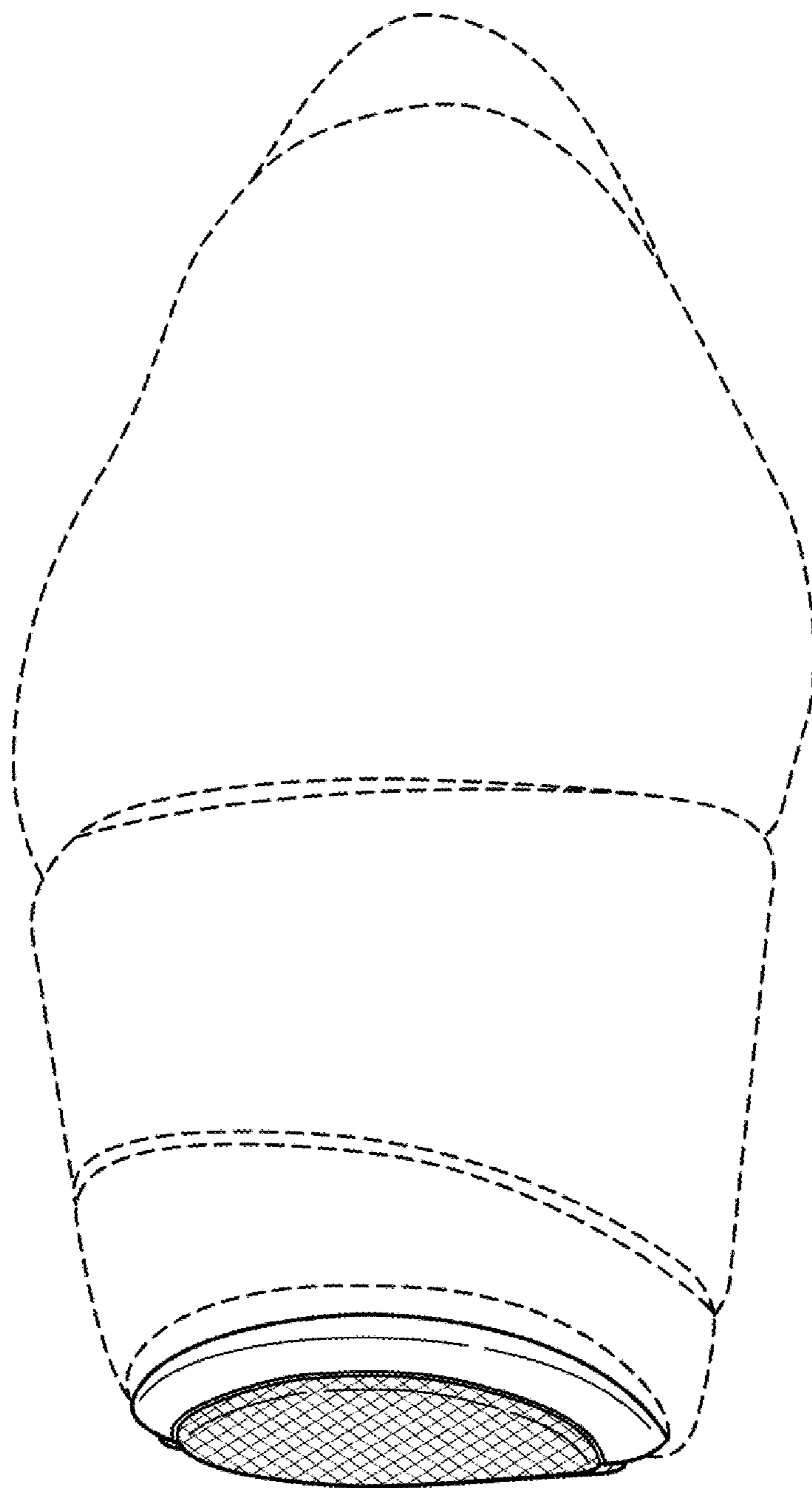
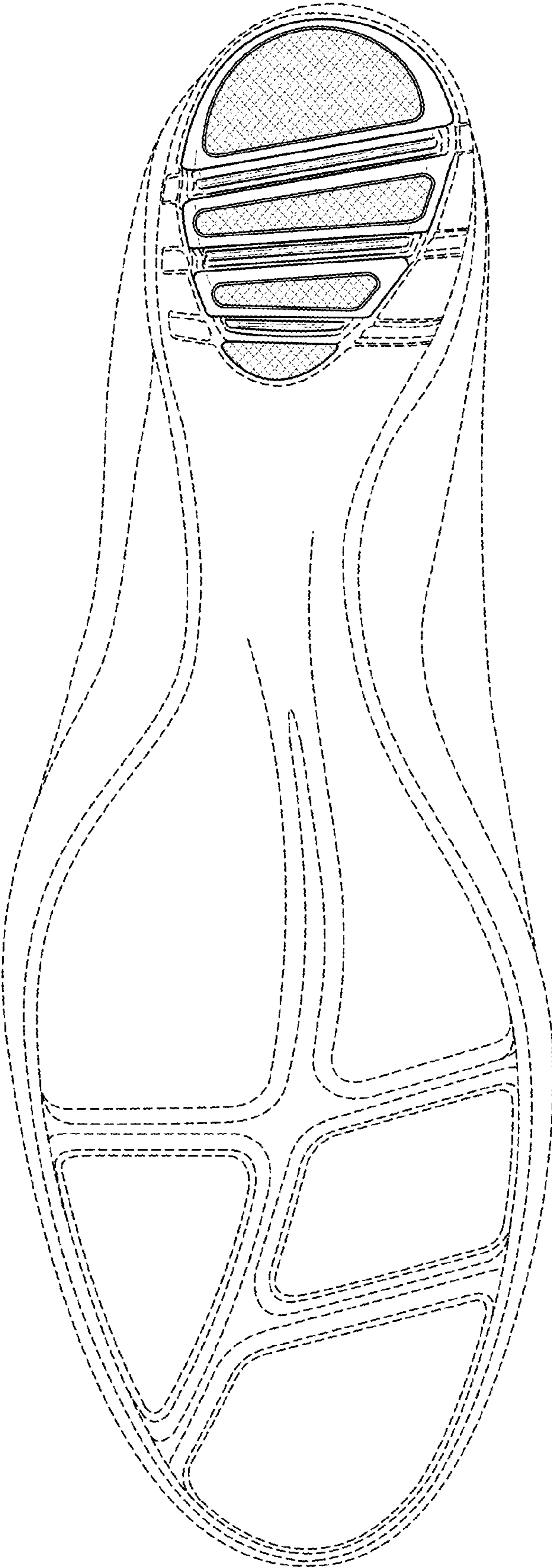

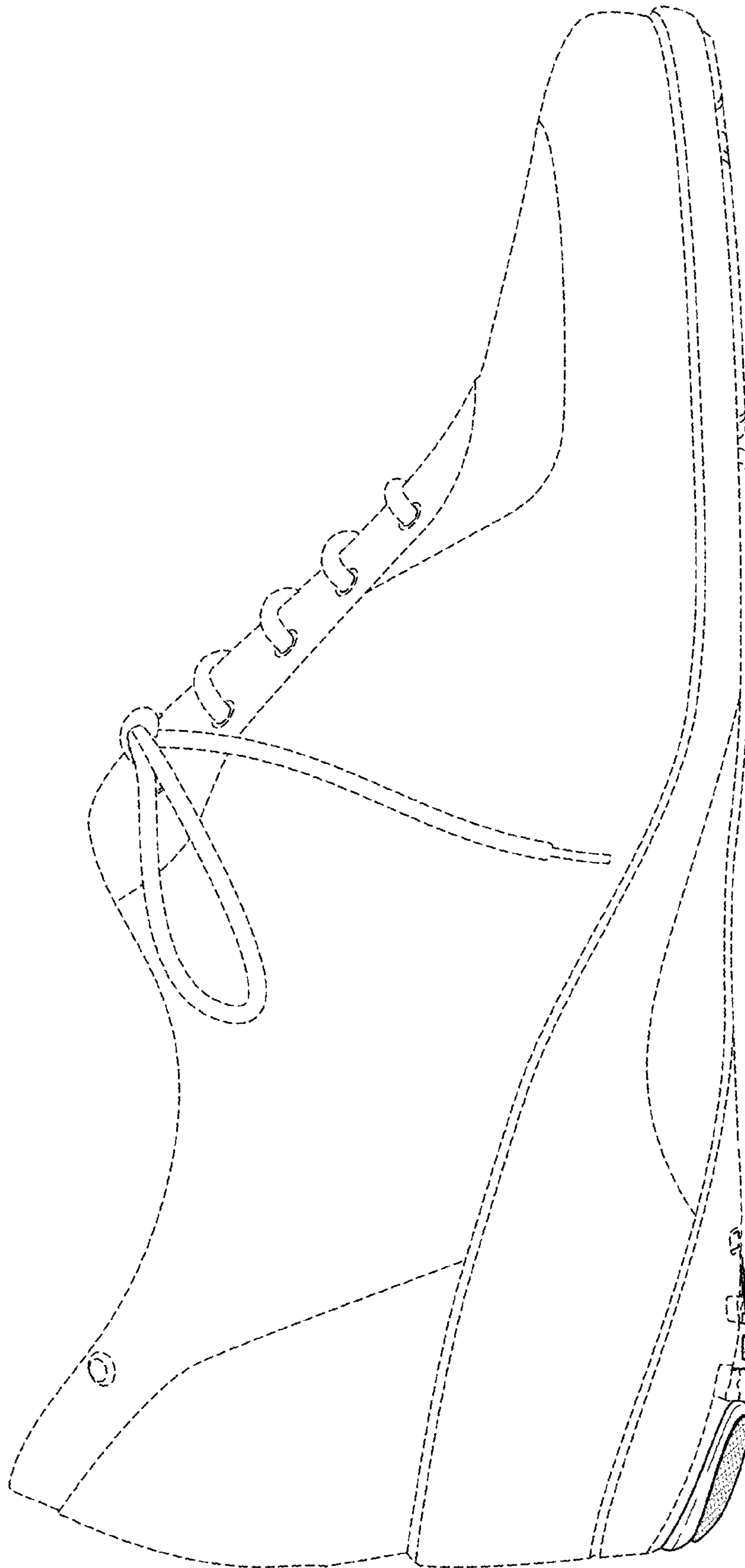

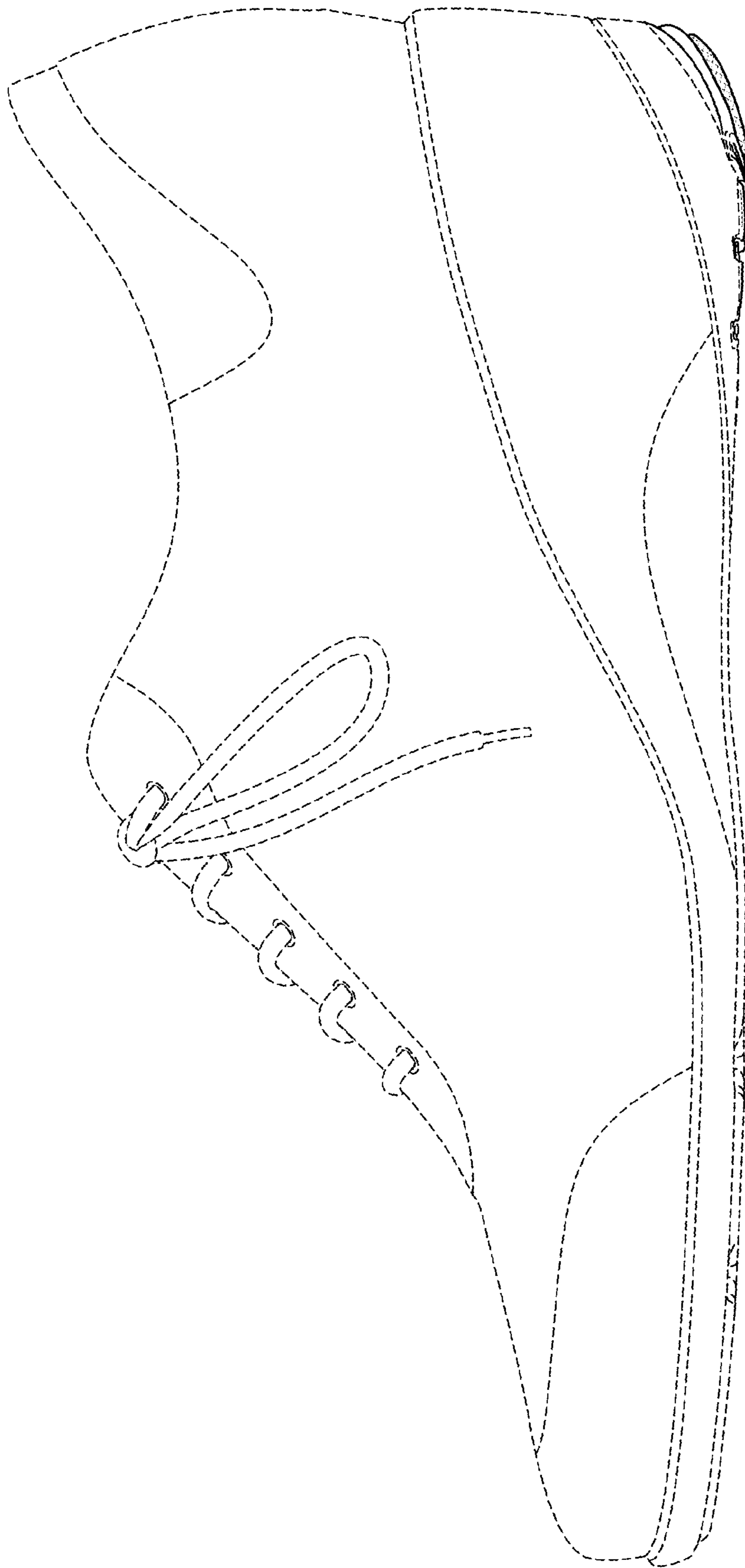
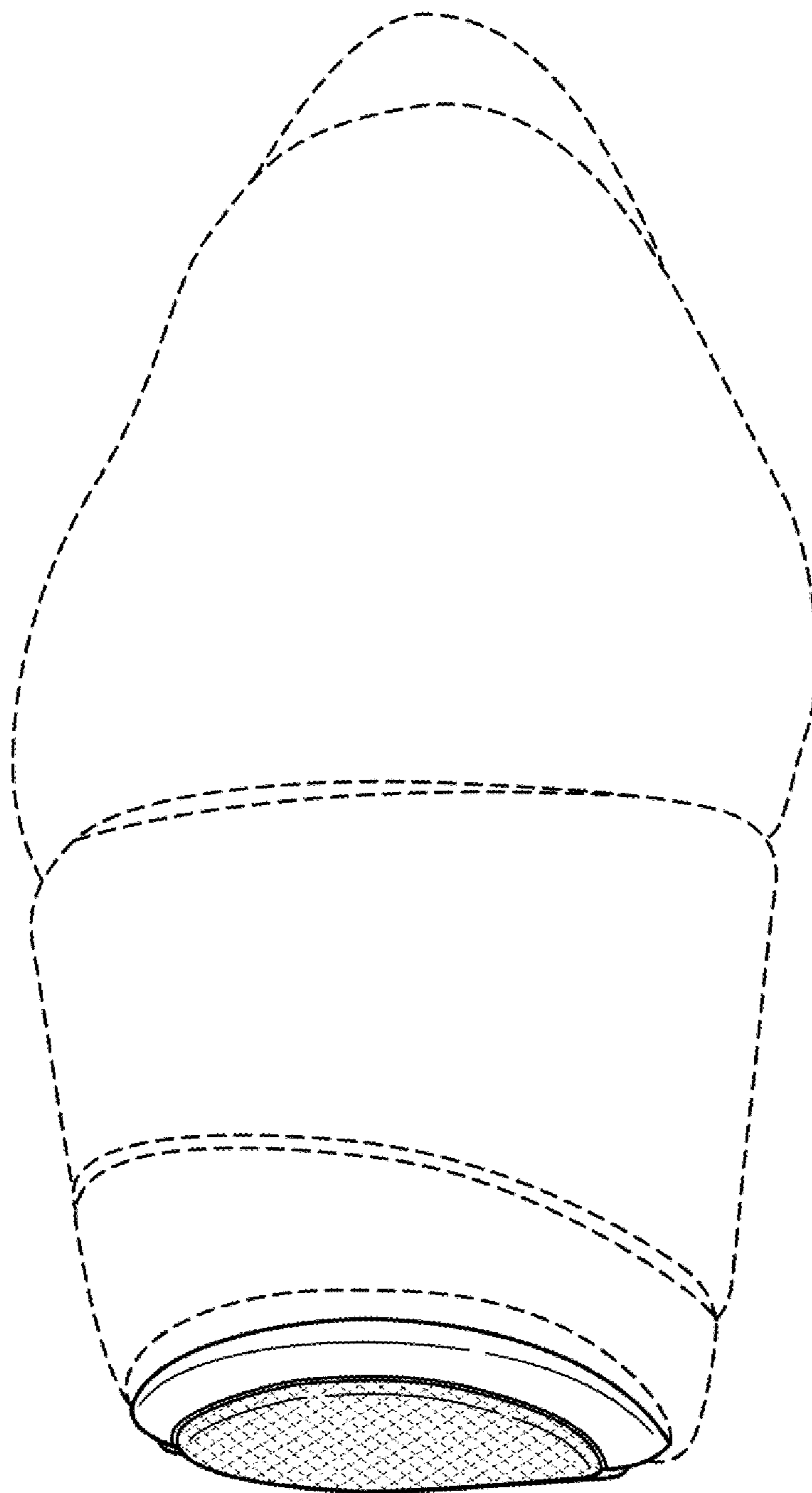
