(57) **CLAIM**

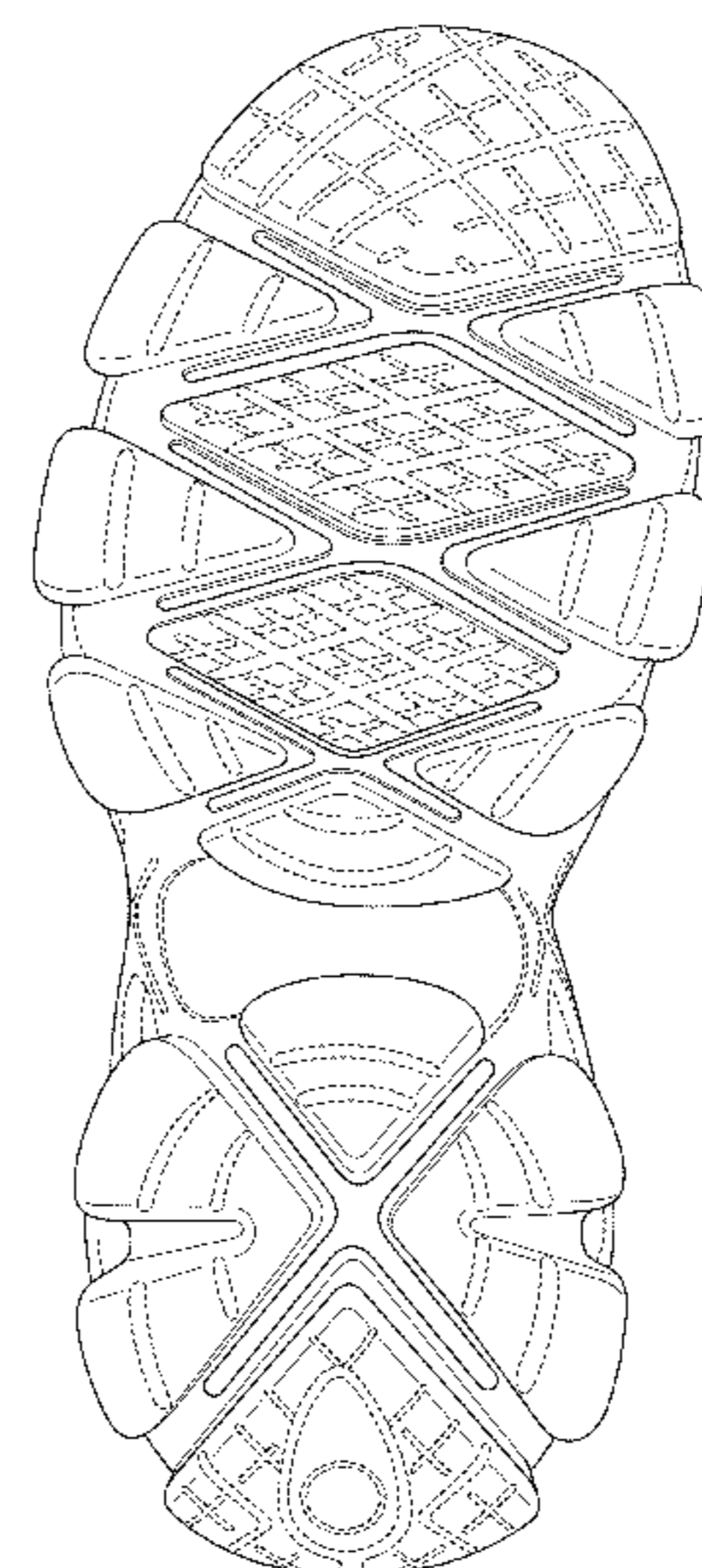
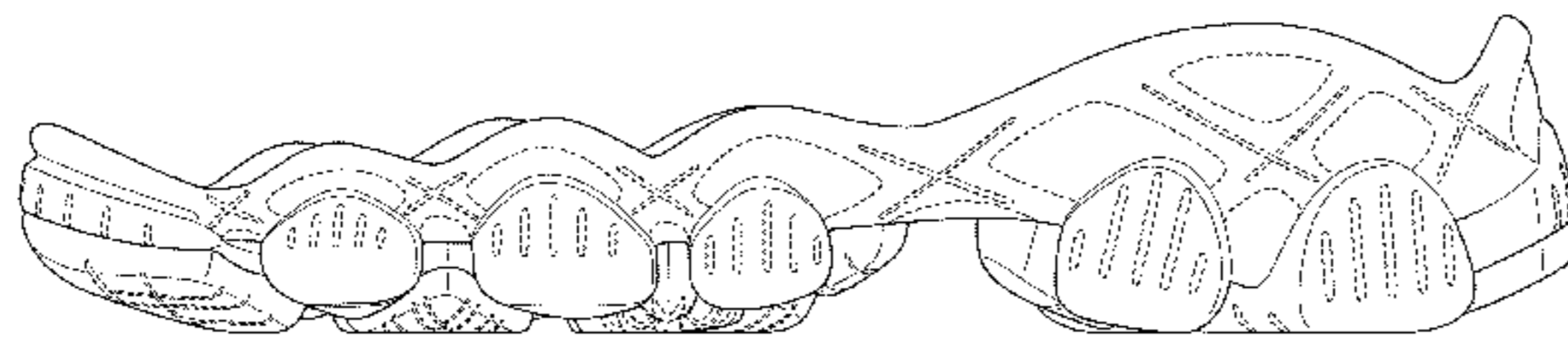
The ornamental design for a footwear outsole, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a footwear outsole, showing my new design;
FIG. 2 is a bottom perspective view of the footwear outsole of FIG. 1;
FIG. 3 is a lateral side view of the footwear outsole of FIG. 1;
FIG. 4 is a medial side view of the footwear outsole of FIG. 1;
FIG. 5 is a front view of the footwear outsole of FIG. 1;
FIG. 6 is a rear view of the footwear outsole of FIG. 1;
FIG. 7 is a top plan view of the footwear outsole of FIG. 1; and,
FIG. 8 is a bottom plan view of the footwear outsole of FIG. 1.

The drawings show a first embodiment of the design of a footwear outsole for a footwear article suitable for being worn on a right foot. The ornamental design also includes a second embodiment, the views of which are mirror images of the drawings, i.e., the design of a footwear outsole on a footwear article for being worn on a left foot. Portions shown in stippled (dashed) lines do not form part of the design.

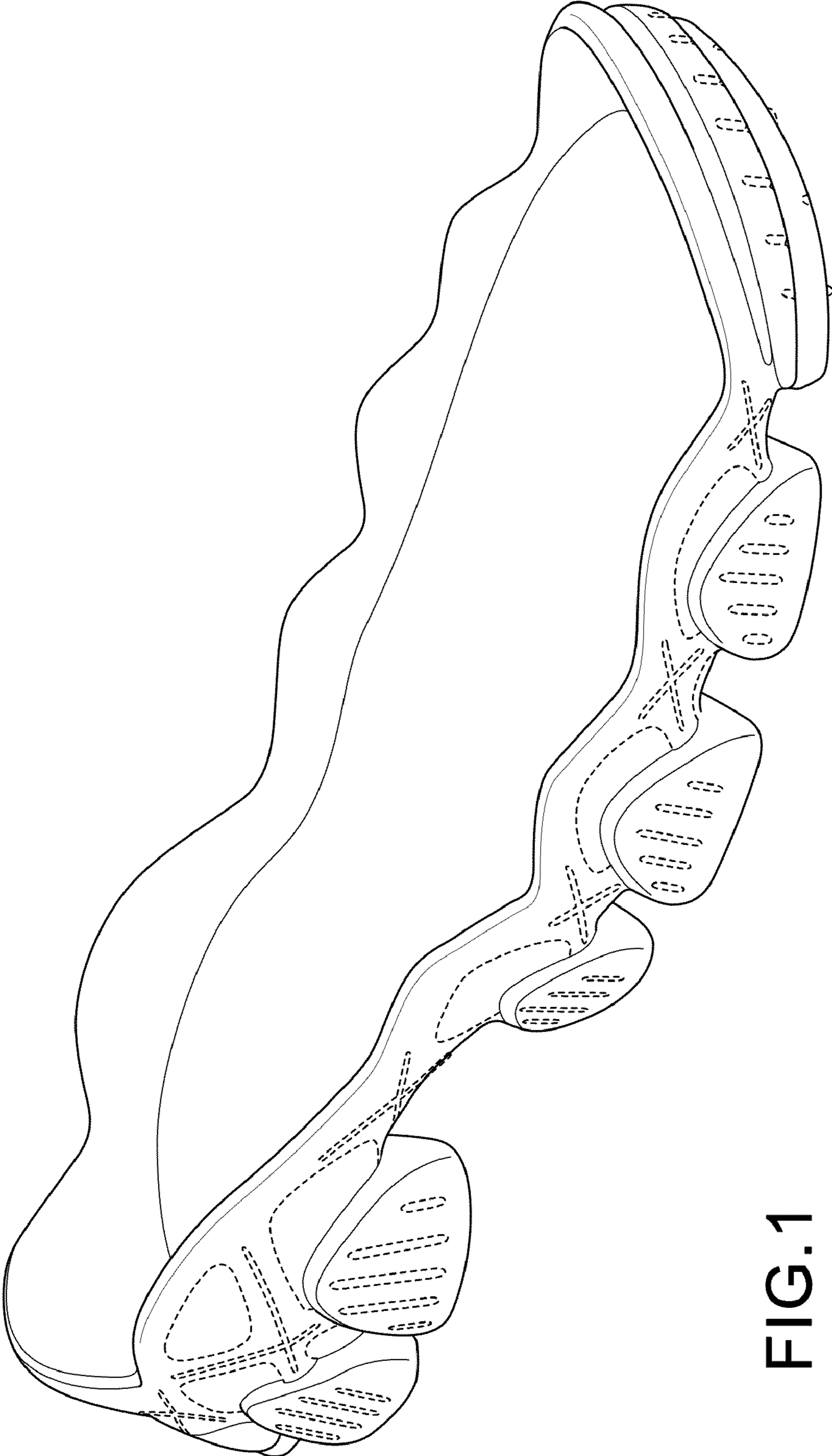

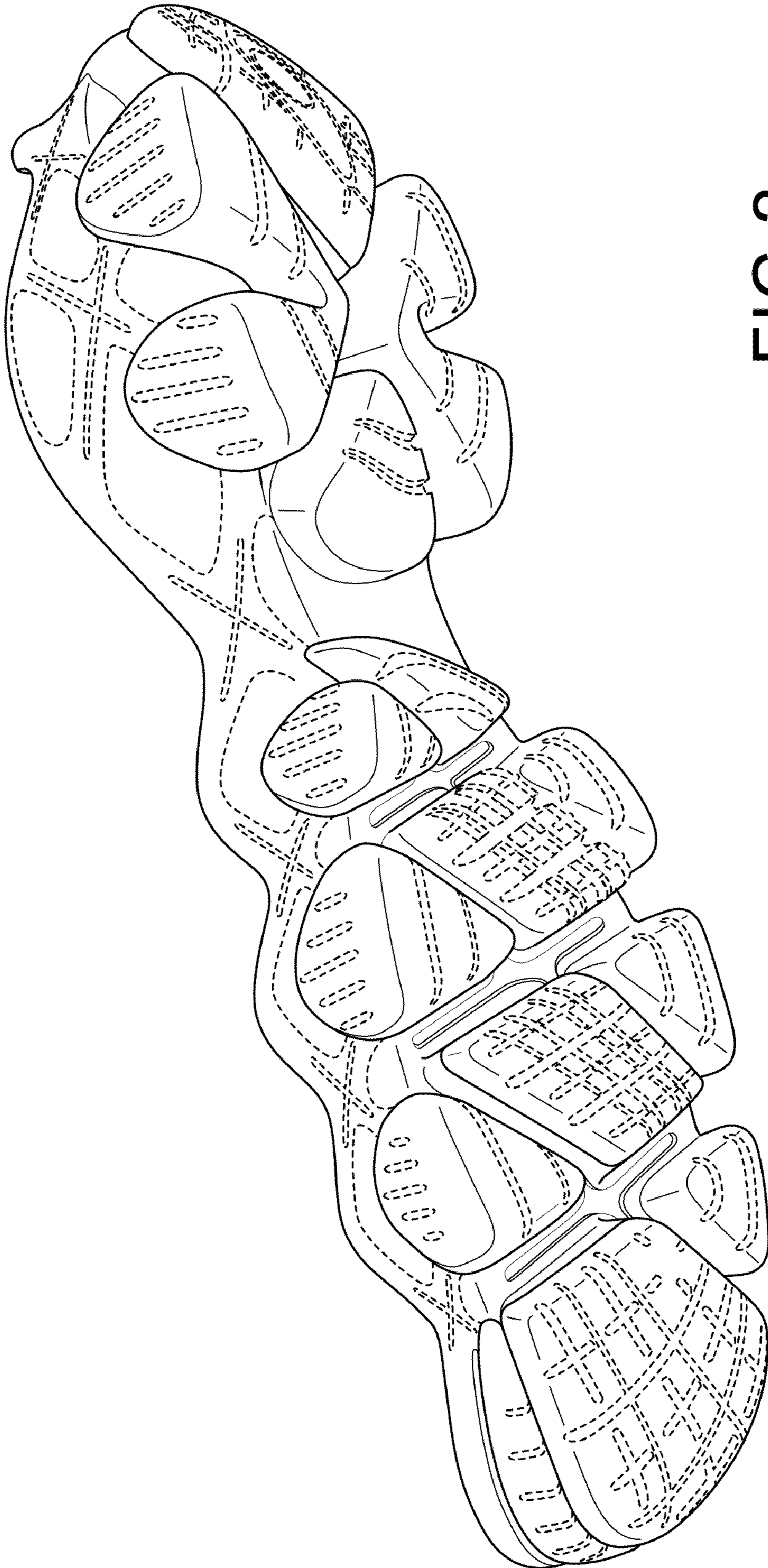

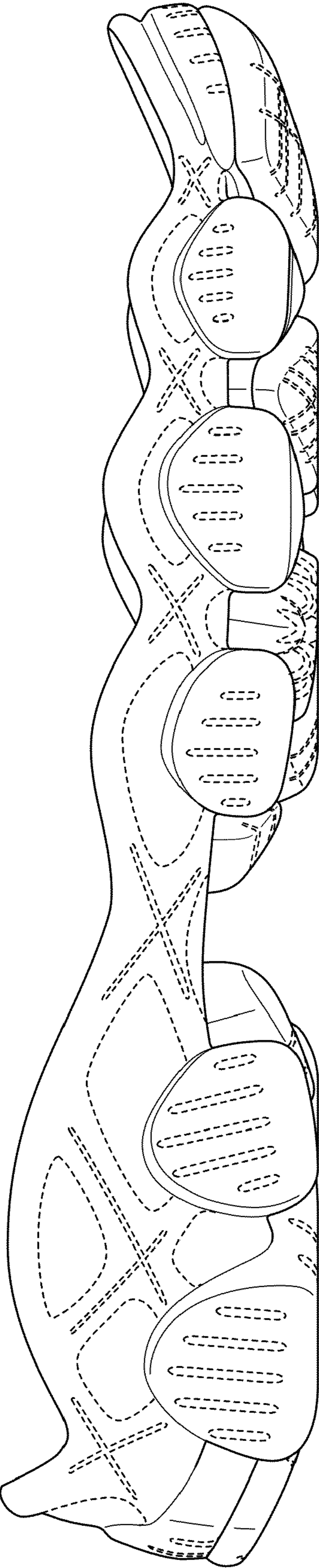

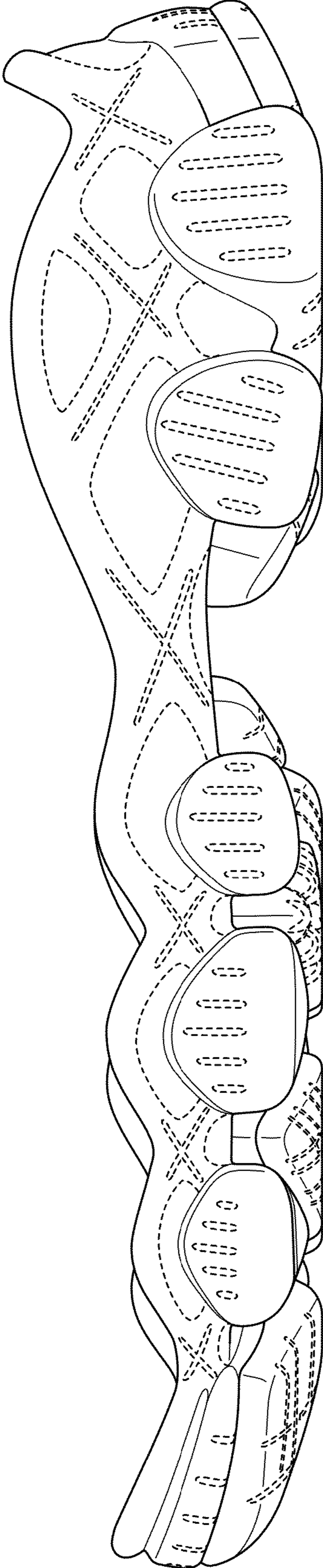

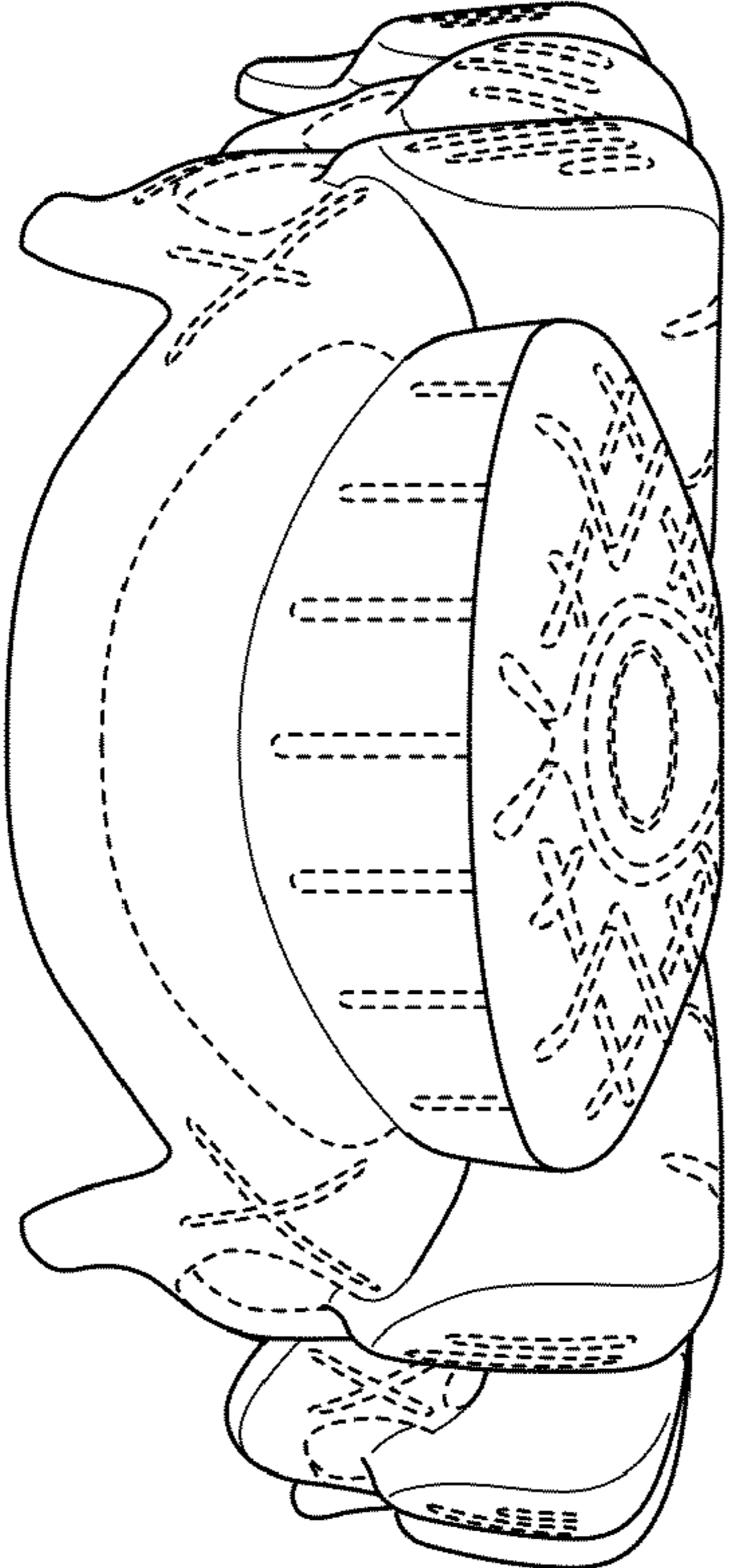

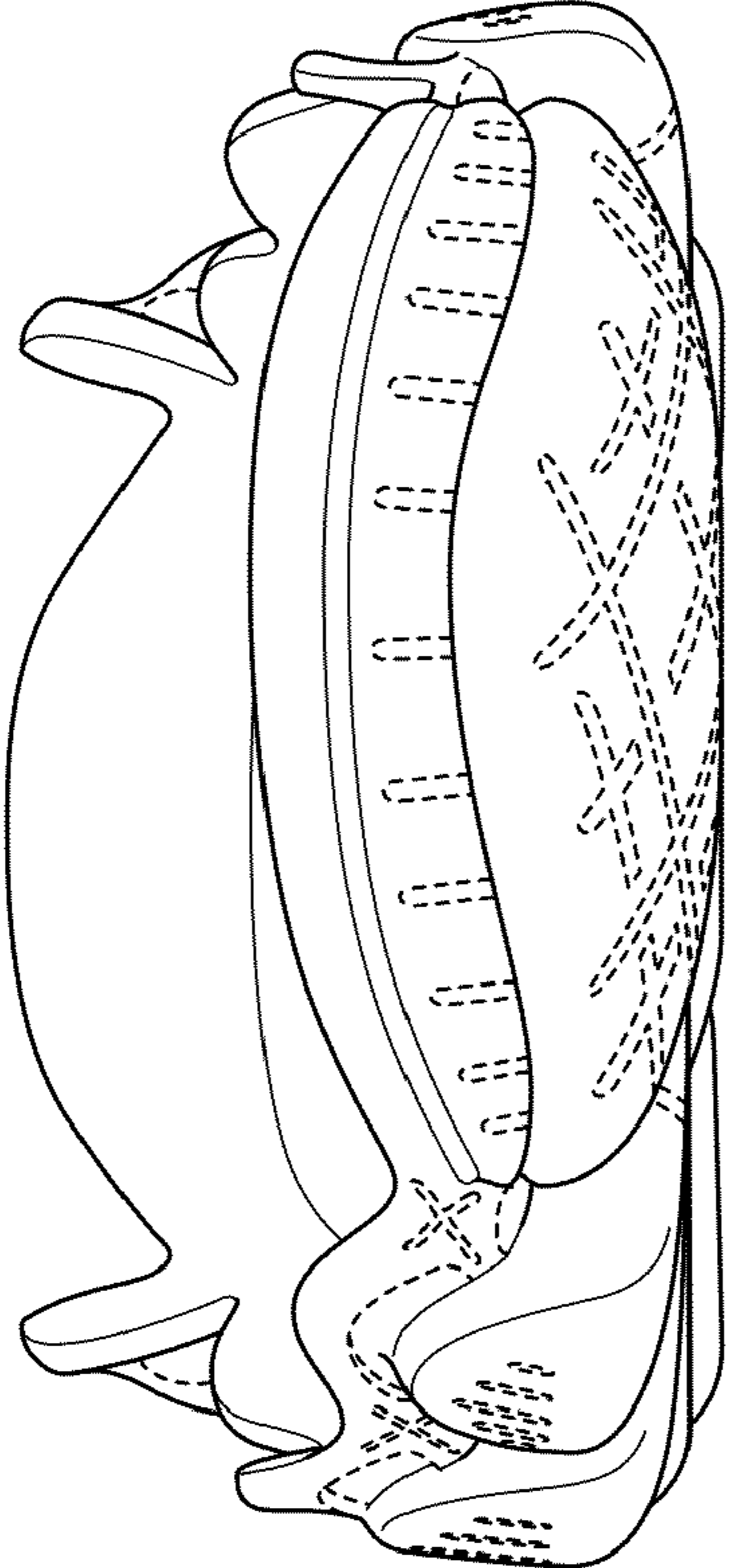

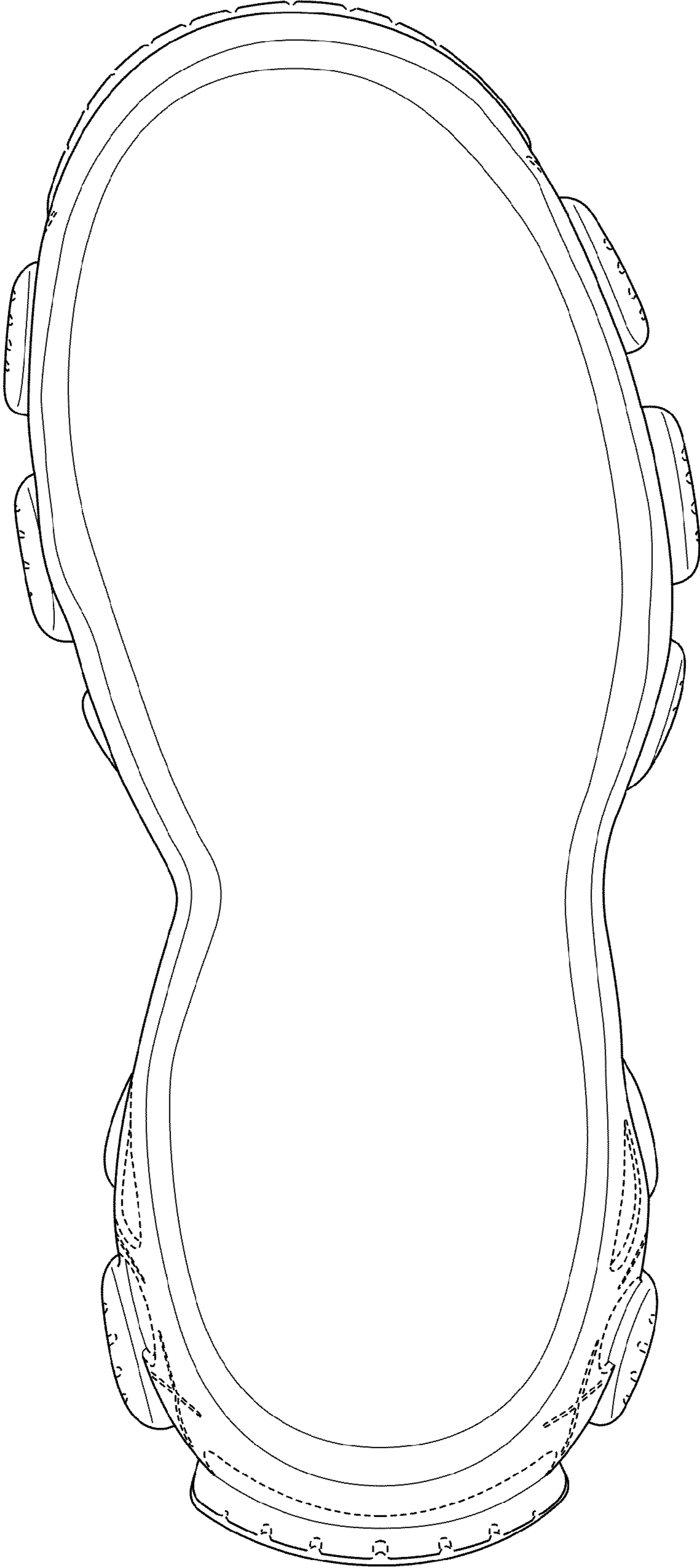

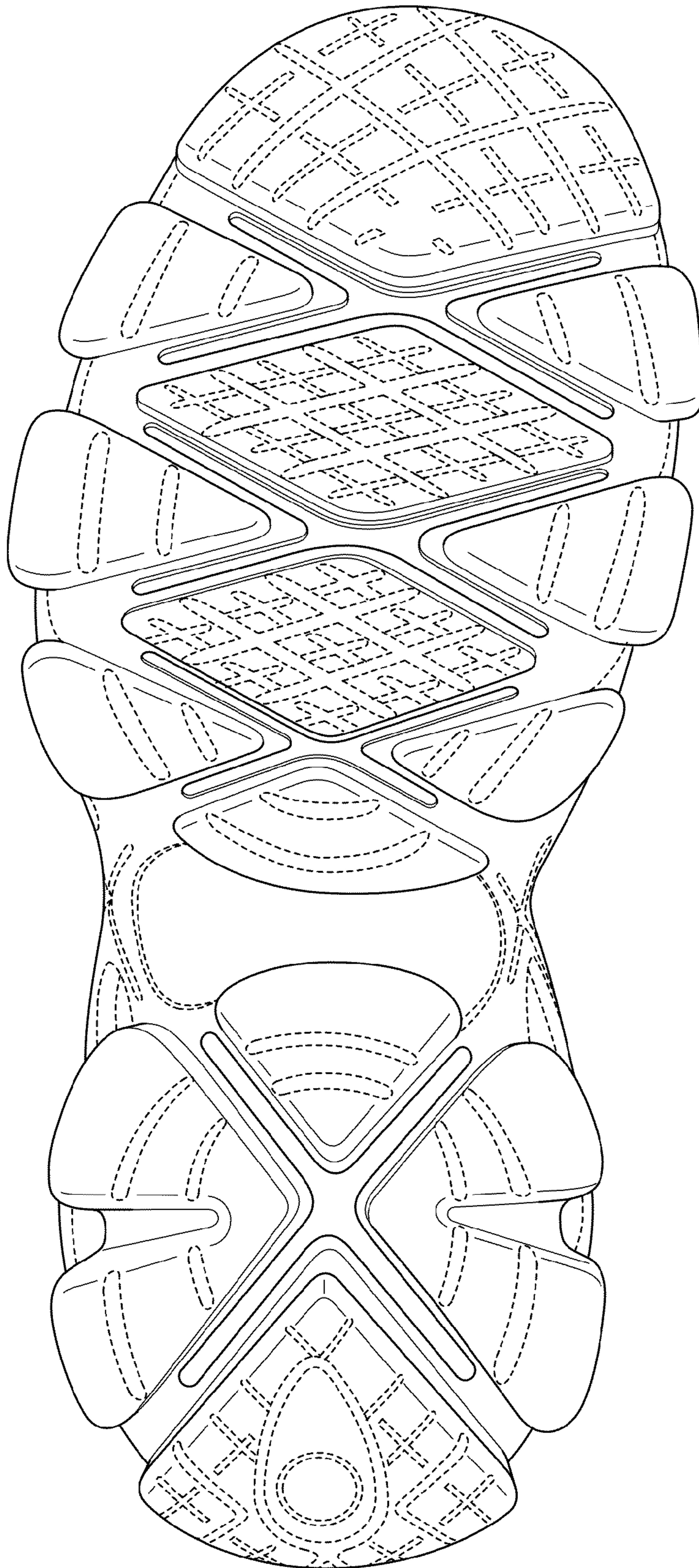
