(57) **CLAIM**

The ornamental design for a combined cooler and table, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view for the design for a combined cooler and table;

FIG. 2 is a bottom perspective view of the design for a combined cooler and table as seen in FIG. 1;

FIG. 3 is a side elevational view of the design for a combined cooler and table, as seen in FIG. 1, at a closed position;

FIG. 4 is a another side elevational view of the design for a combined cooler and table, as seen in FIG. 1, at a closed position;

FIG. 5 is a top perspective view of the design for a combined cooler and table, as seen in FIG. 1, at an opened position;

FIG. 6 is a bottom perspective view of the design for a combined cooler and table, as seen in FIG. 1, at an opened position;

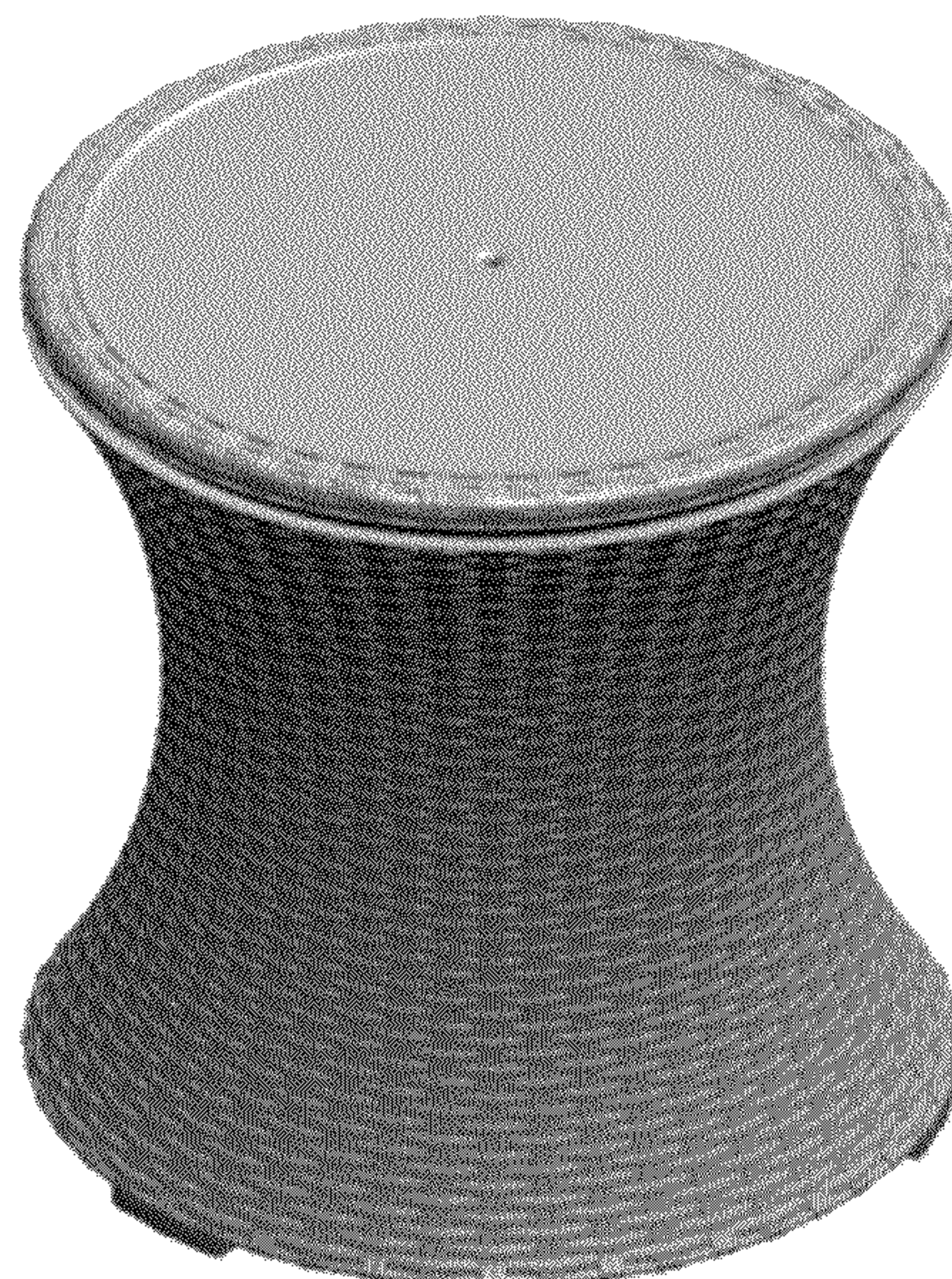
FIG. 7 is a side elevational view of the design for a combined cooler and table, as seen in FIG. 1, at an opened position;

FIG. 8 is a another side elevational view of the design for a combined cooler and table, as seen in FIG. 1, at an opened position;

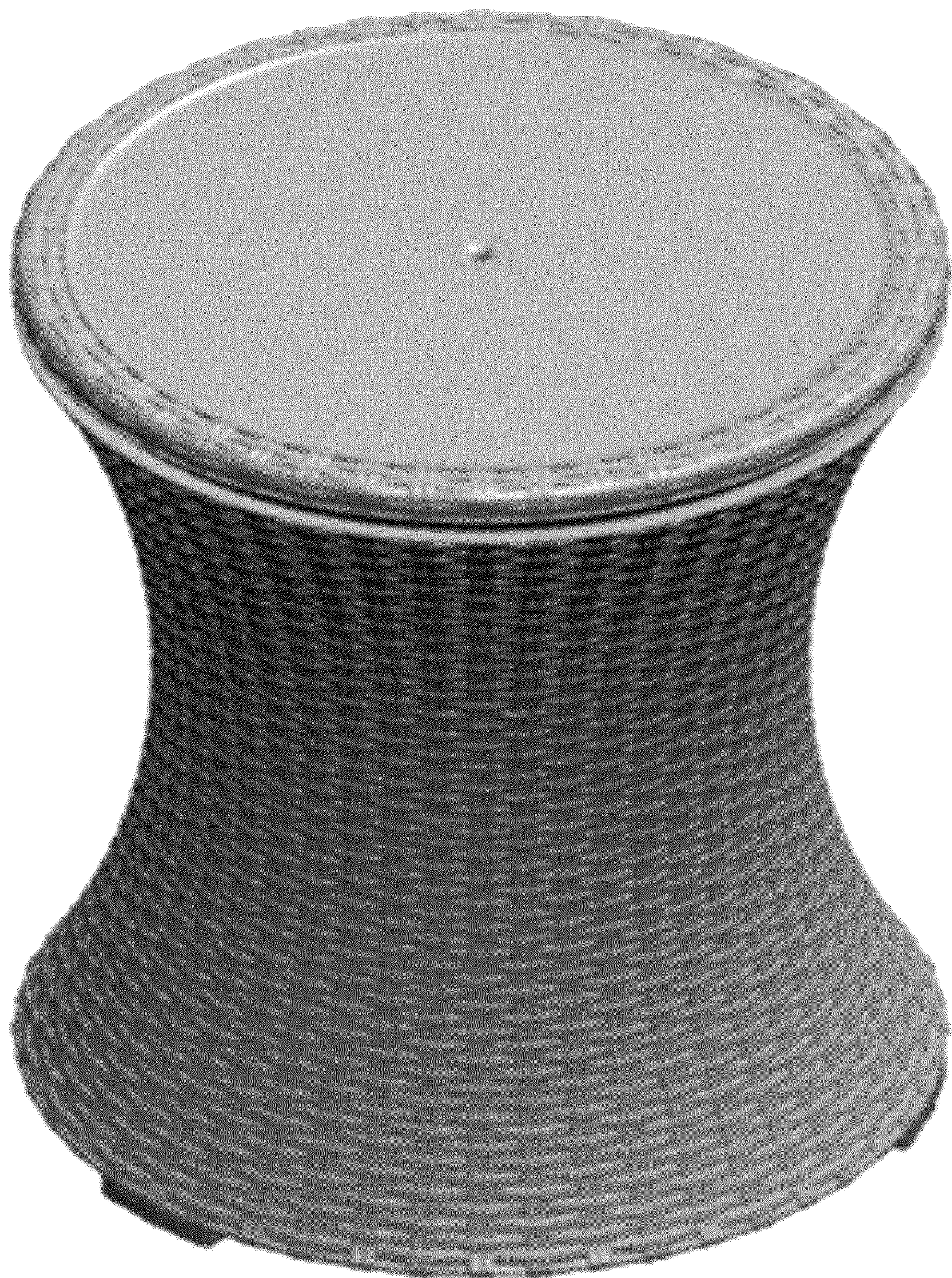

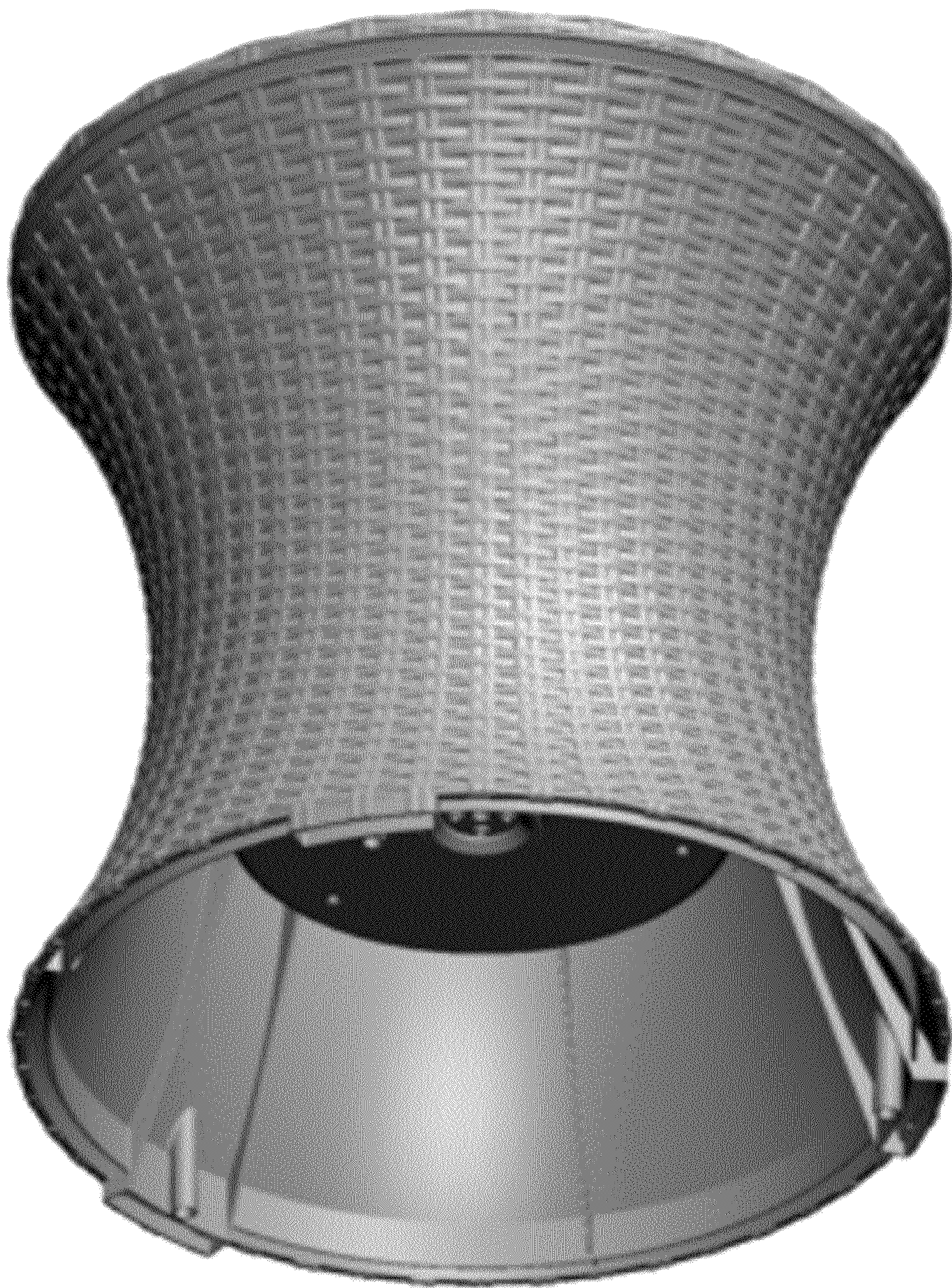

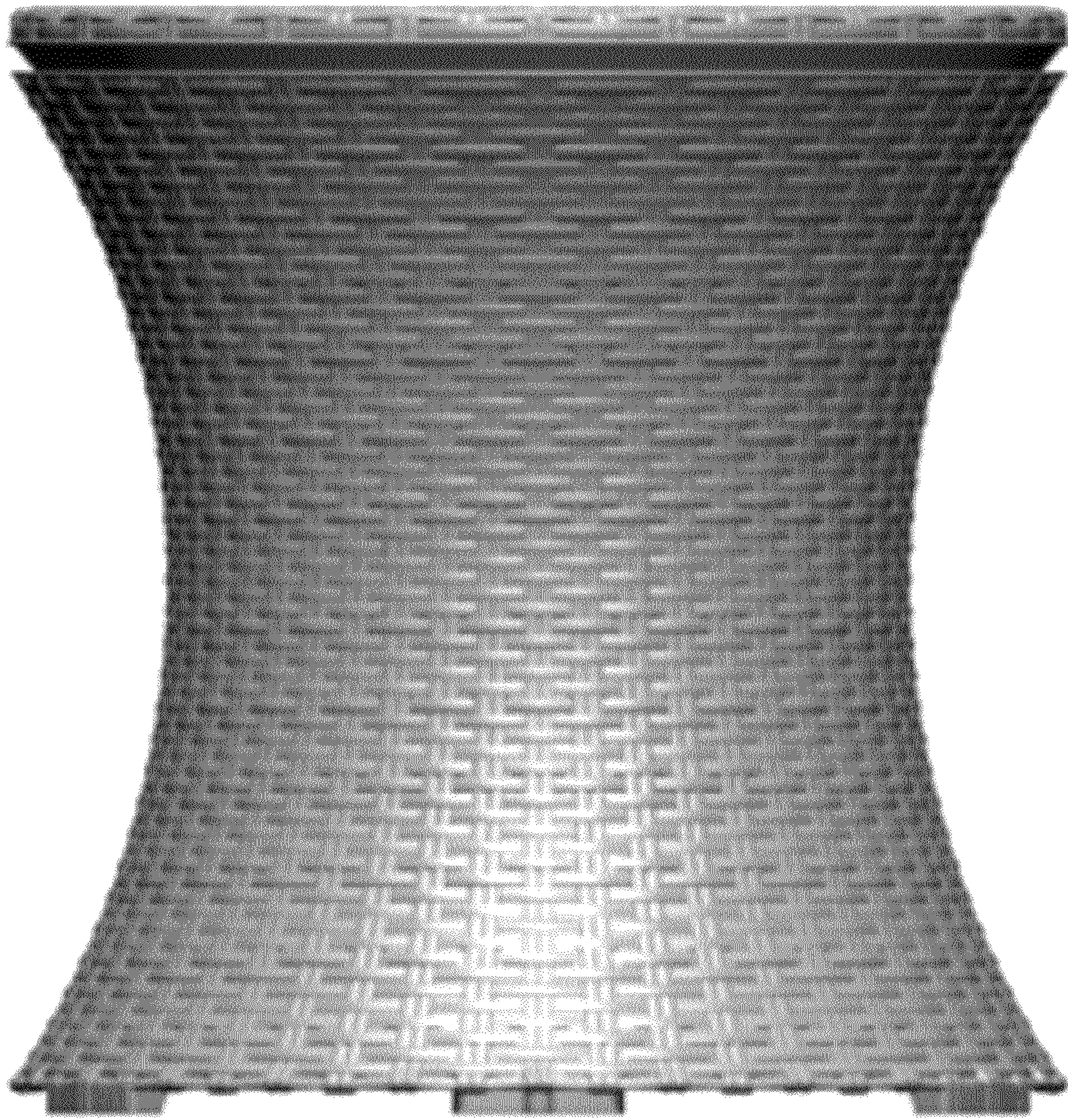

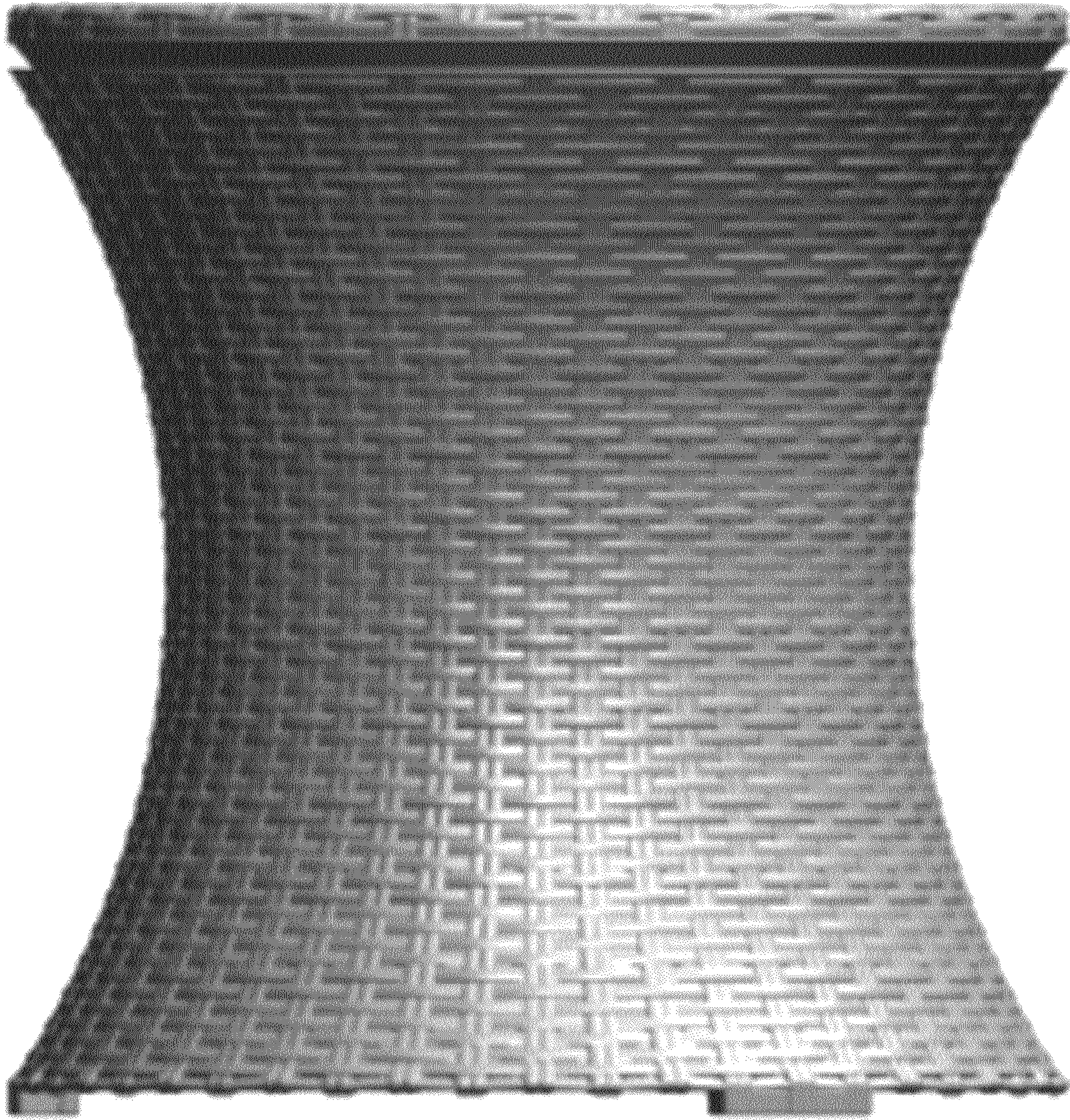

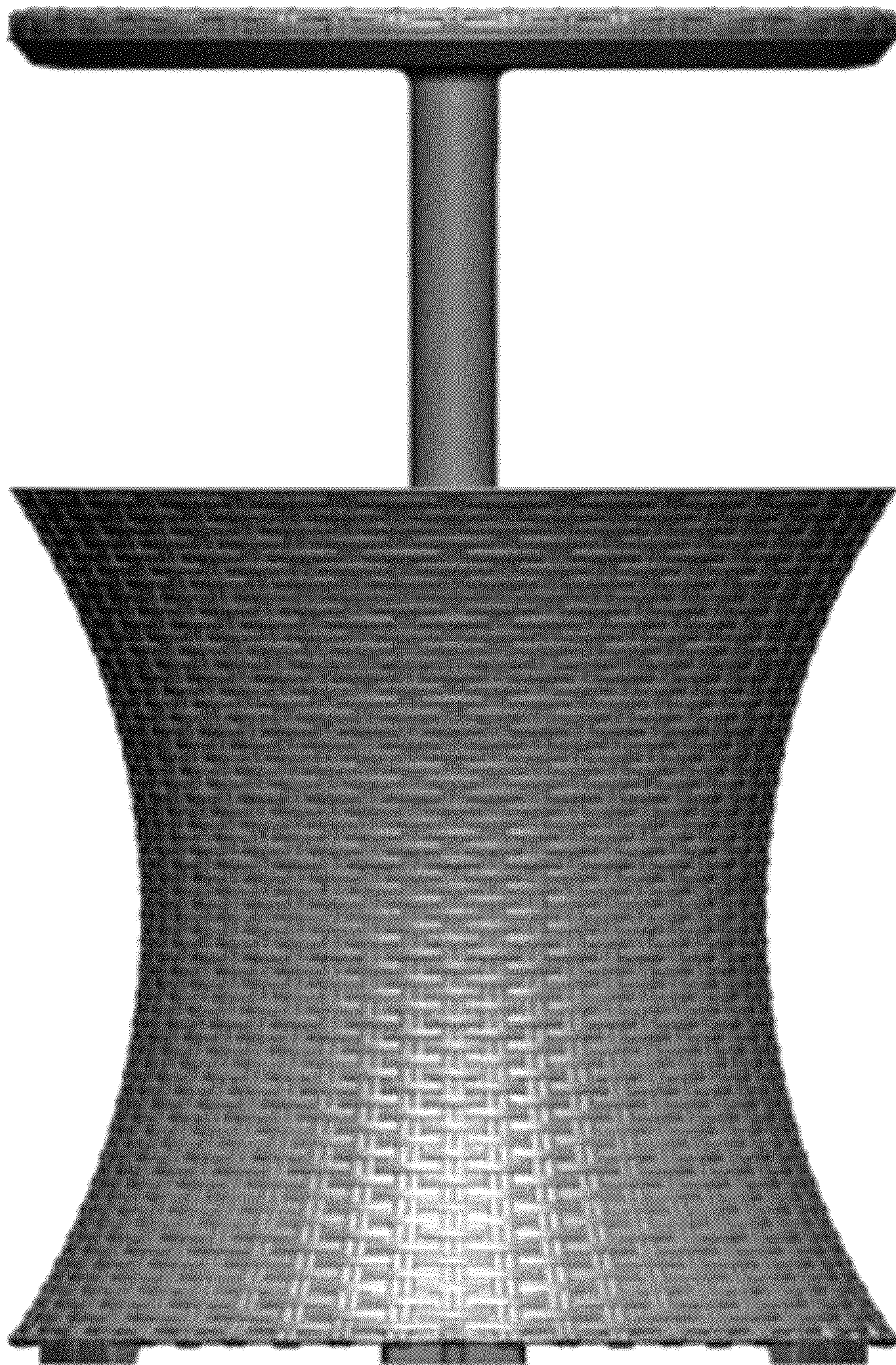

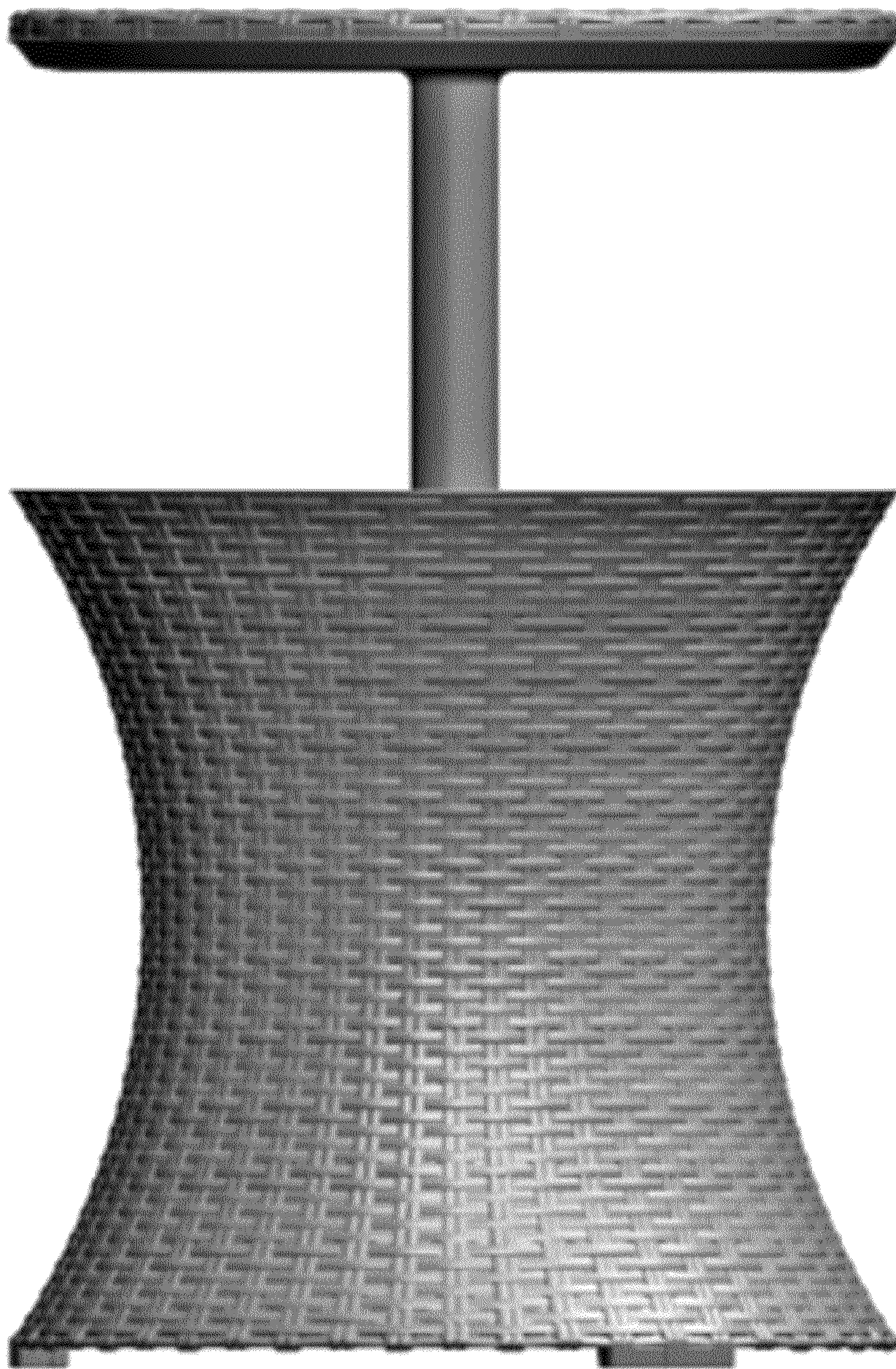

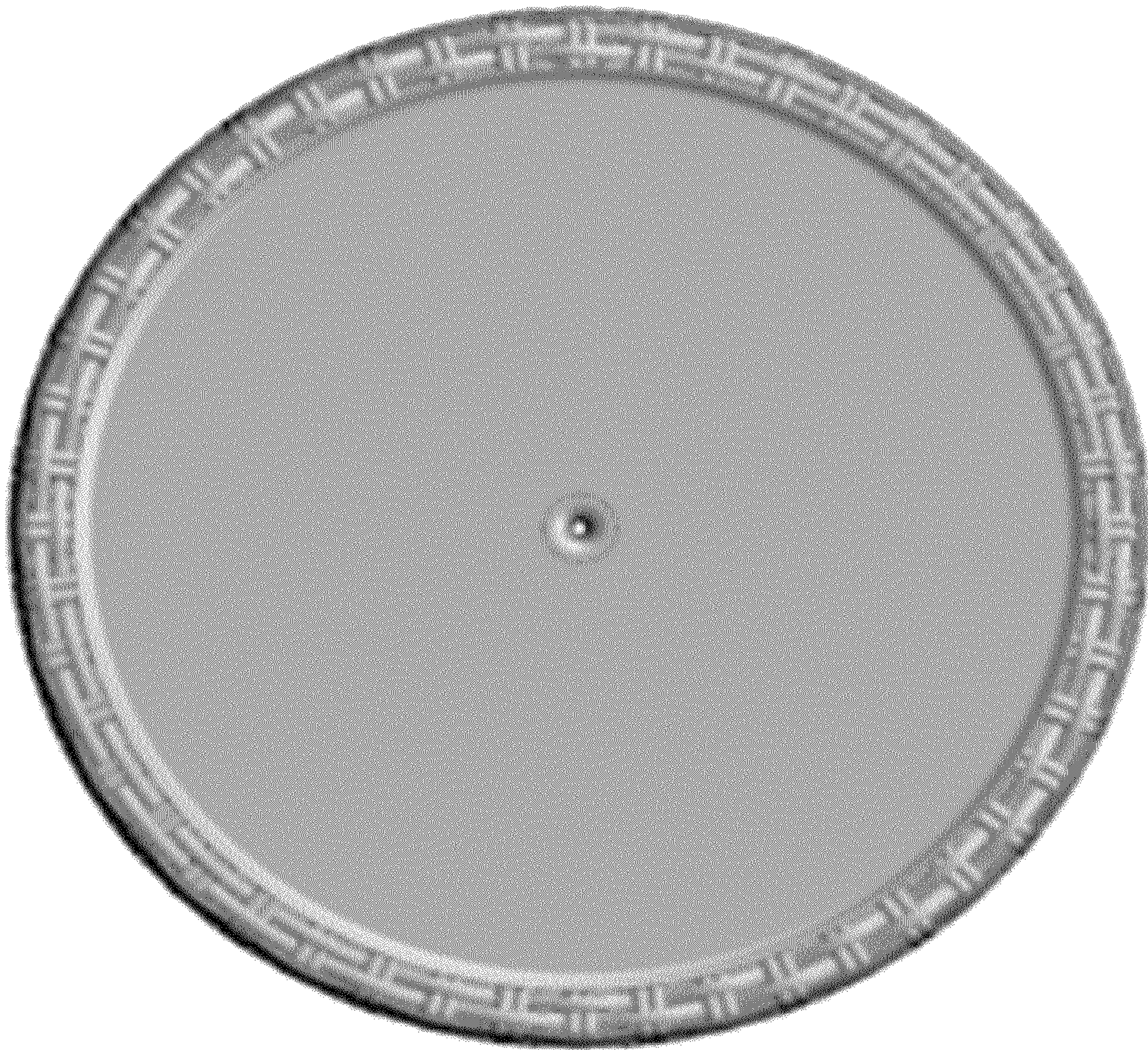

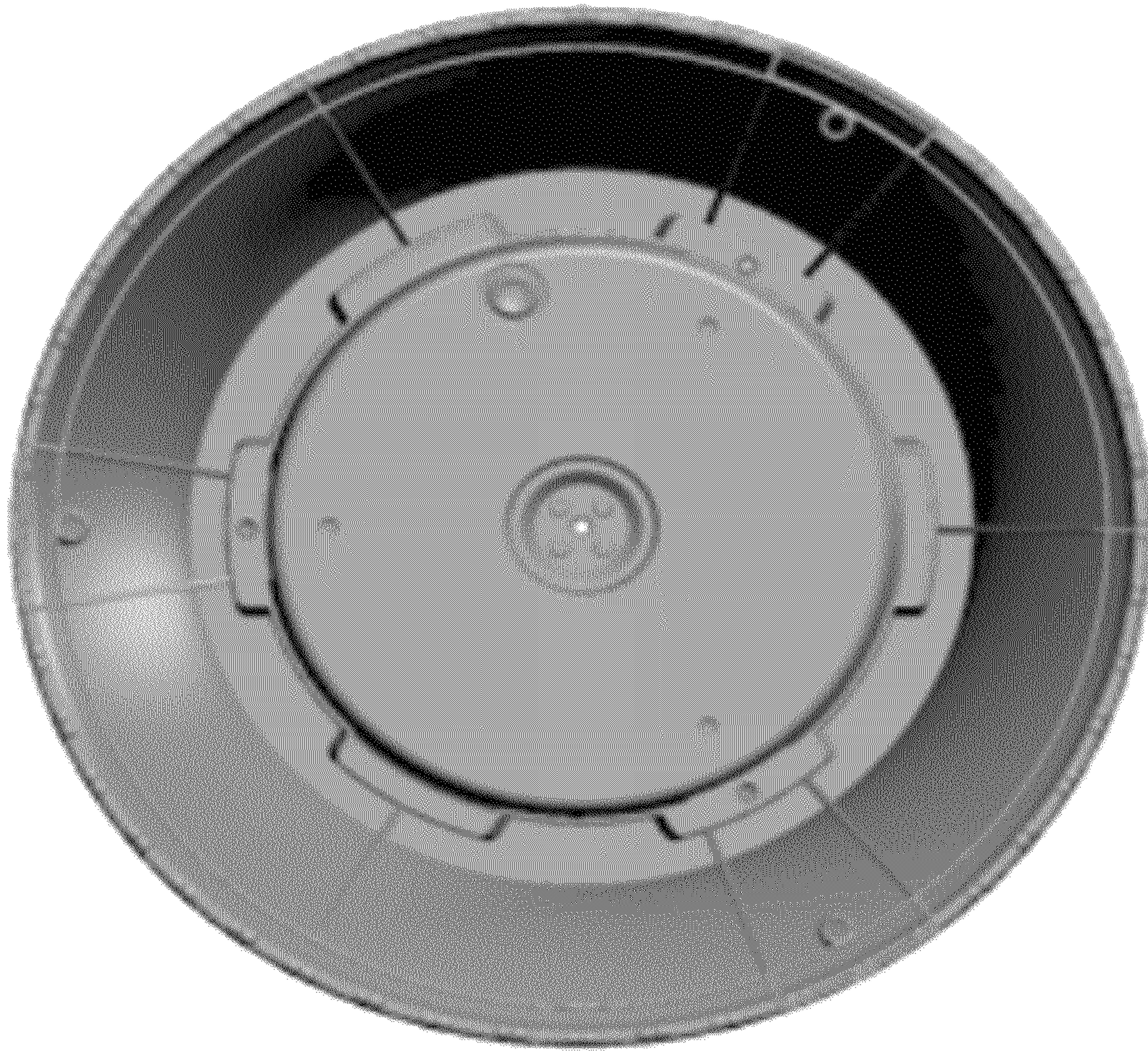
