(57) **CLAIM**

The ornamental design for a case for a recording media, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for a recording media showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof; and

FIG. 4 is a top plan view thereof;

FIG. 5 is an enlarged front elevational view thereof along the lines 5-5 and 5'-5' of FIG. 2;

FIG. 6 is an enlarged cross sectional view thereof along the line 6-6 of FIG. 5;

FIG. 7 is another enlarged cross sectional view thereof along the line 7-7 of FIG. 5; and,

FIG. 8 is still another enlarged cross sectional view thereof along the line 8-8 of FIG. 5.

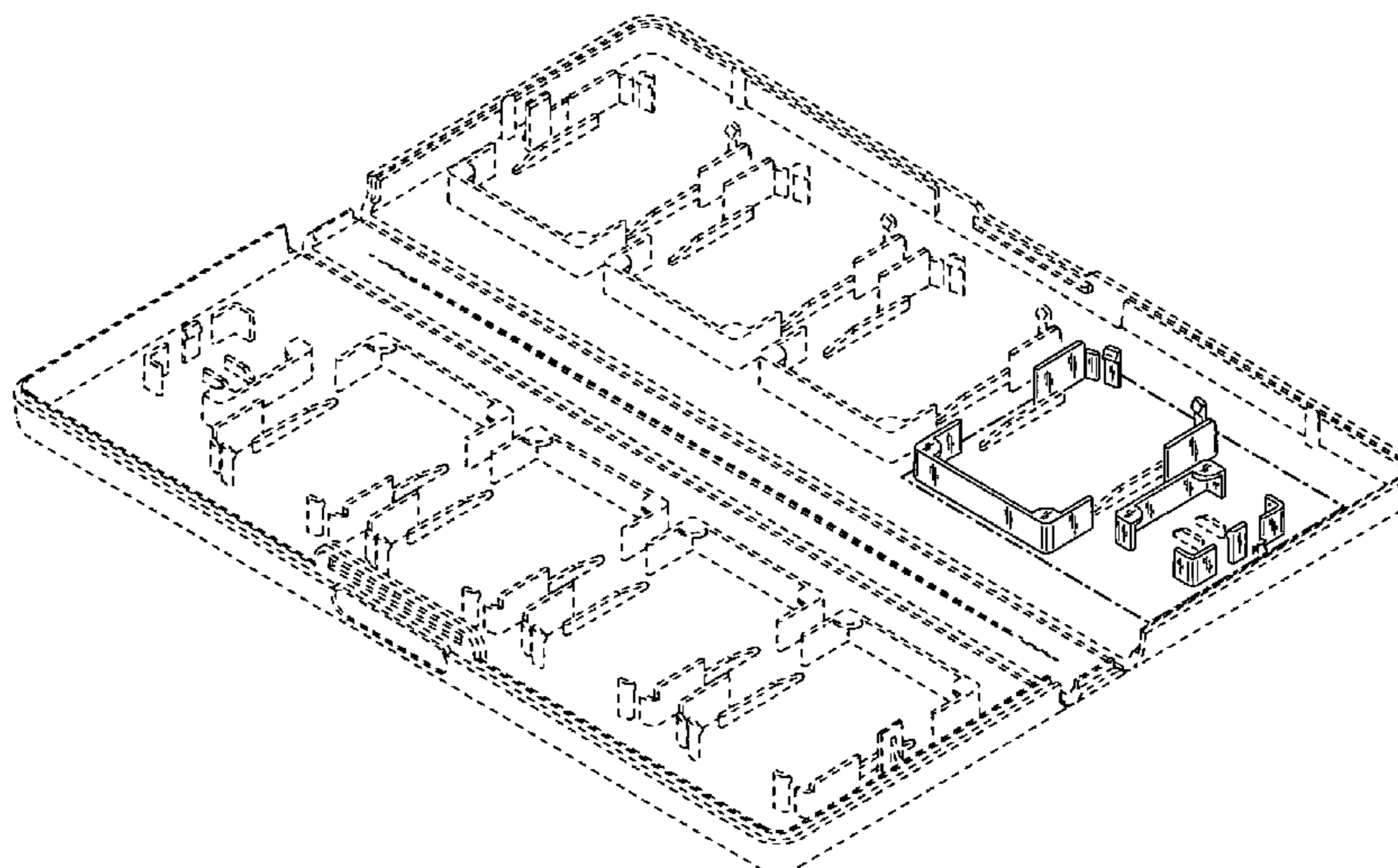

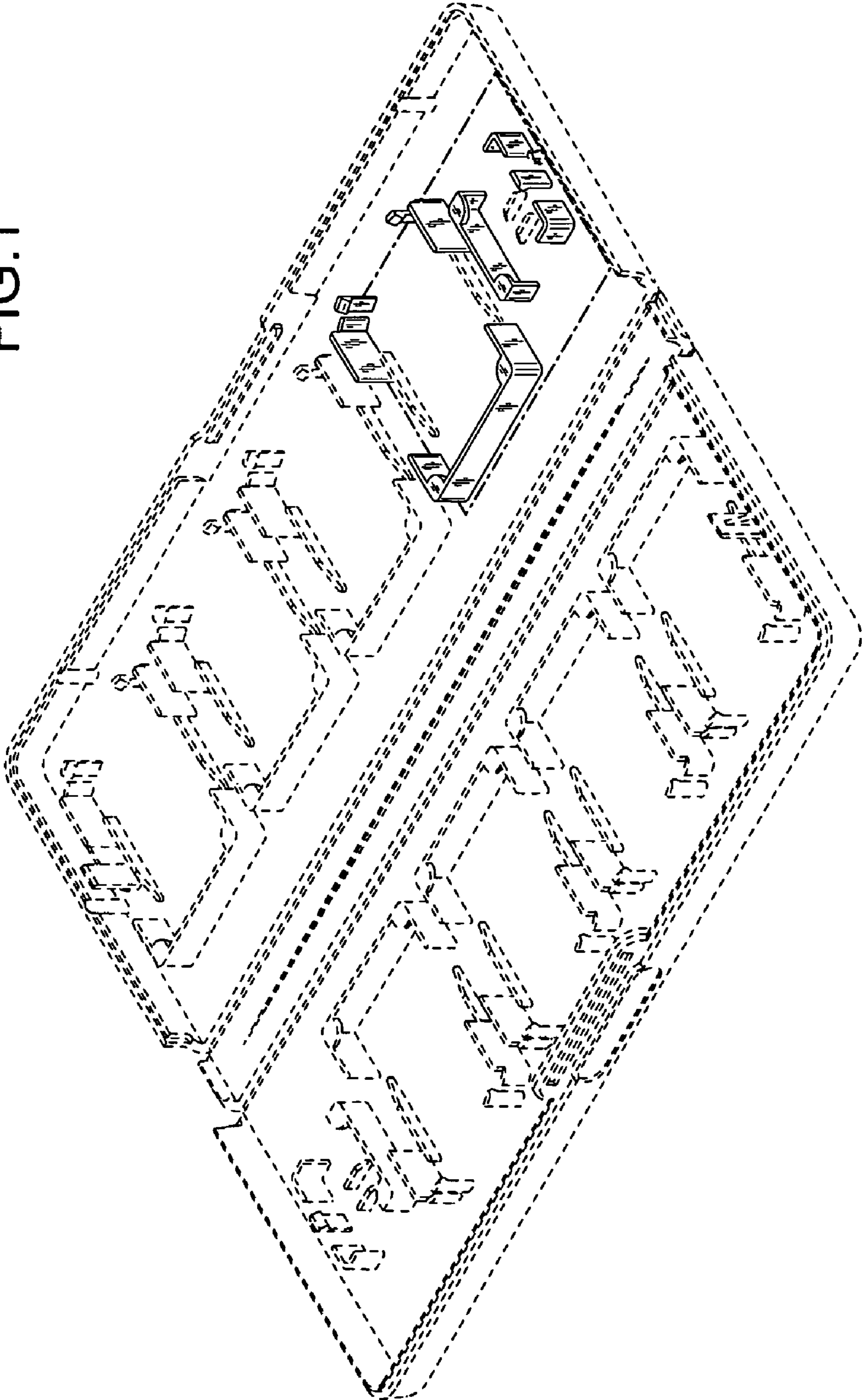

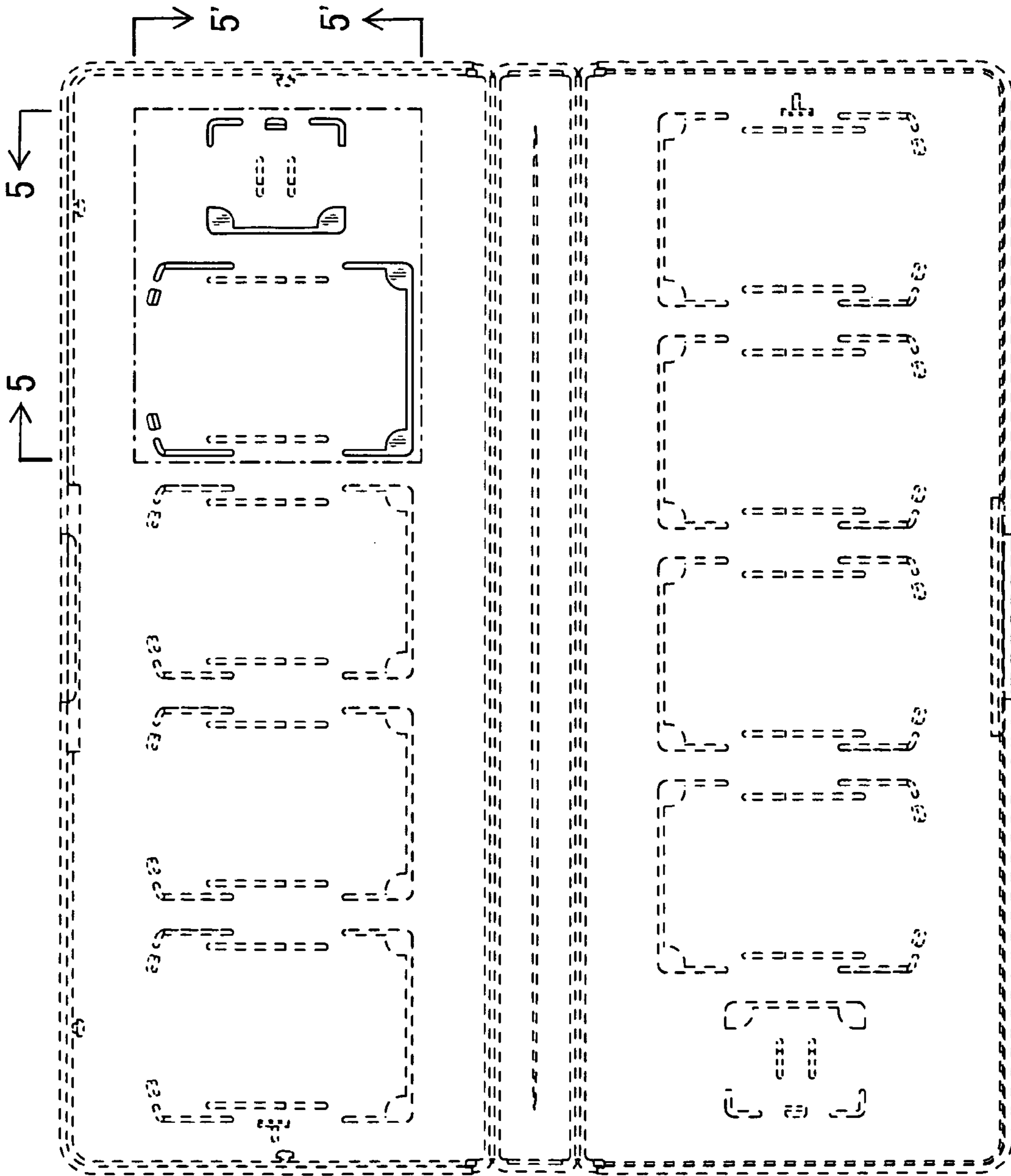

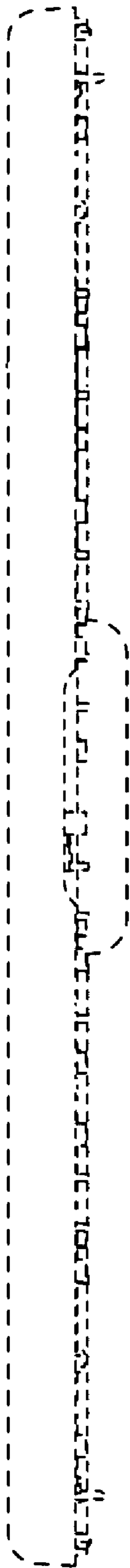

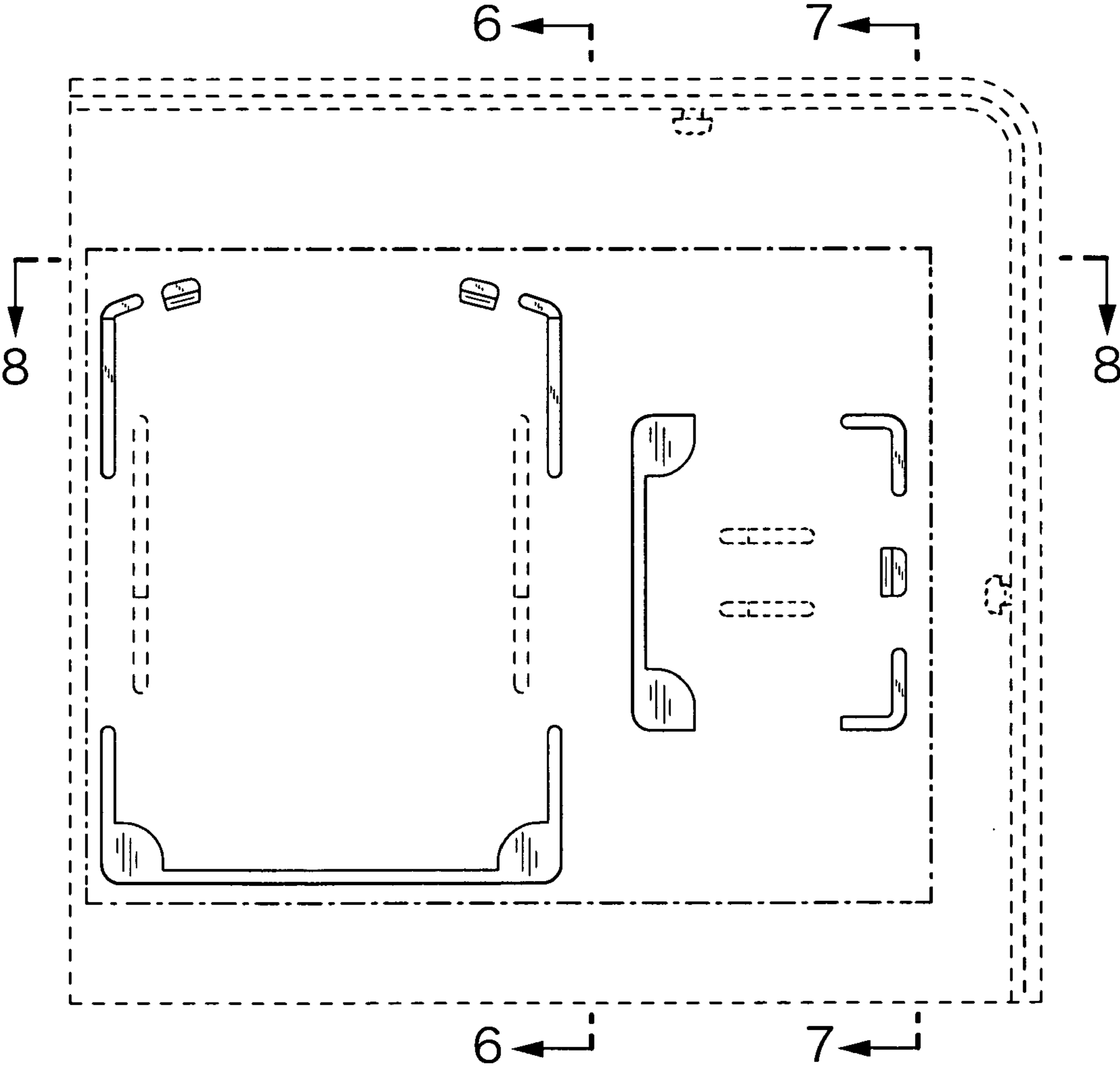

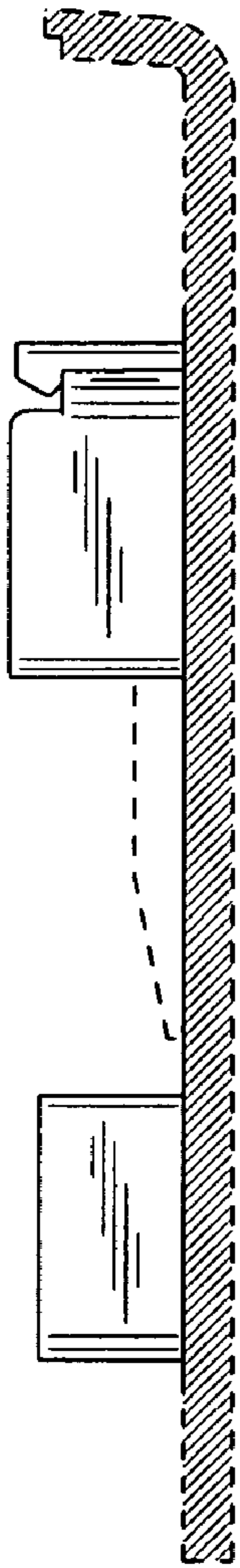

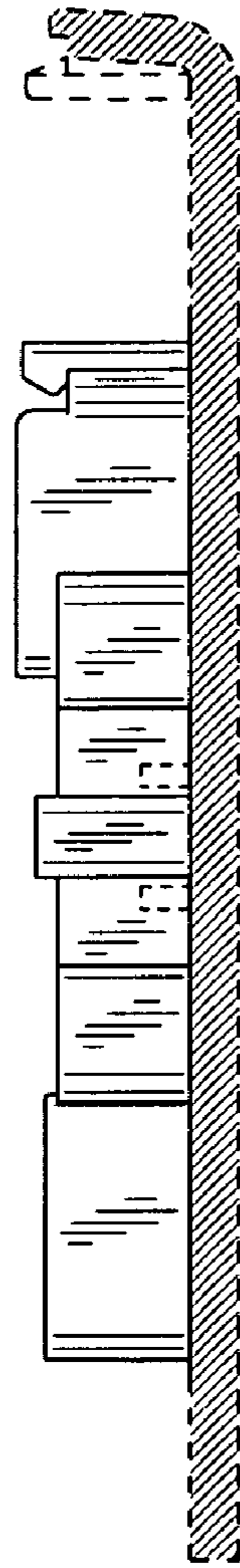
