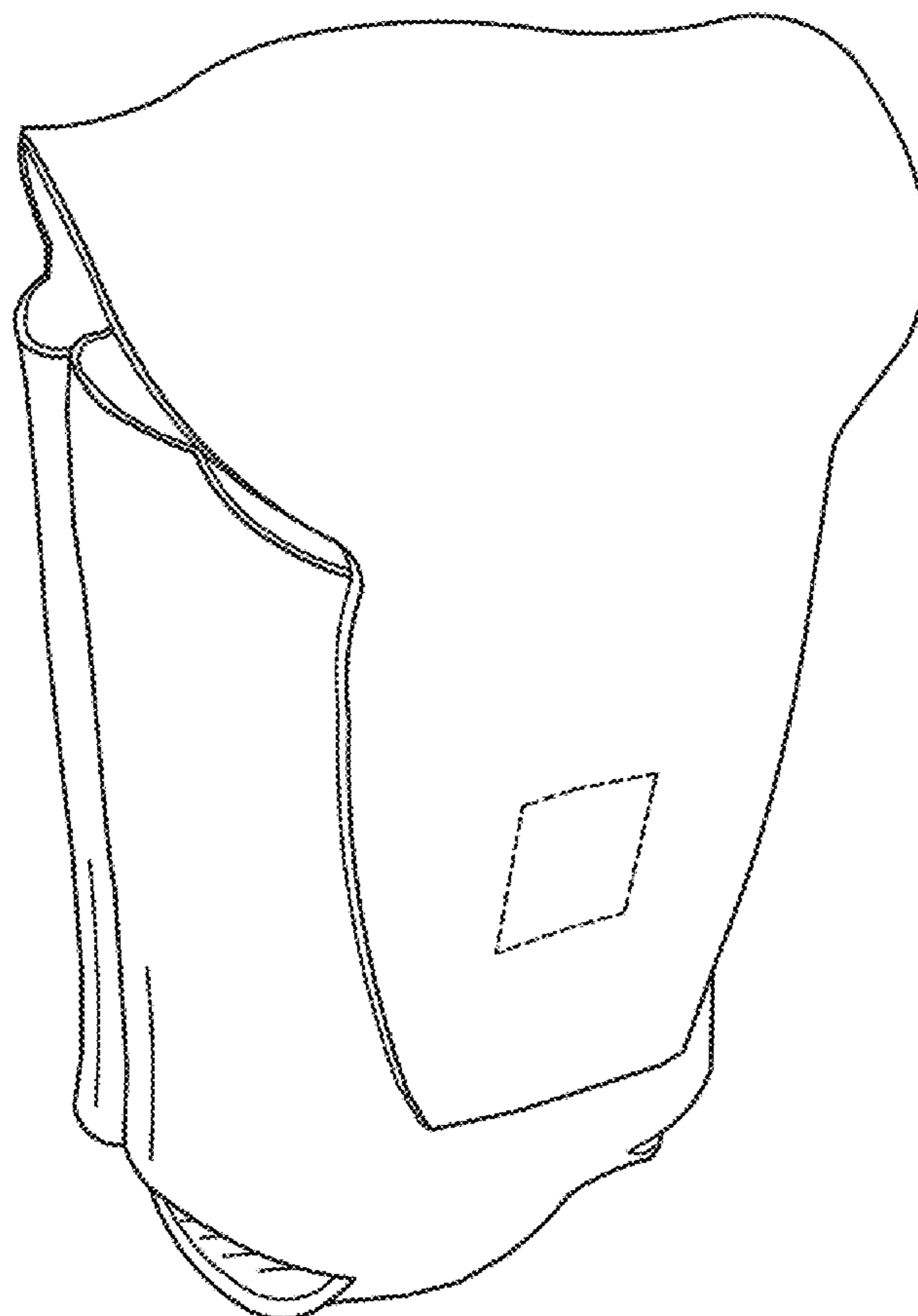
(57) **CLAIM**

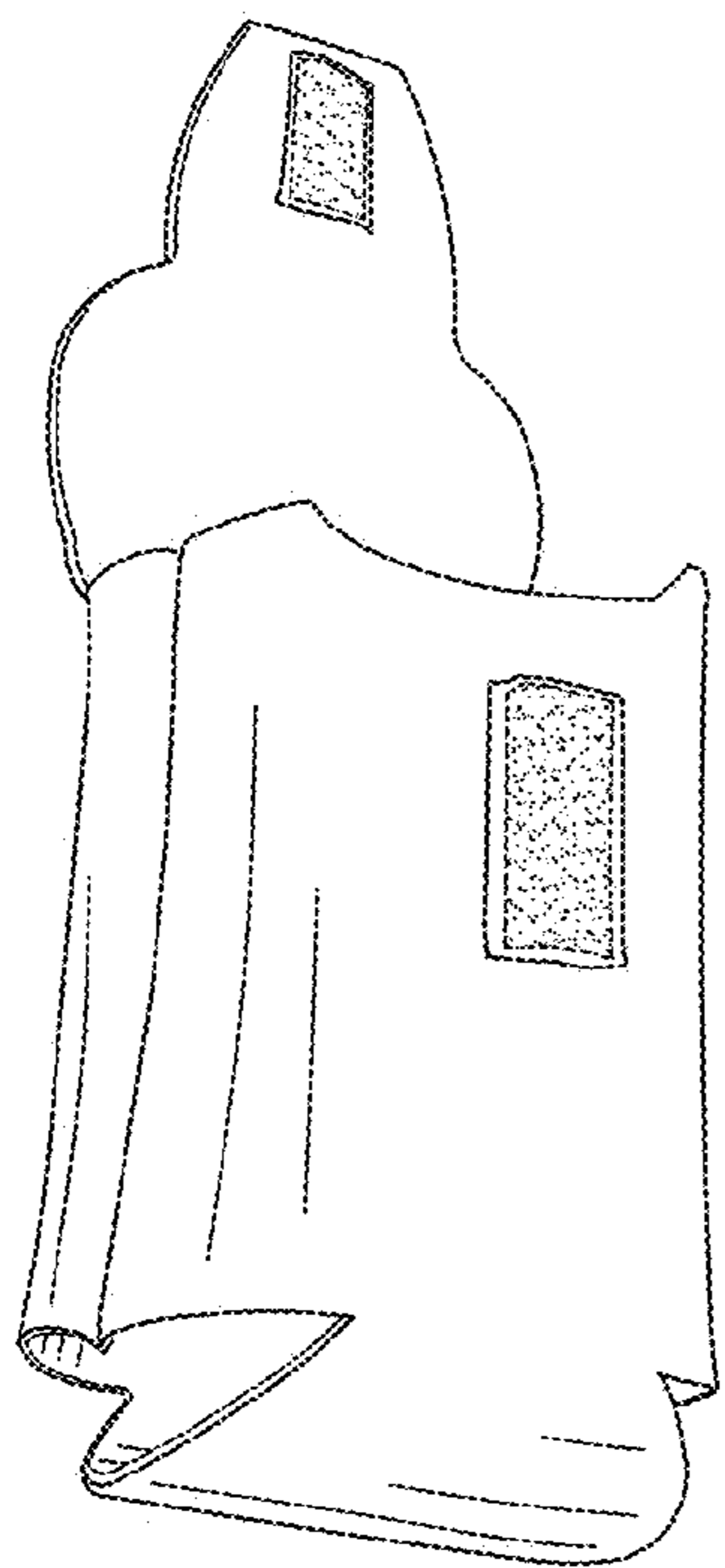
I claim the ornamental design for an insulated beverage container holder, as shown and described.

**DESCRIPTION**

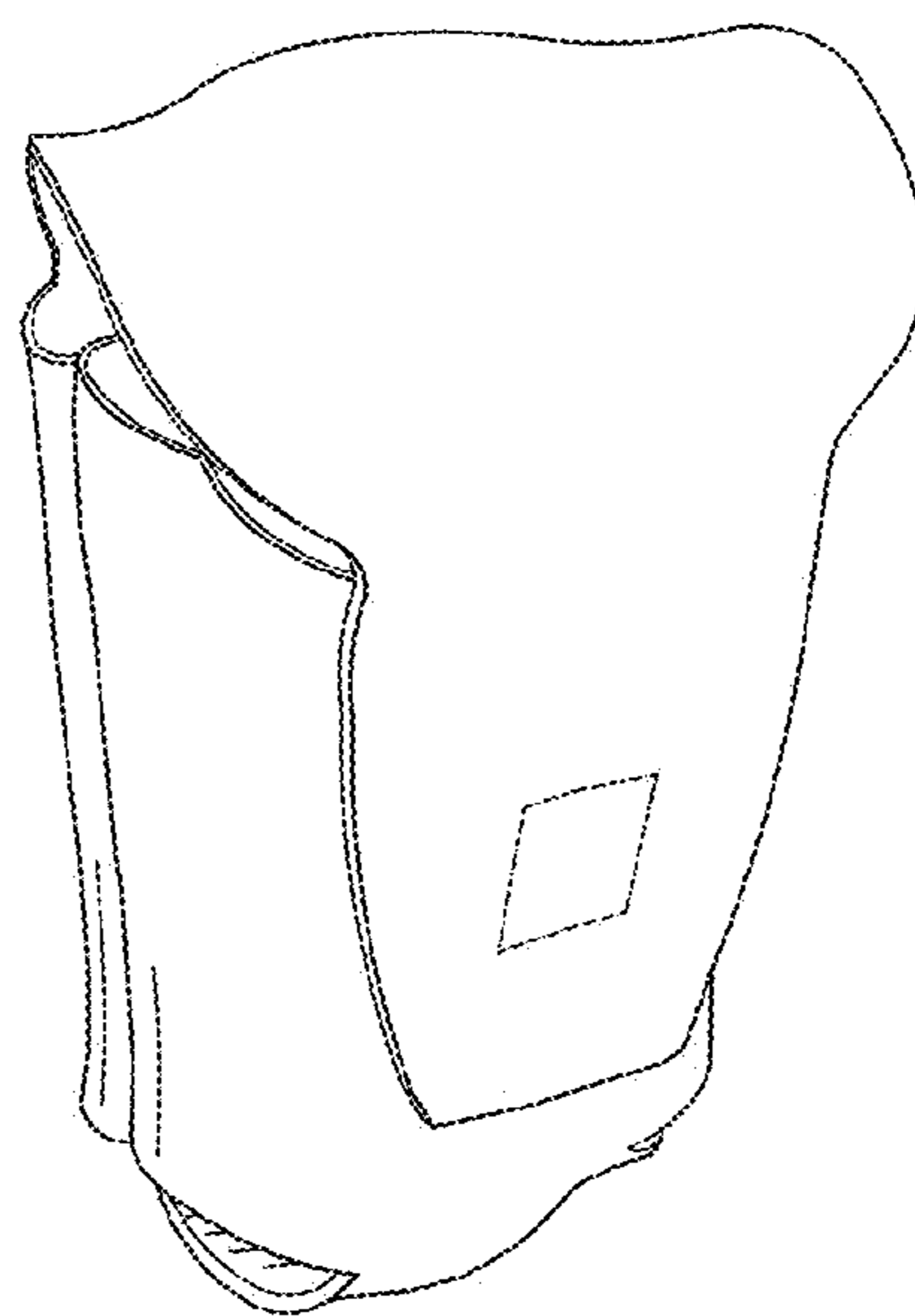

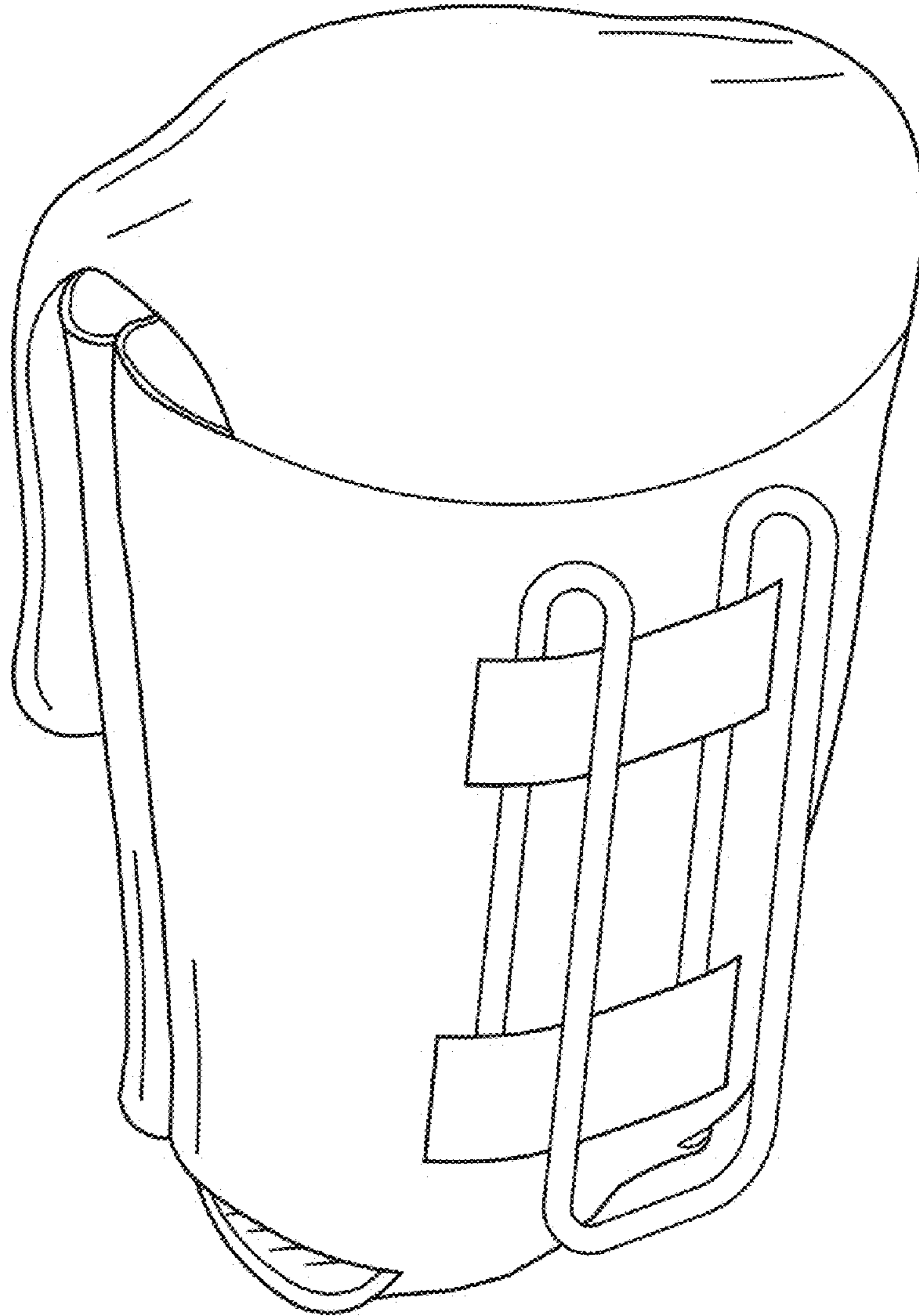
