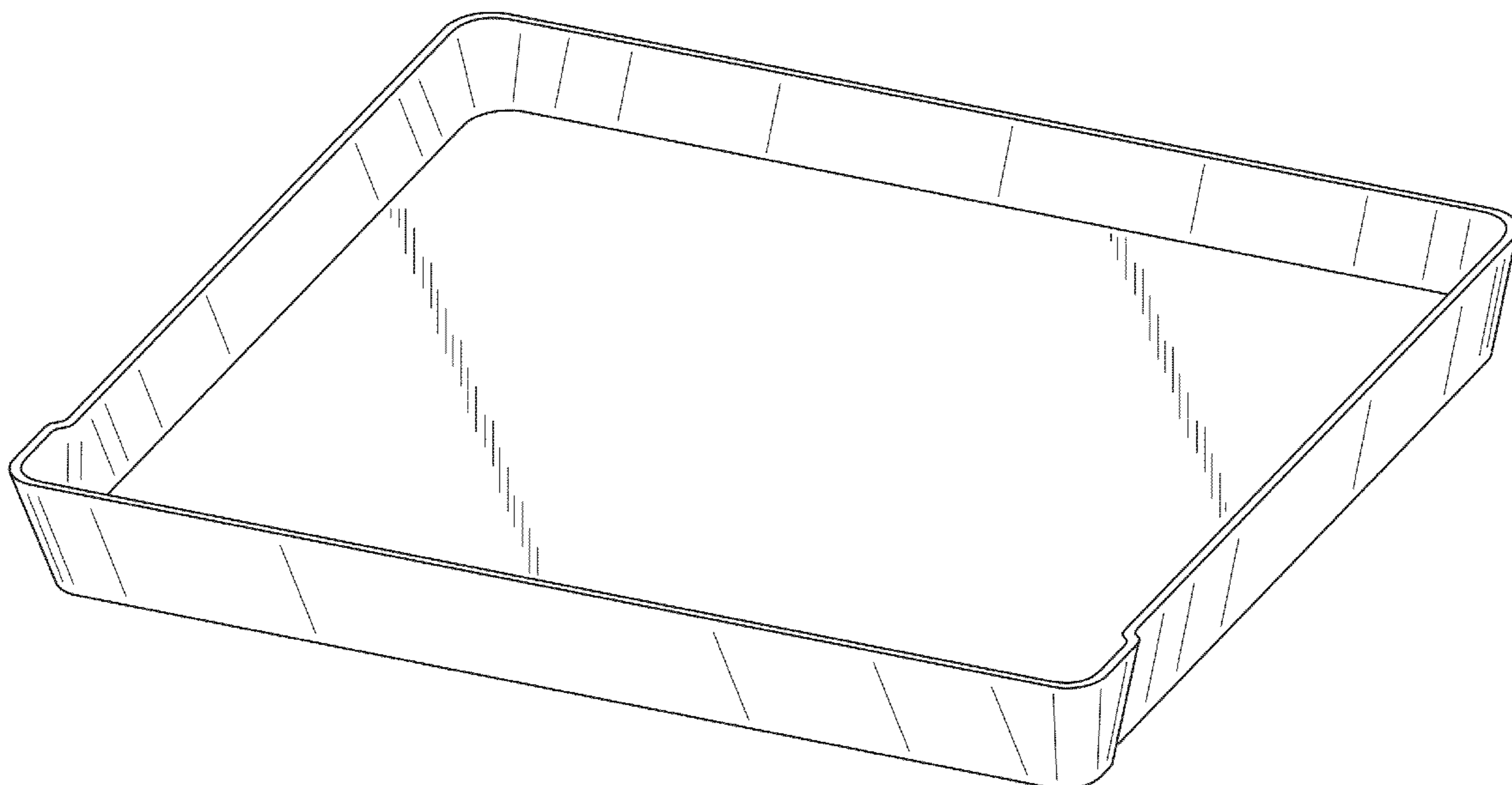
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top perspective view of a tray showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, the left side view being a mirror image of the right side view;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

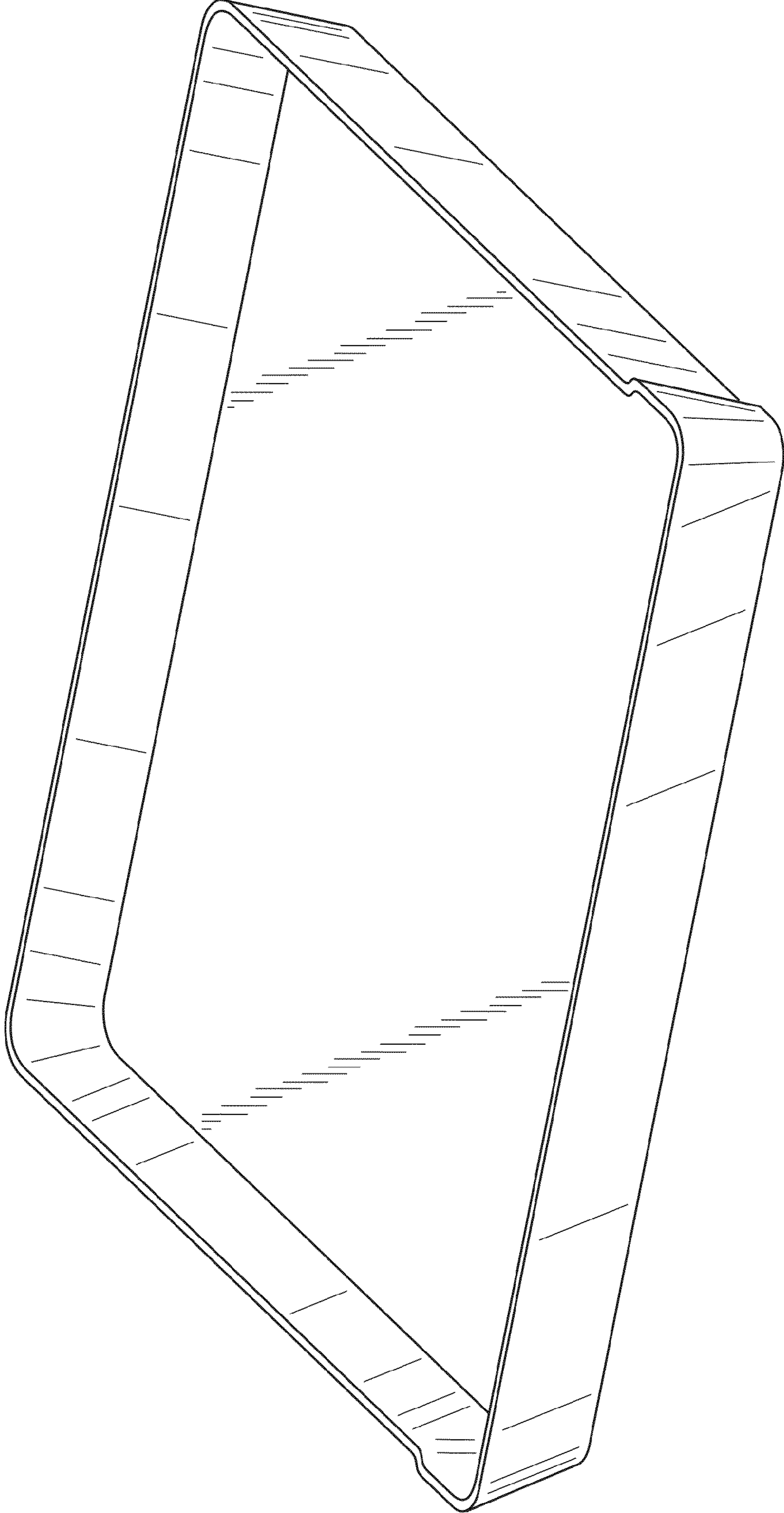

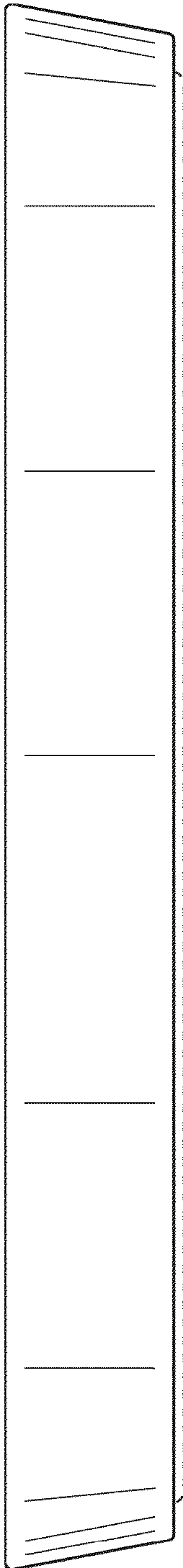

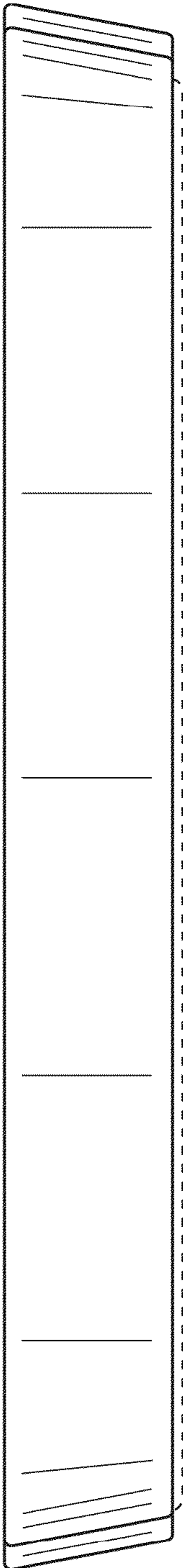

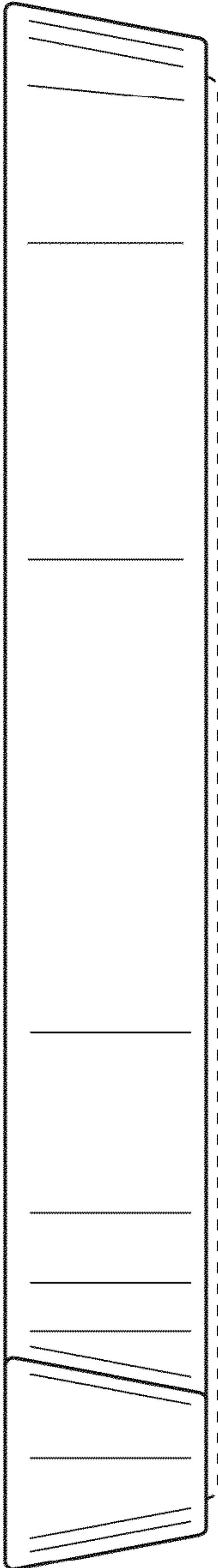

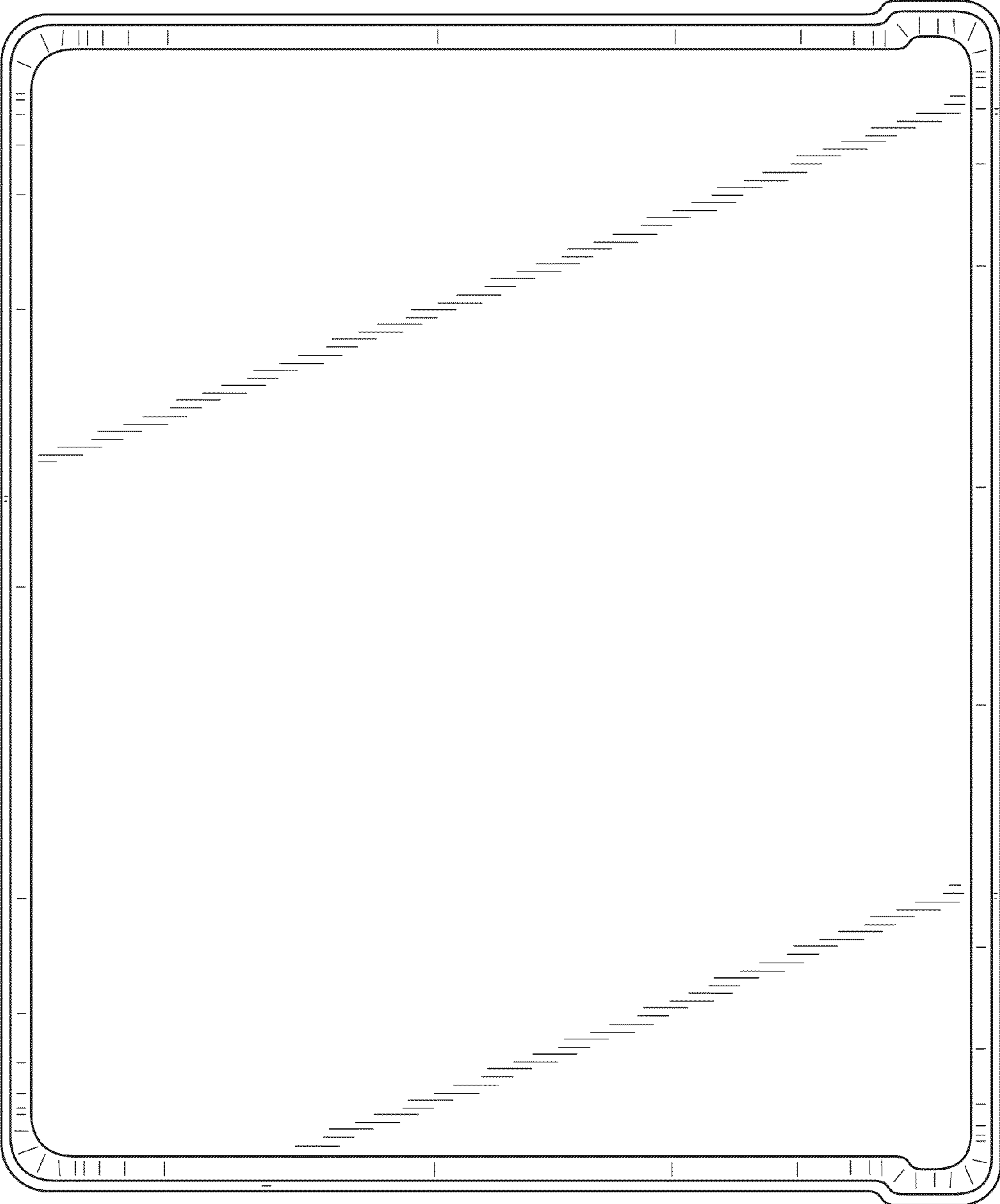

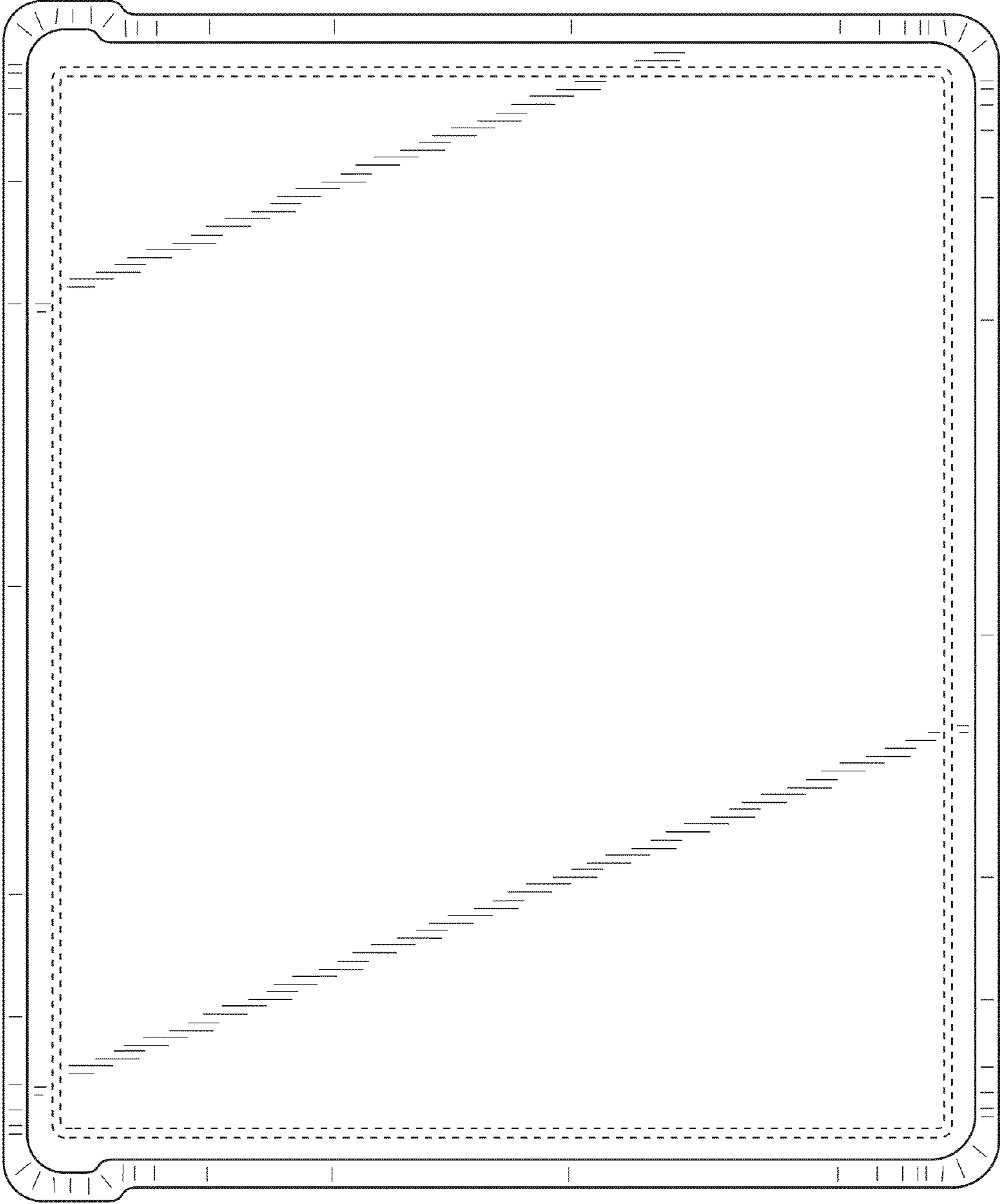
