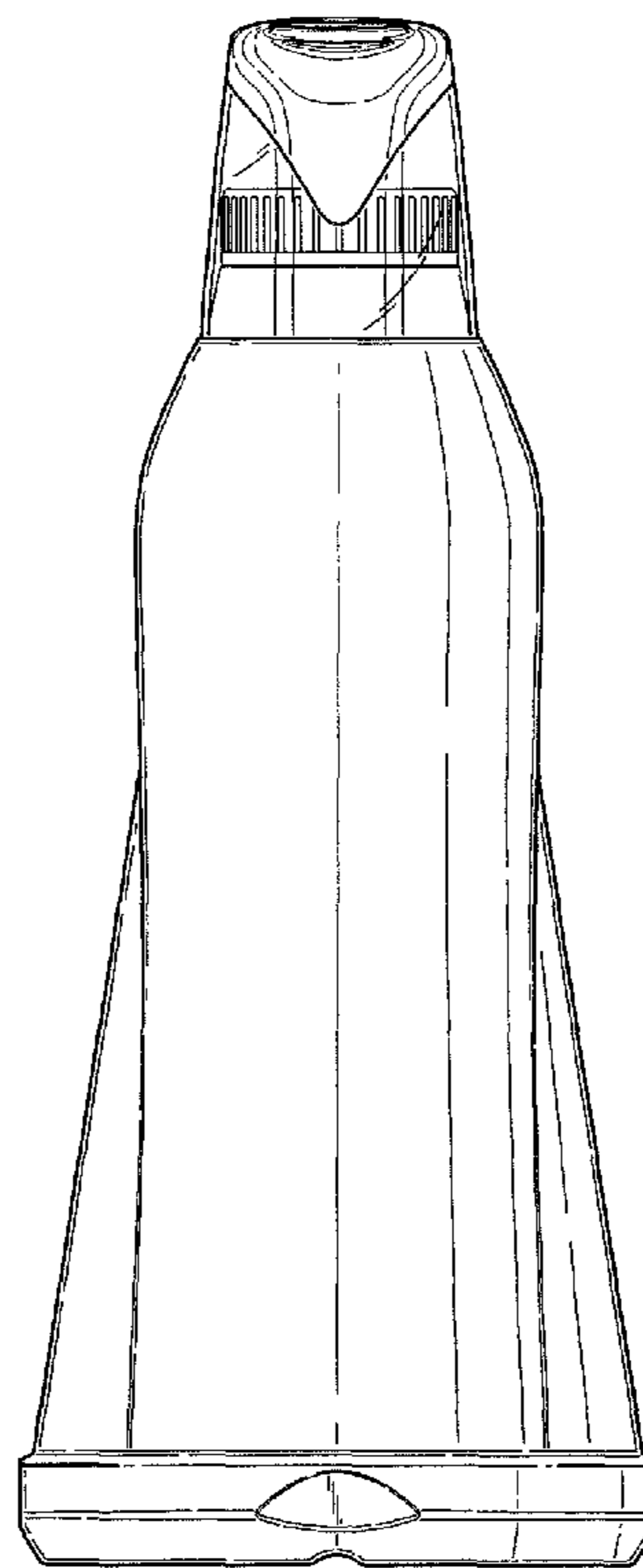
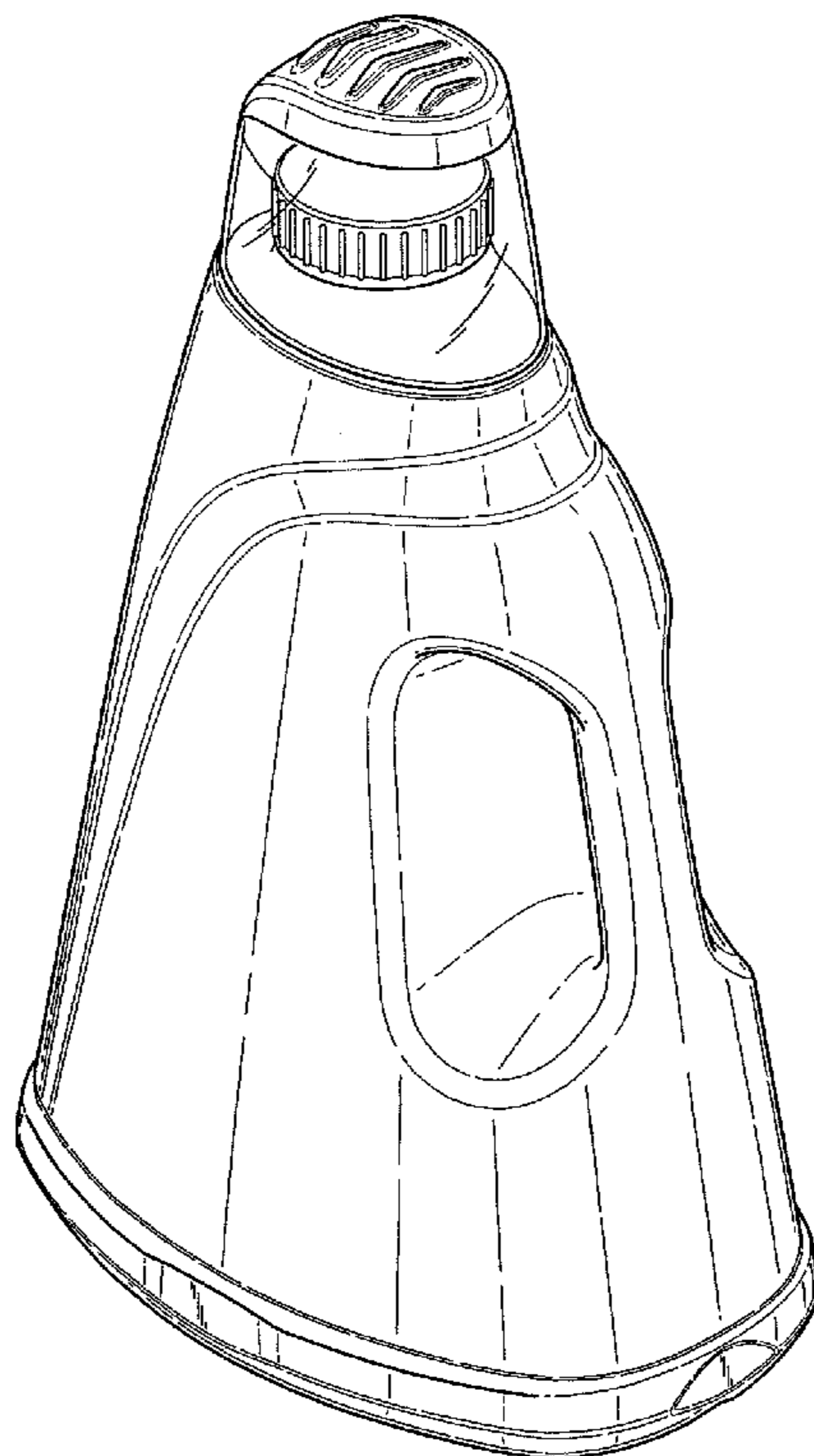
The ornamental design for a bottle with handle, screw top and transparent cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our bottle with handle, screw top and transparent cap;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a back elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

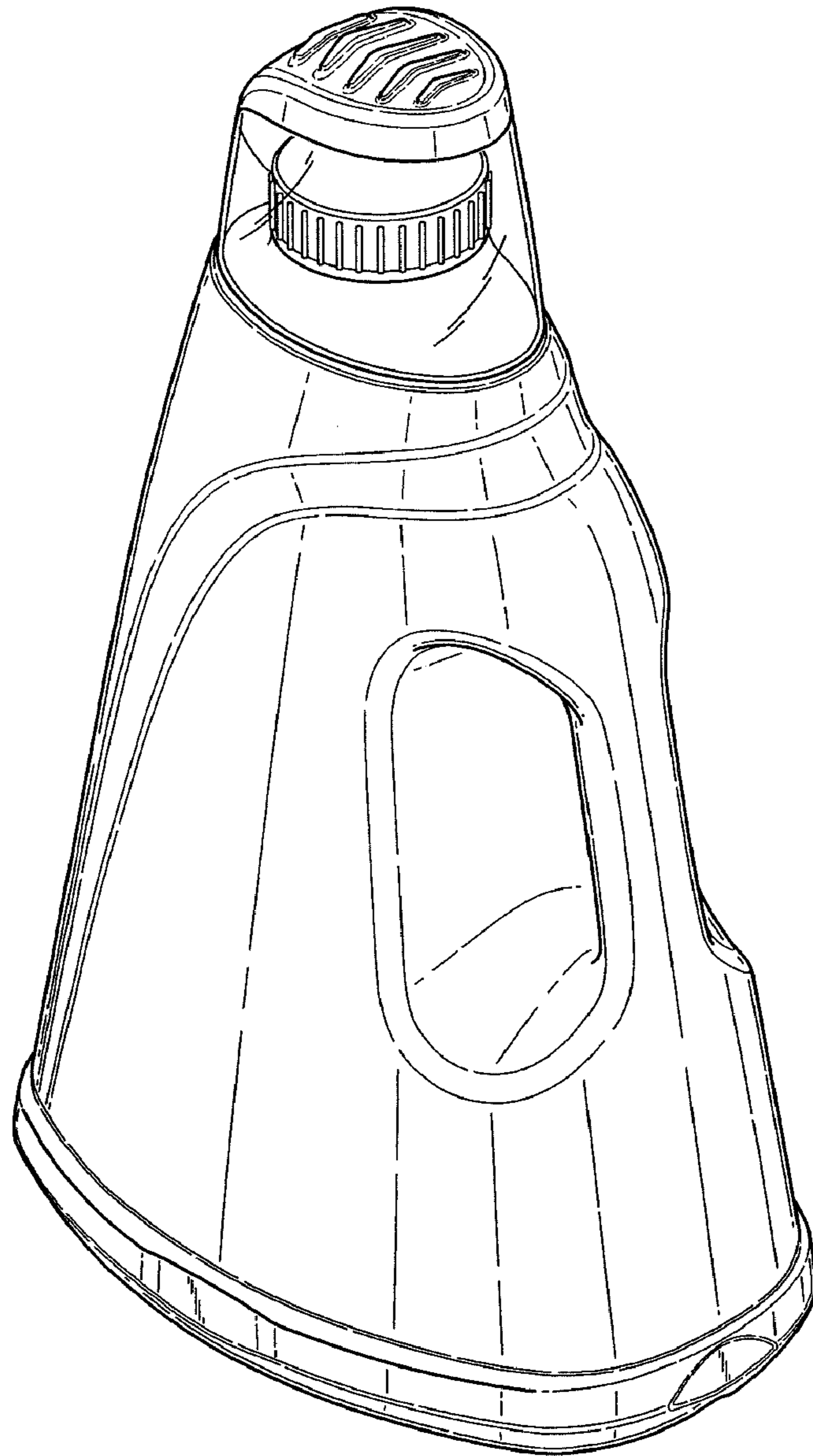

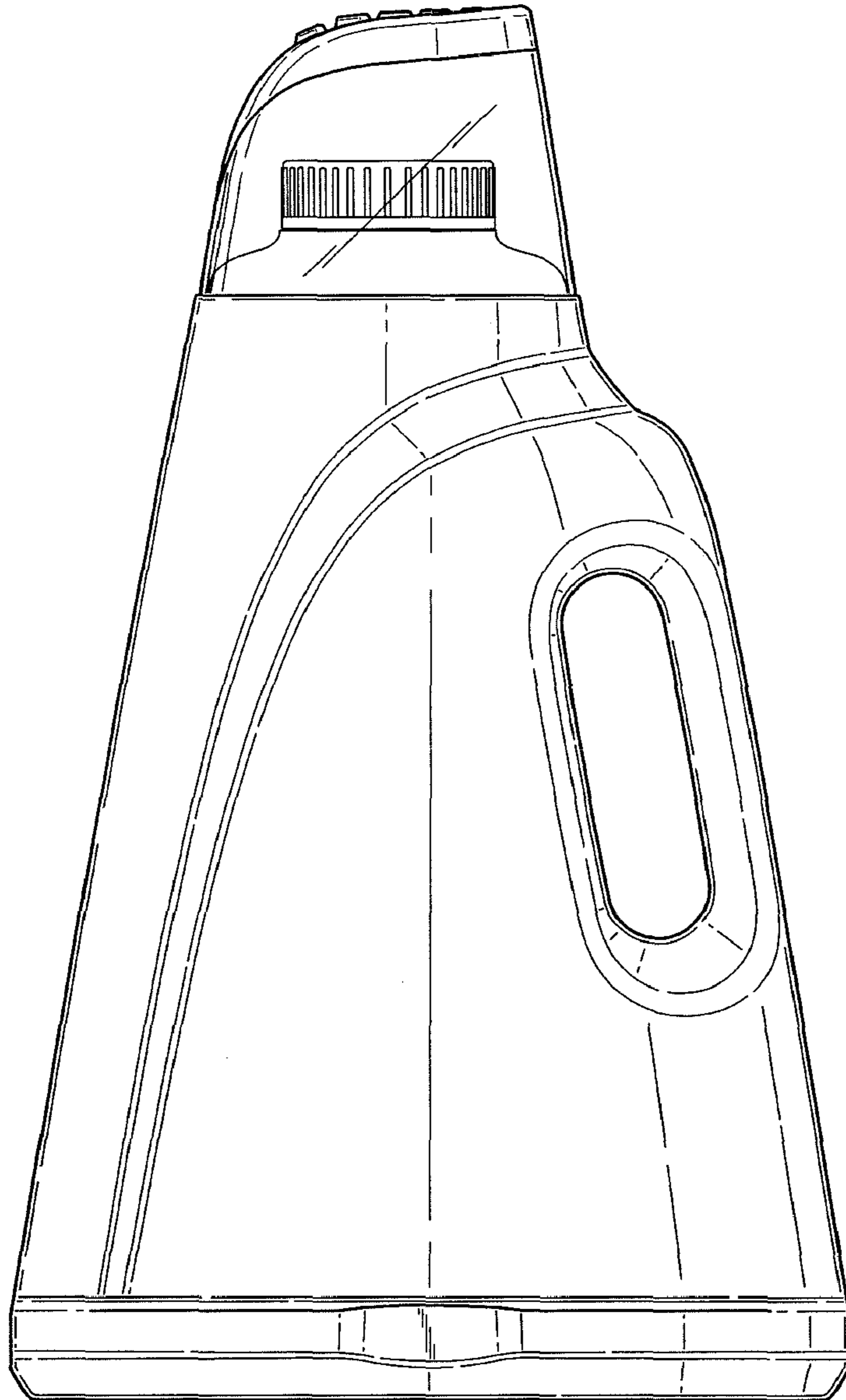

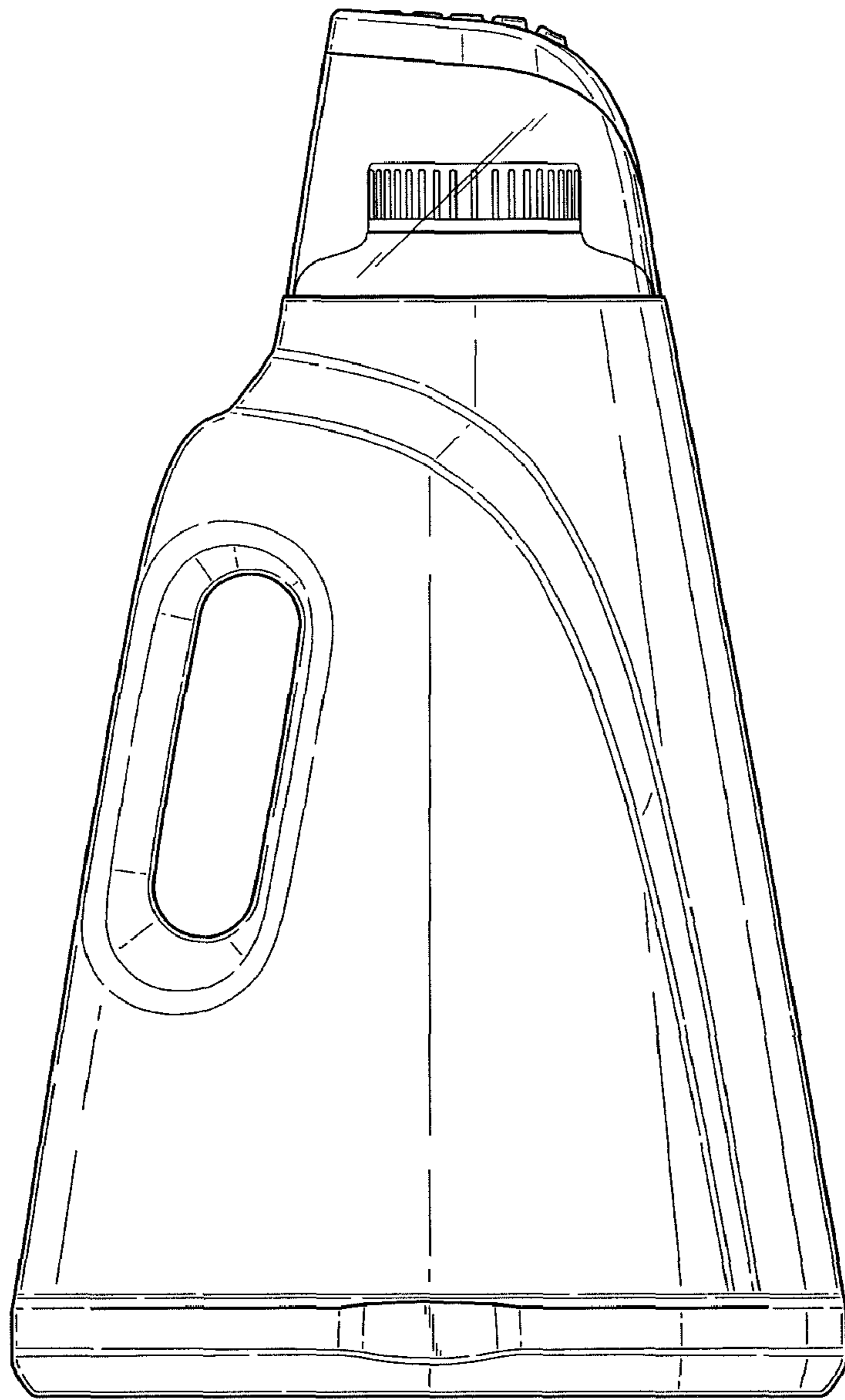

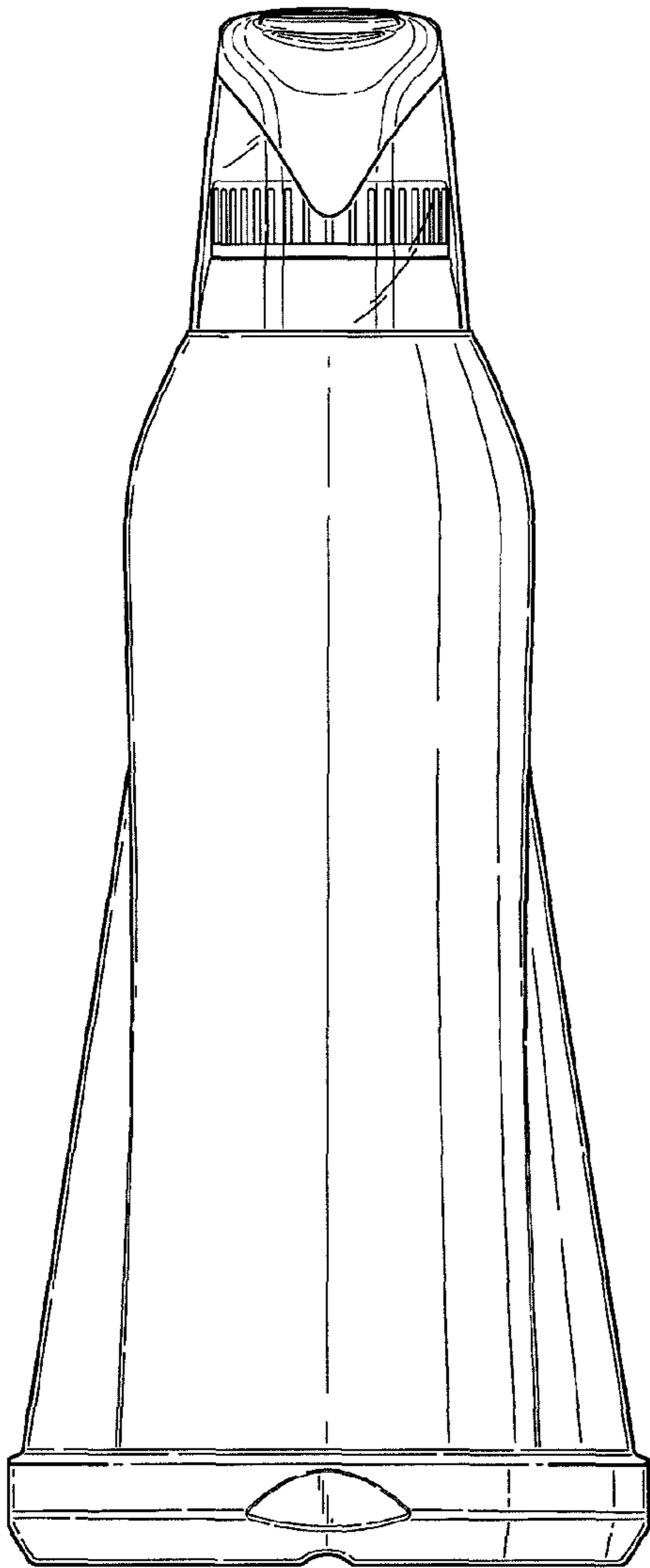

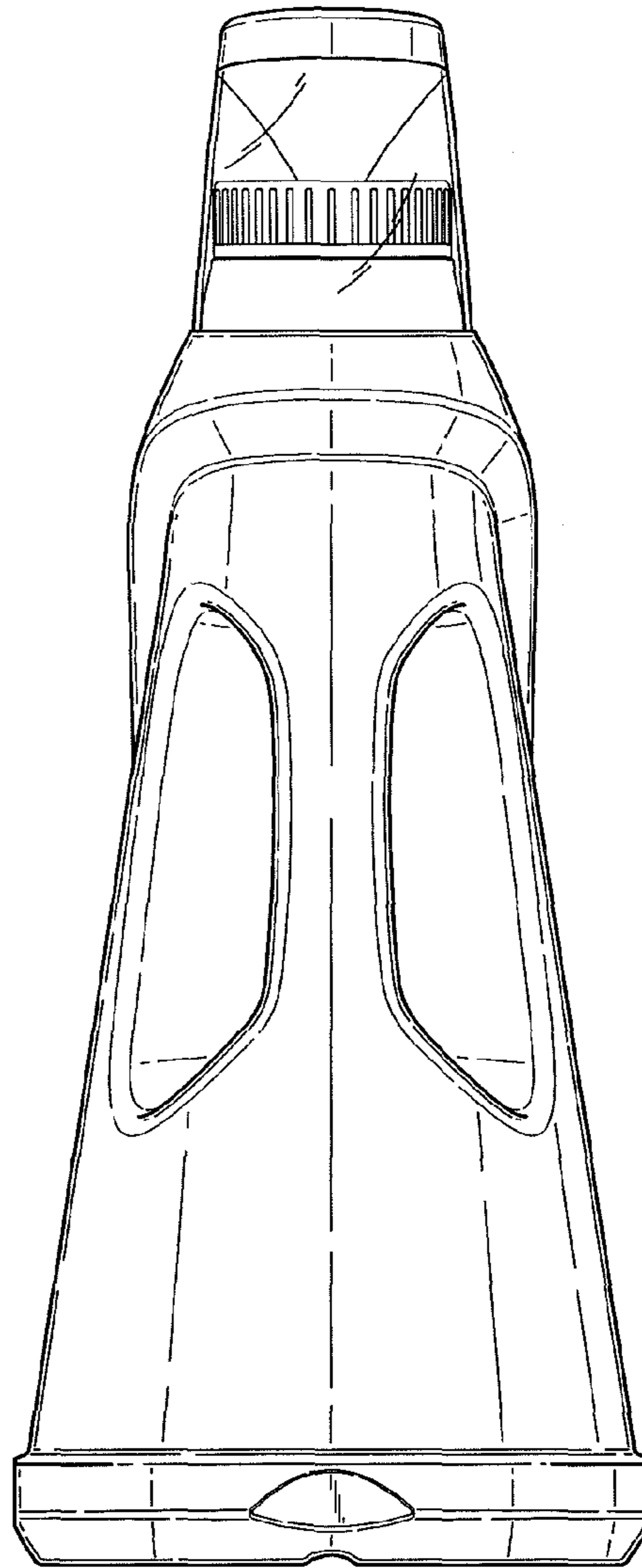

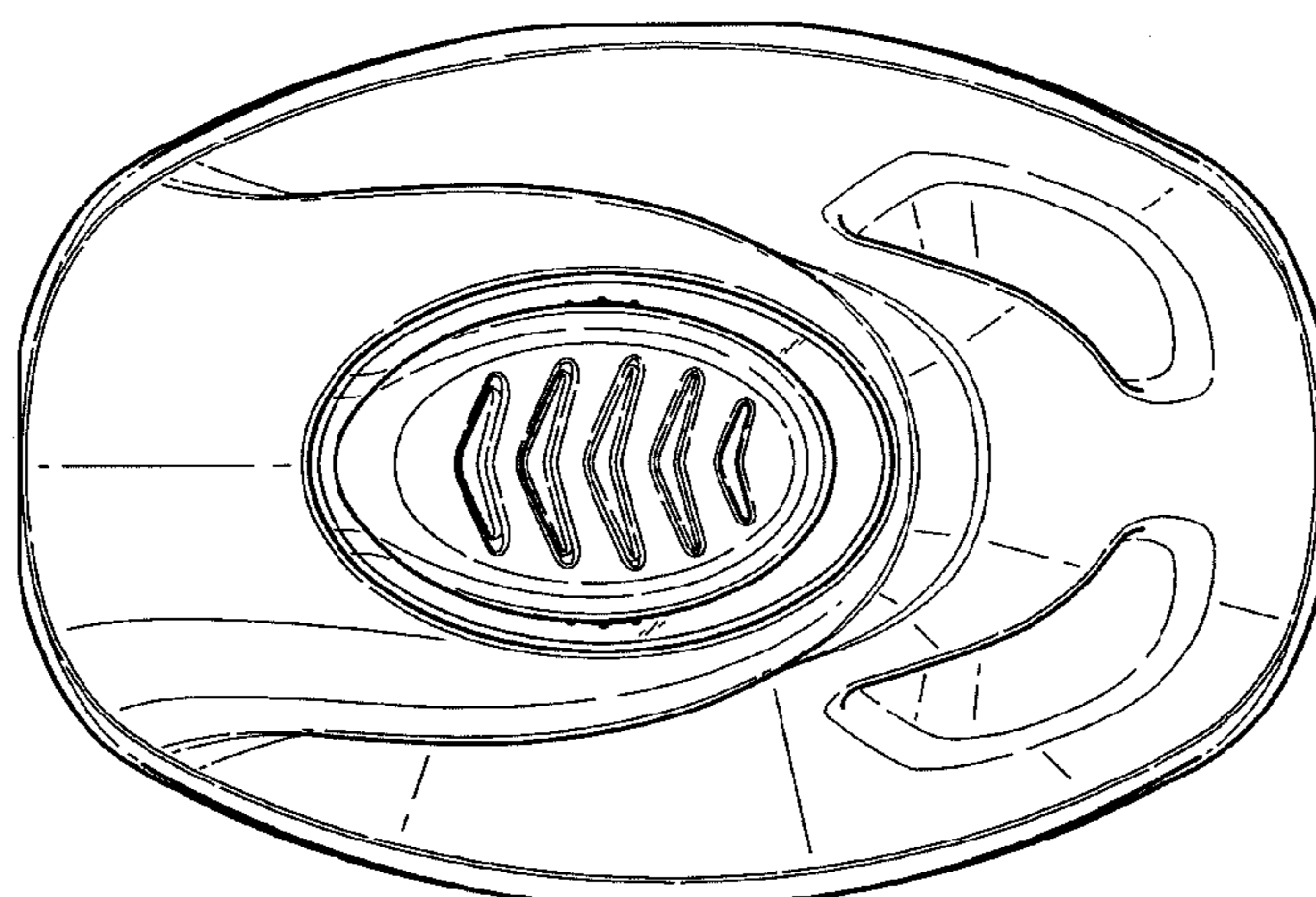

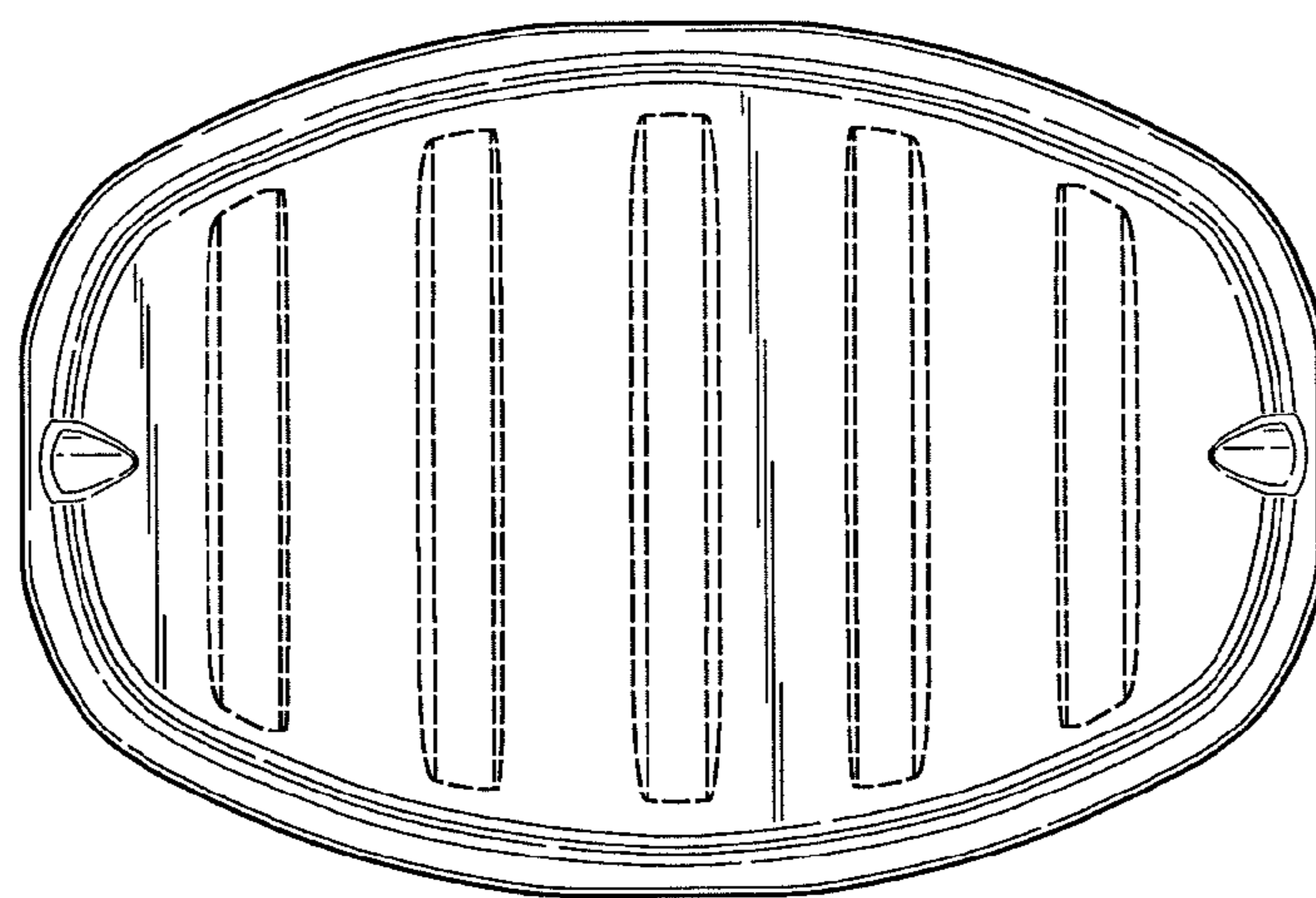
