DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of the dual marking gauge of this invention.

FIG. 2 is a bottom plan view of the design for the dual marking gauge shown in FIG. 1.

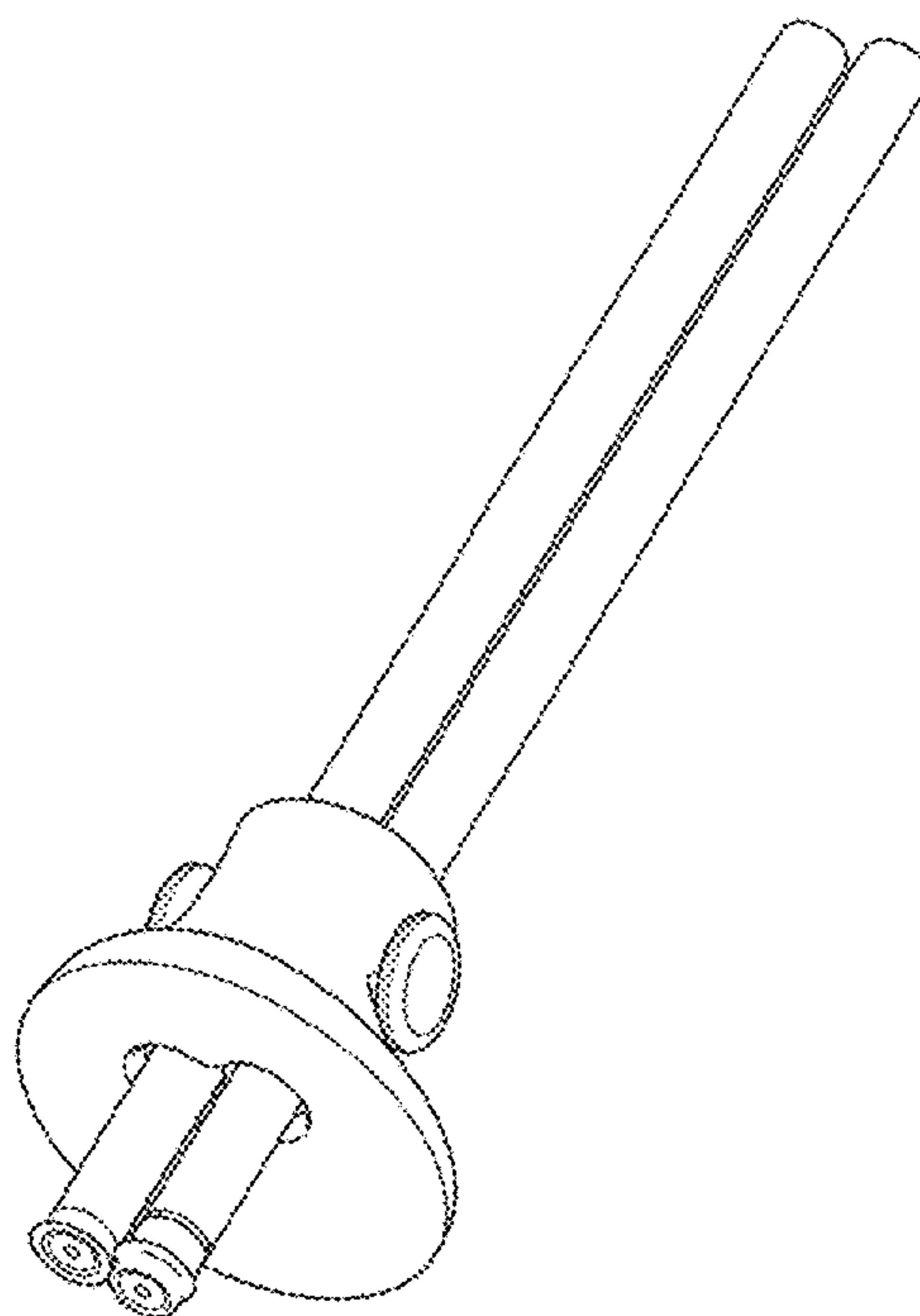
FIG. 3 is a right side view of the design for the dual marking gauge shown in FIG. 1.

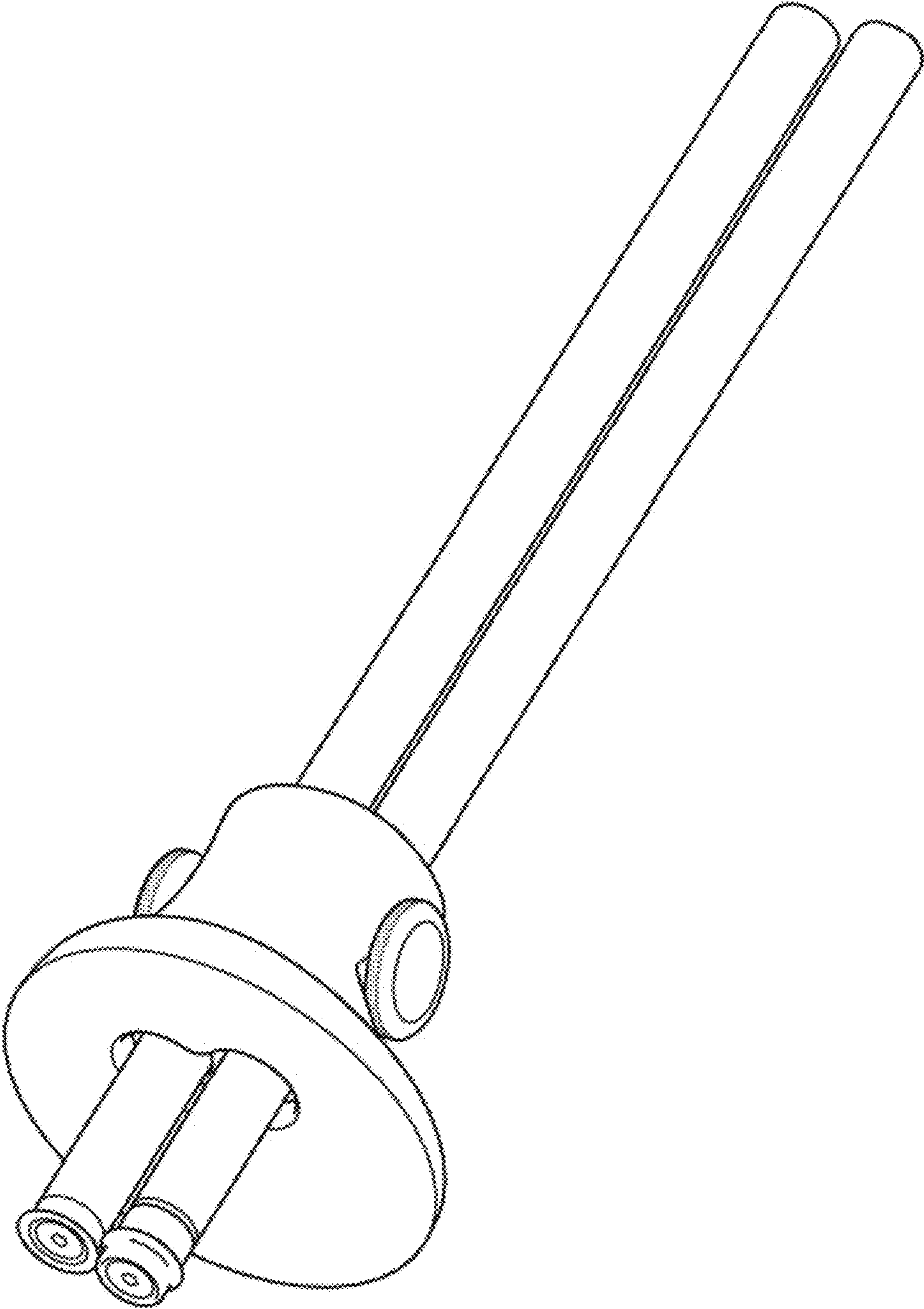

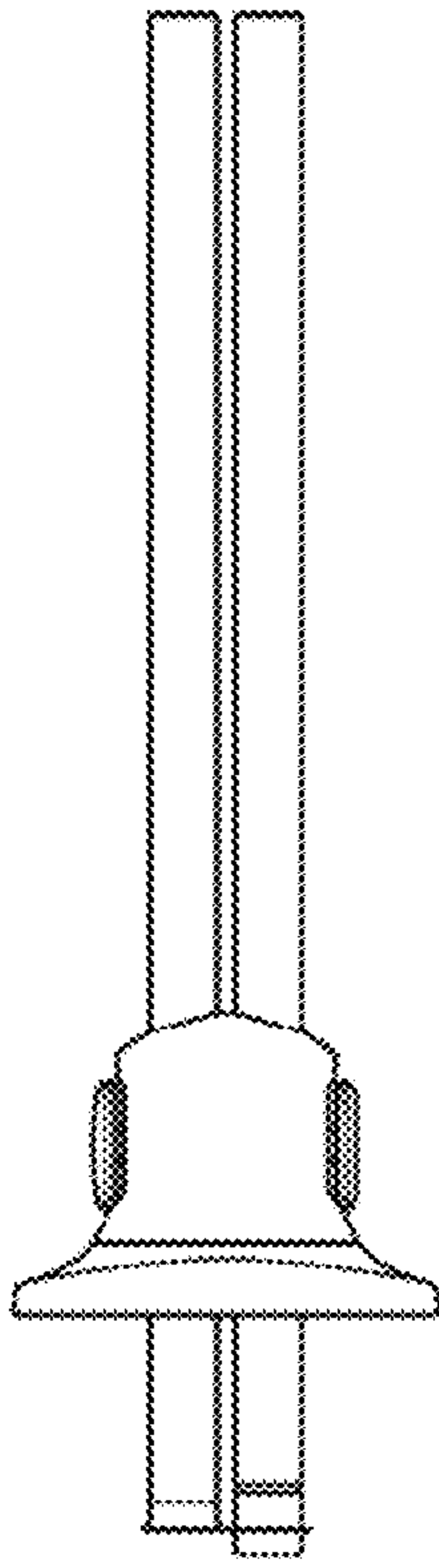

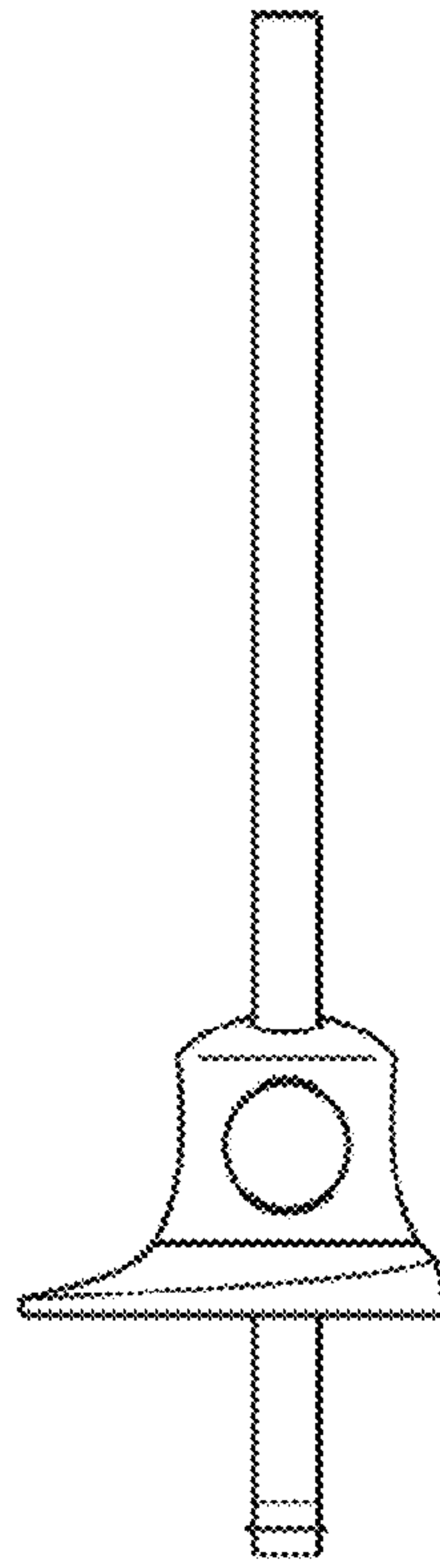

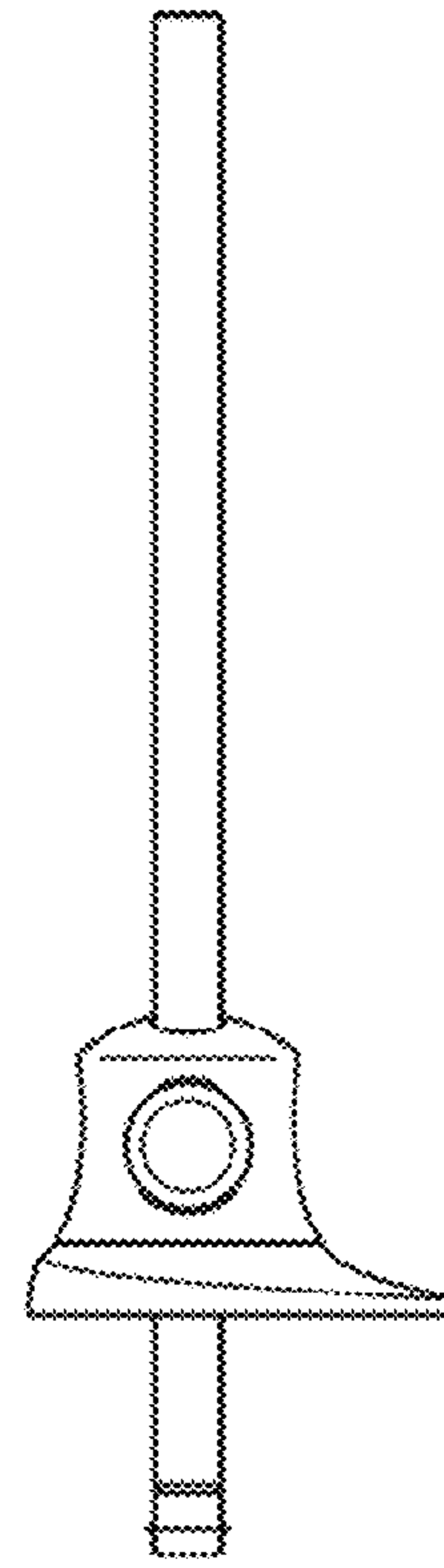

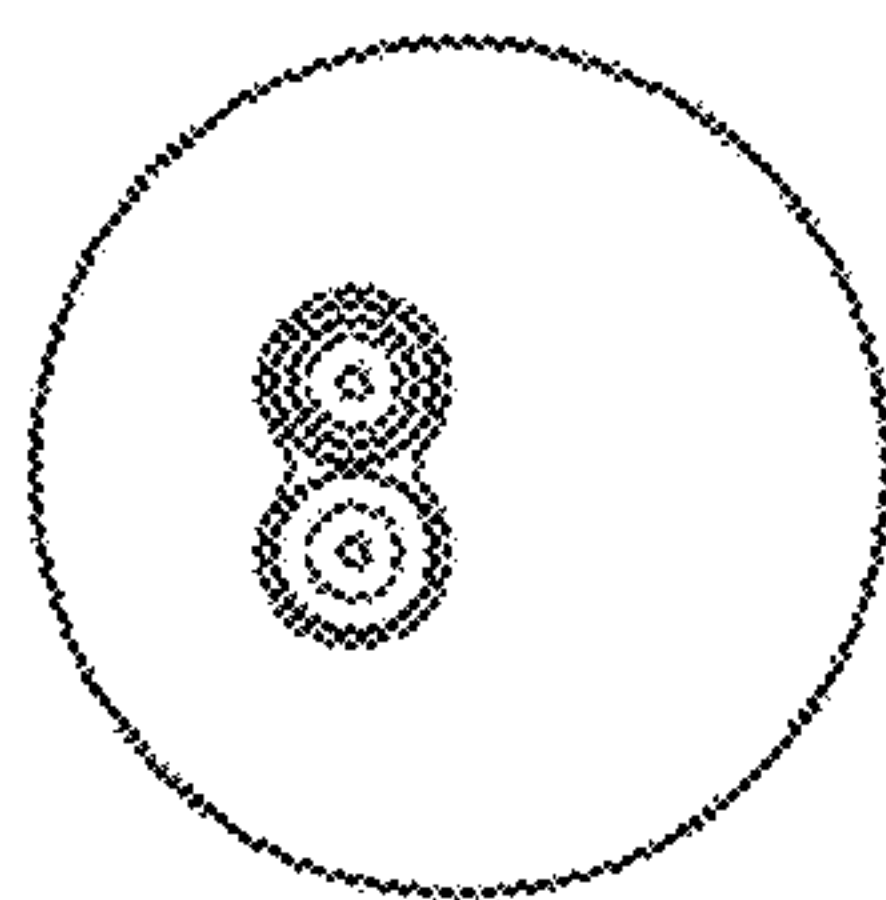

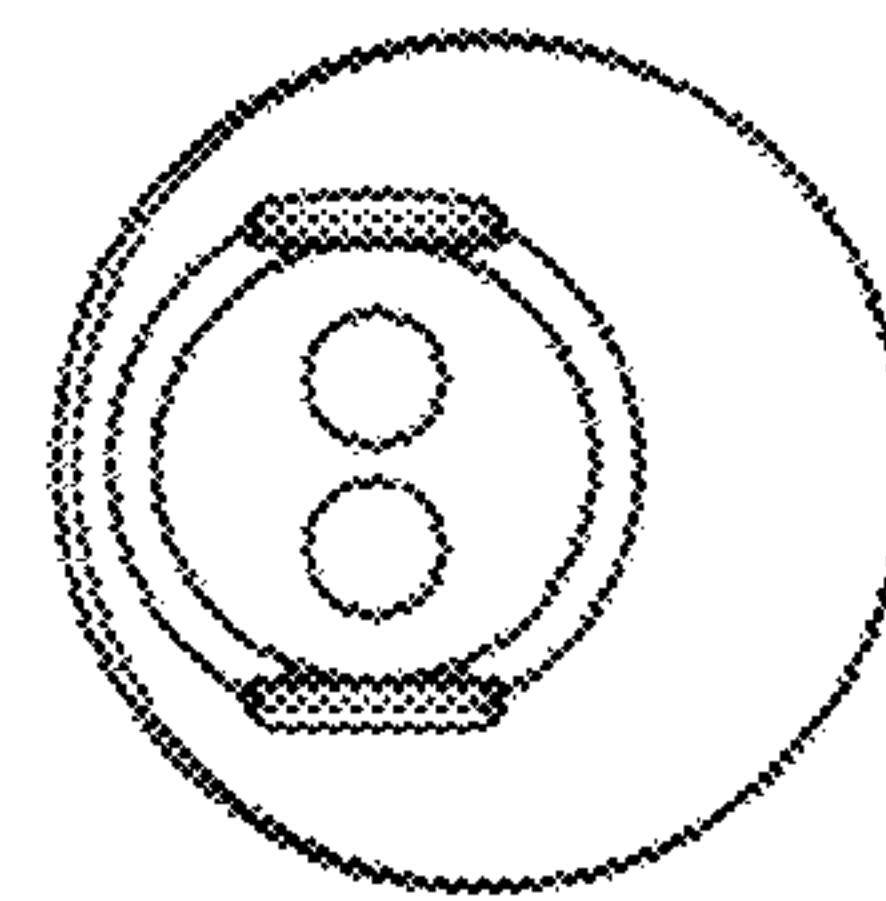
