(57) **CLAIM**

The ornamental design for a retractable lanyard, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a retractable lanyard showing my new design;

FIG. 2 is a front view of the retractable lanyard shown in FIG. 1;

FIG. 3 is a rear view of the retractable lanyard shown in FIG. 1;

FIG. 4 is a first side view of the retractable lanyard shown in FIG. 1;

FIG. 5 is a second side view of the retractable lanyard shown in FIG. 1;

FIG. 6 is a perspective view of a third embodiment of a retractable lanyard showing my new design;

FIG. 7 is a front view of the retractable lanyard shown in FIG. 6;

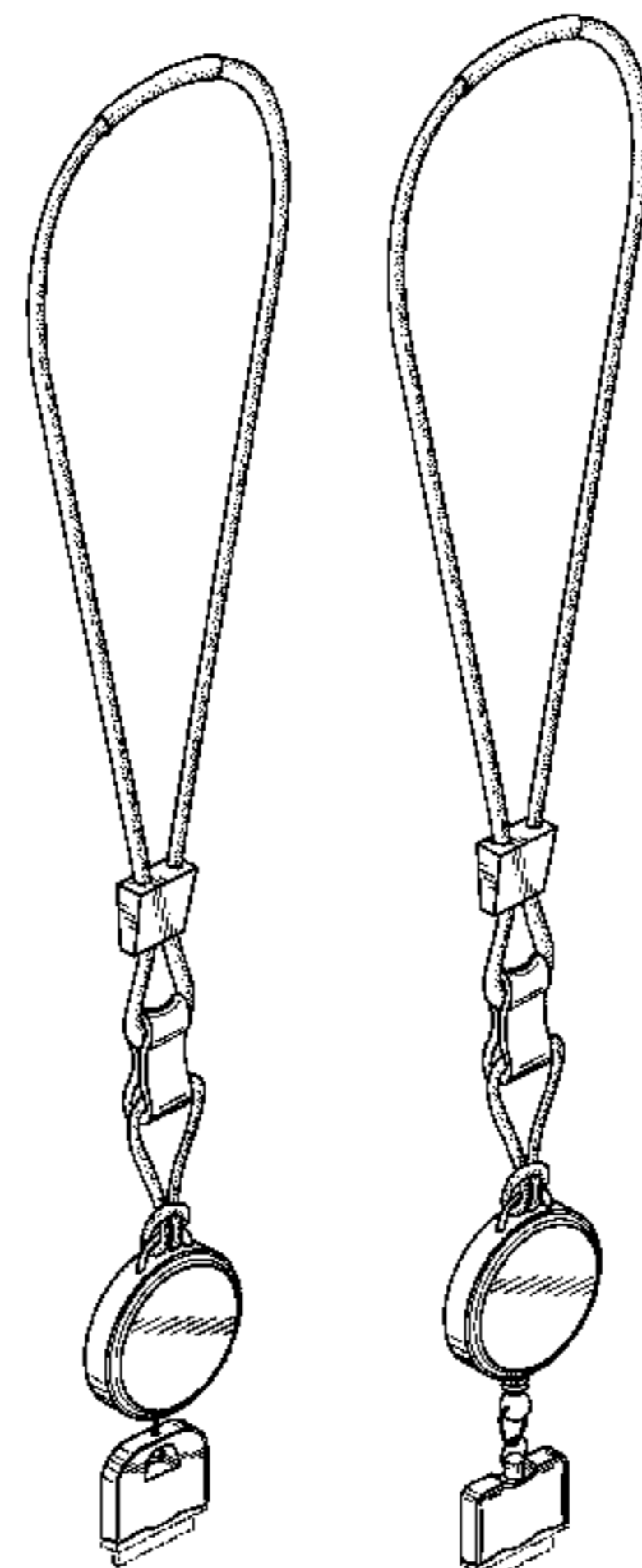
FIG. 8 is a rear view of the retractable lanyard shown in FIG. 6;

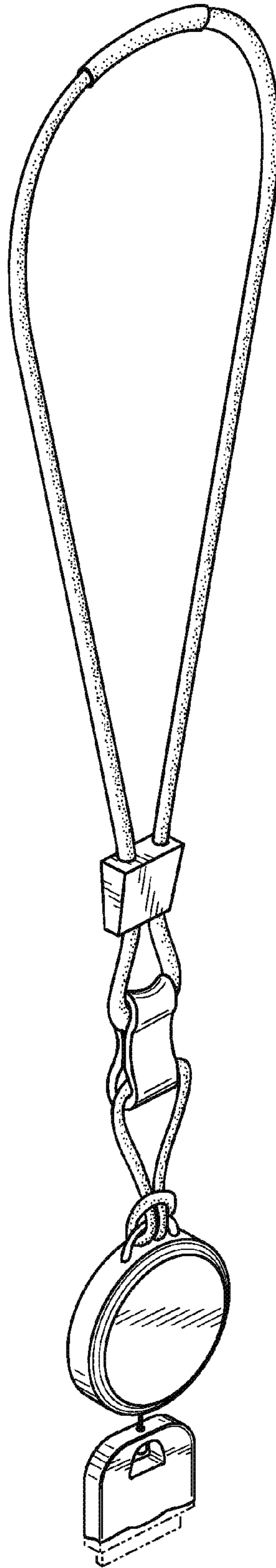

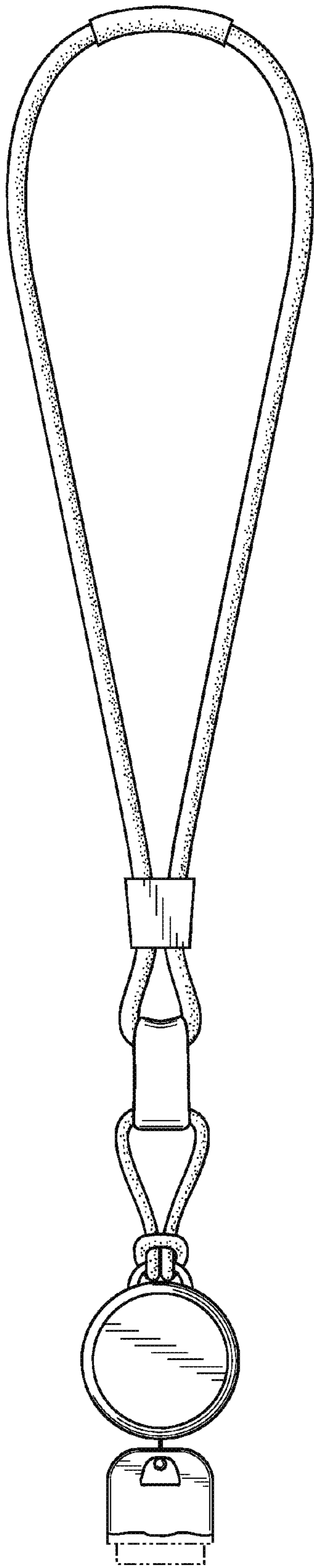

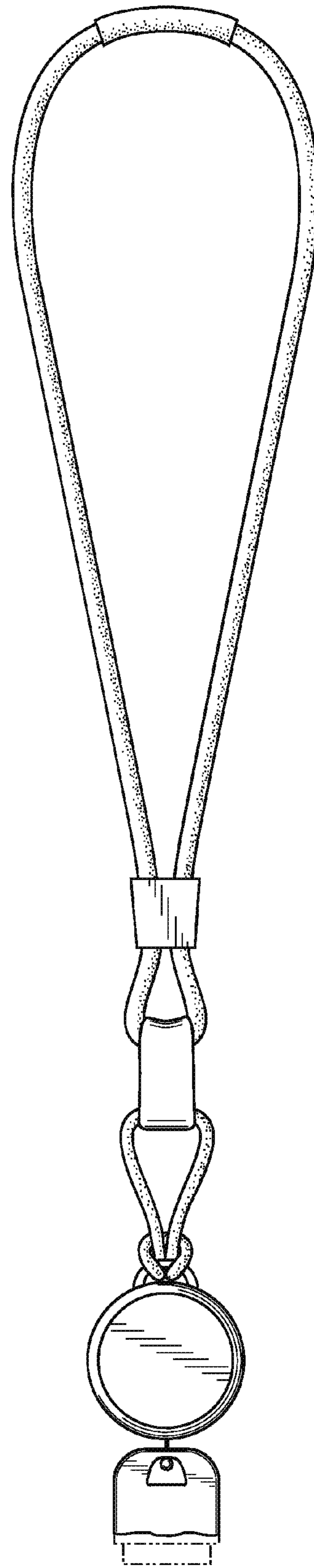

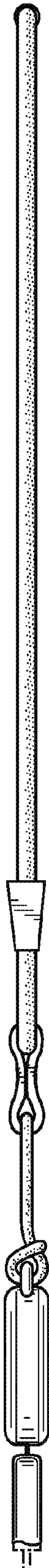

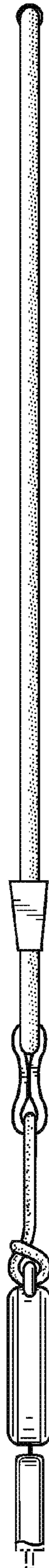

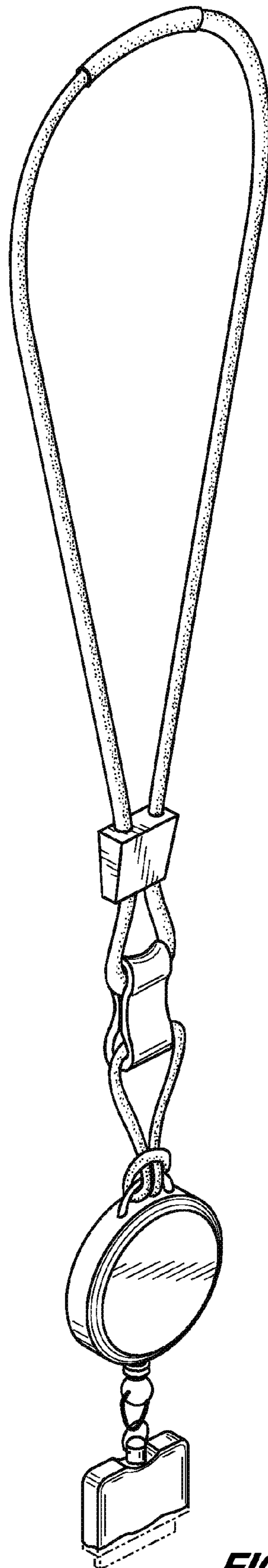

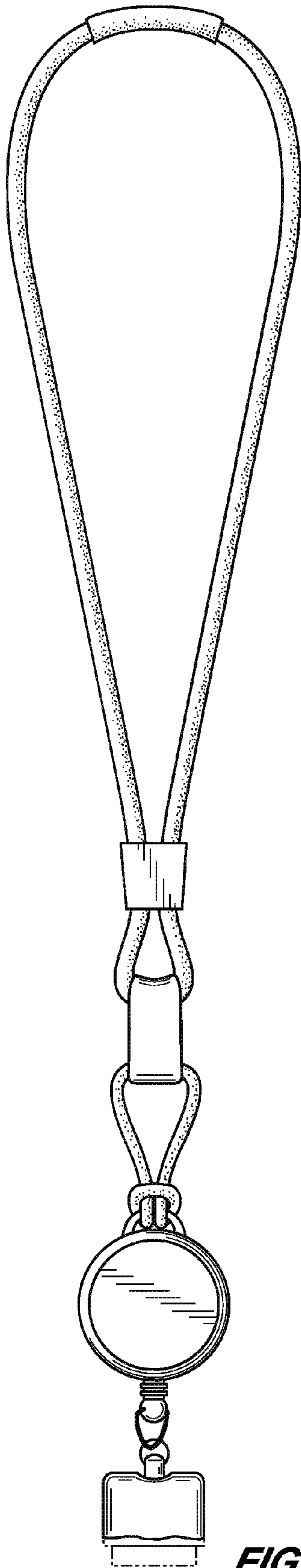

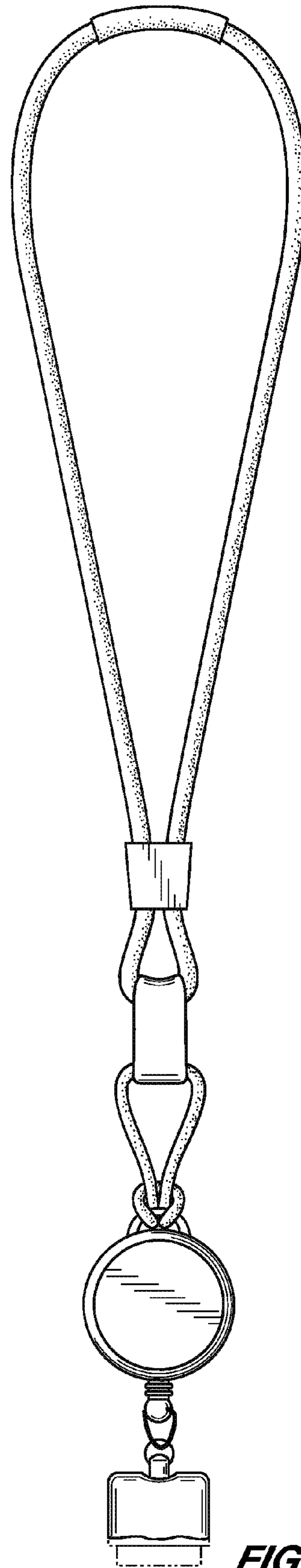

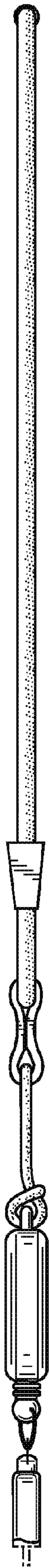

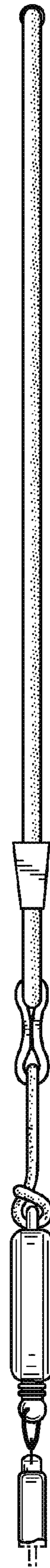
