**DESCRIPTION**

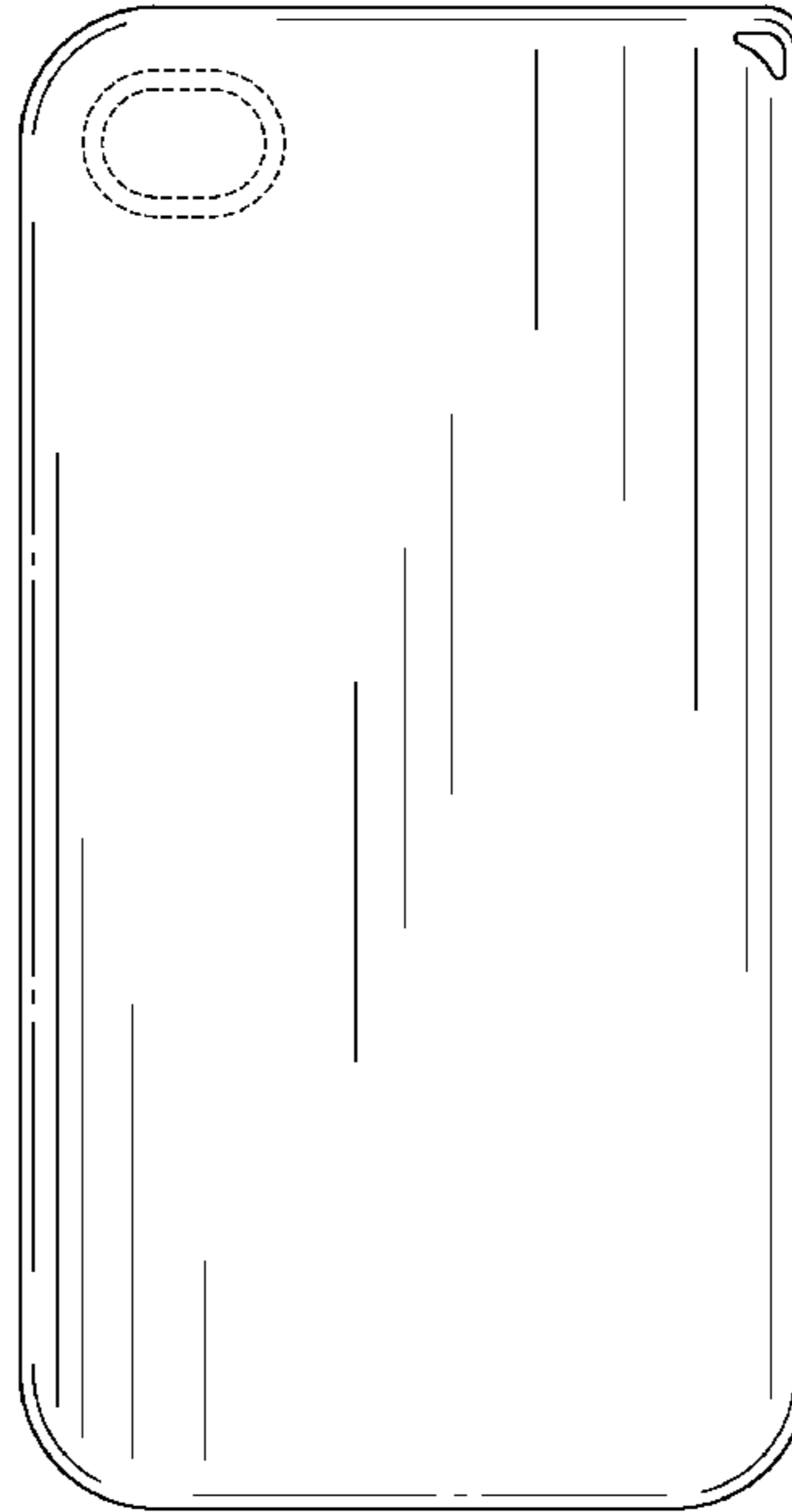
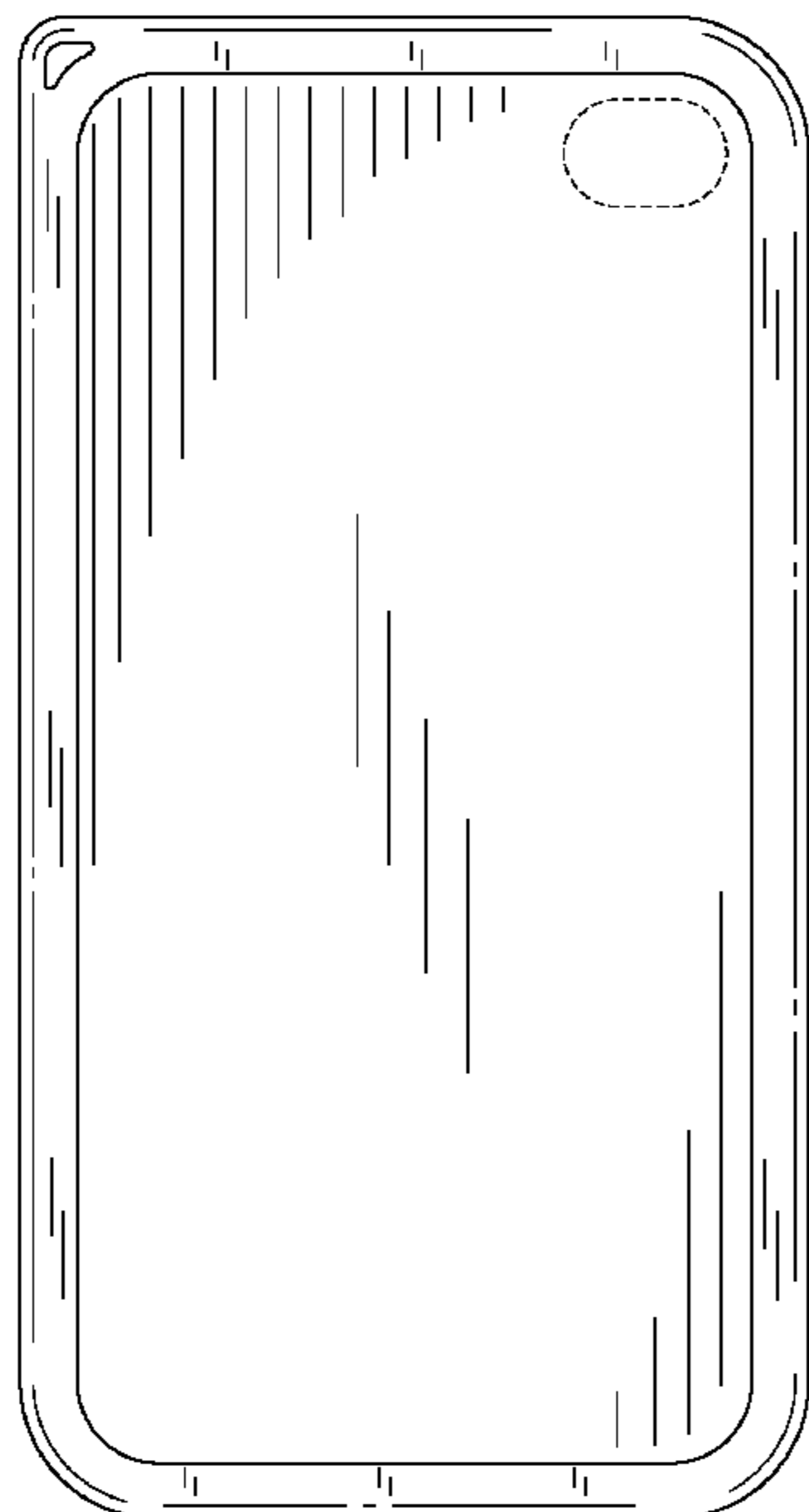

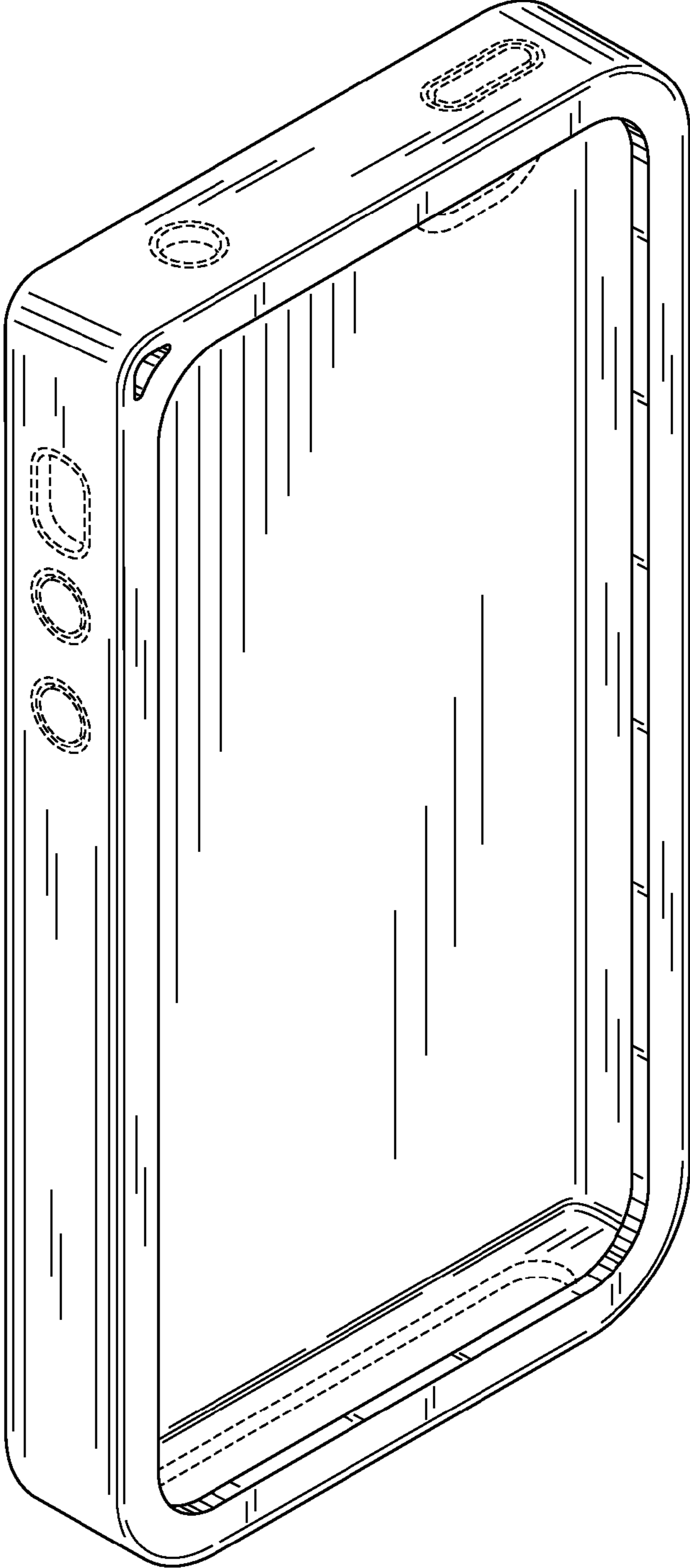

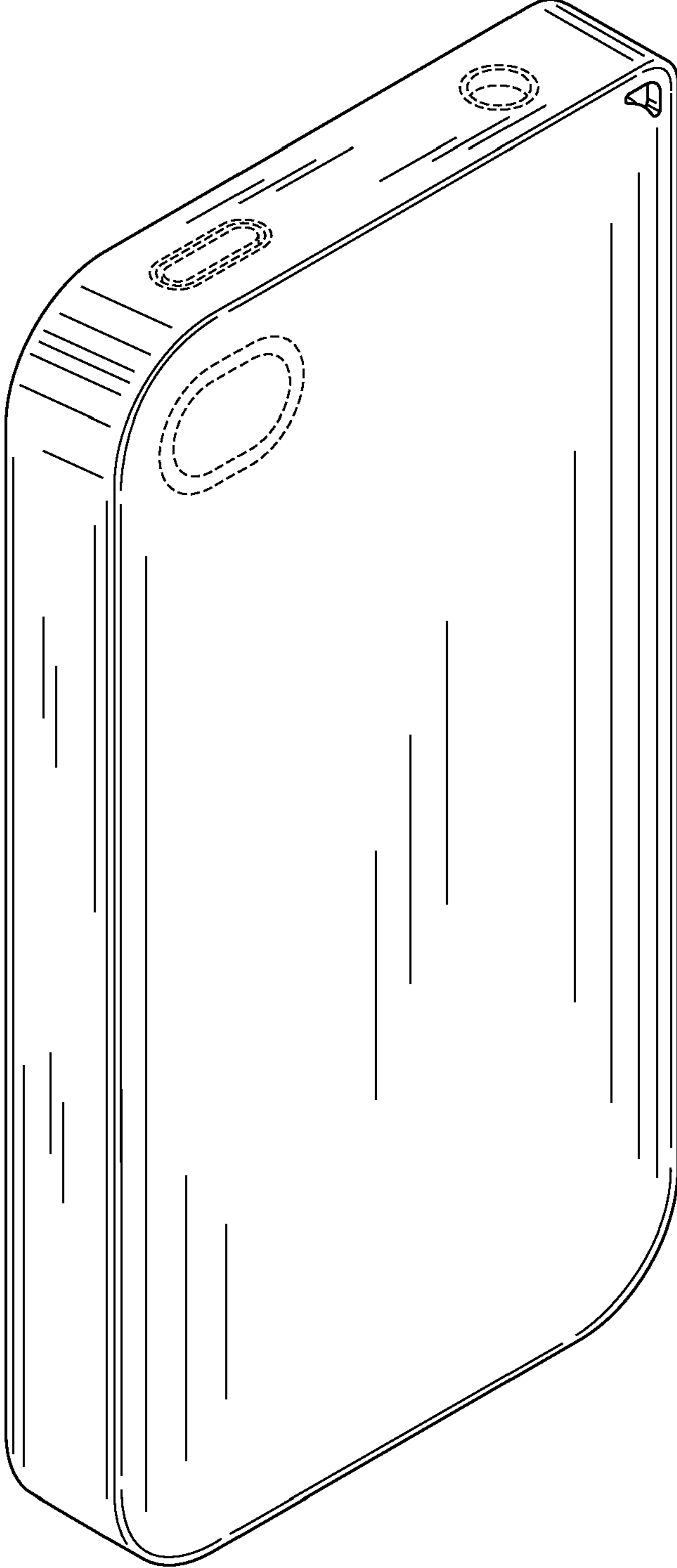

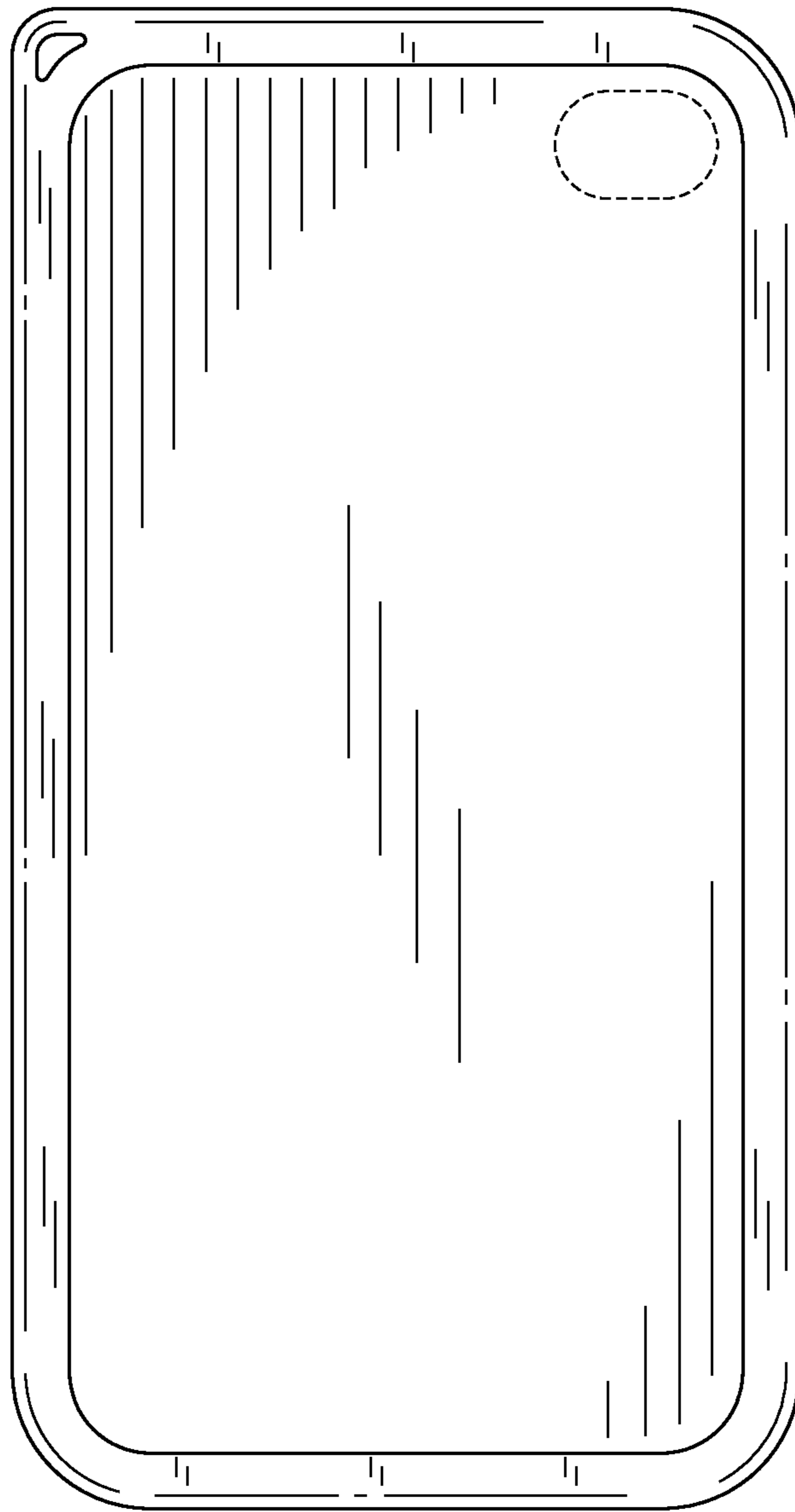

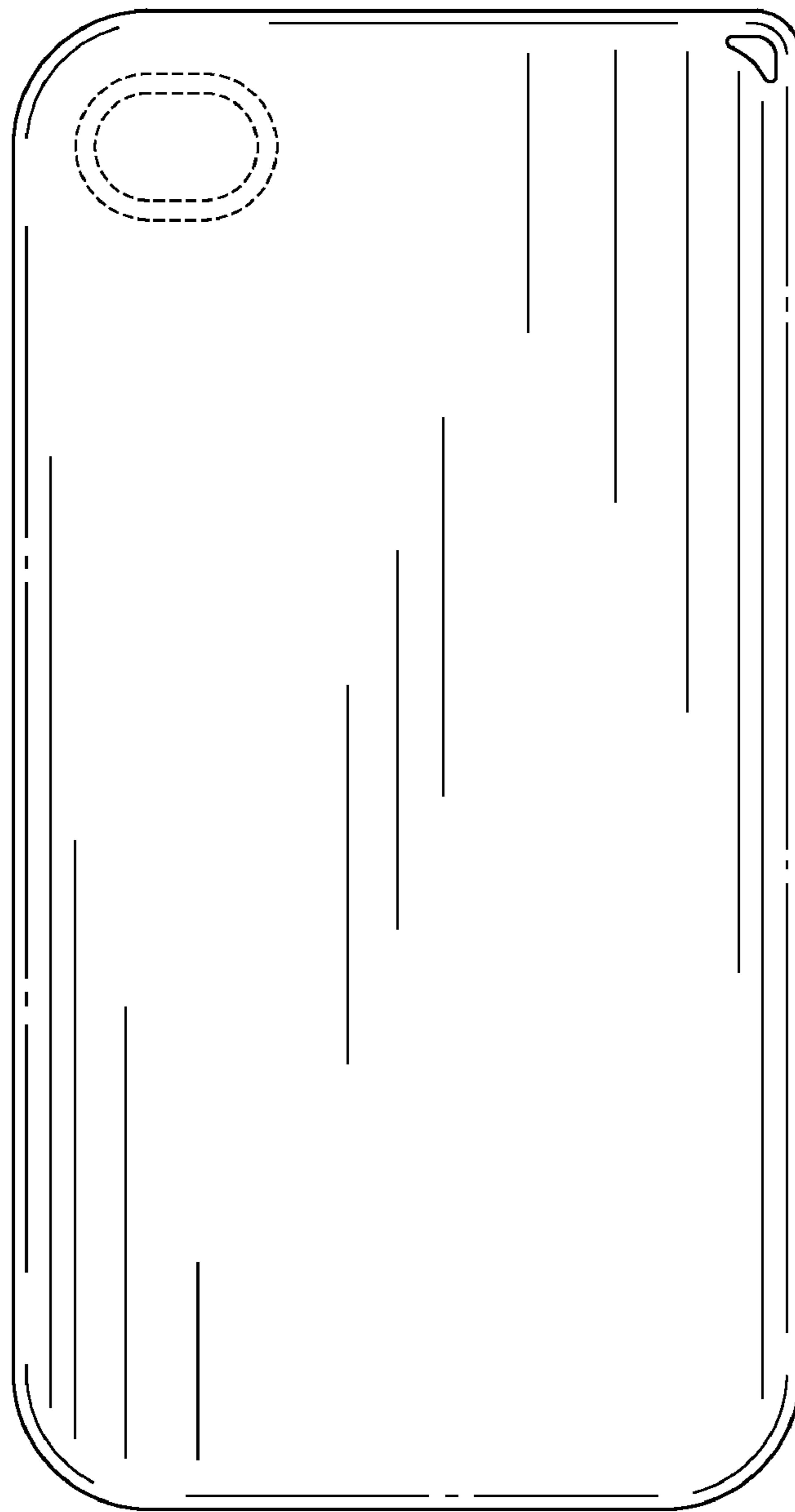

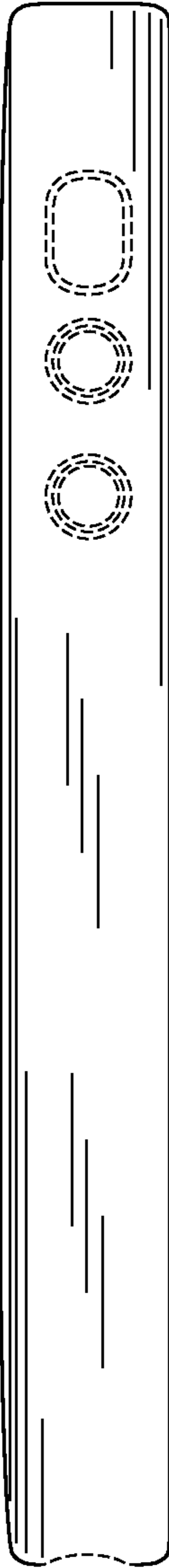

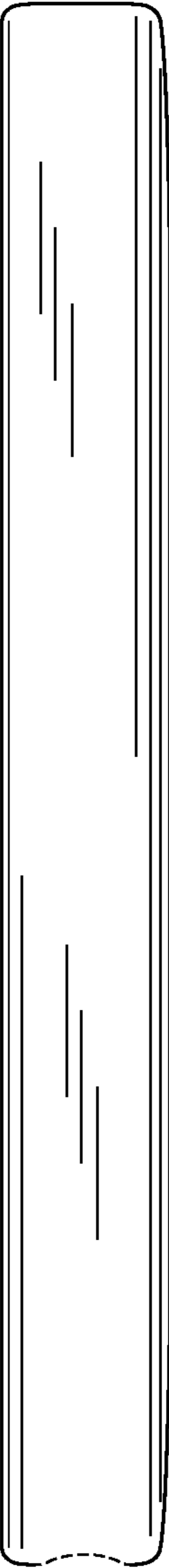

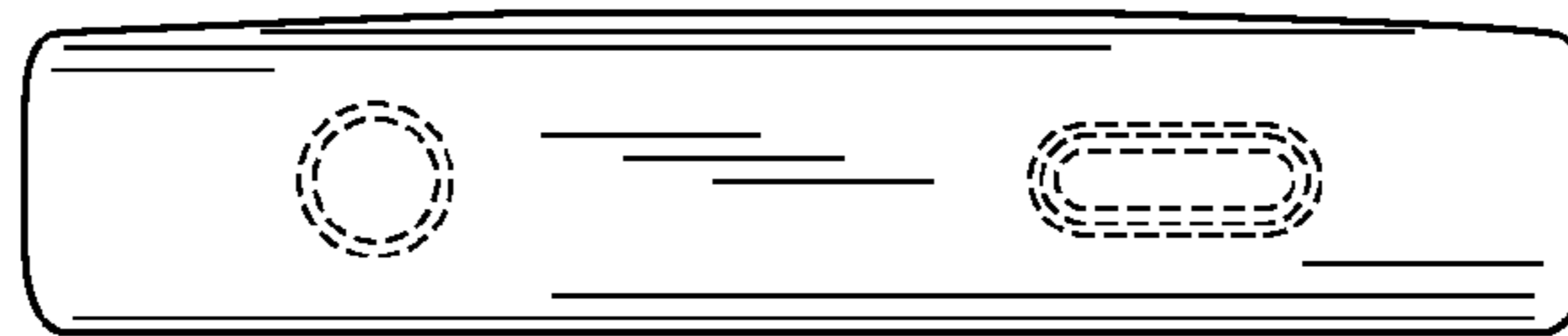
