The ornamental design for a display screen with icon, as shown and described.

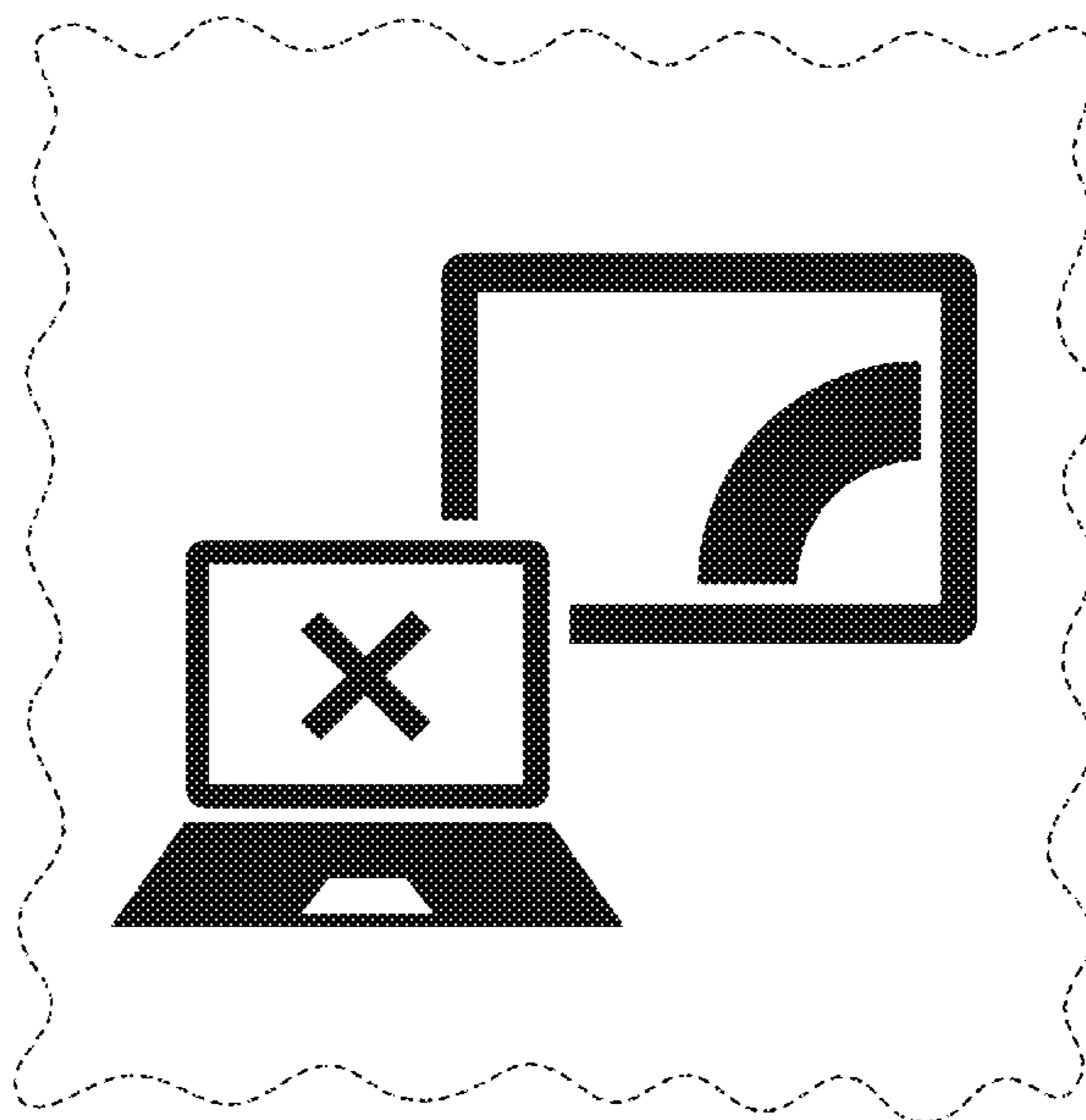
**DESCRIPTION**

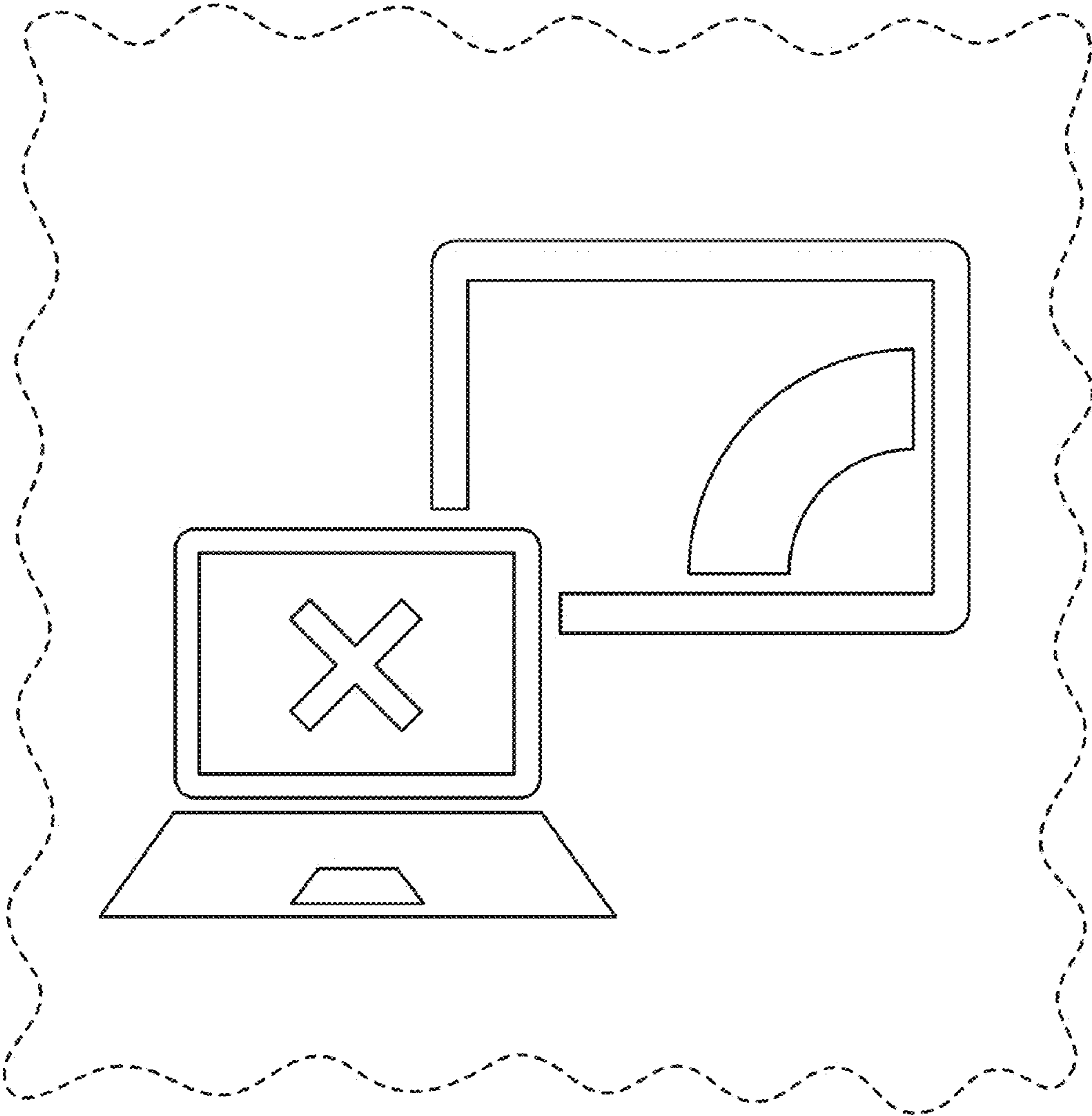

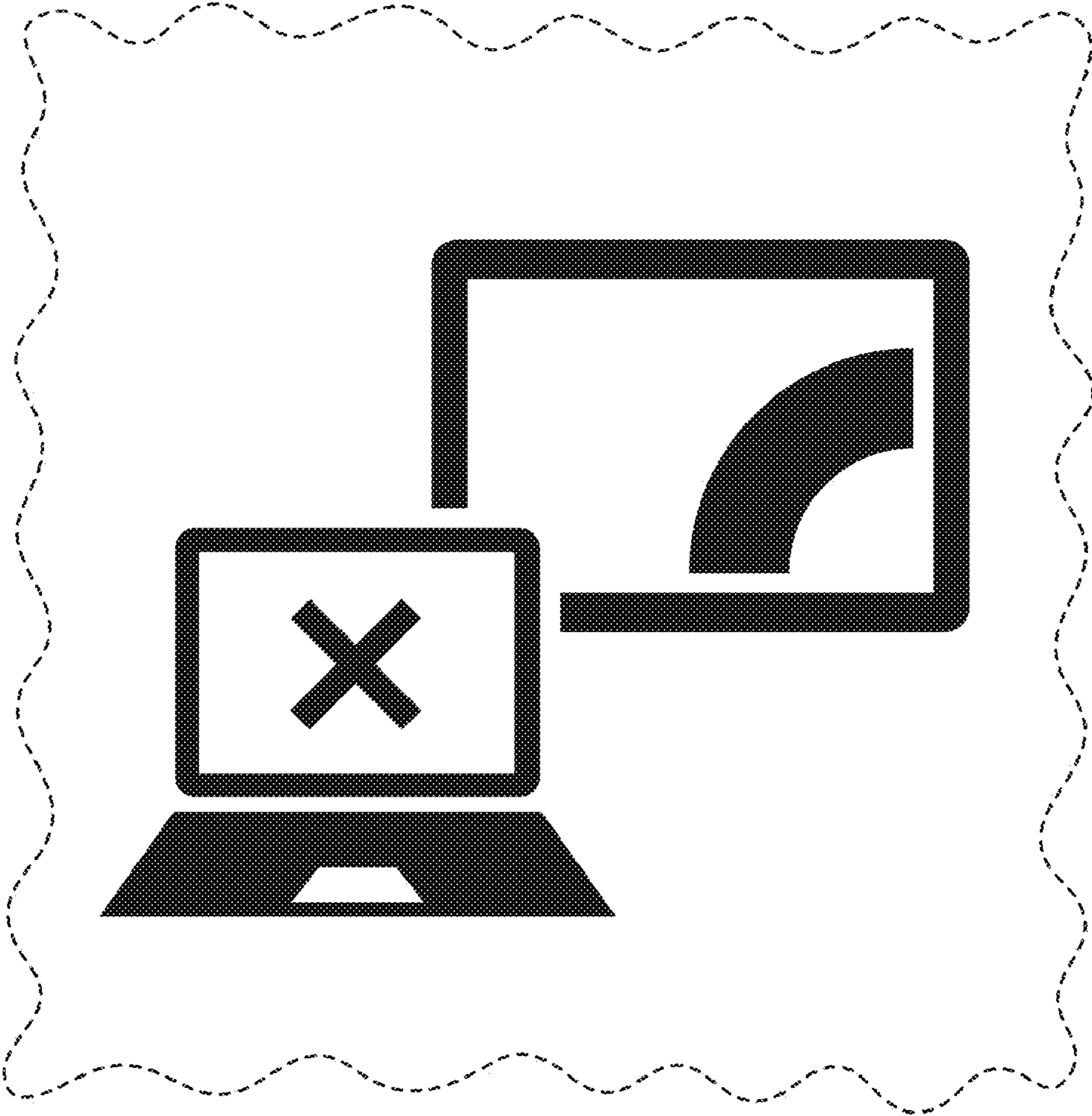
