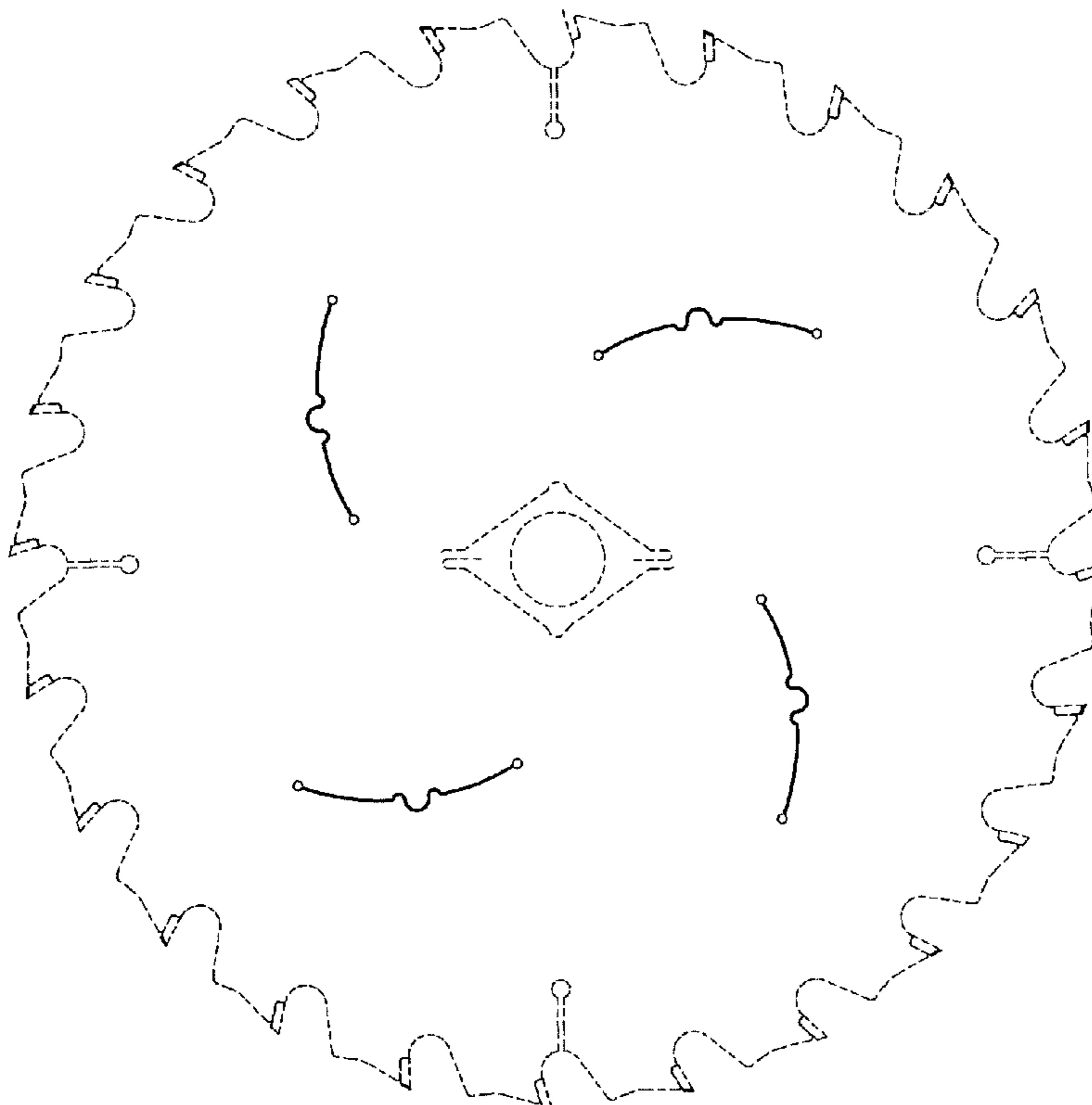
FIG. 1 is a perspective view of the saw blade body slots.

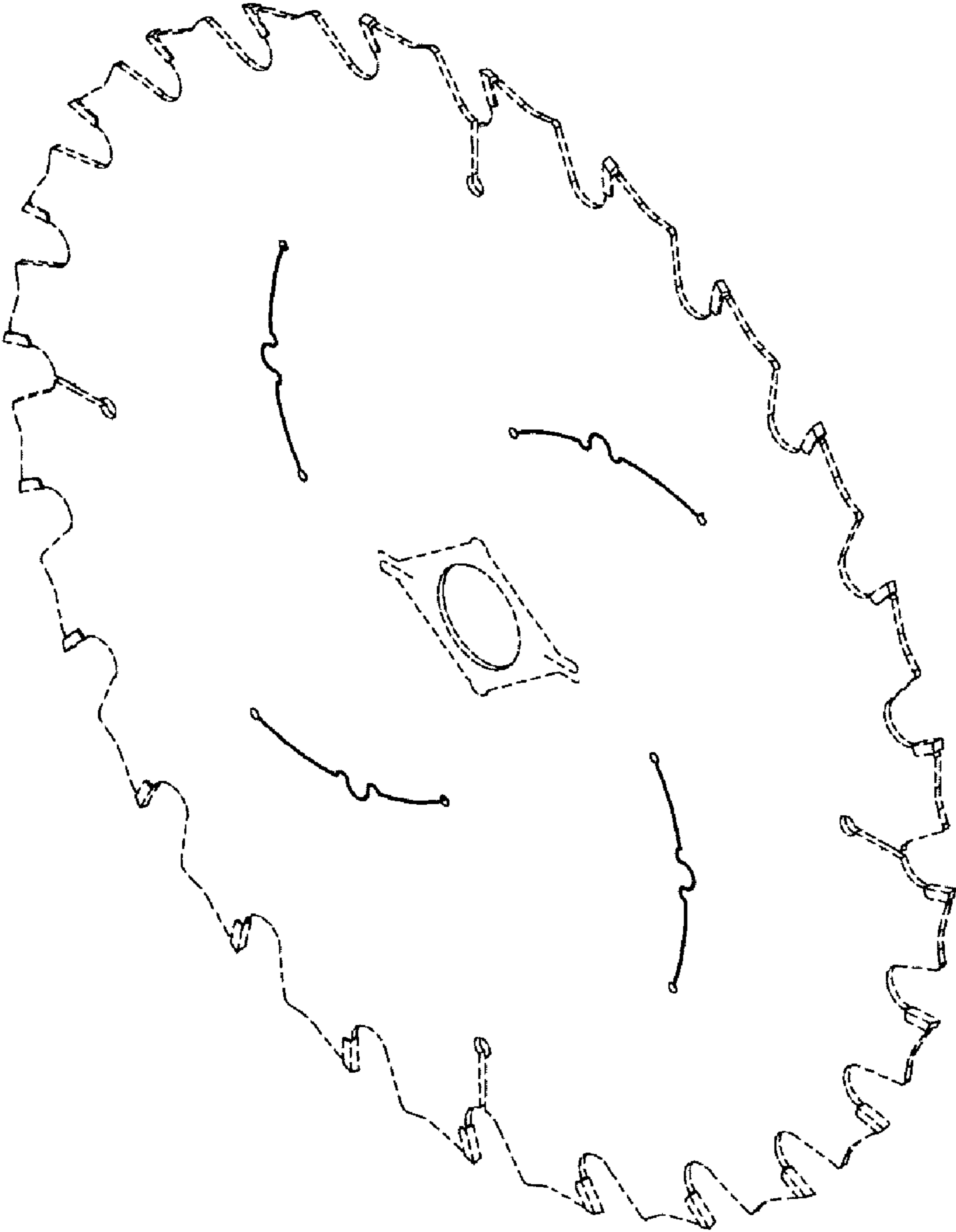

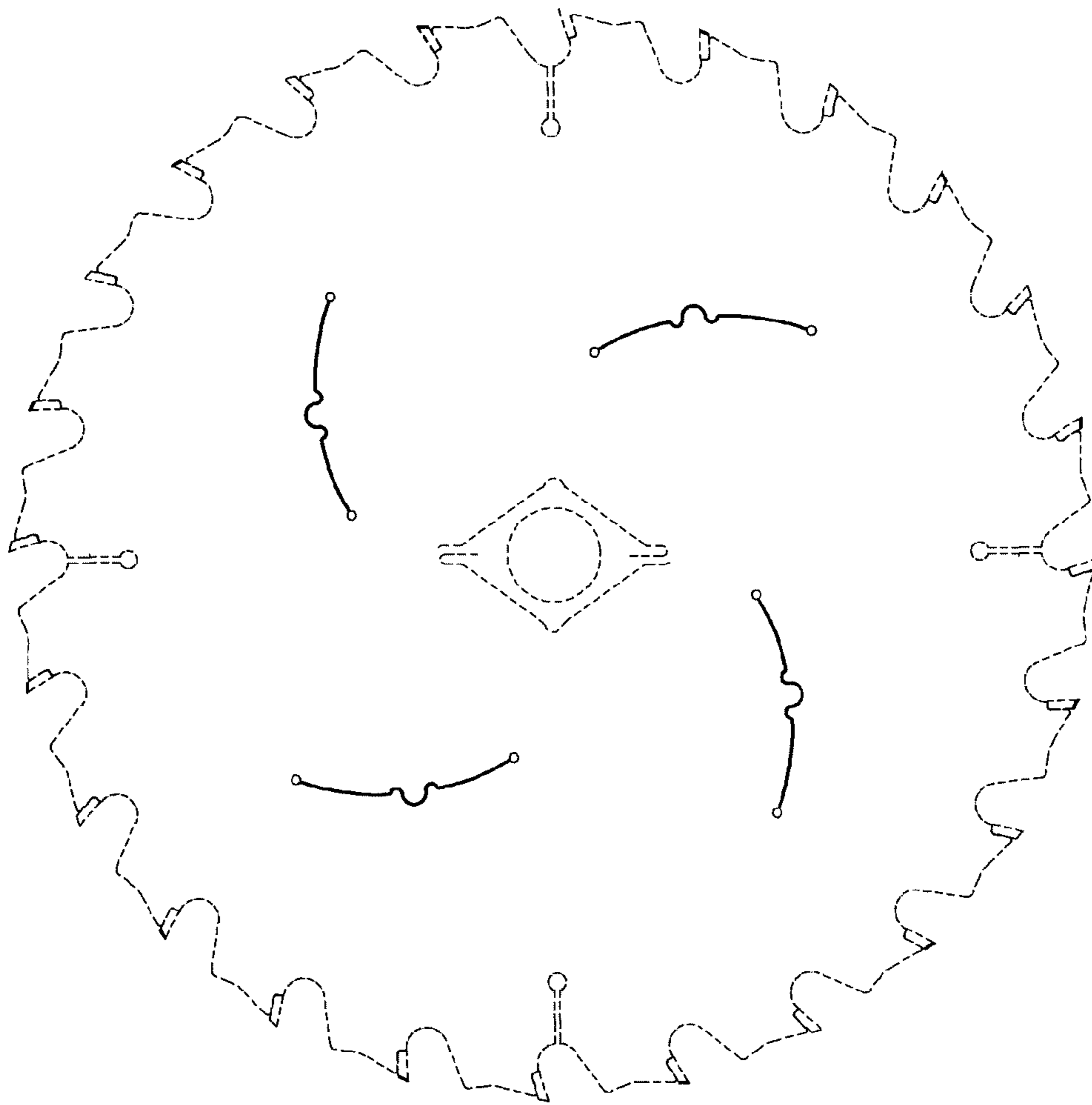

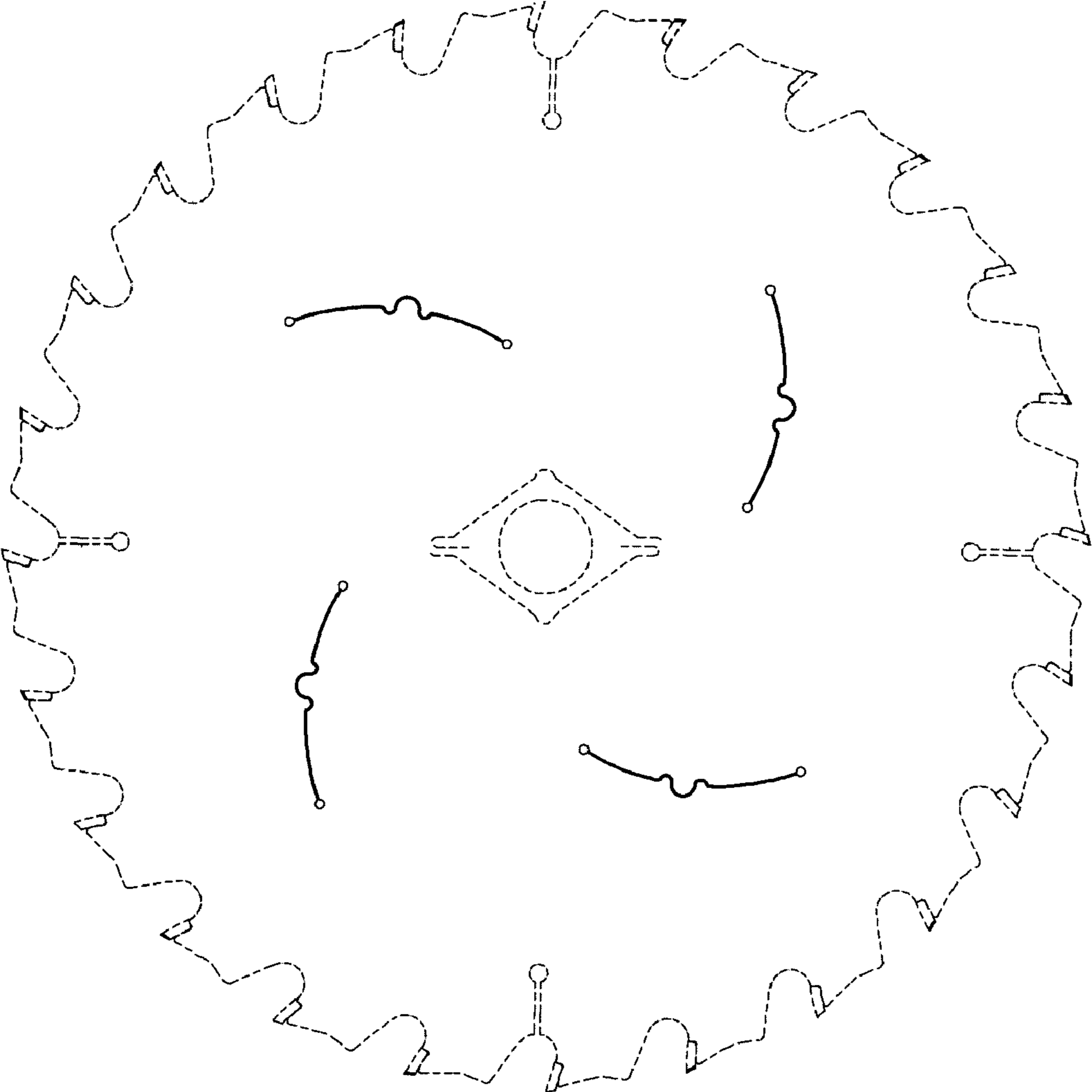
