(57) **CLAIM**

I claim the ornamental design for a football themed hand clap maraca, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a football themed hand clap maraca in a percussion position, showing my new design;

FIG. 2 is a perspective view in a non-percussion position thereof;

FIG. 3 is a side elevation view thereof;

FIG. 4 is an opposite side, relative to FIG. 3, elevation view thereof;

FIG. 5 is a front elevation view thereof;

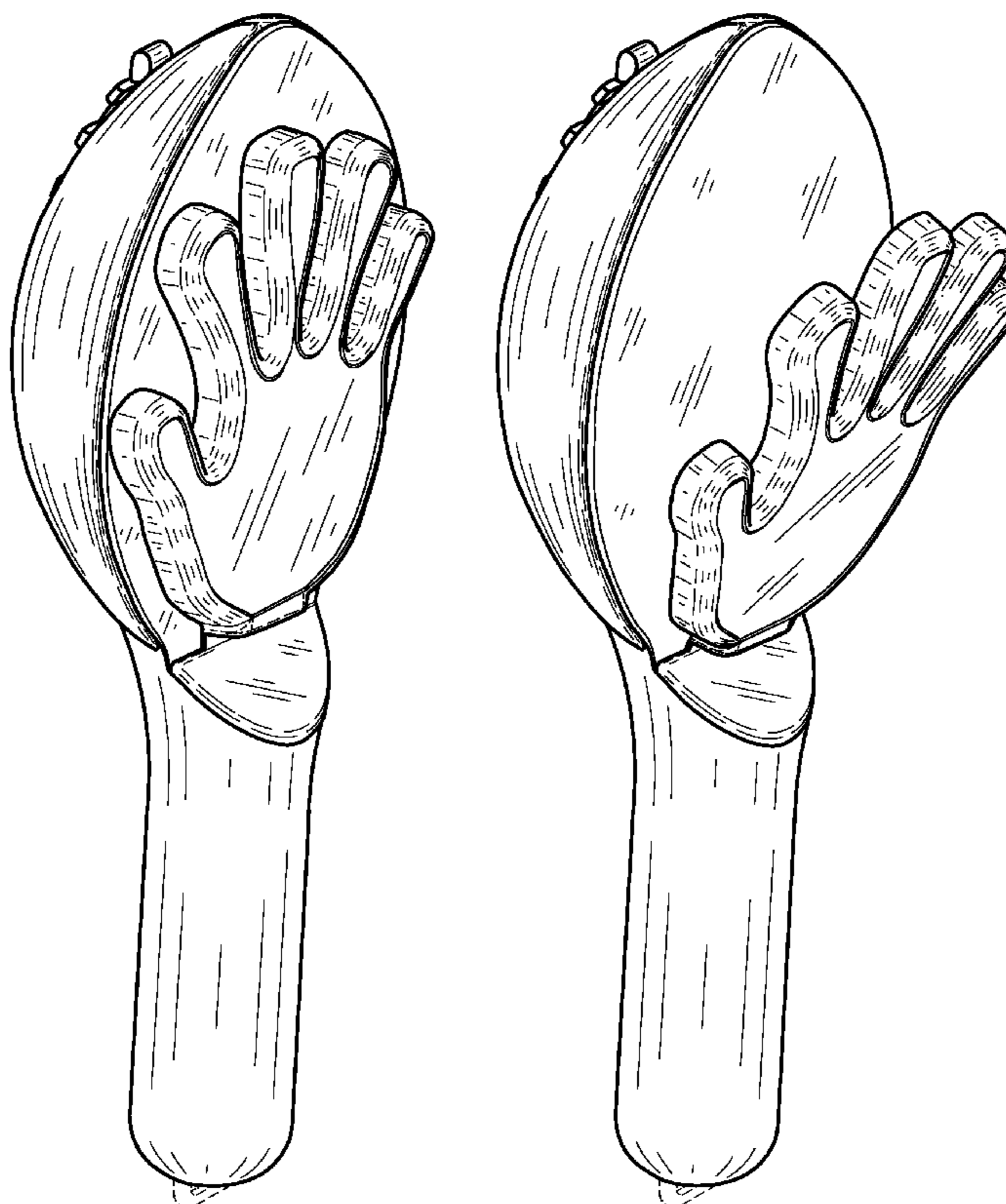
FIG. 6 is a back elevation view thereof;

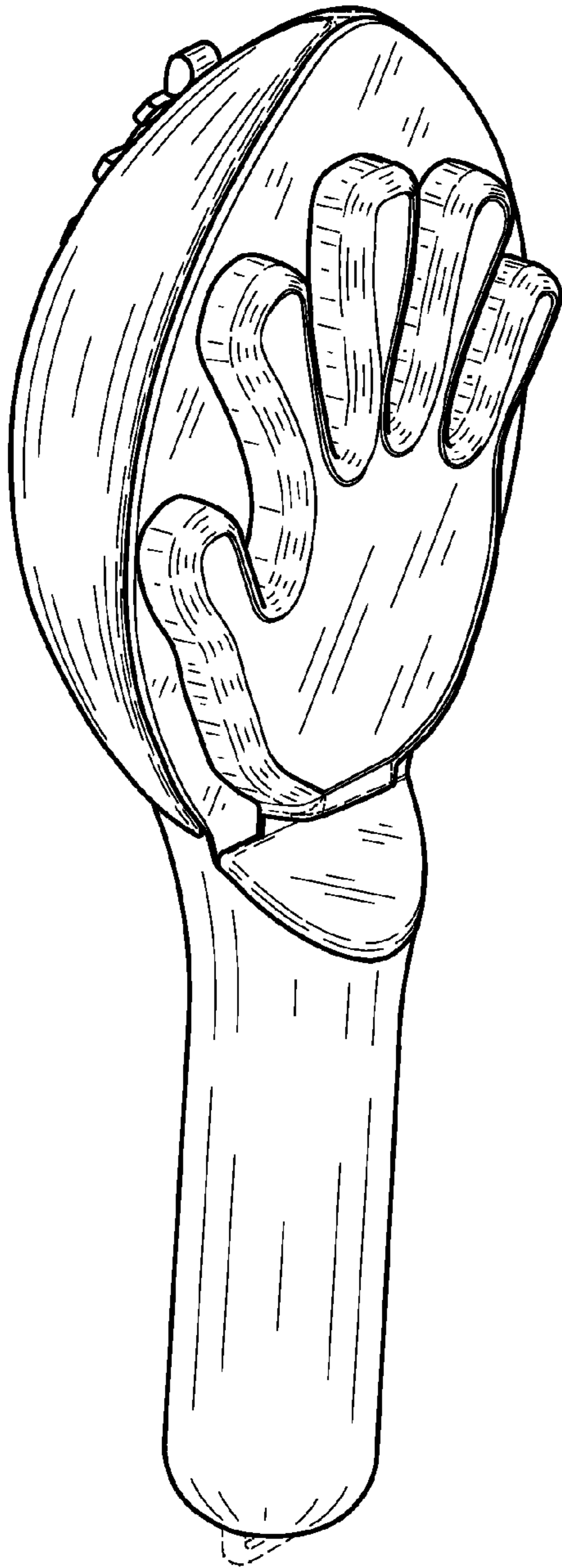
FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan elevation thereof.

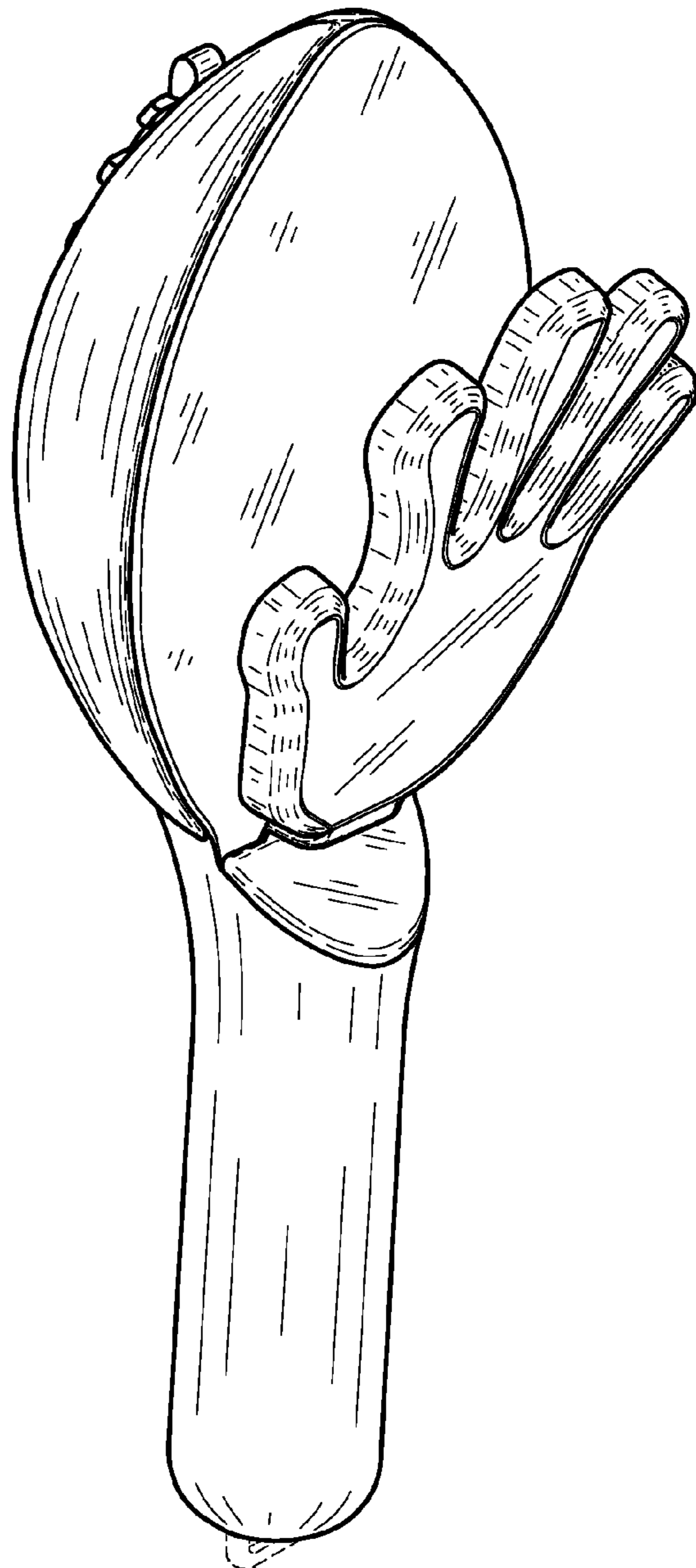
The broken lines shown throughout the views represent the portions of the football themed hand clap maraca, which form no part of the claimed design.

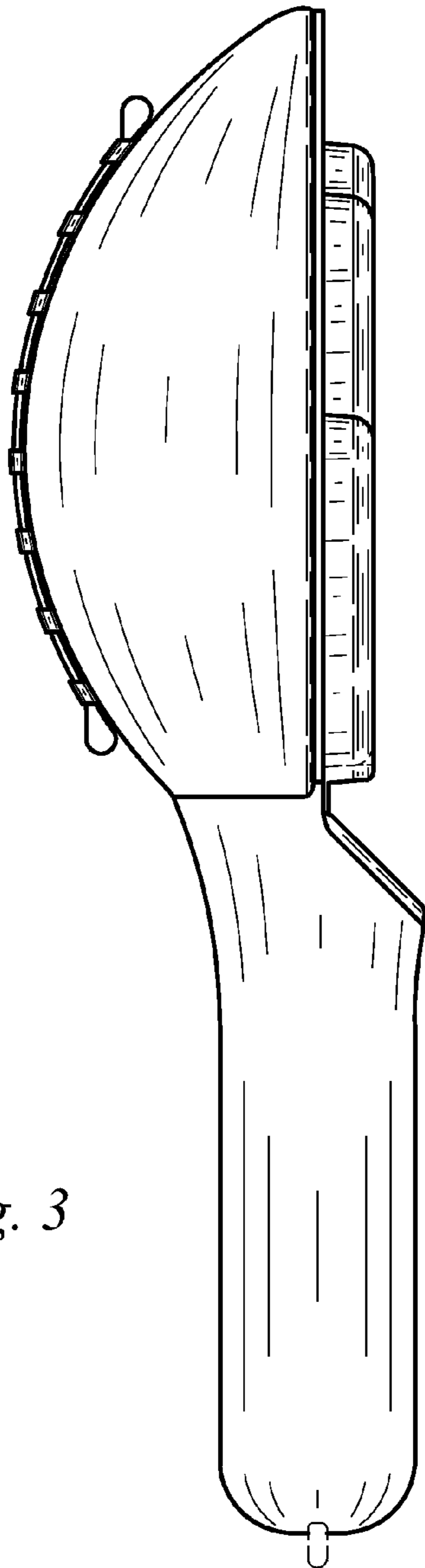




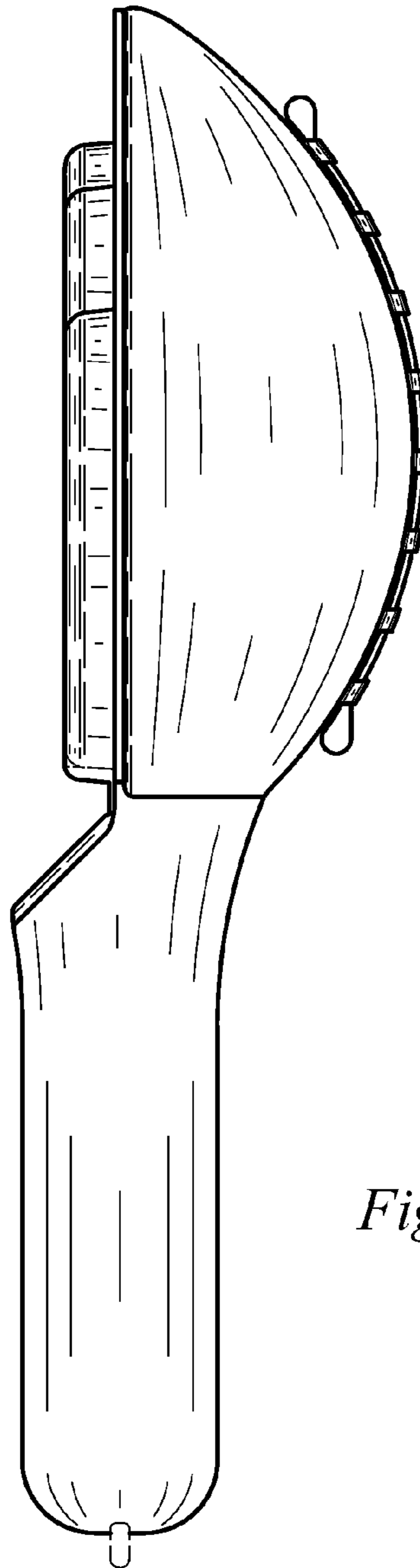

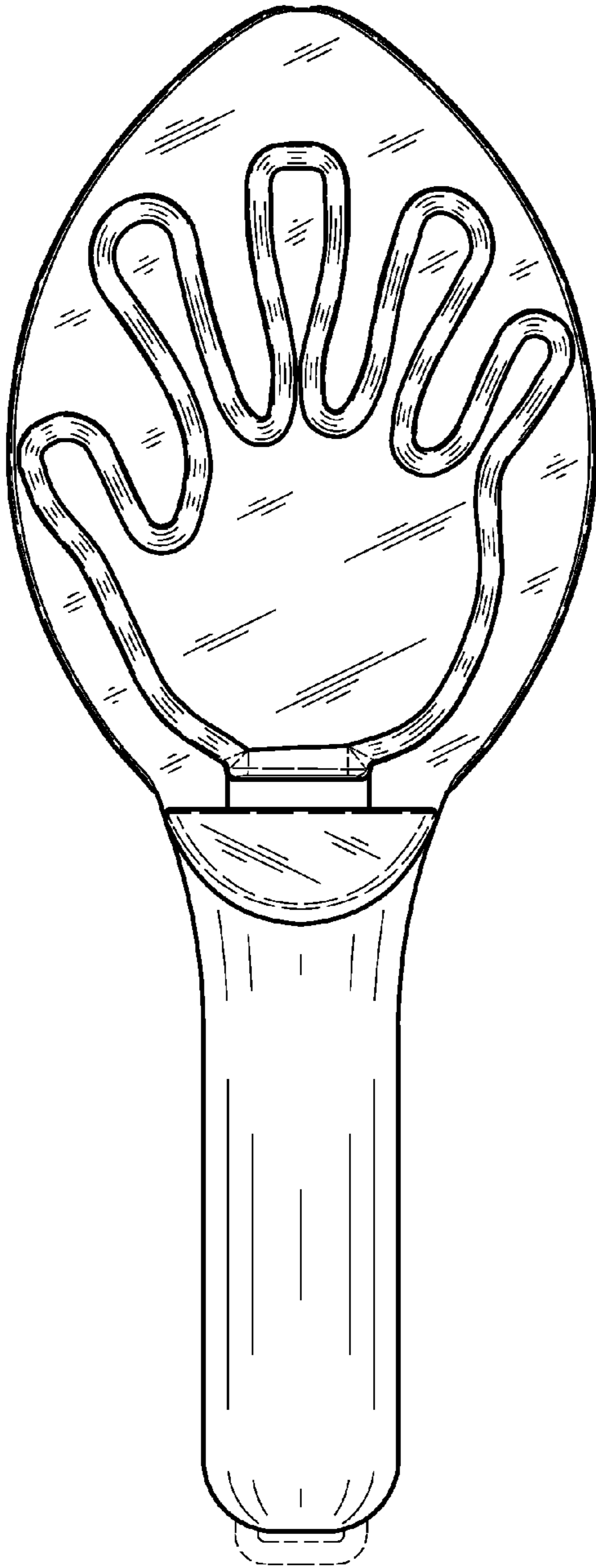

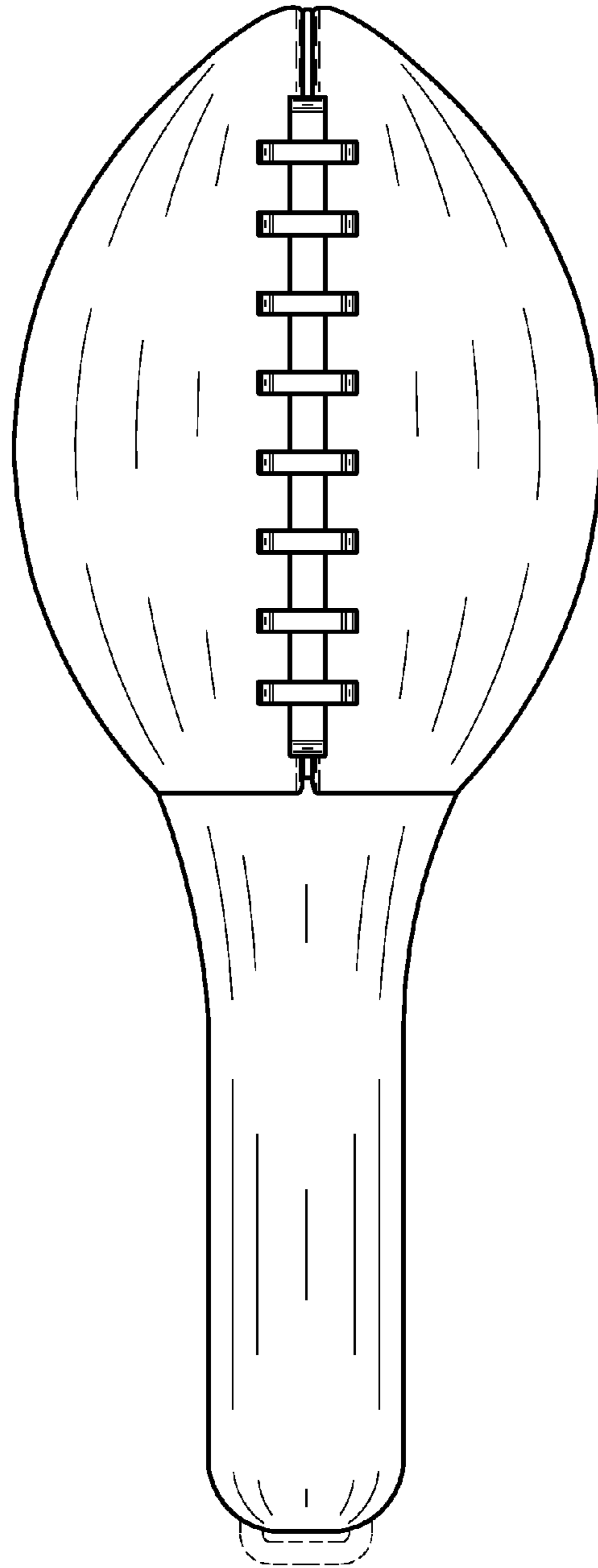

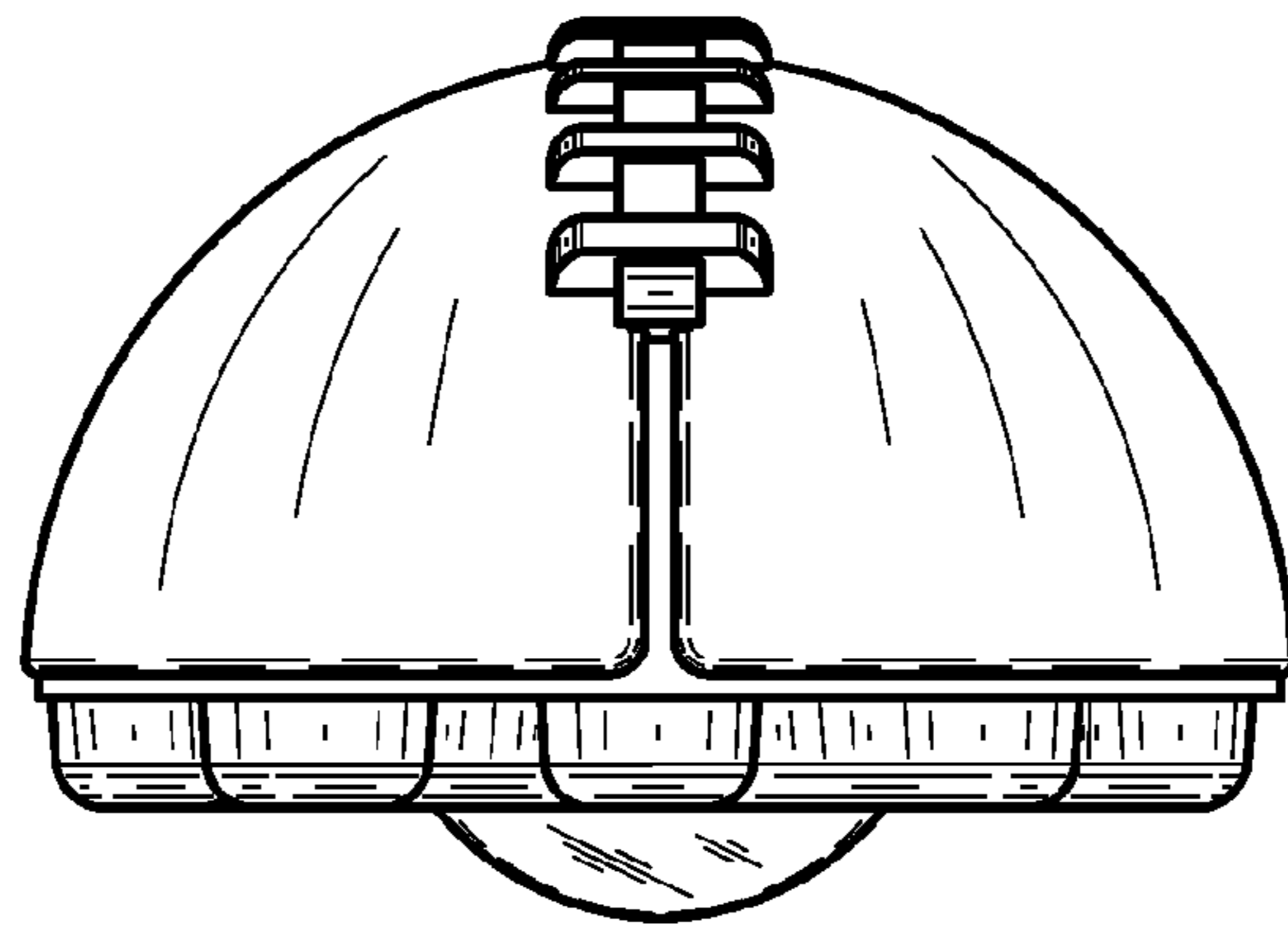

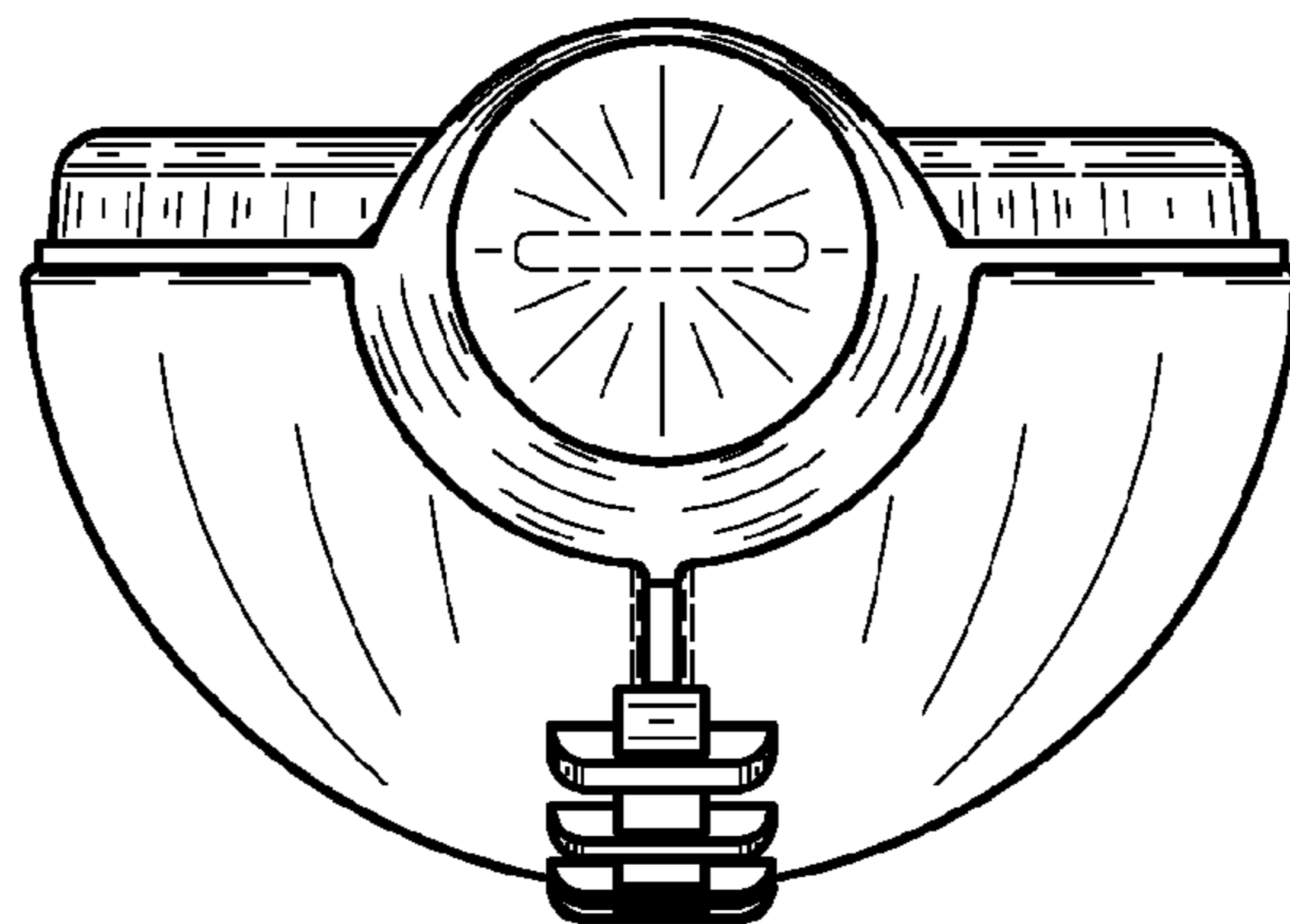
