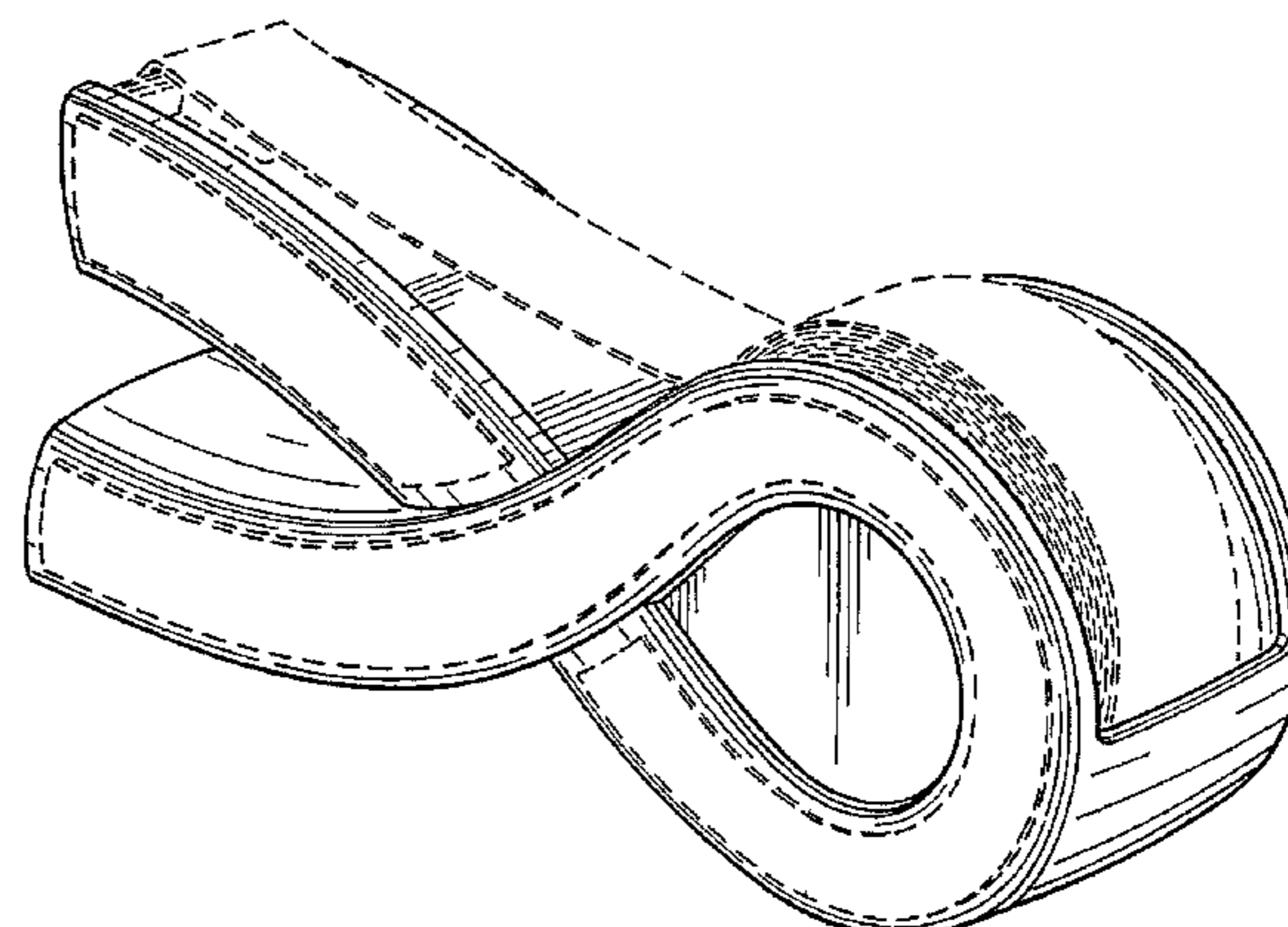
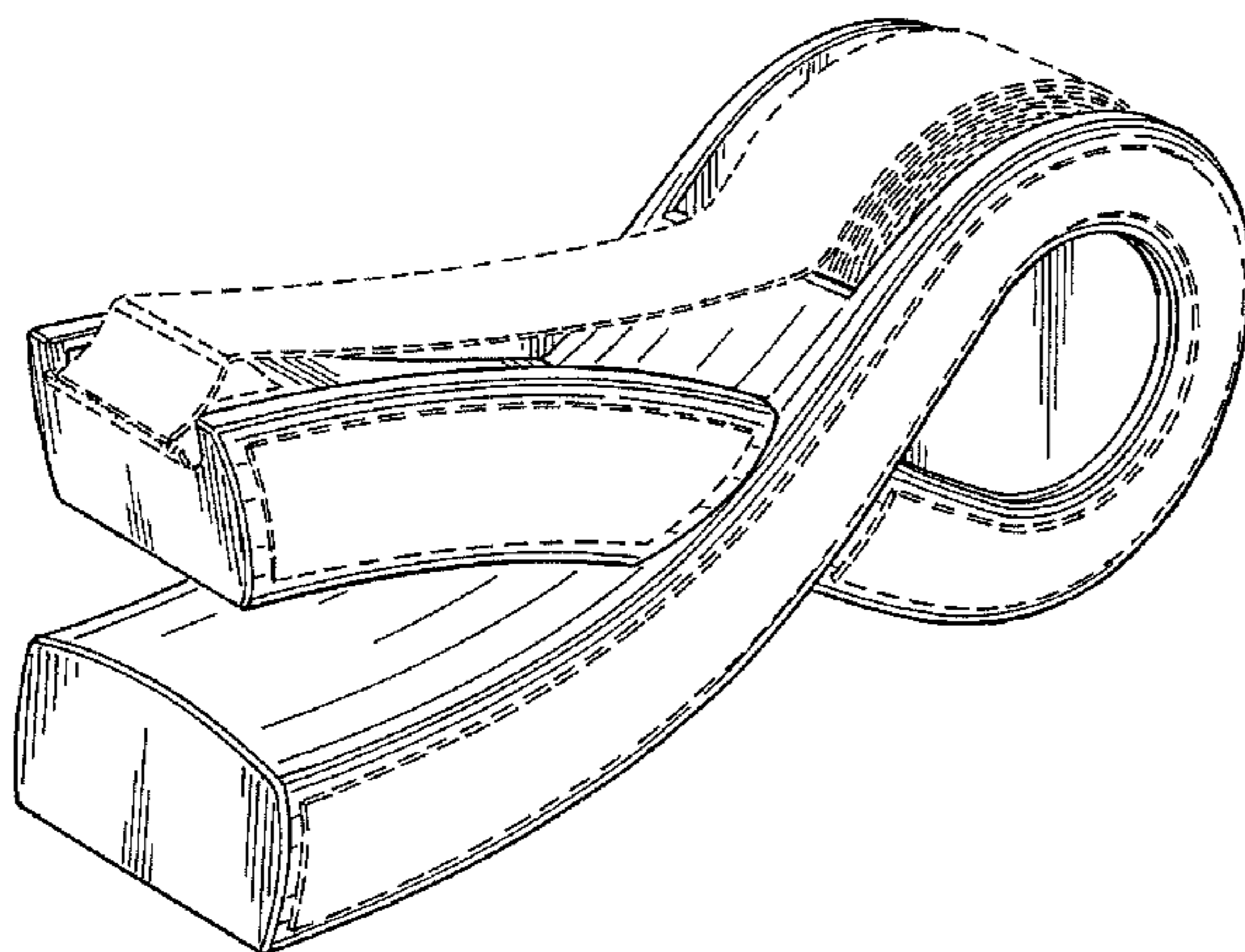
(57) **CLAIM**

The ornamental design for ribbon tape dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a side, top, perspective view of the ribbon tape dispenser with elements thereof shown in phantom;
FIG. 2 is an opposing side, top, perspective view of the ribbon tape dispenser;
FIG. 3 is a left side view thereof, the right side view thereof being a mirror image thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof,
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines shown are included for illustrative purposes only form no part of the claimed design.

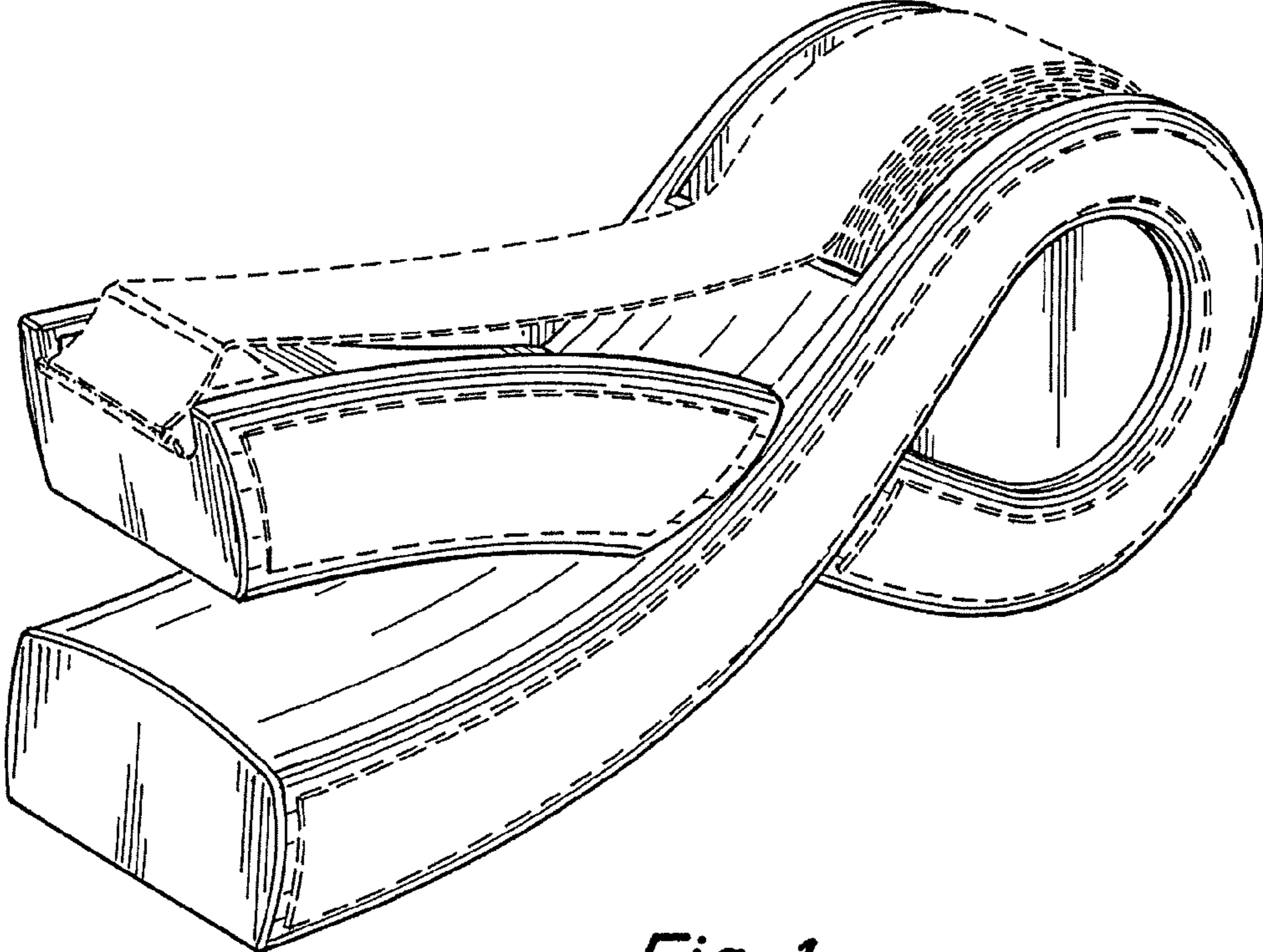

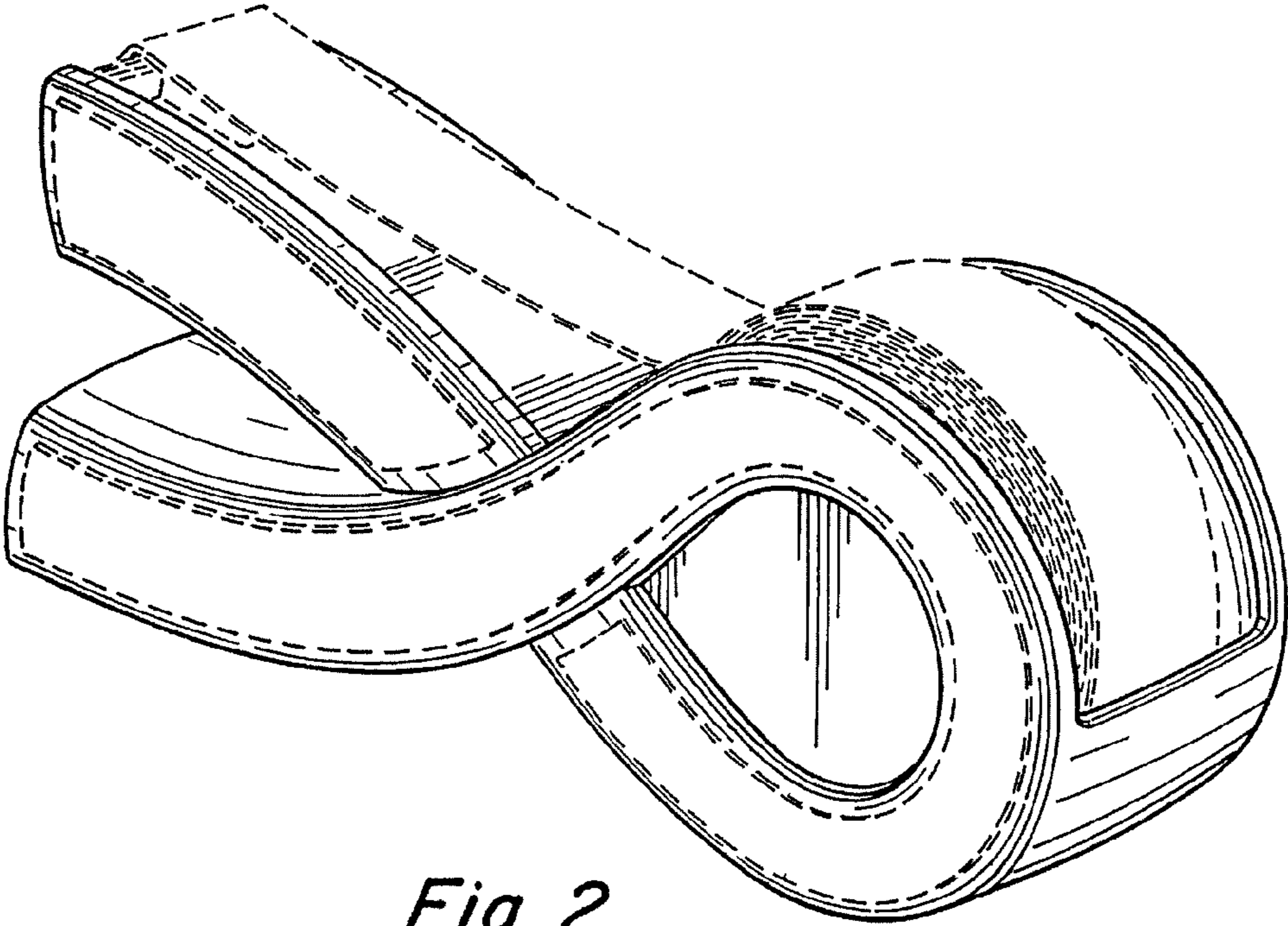

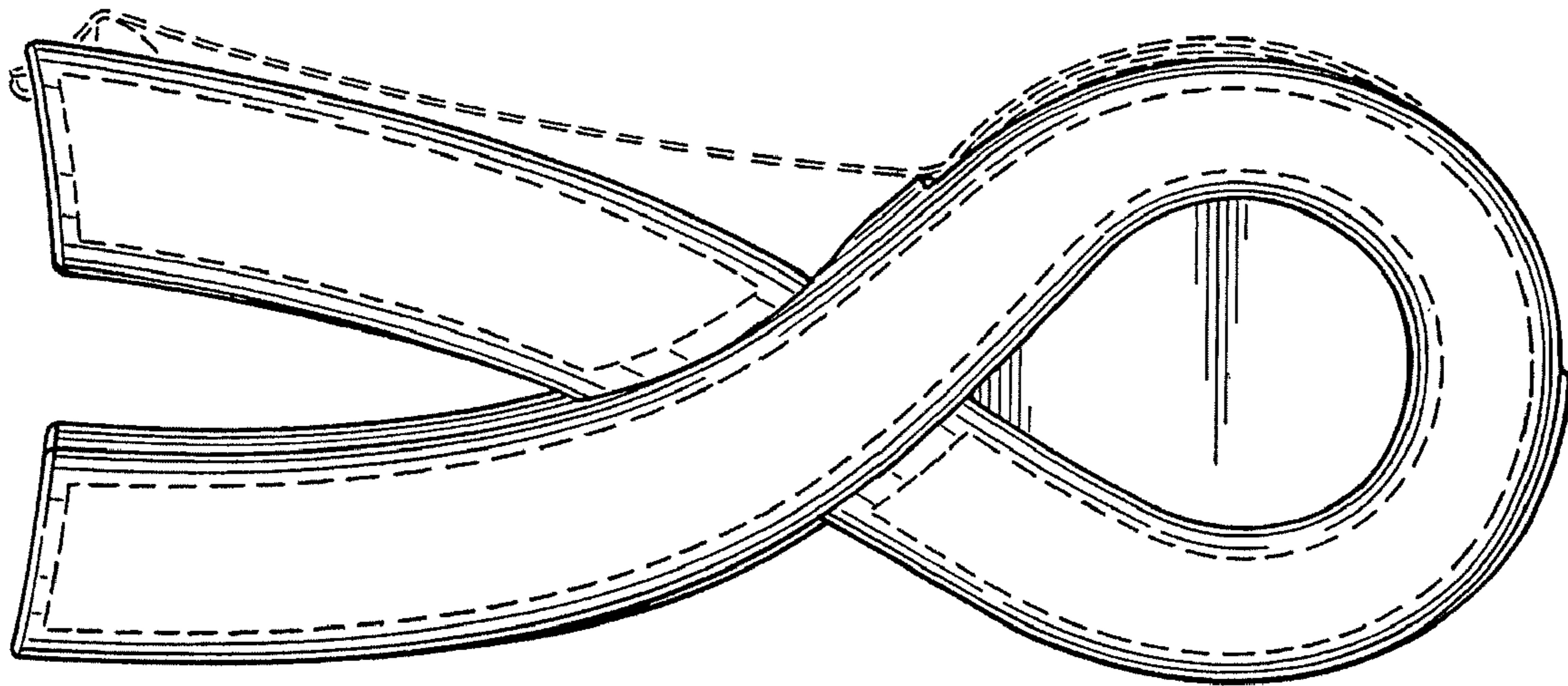

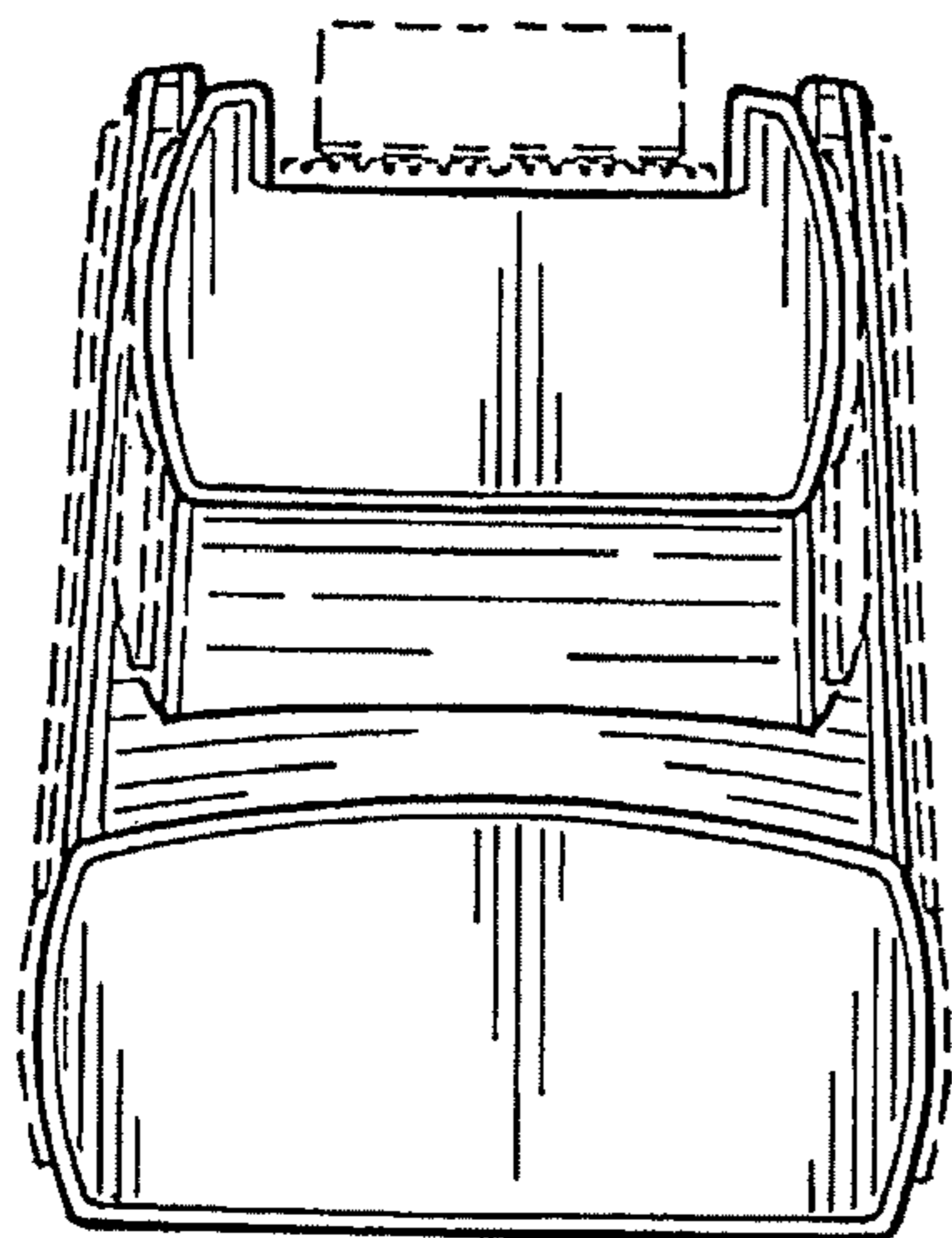

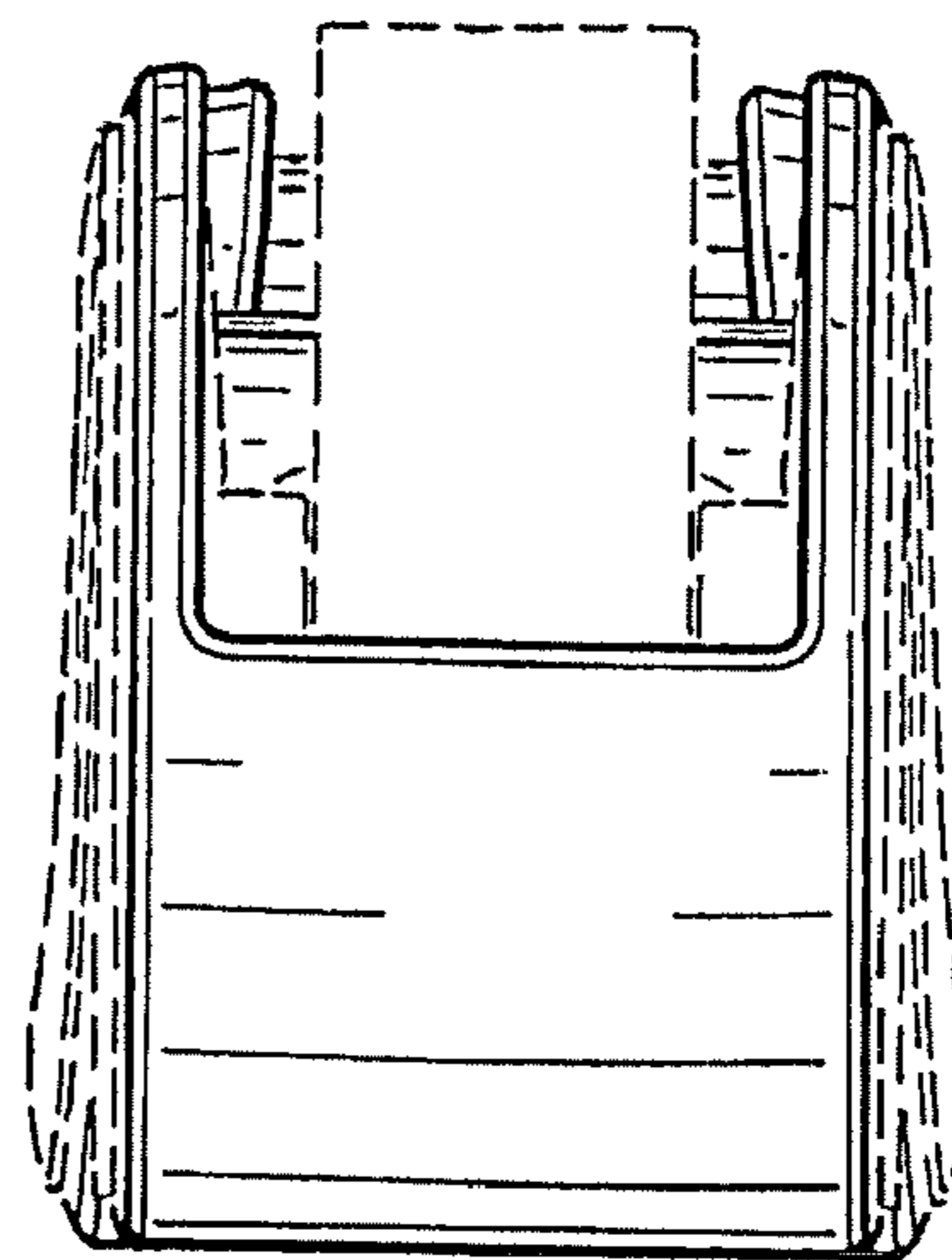

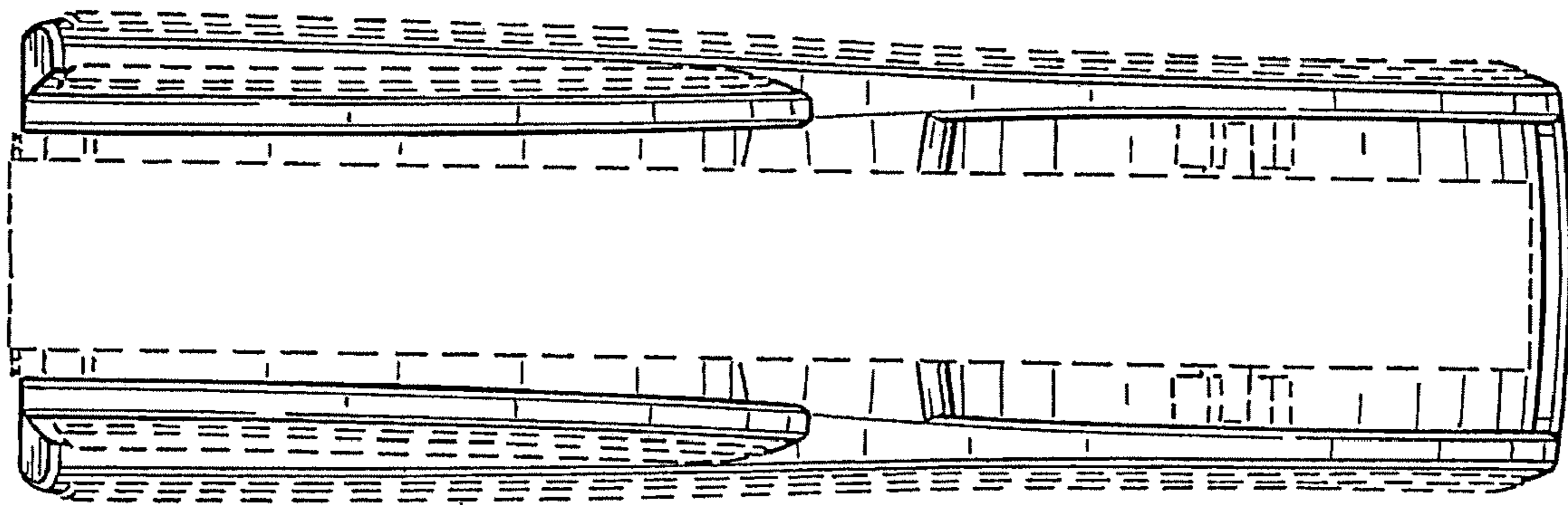

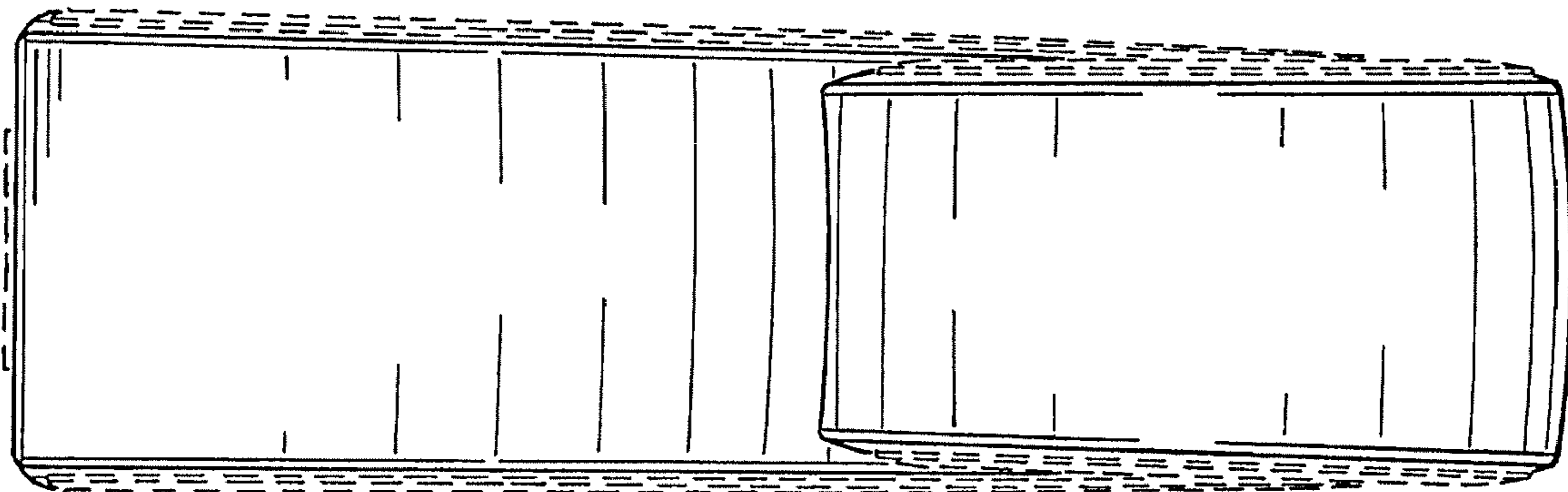
