FIG. 23 is a front view thereof;

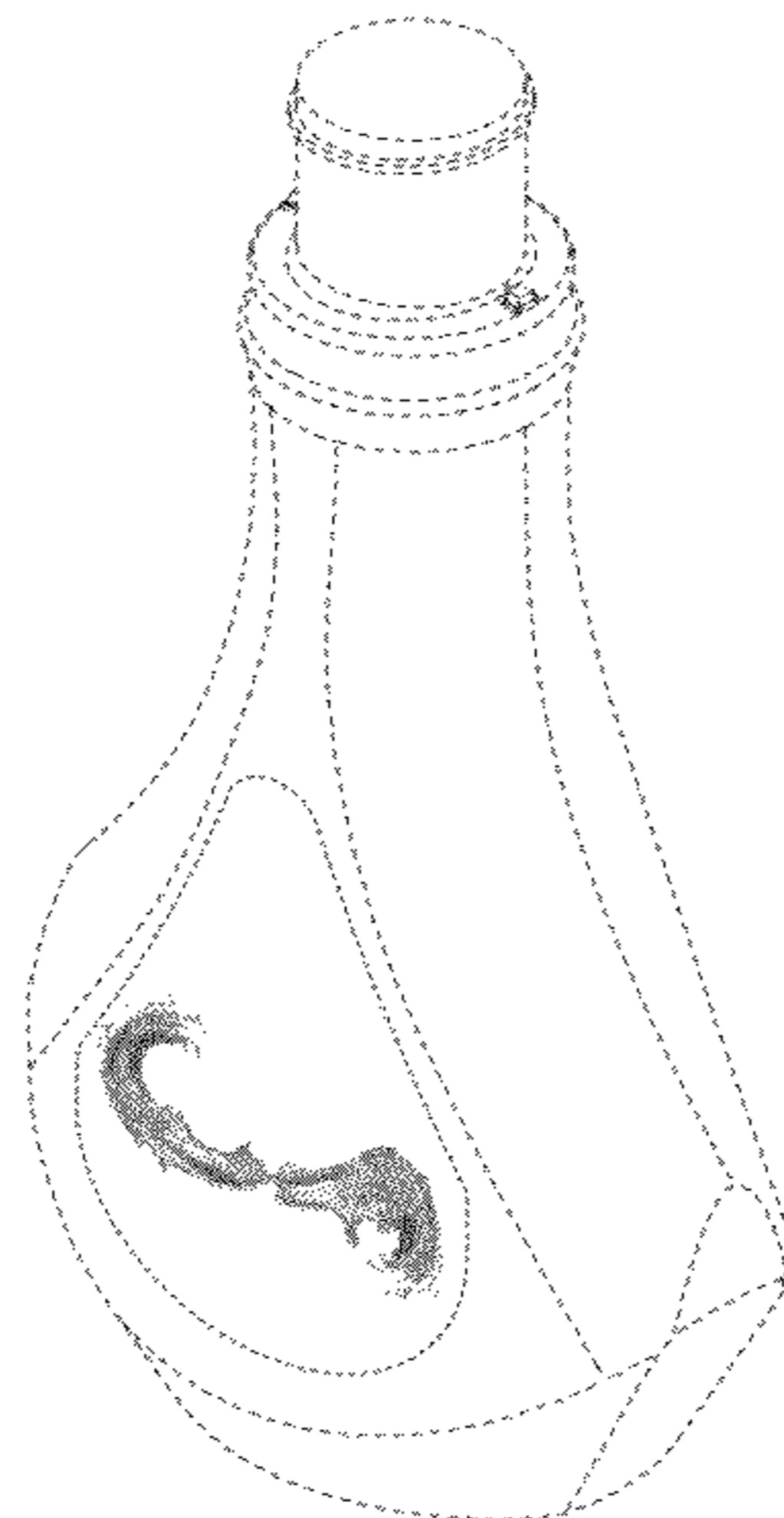
FIG. 24 is a back view thereof;

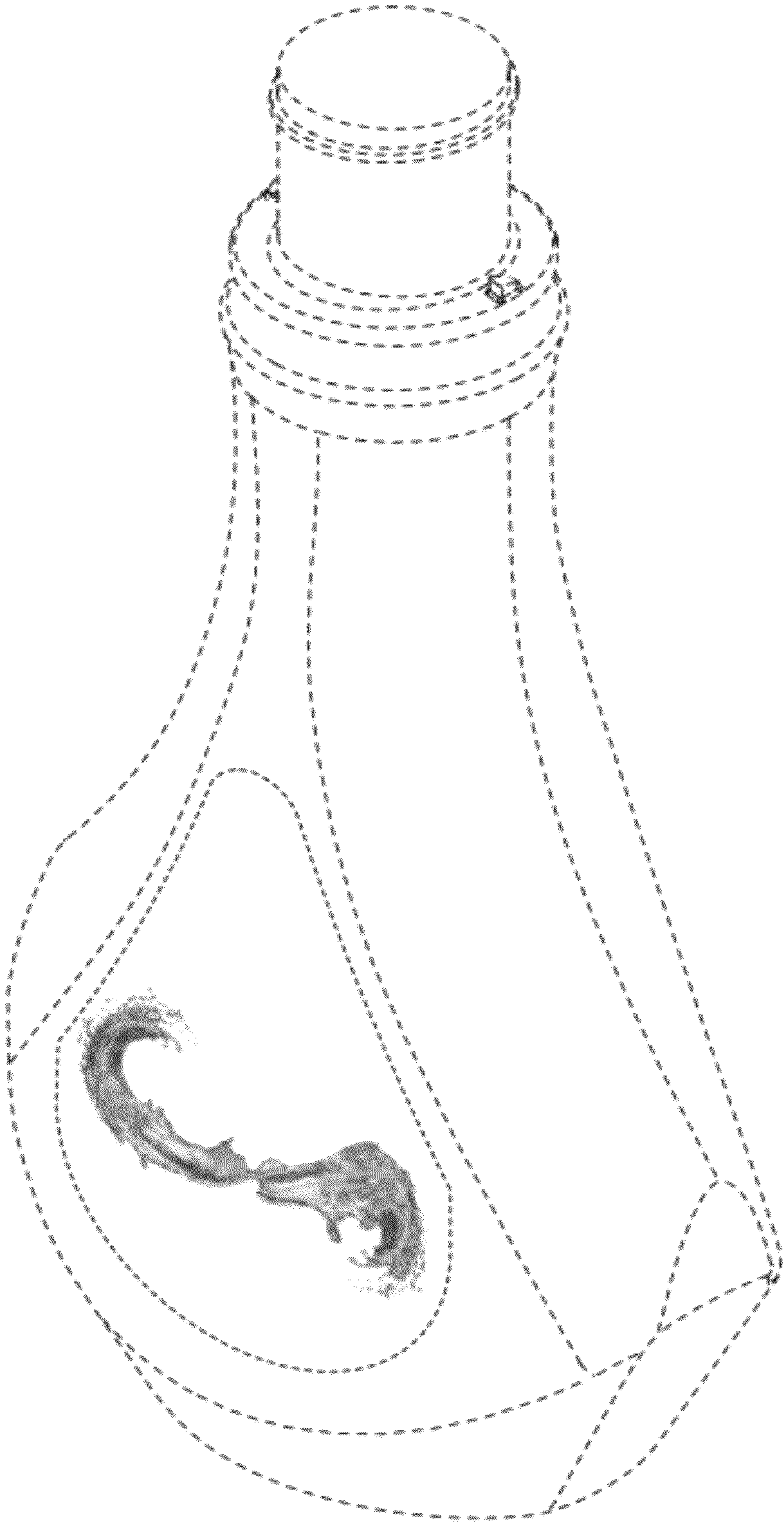

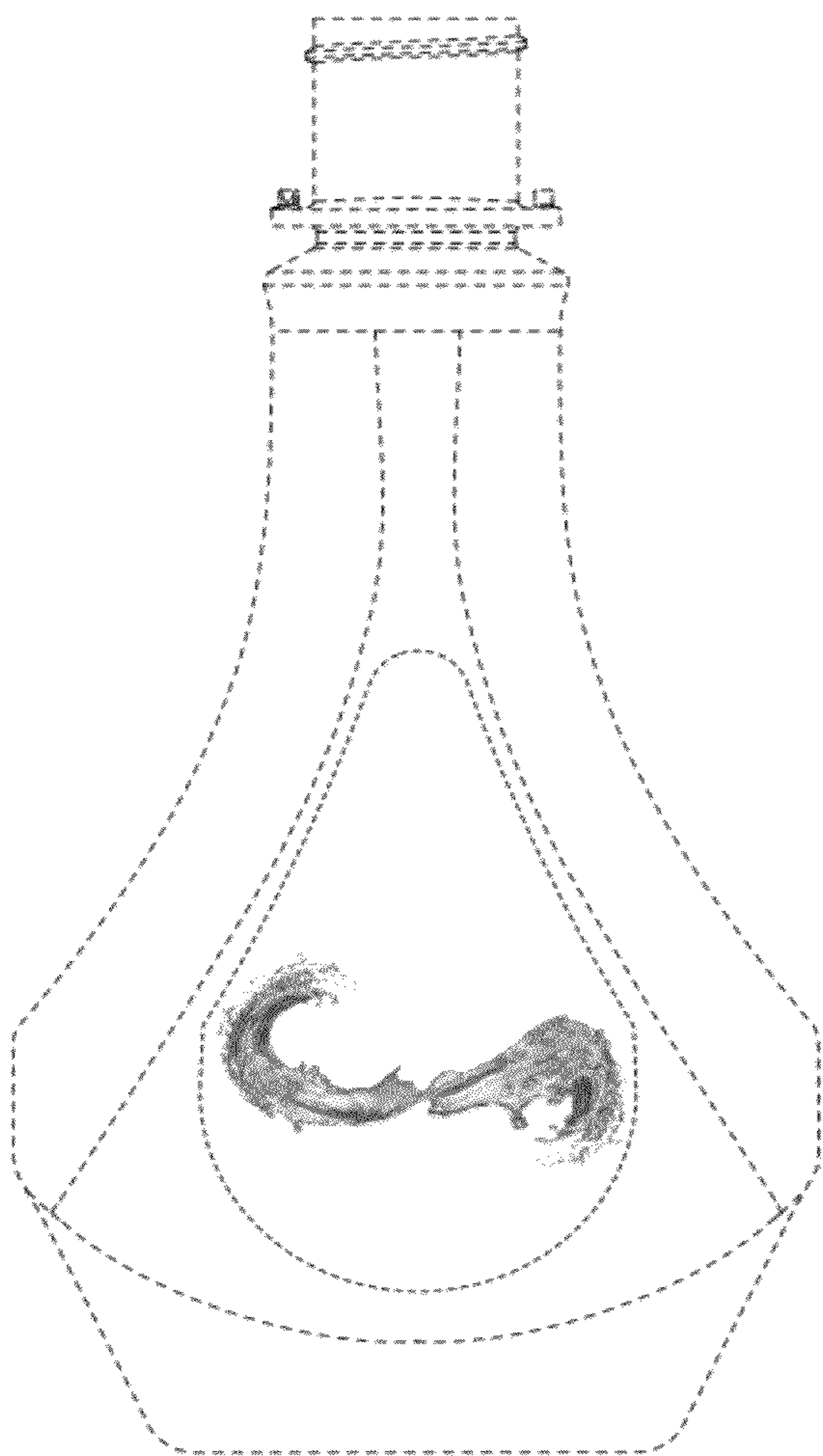

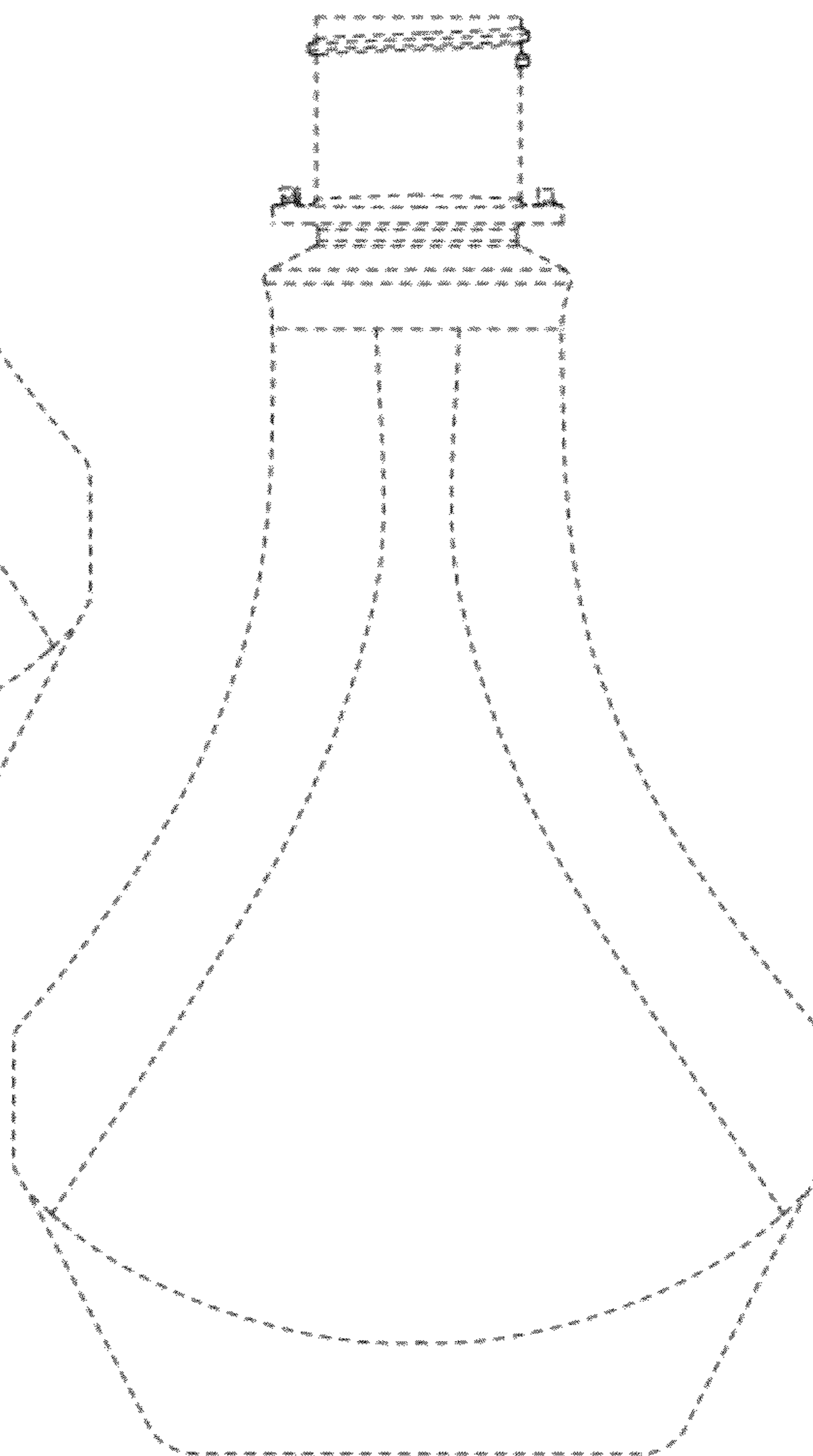

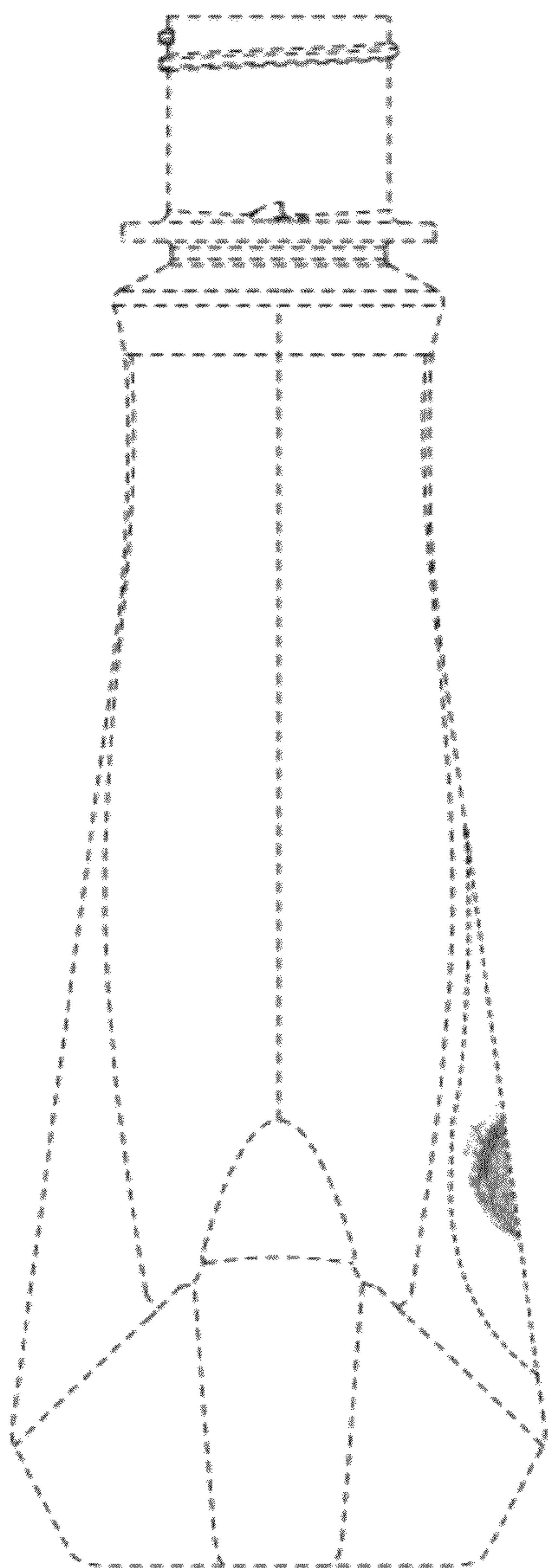

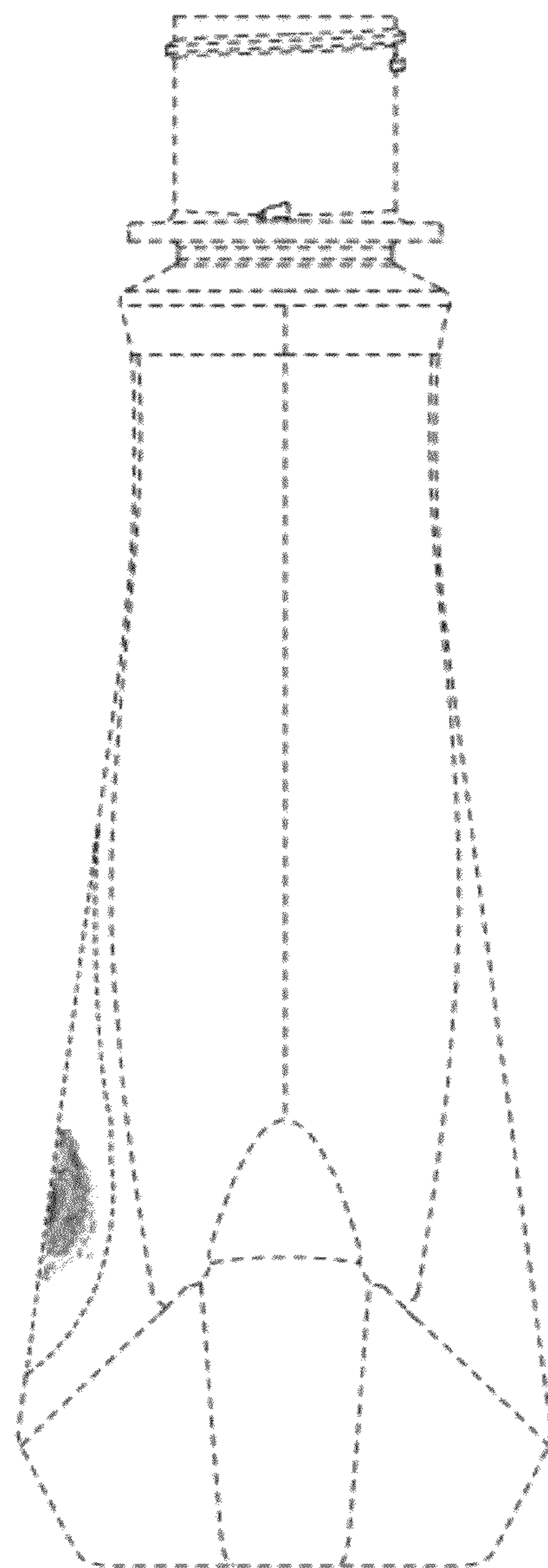

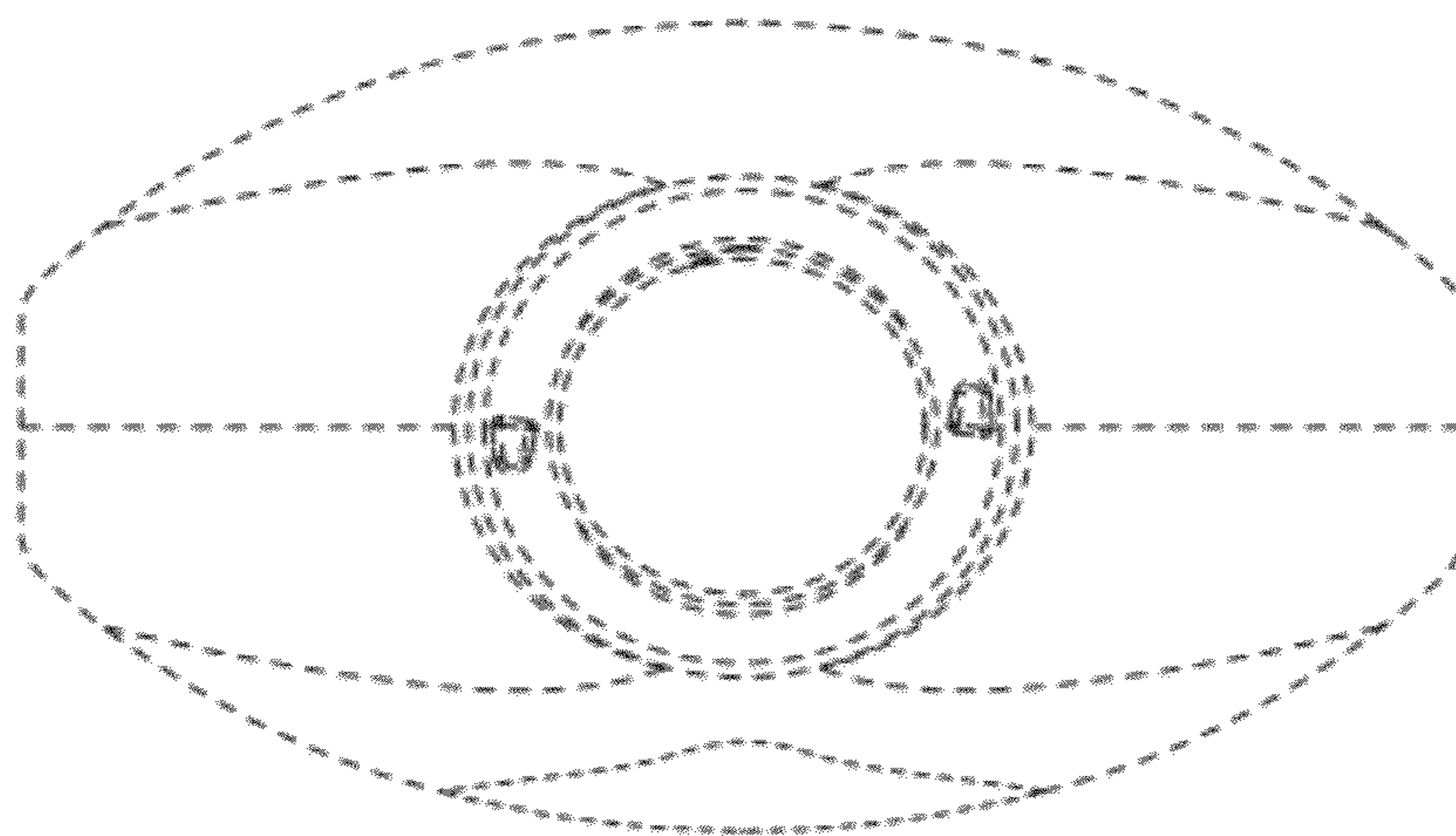

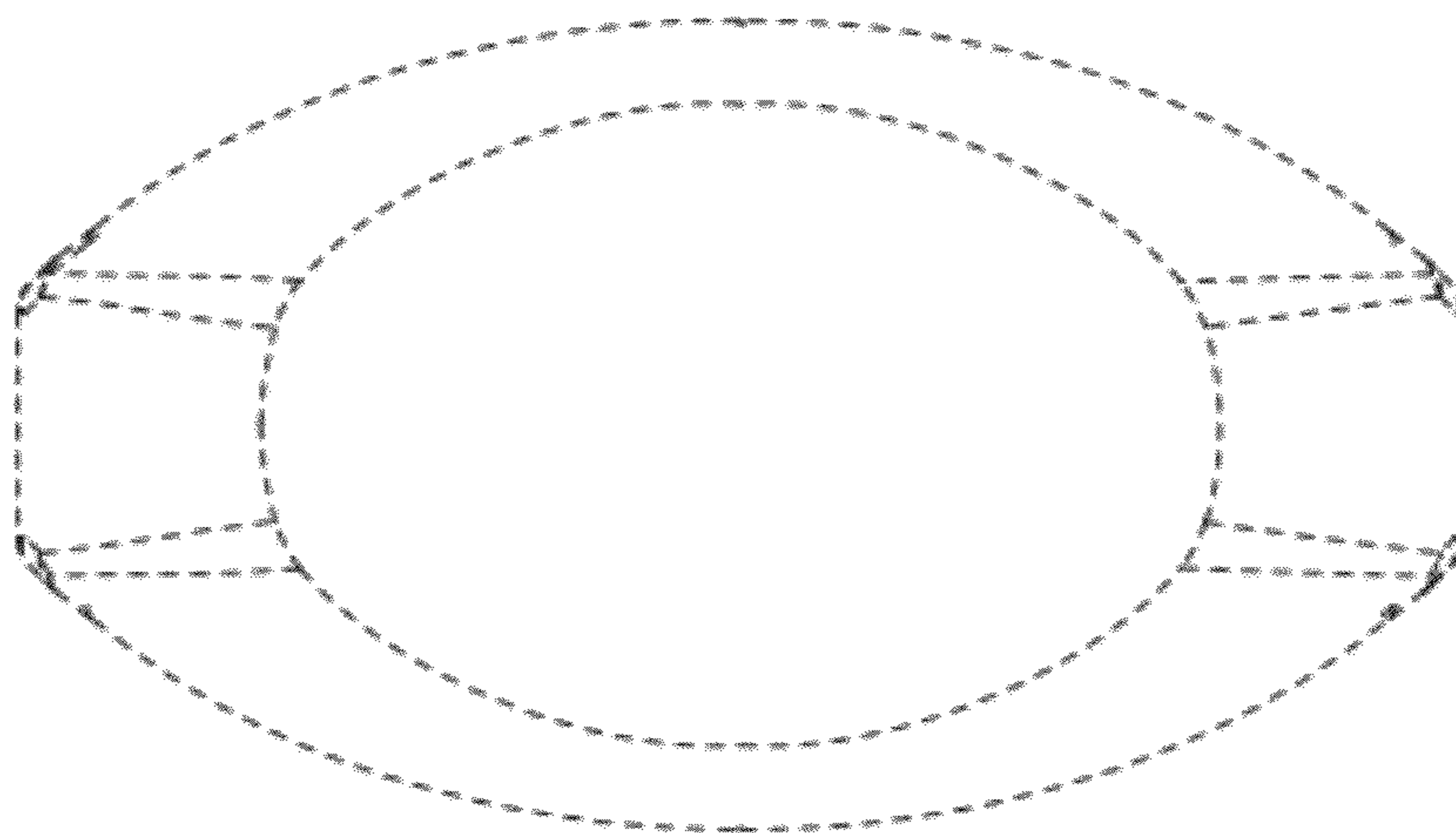

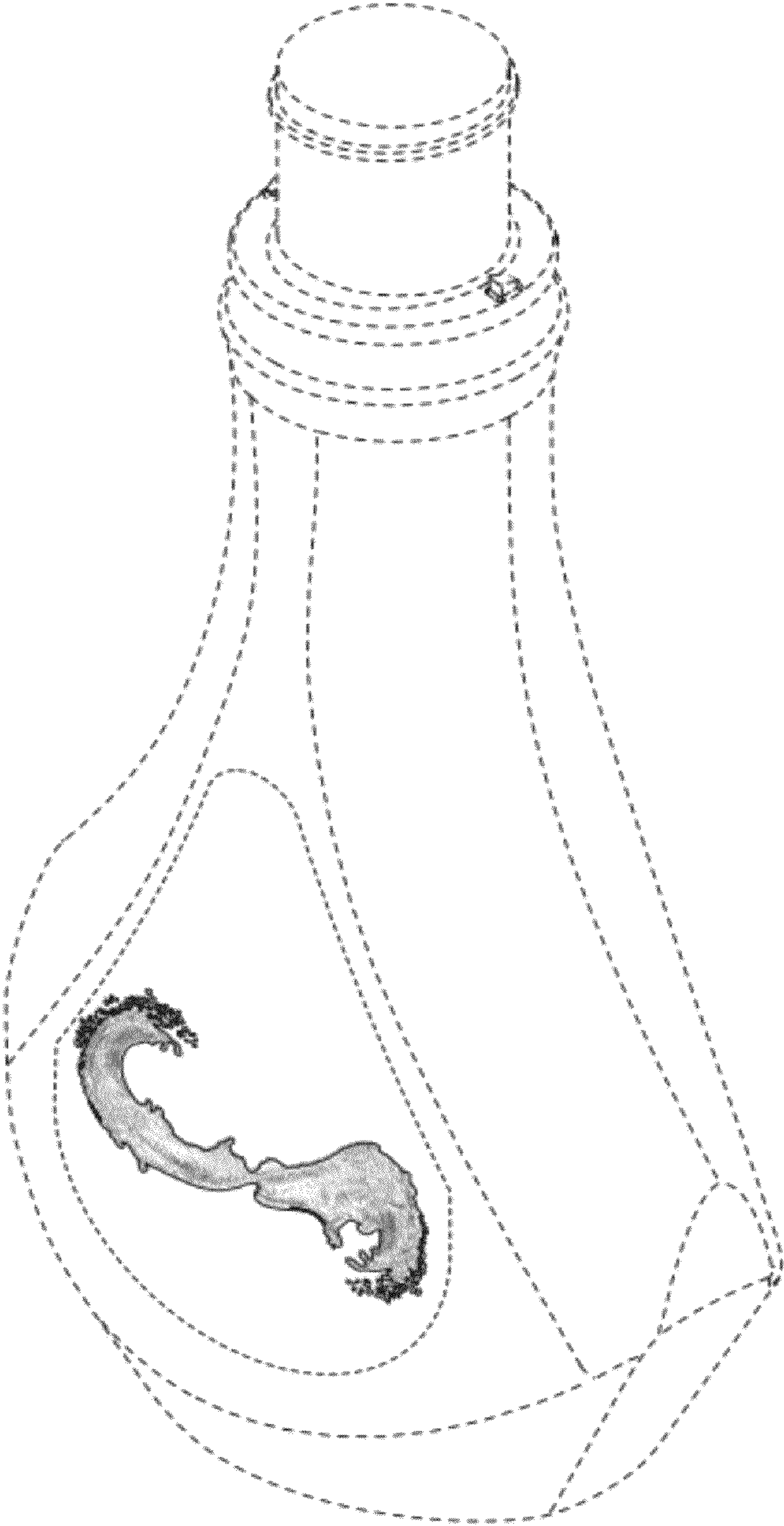

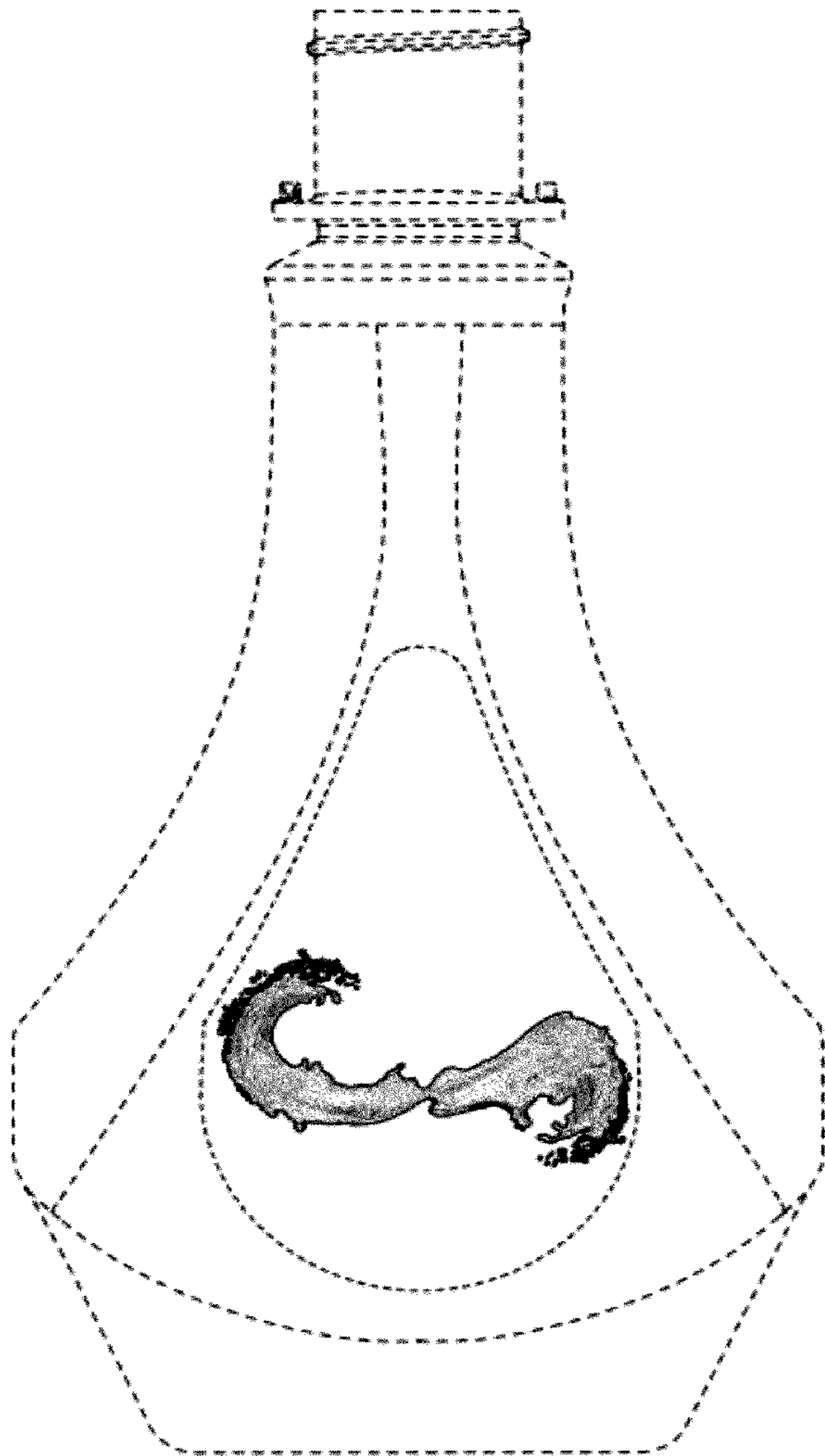

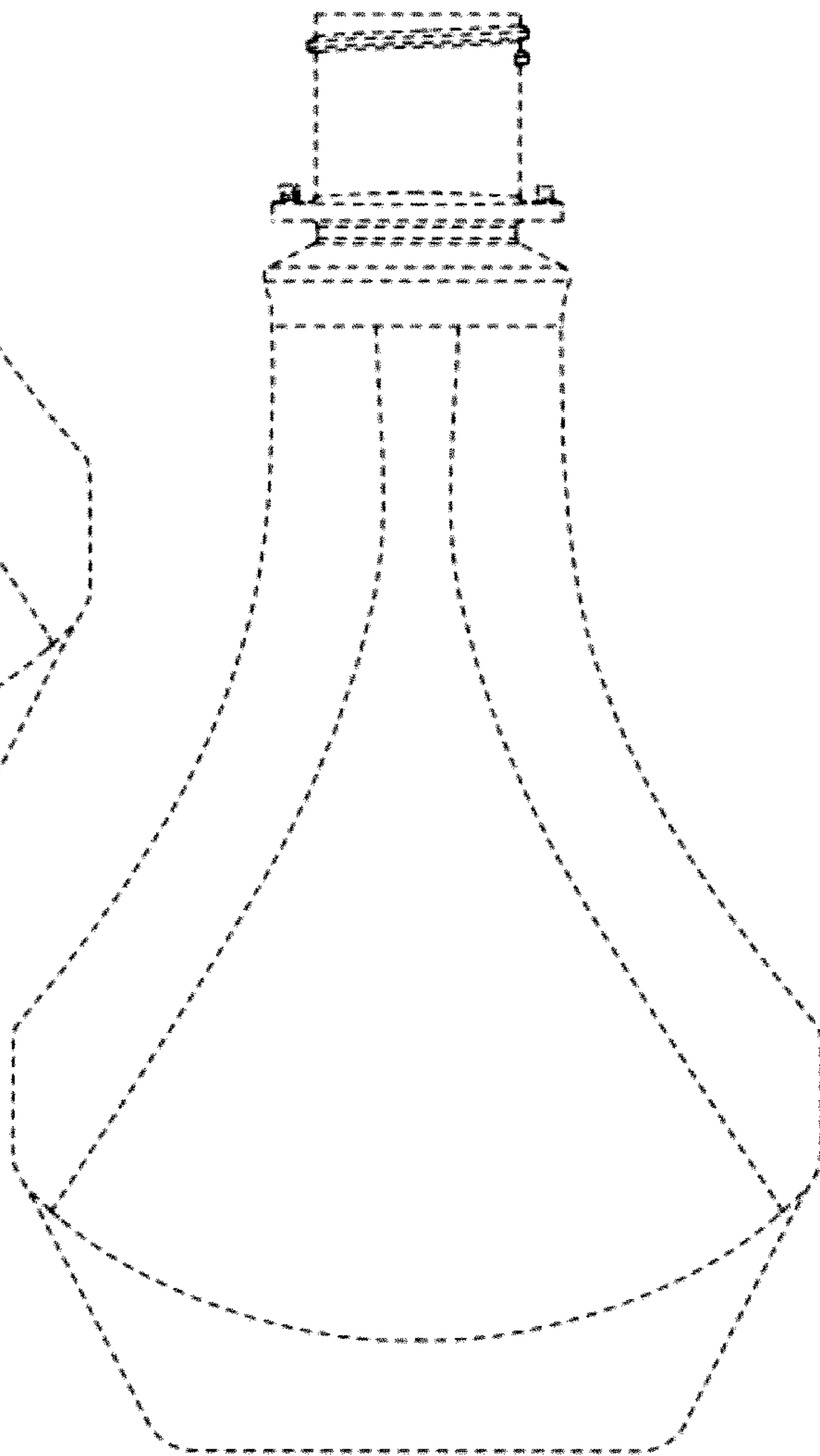

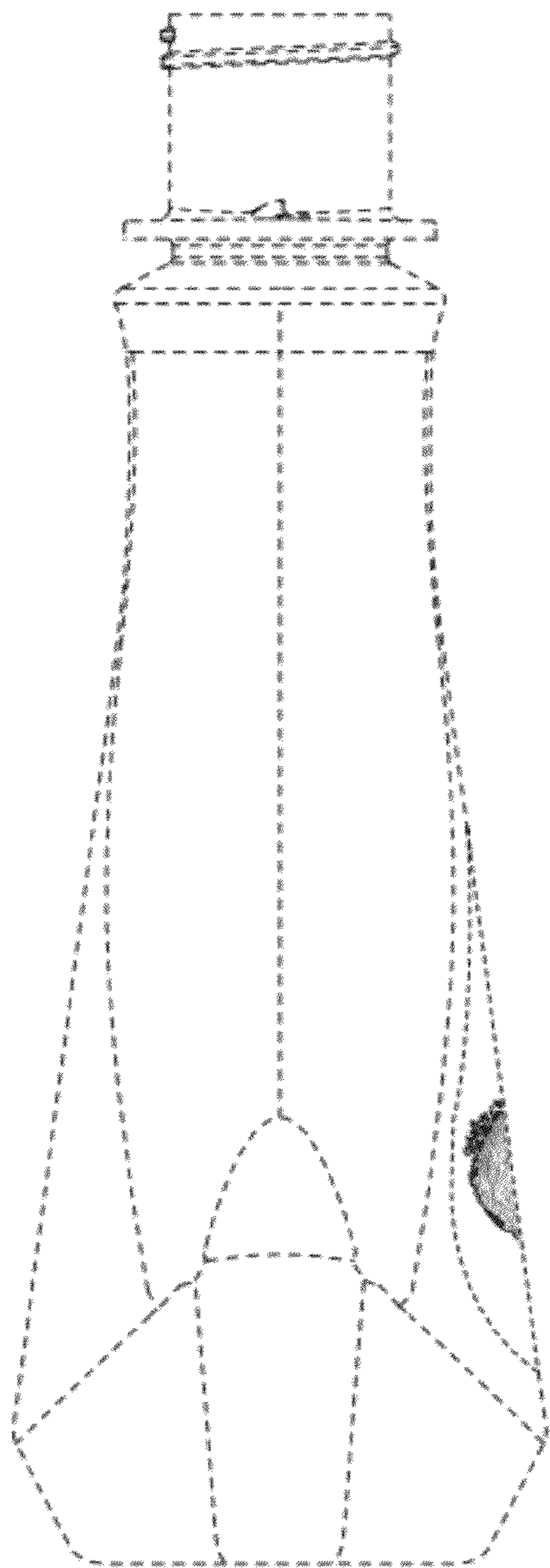

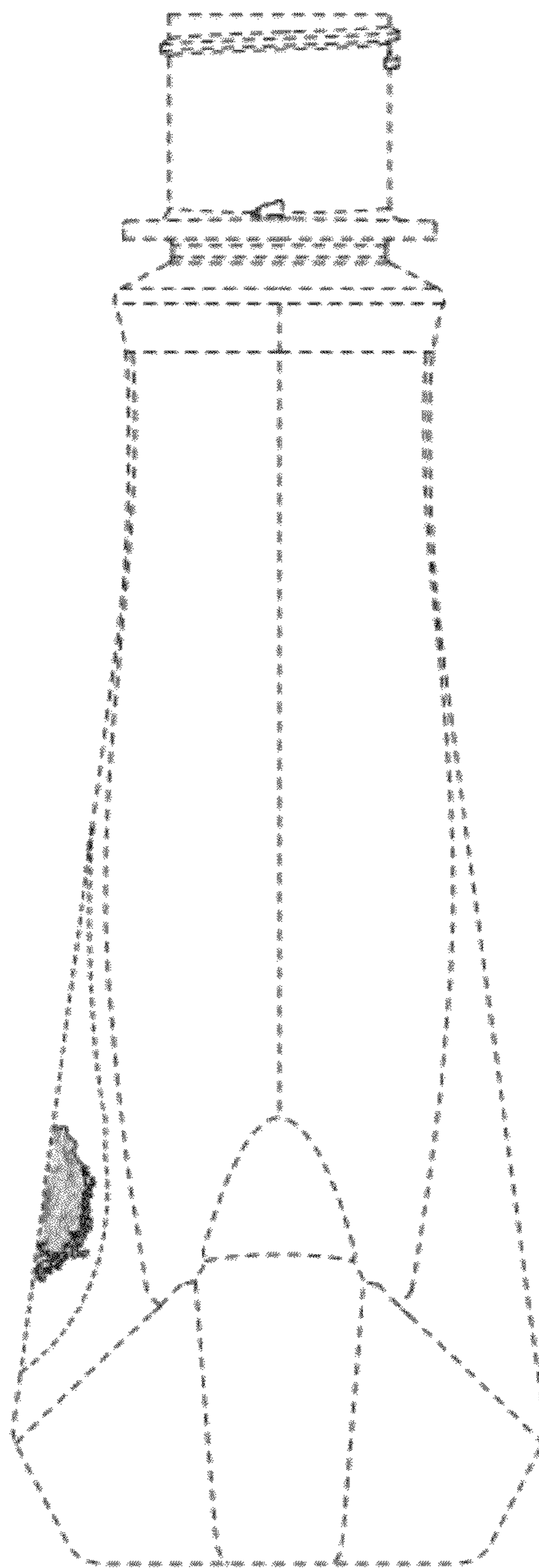

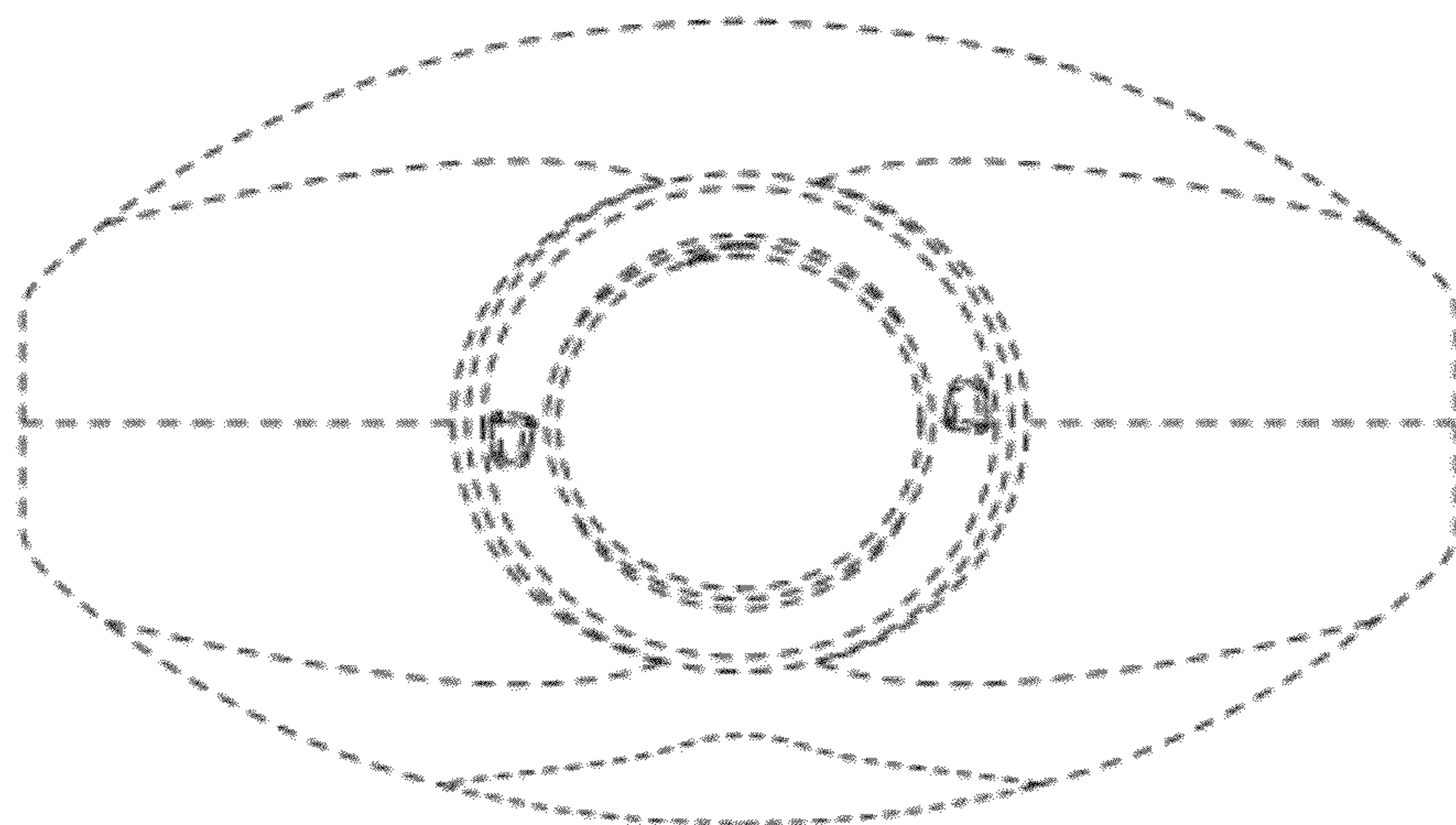

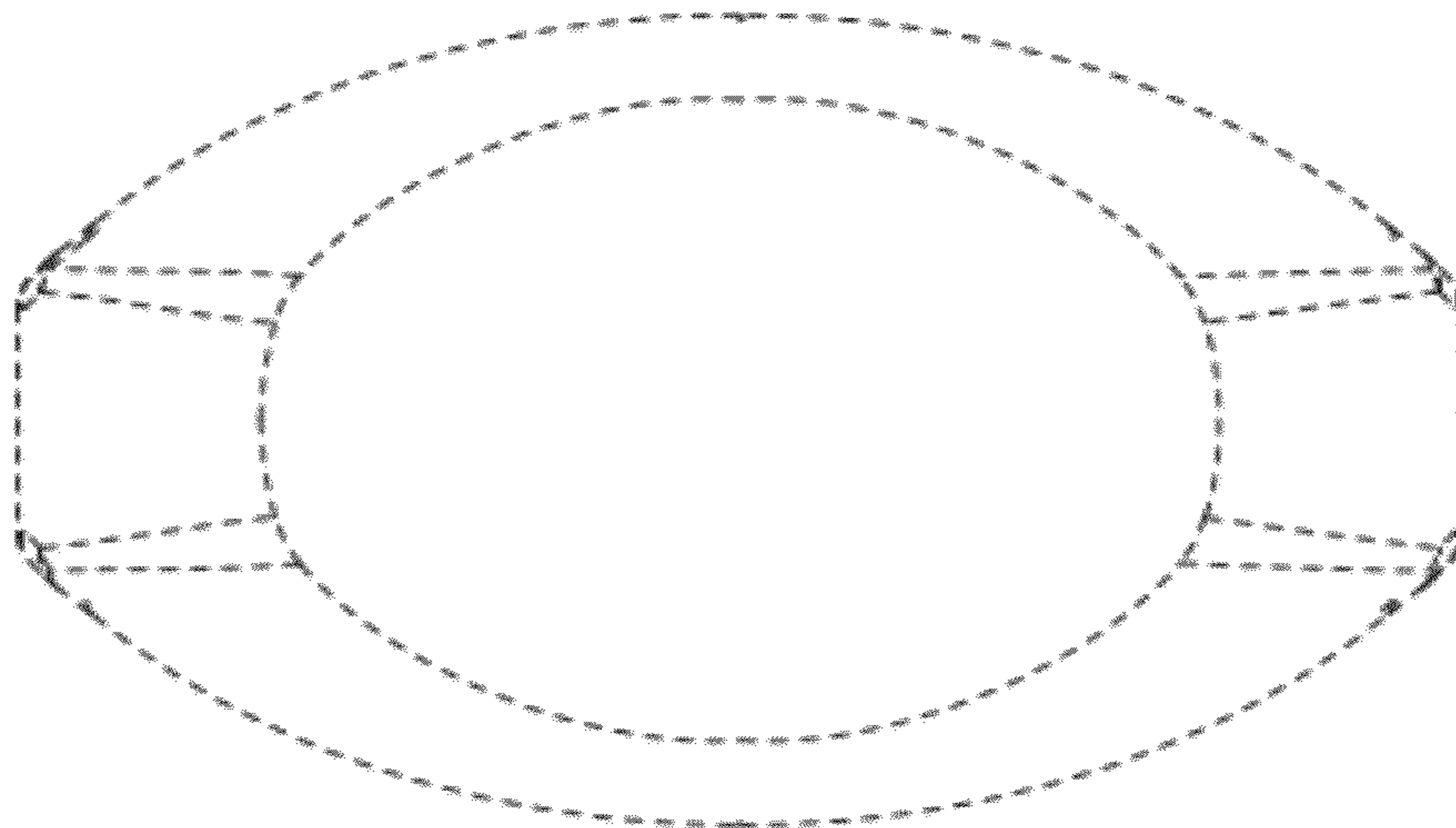

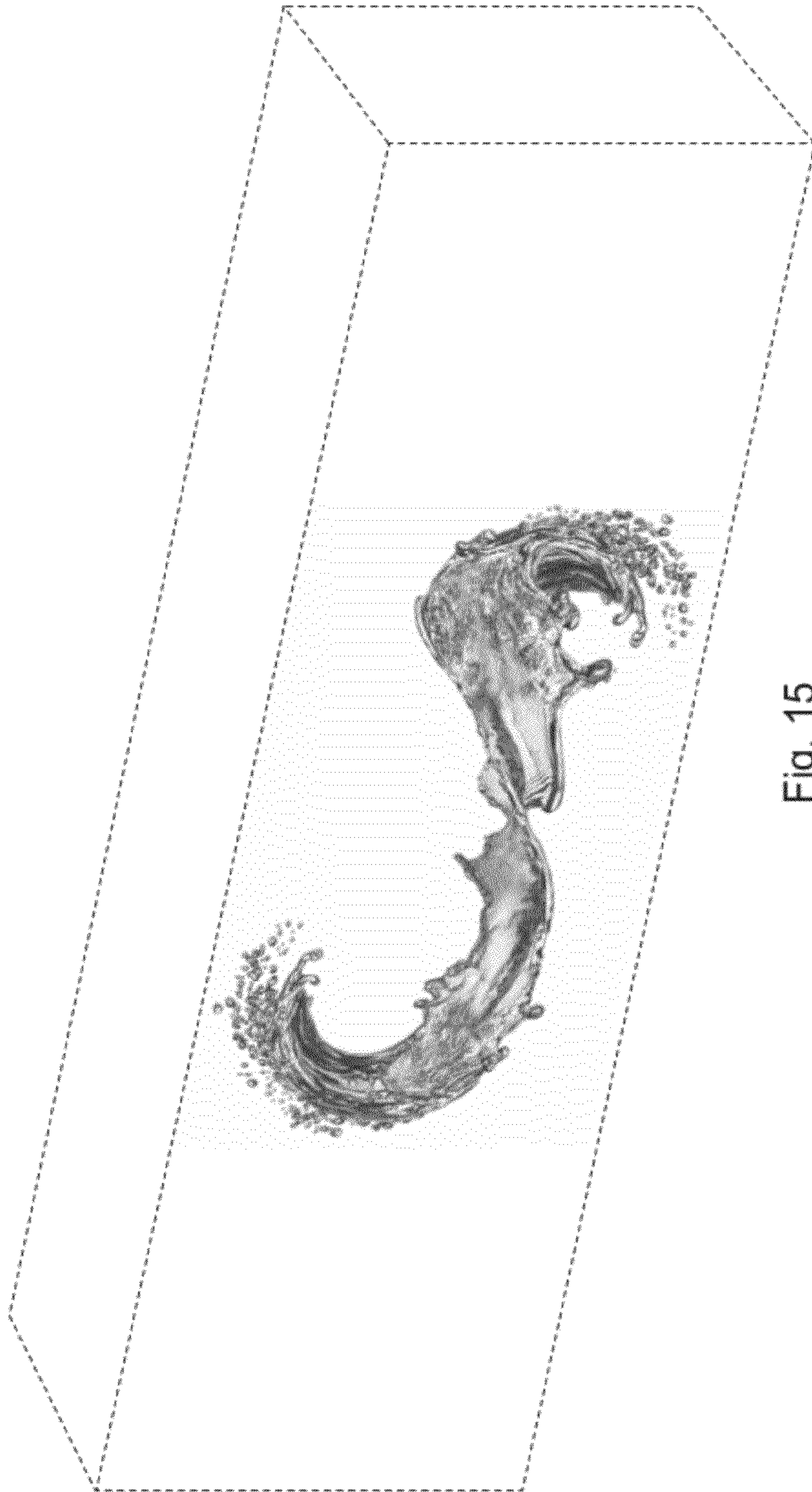

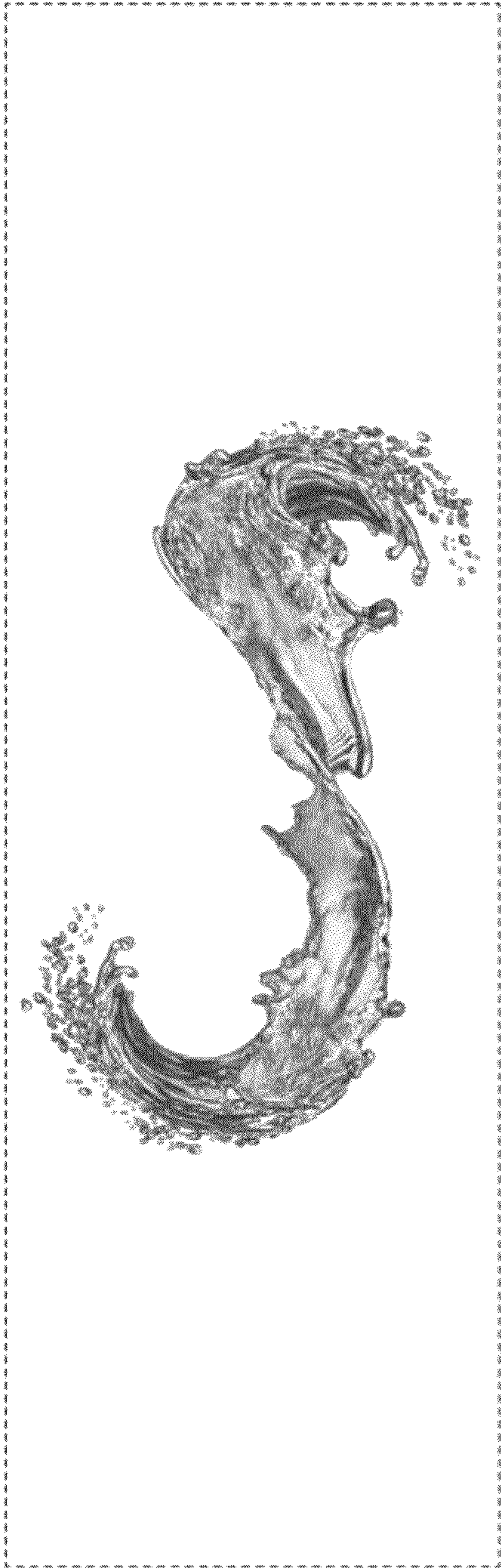

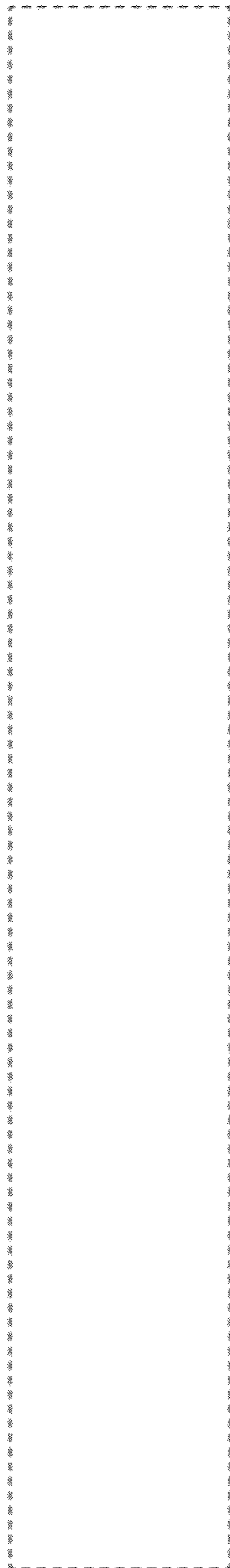

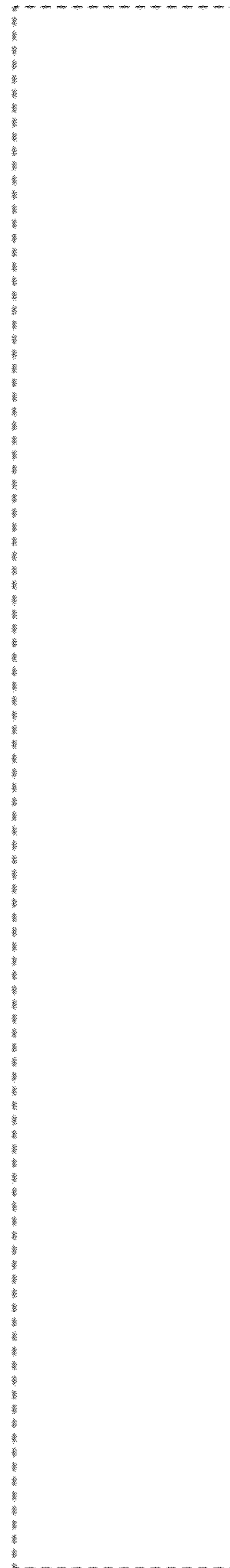

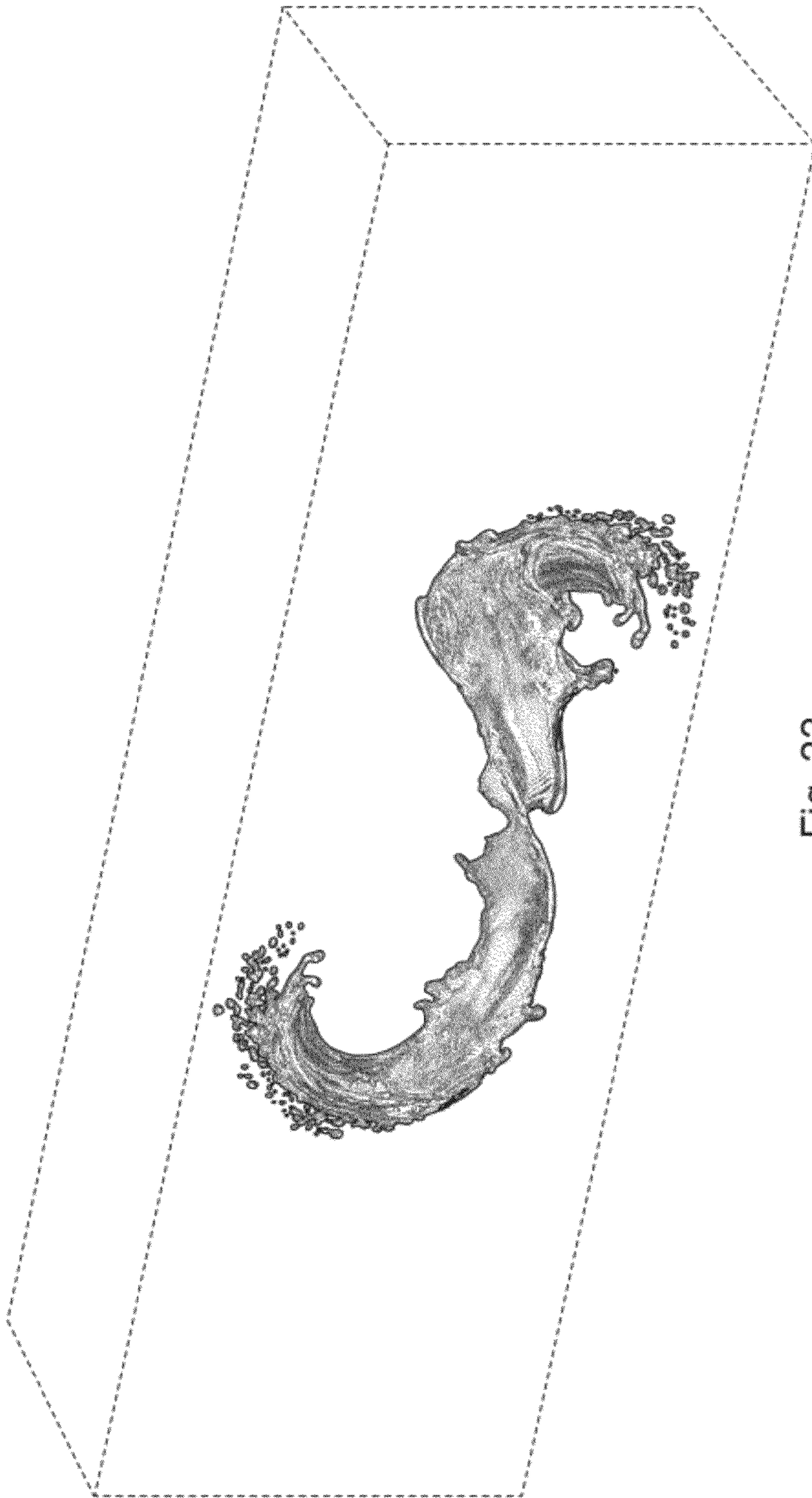

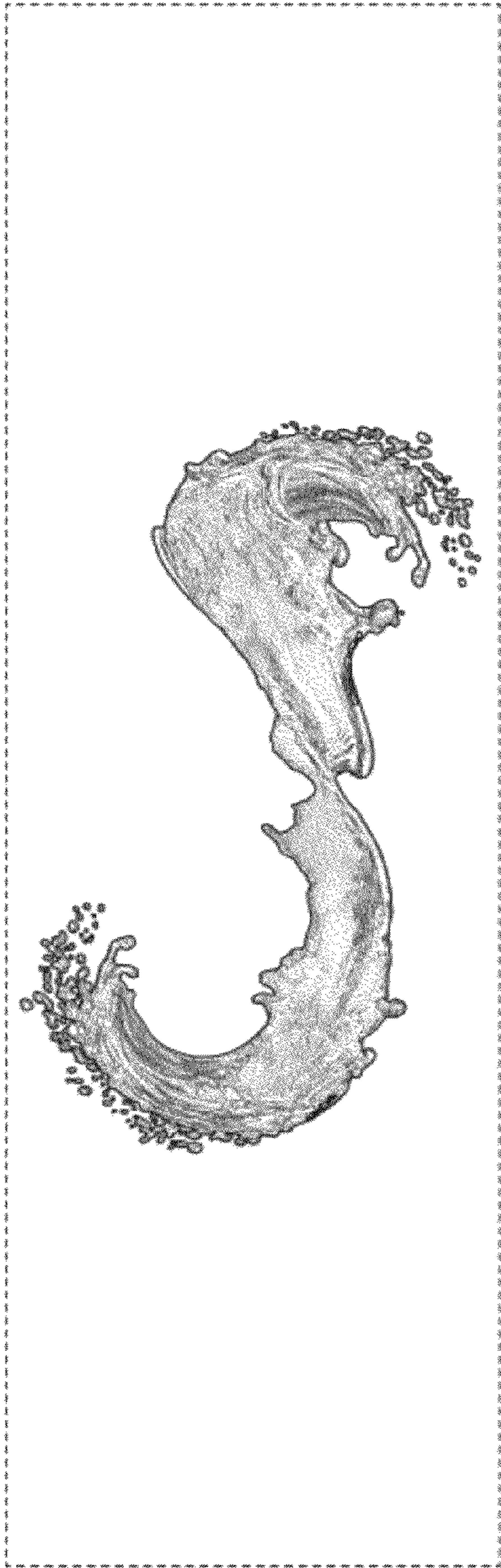

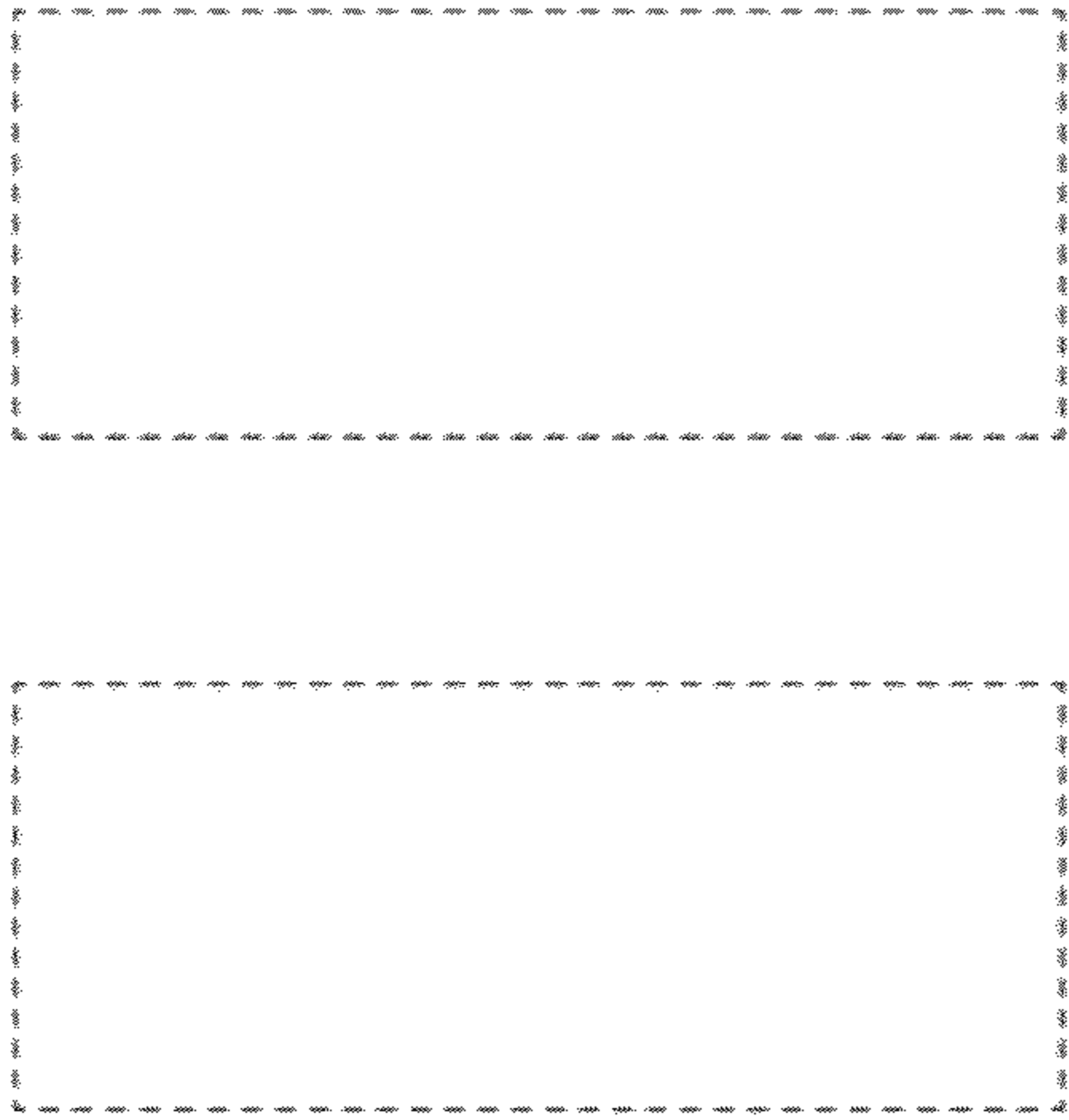

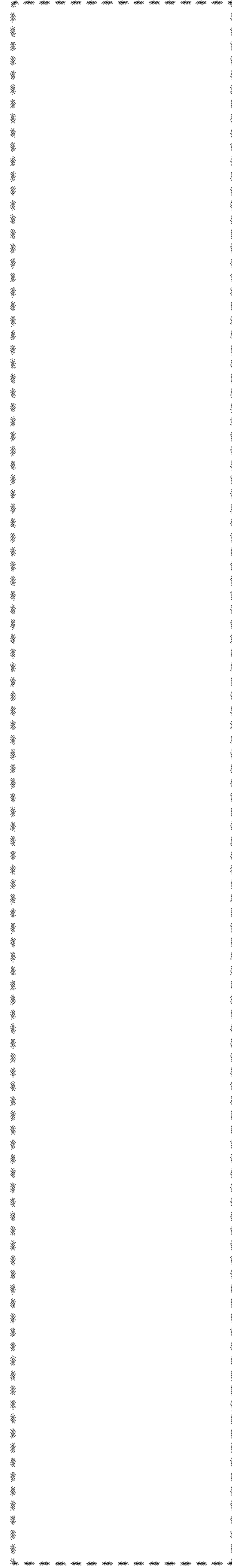

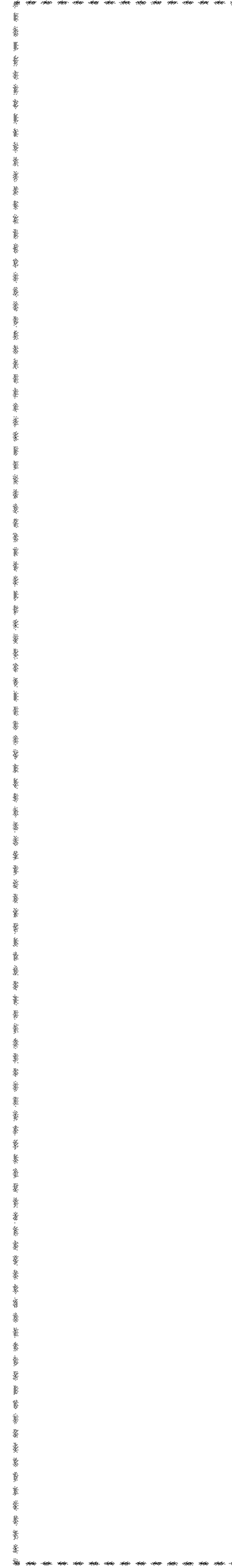
