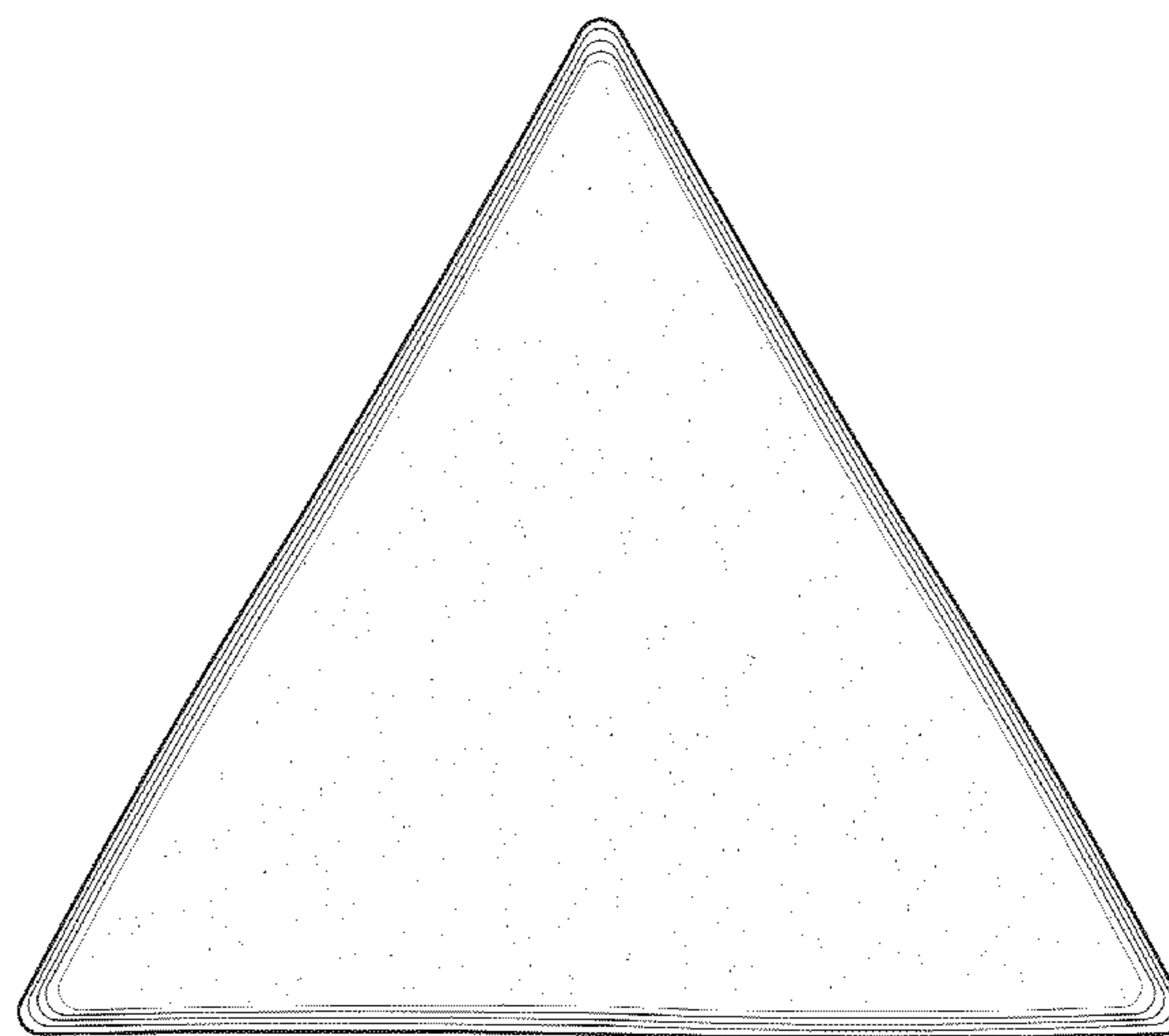
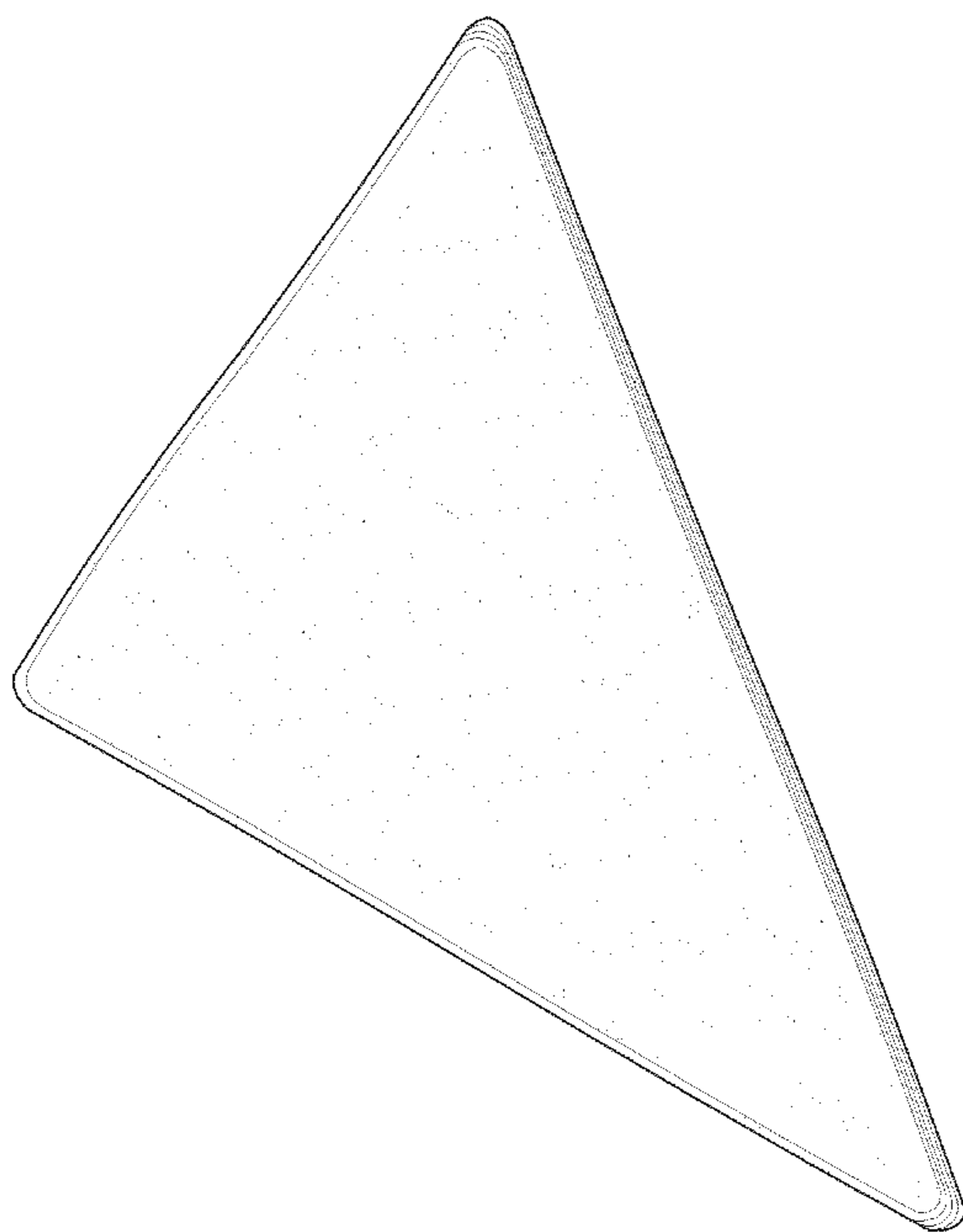
(57) **CLAIM**

The ornamental design for a triangular-shaped feminine wipe, as shown and described.

DESCRIPTION

FIG 1 is a perspective view of a triangular-shaped feminine wipe showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a side view (opposite side view is mirror image) thereof;
FIG. 5 is an opposite side view of FIG. 4, wherein the layers are partly separated thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a back view thereof.

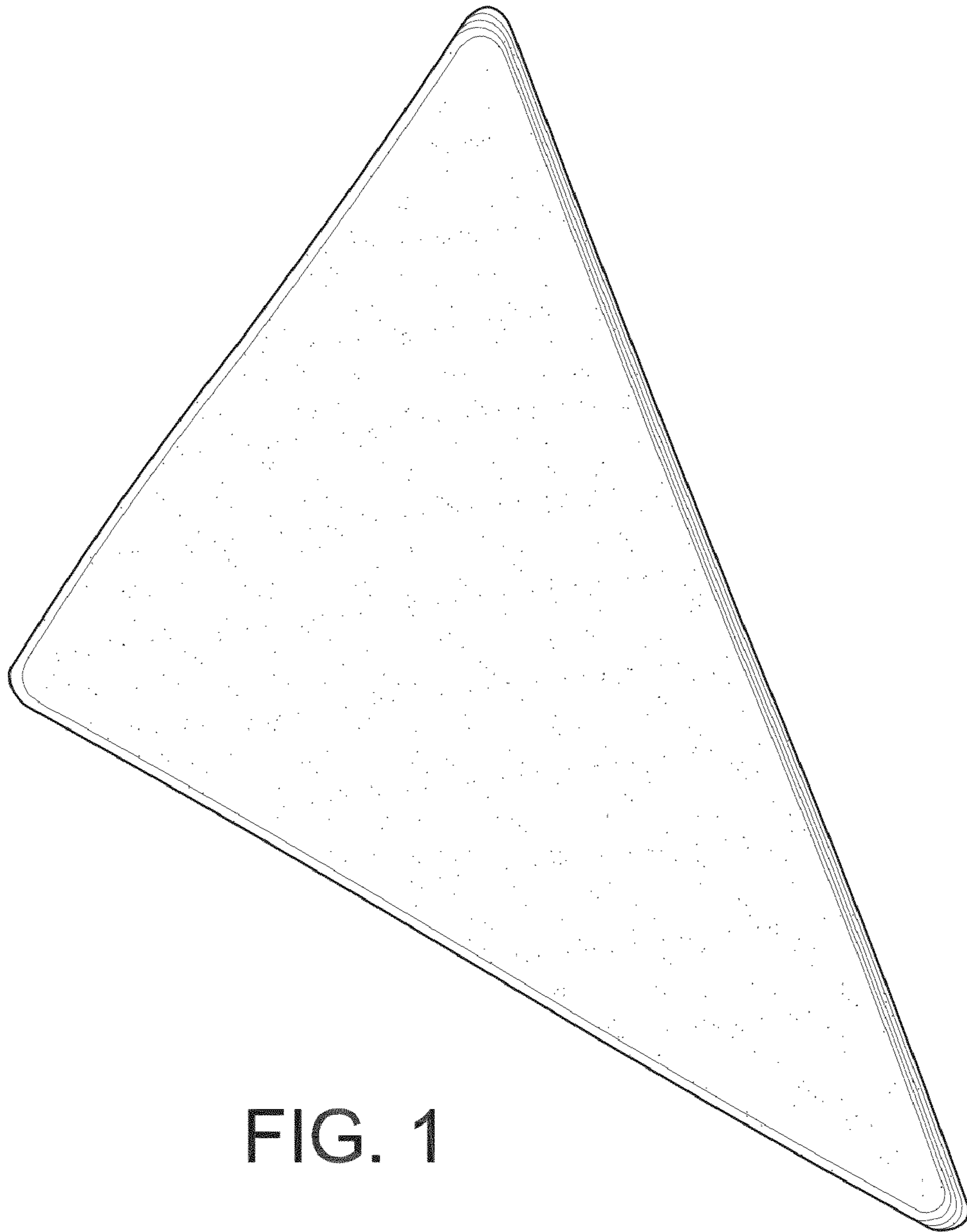

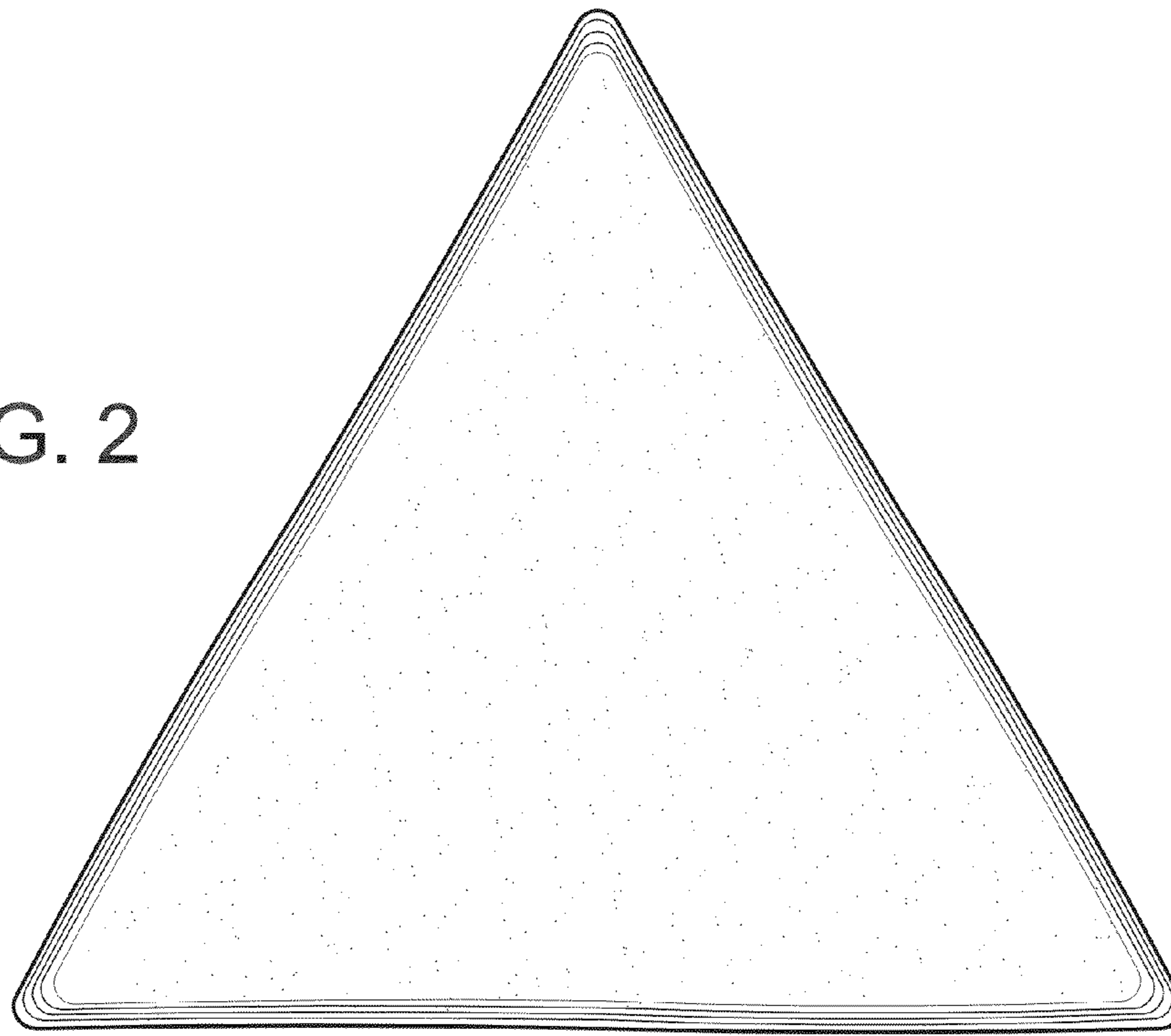

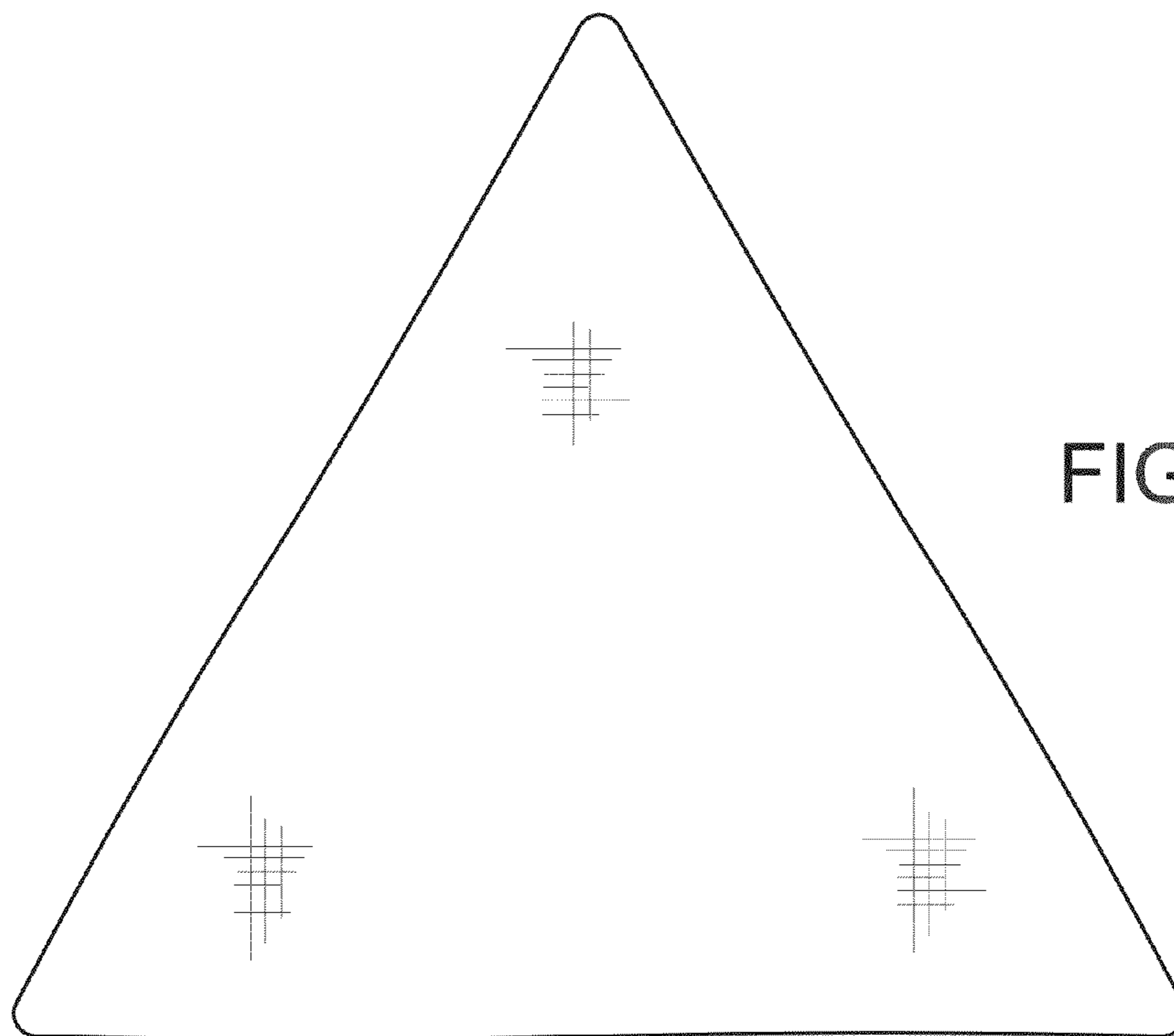

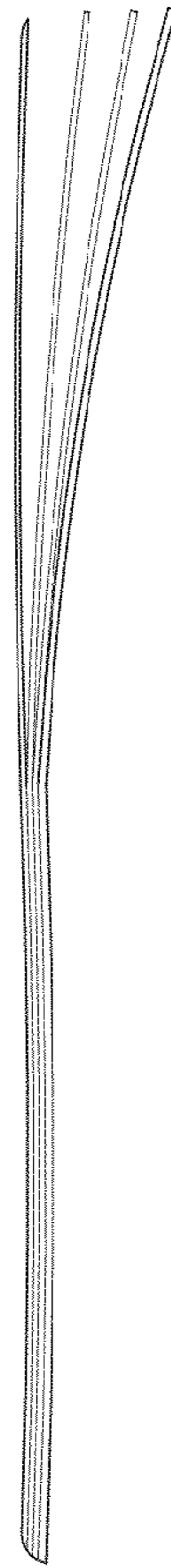

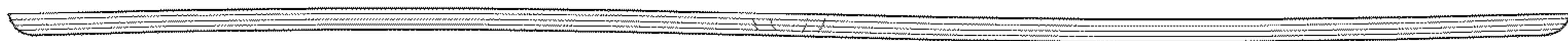

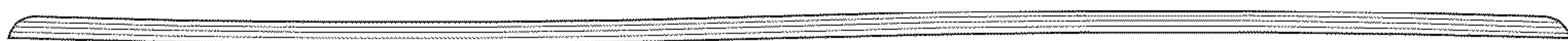
