**DESCRIPTION**

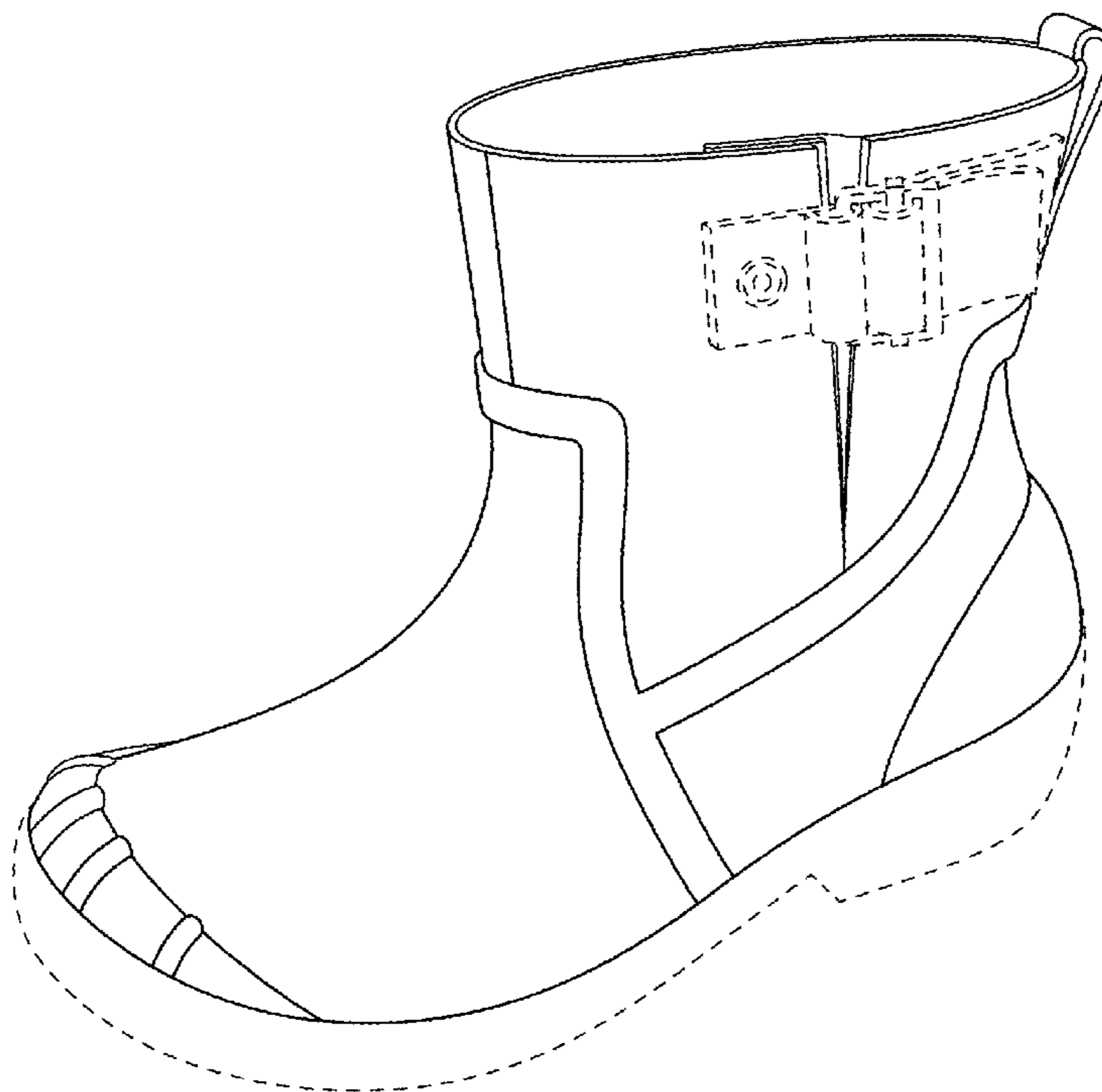

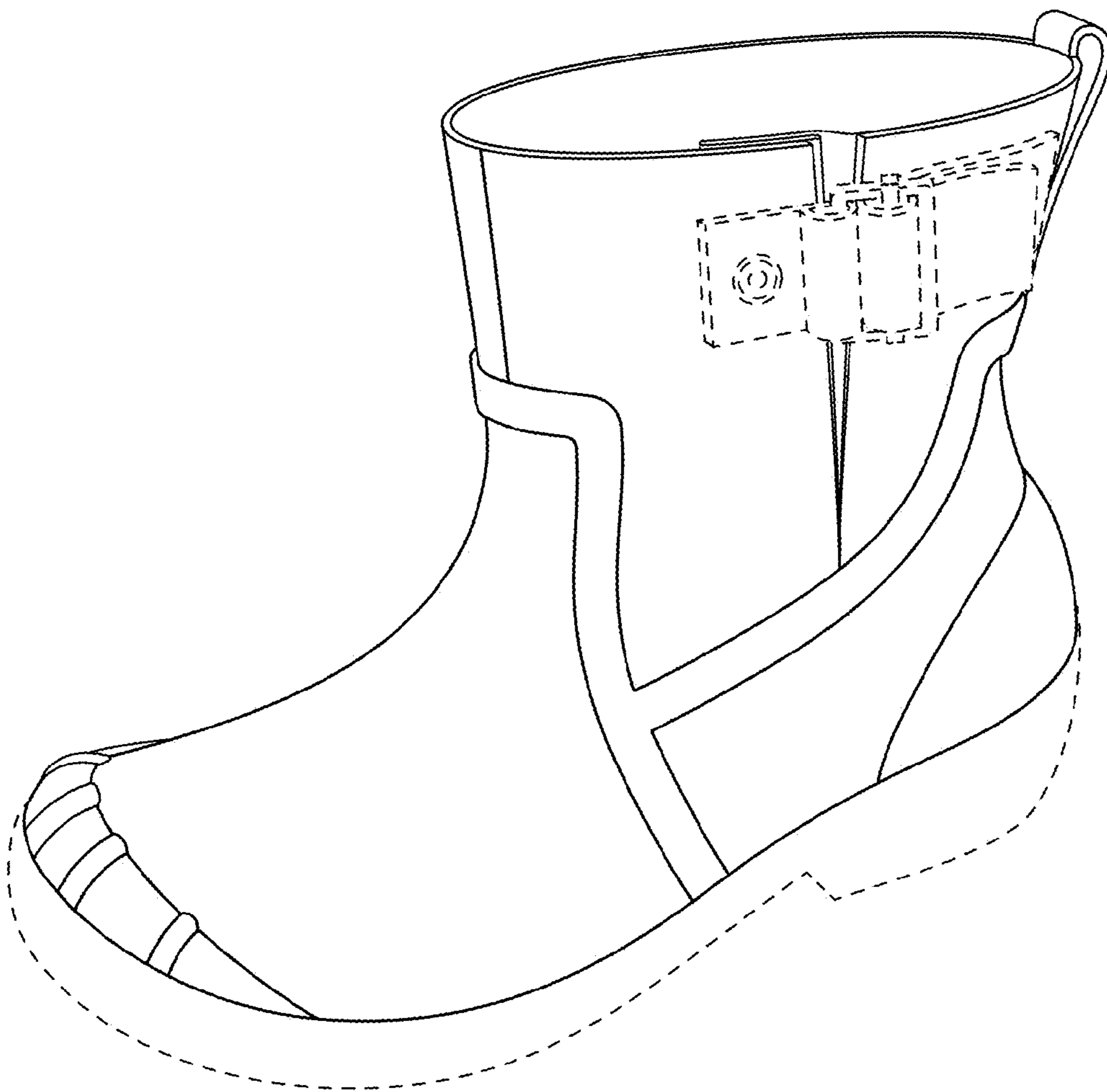

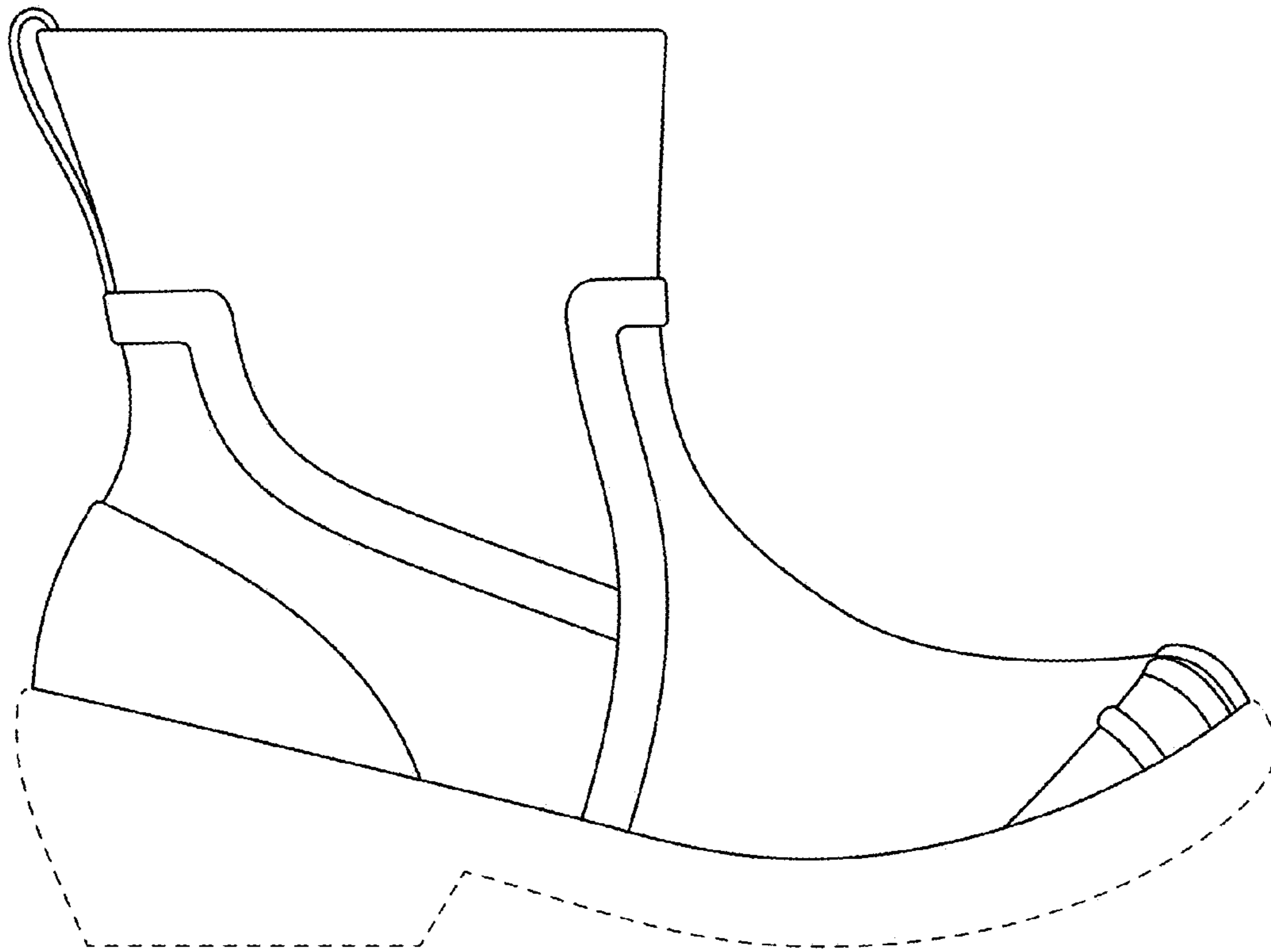
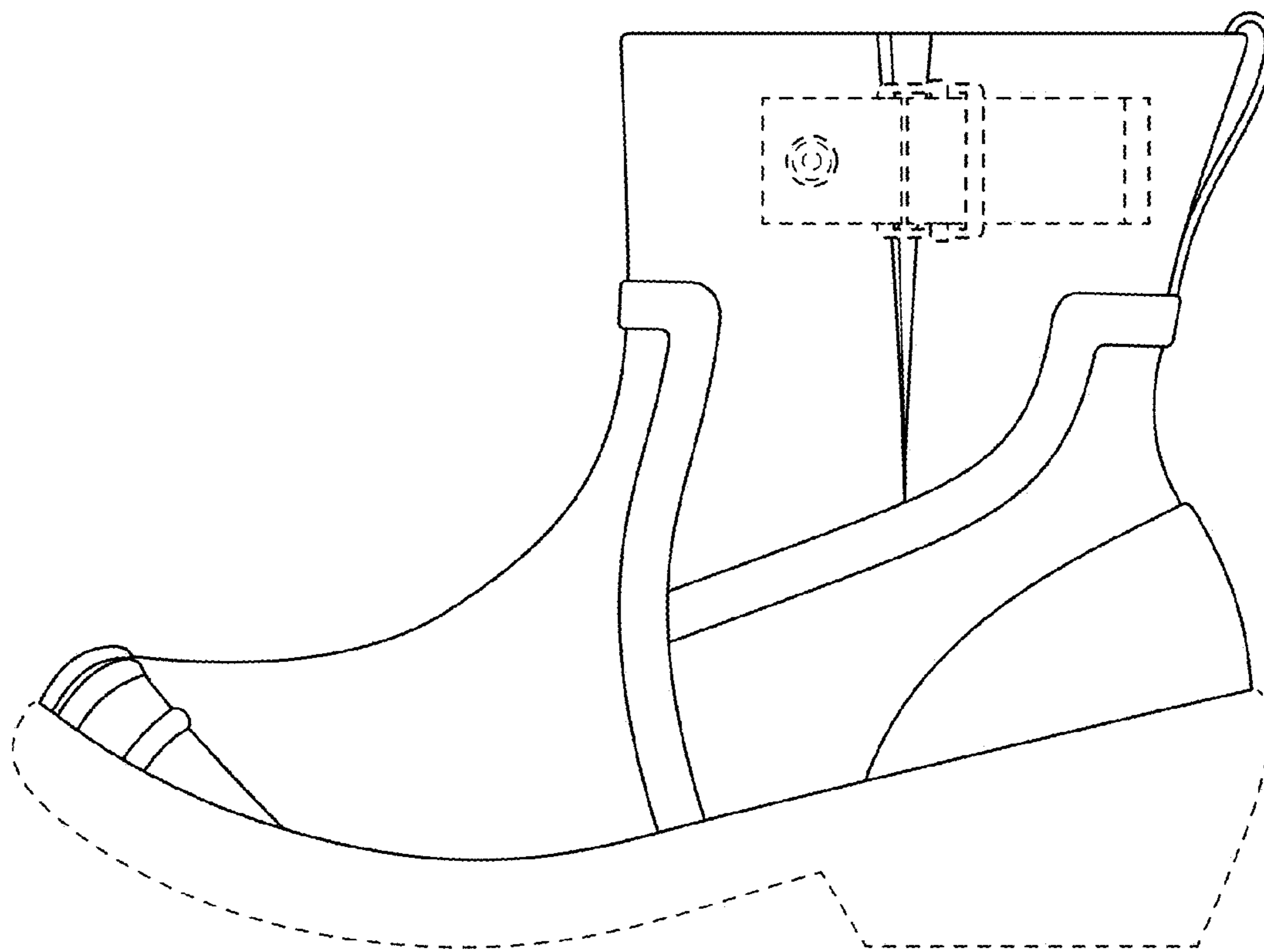

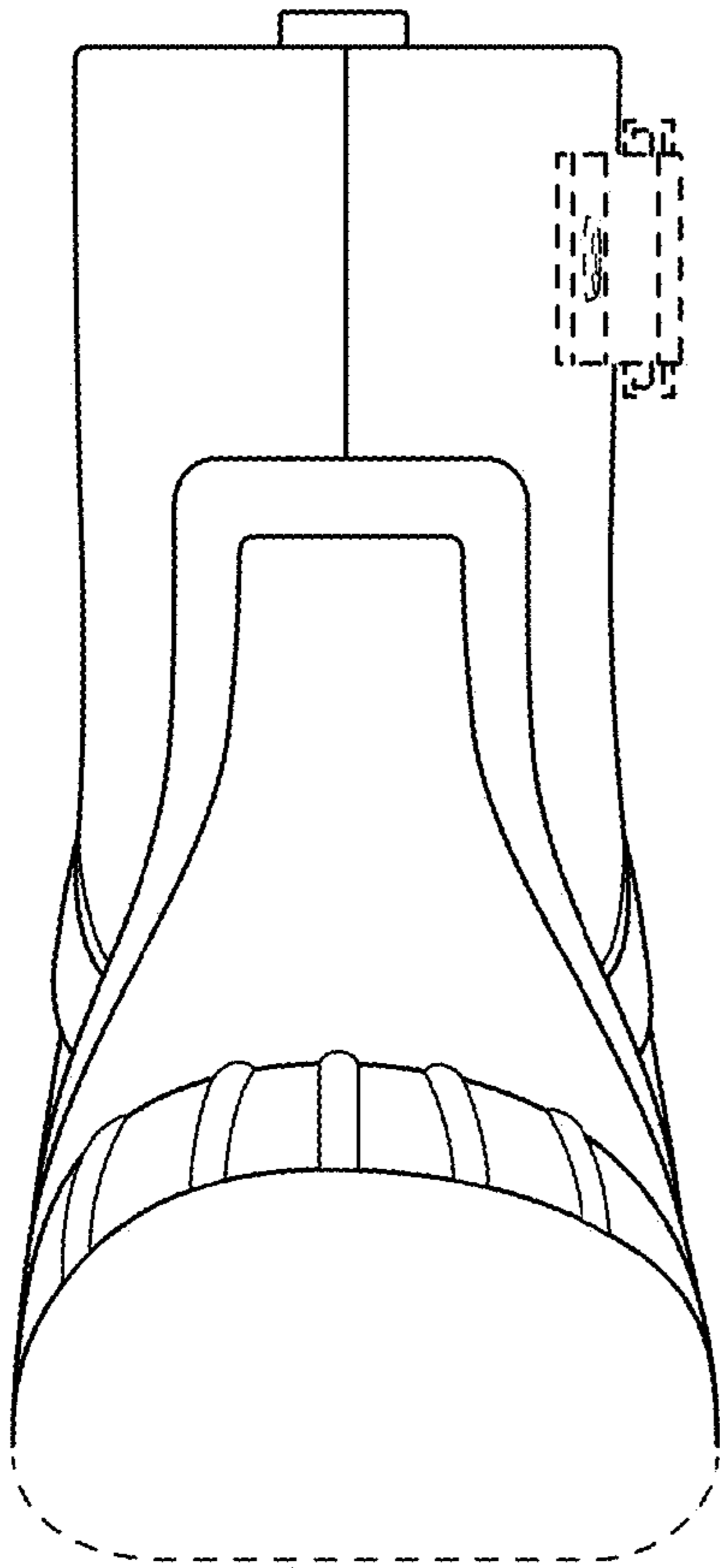
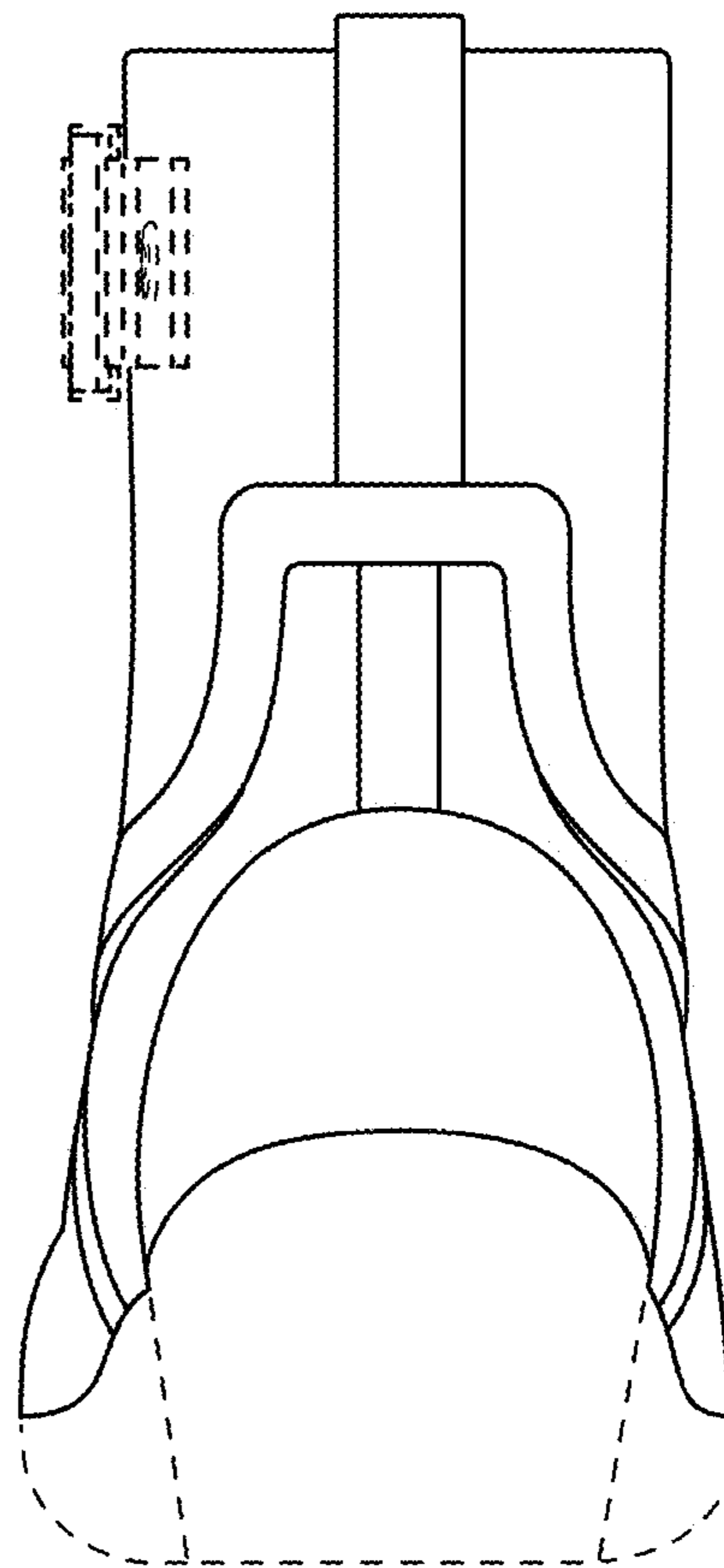

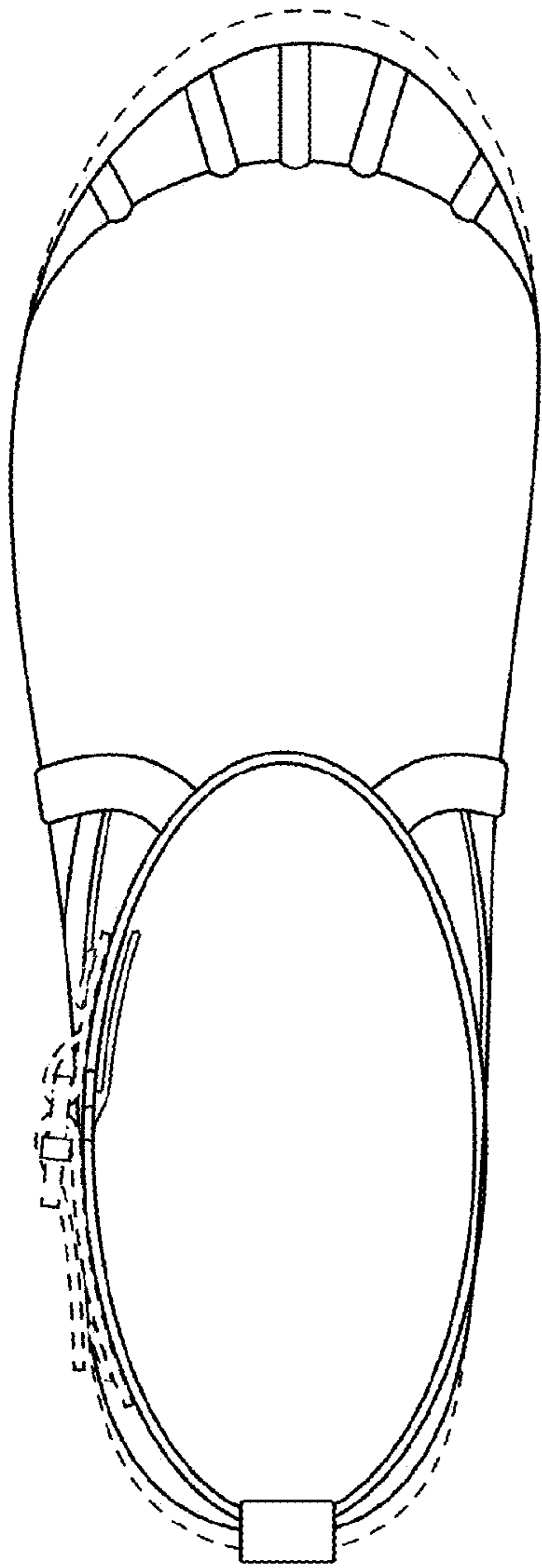
