(57) **CLAIM**

We claim the ornamental design for a toilet stool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toilet stool, showing my new design;

FIG. 2 is a right side elevation view thereof, the left-side elevational view being a mirror image thereof;

FIG. 3 is a front elevation view thereof;

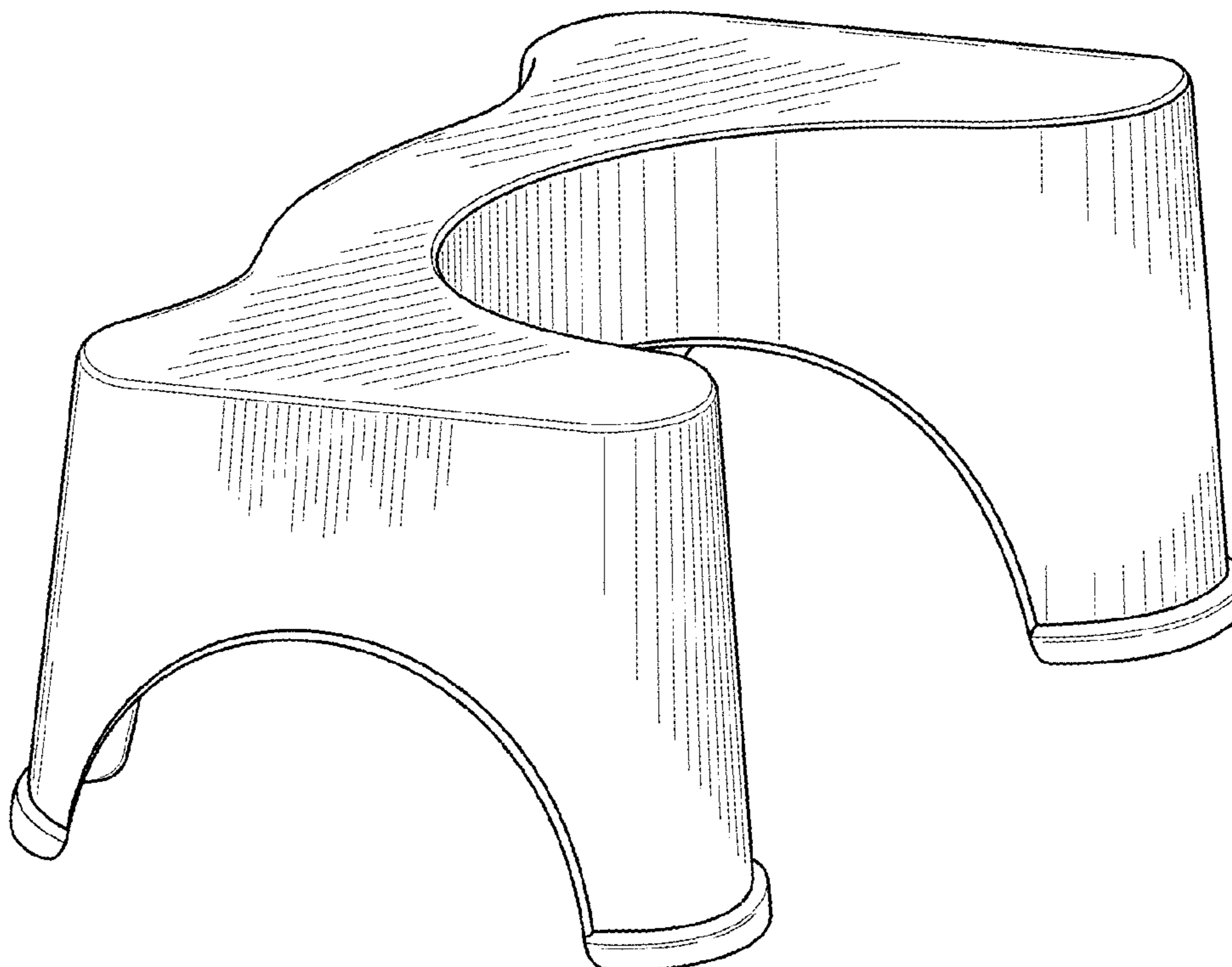
FIG. 4 is a rear elevational view thereof;

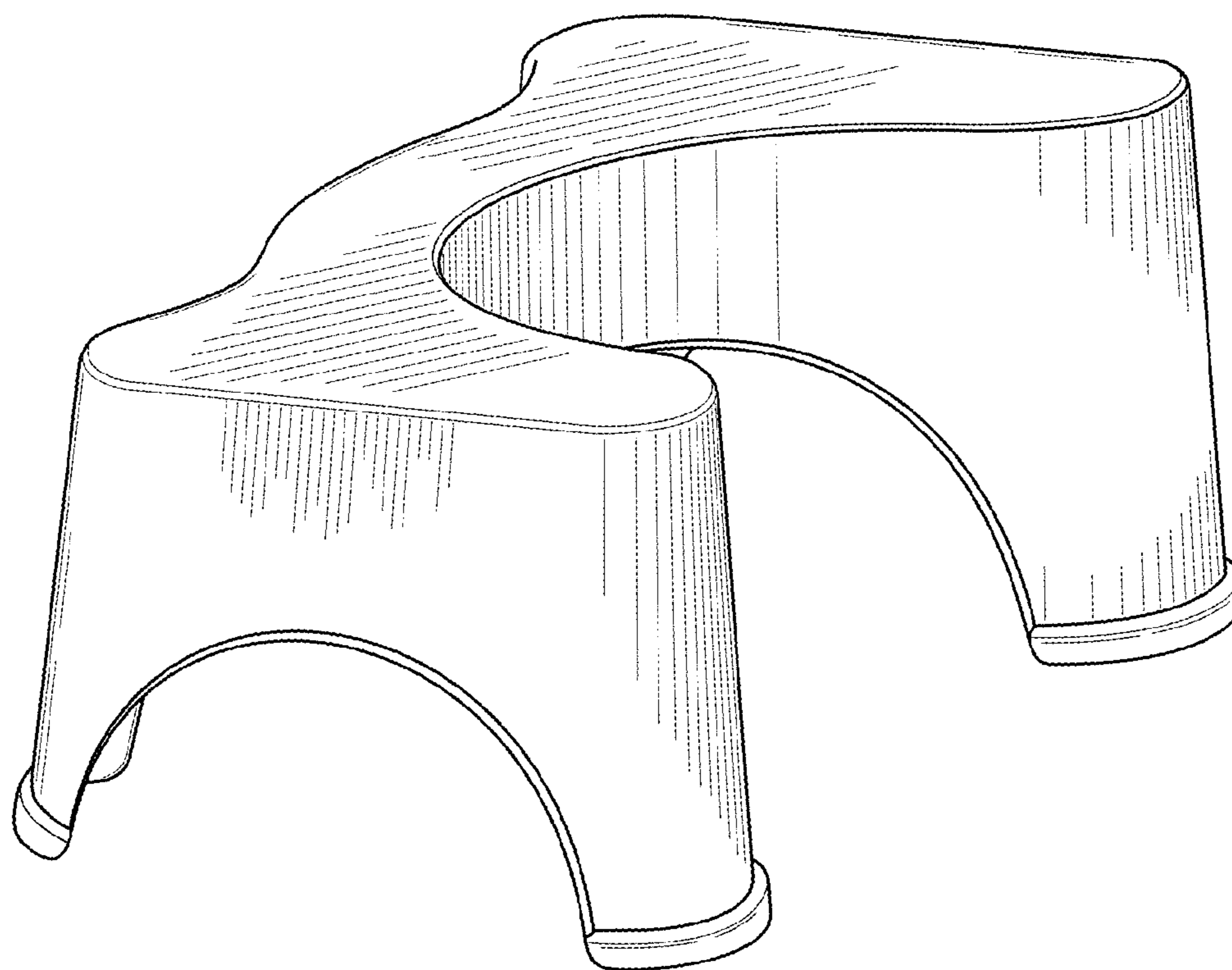

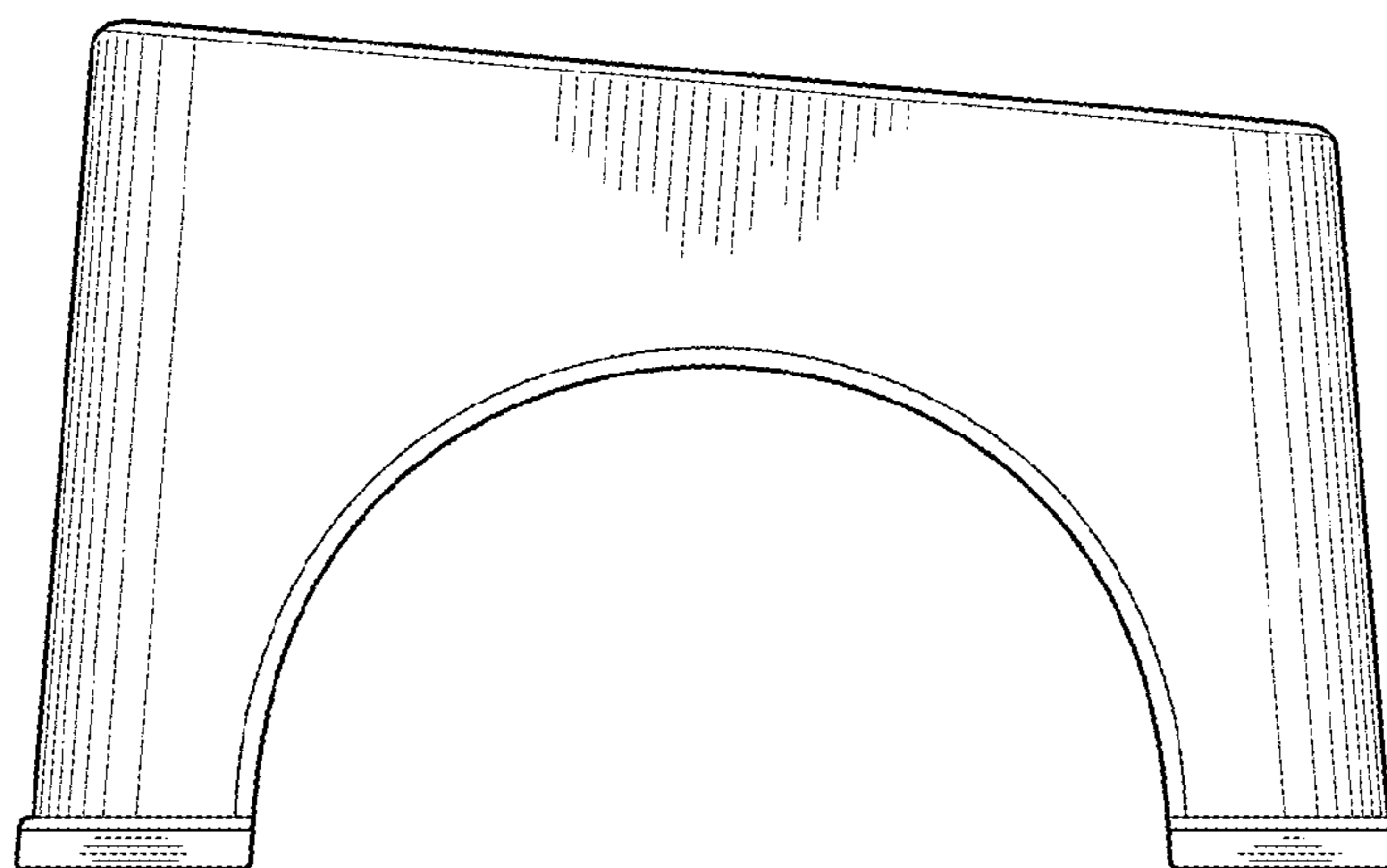

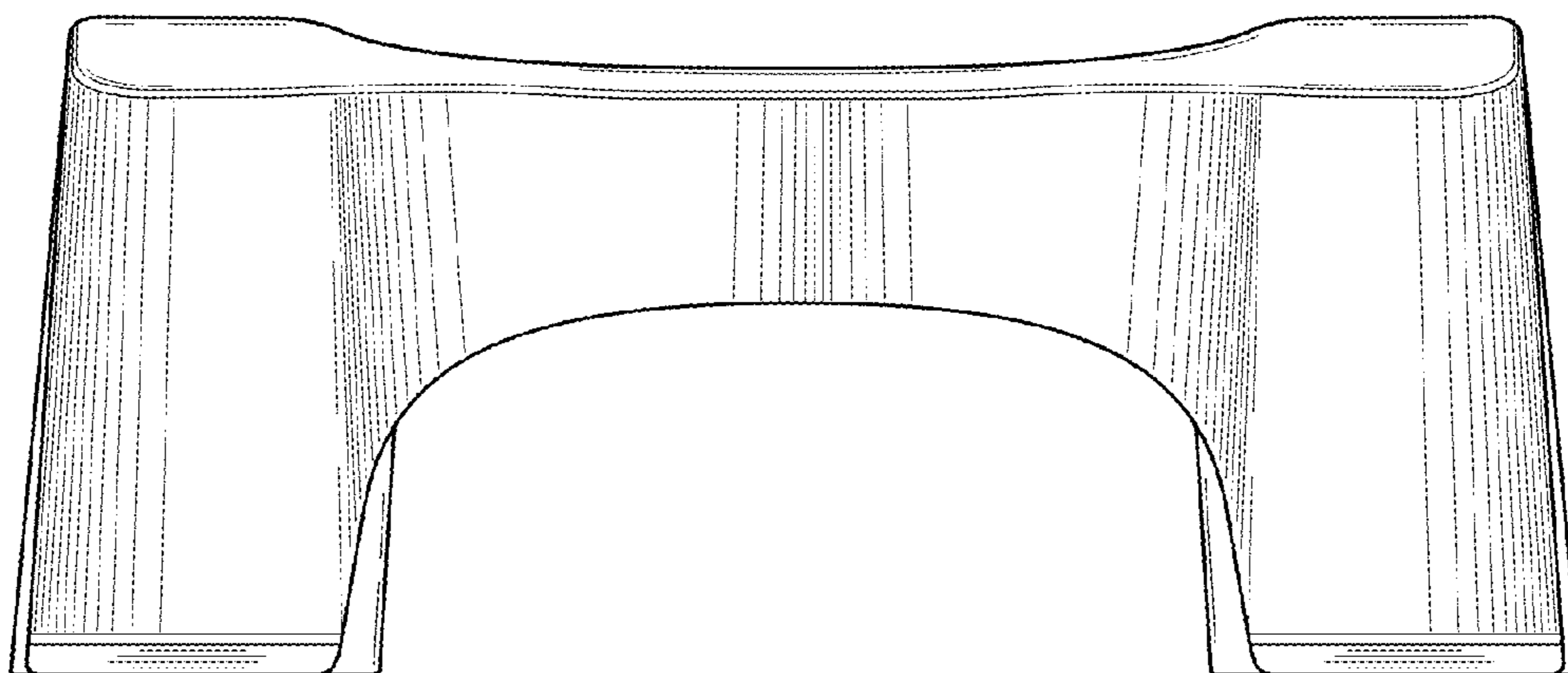

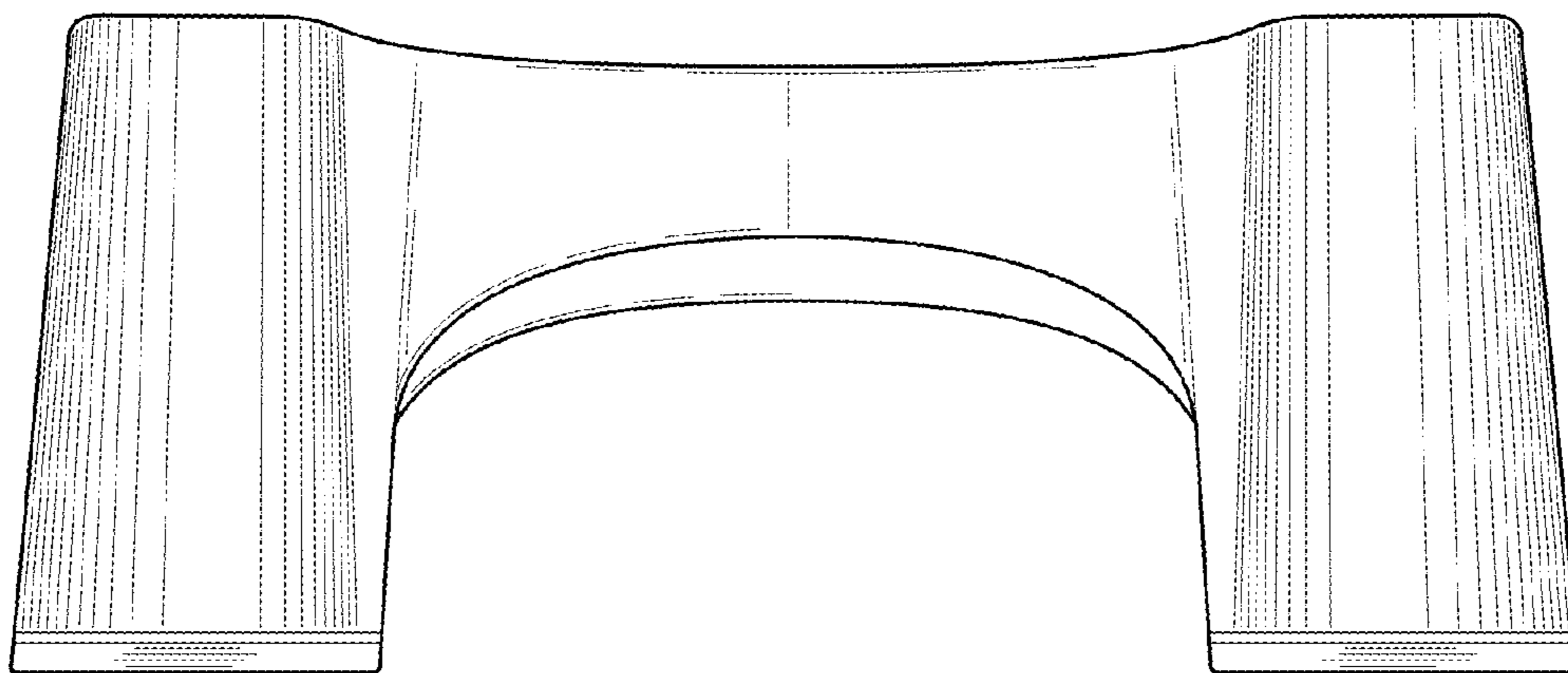

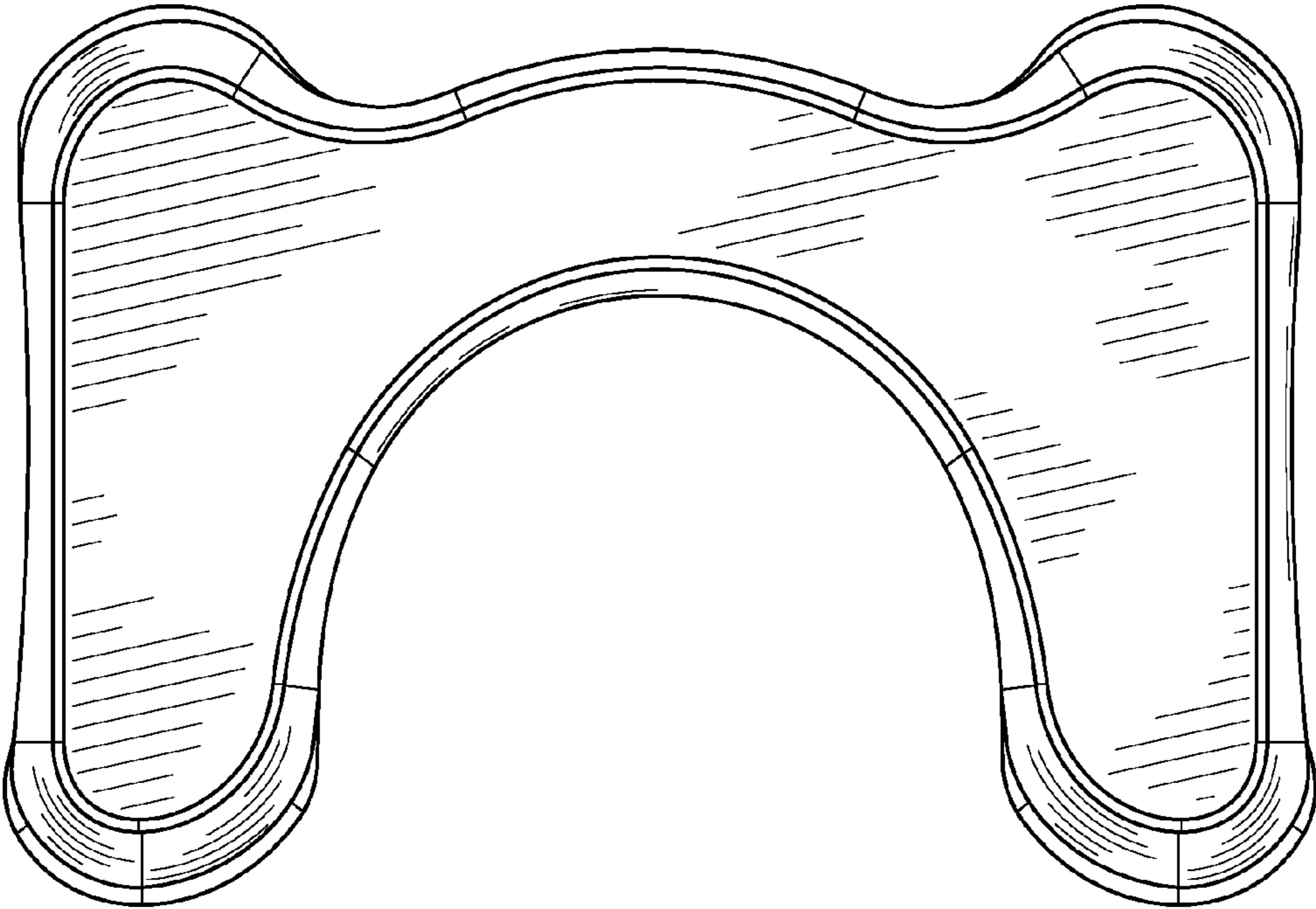

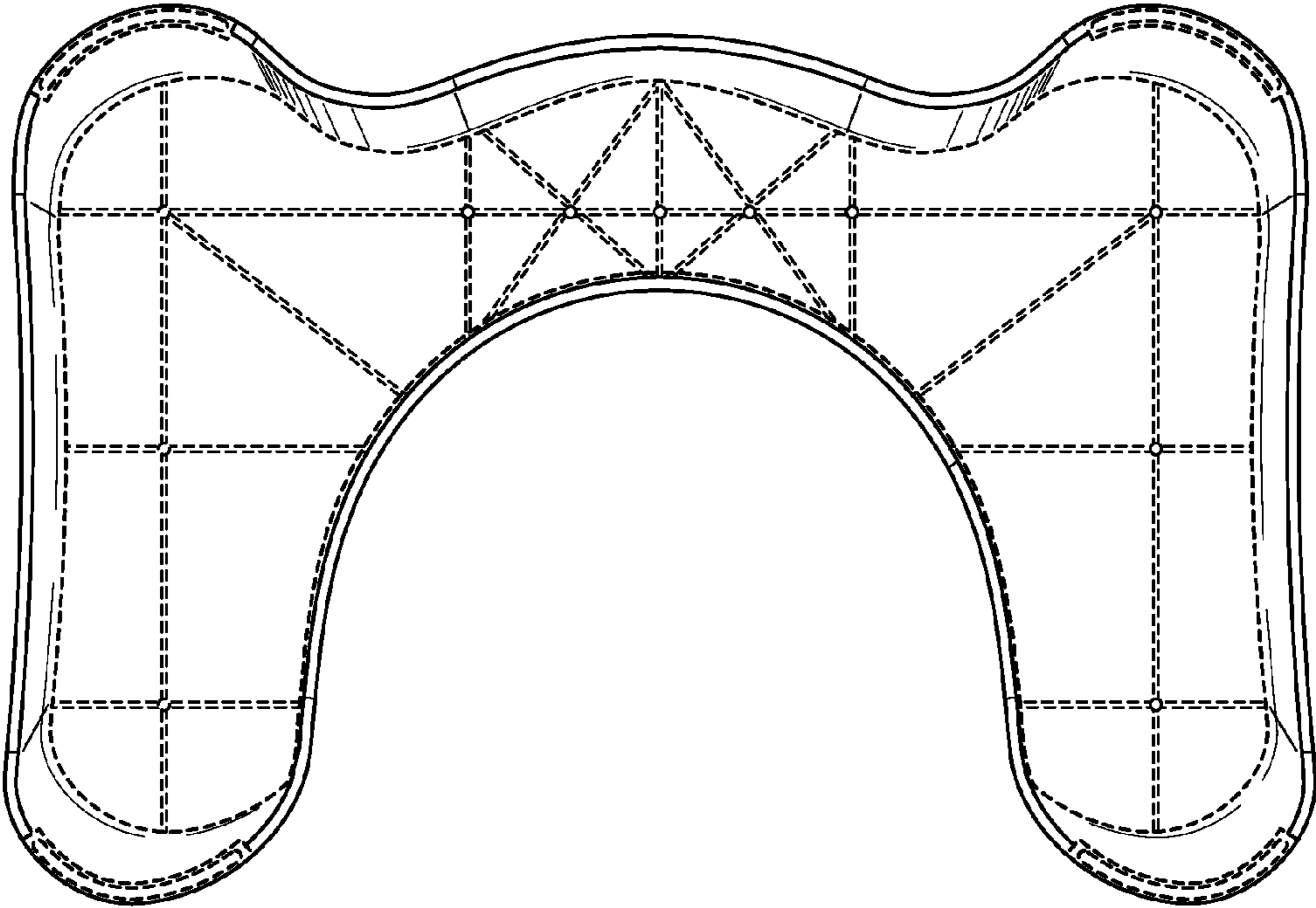
