The ornamental design for a sport towel, as shown and described.

DESCRIPTION

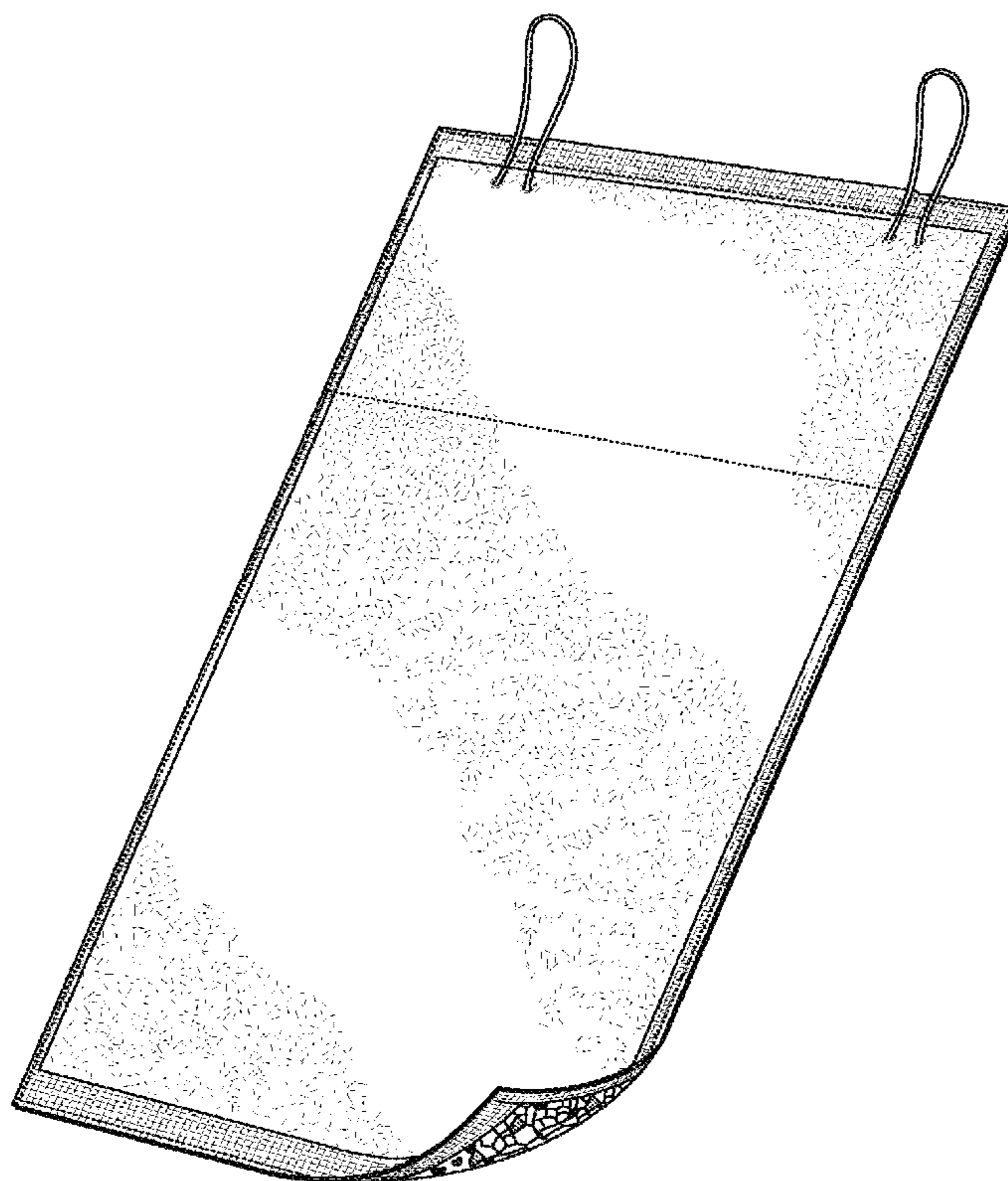
FIG. 1 is a front view of a first embodiment of a sport towel. FIG. 2 is a back view of the embodiment shown in FIG. 1. FIG. 3 is a left side view of the embodiment shown in FIG. 1. FIG. 4 is a right side view of the embodiment shown in FIG. 1.

FIG. 5 is a top view of the embodiment shown in FIG. 1. FIG. 6 is a bottom view of the embodiment shown in FIG. 1. FIG. 7 is a view of the embodiment of FIG. 1 showing the sport towel in a rolled up or storage configuration; and, FIG. 8 is a perspective drawing of the embodiment of FIG. 1 showing the front view.

In the drawings, the broken lines indicate stitching.

The pattern shown on the rear surface in FIGS. 2 and 8 is continuous throughout.

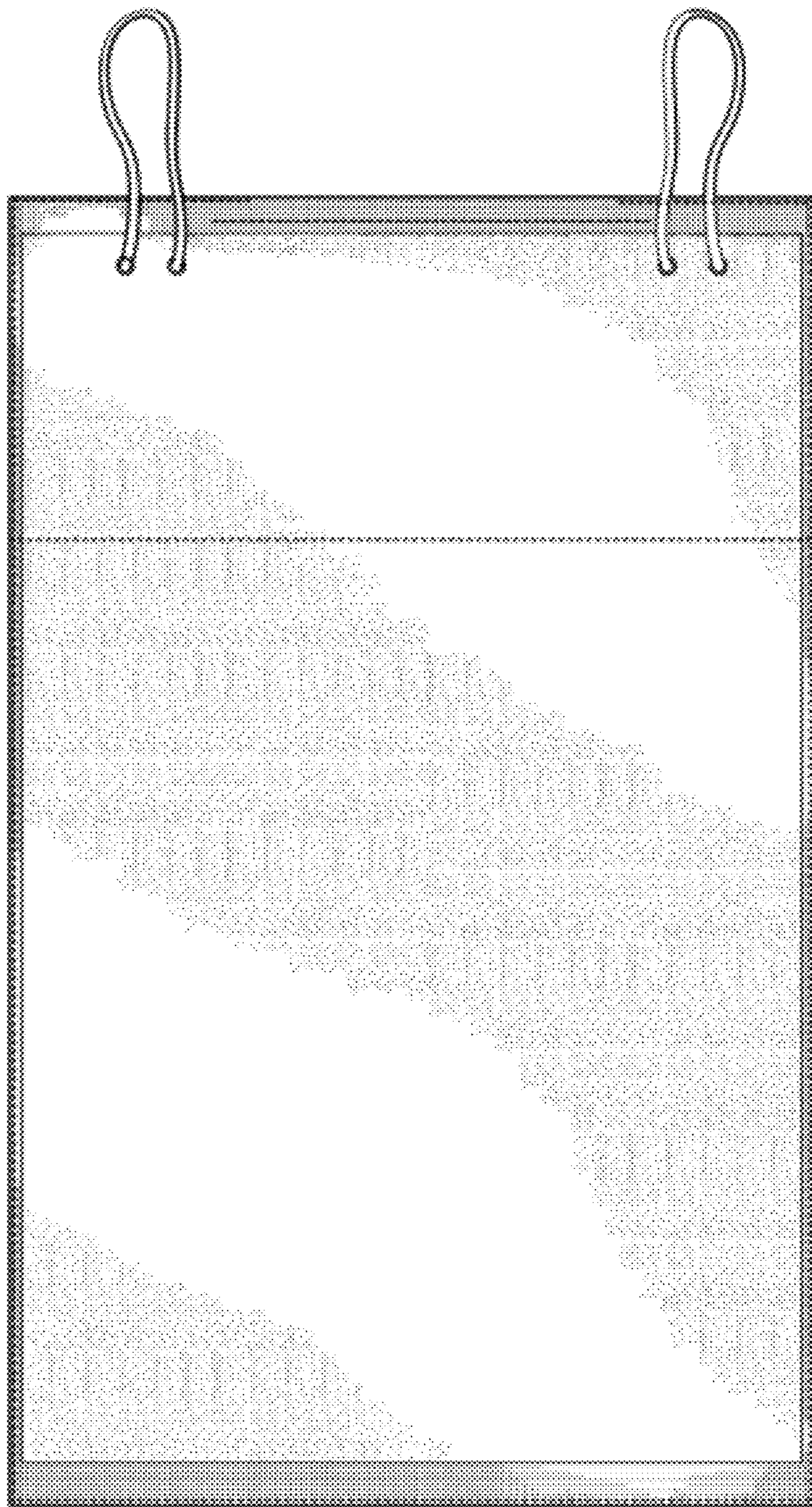

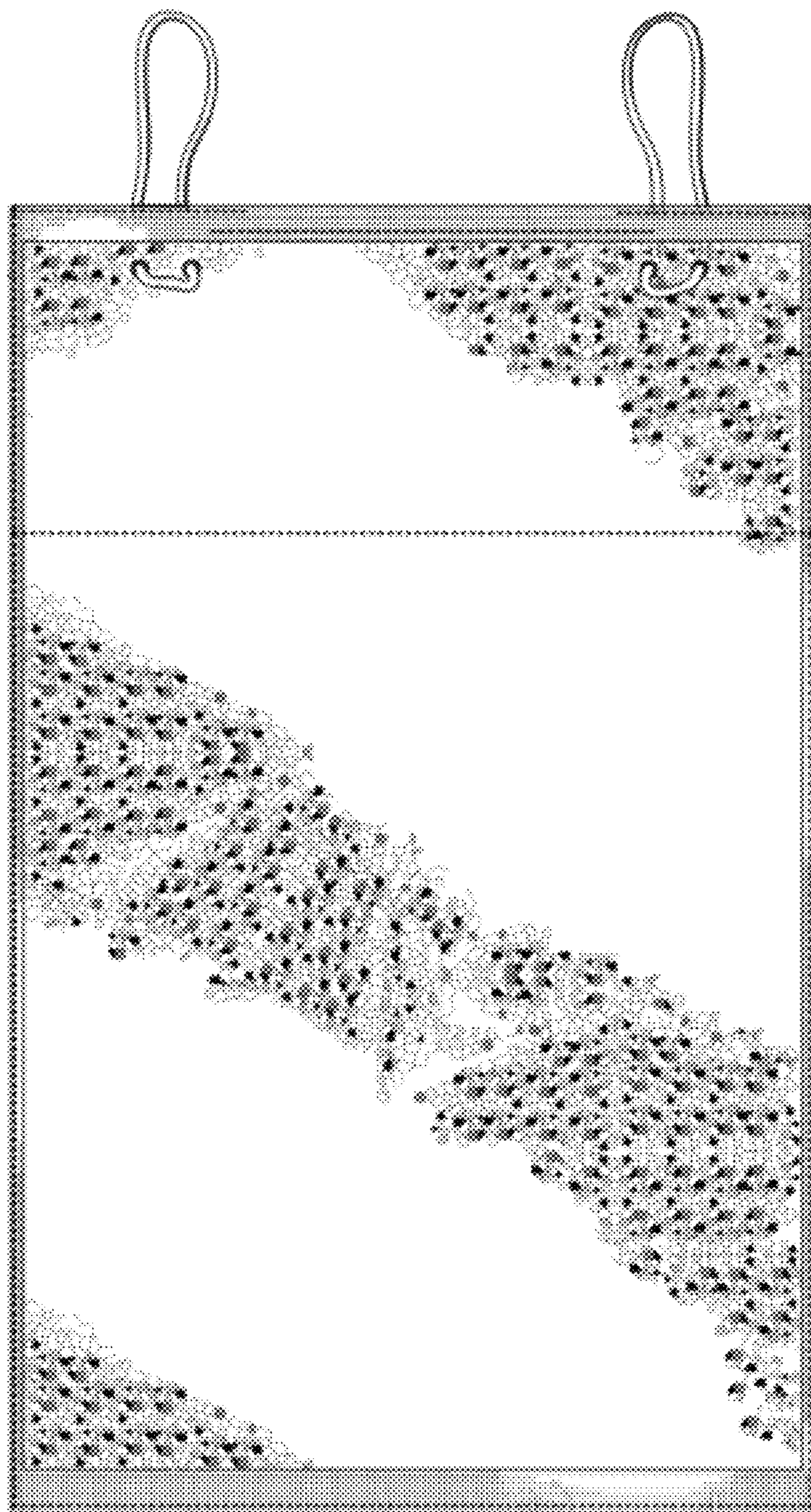

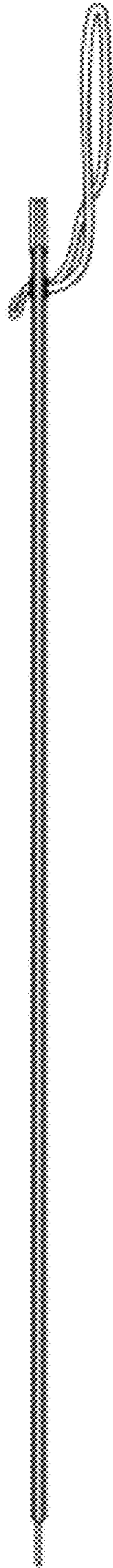

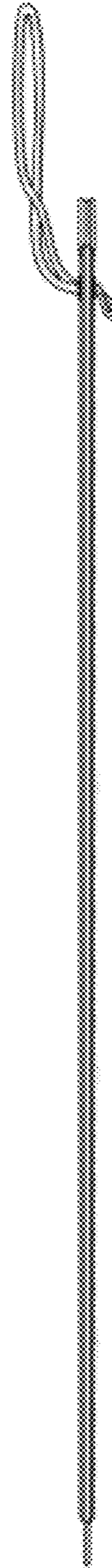

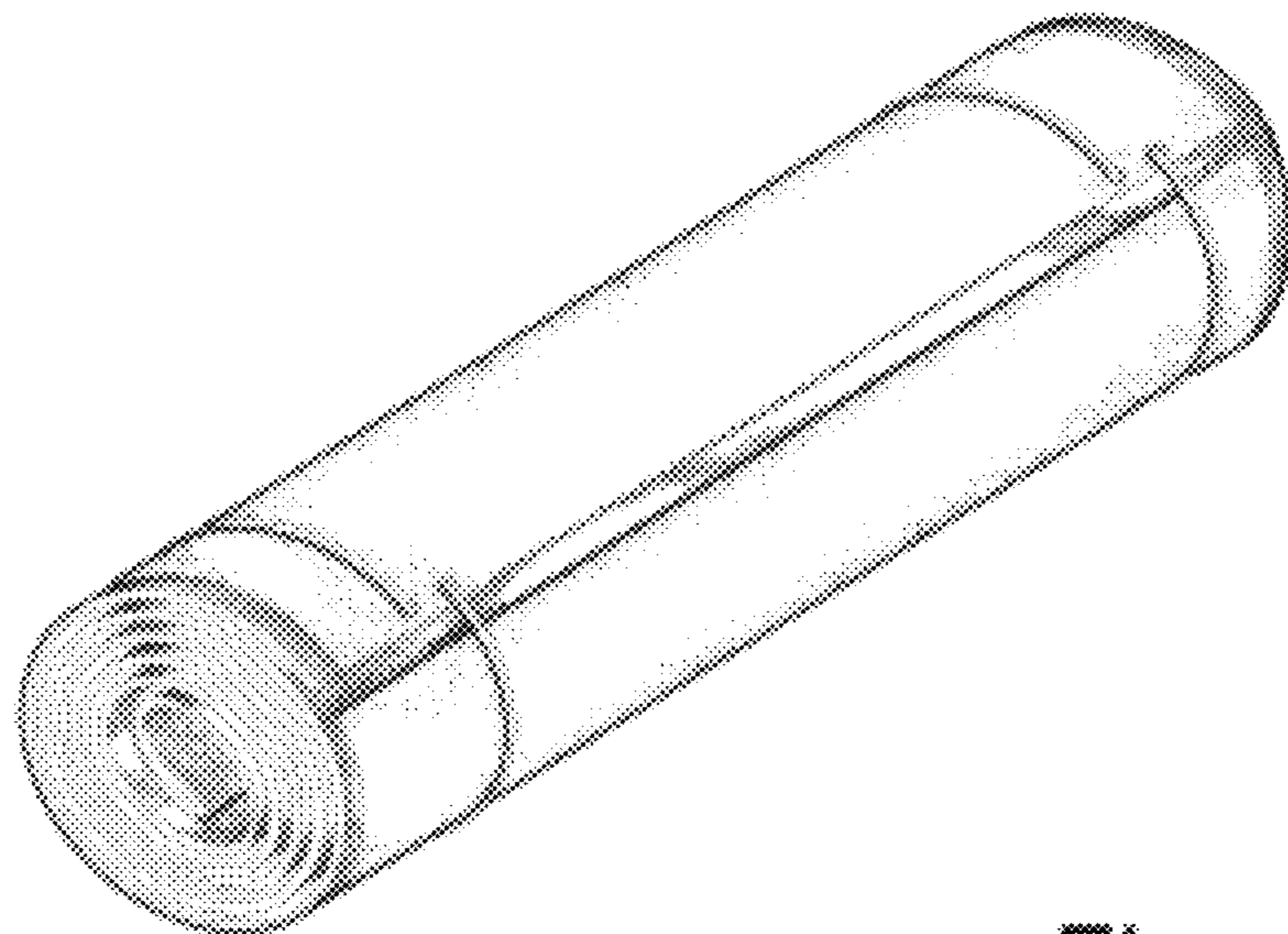

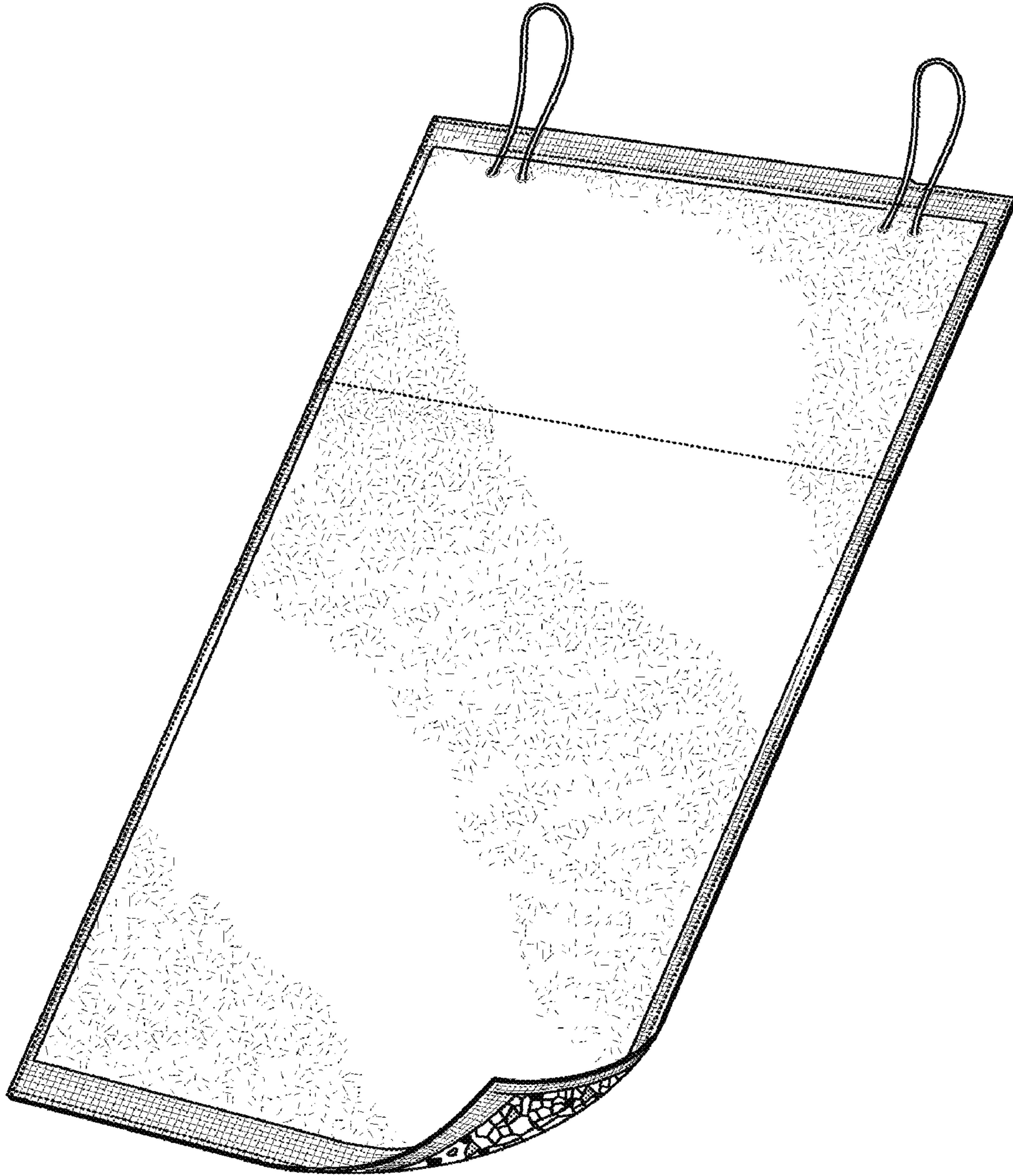
