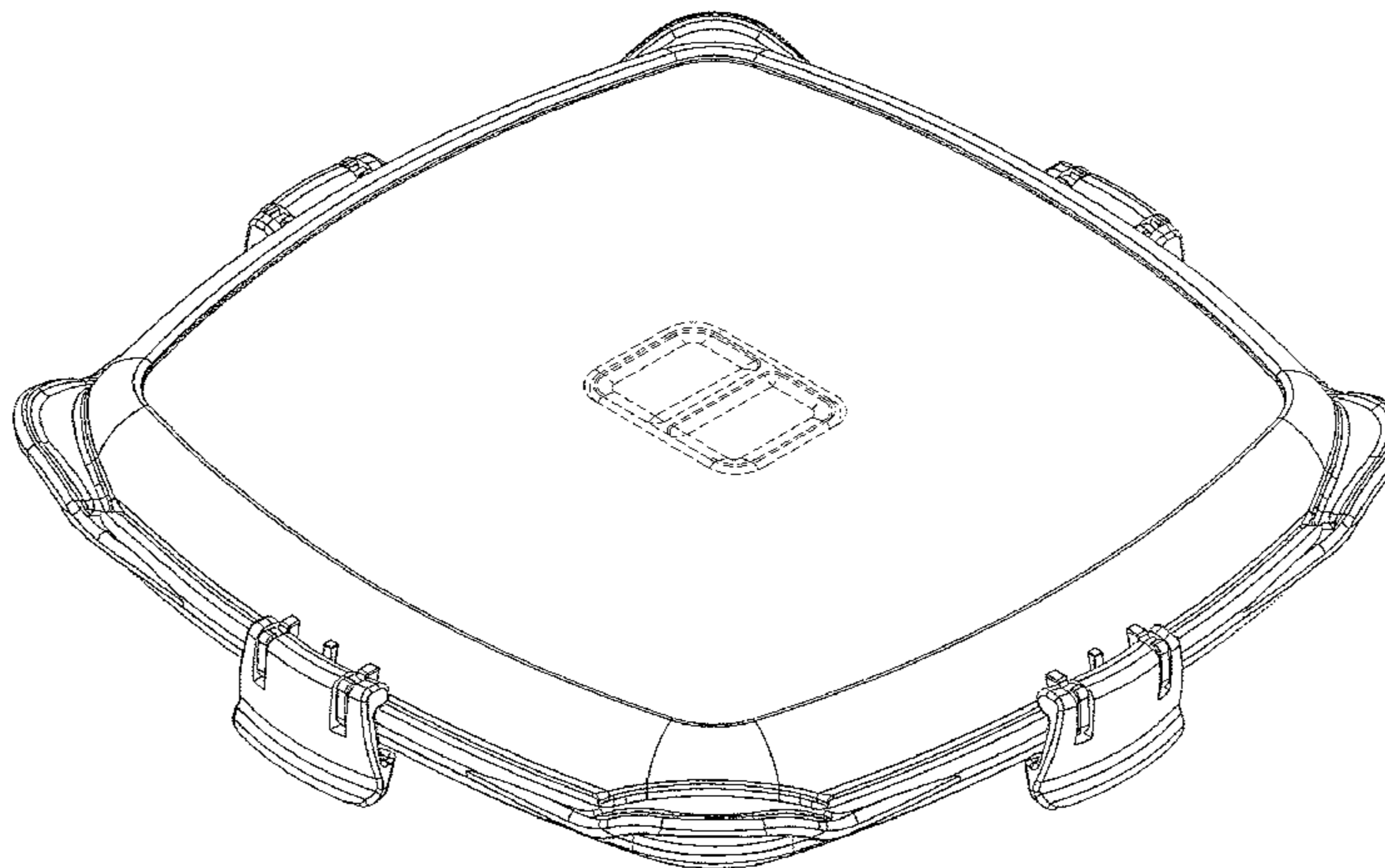
(57) **CLAIM**

We claim the ornamental design for the container lid, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the container lid embodying our design;
FIG. 2 is a bottom perspective view of FIG. 1;
FIG. 3 is a bottom perspective view from a different angle of FIG. 1;
FIG. 4 is a side elevational view of FIG. 1, the other three sides being identical;
FIG. 5 is a top plan view of FIG. 1; and,
FIG. 6 is a bottom plan view of FIG. 1.
The vent shown in hidden line in the FIGS. 1 through 3 and 5 and 6 does not form a part of the design being patented.

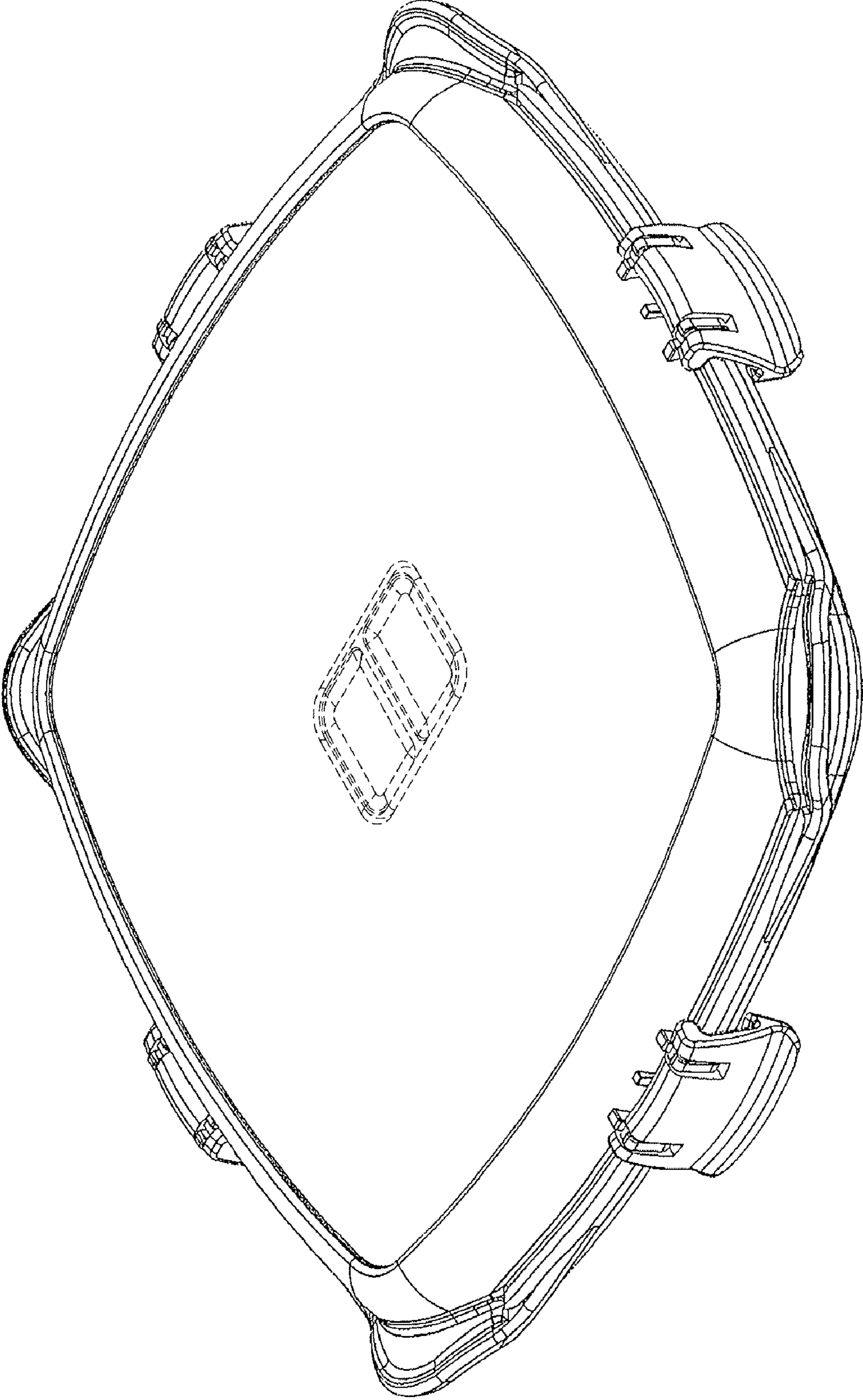

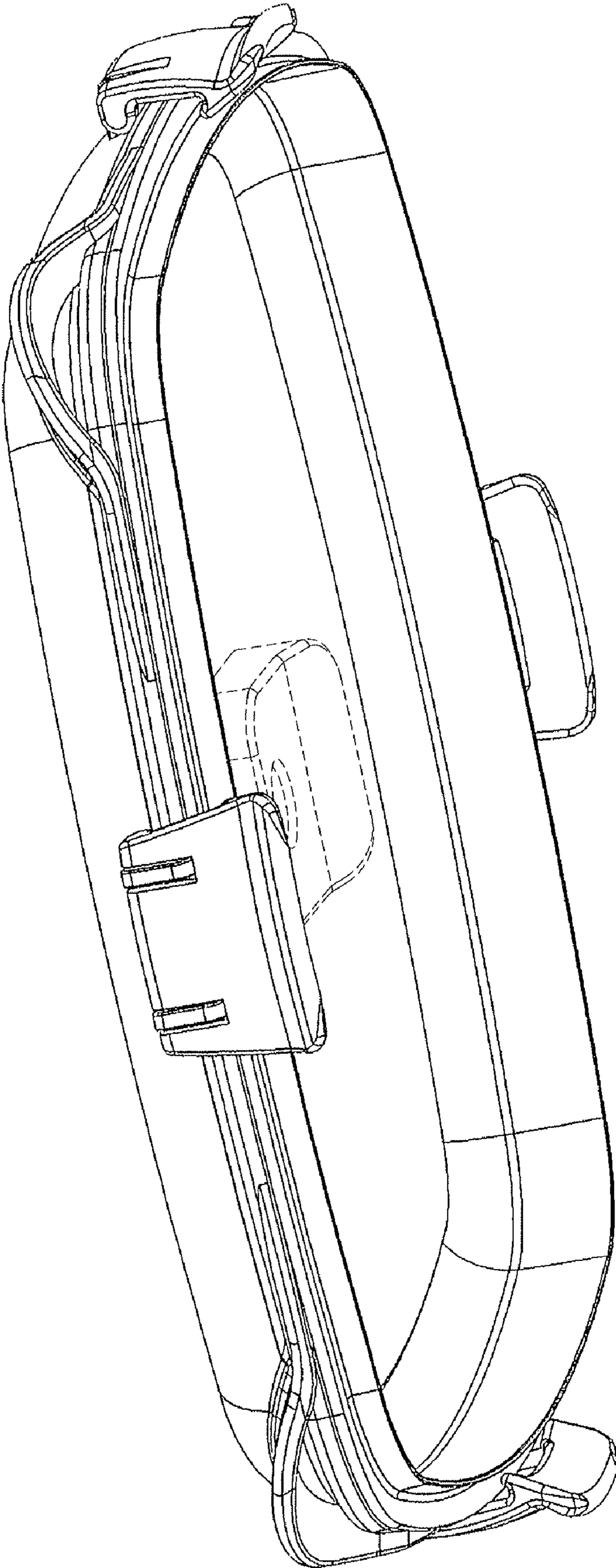

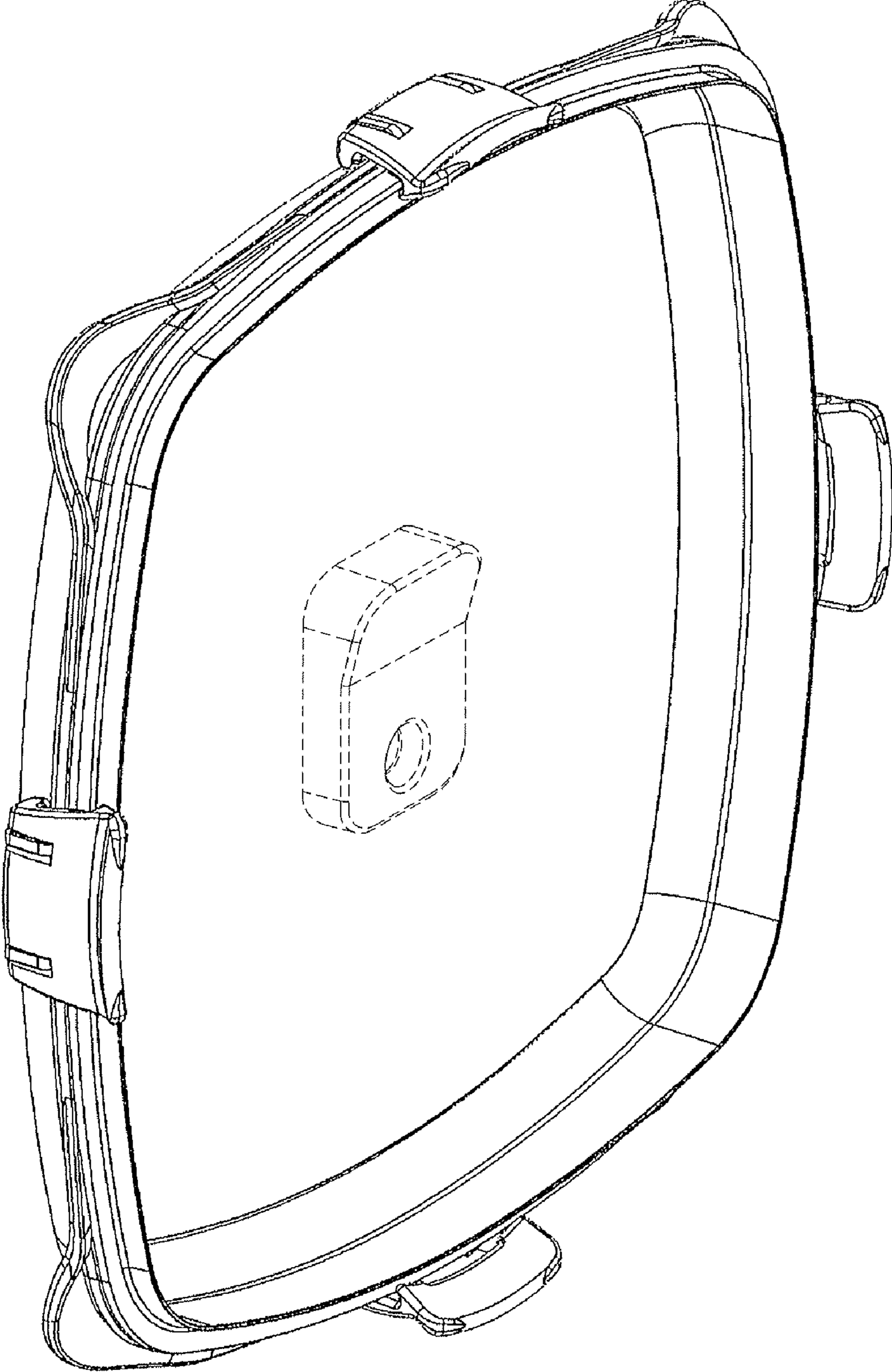

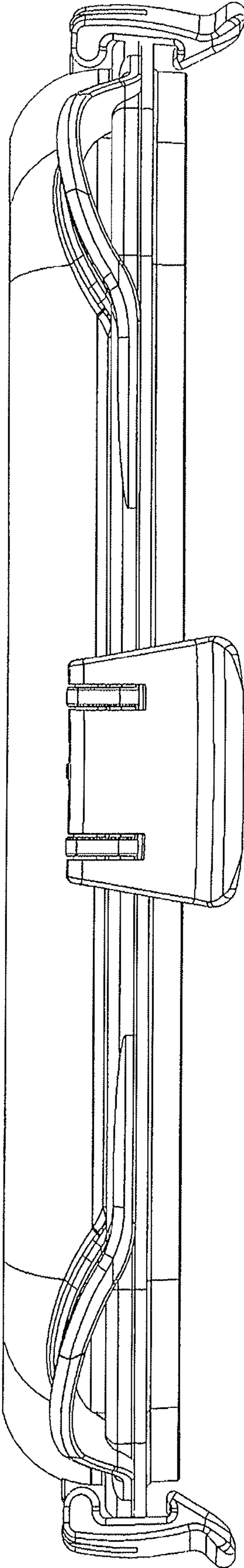

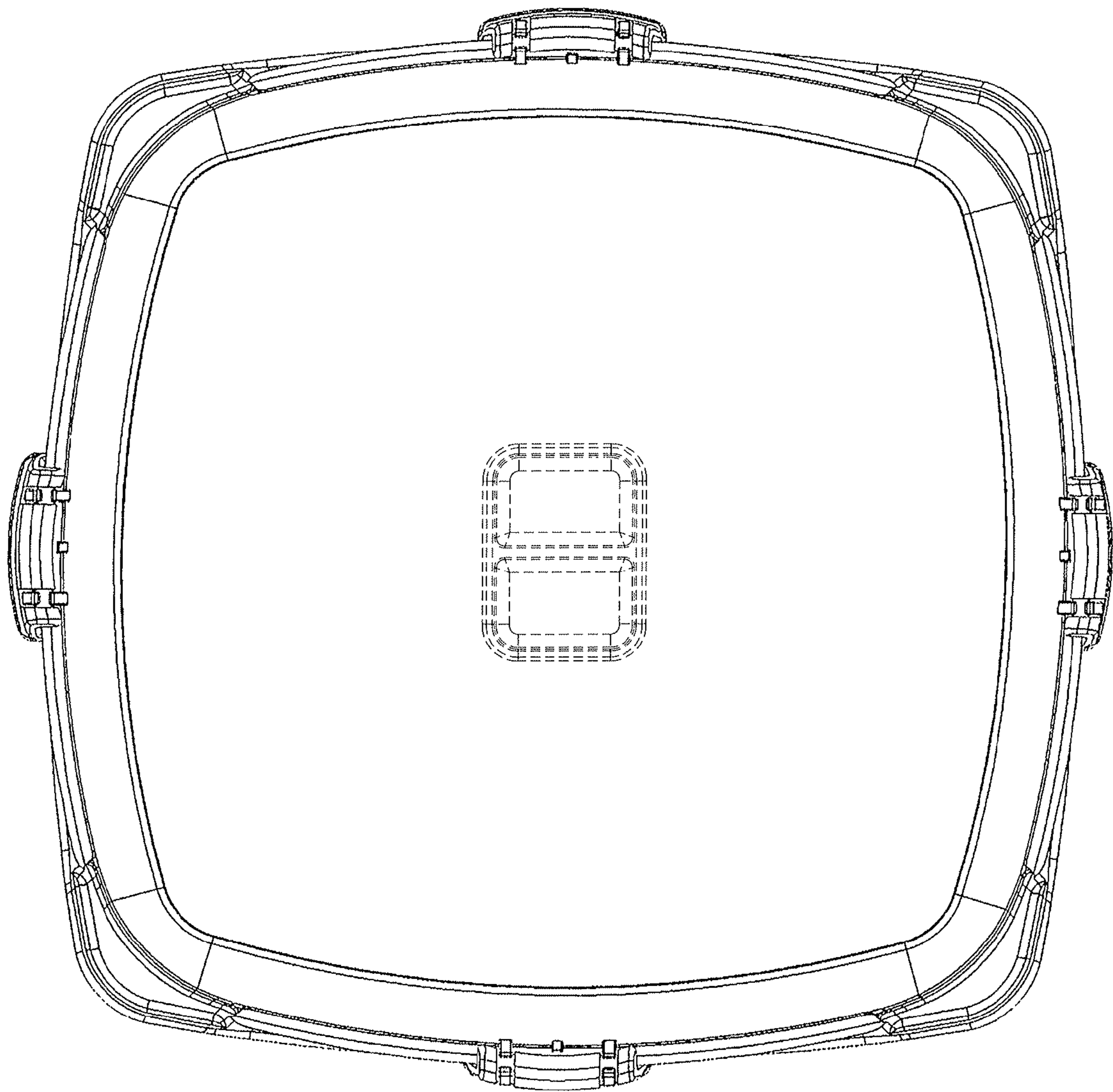

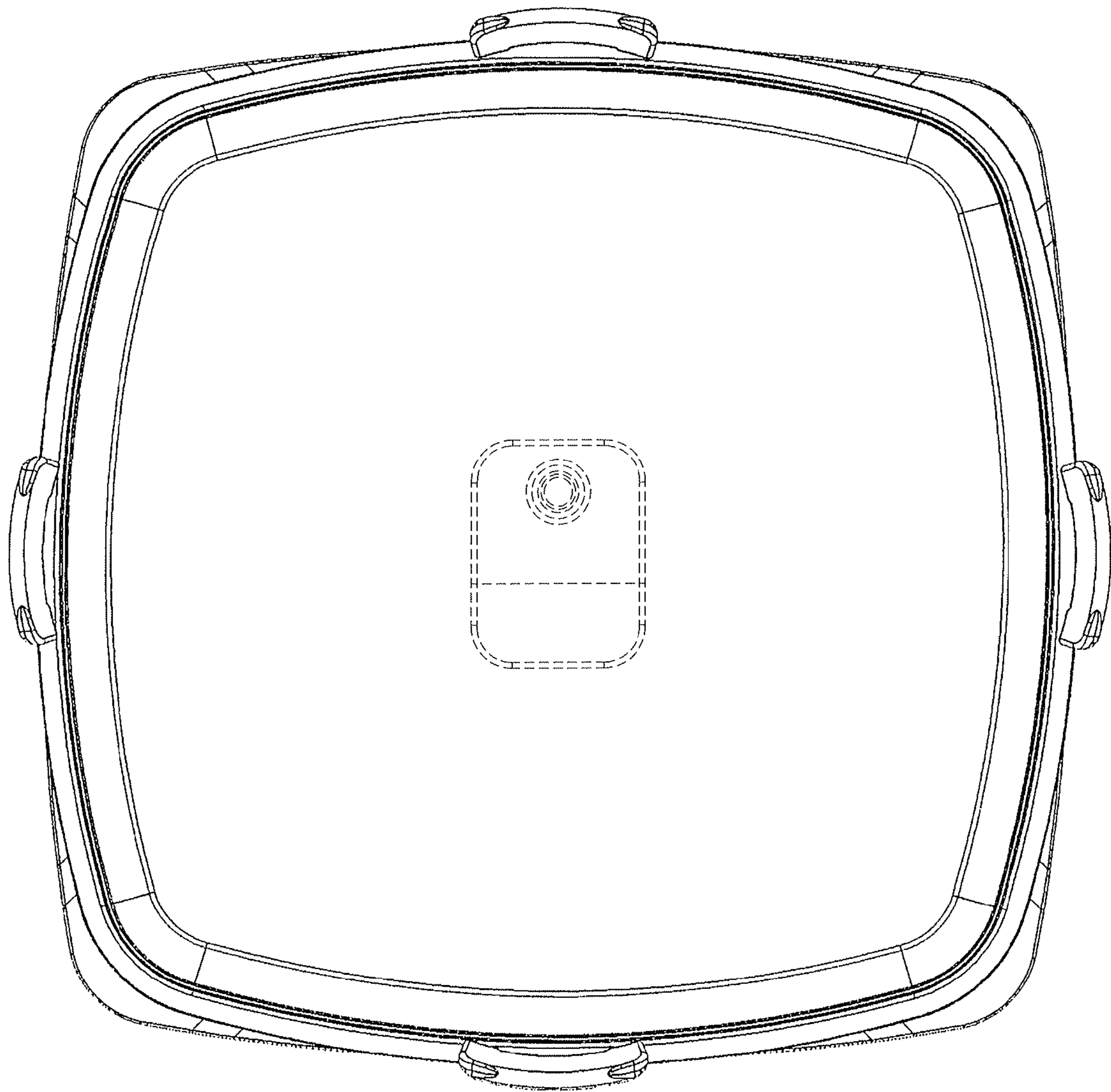
