(57) **CLAIM**

The ornamental design for an ornamental feature for zipper slider, as shown and described.

**DESCRIPTION**

FIG. 11 is a rear view of FIG. 8;

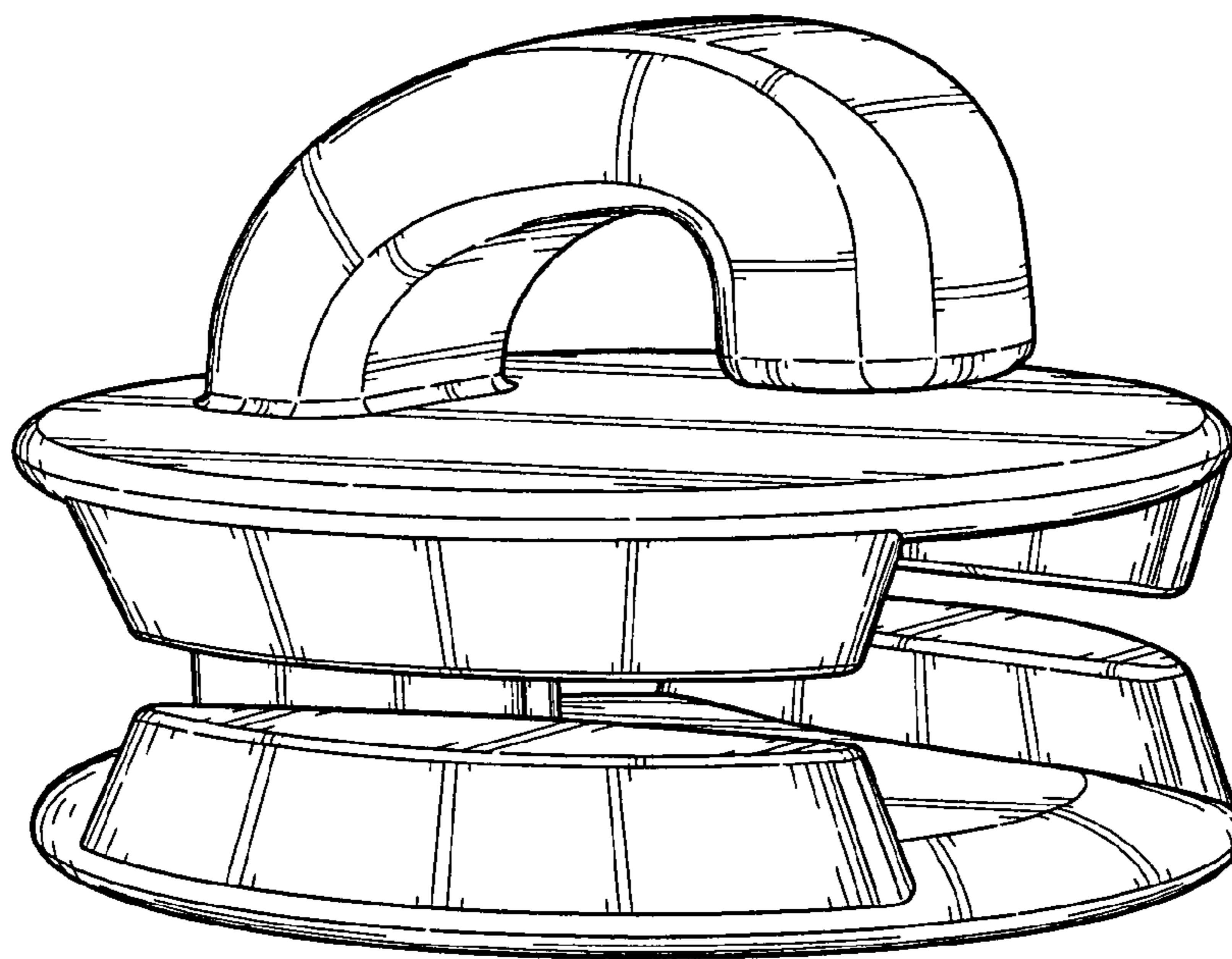
FIG. 12 is a front view of FIG. 8;

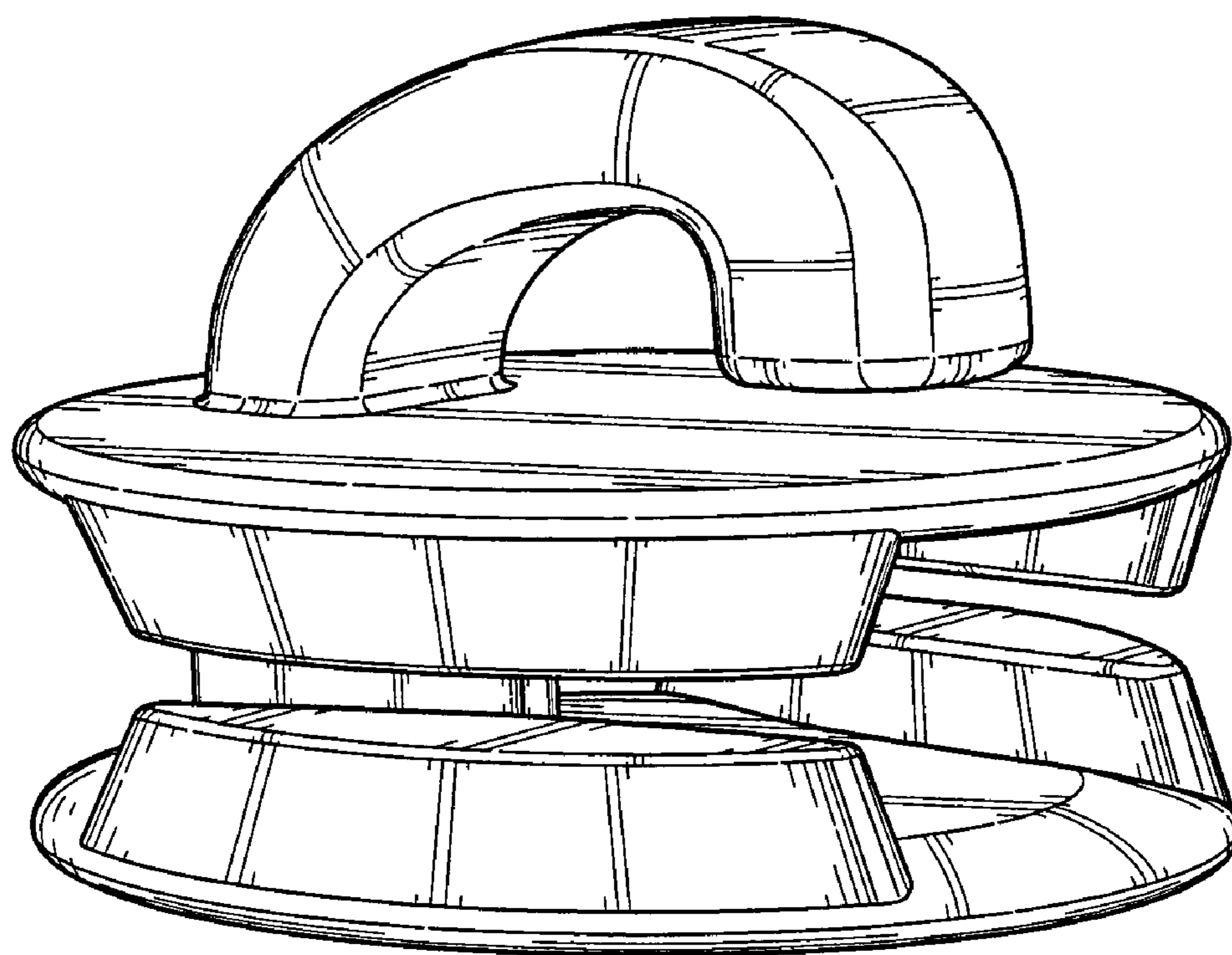

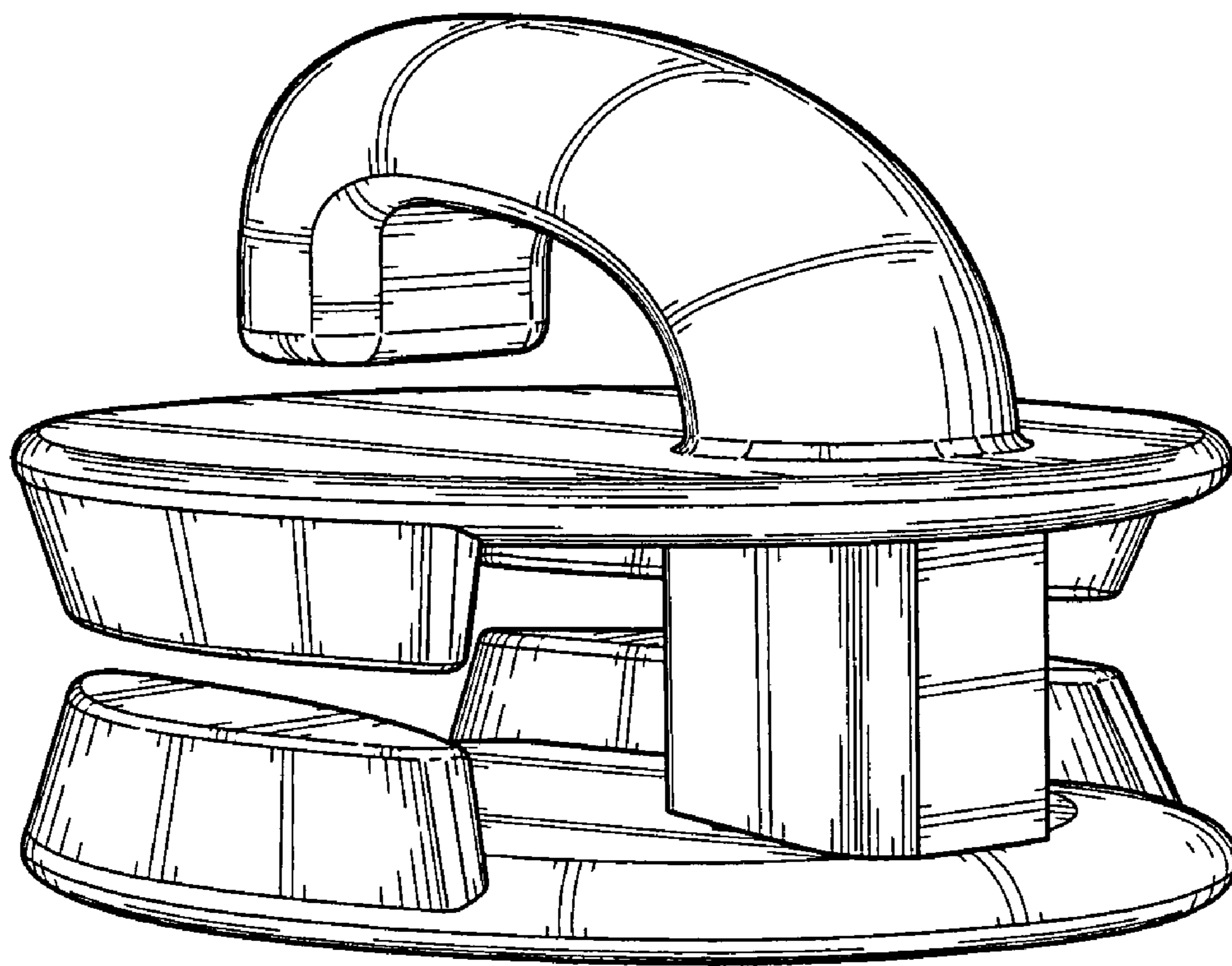

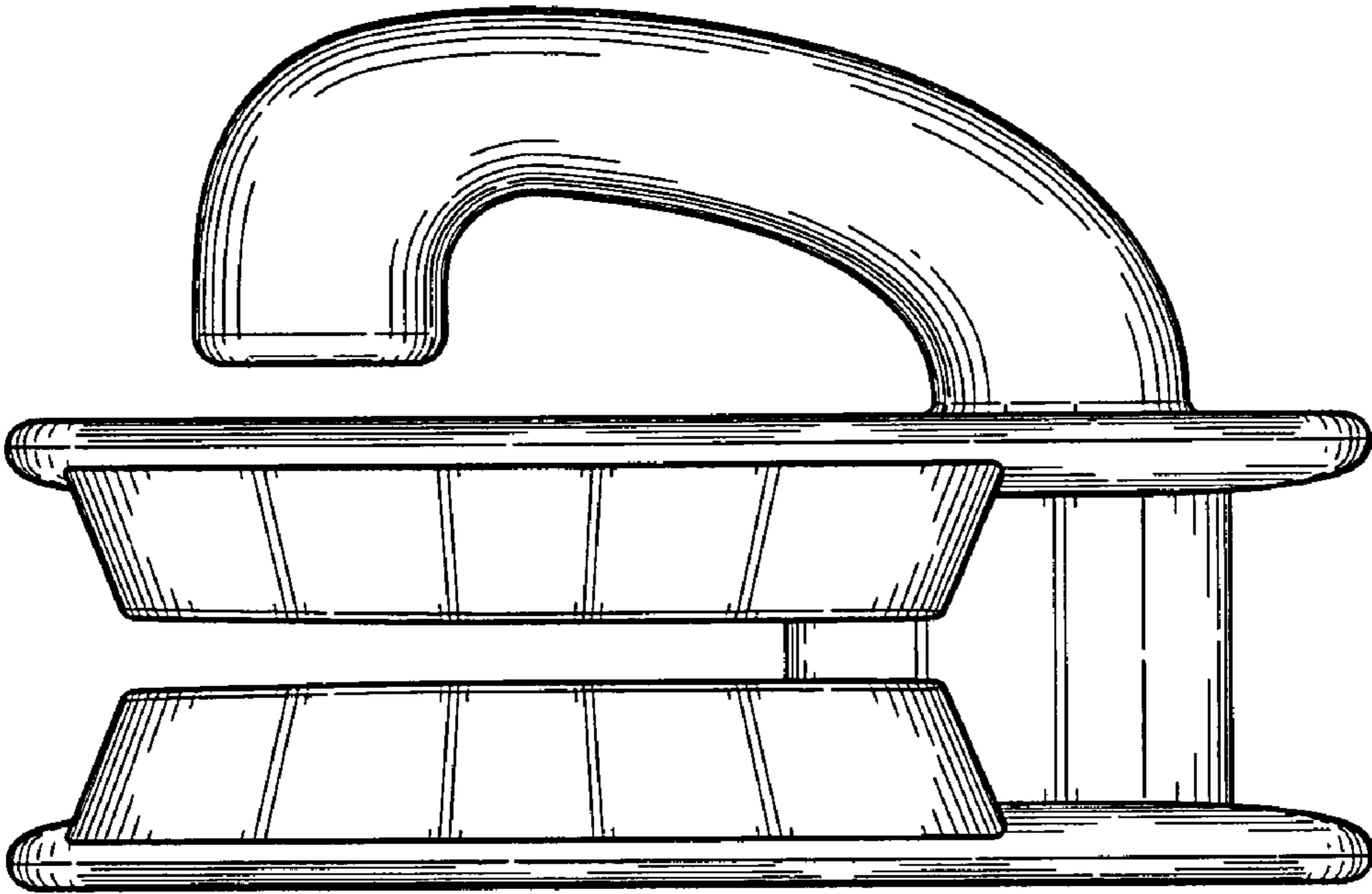

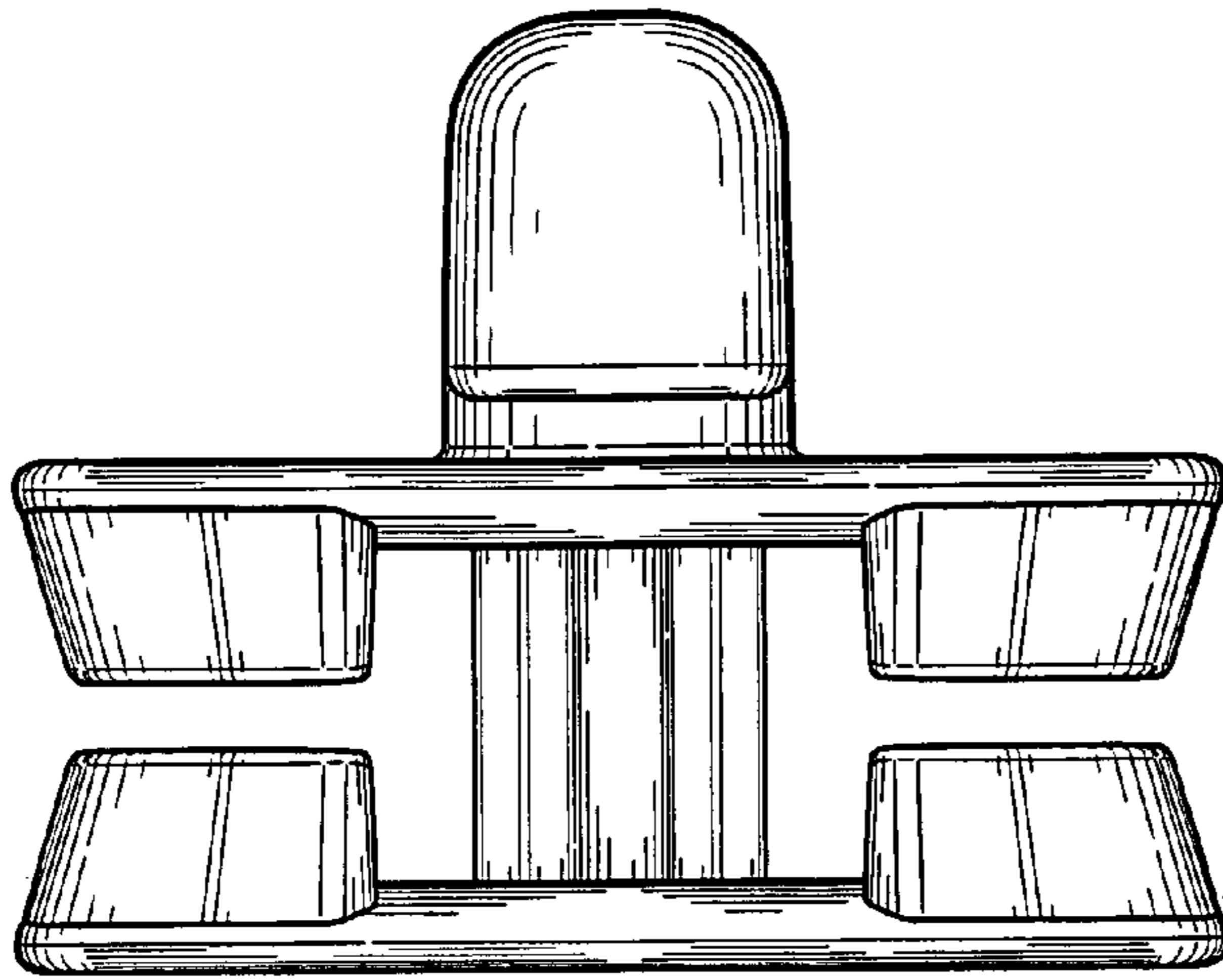

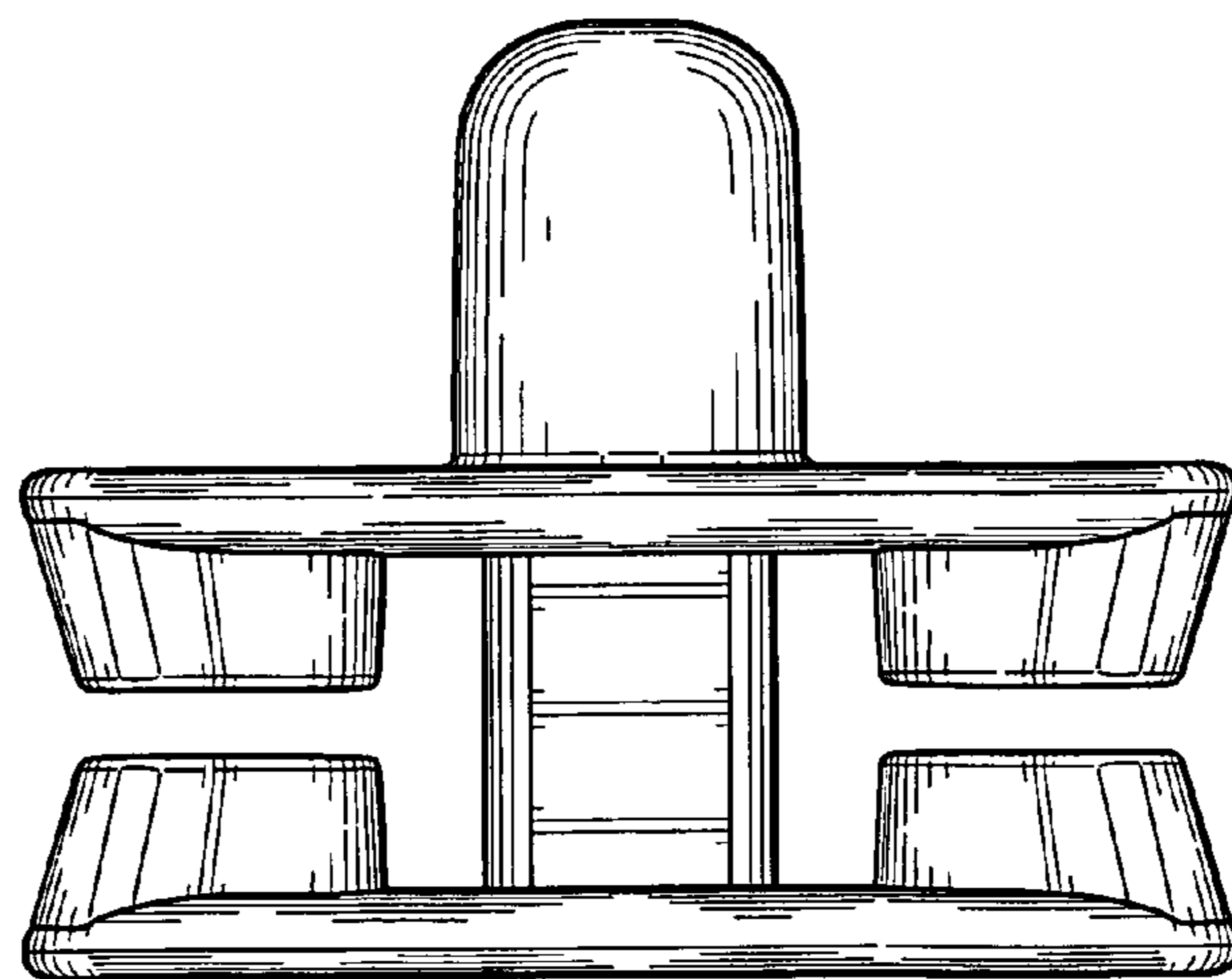

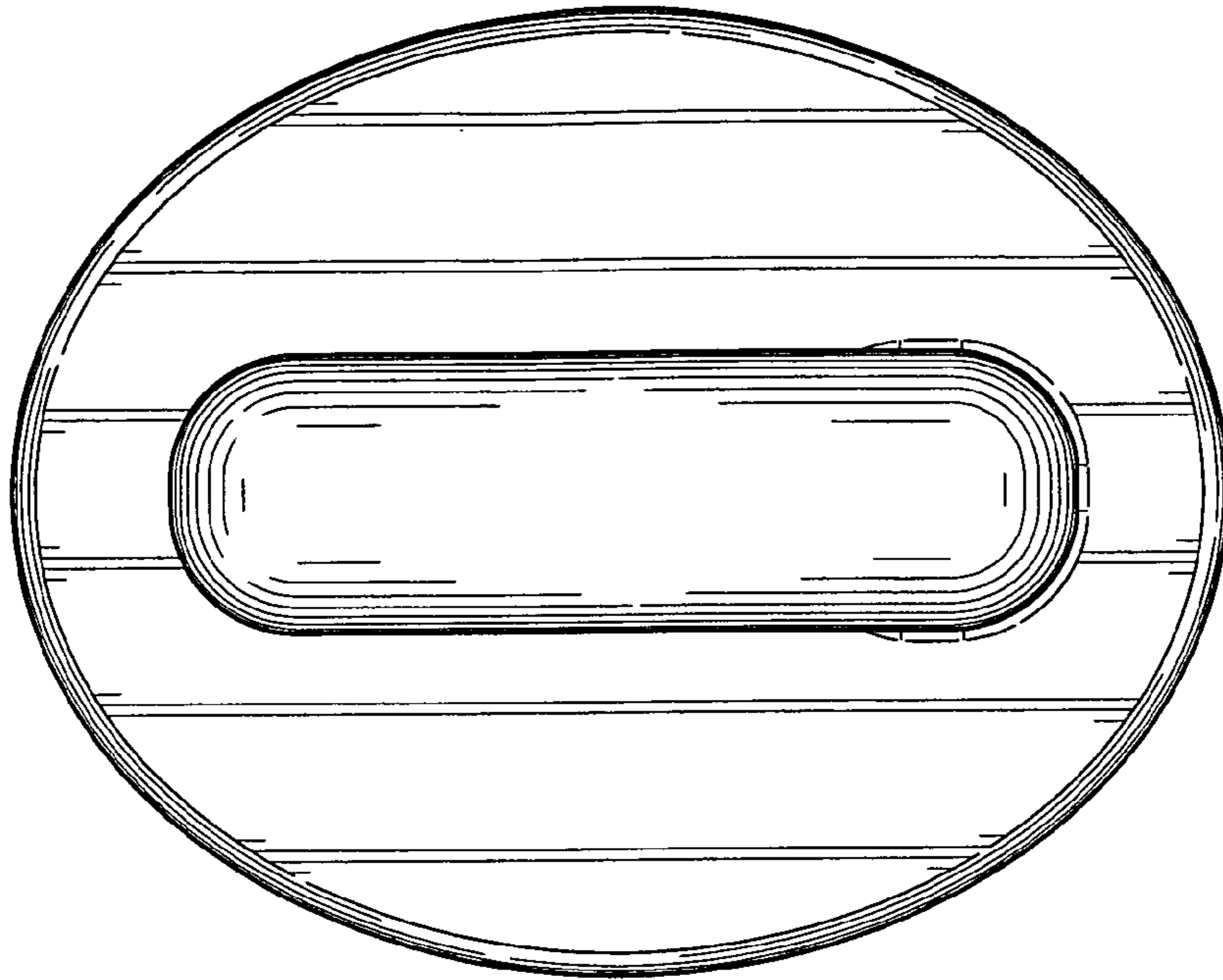

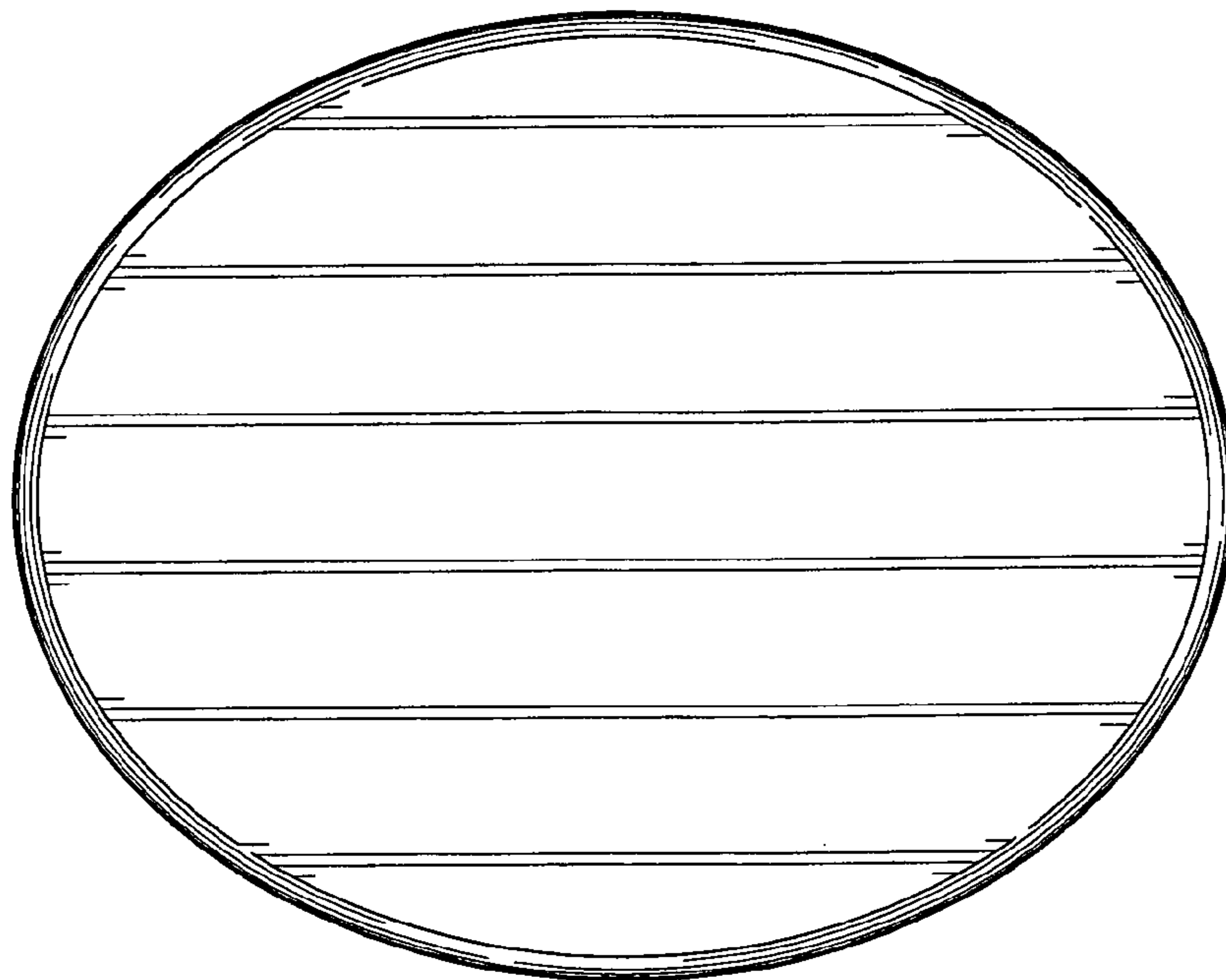

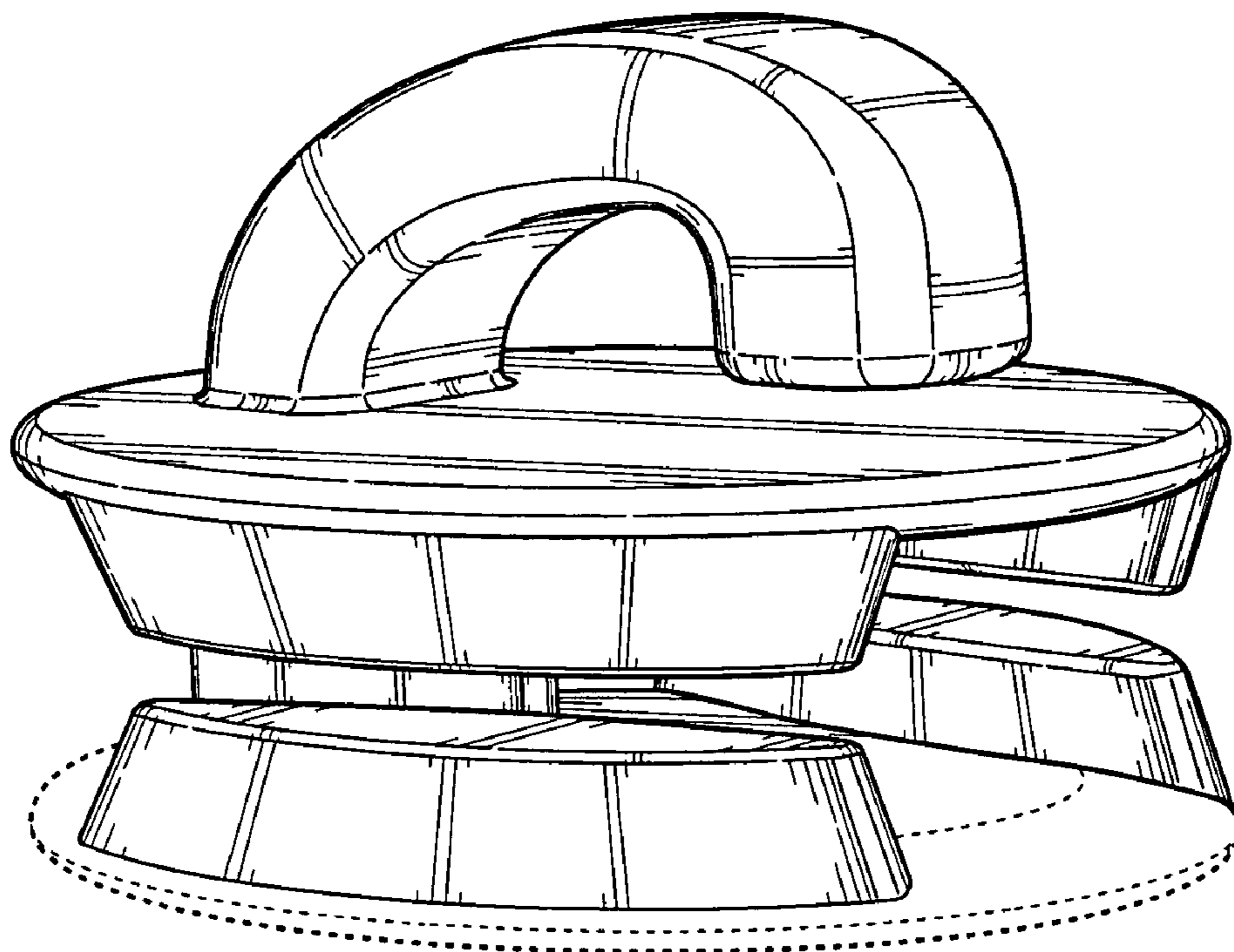

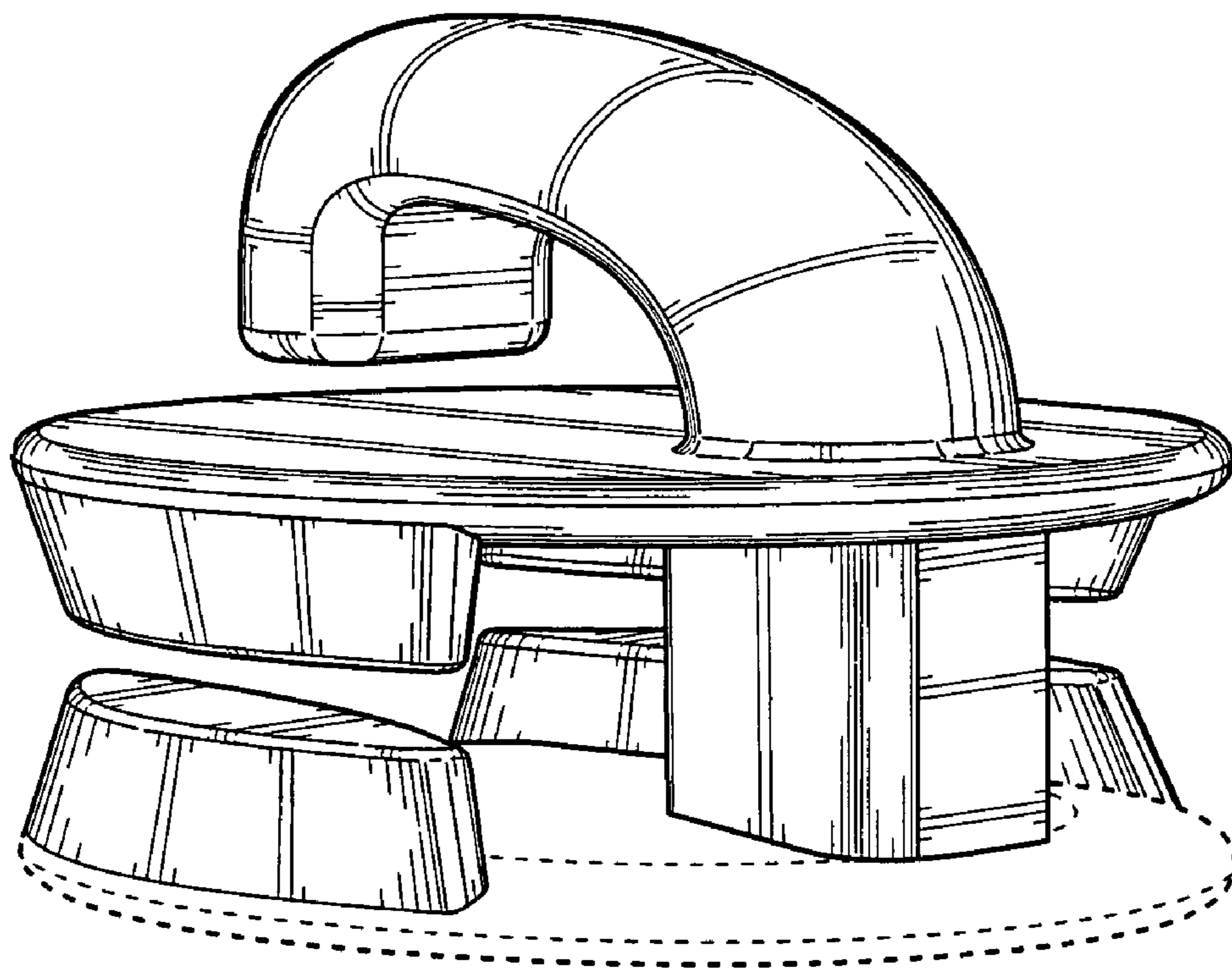

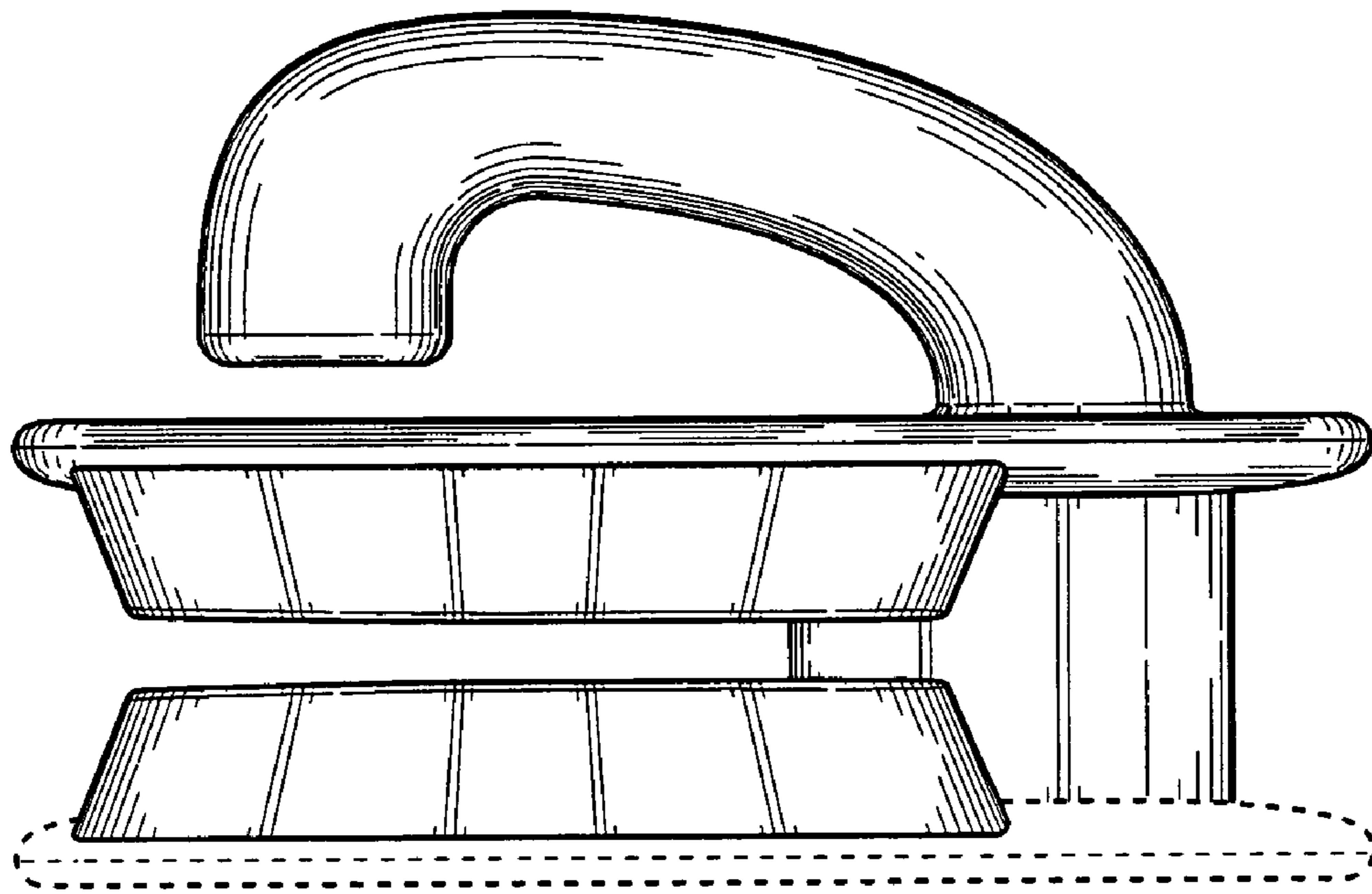

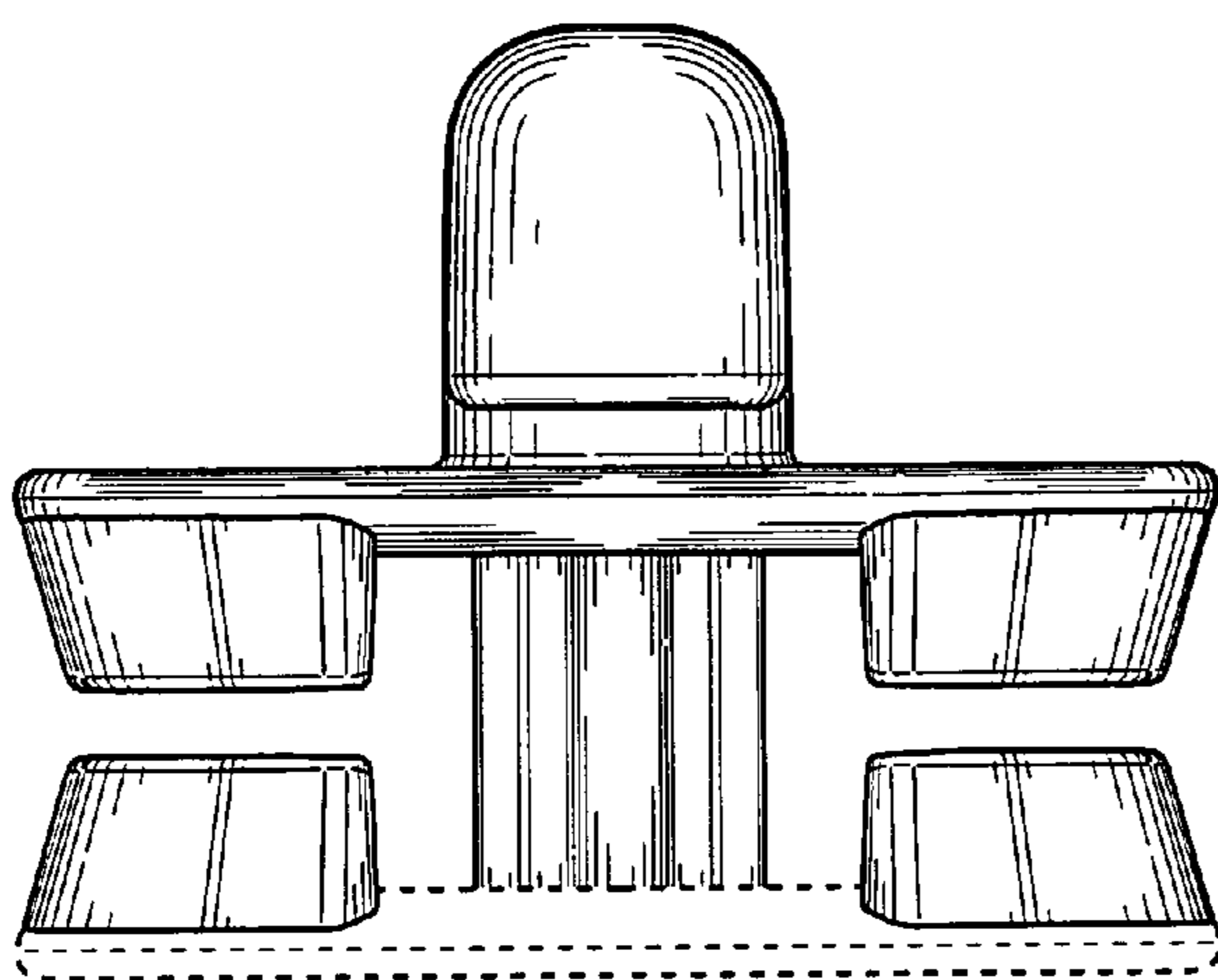

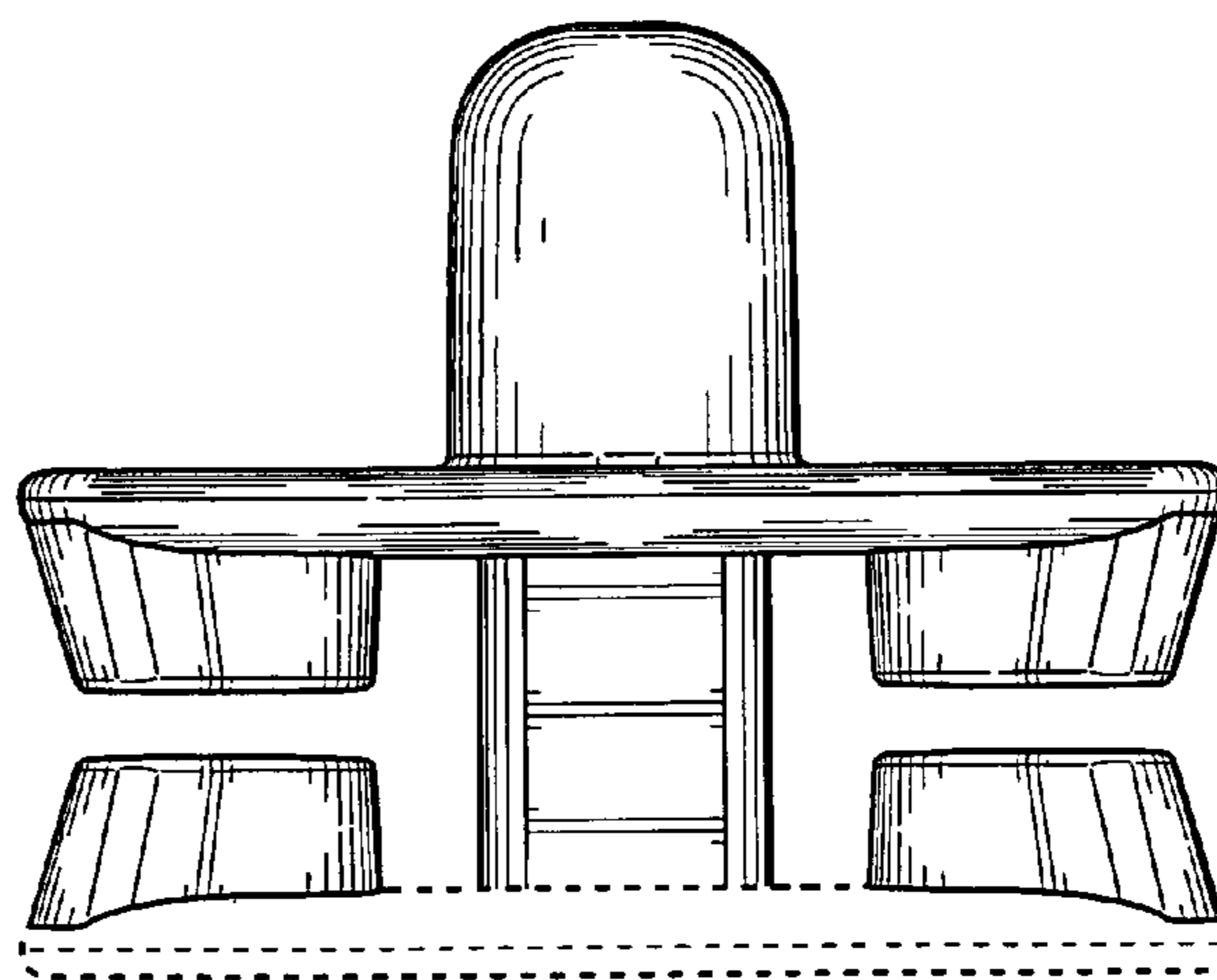

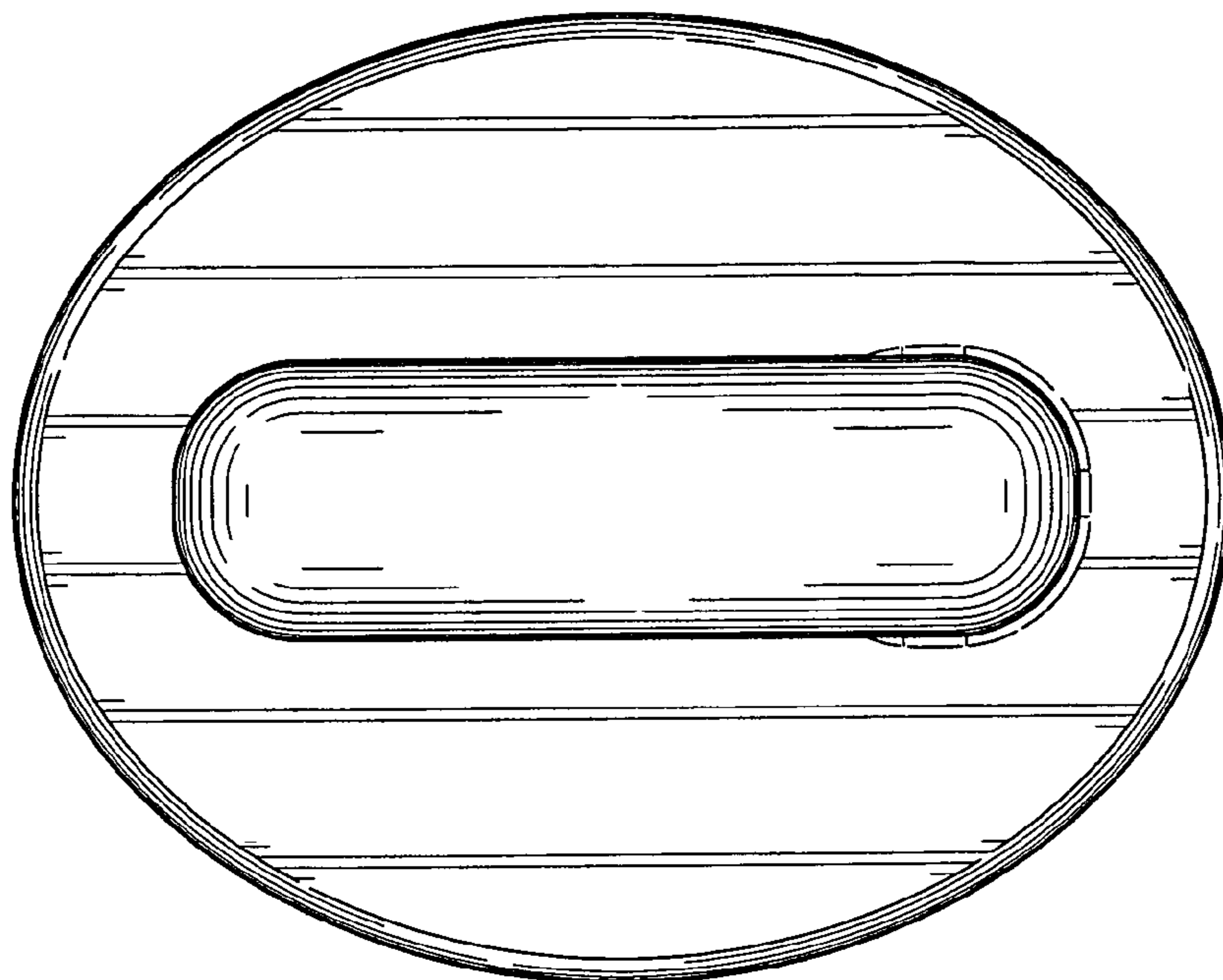

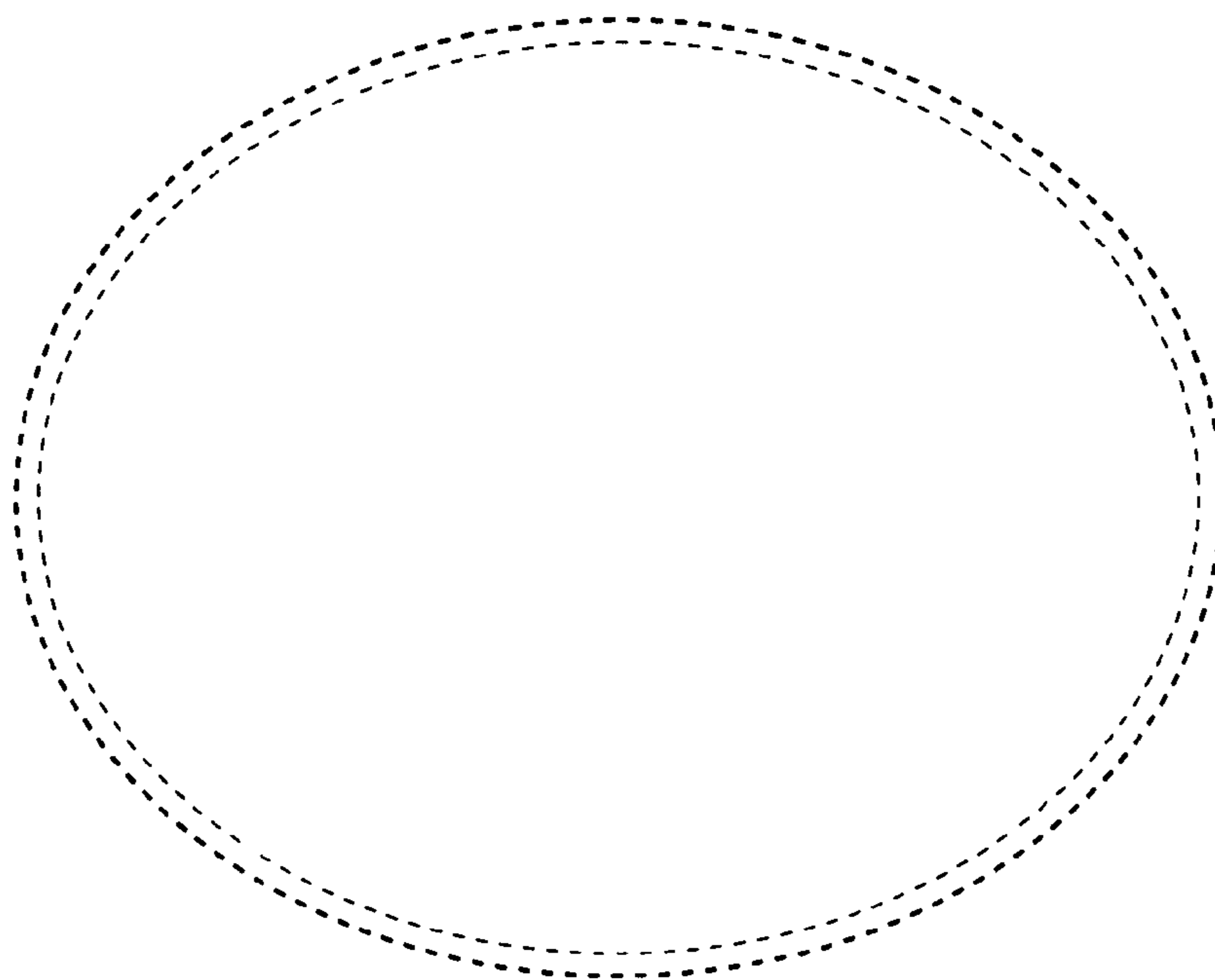
