DESCRIPTION

FIG. 1 is a rear elevation view of a connector showing my design;

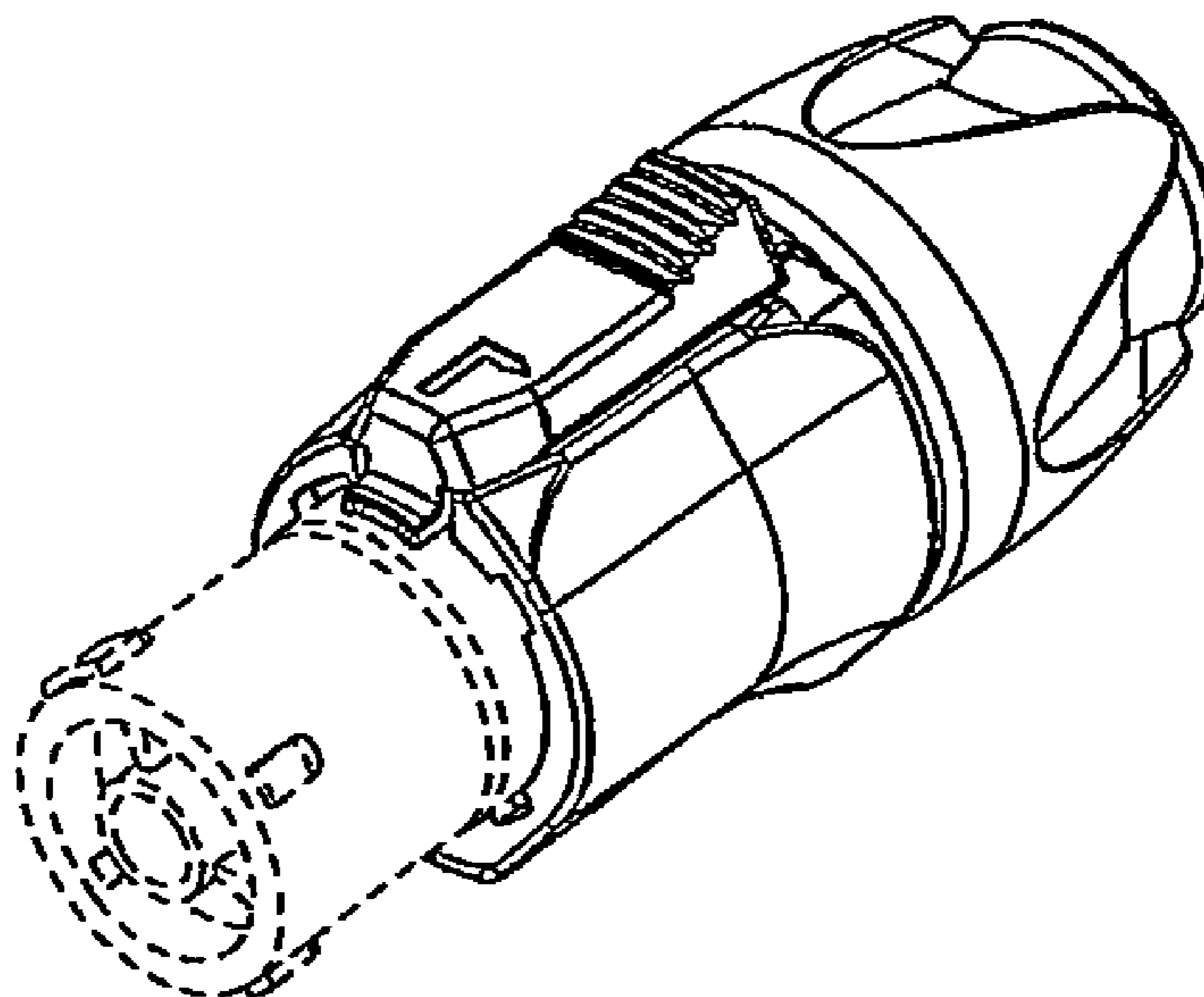

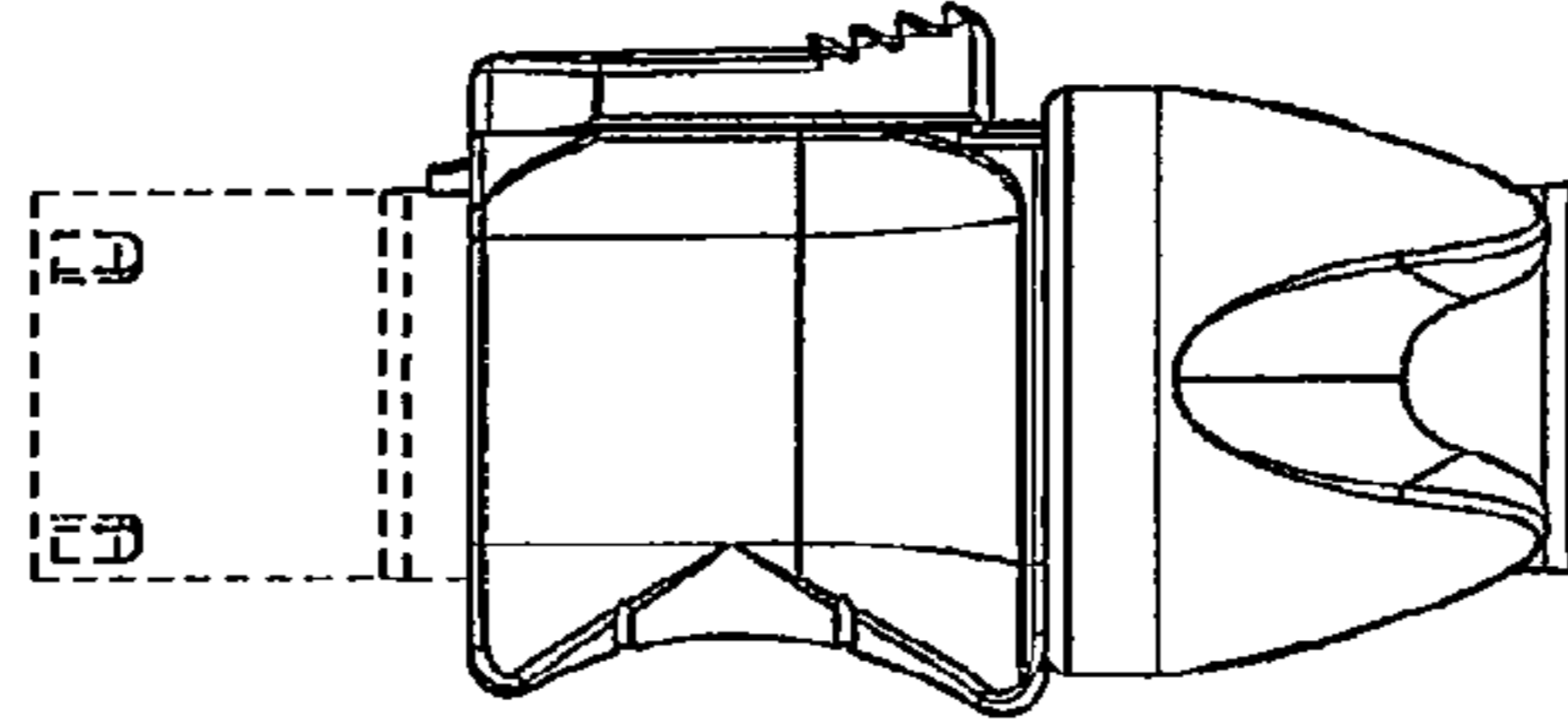

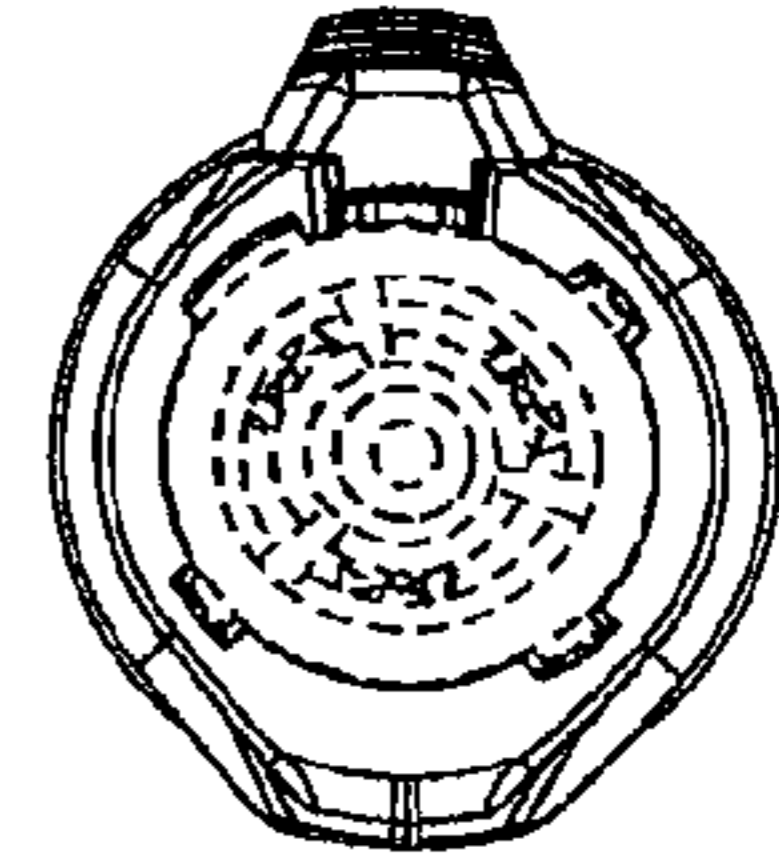

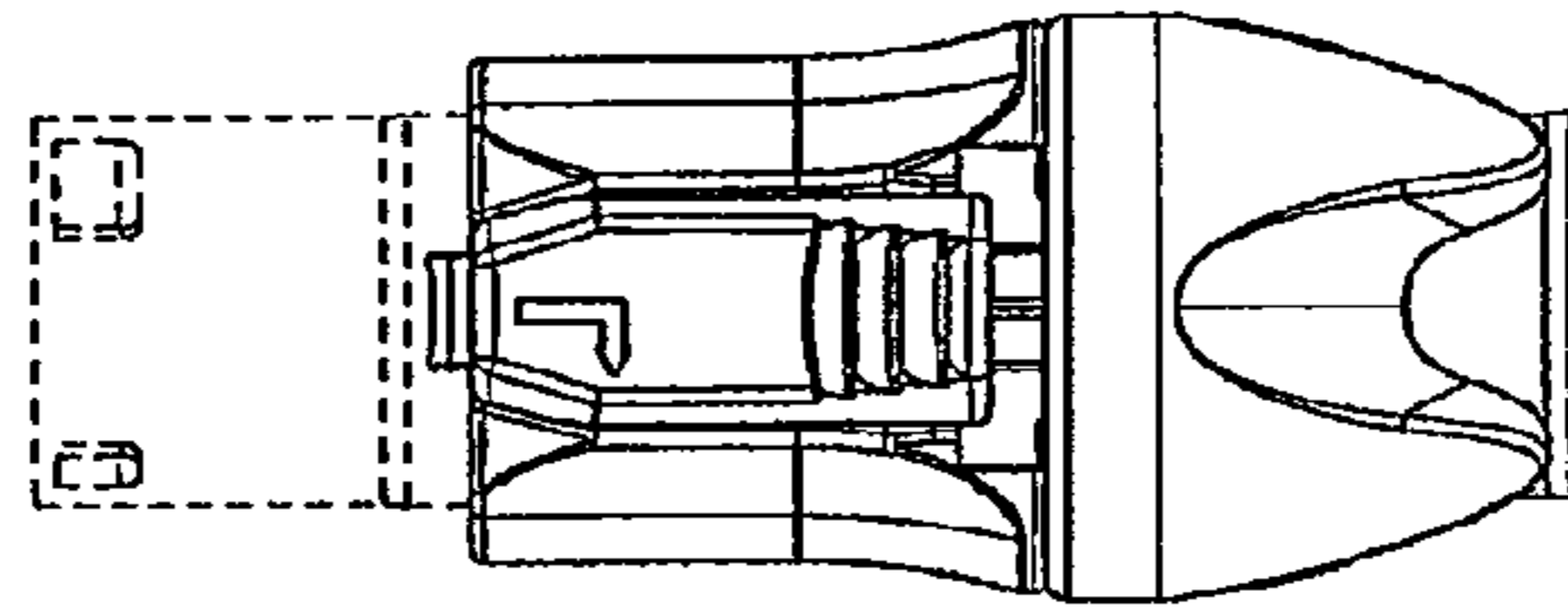

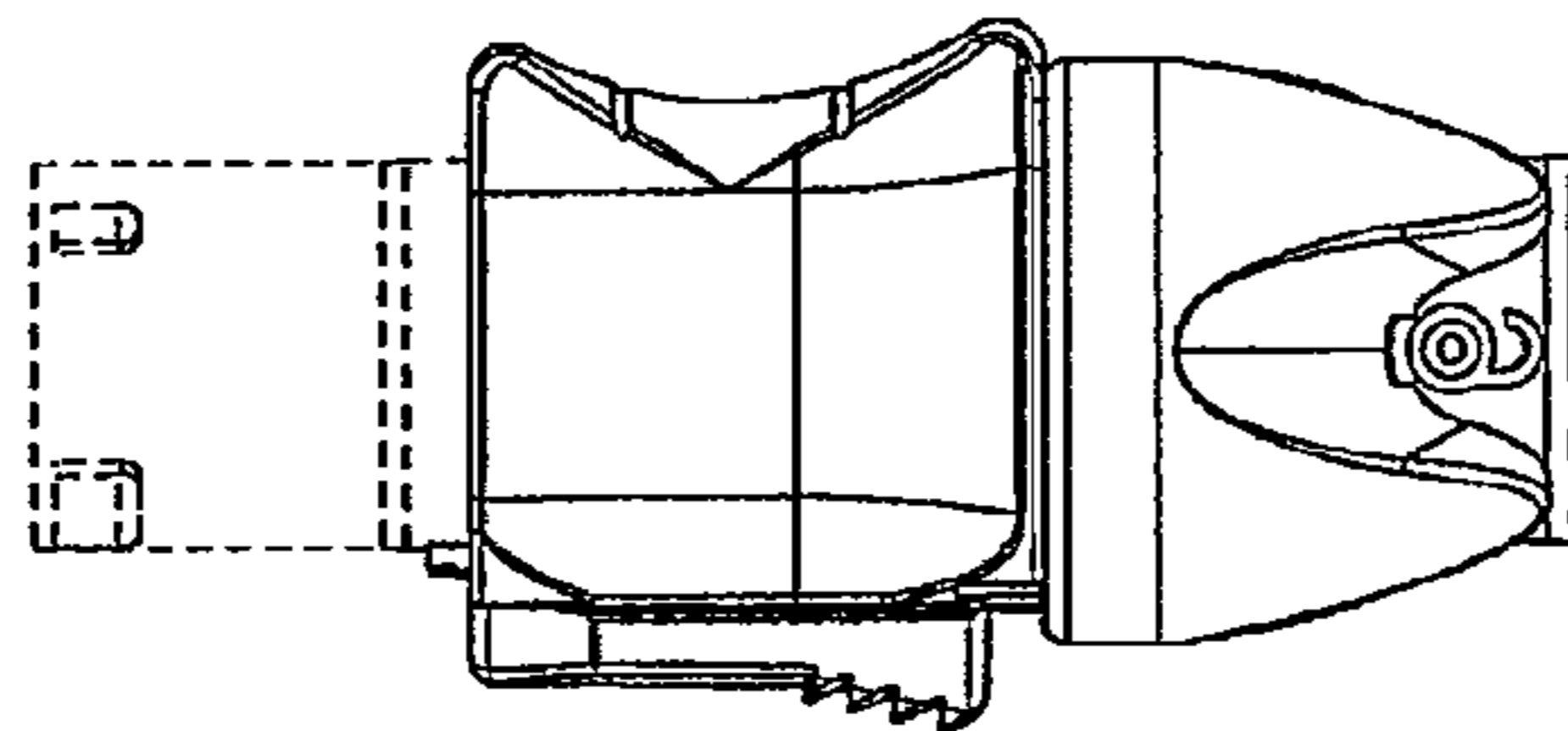

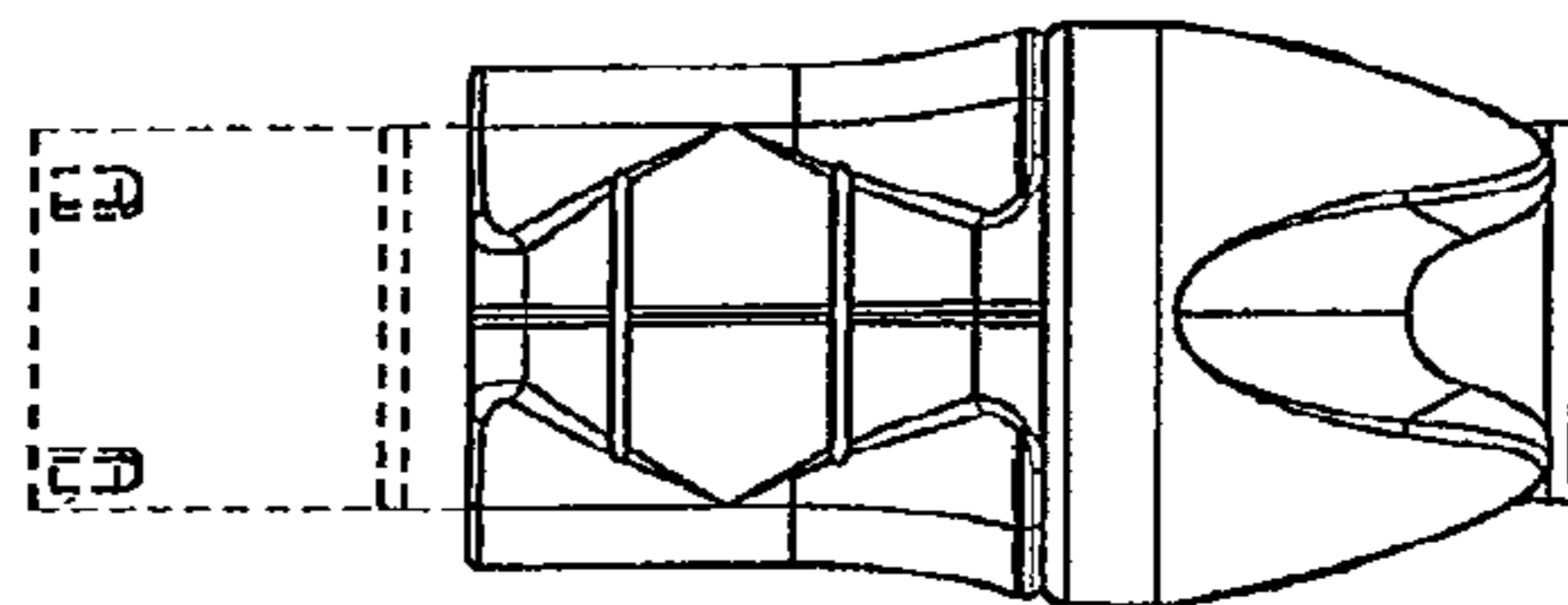

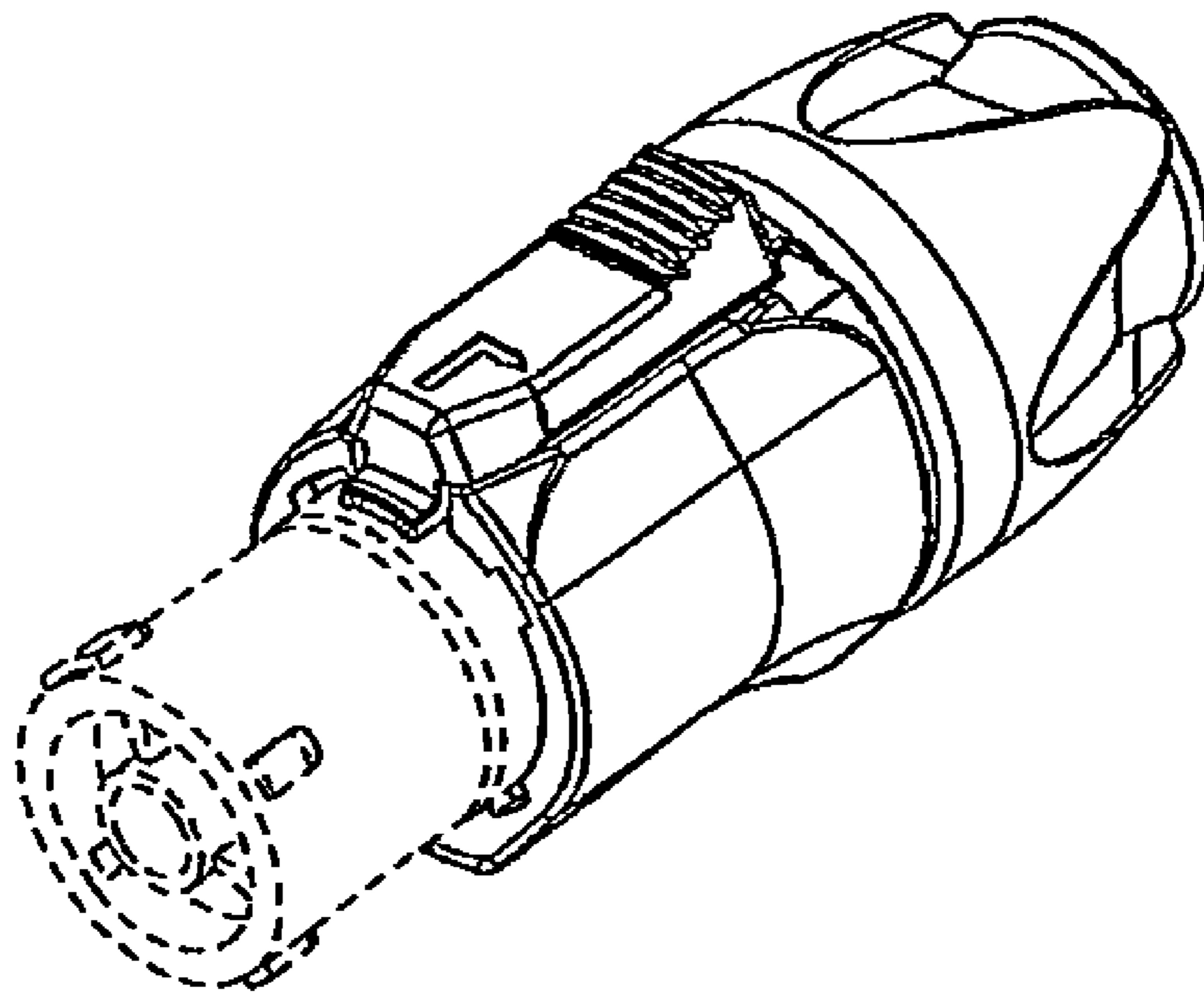
