(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile terminal; FIG. 2 is a front view of the mobile terminal of FIG. 1; FIG. 3 is a rear view of the mobile terminal of FIG. 1; FIG. 4 is a left-side view of the mobile terminal of FIG. 1; FIG. 5 is a right-side view of the mobile terminal of FIG. 1; FIG. 6 is a top plan view of the mobile terminal of FIG. 1; and, FIG. 7 is a bottom plan view of the mobile terminal of figure. Features shown in broken lines in FIGS. 1 and 2 form no part of the claimed design.

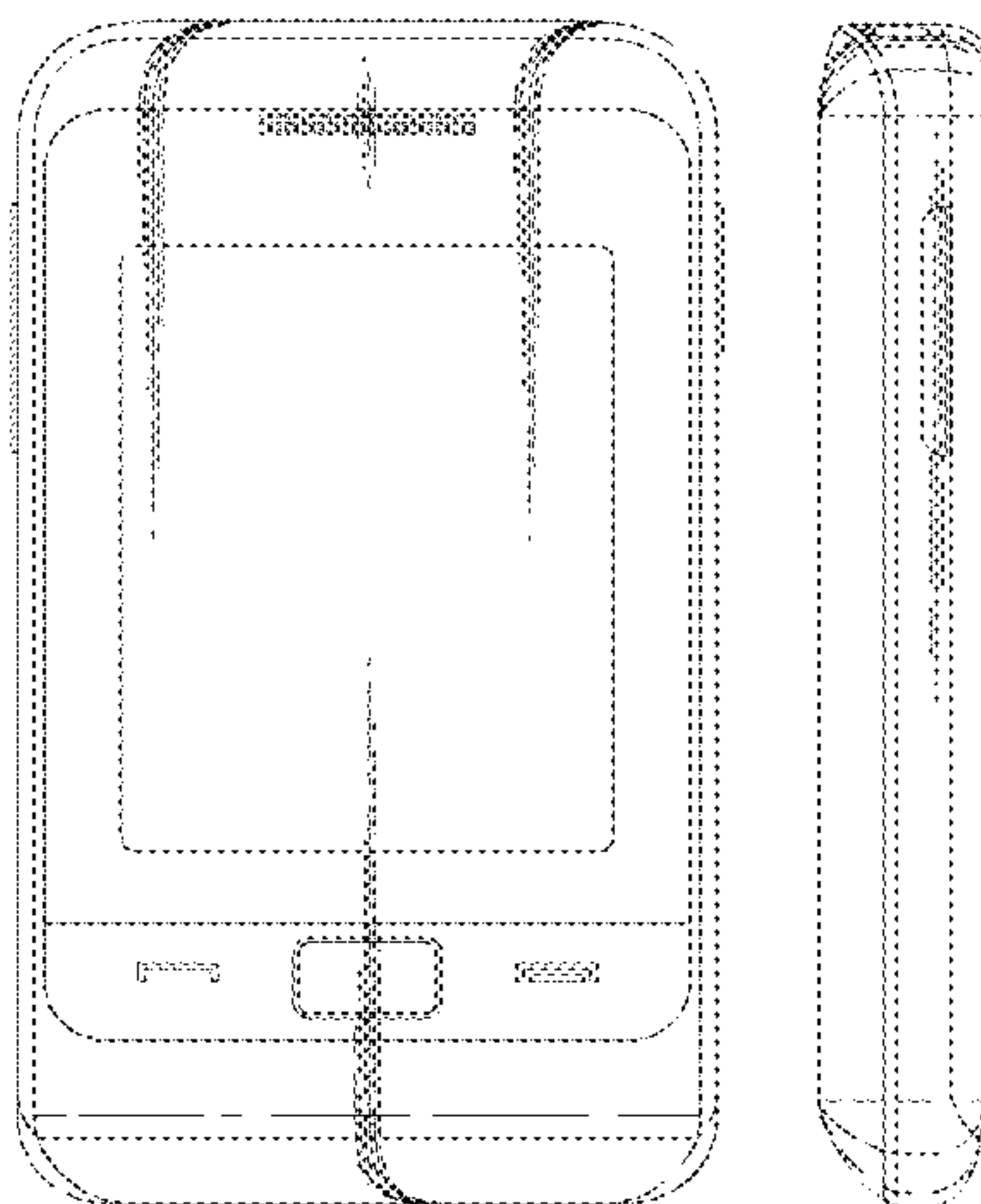

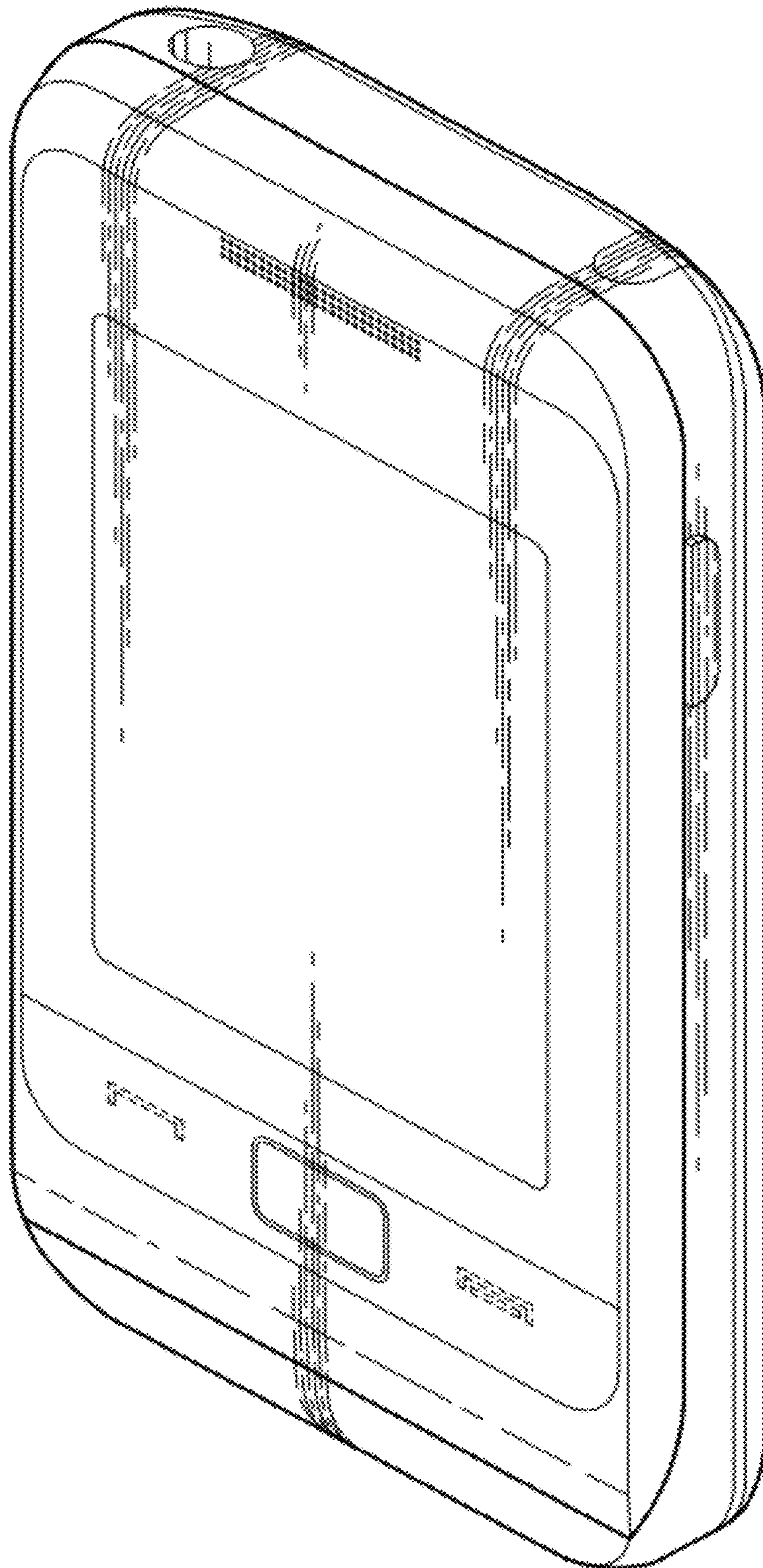

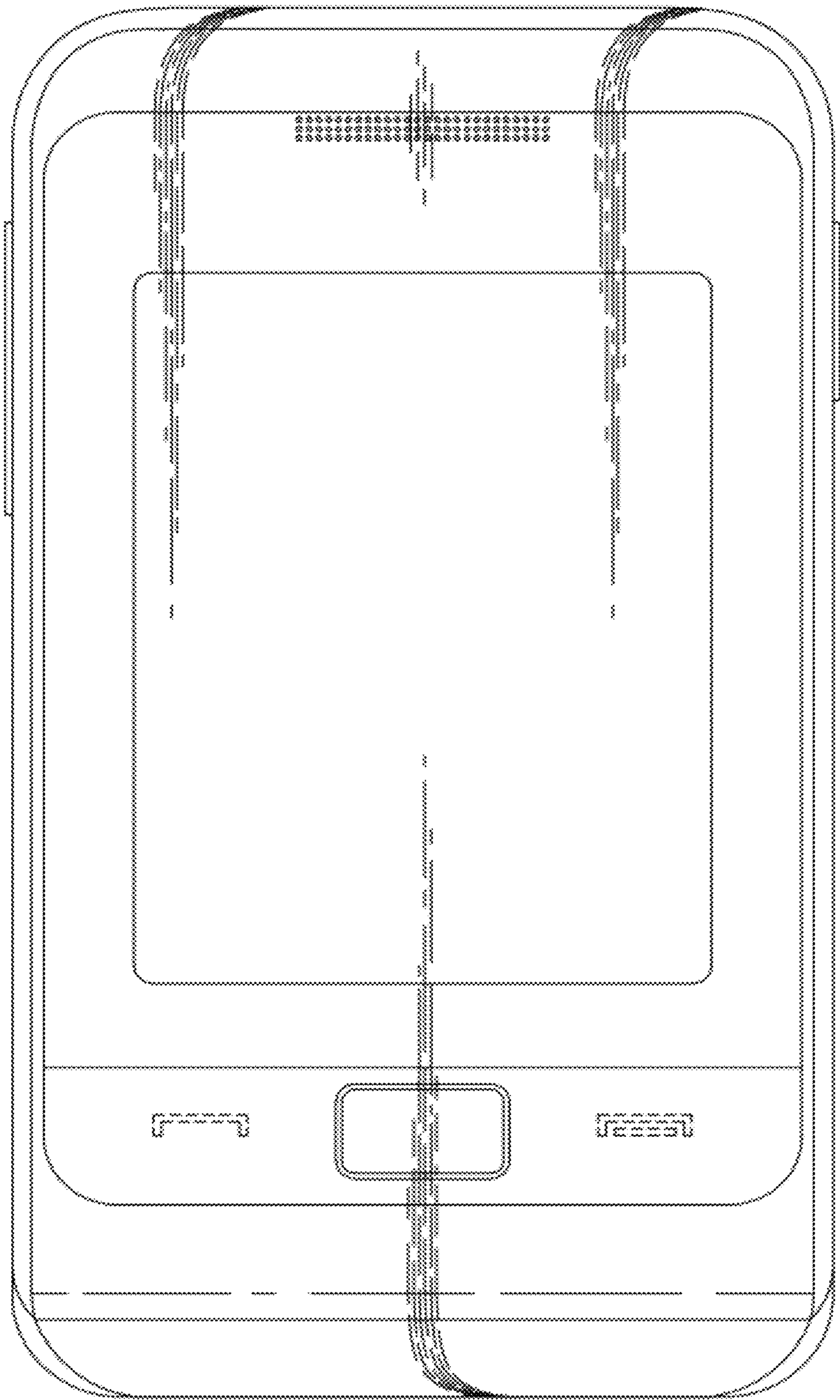

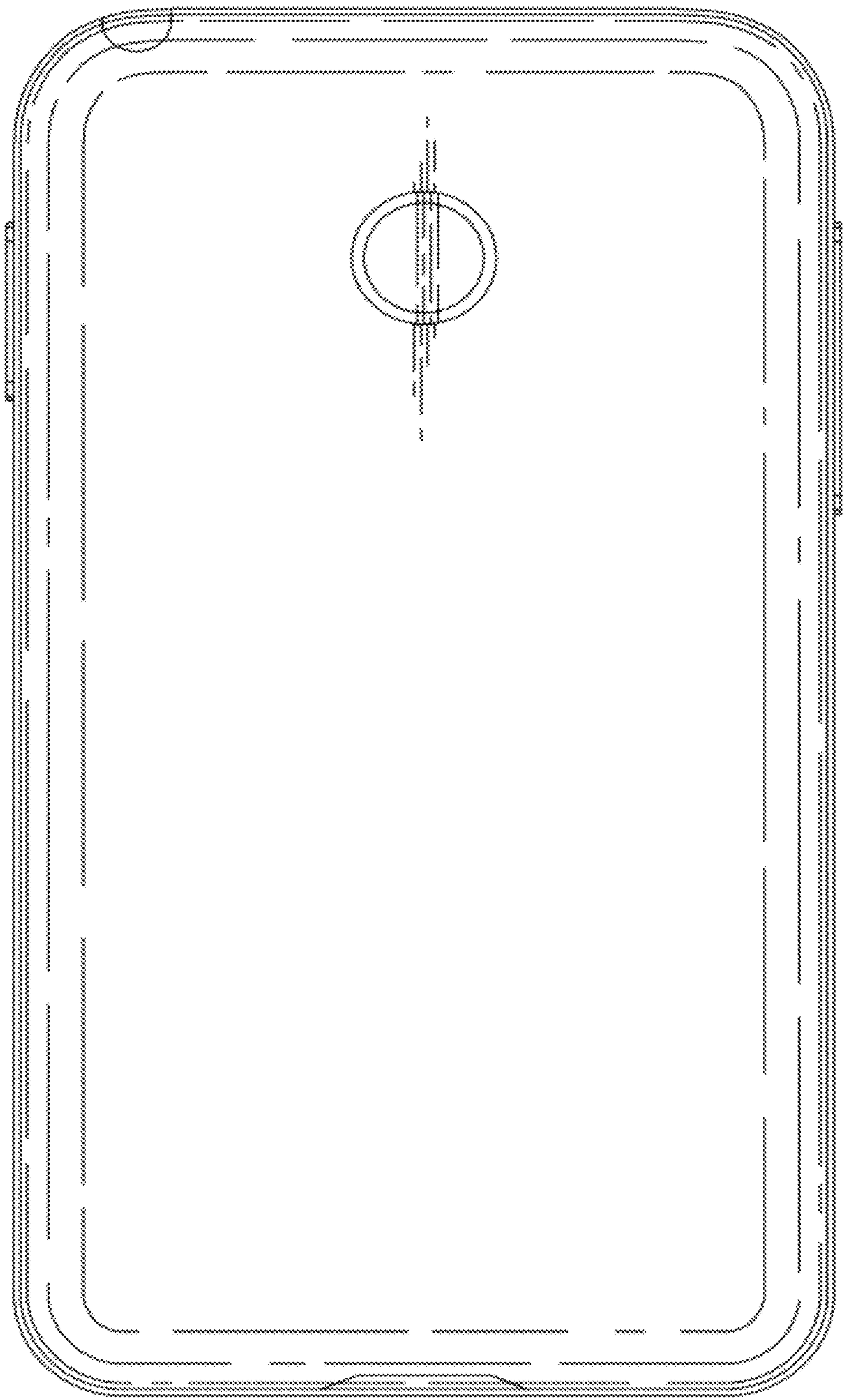

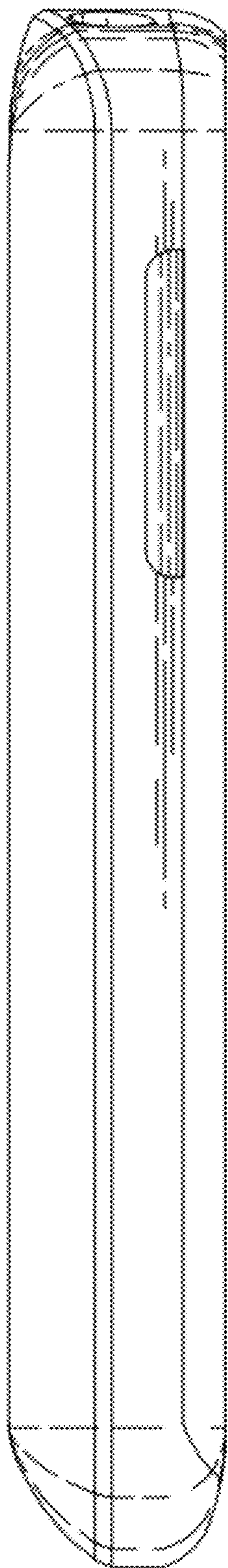

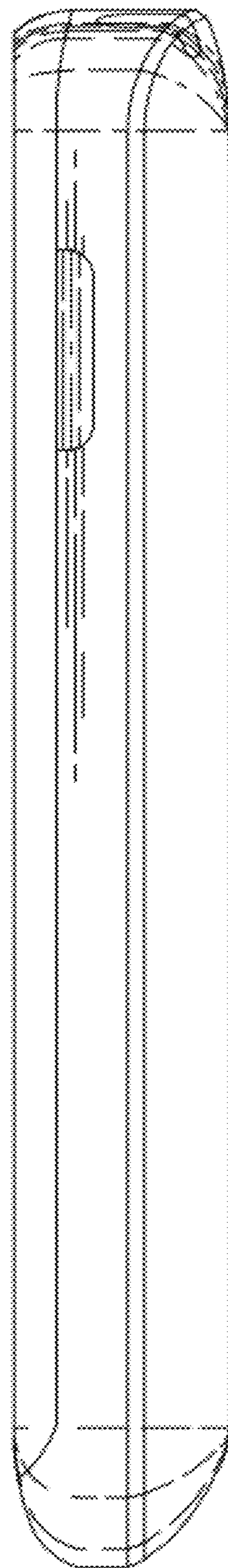

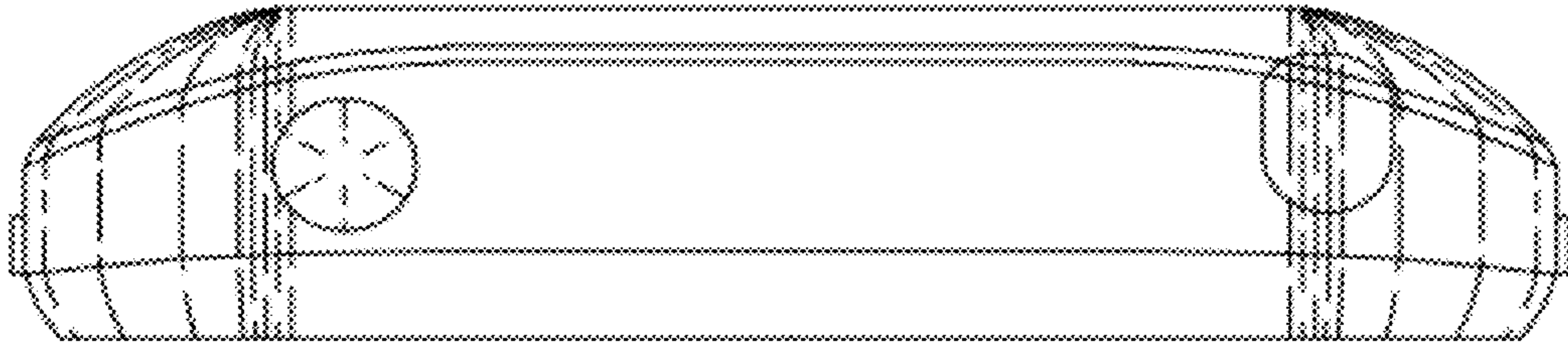
