(57) **CLAIM**

The ornamental design for an electronic device mount, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of the electronic device mount, with an electronic device attached.

FIG. 2 is a perspective front view of the electronic device mount, with the electronic device unattached.

FIG. 3 is a left side view of the electronic device mount, with an electronic device attached.

FIG. 4 is a top view of the electronic device mount, with an electronic device attached.

FIG. 5 is a bottom view of the electronic device mount, with an electronic device attached.

FIG. 6 is a bottom view of the electronic device mount, with an electronic device unattached.

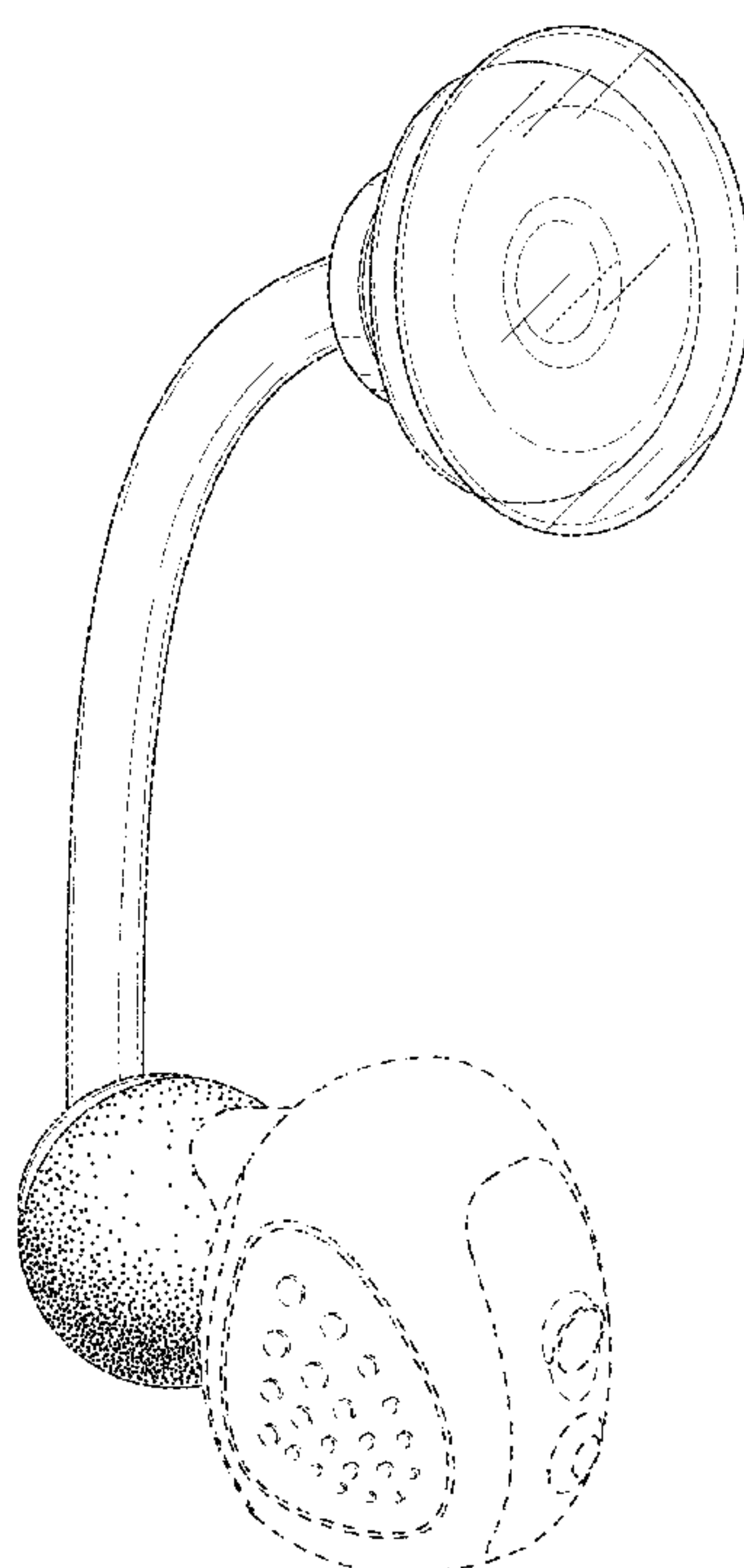
FIG. 7 is a rear view of the electronic device mount, with an electronic device attached.

FIG. 8 is a front view of the electronic device mount, an electronic device attached; and,

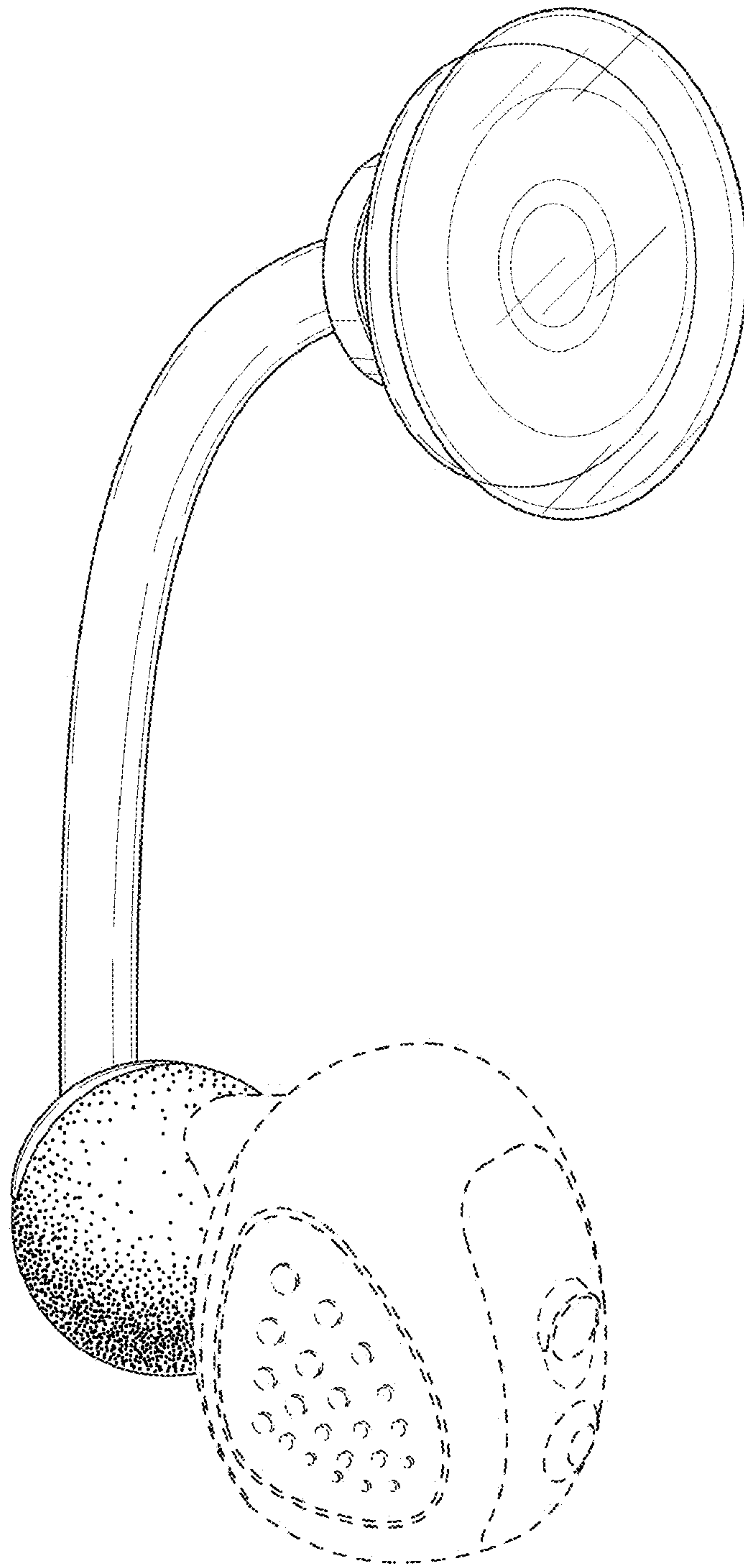

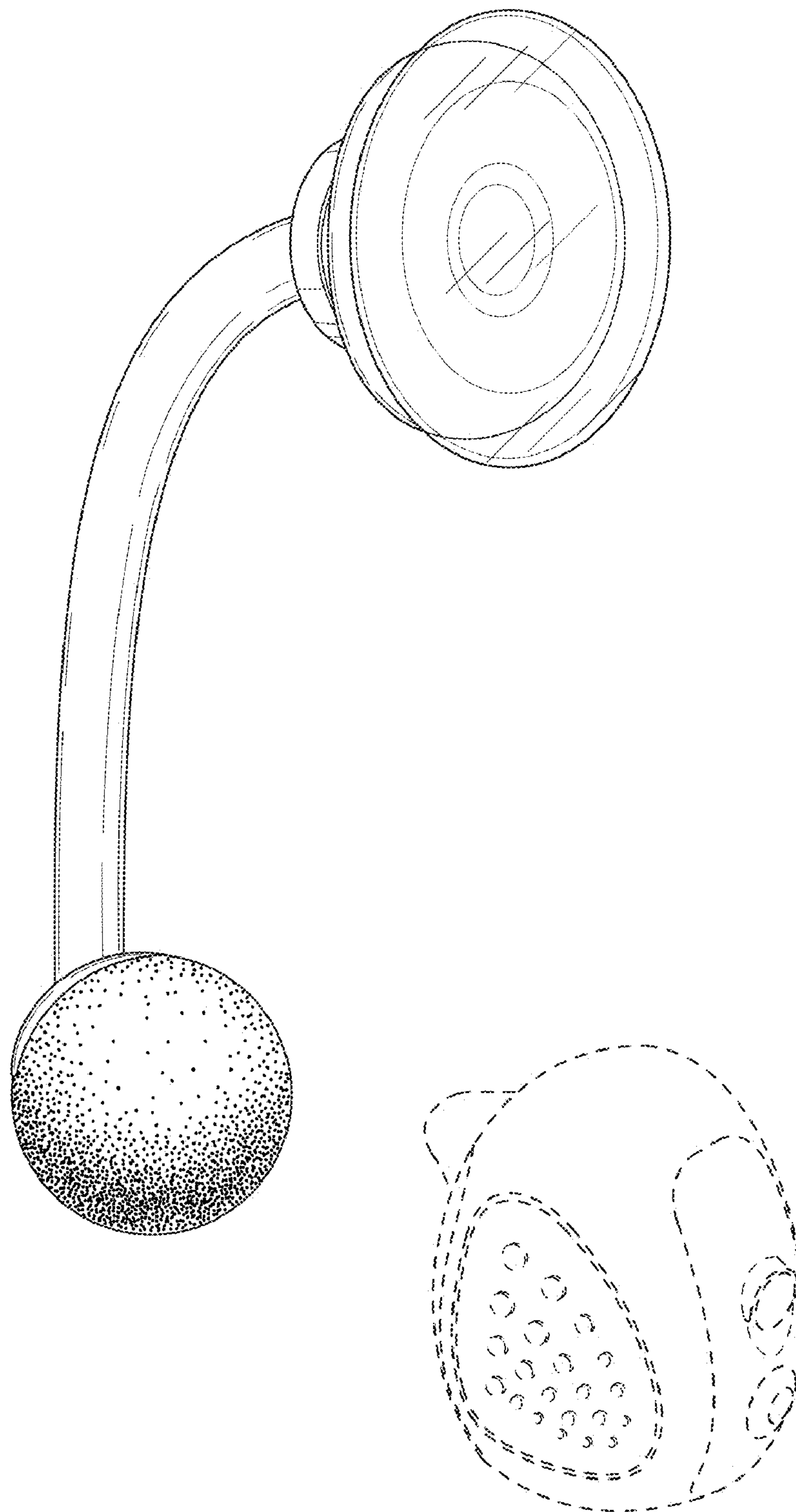

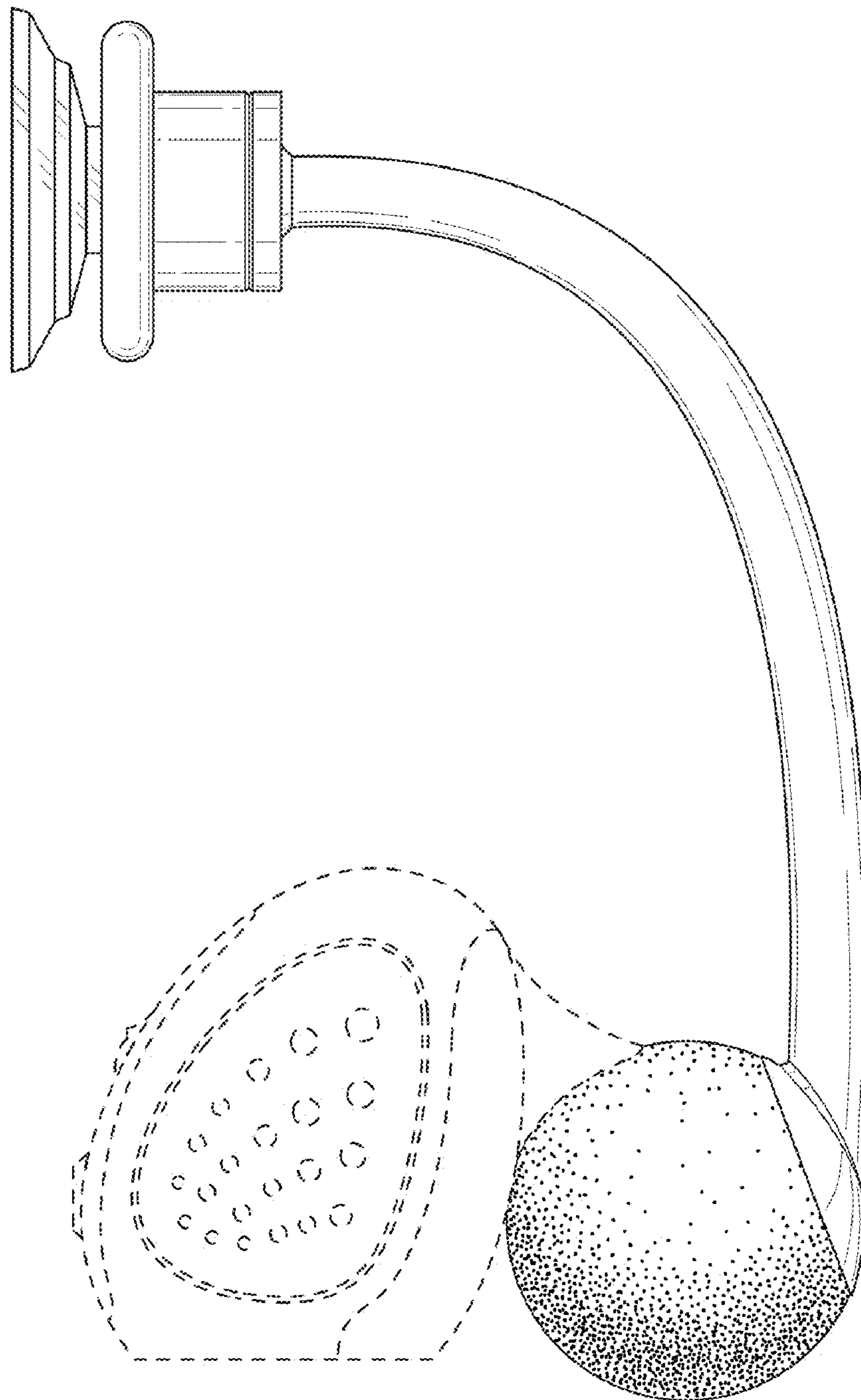

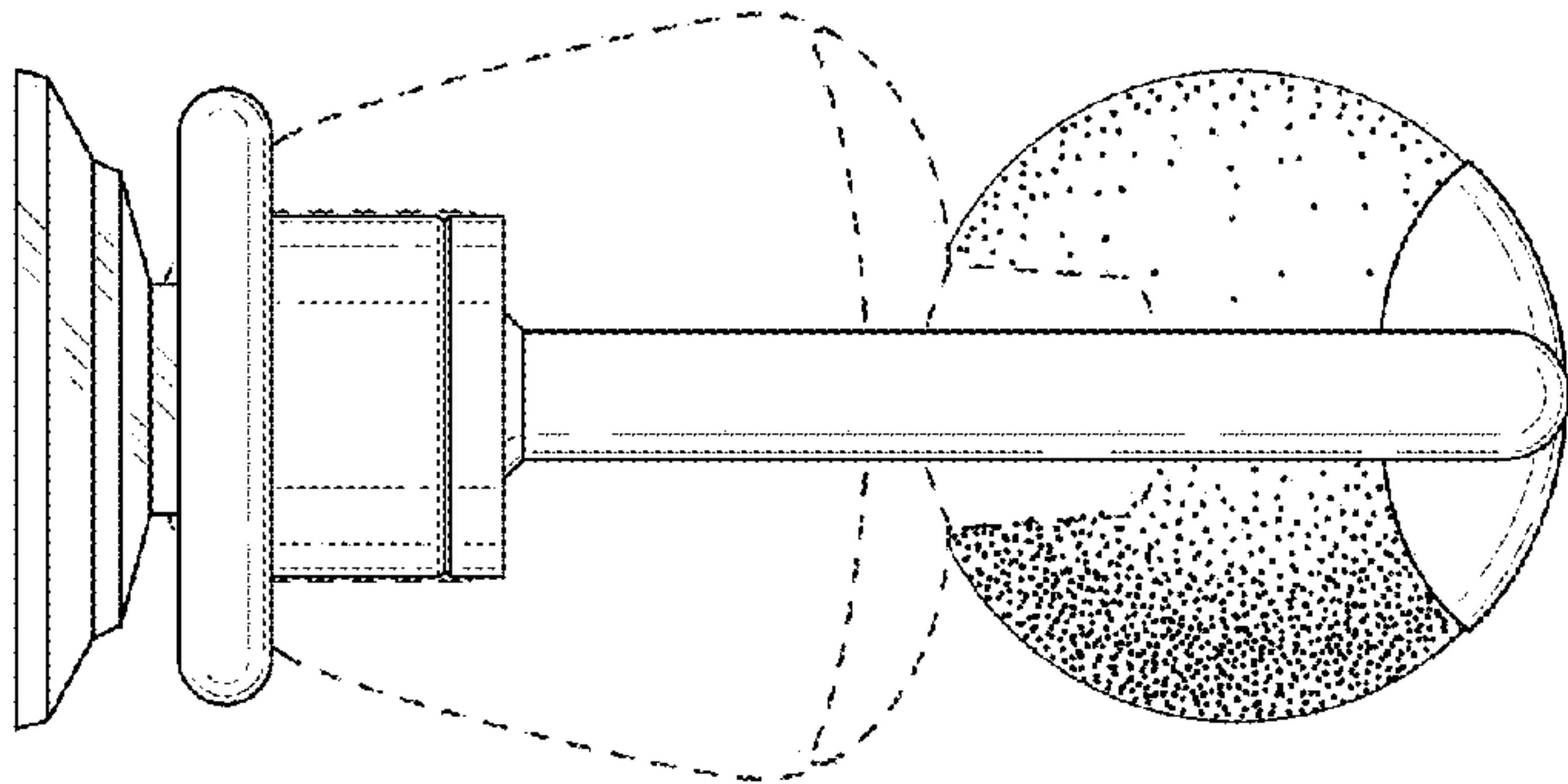

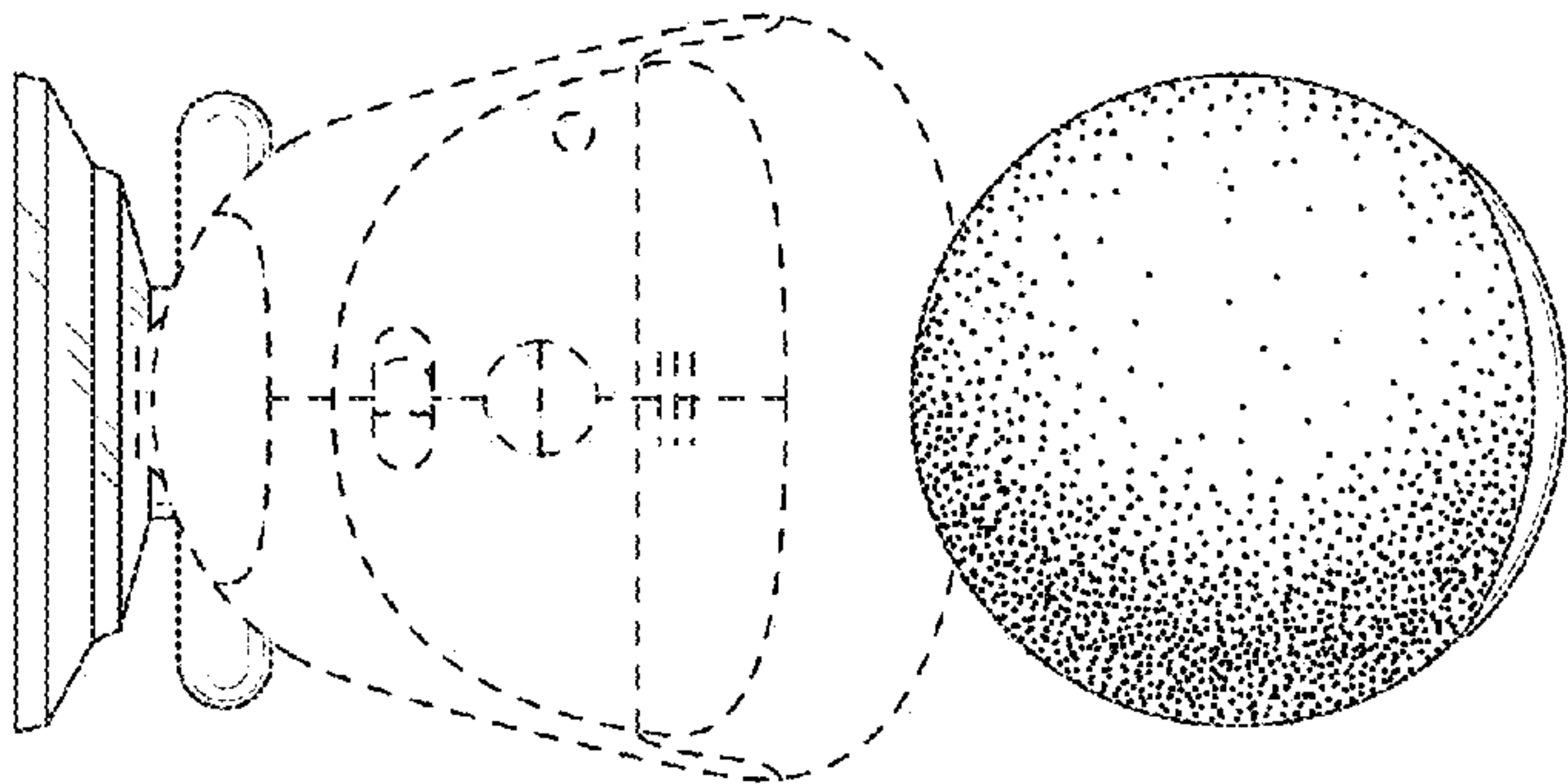
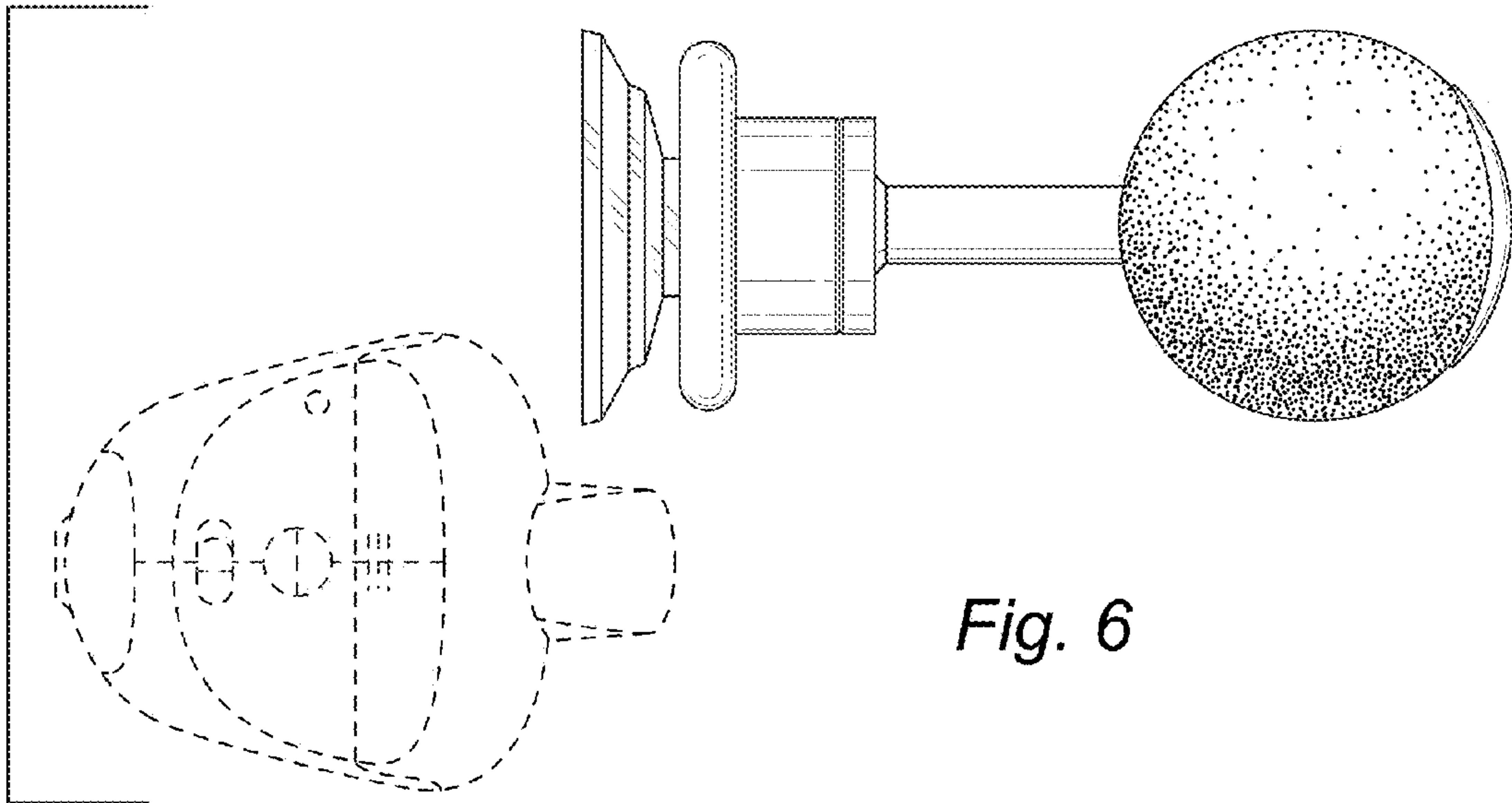

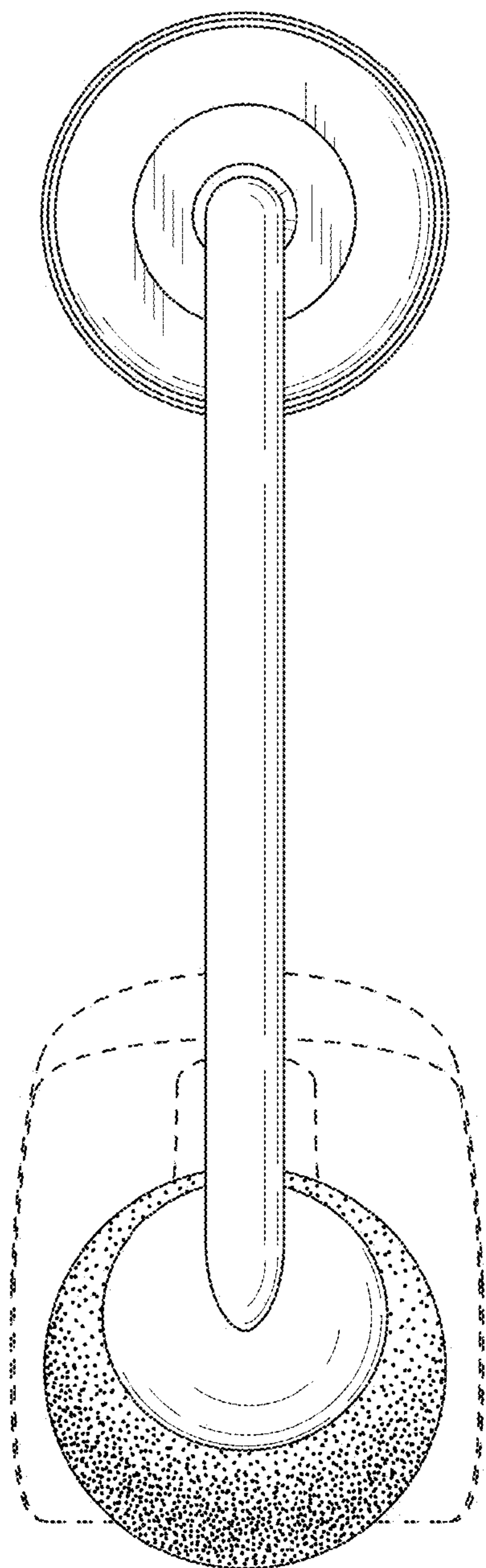

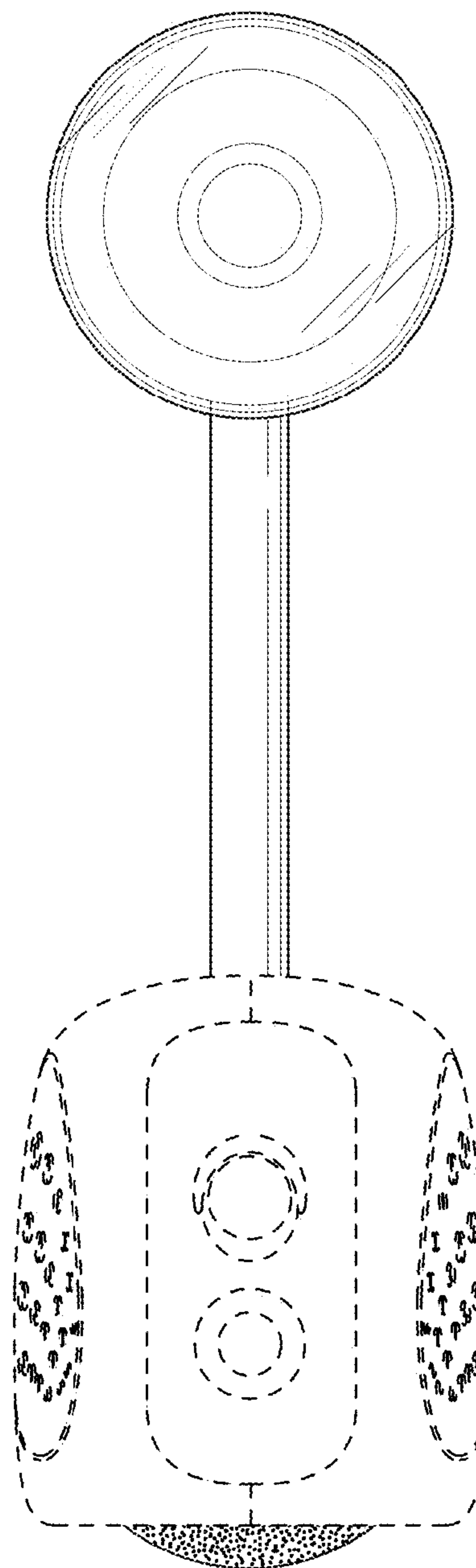

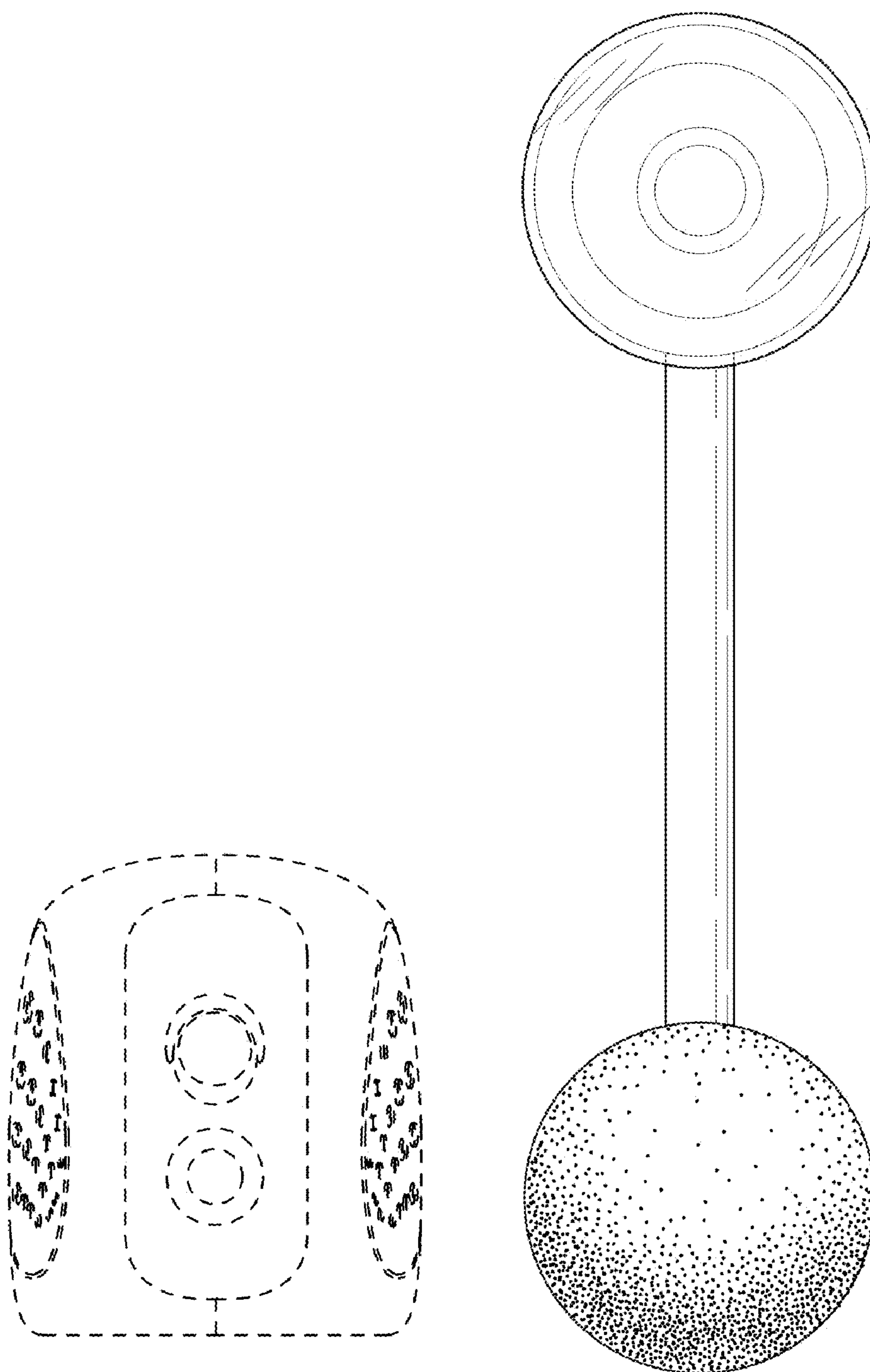
