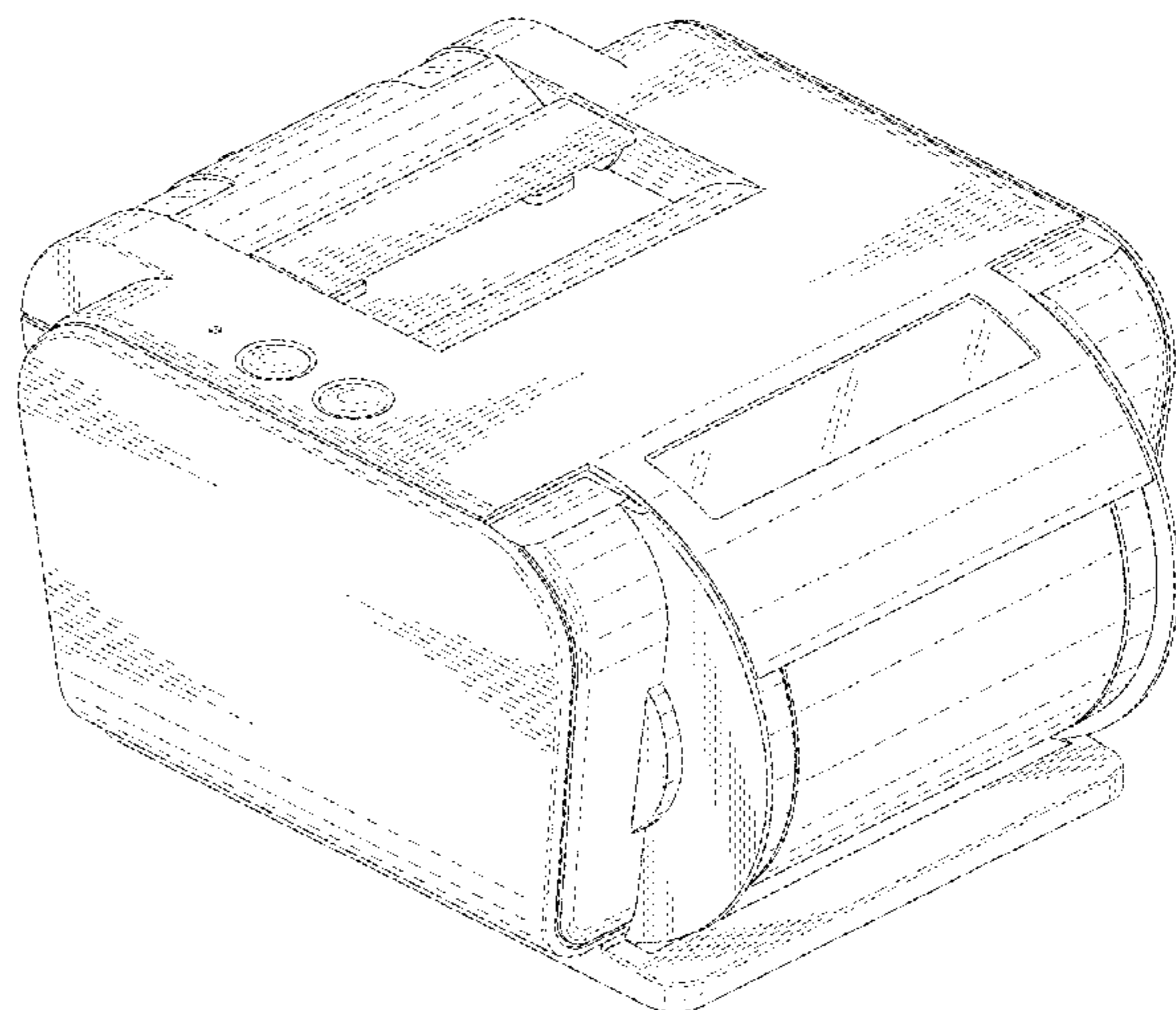
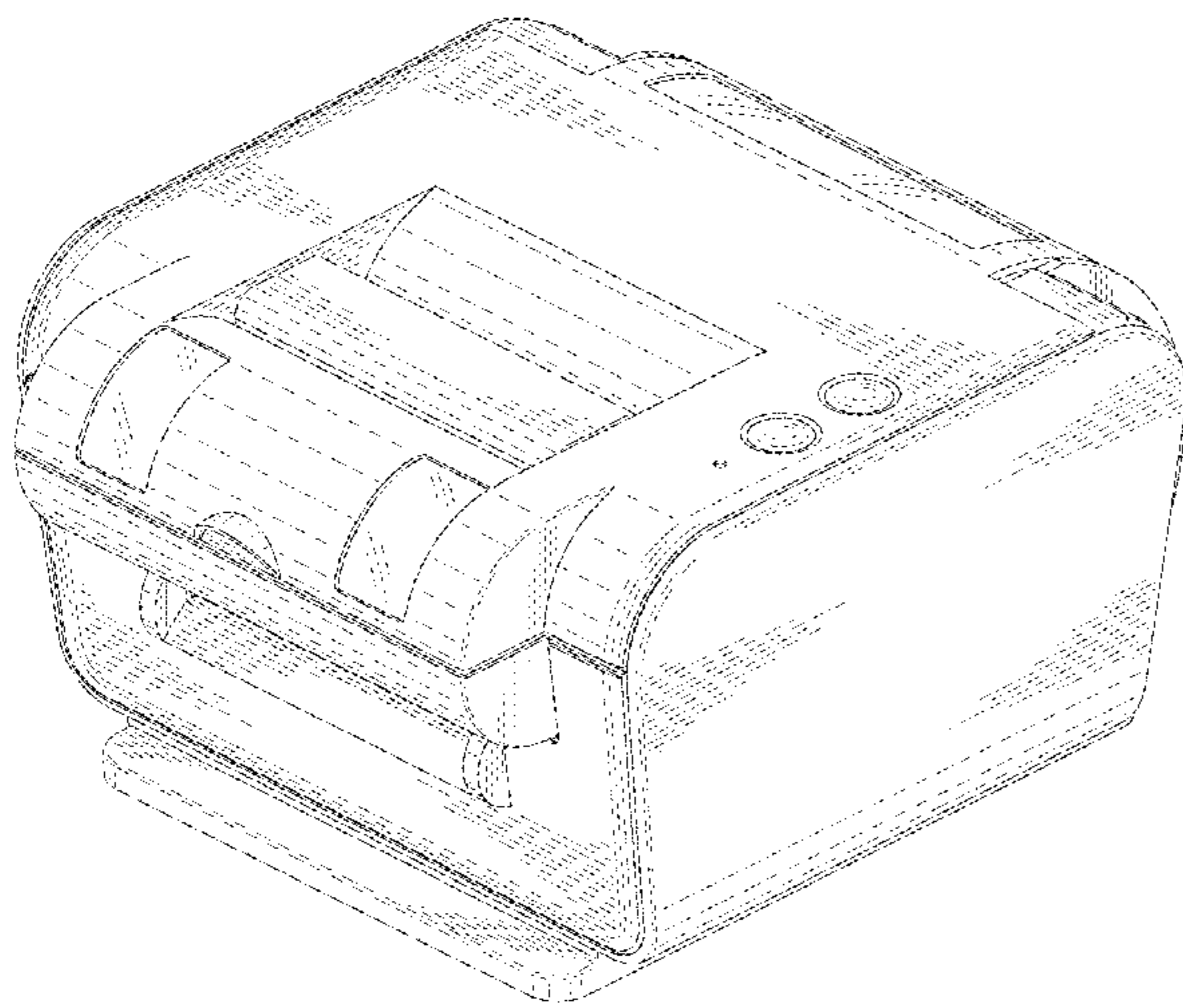
(57) **CLAIM**

The ornamental design for a label printer, as shown.

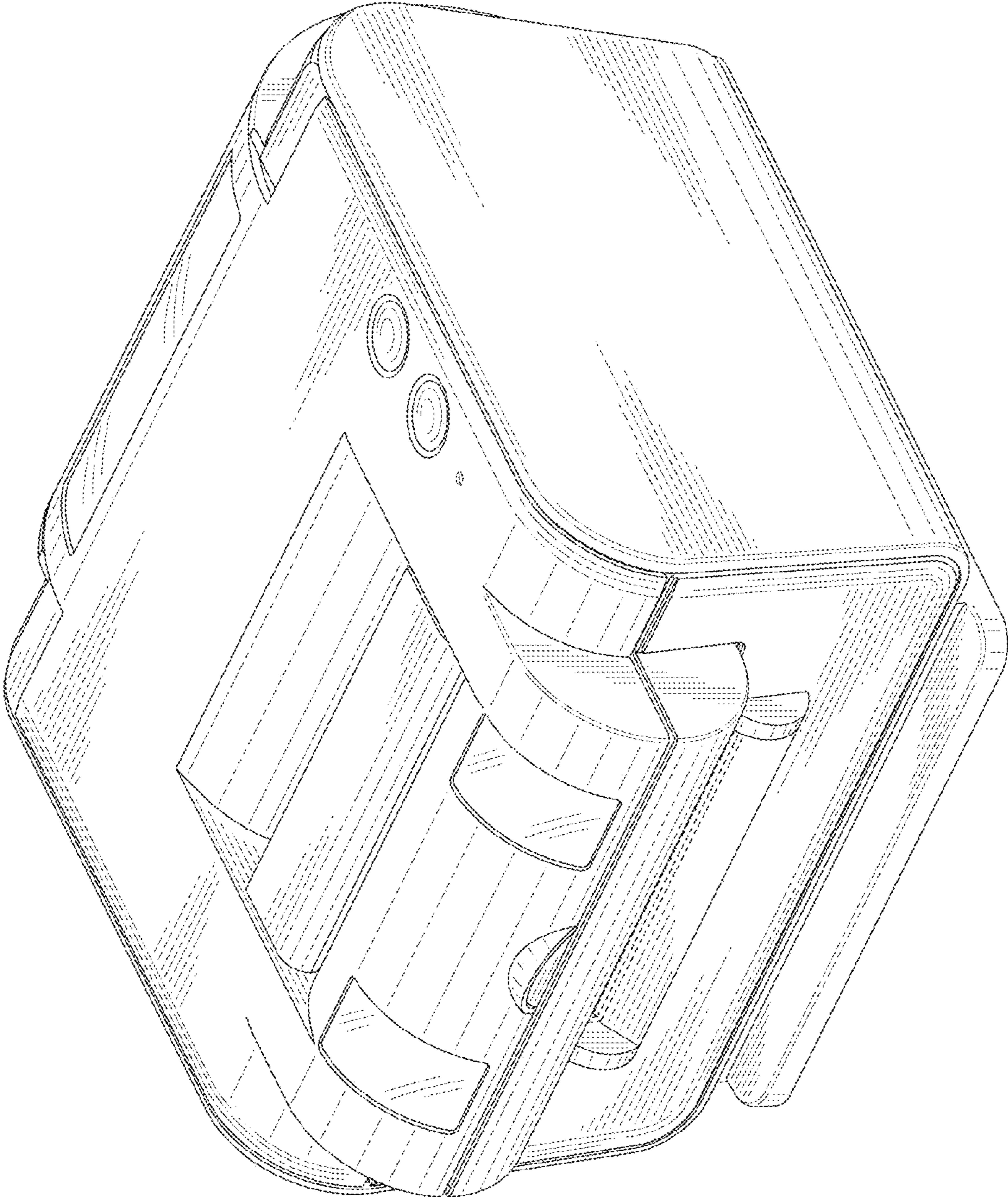
**DESCRIPTION**

FIG. 8 is a left side elevational view thereof.

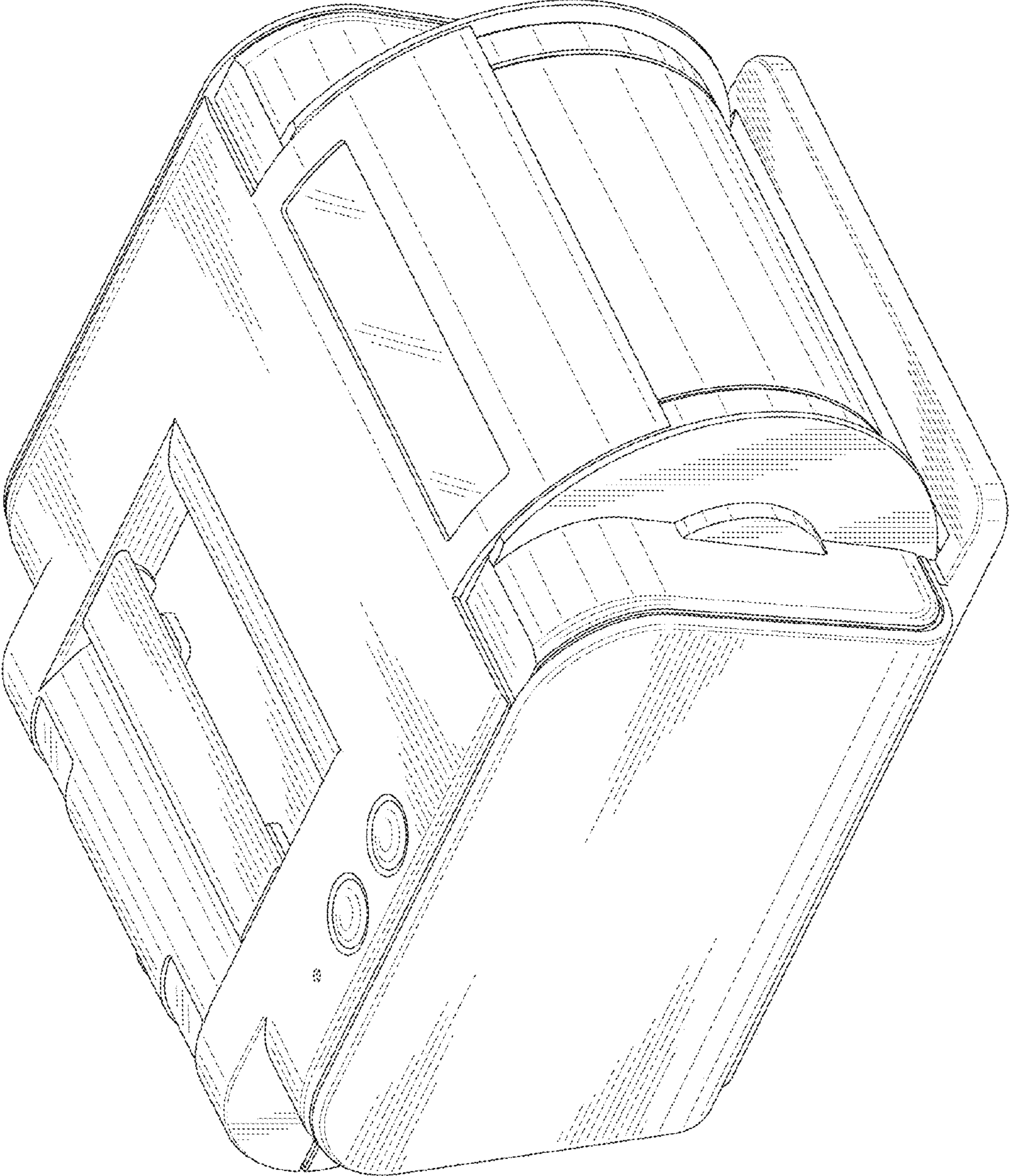

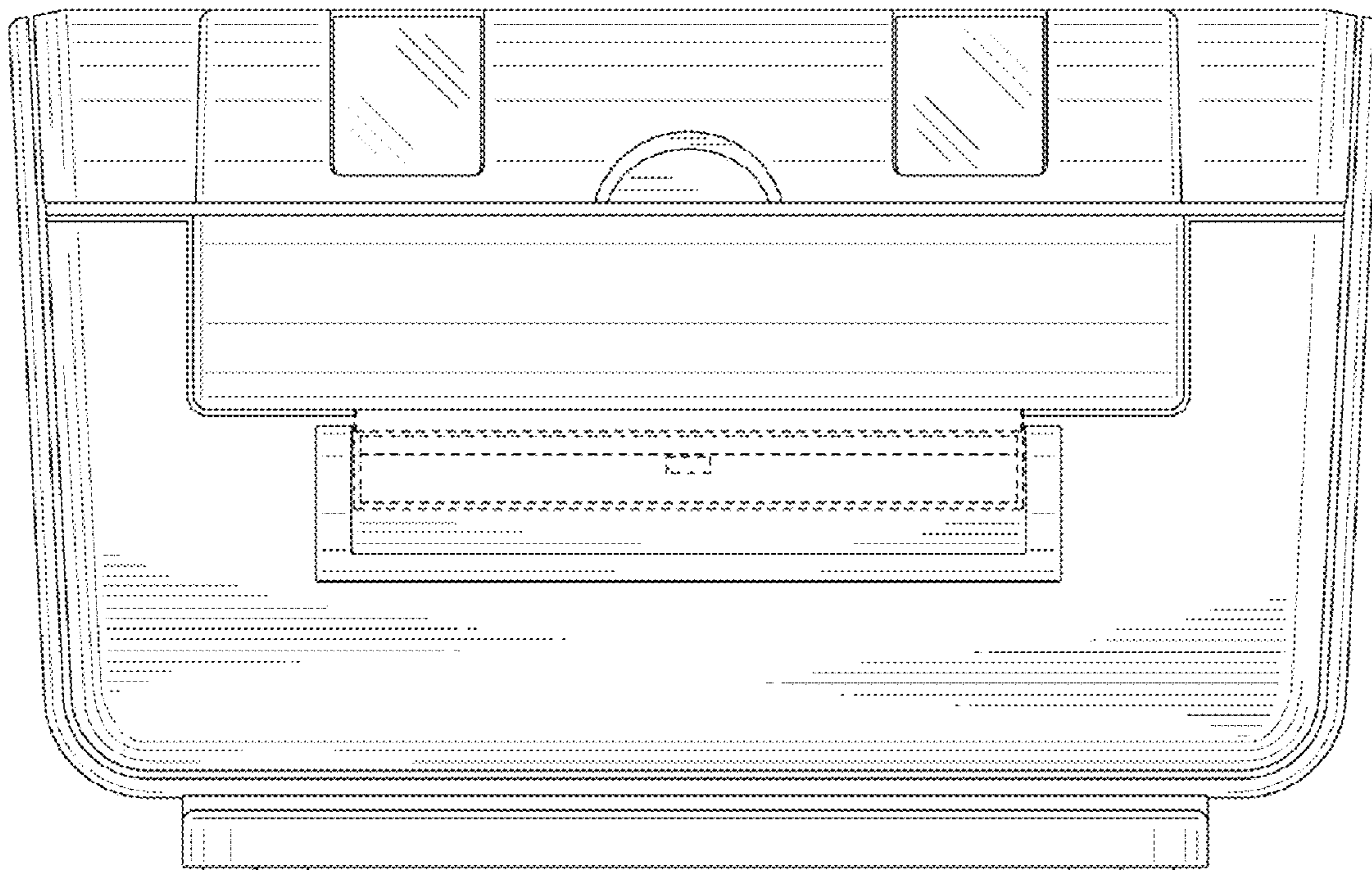

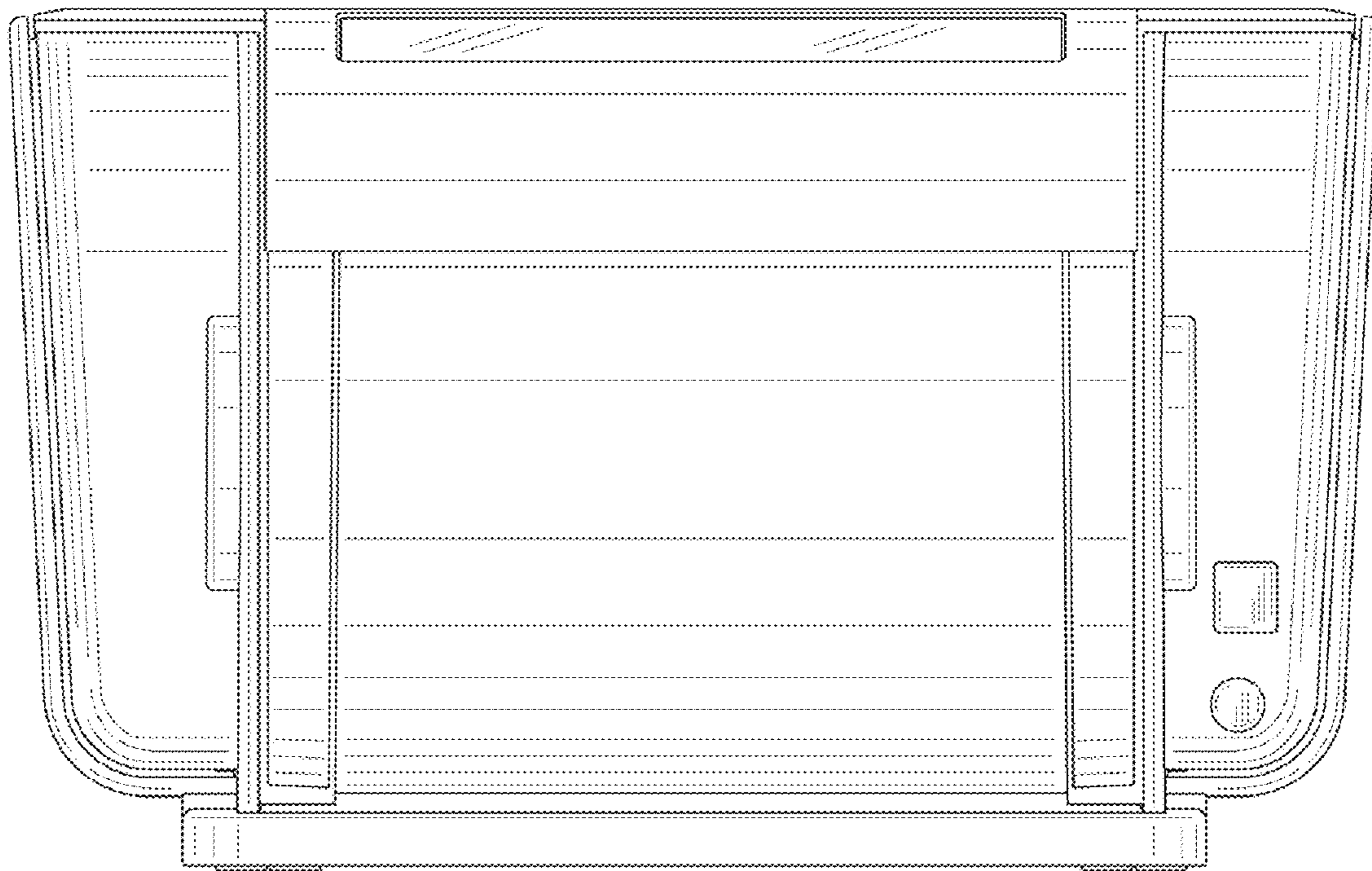

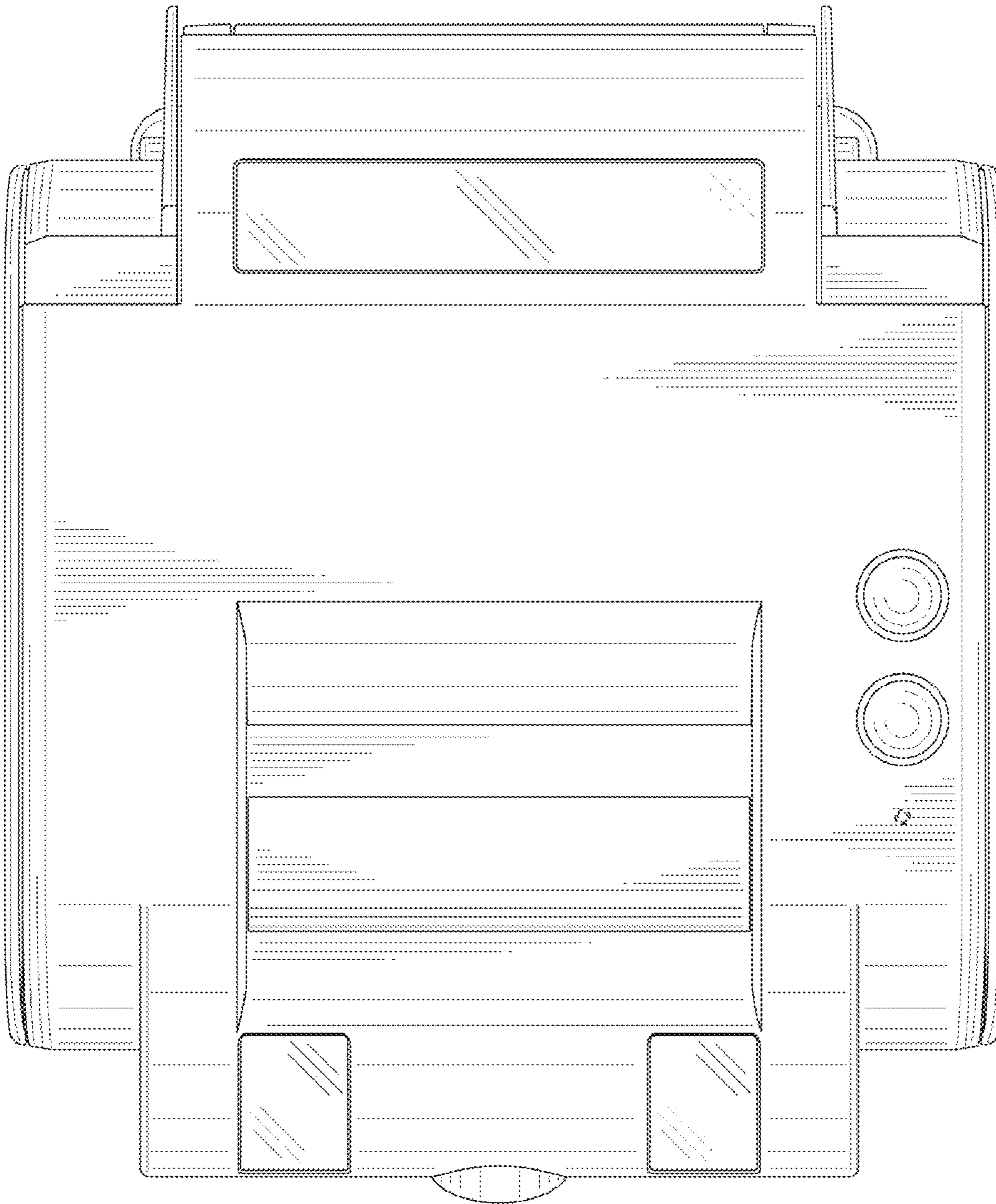

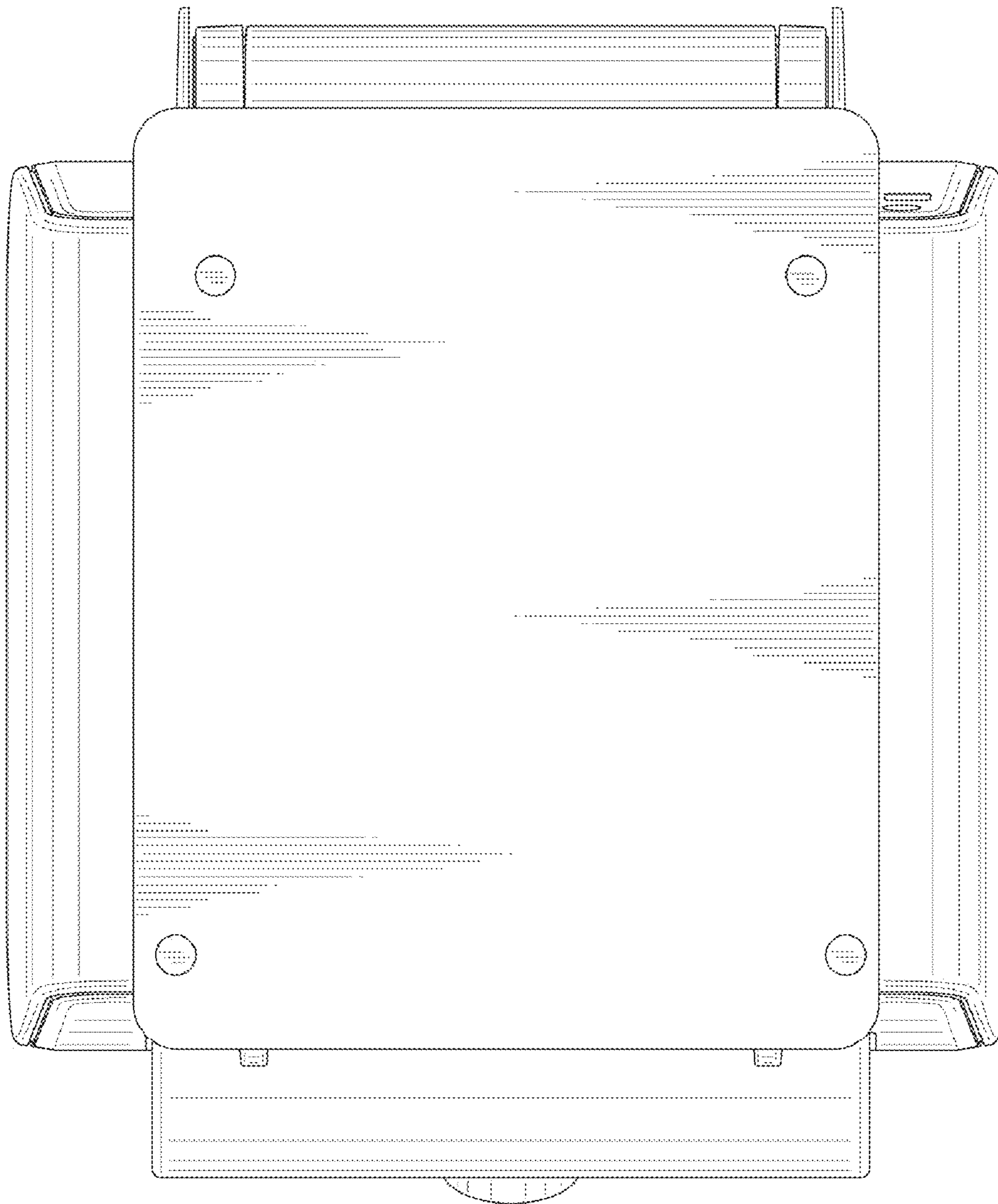

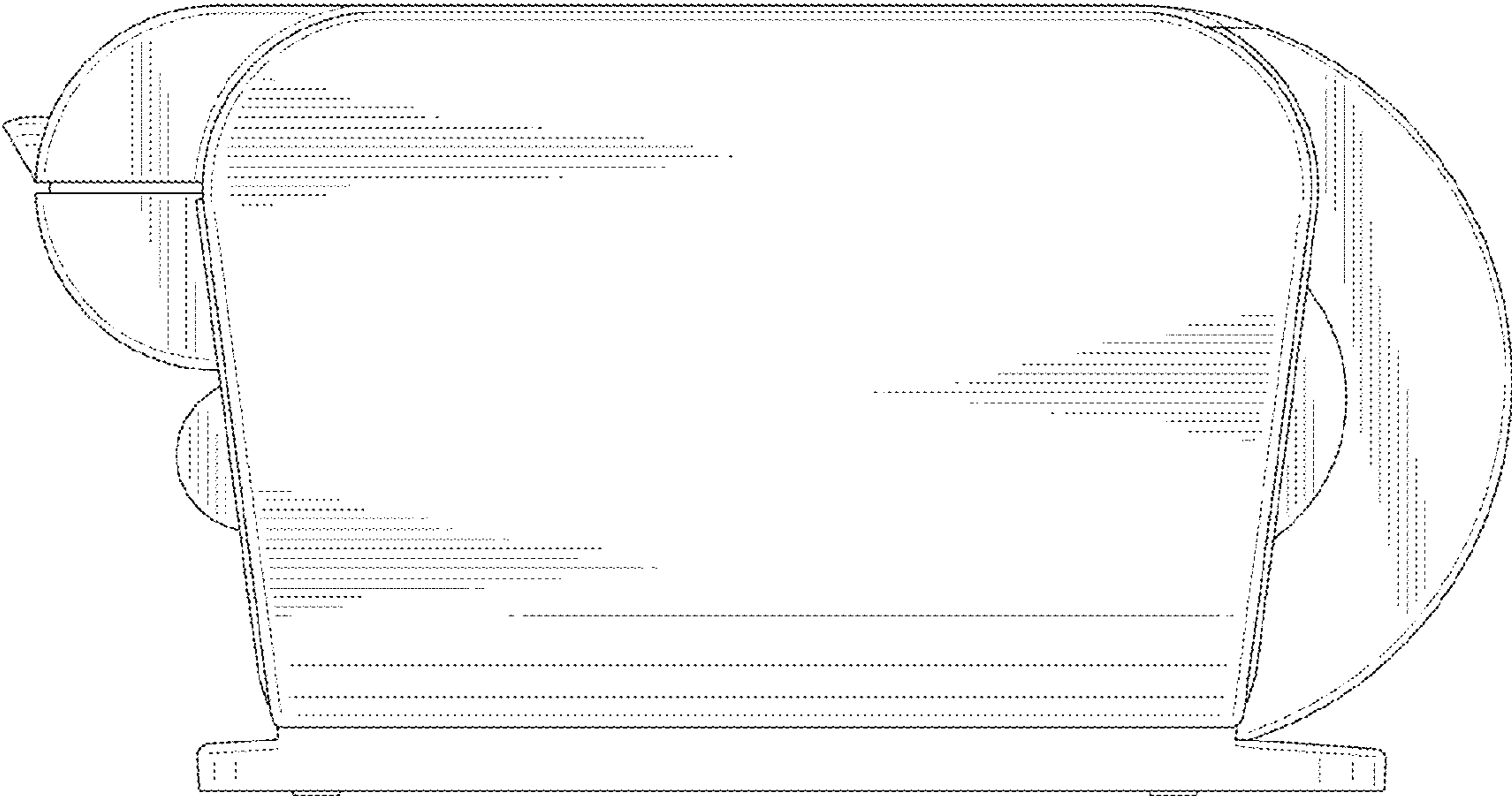
