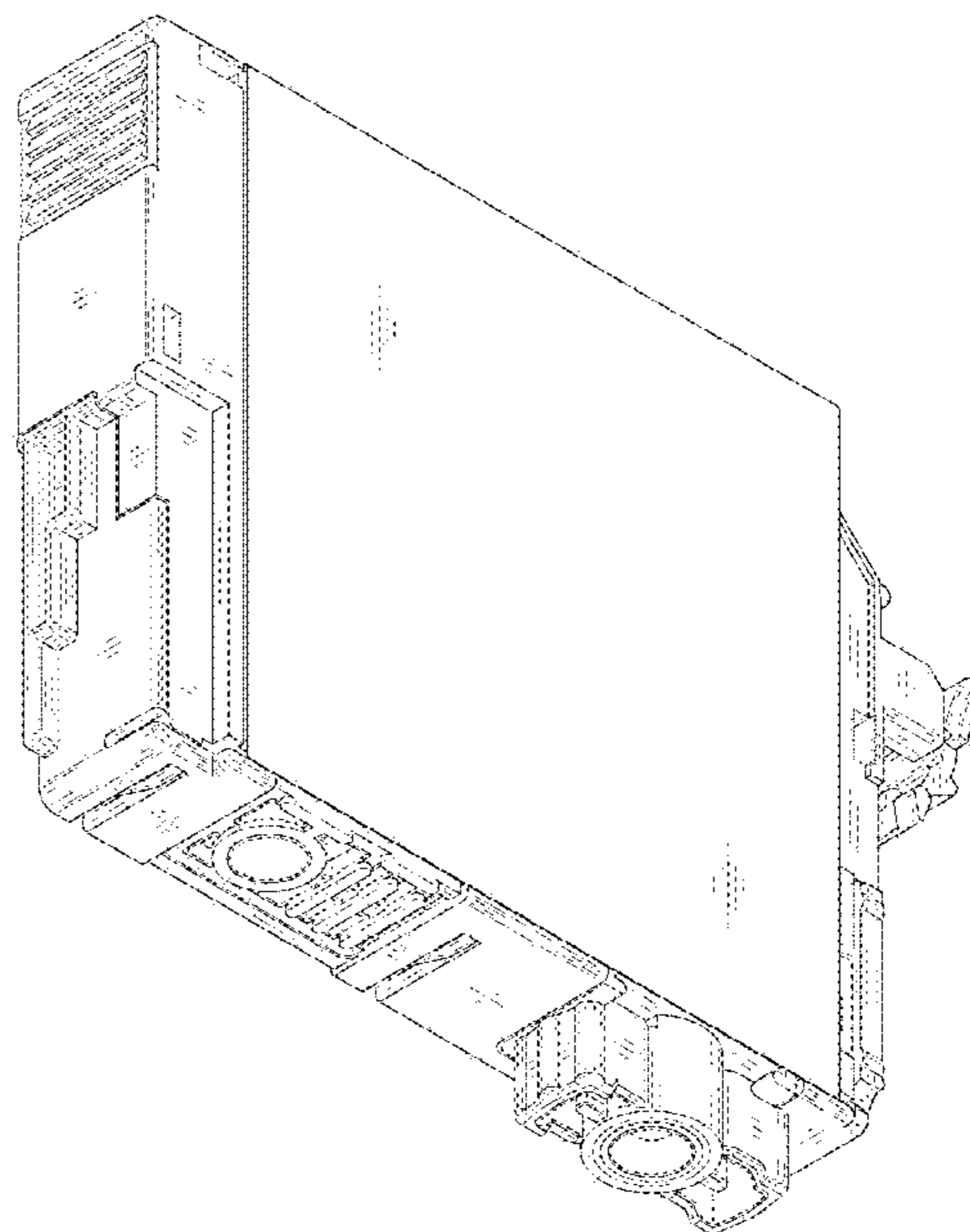
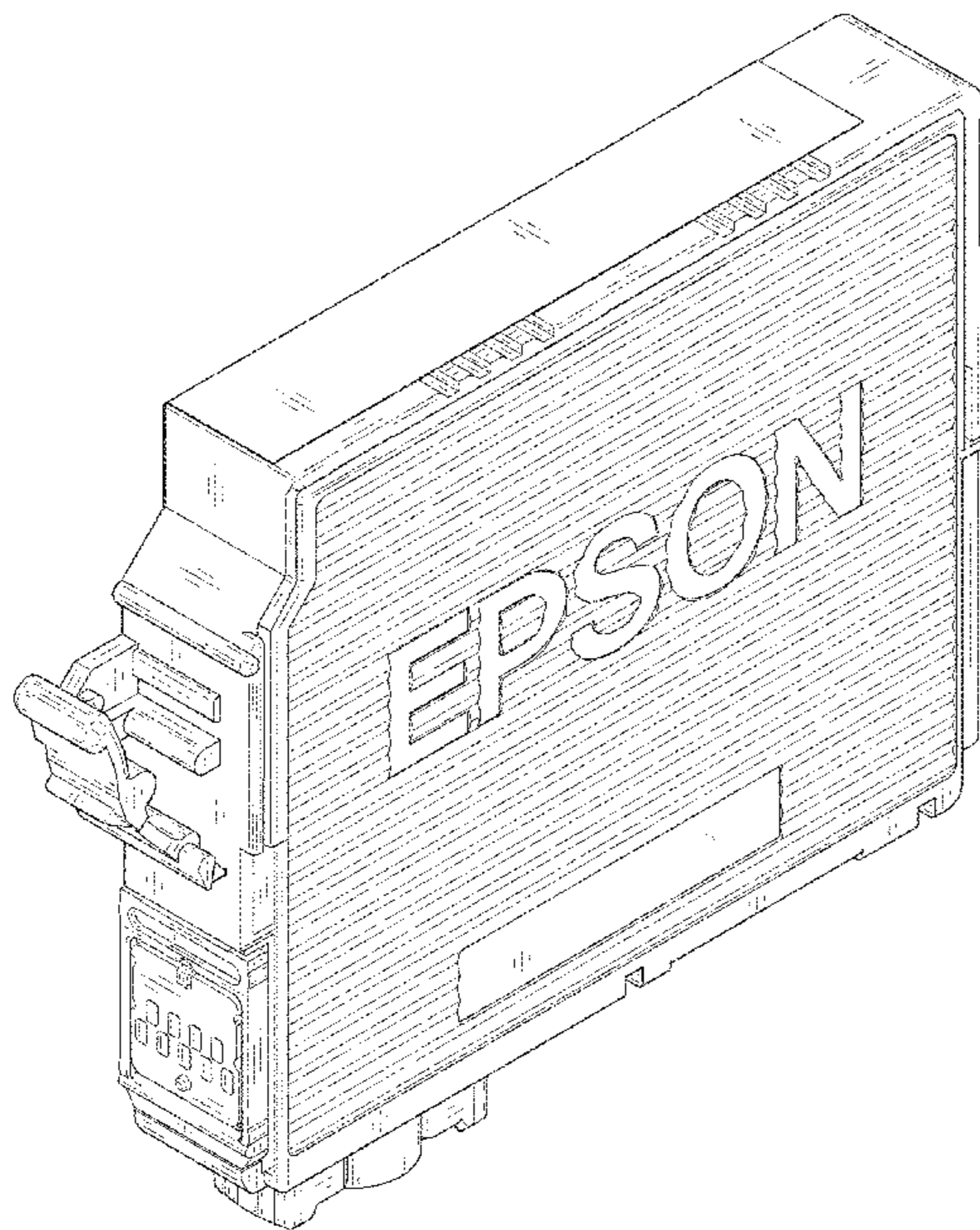
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of an ink cartridge showing our new design;

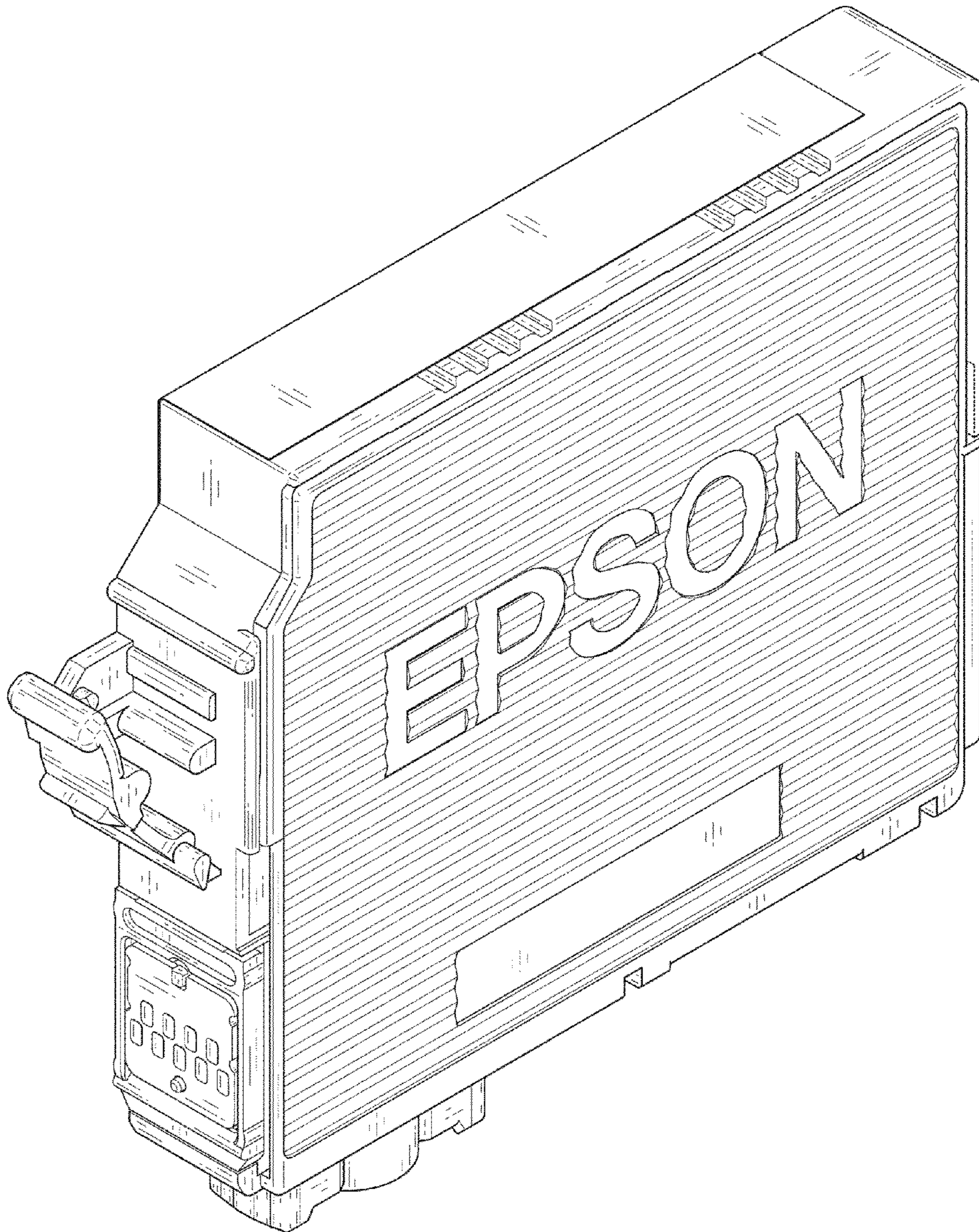

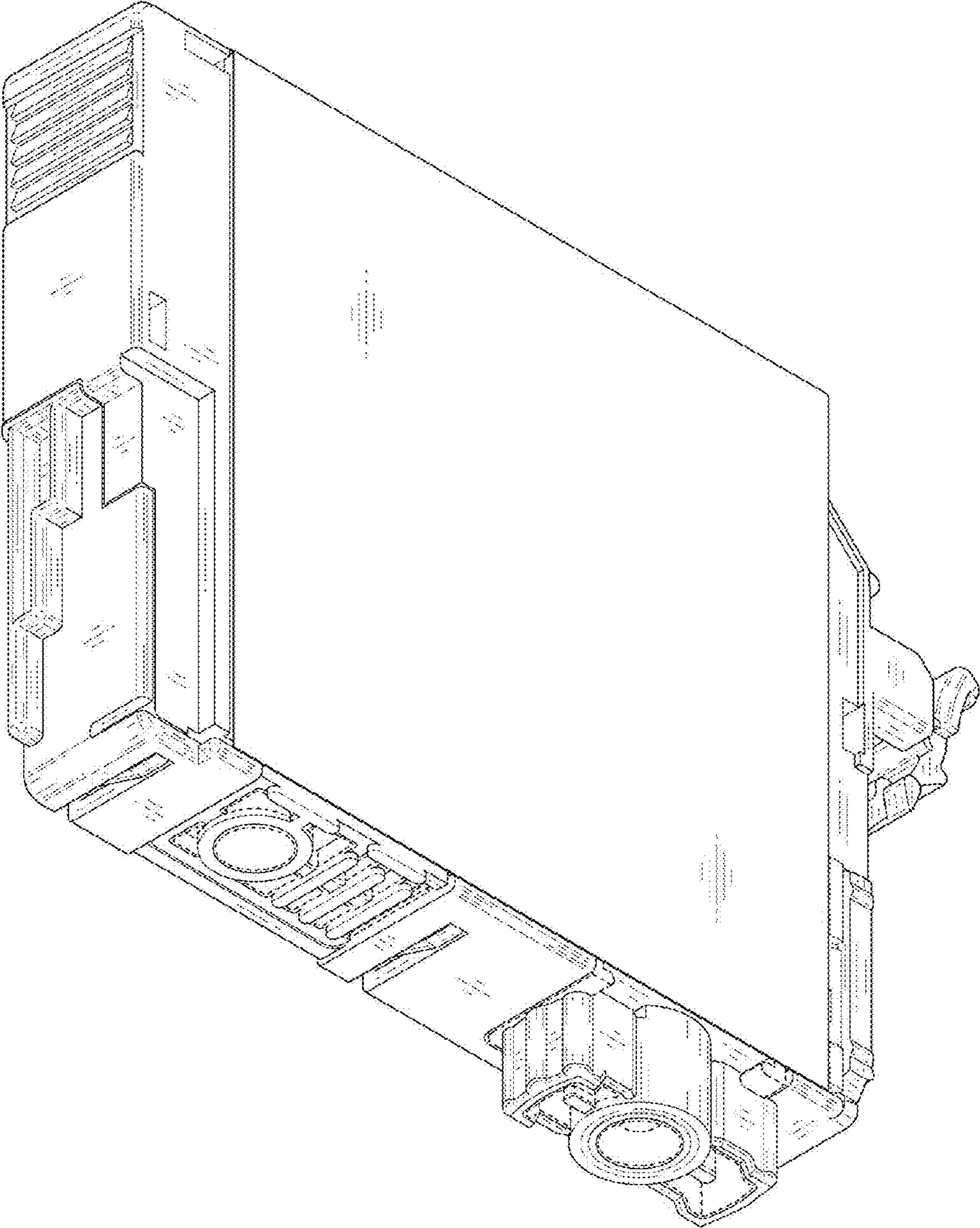

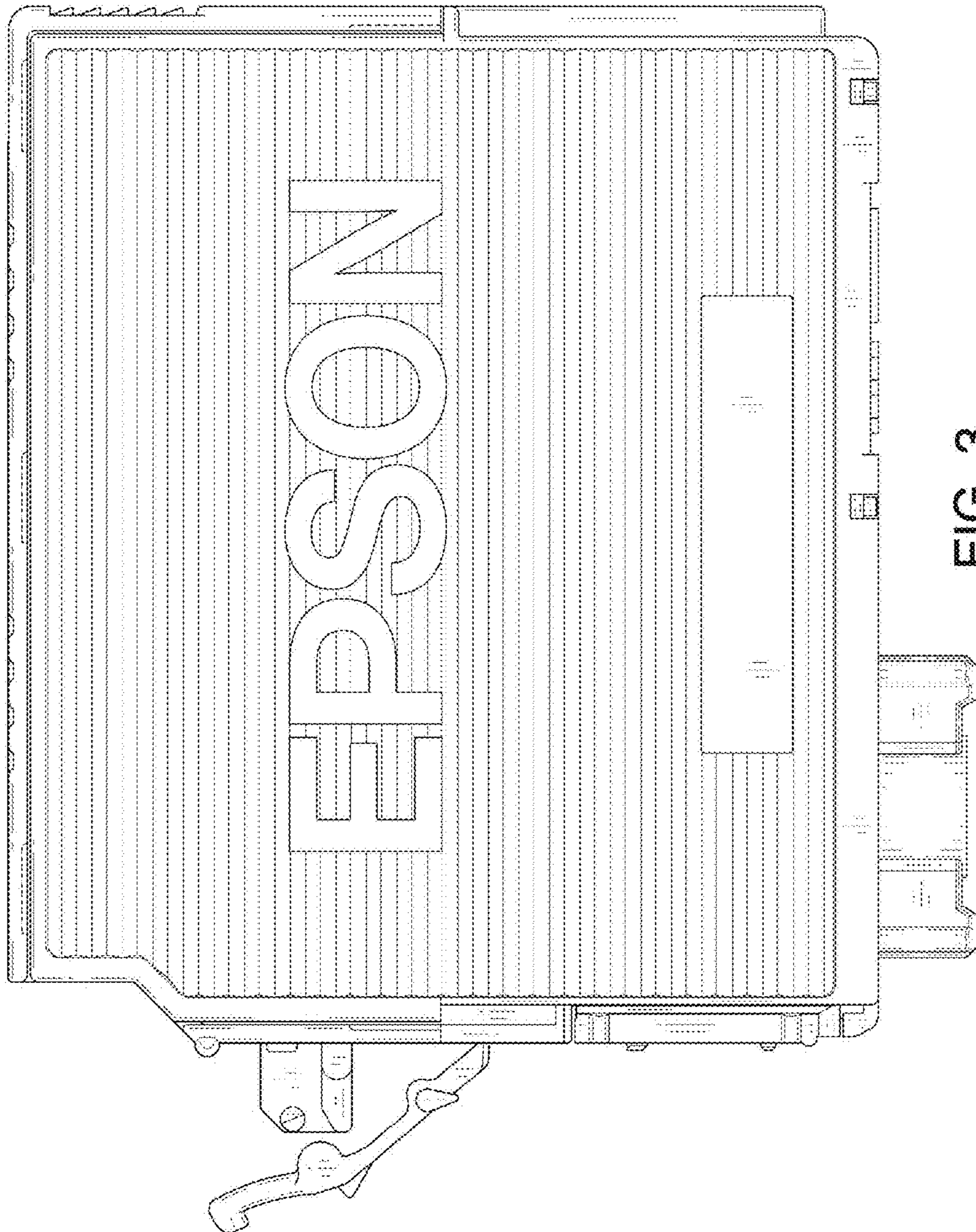

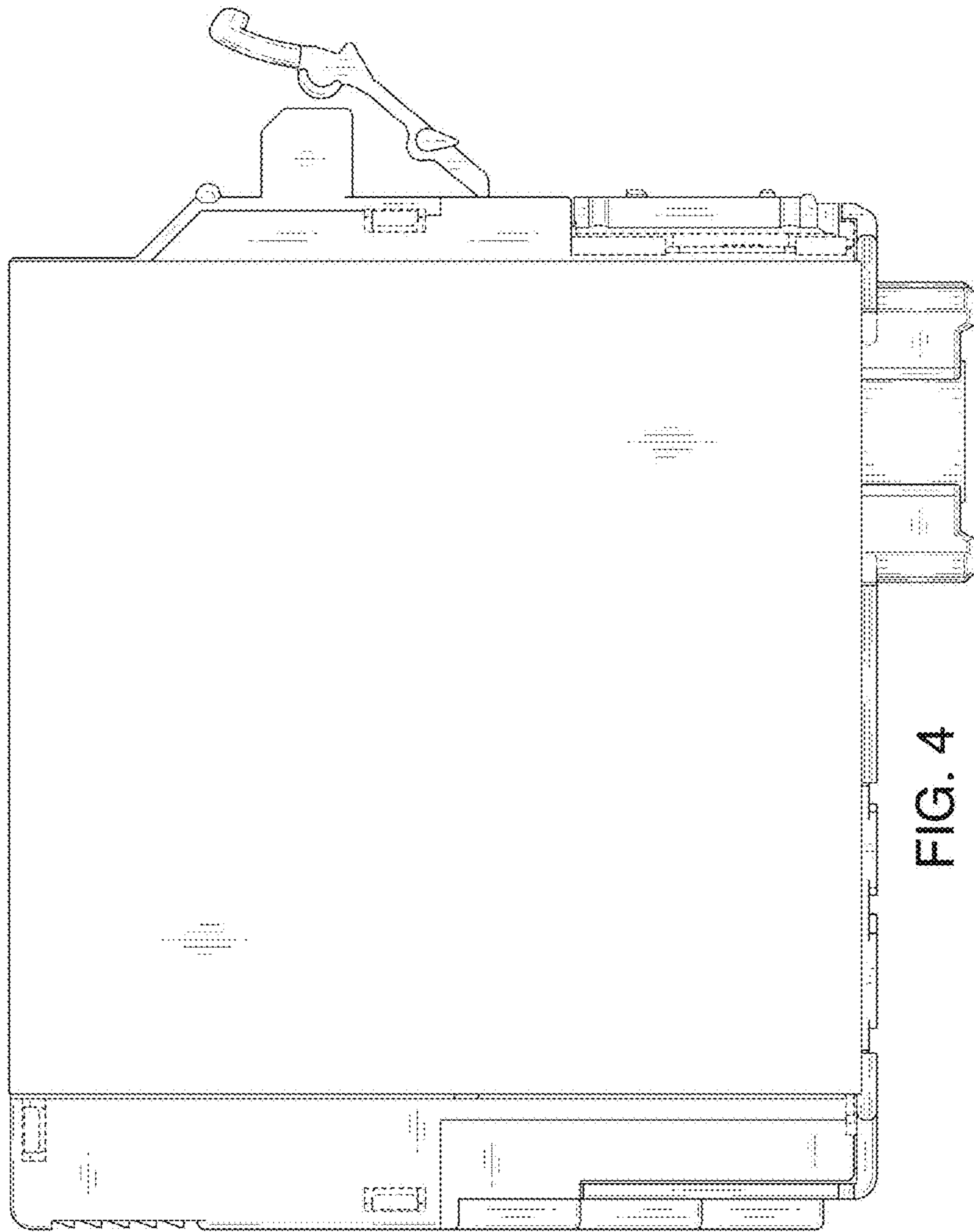

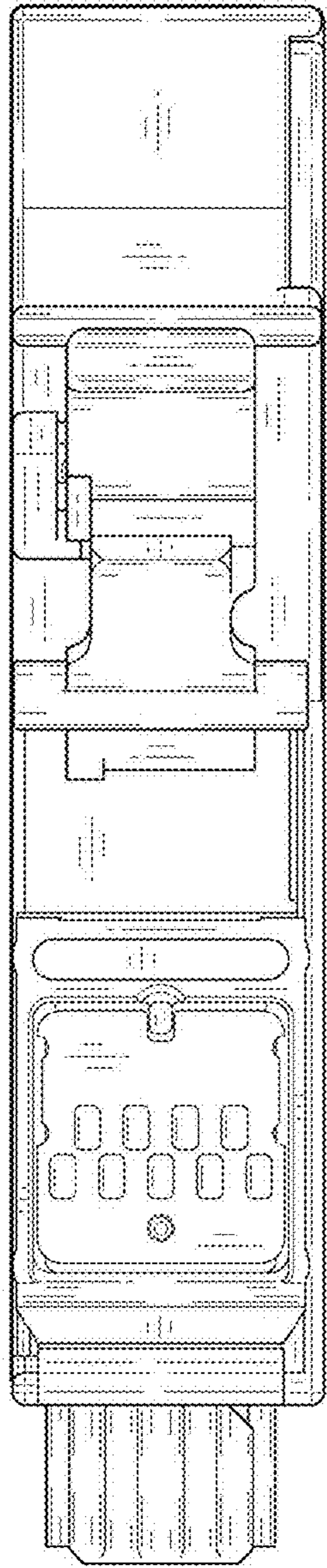

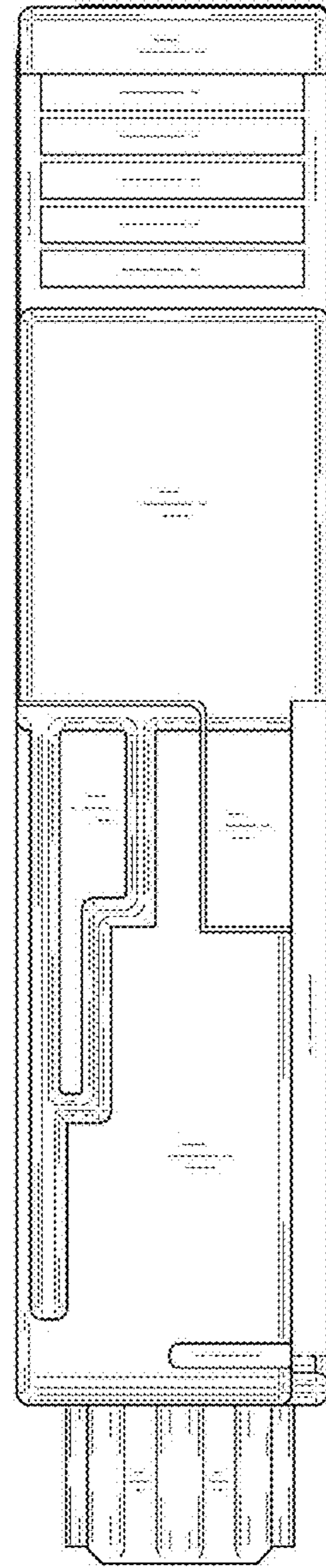

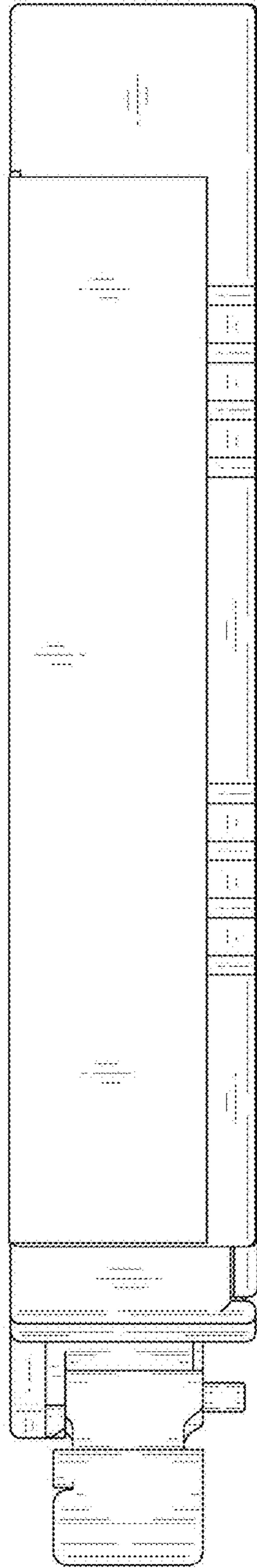

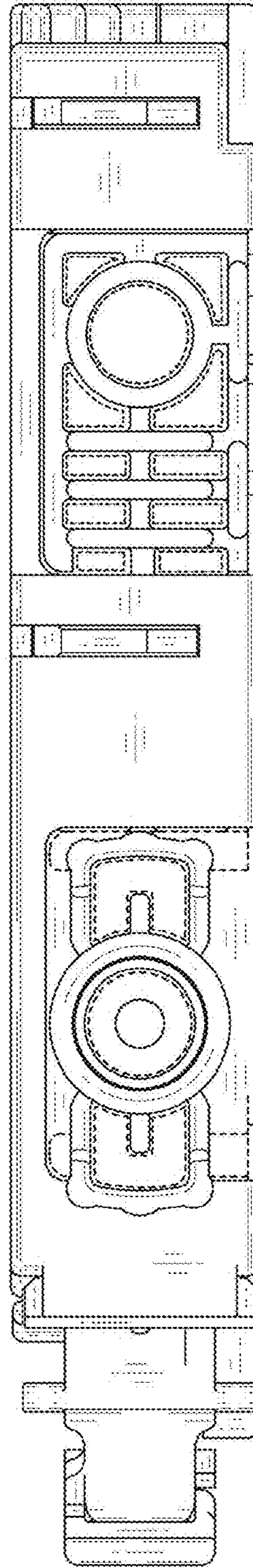
