FIG. 3 is a view of a third embodiment of a label according to our new design.

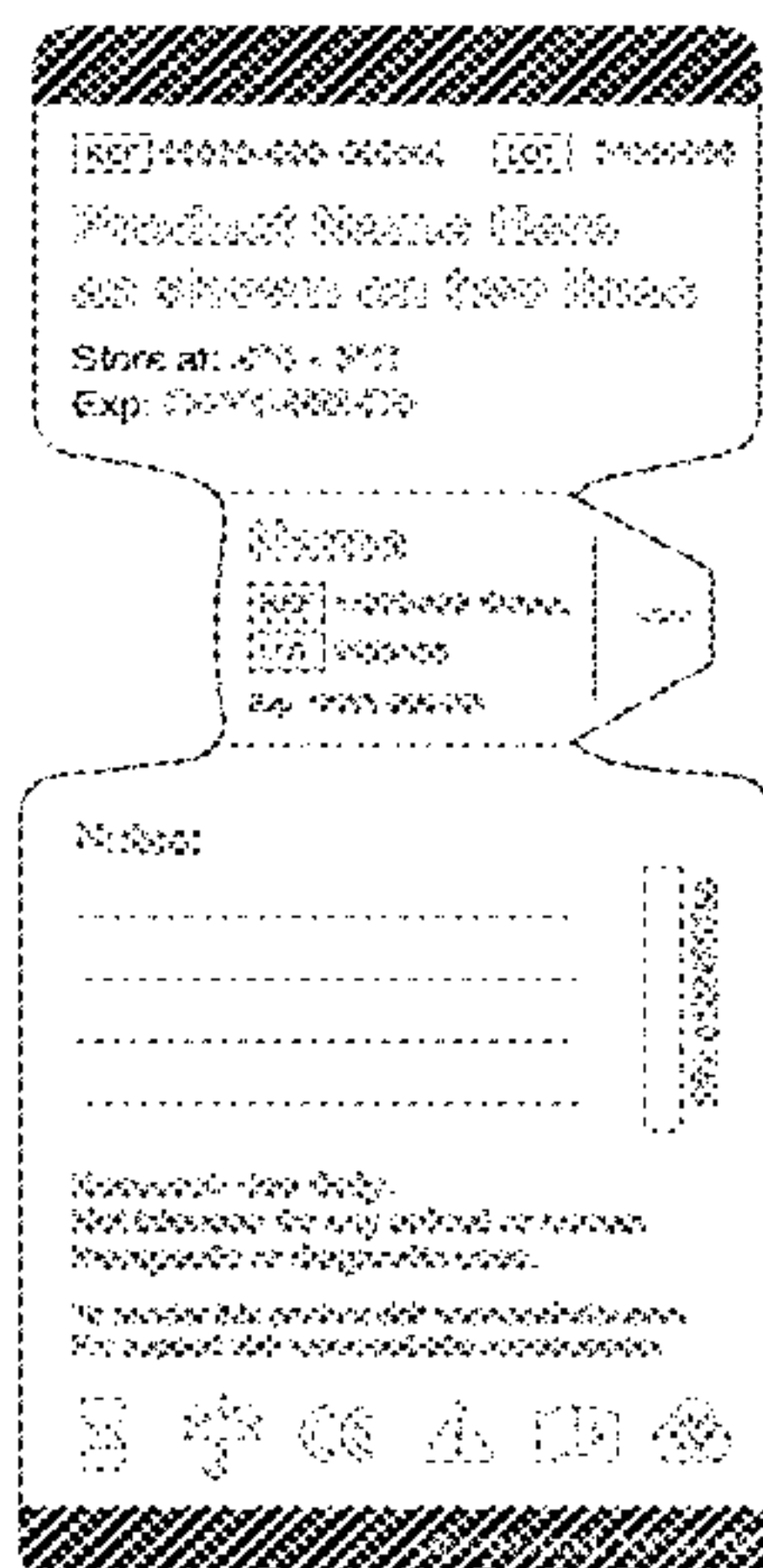
FIG. 4 is a view of a fourth embodiment of a label according to our new design.

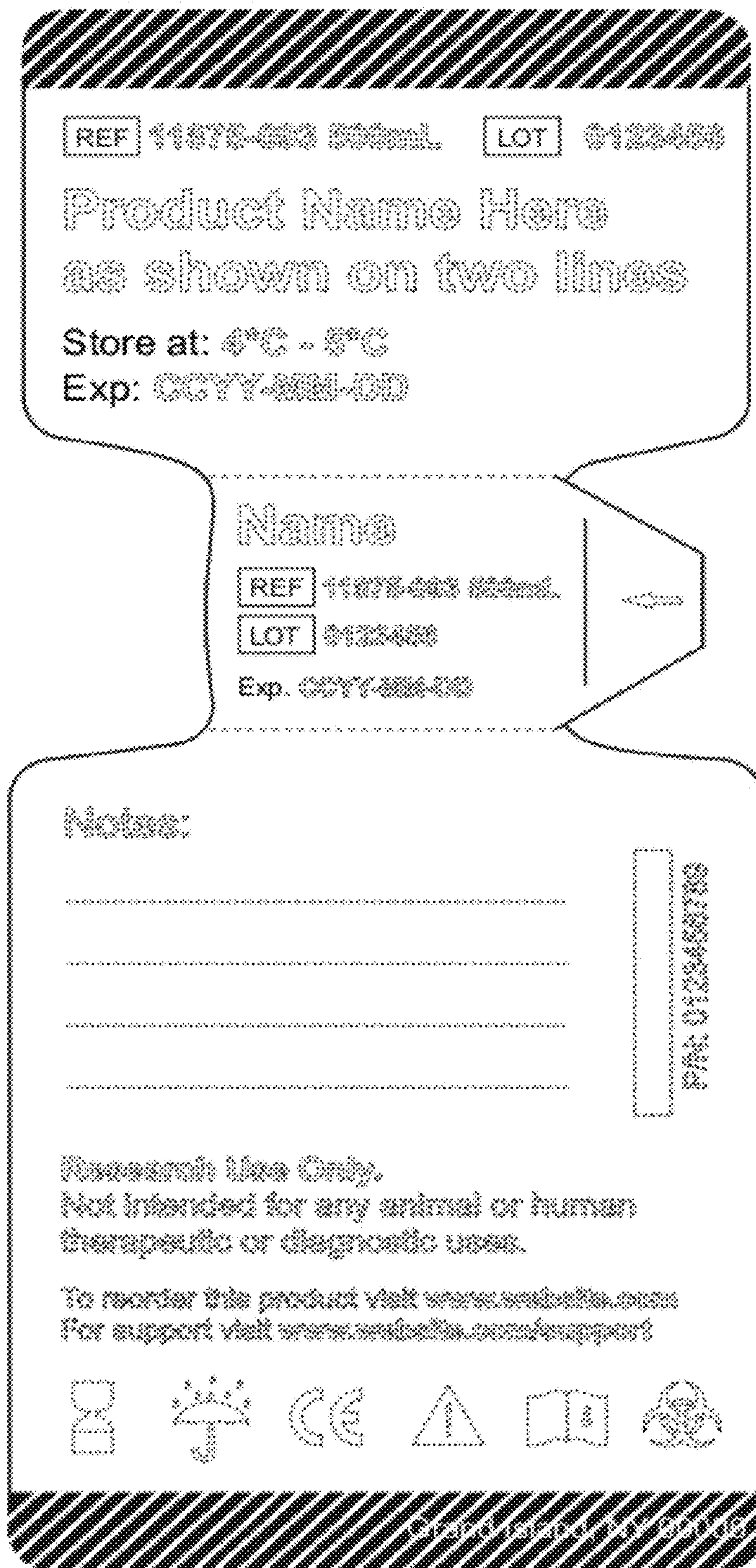

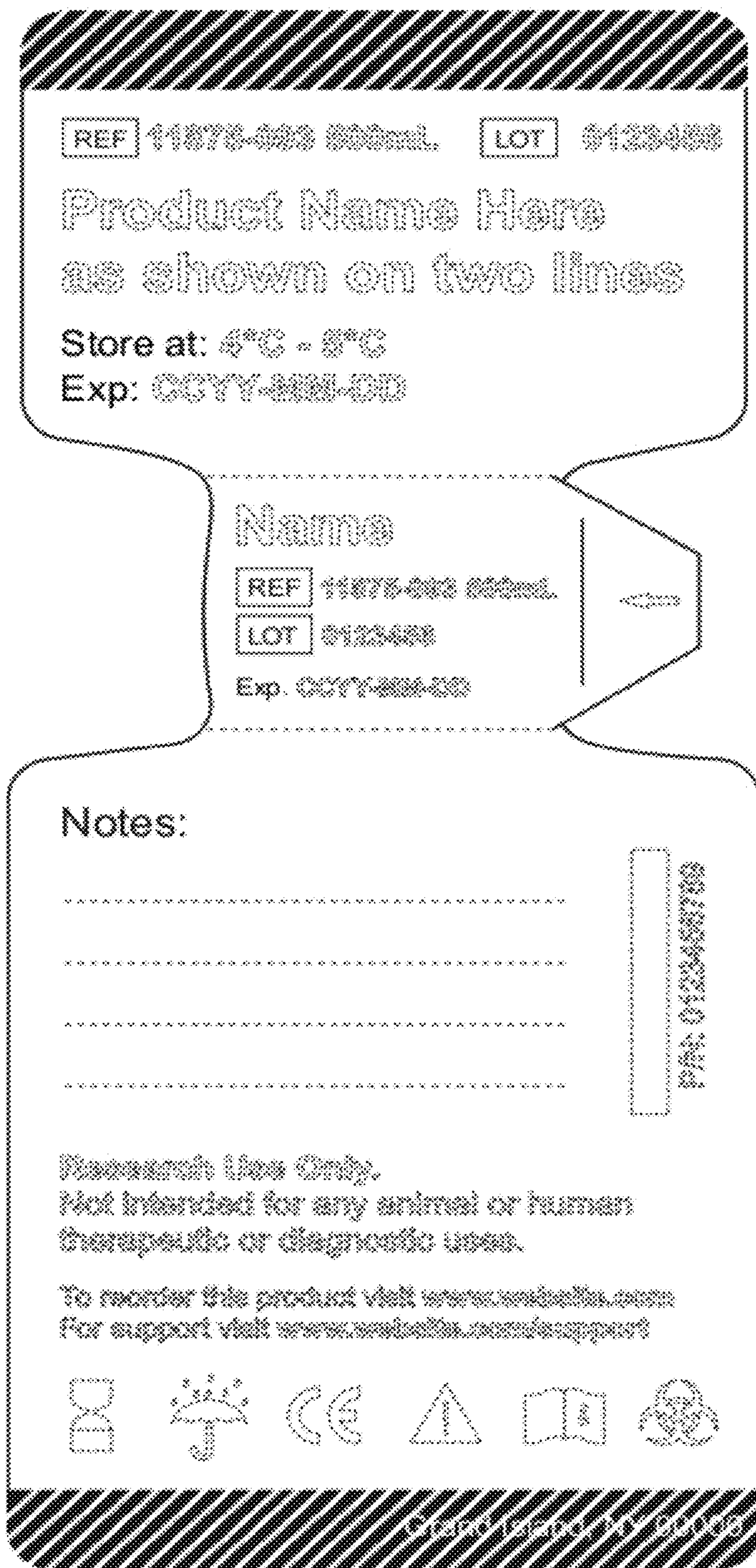

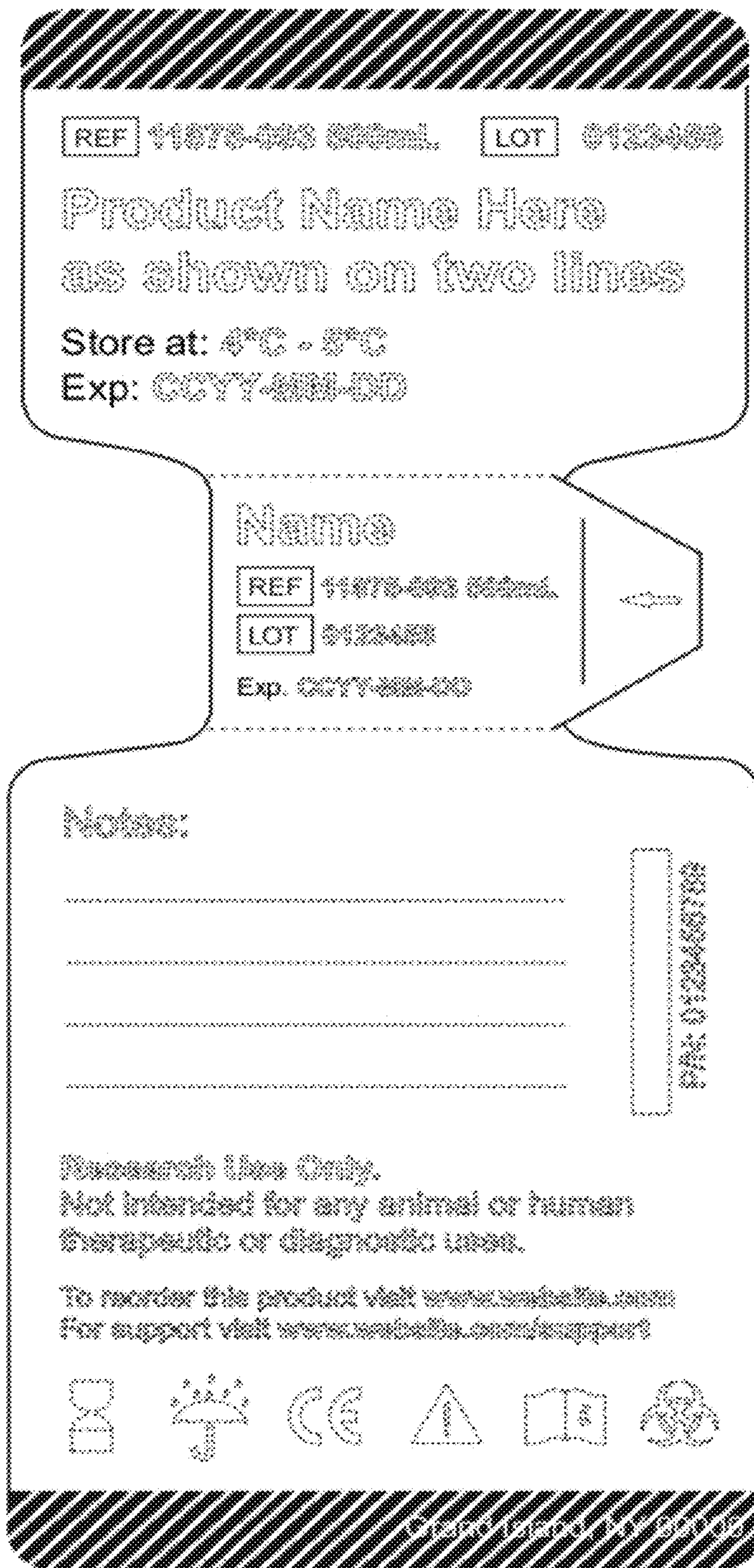

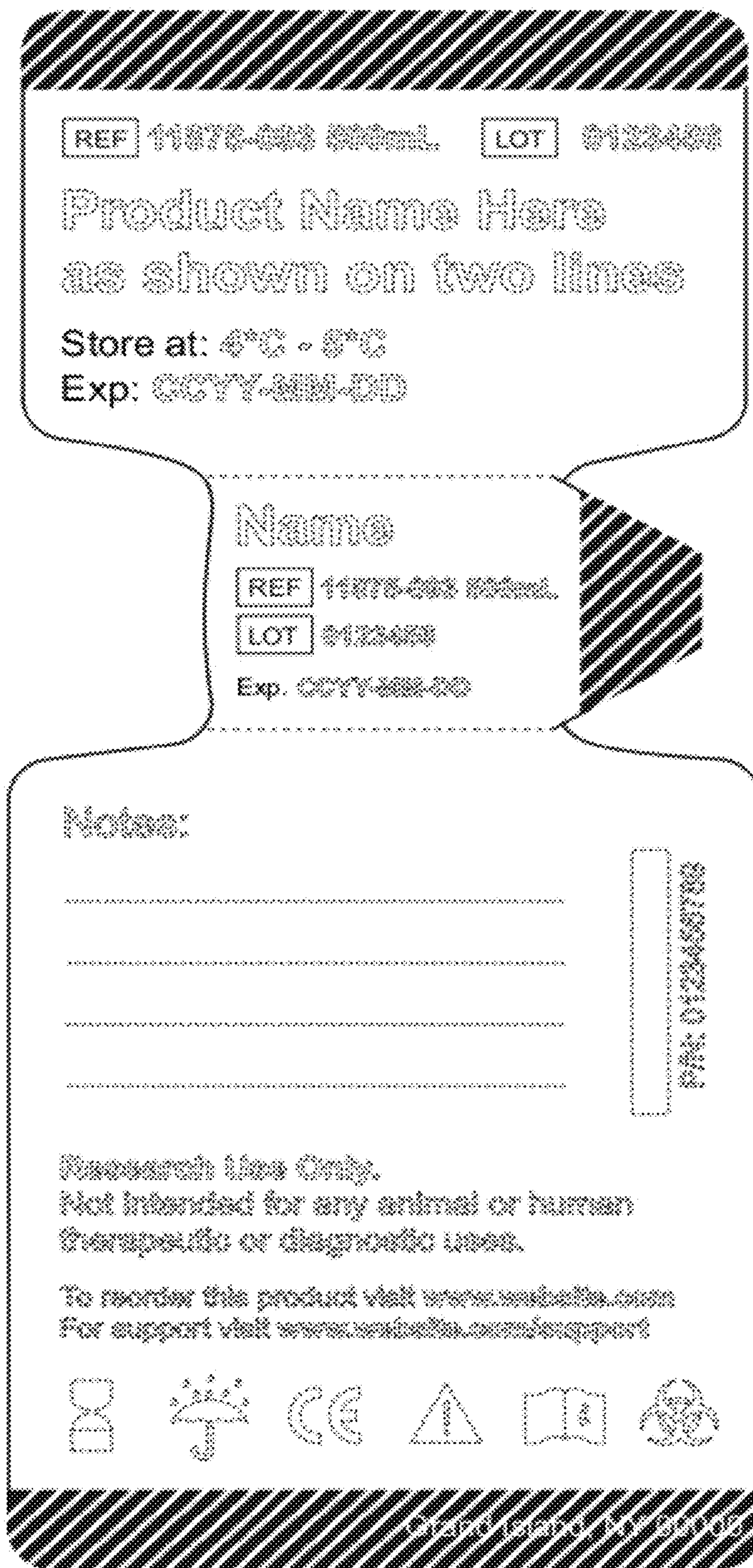

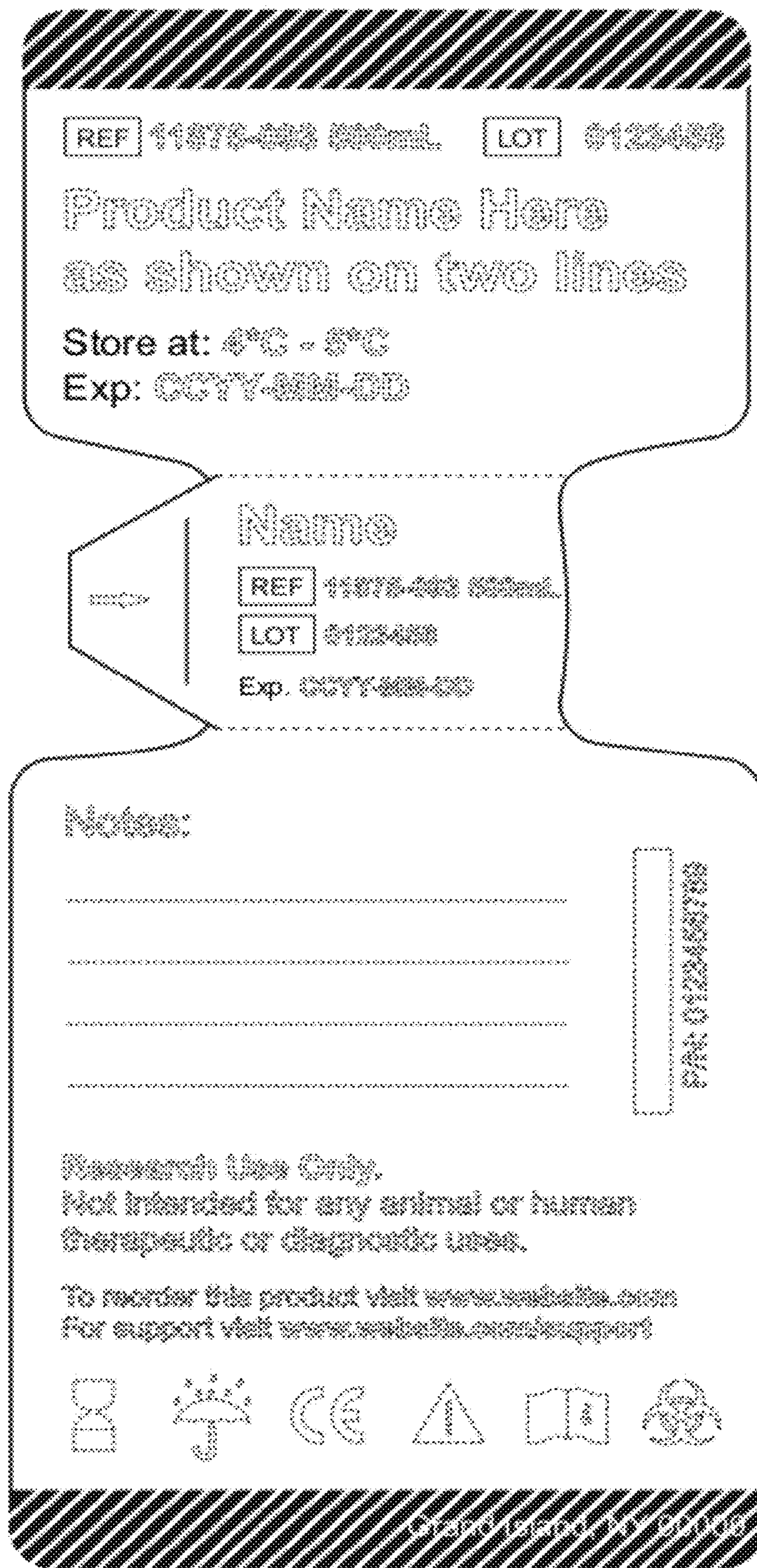

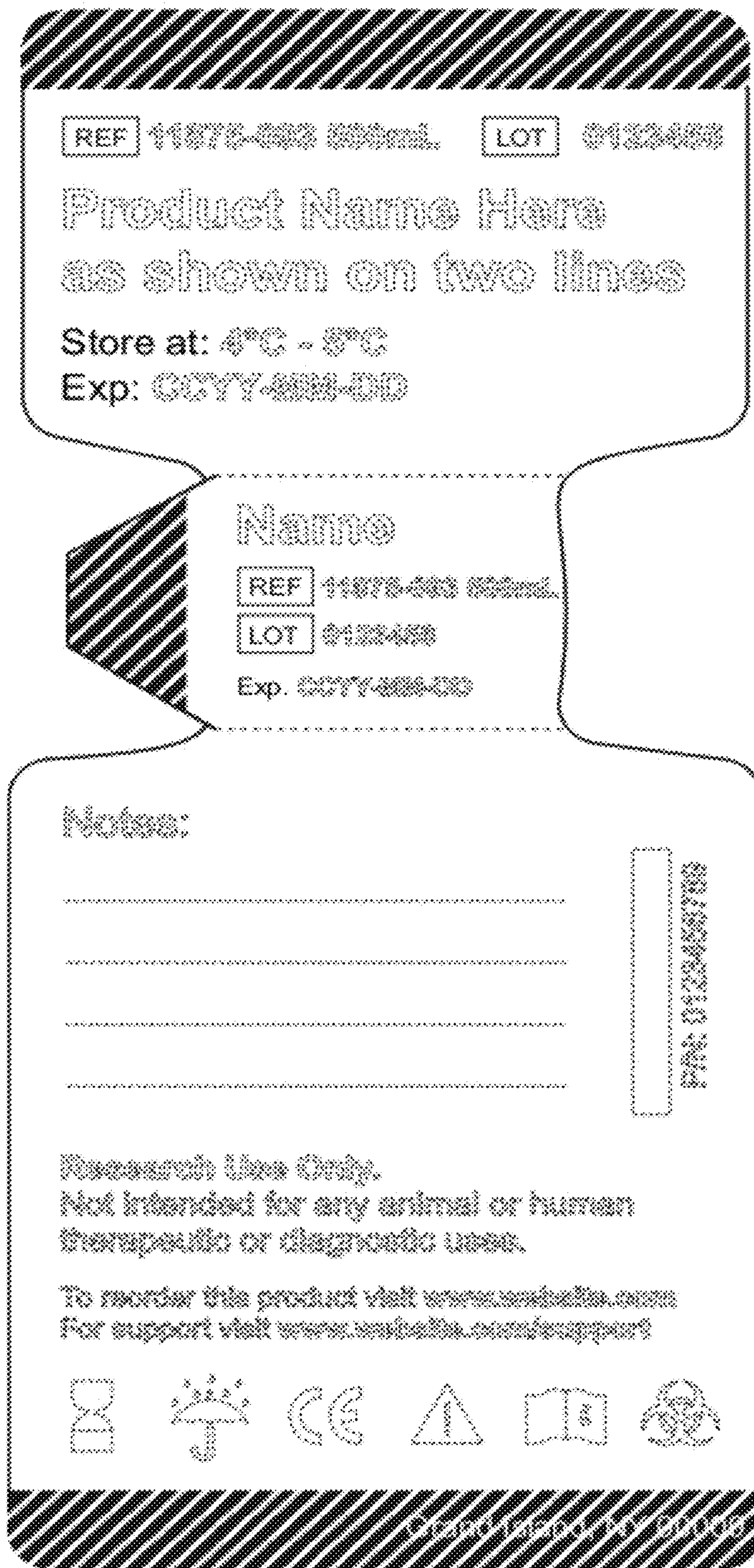
