DESCRIPTION

FIG. 9 is a top view thereof;

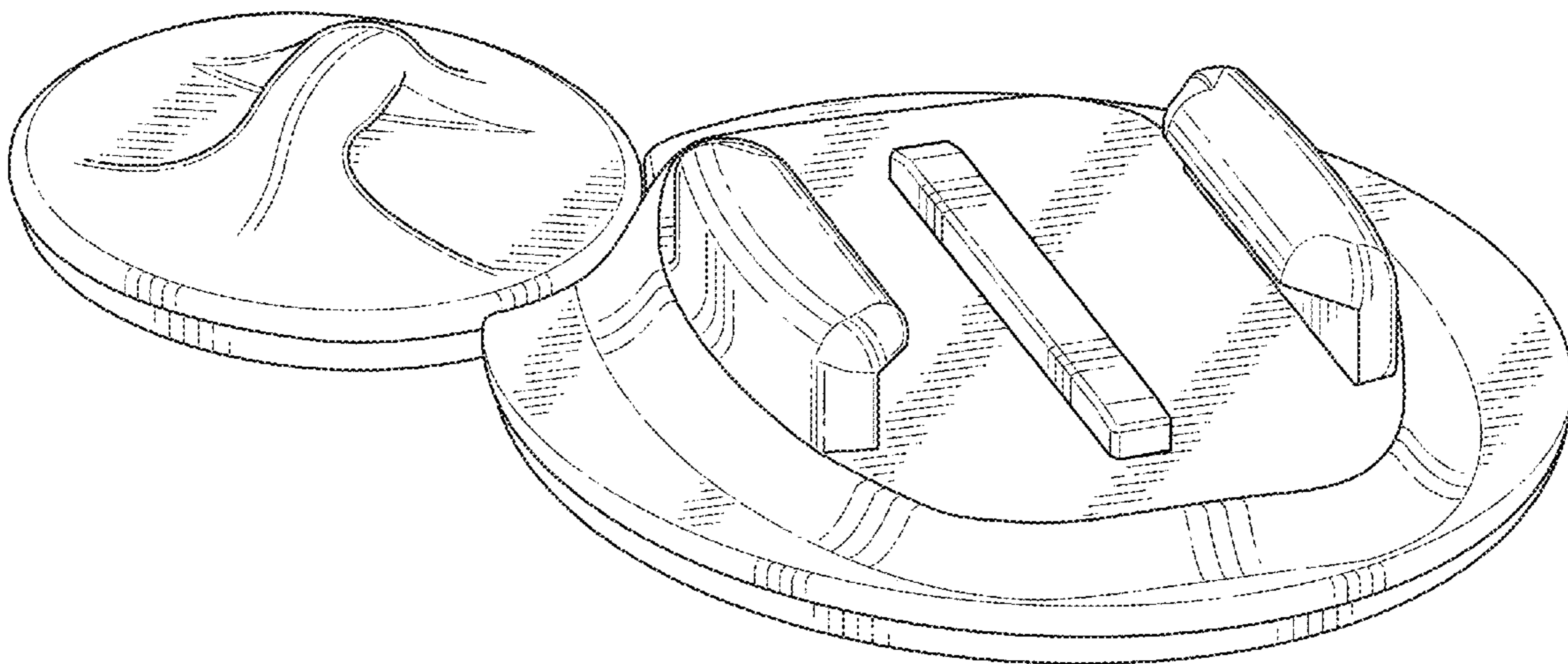
FIG. 10 is a bottom view thereof;

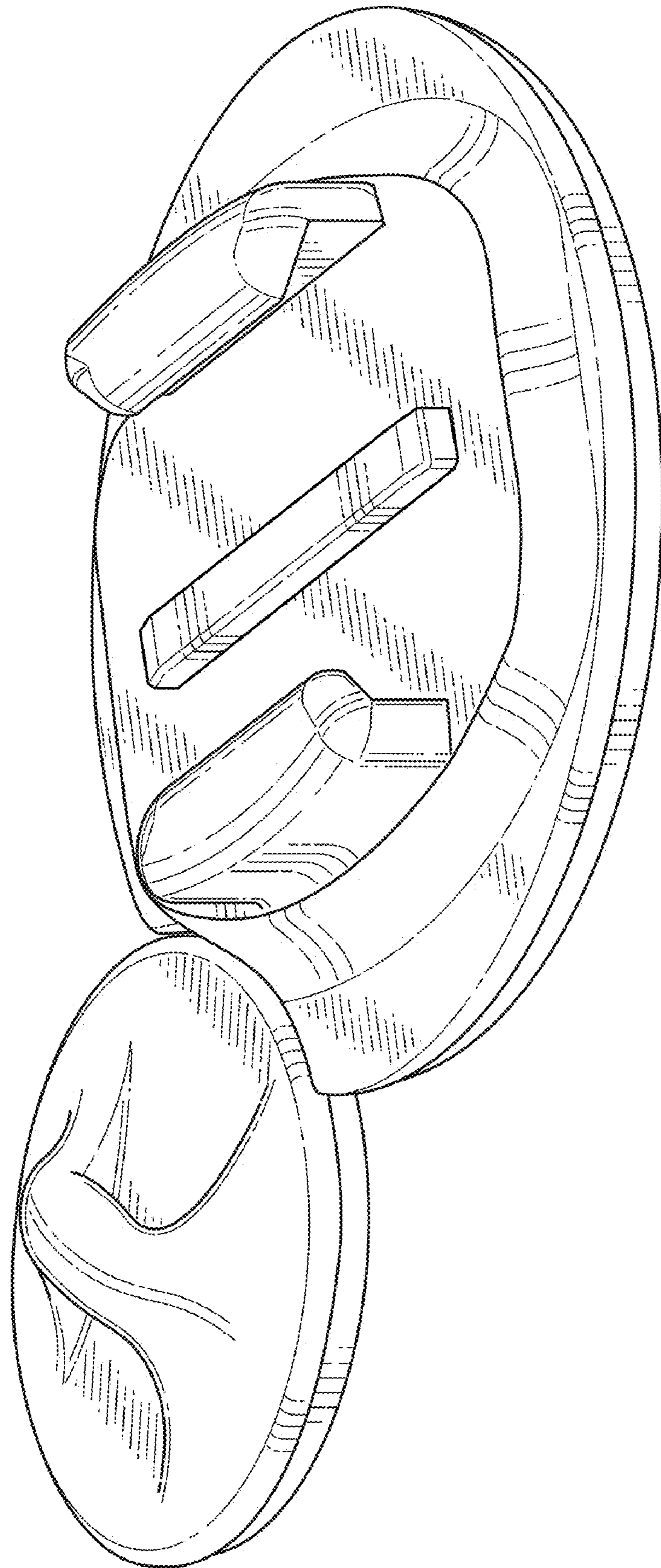

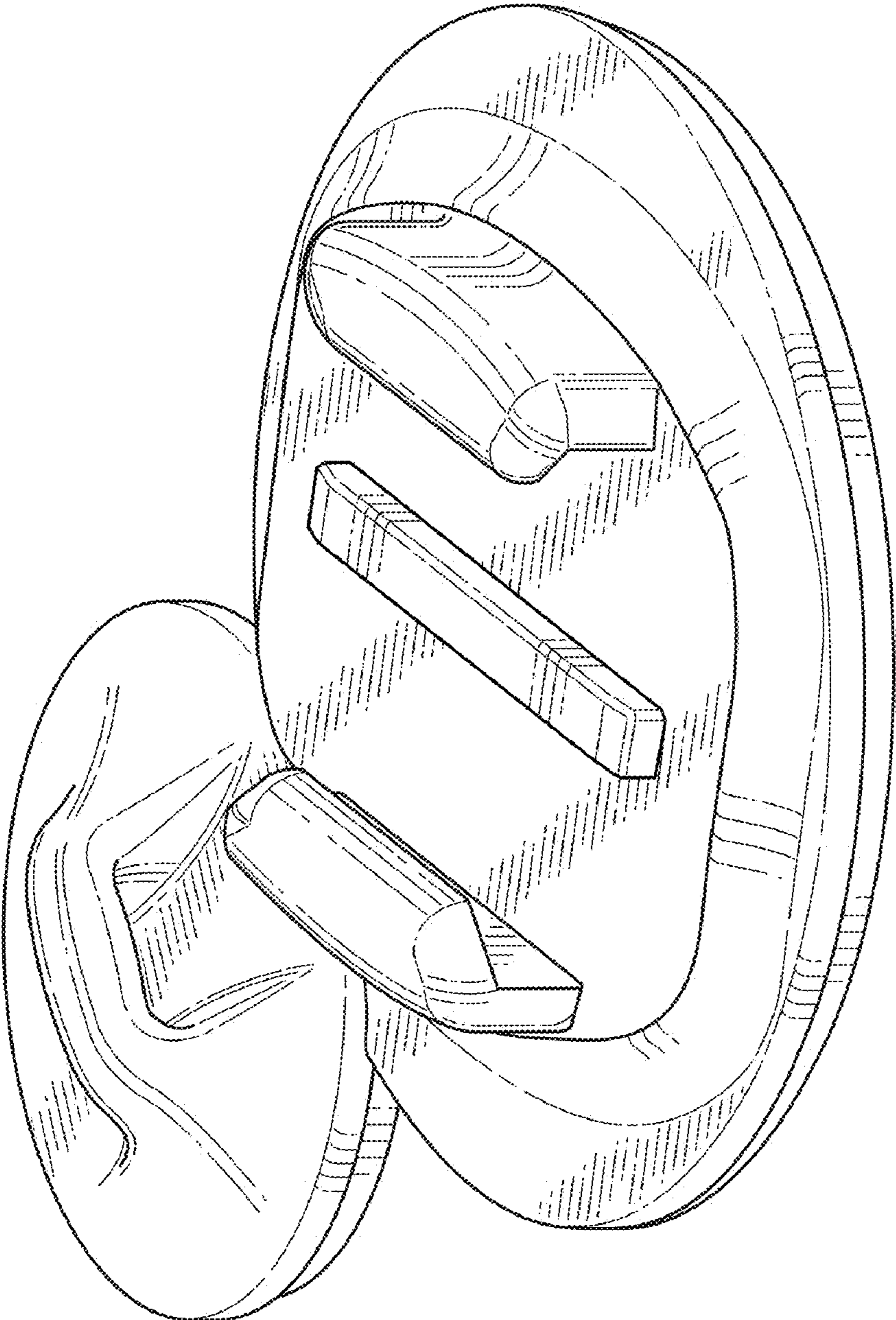

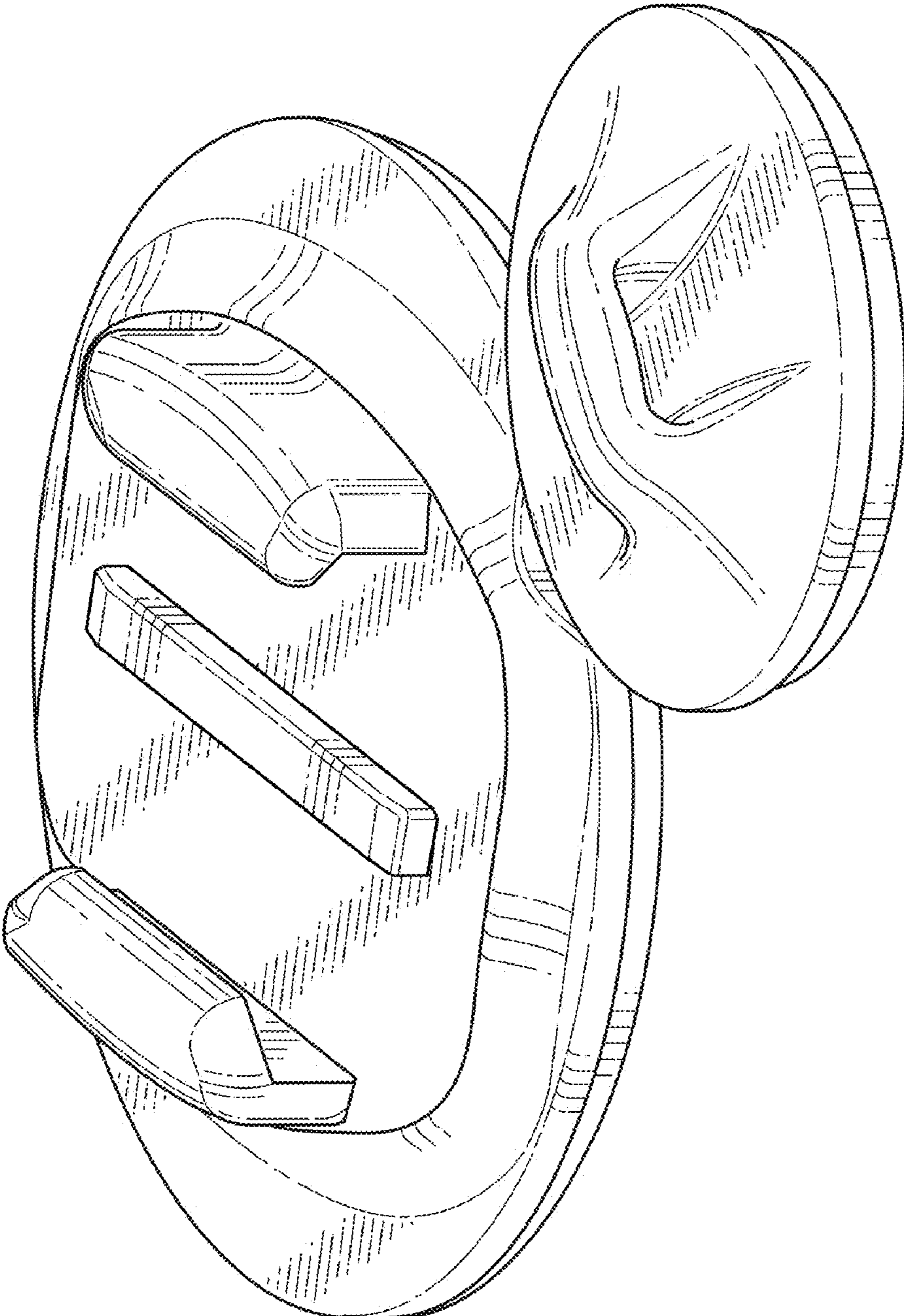

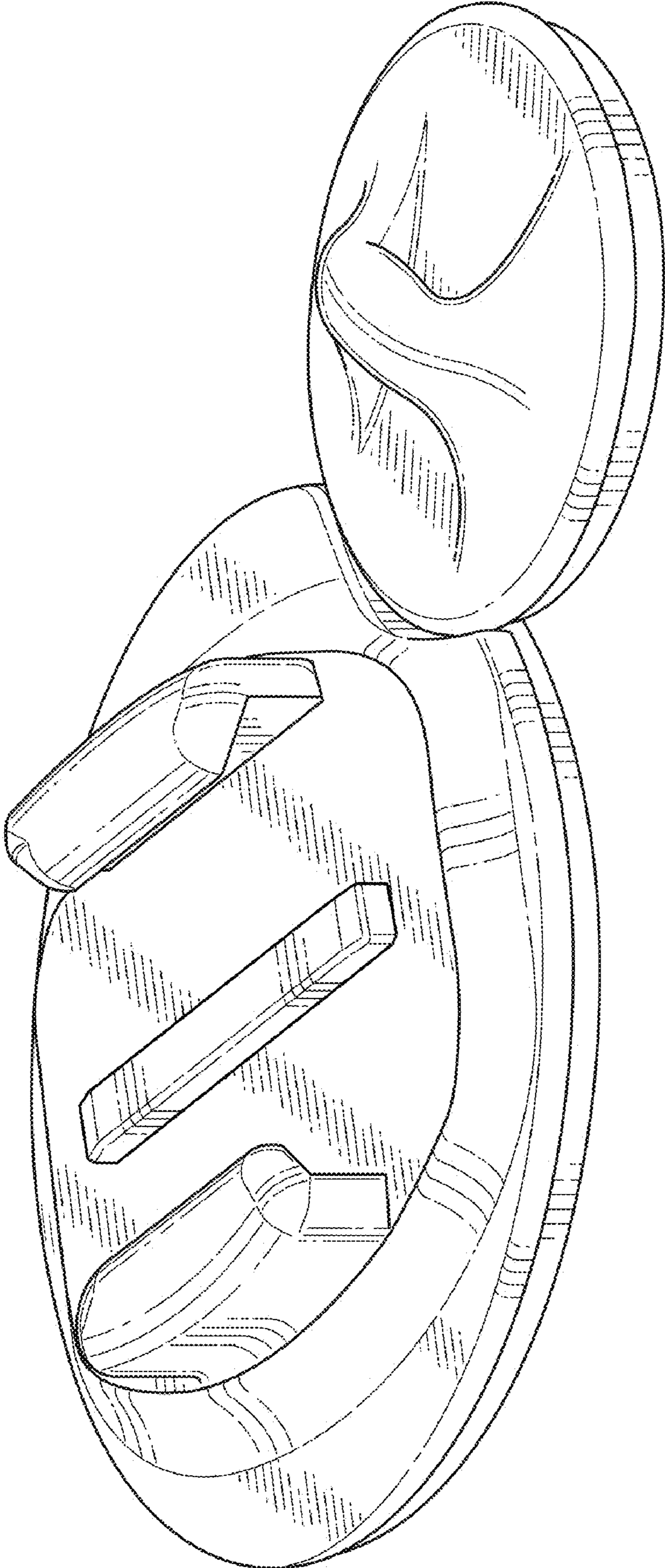

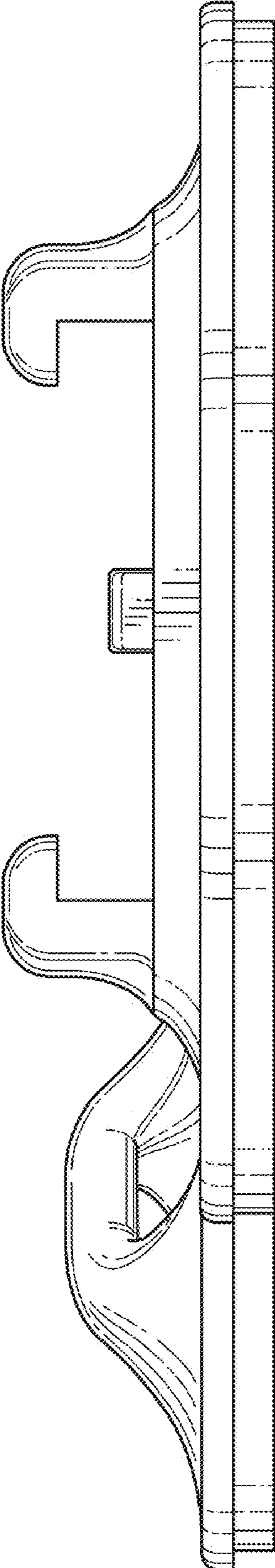

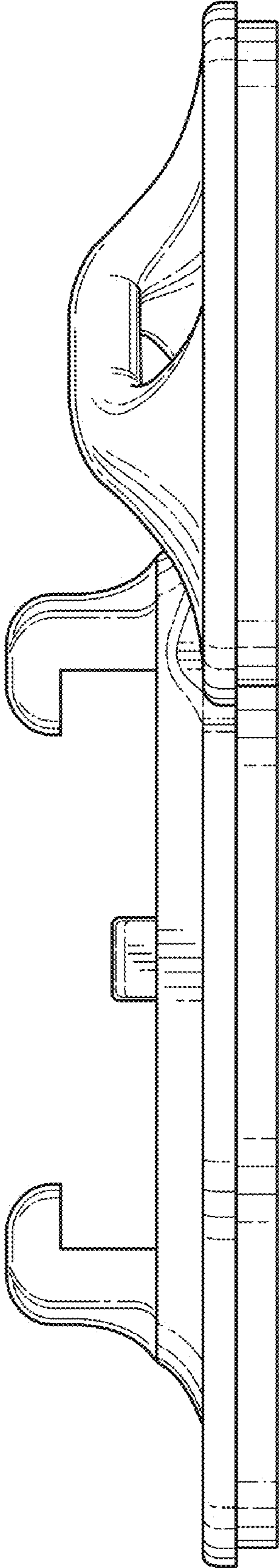

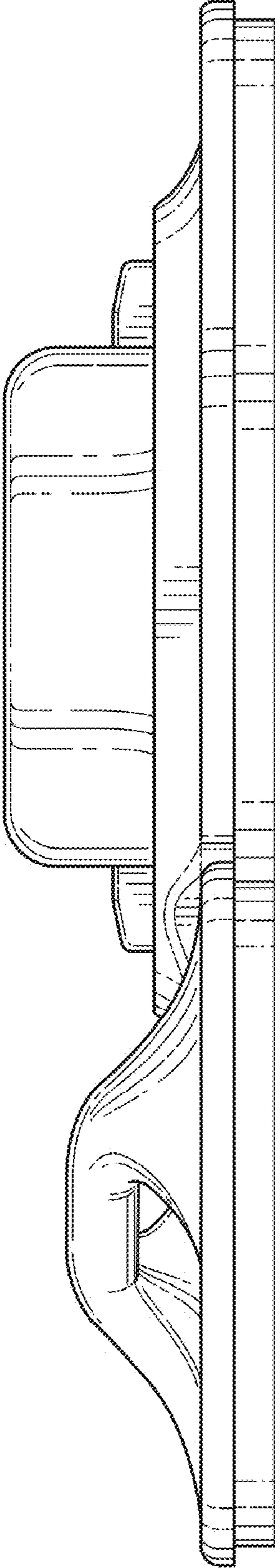

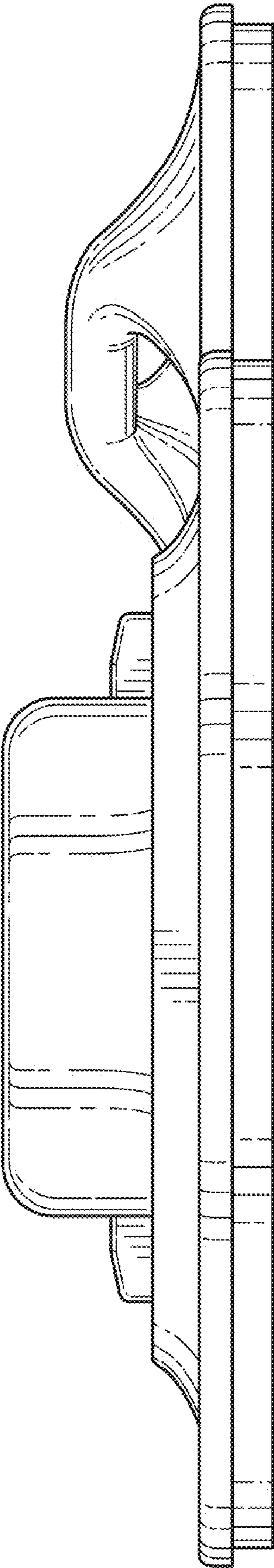

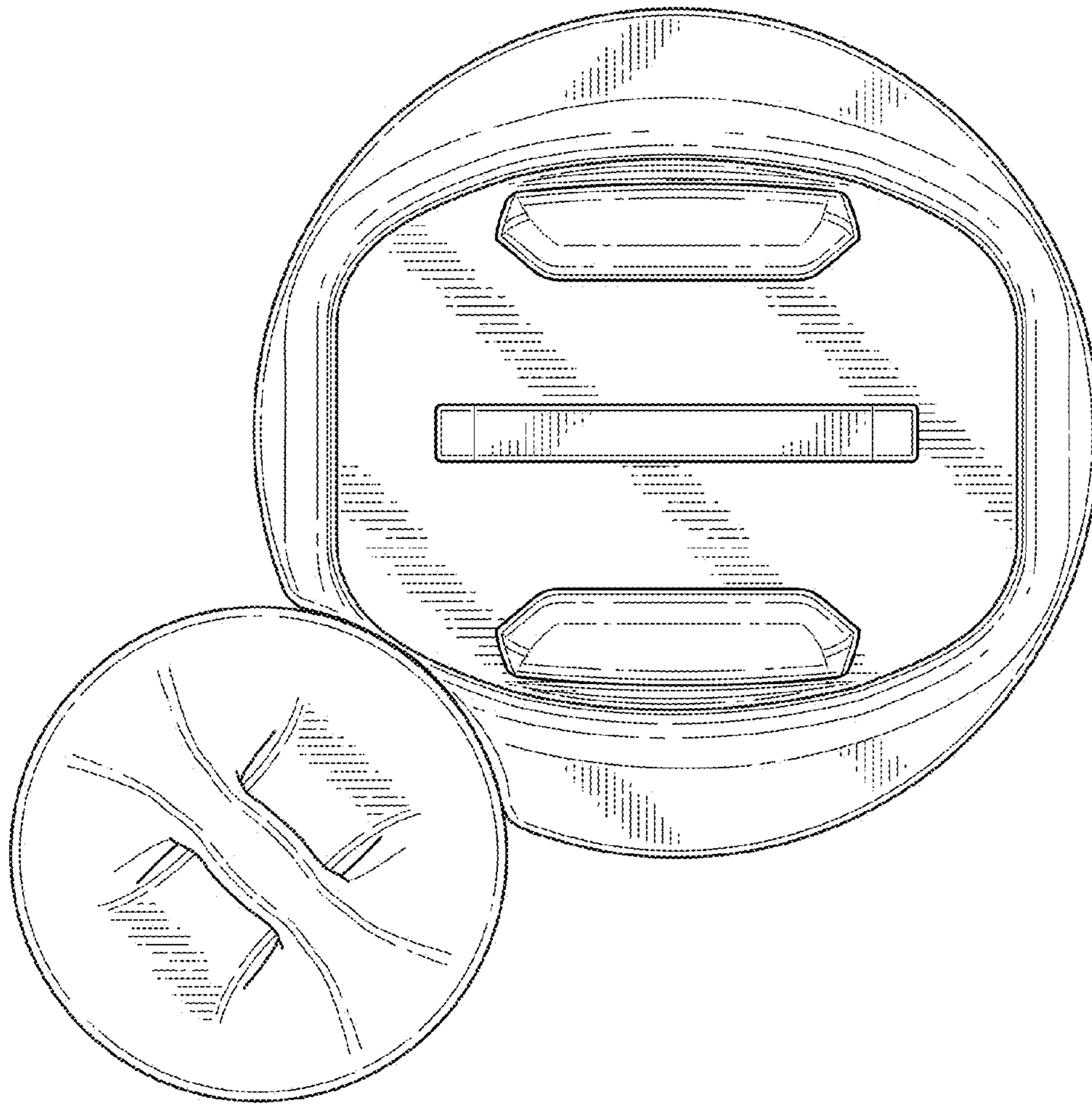

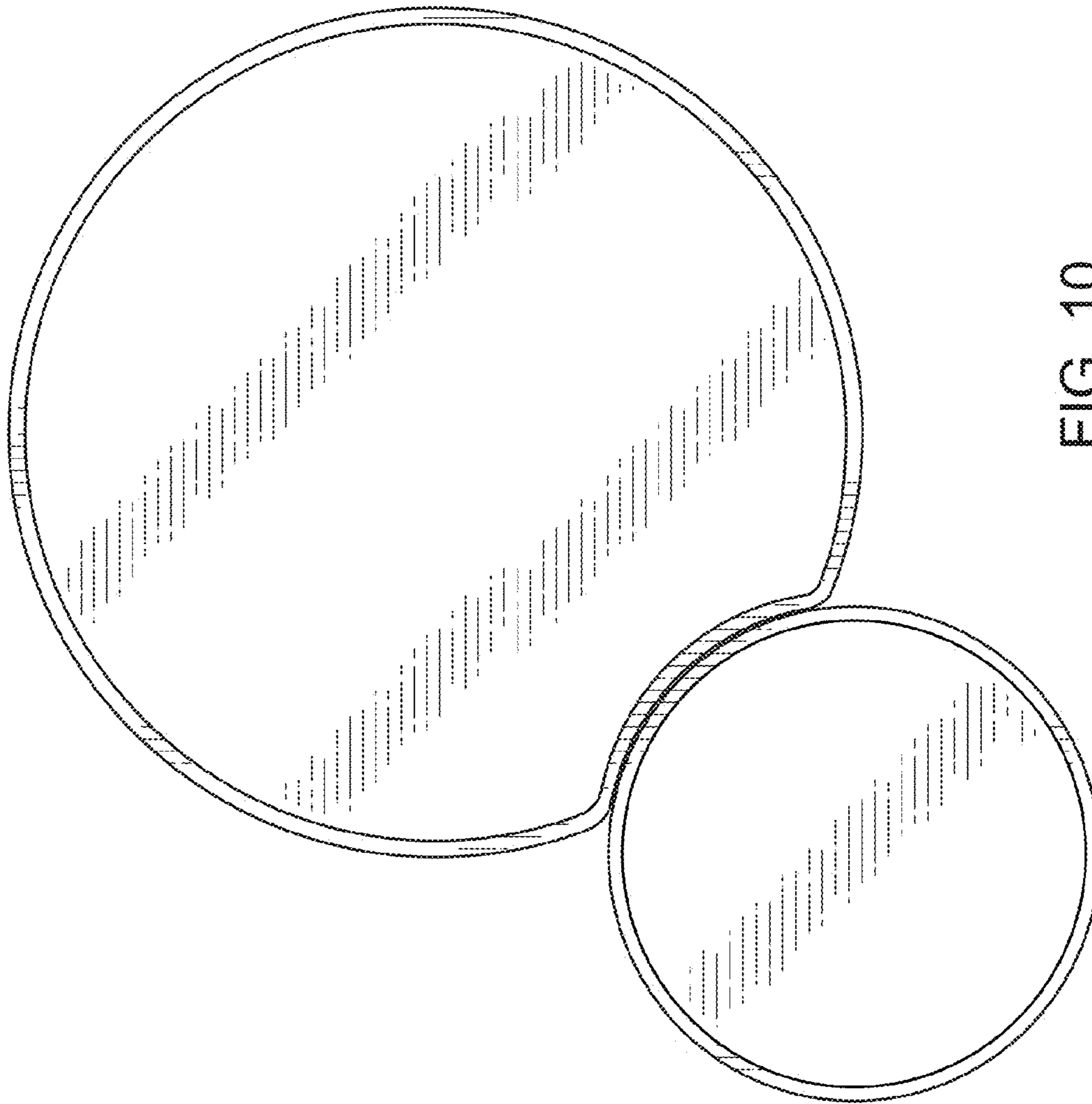

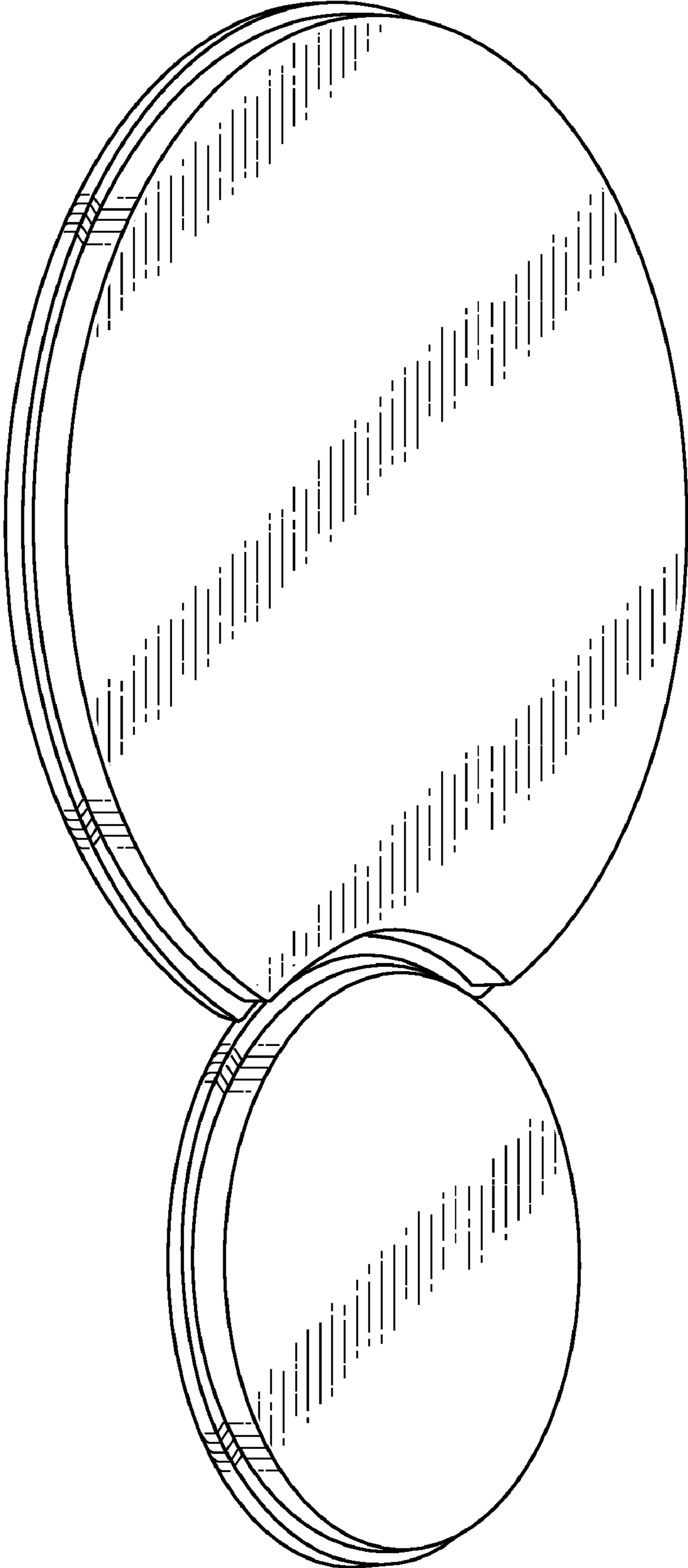

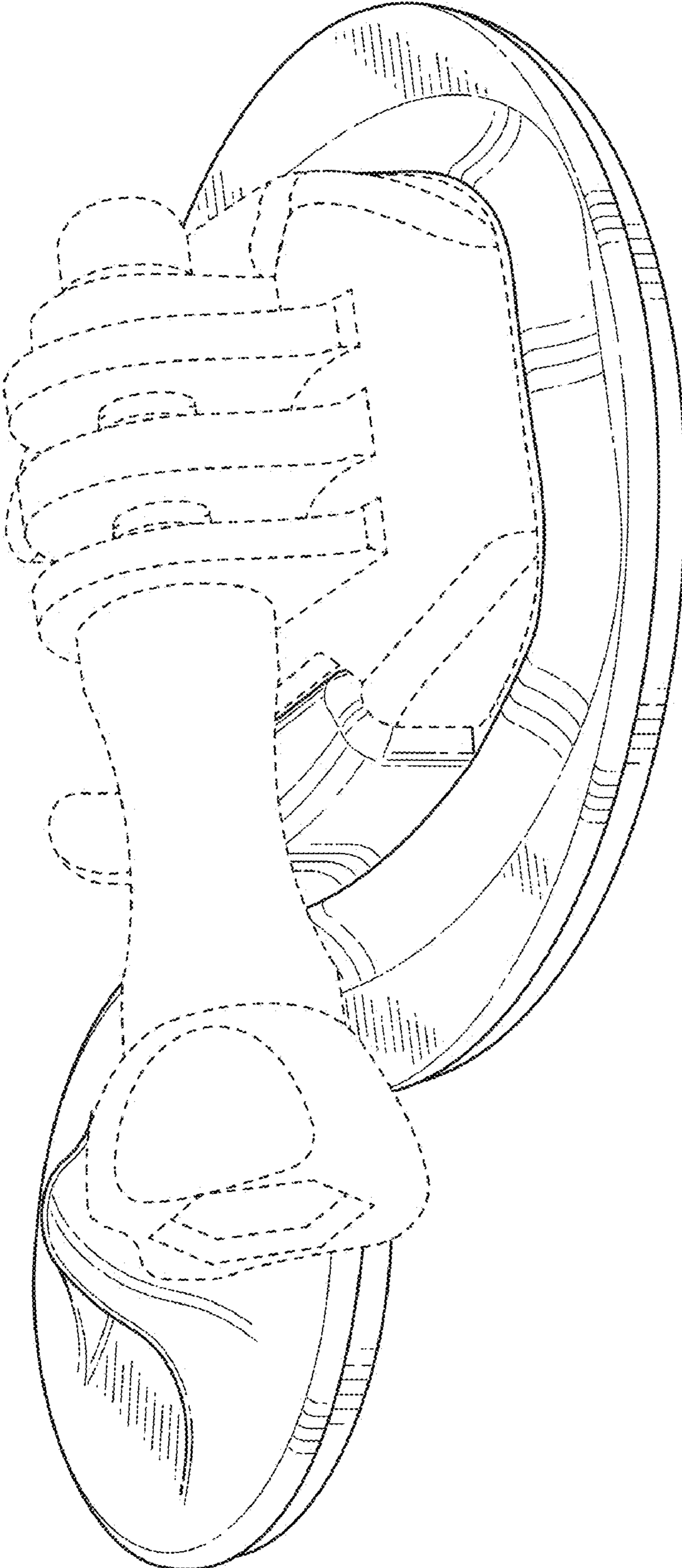
