(57) **CLAIM**

The ornamental design for a low profile snag-less fishing rod tip top guide design, shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fishing rod guide showing an embodiment of my new design;

FIG. 2 is a perspective view of a fishing rod guide on a fishing rod as background for the fishing rod guide of FIG. 1;

FIG. 3 is a side view of the fishing rod guide of FIG. 1;

FIG. 4 is an opposite side view of the fishing rod guide of FIG. 1;

FIG. 5 is a front view of the fishing rod guide of FIG. 1;

FIG. 6 is a rear view of the fishing rod guide of FIG. 1;

FIG. 7 is a top plan view of the fishing rod guide of FIG. 1;

FIG. 8 is a bottom plan view of the fishing rod guide of FIG. 1;

FIG. 9 is a perspective view of a fishing rod guide showing a second embodiment of my design;

FIG. 10 is a perspective view of a fishing rod guide on a fishing rod as background for the fishing rod guide of FIG. 9;

FIG. 11 is a side view of the fishing rod guide of FIG. 9;

FIG. 12 is an opposite side view of the fishing rod guide of FIG. 9;

FIG. 13 is a front view of the fishing rod guide of FIG. 9;

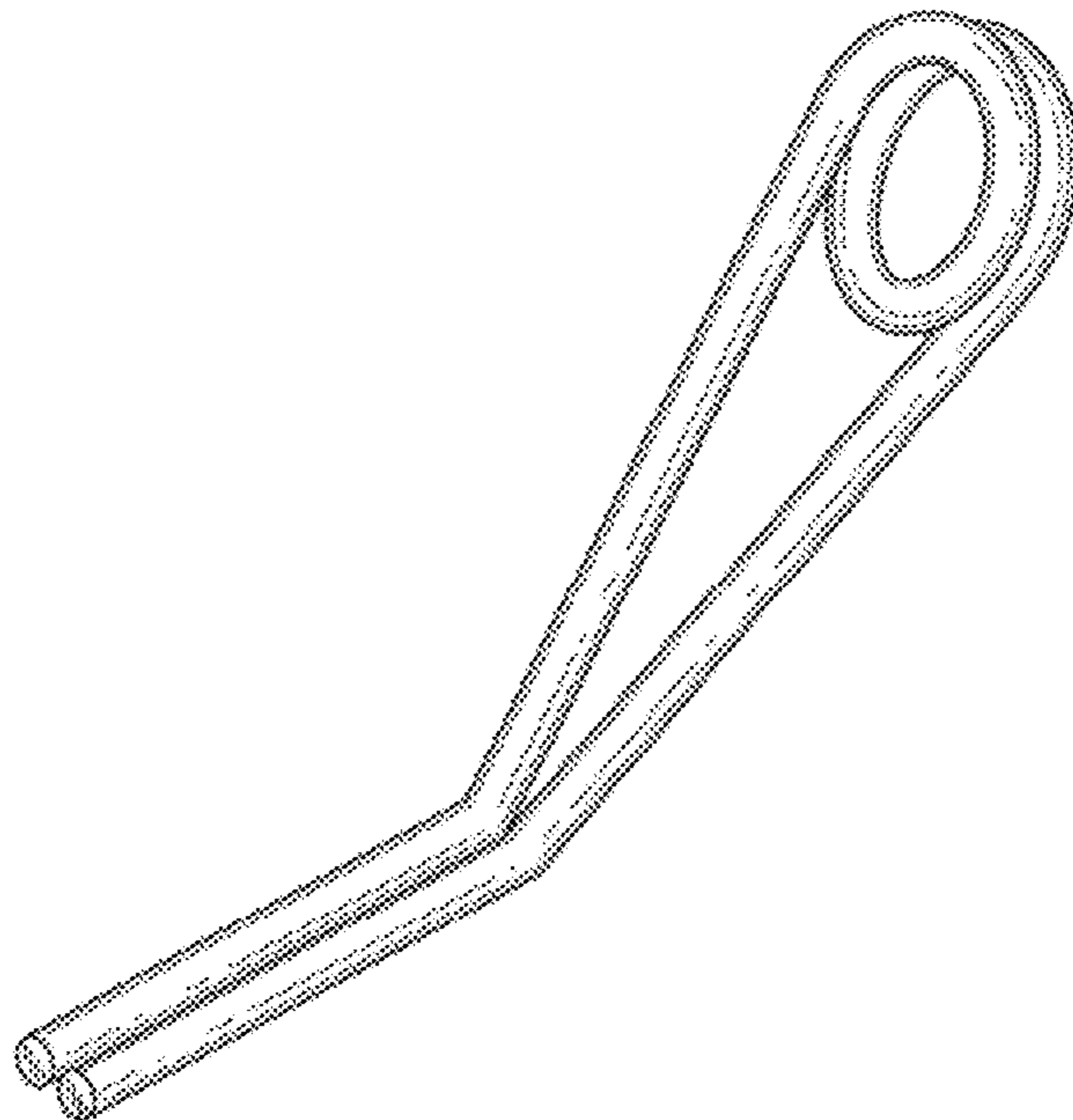
FIG. 14 is a rear view of the fishing rod guide of FIG. 9;

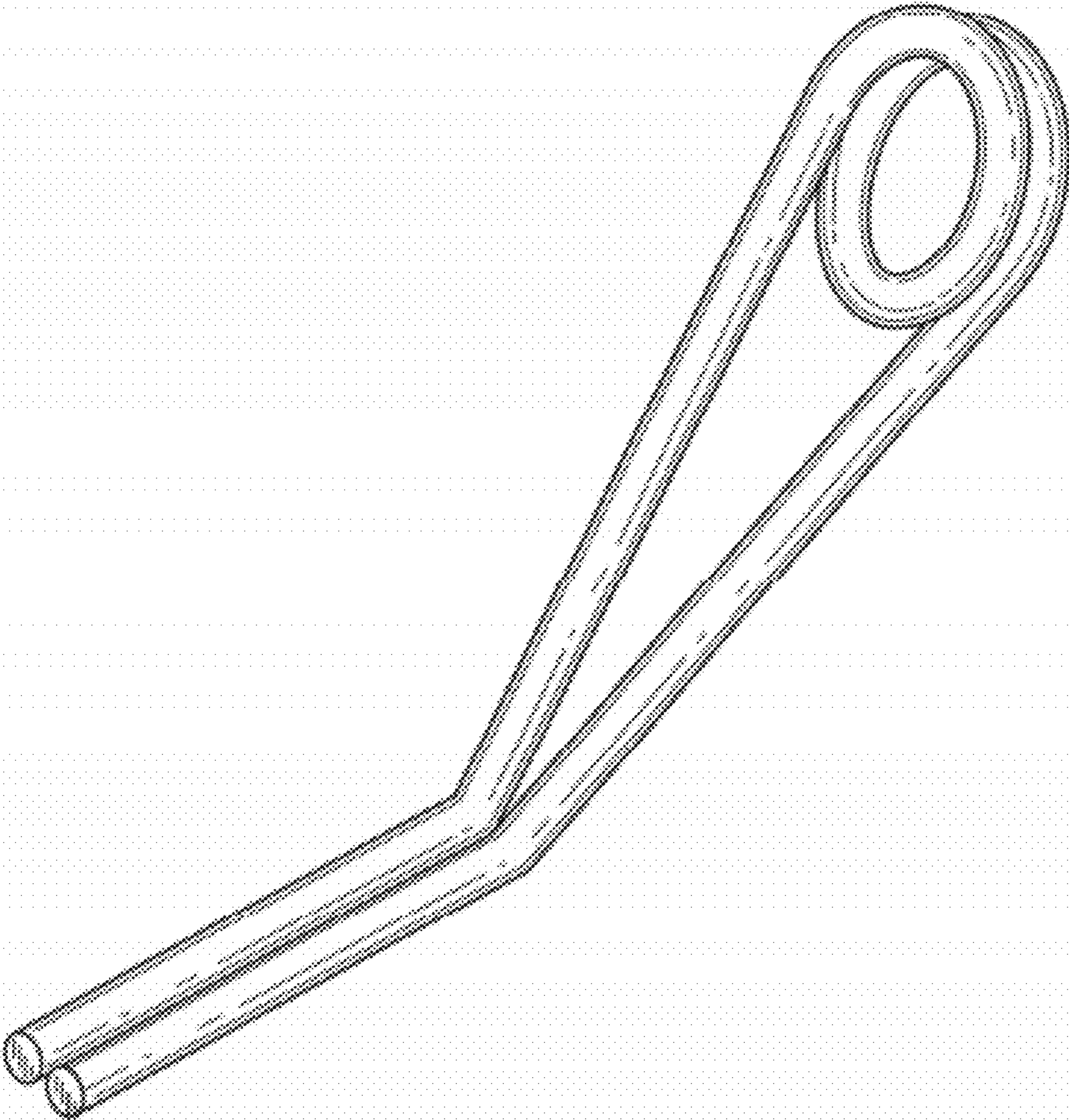

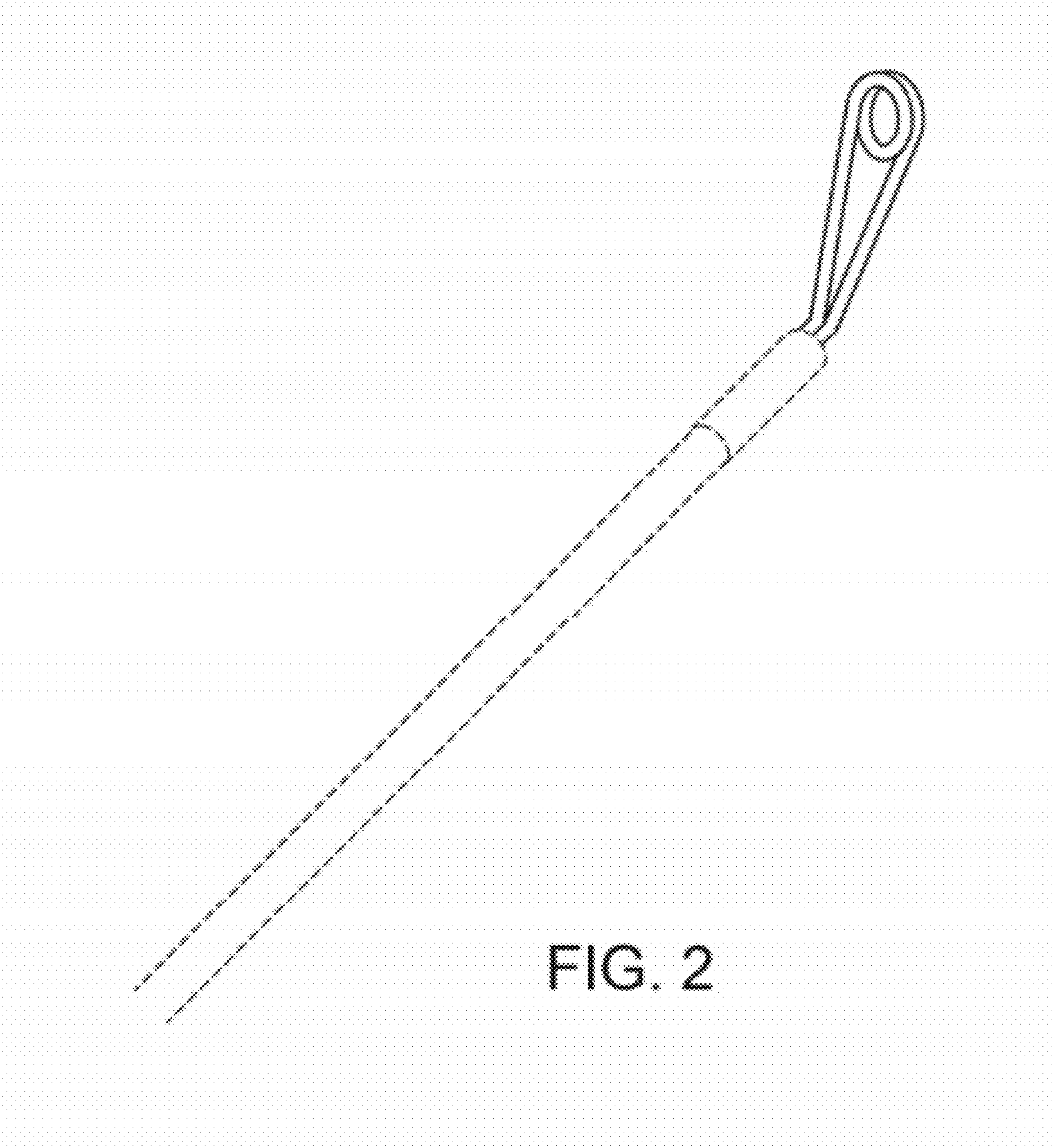

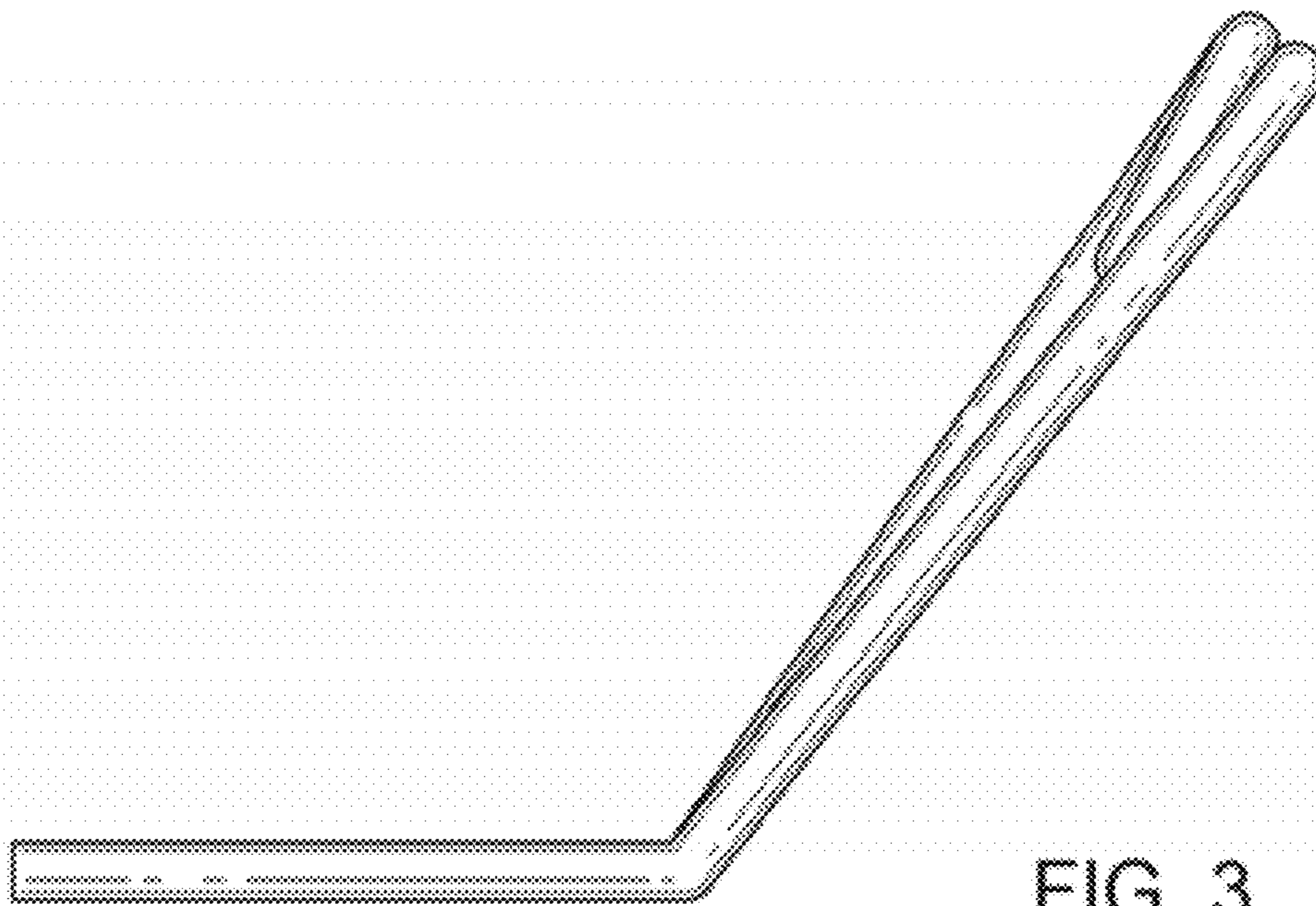

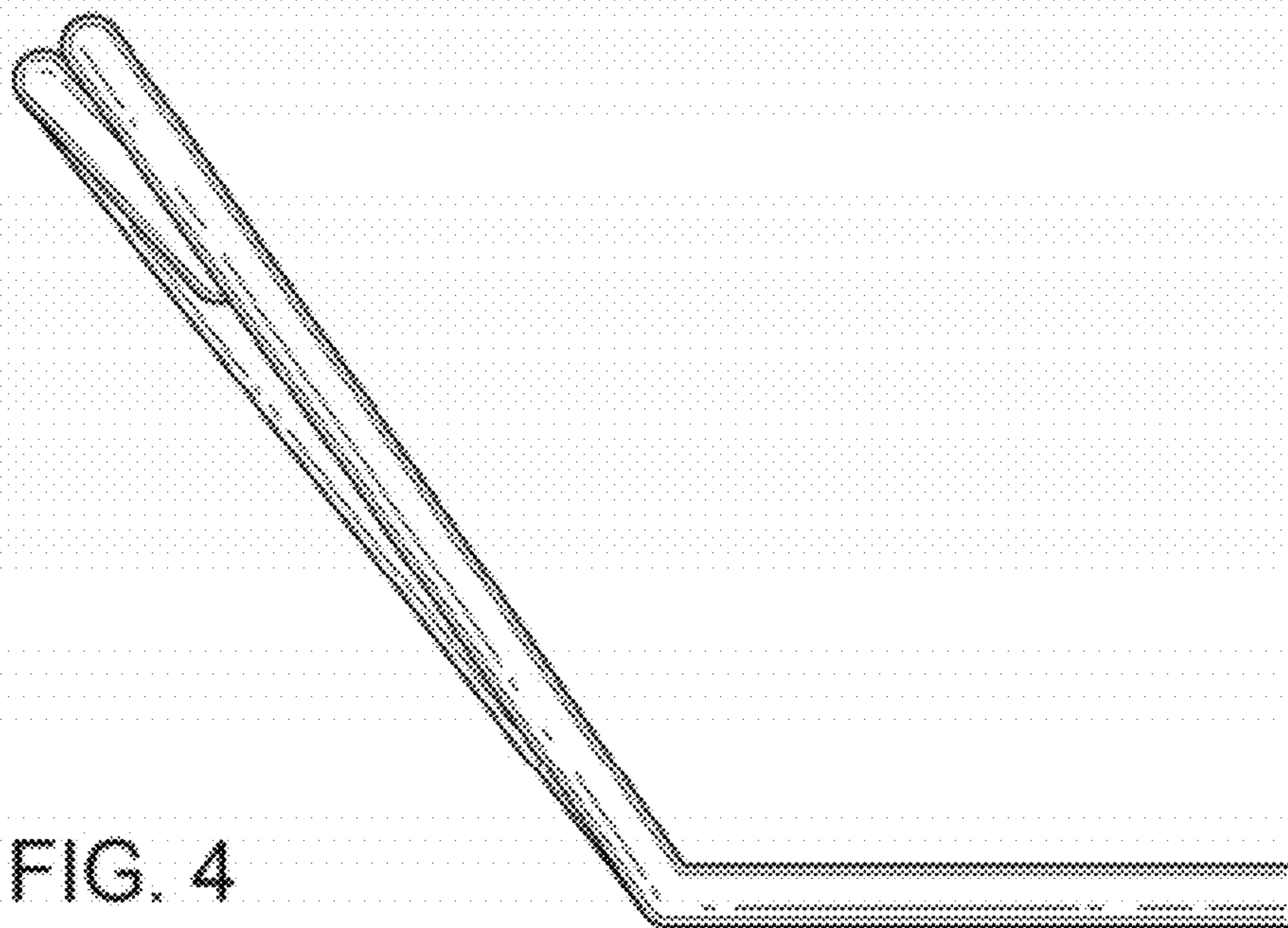

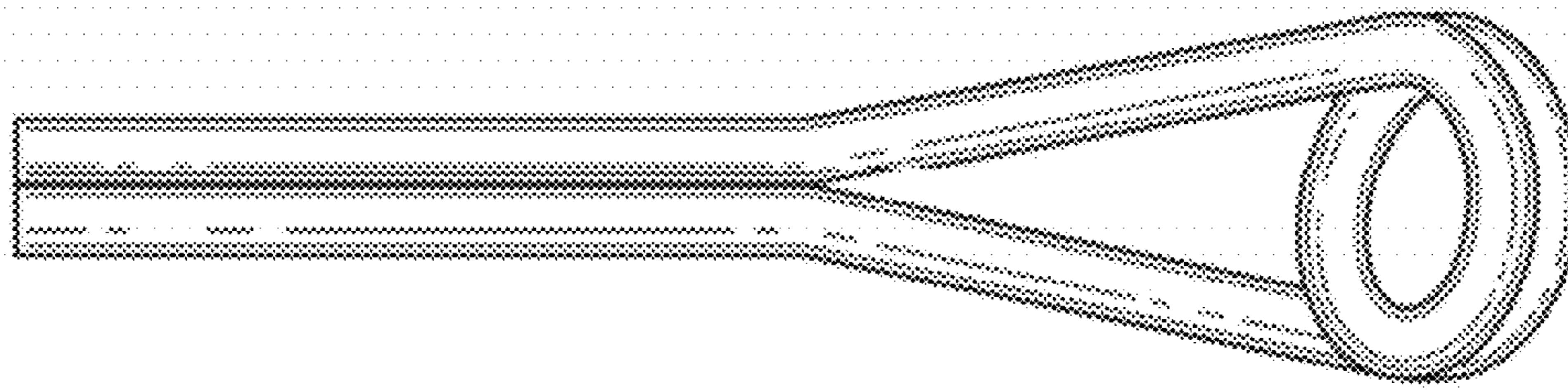

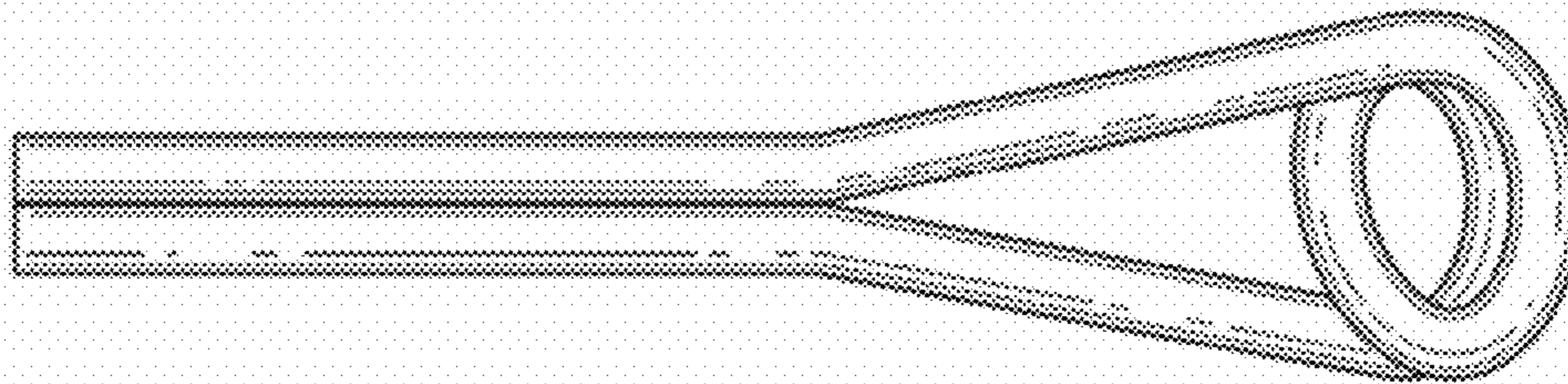

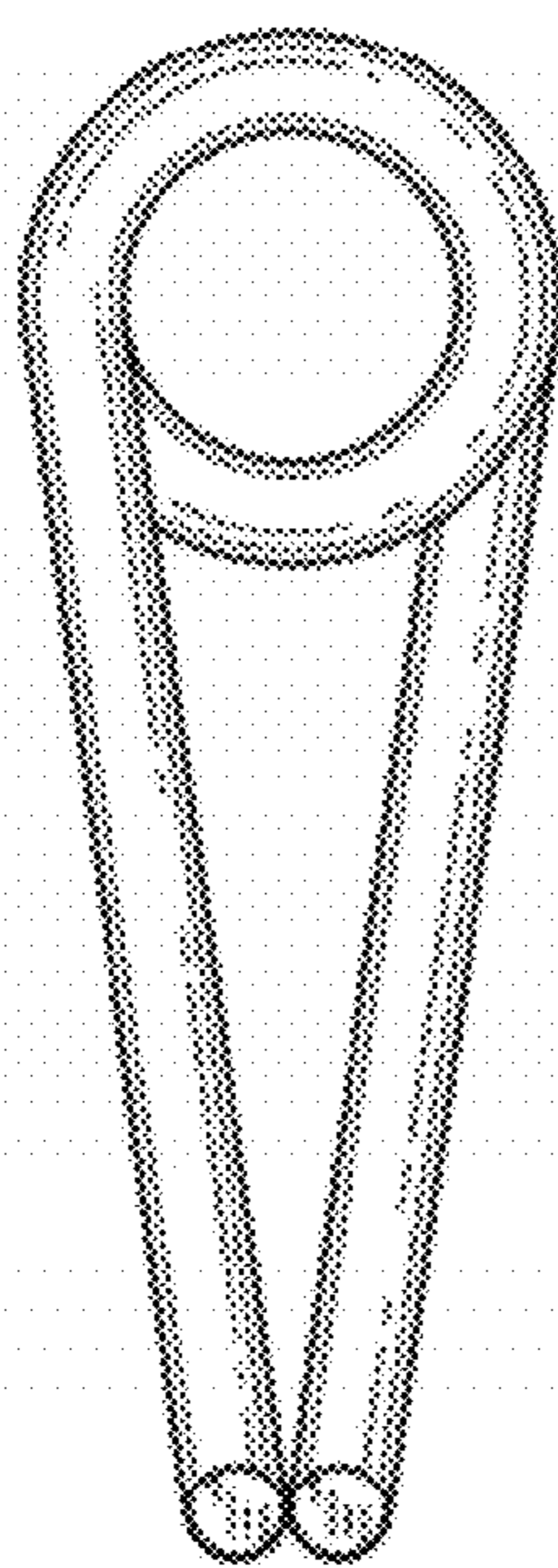

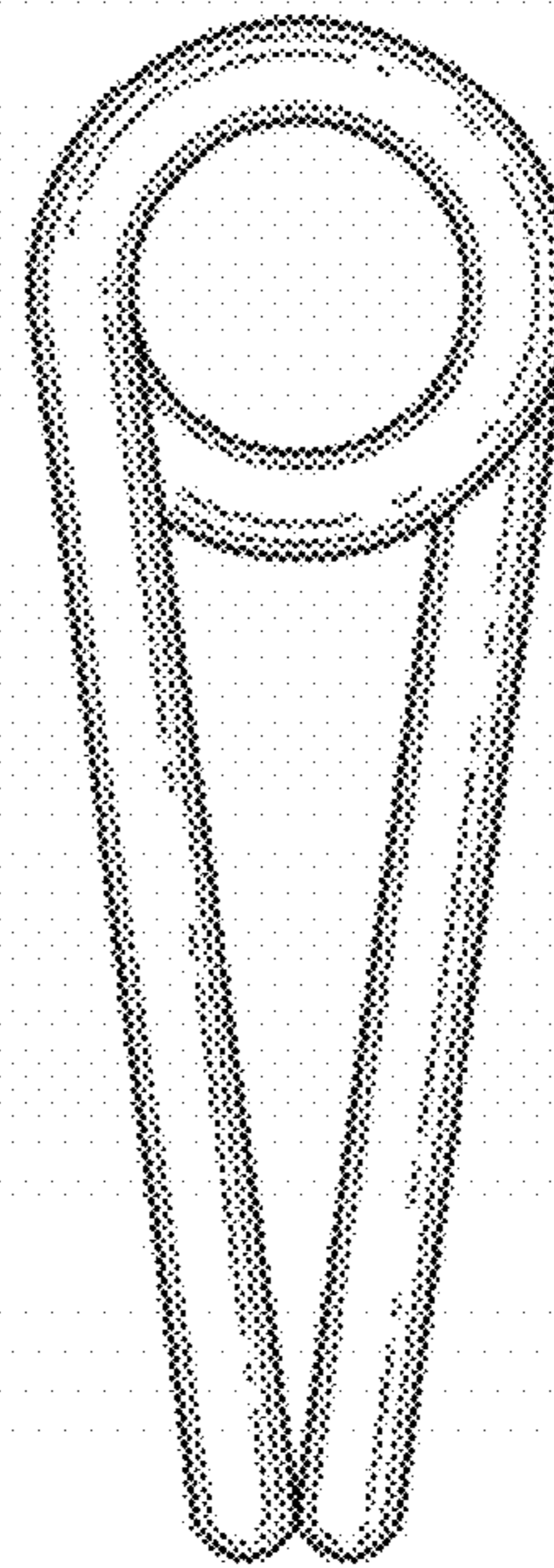

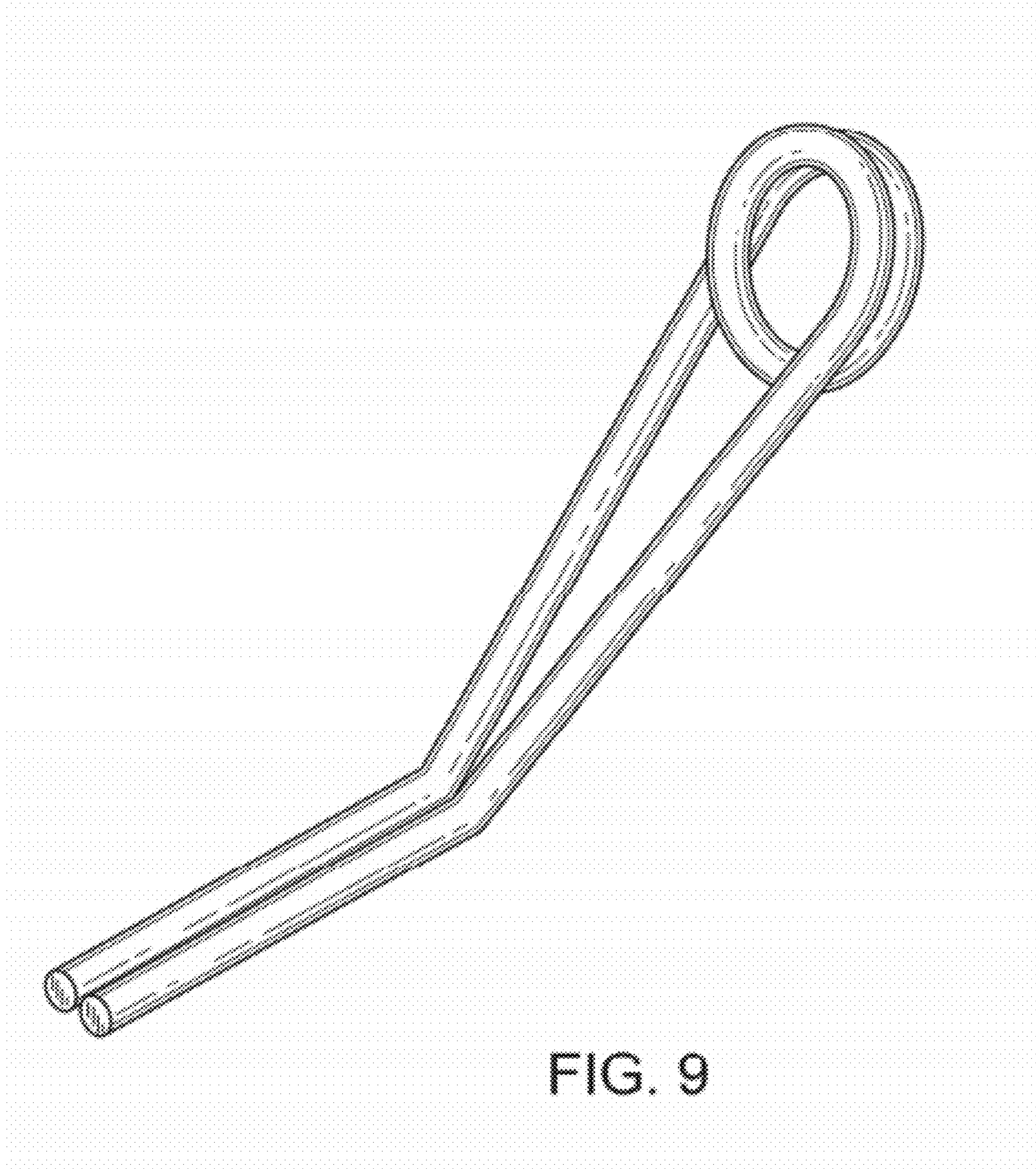

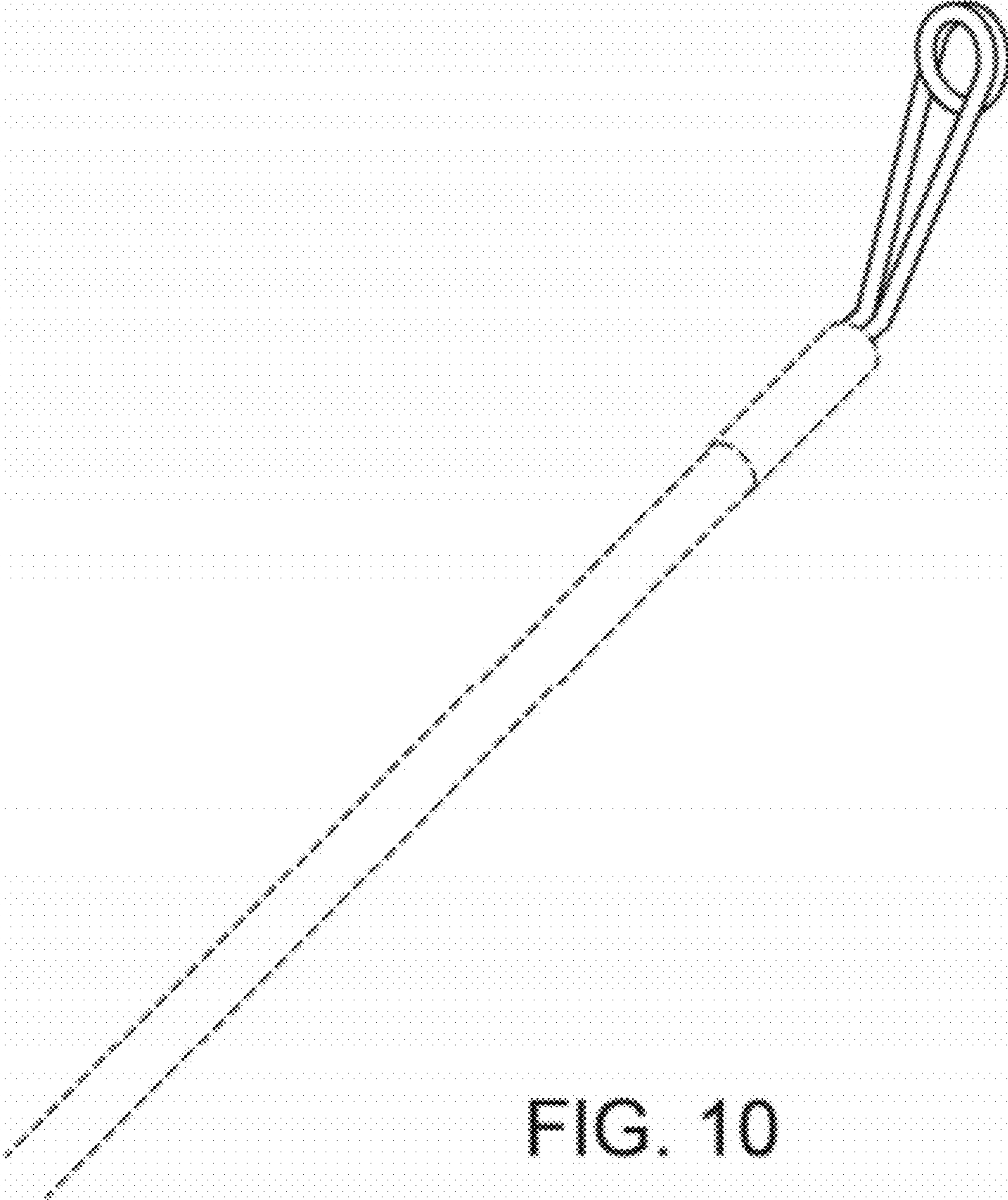

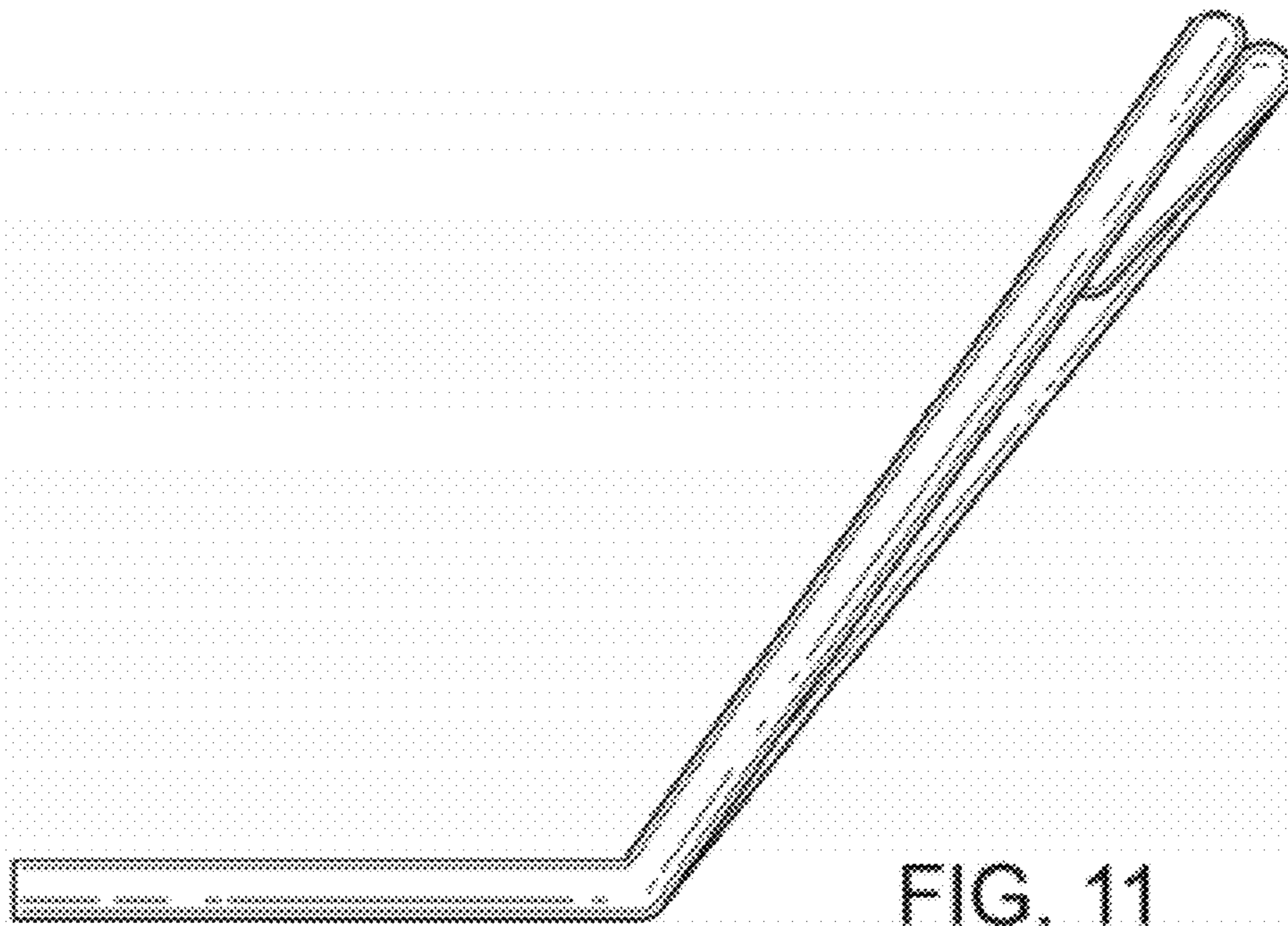

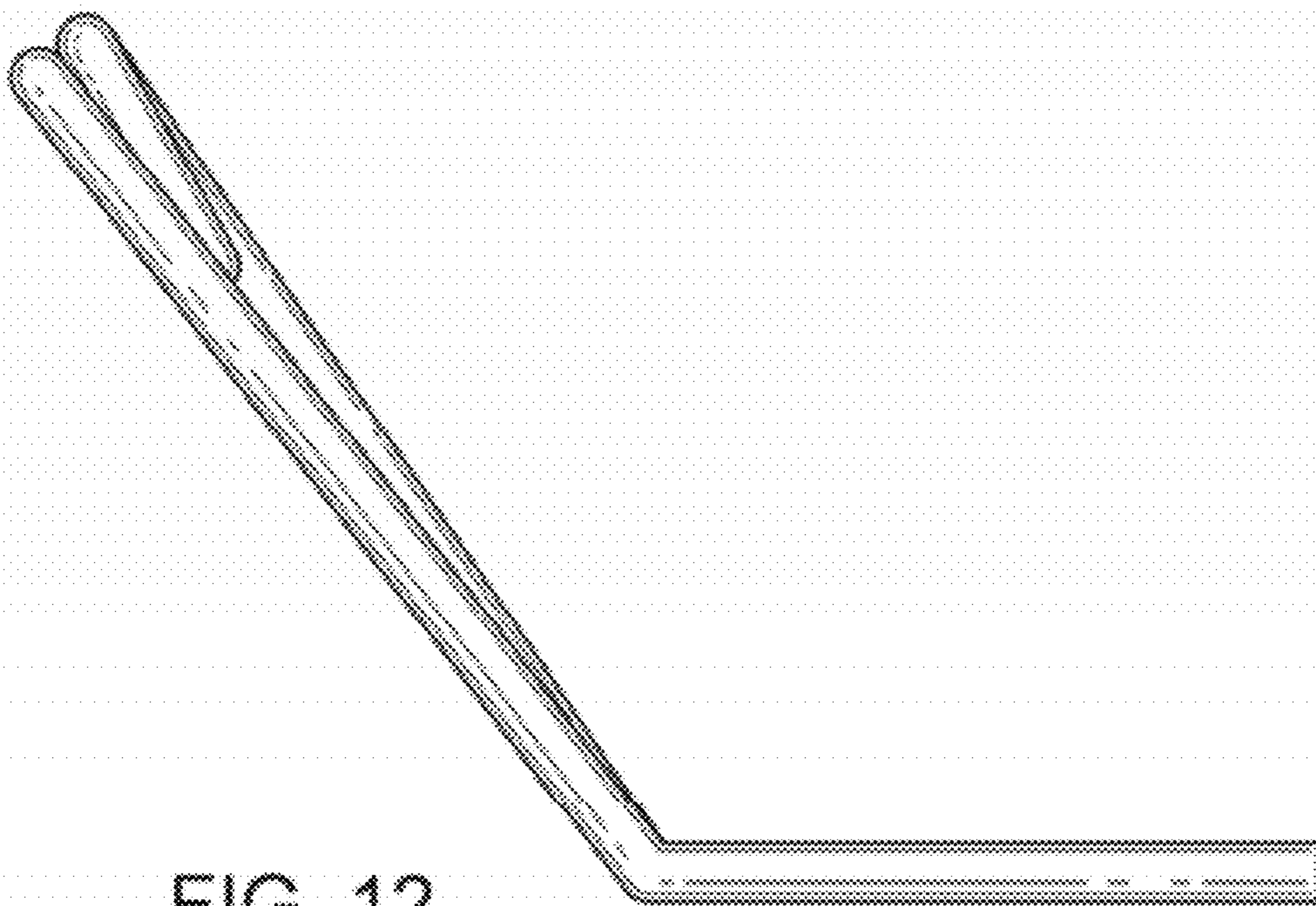

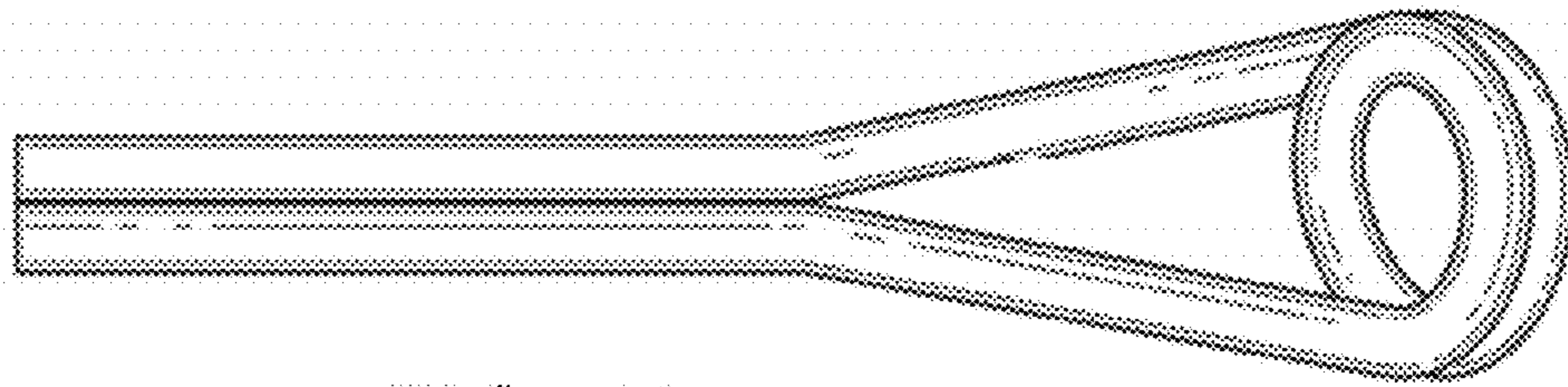

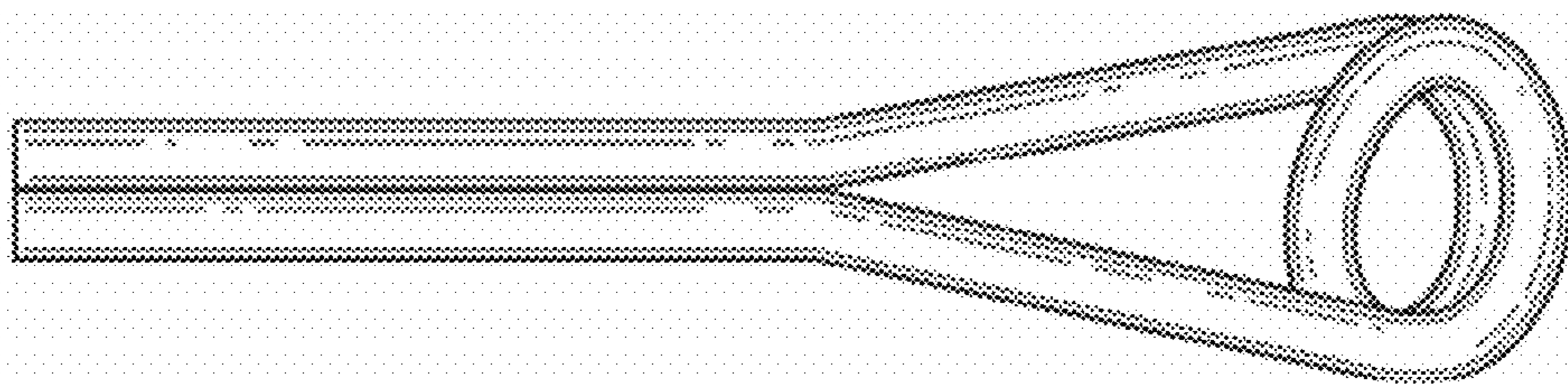

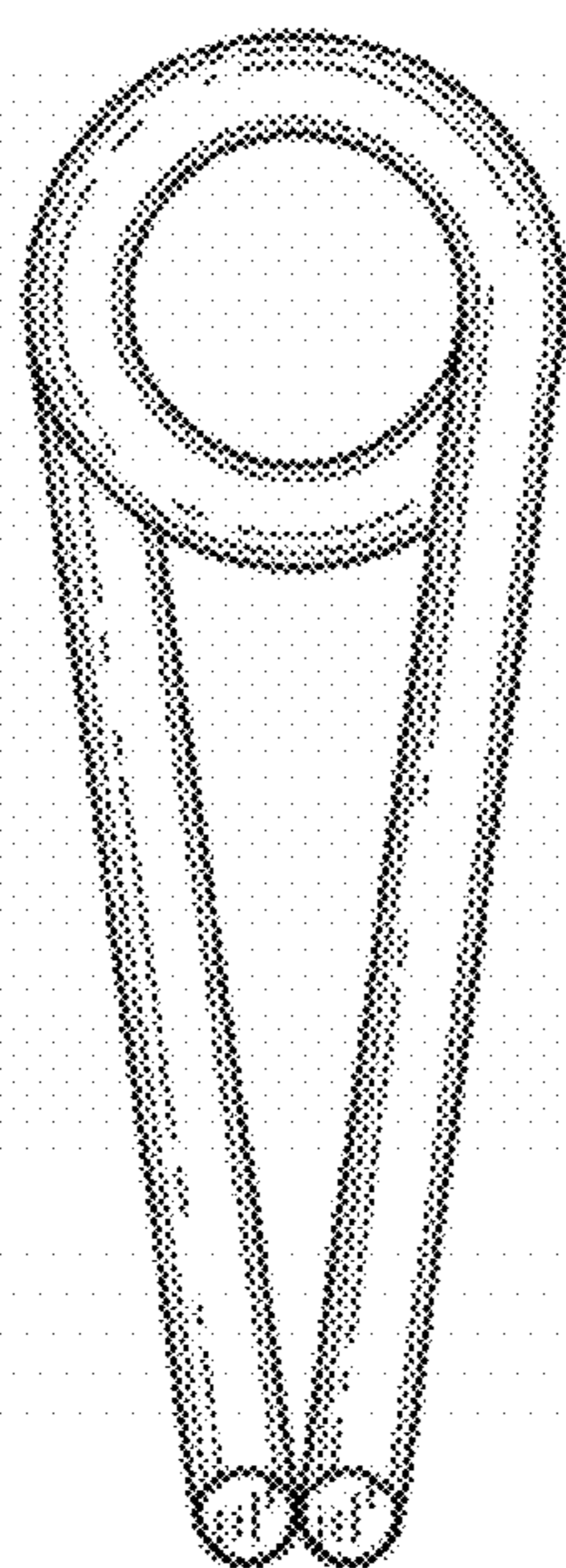

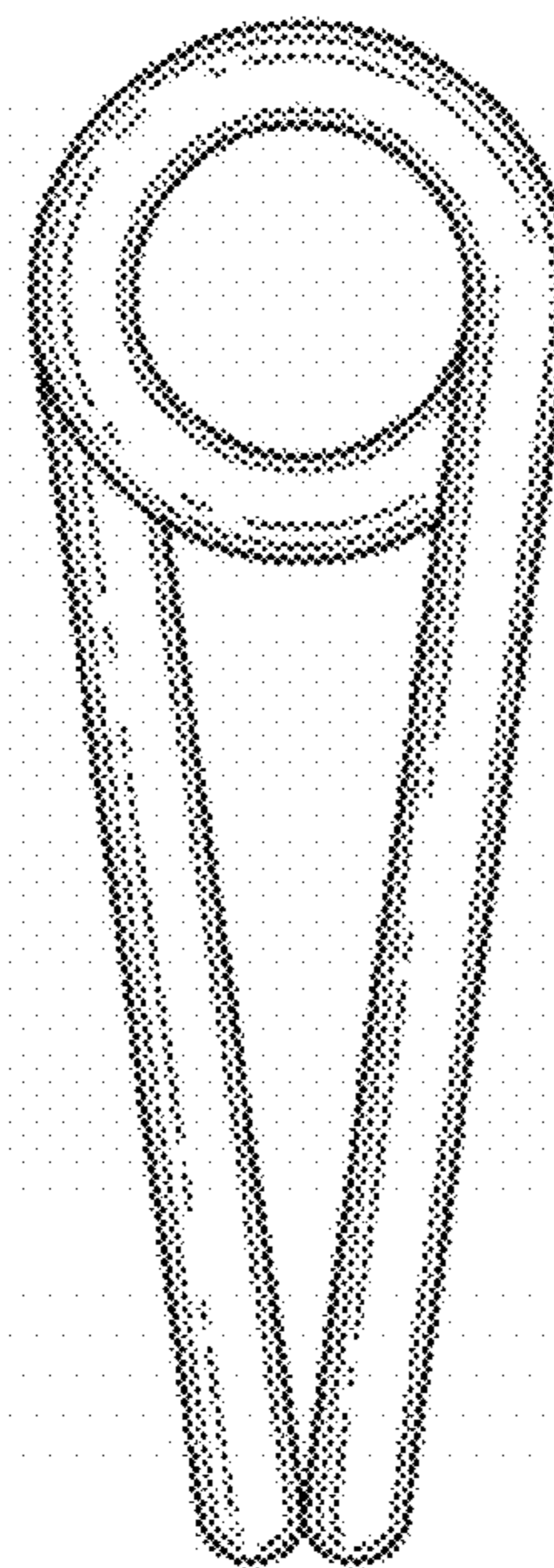
