(57) **CLAIM**

The ornamental design for a vaporizer heating assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective downward-looking front view of a vaporizer heating assembly according to the present invention;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a top plan view of the vaporizer heating assembly of FIG. 1 with a vapor tube extended from the top and right side; FIG. 8 is a bottom plan view of the vaporizer heating assembly of FIG. 1;

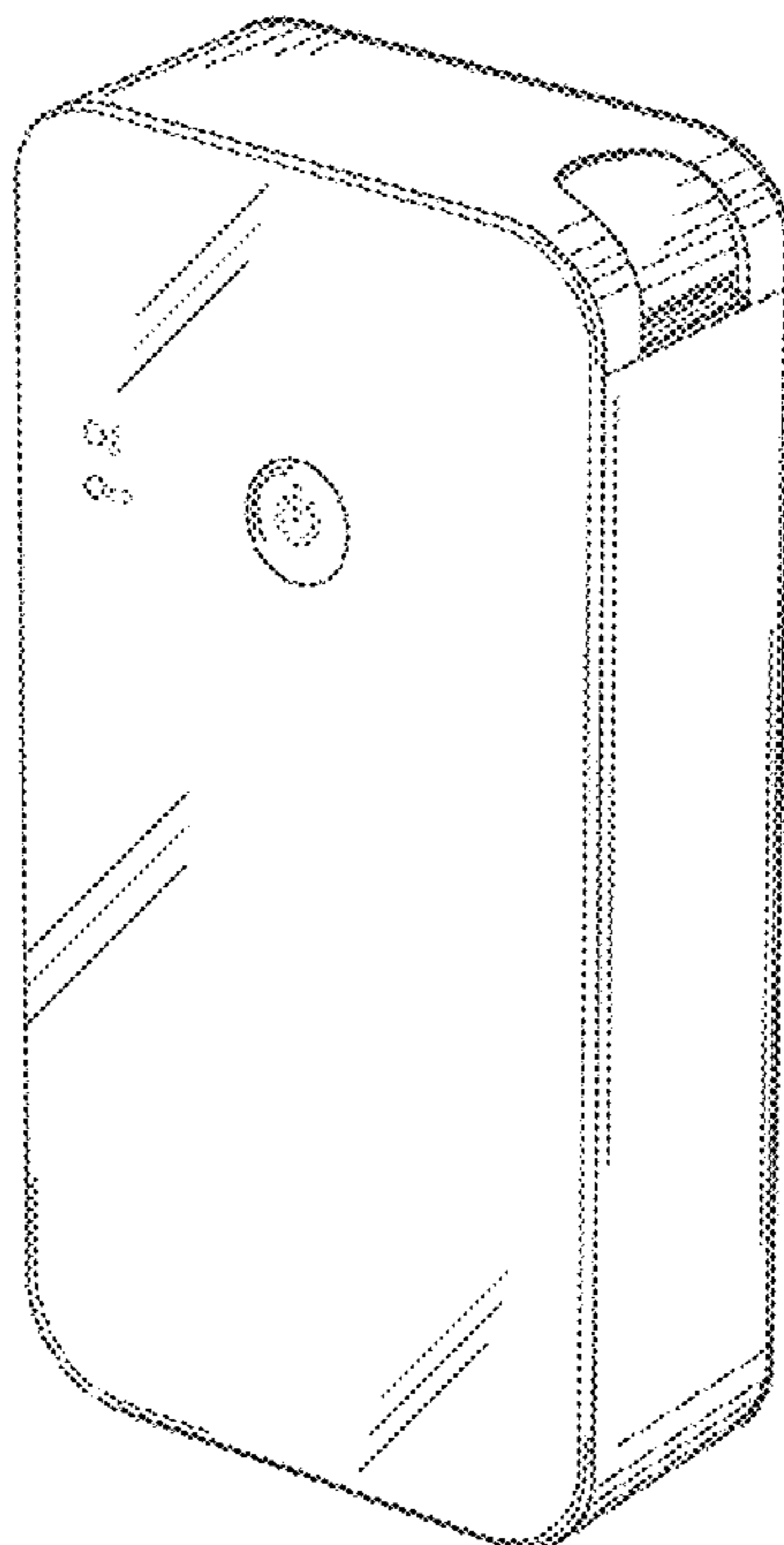
FIG. 9 is a perspective downward-looking front view of the vaporizer heating assembly of FIG. 1 with the lid open and exposing the vapor tube of FIG. 7 in a stored position;

FIG. 10 is a perspective downward-looking front view of the vaporizer heating assembly of FIG. 1 with the vapor tube of FIG. 7 extending from the top and right side; and,

FIG. 11 is a front elevation view of the vaporizer heating assembly of FIG. 1 with the vapor tube of FIG. 7 extending from the top and right side.

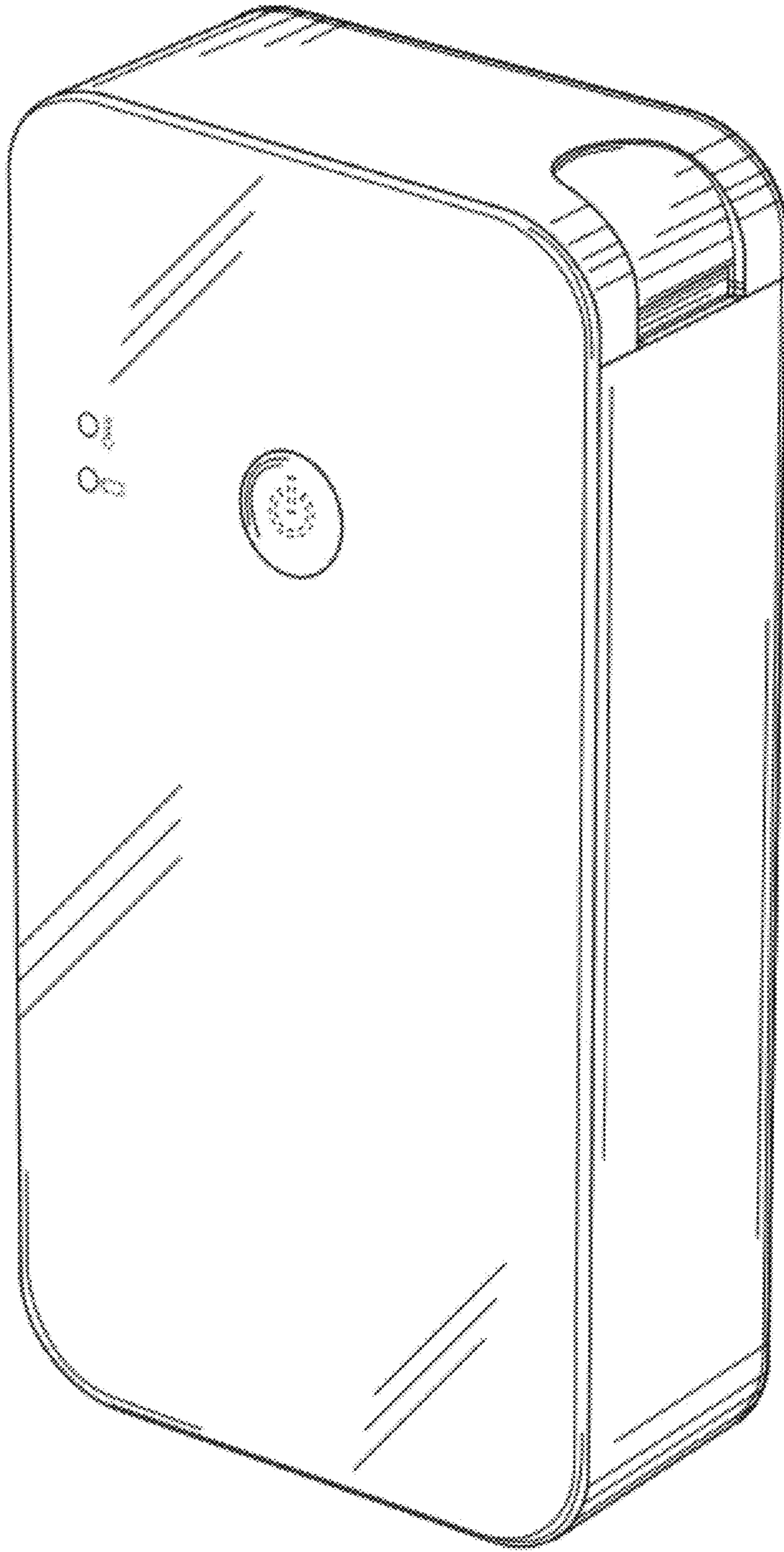

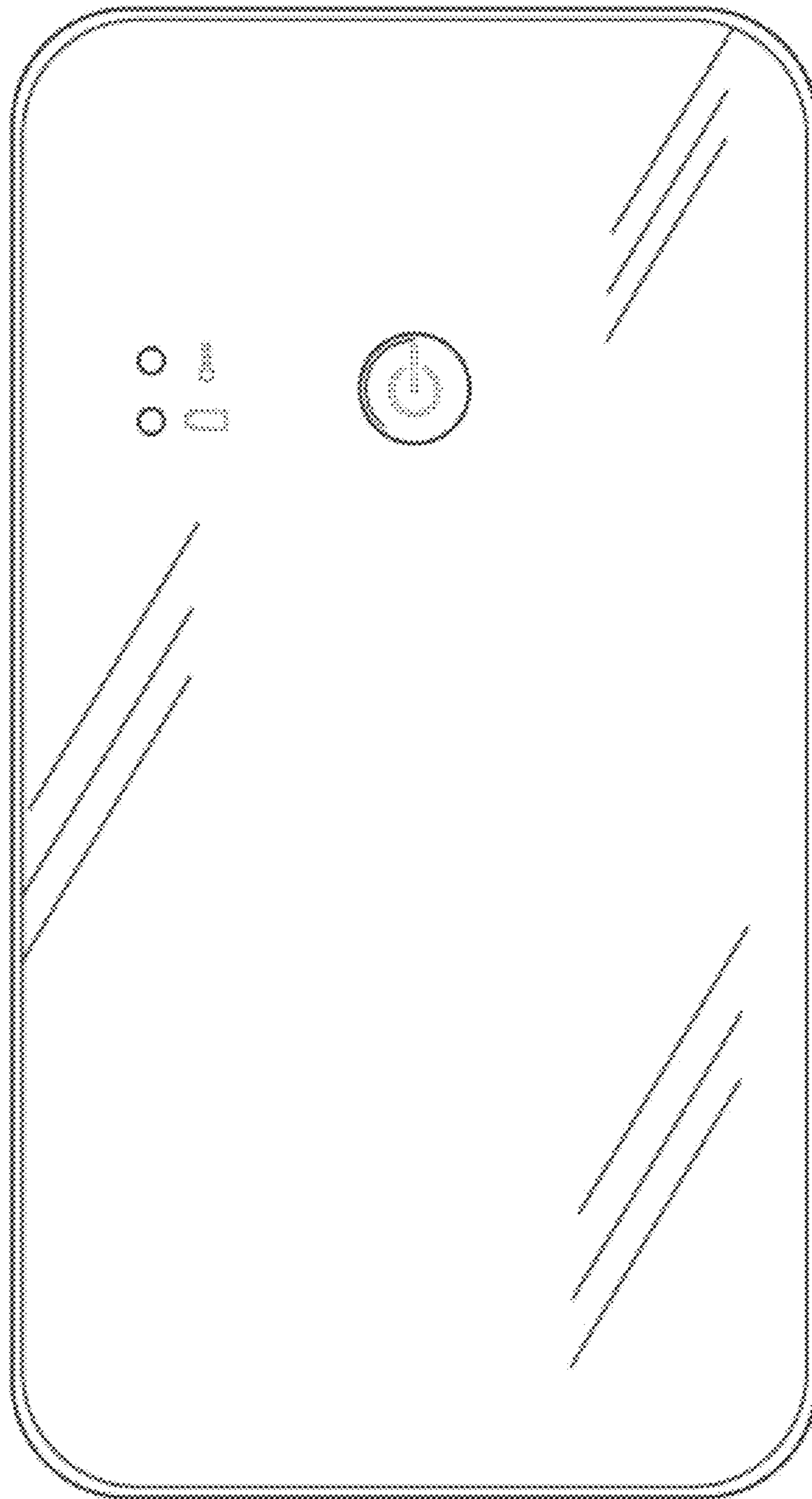

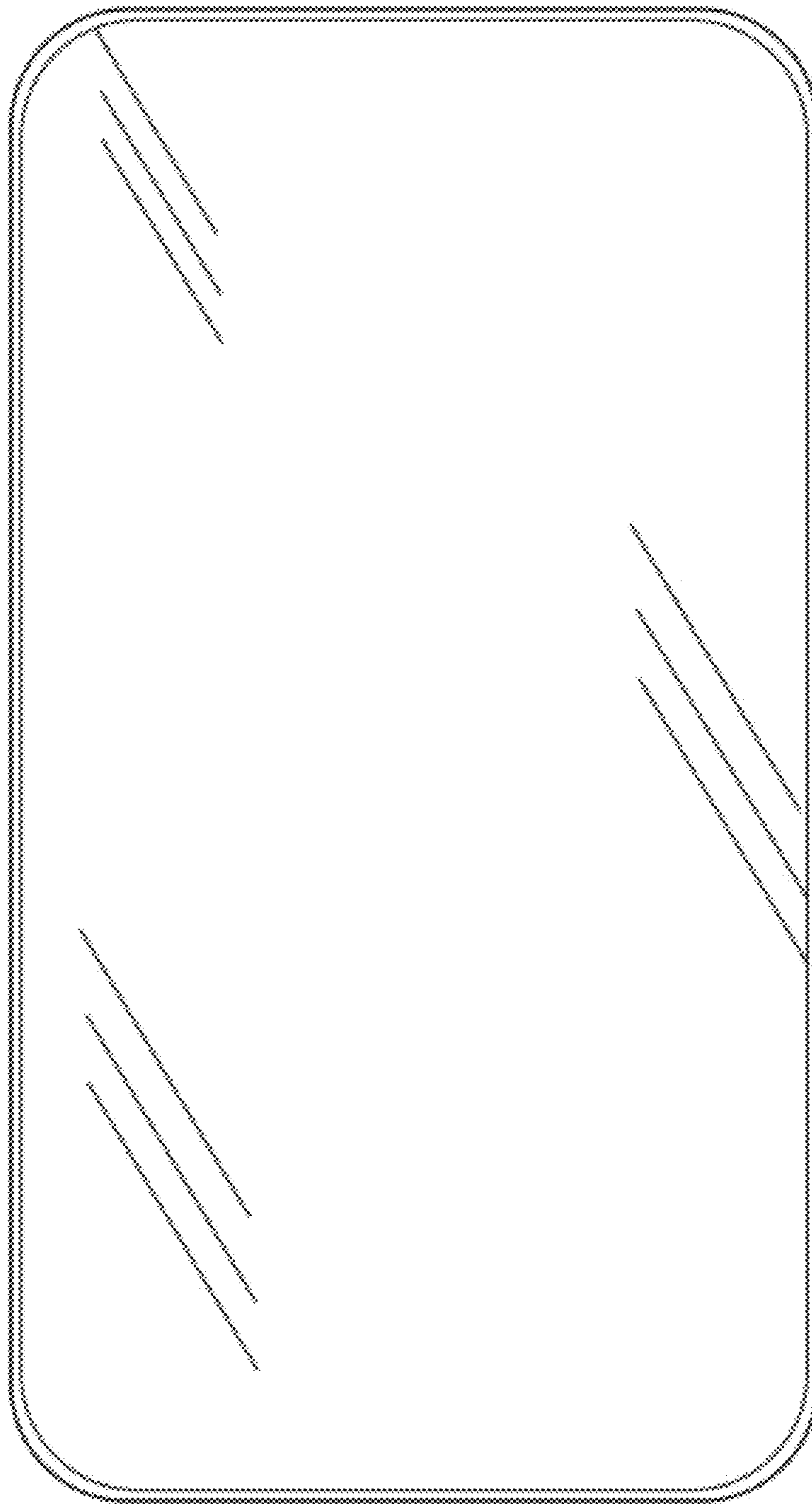

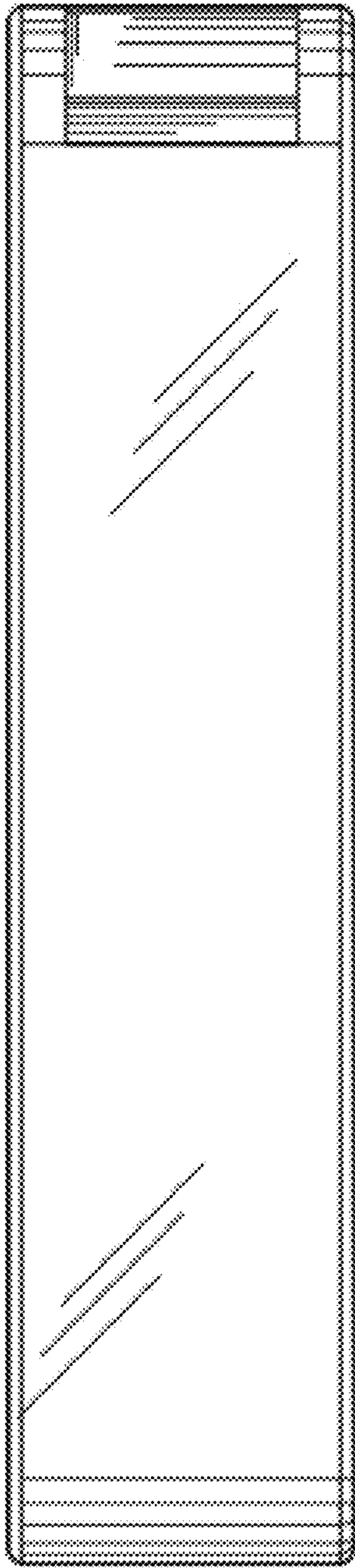

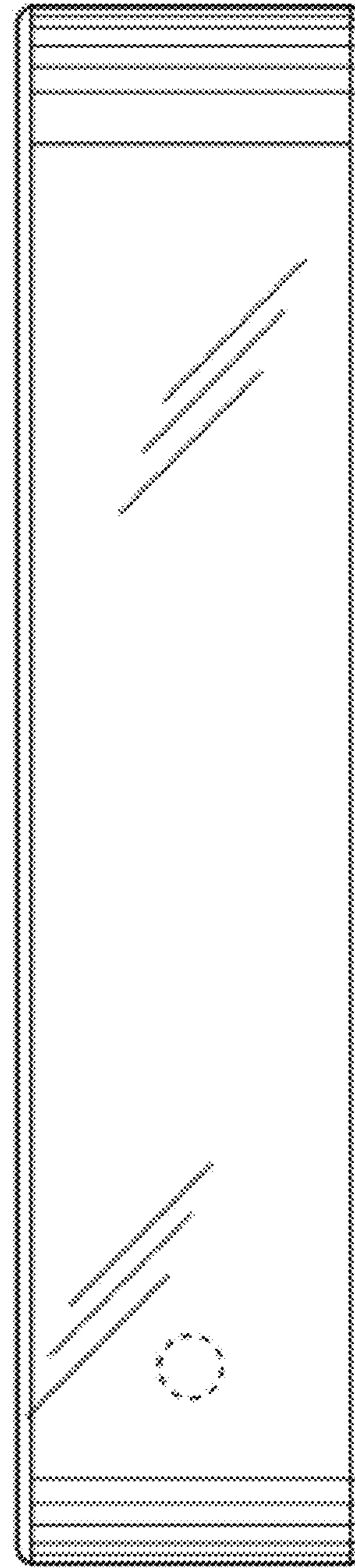

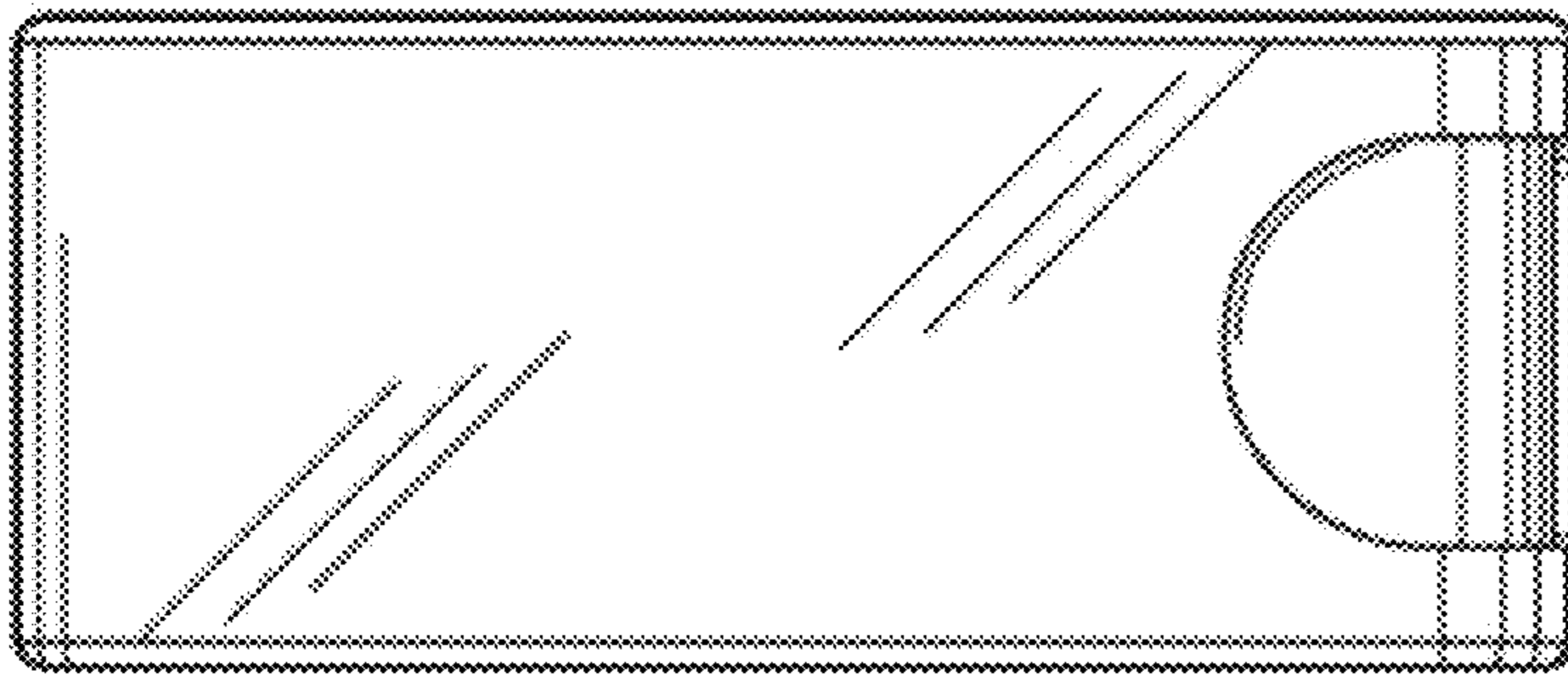

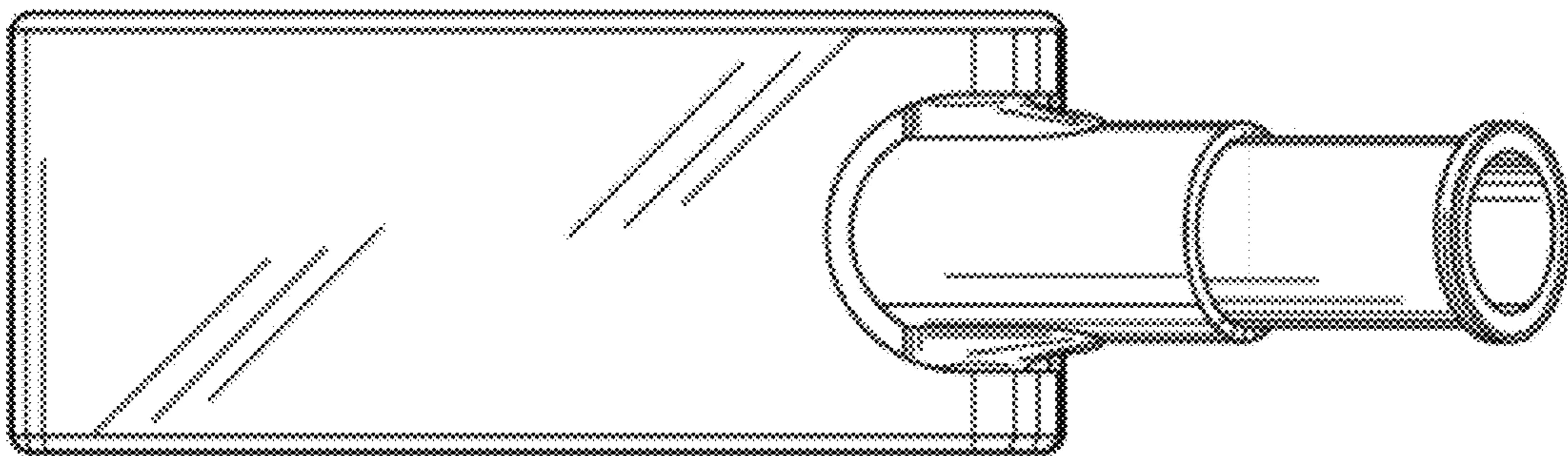

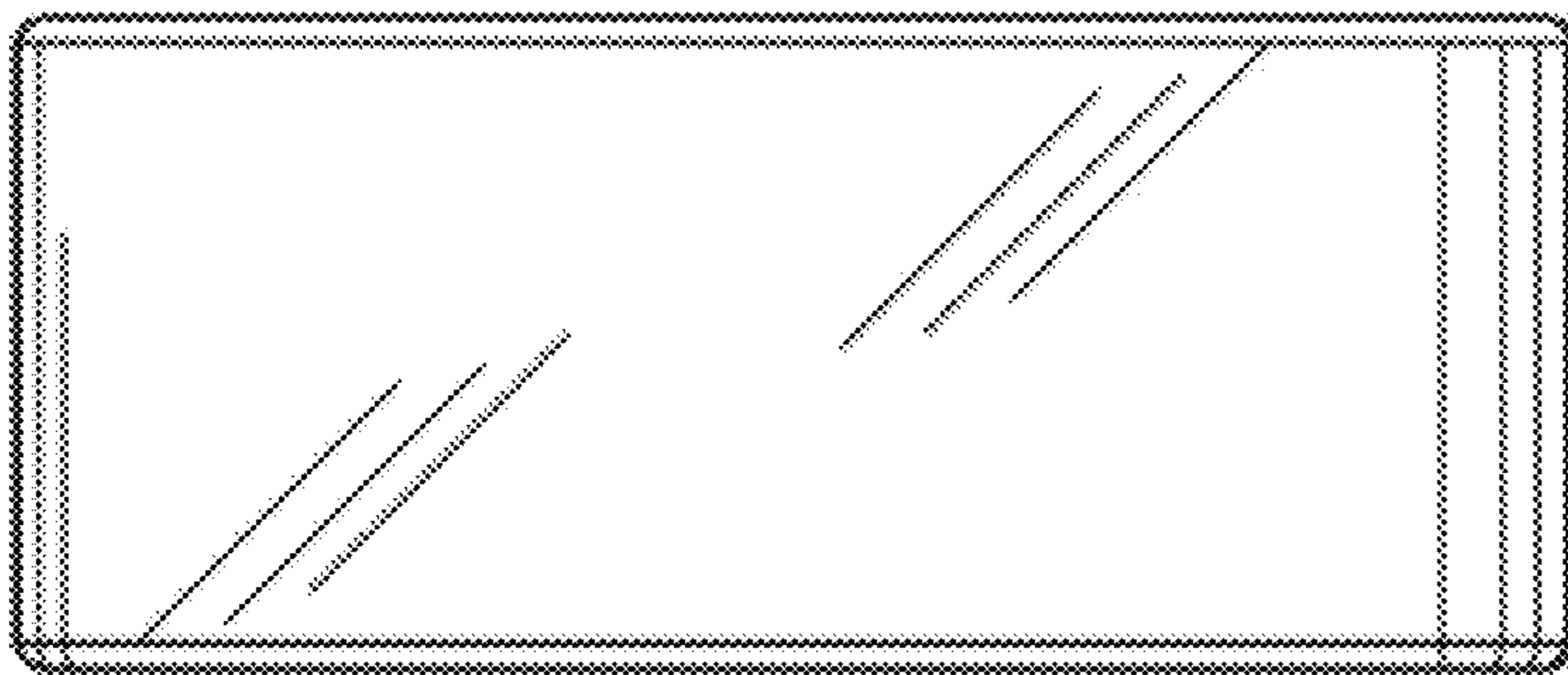

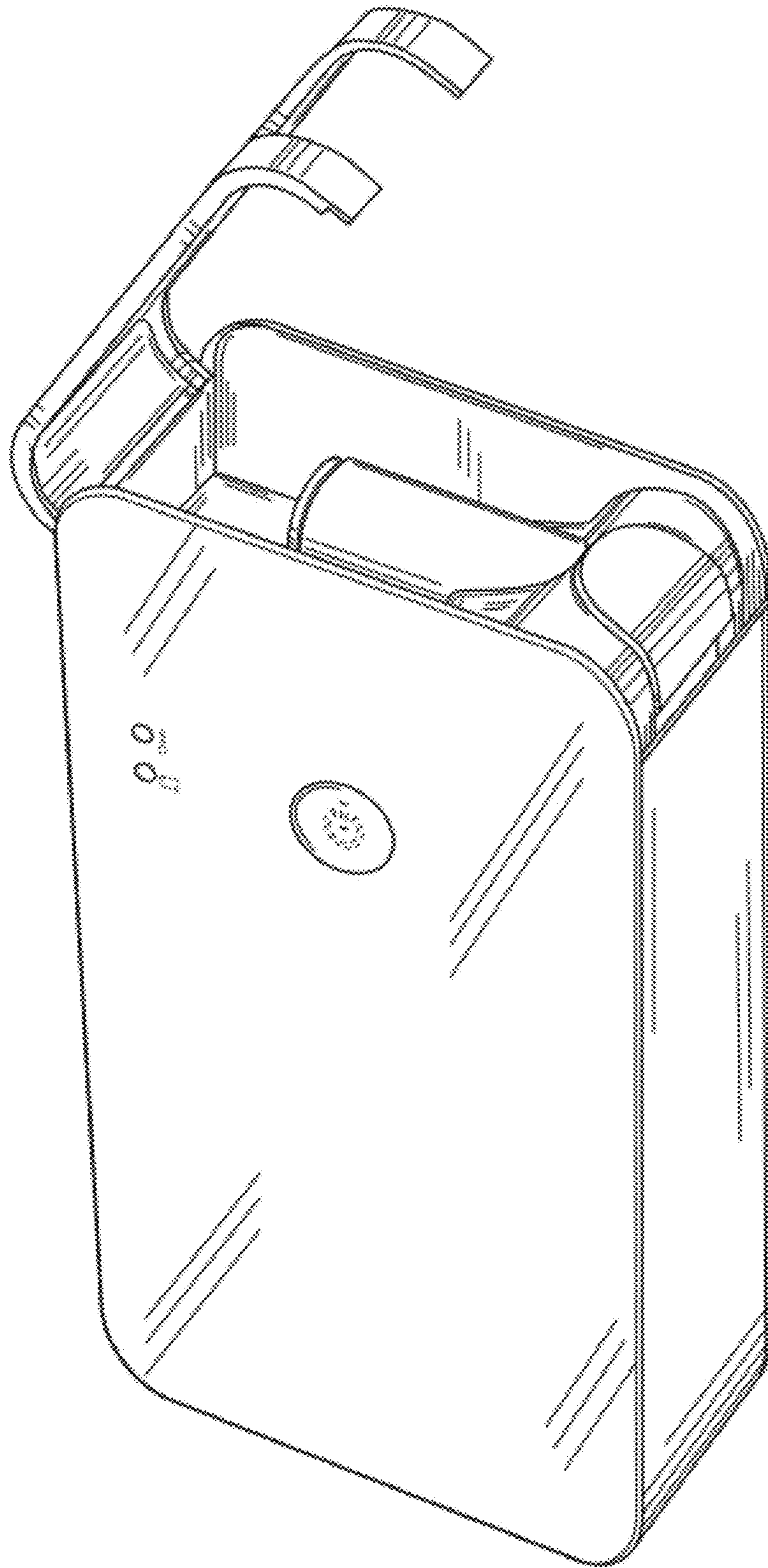

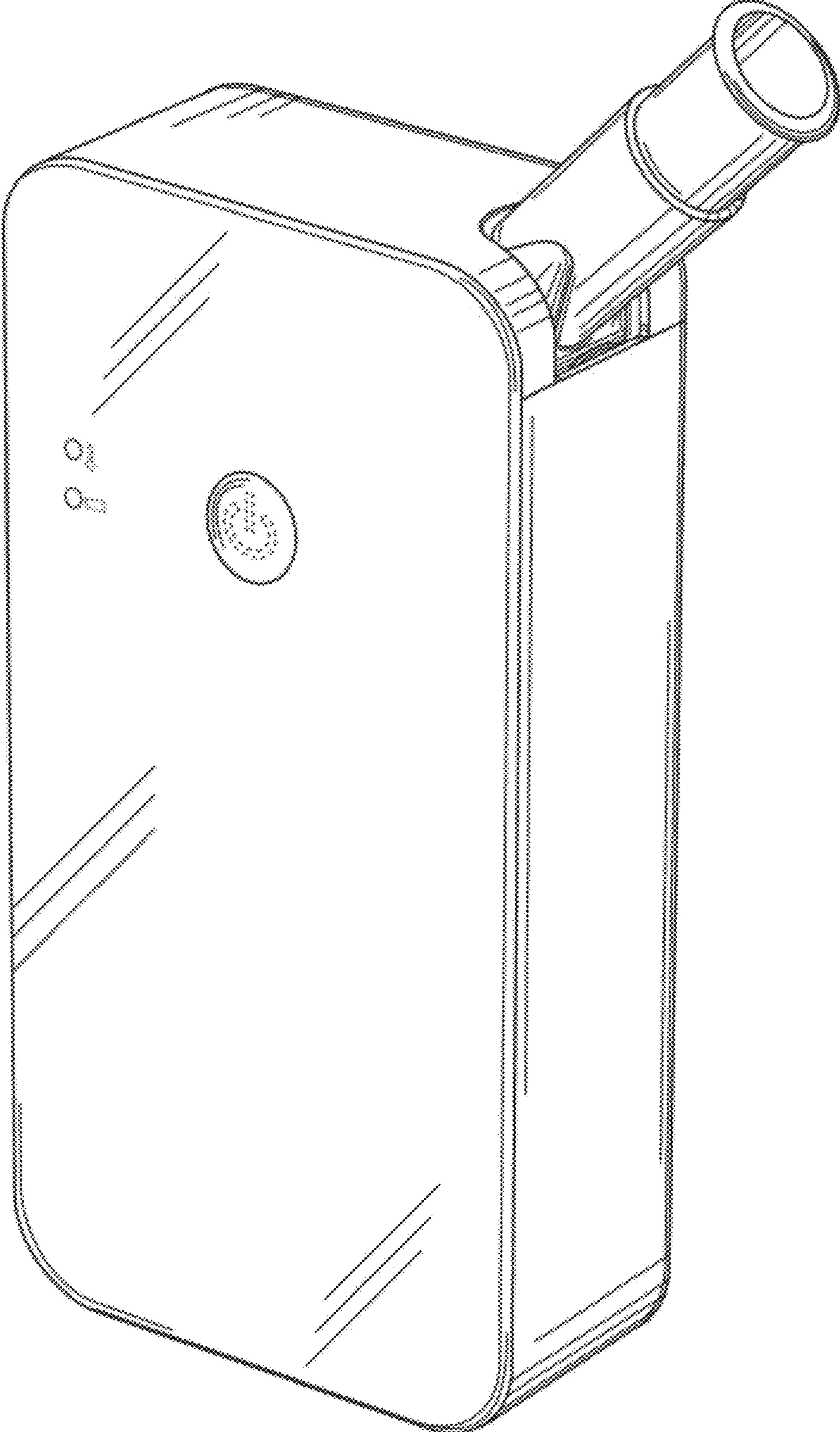

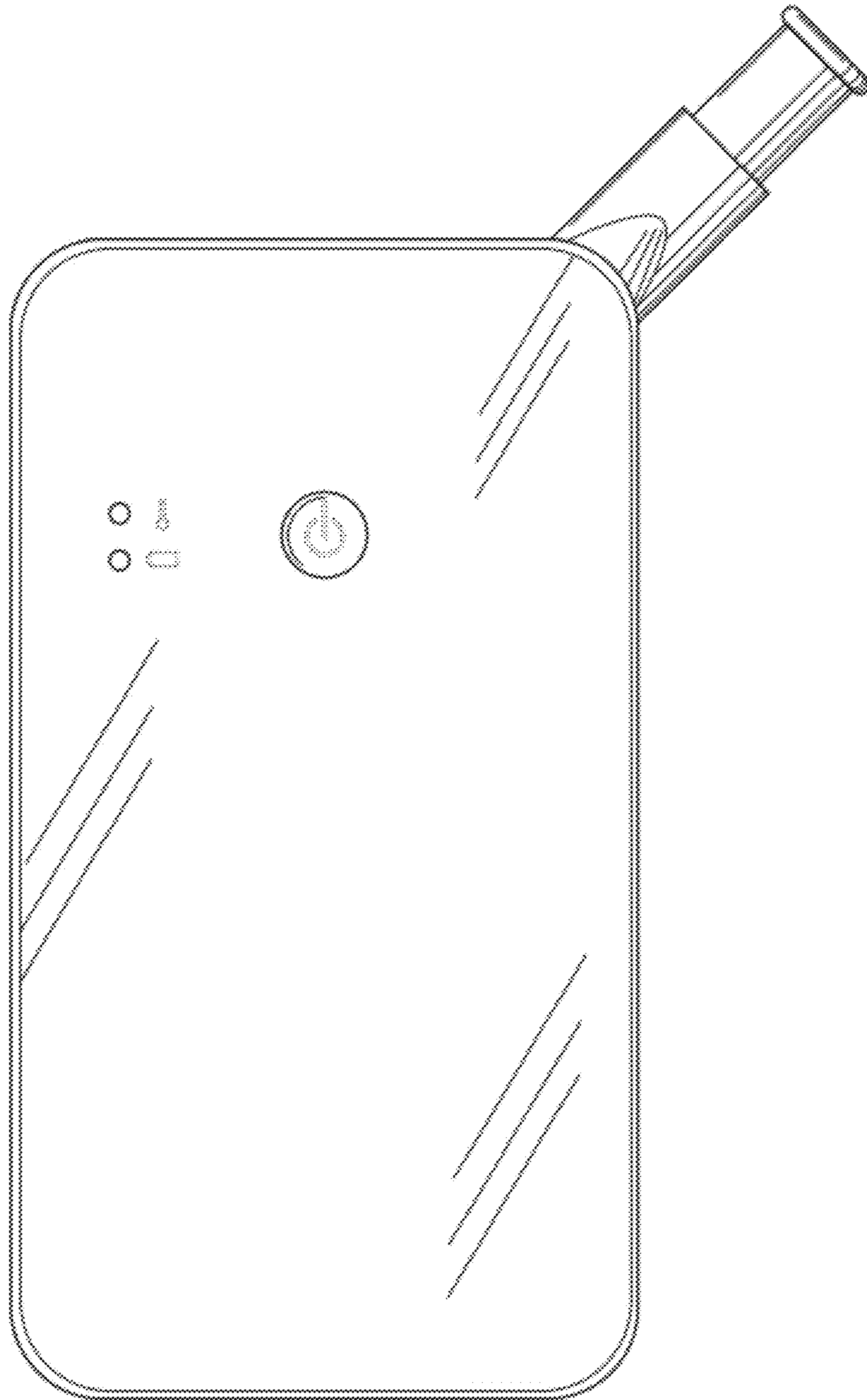
